FIG. 12 is a left side elevation view FIG. 7.

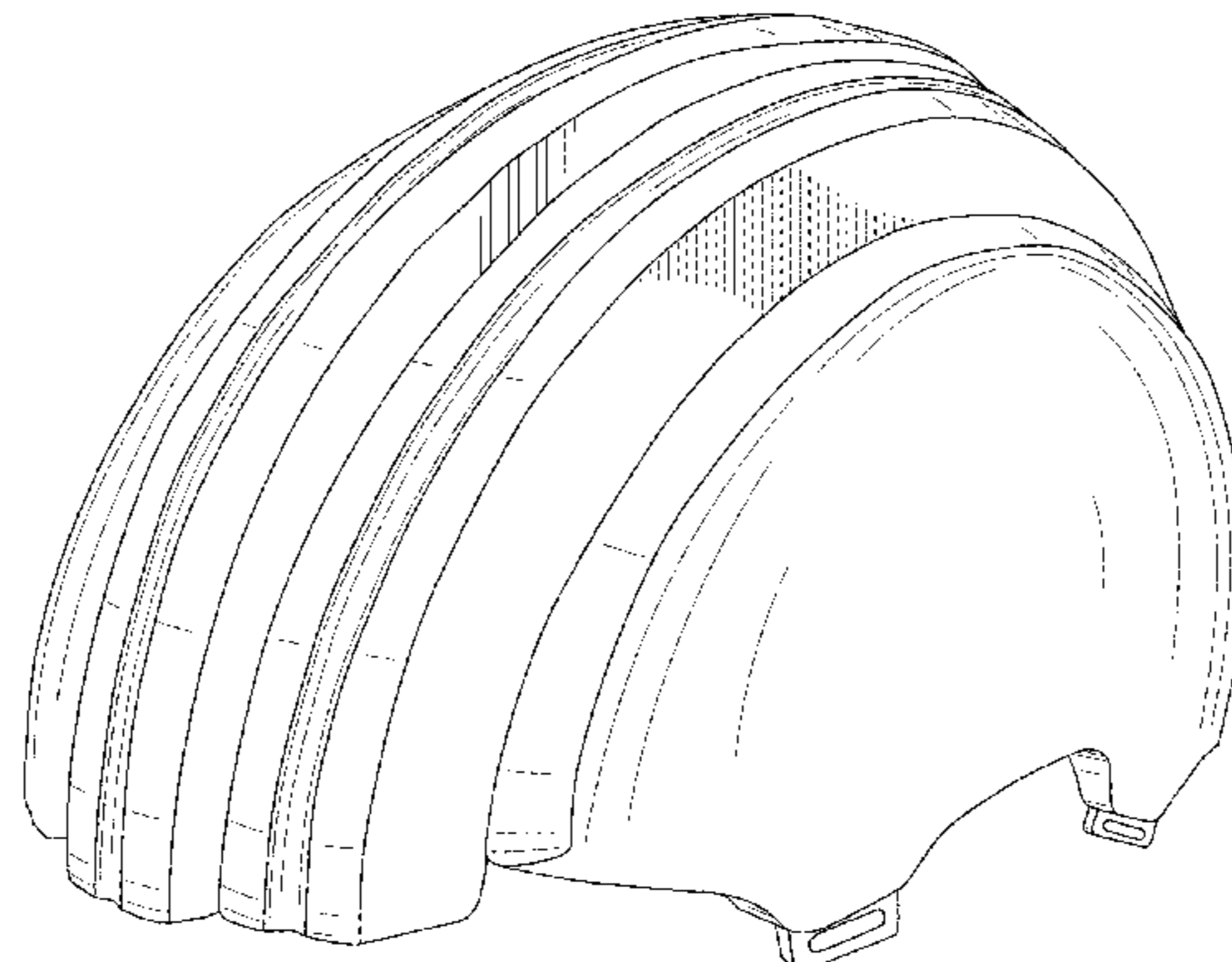
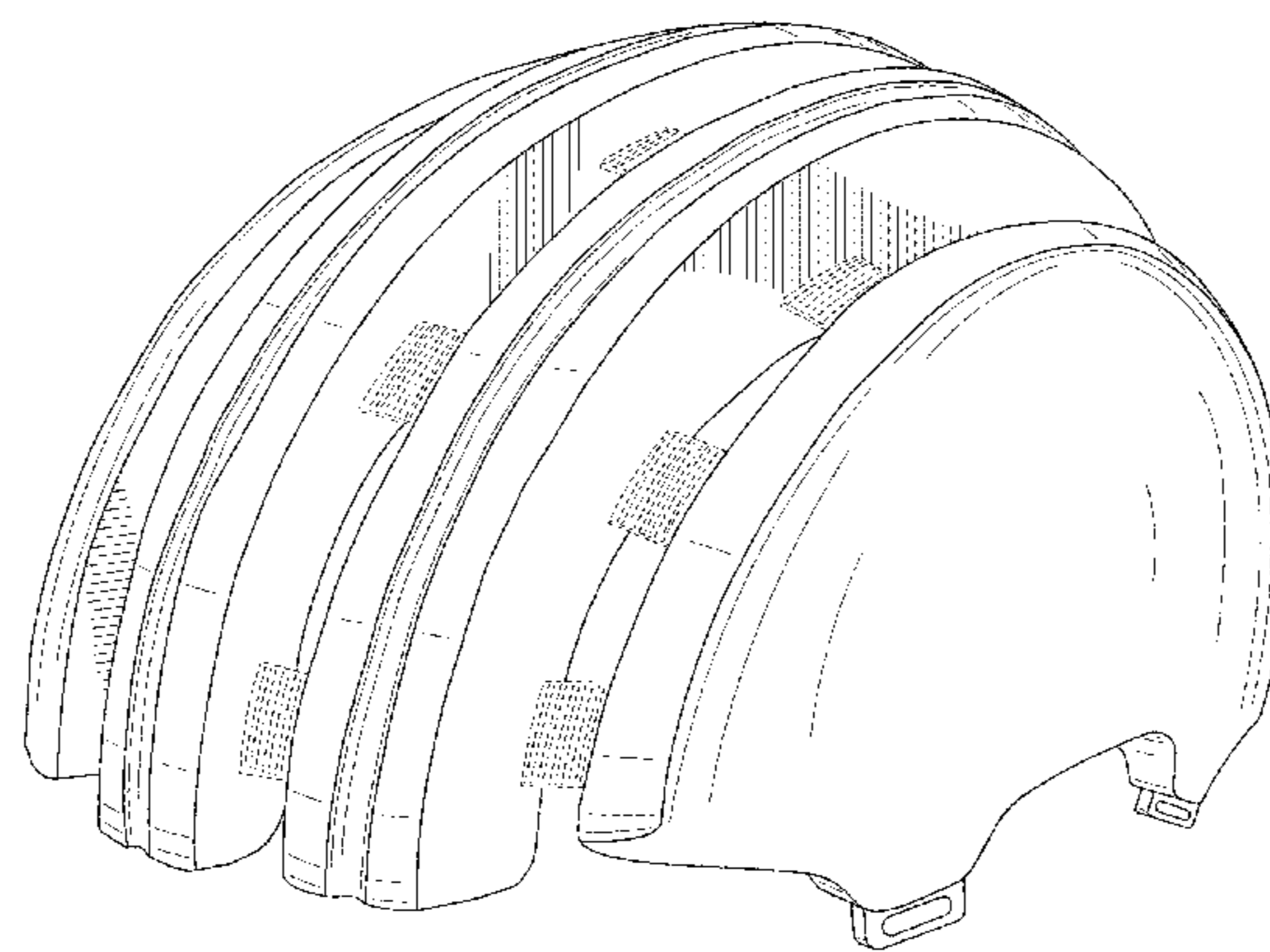

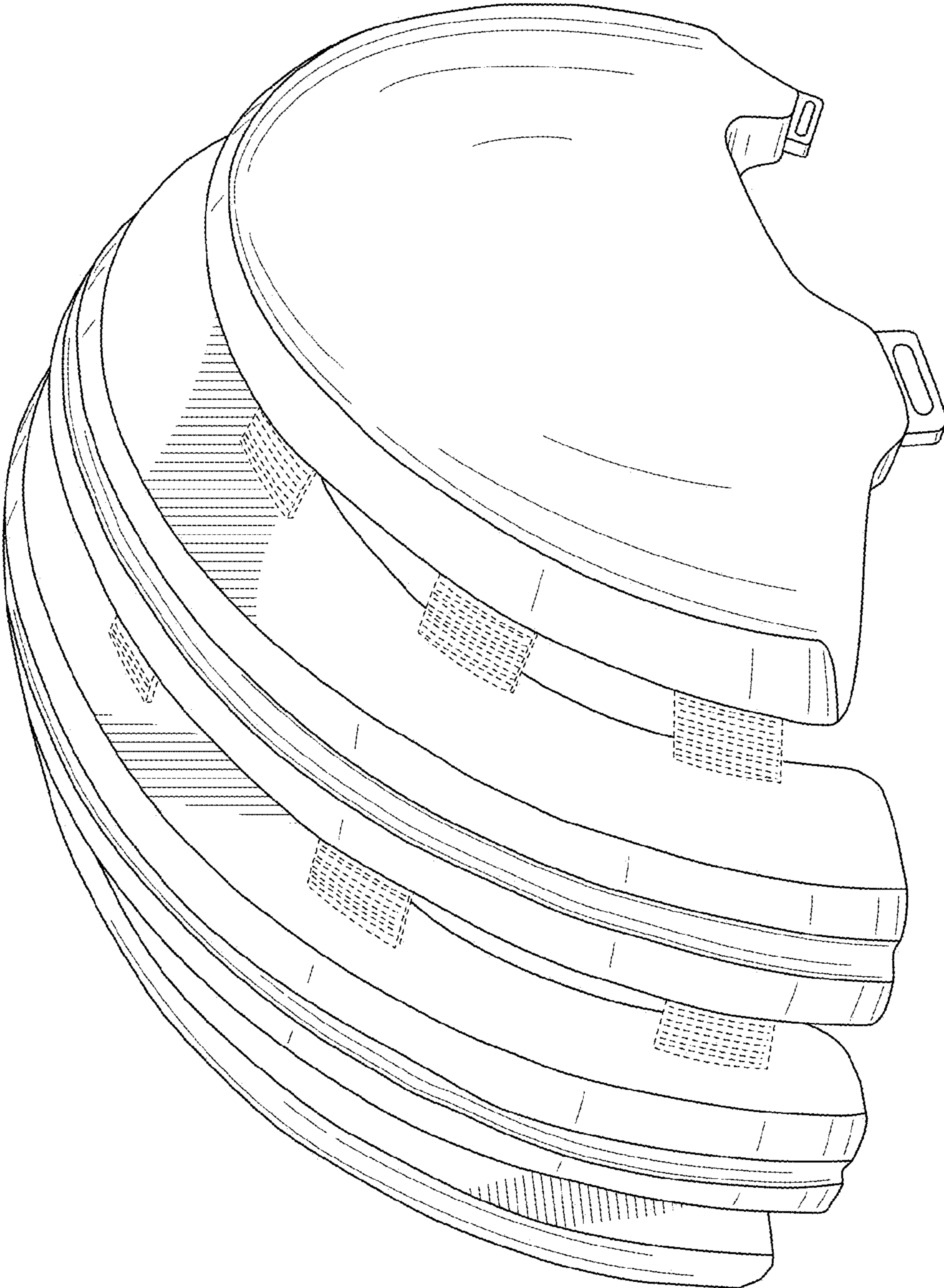

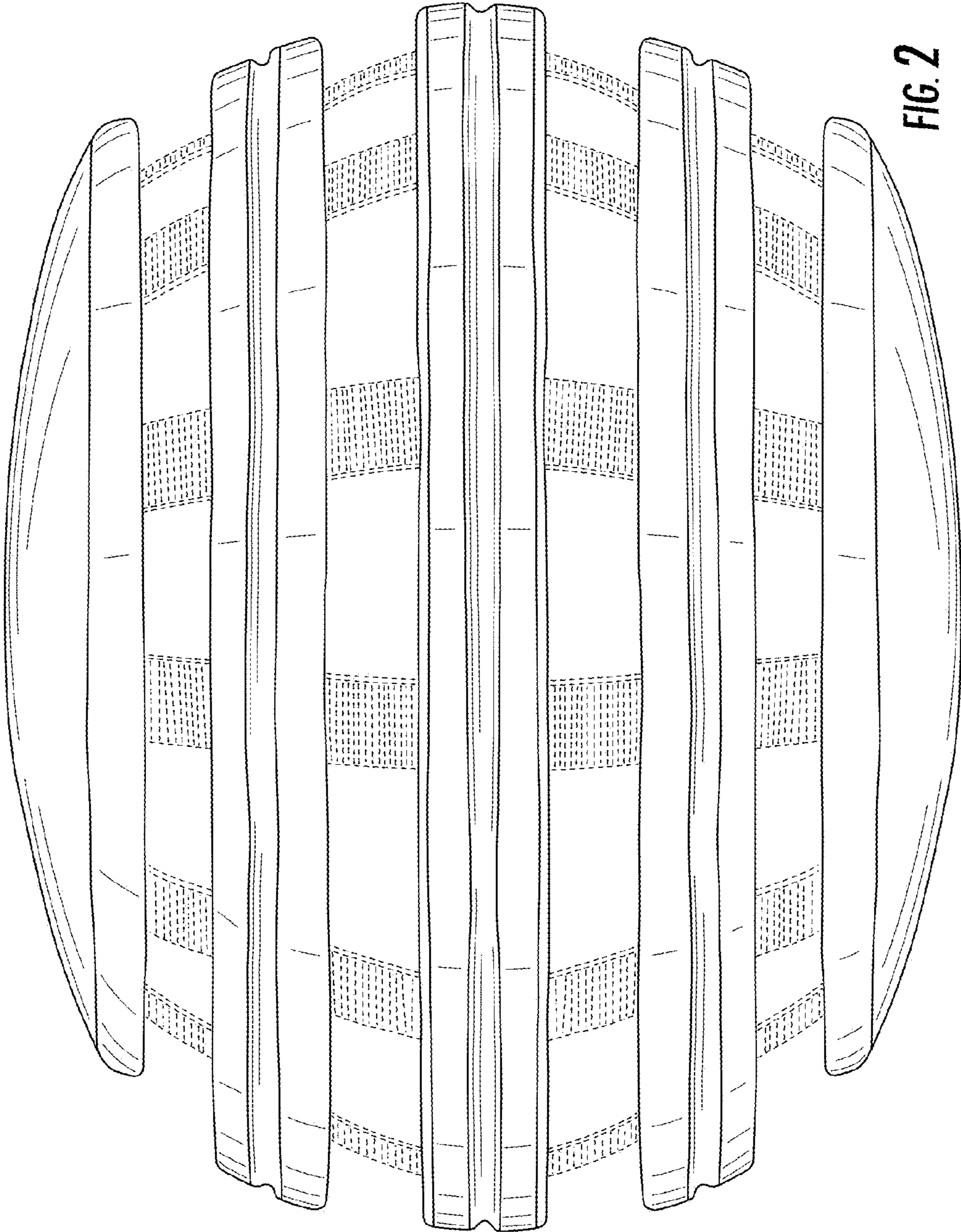

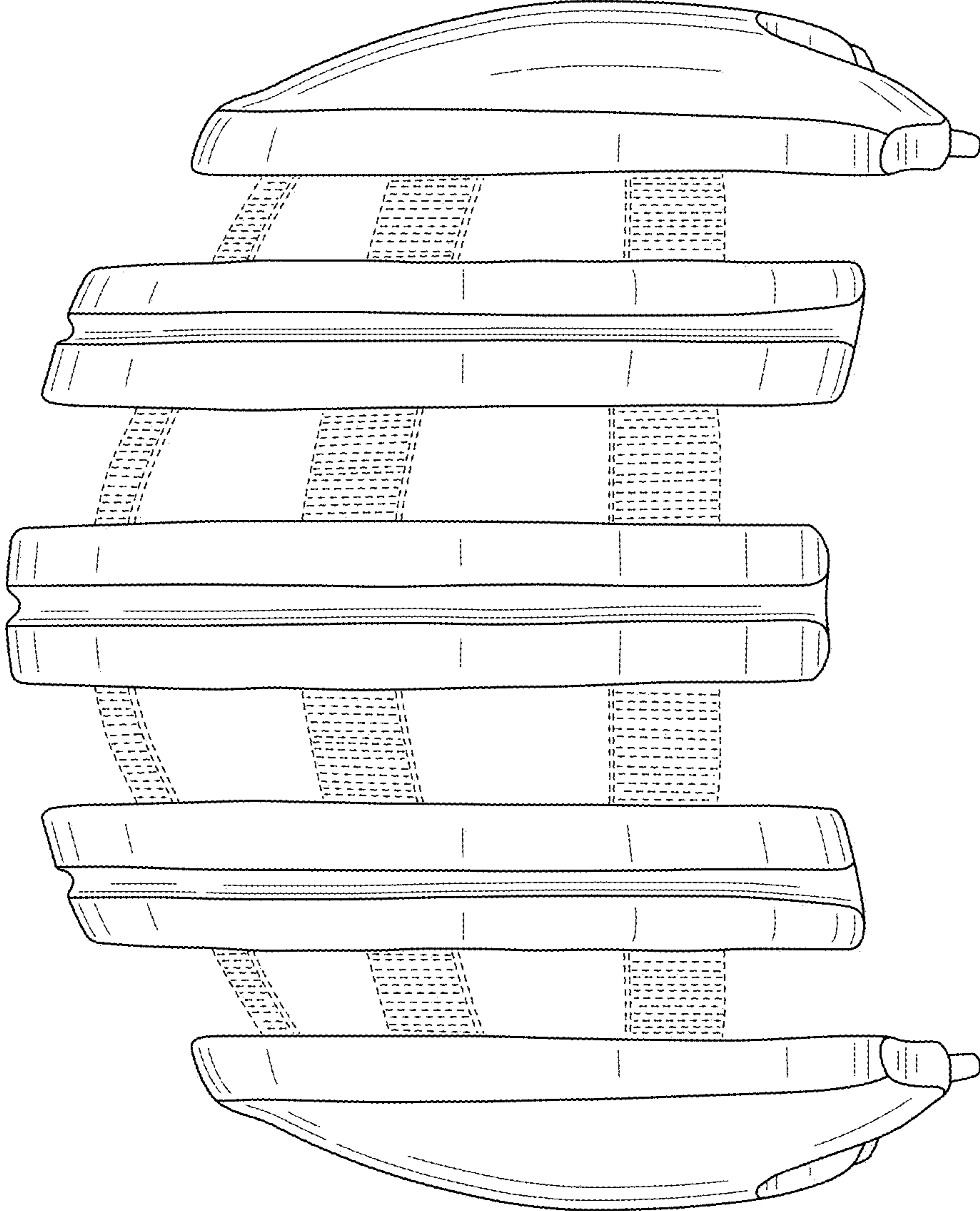

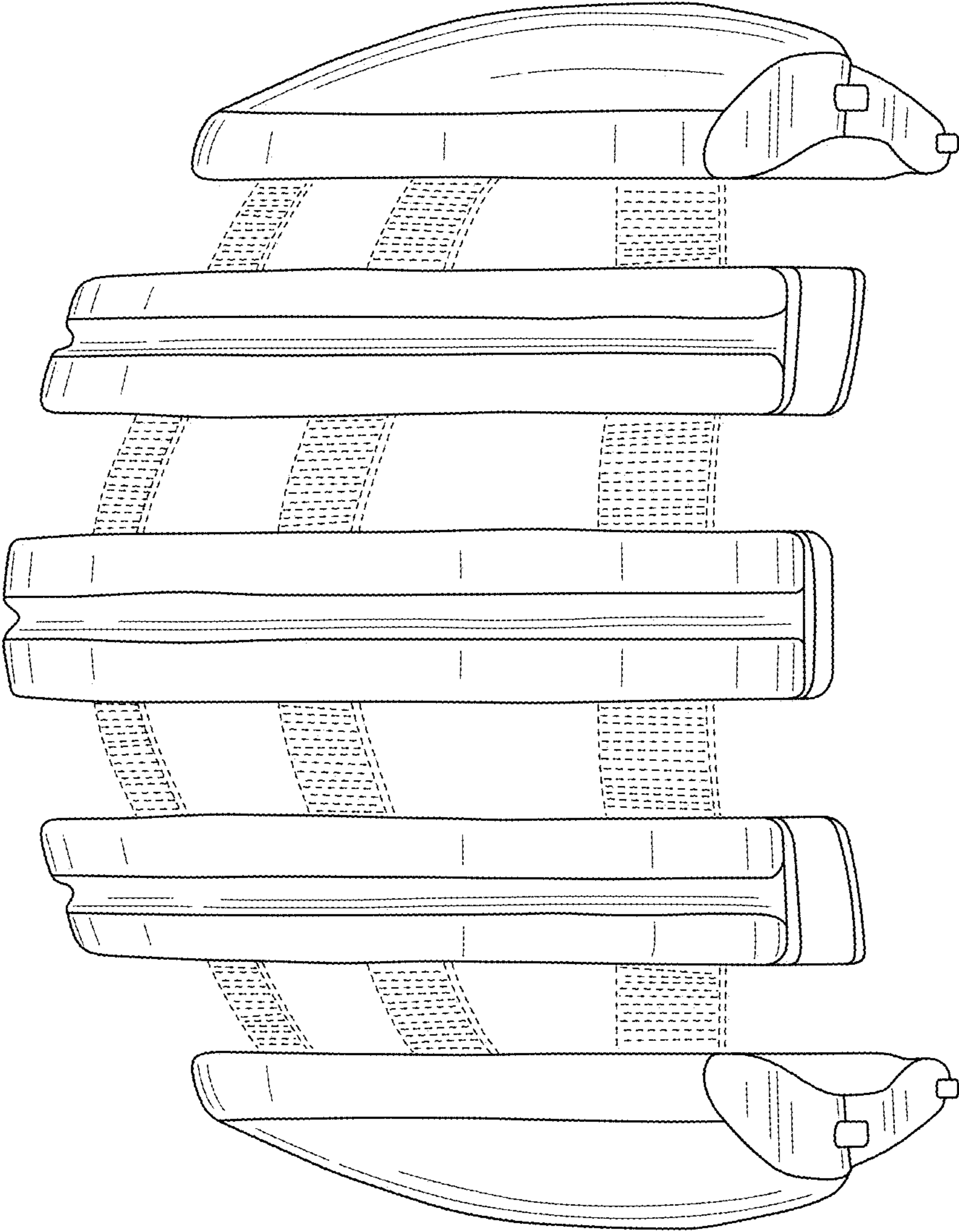

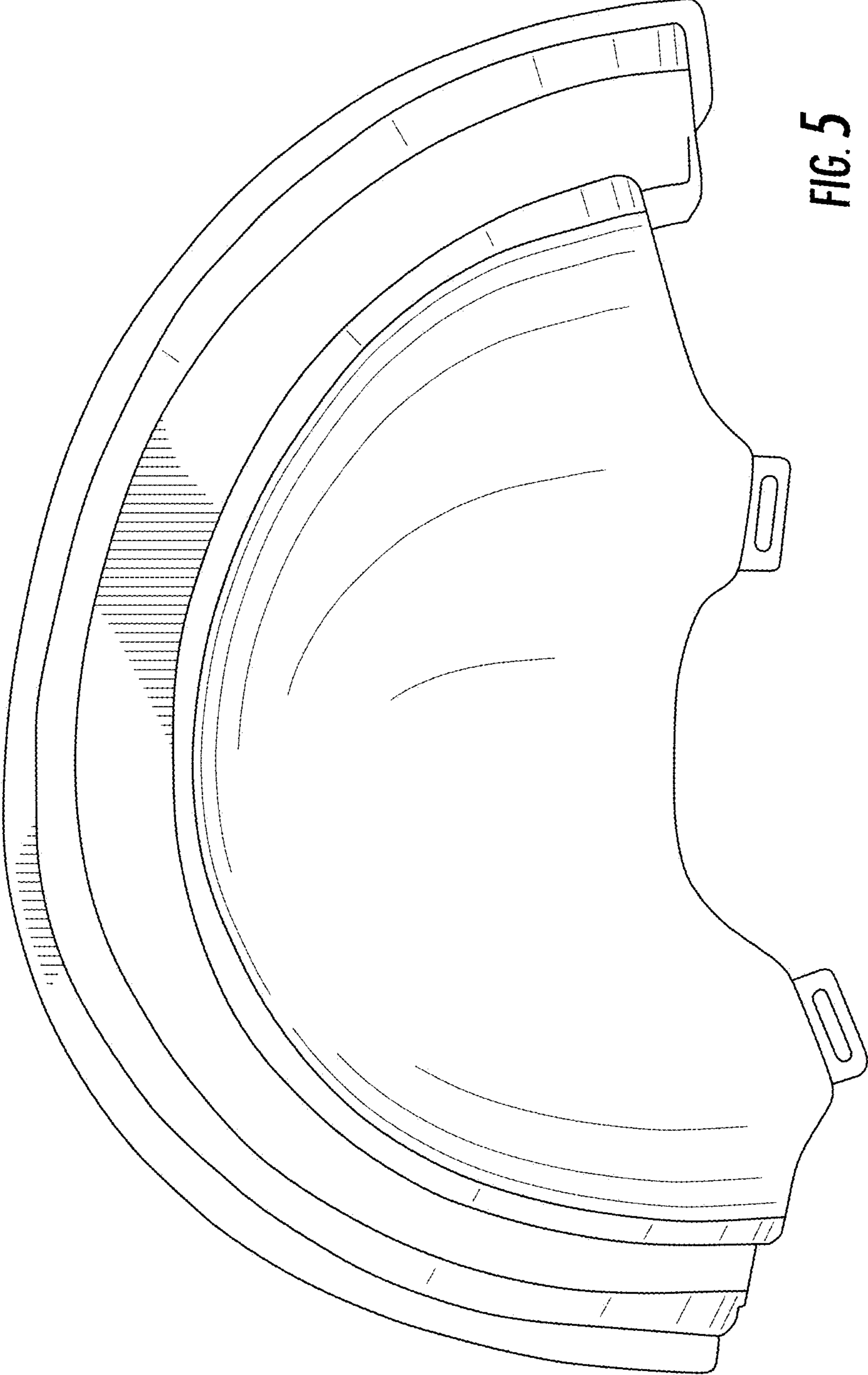

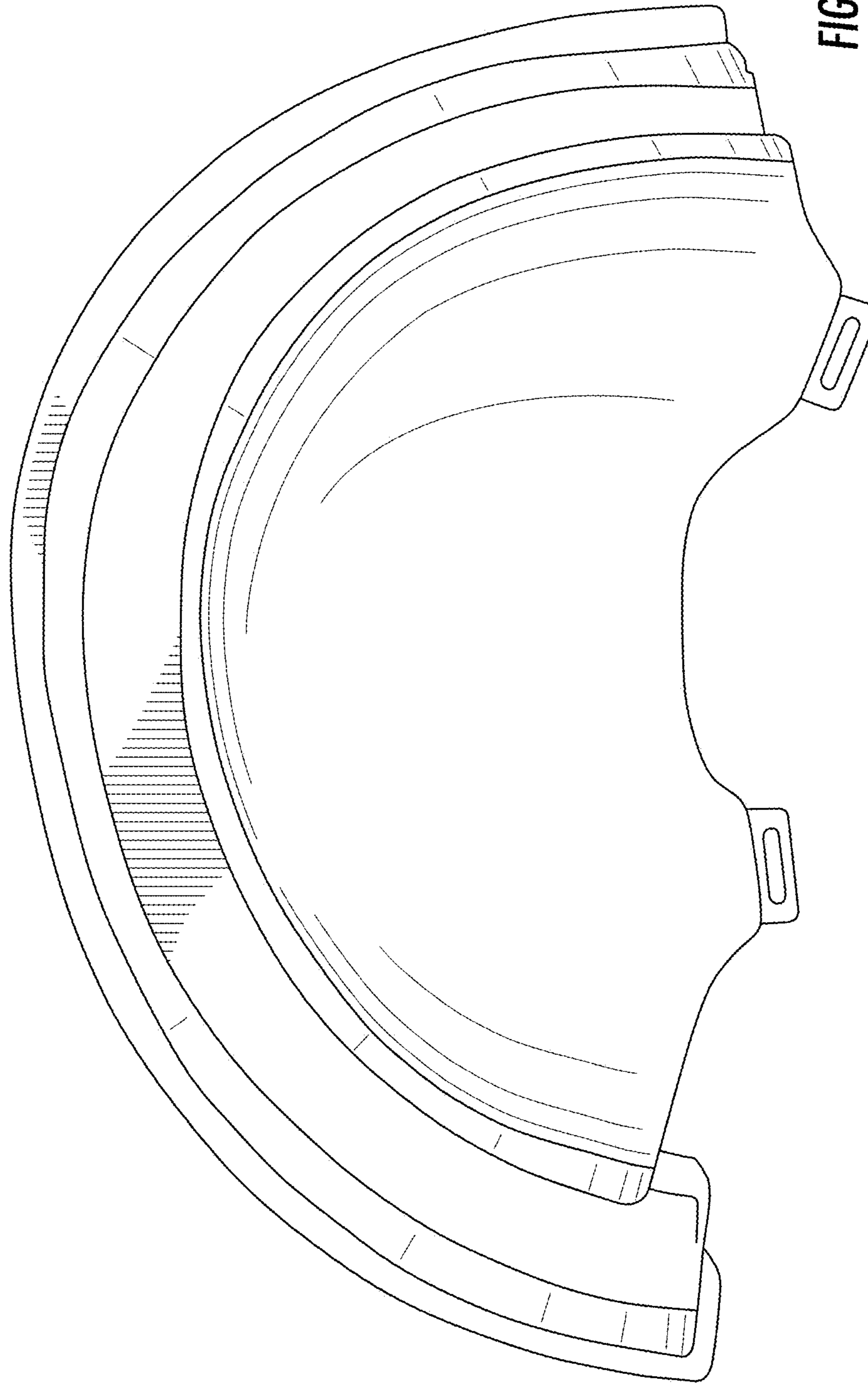

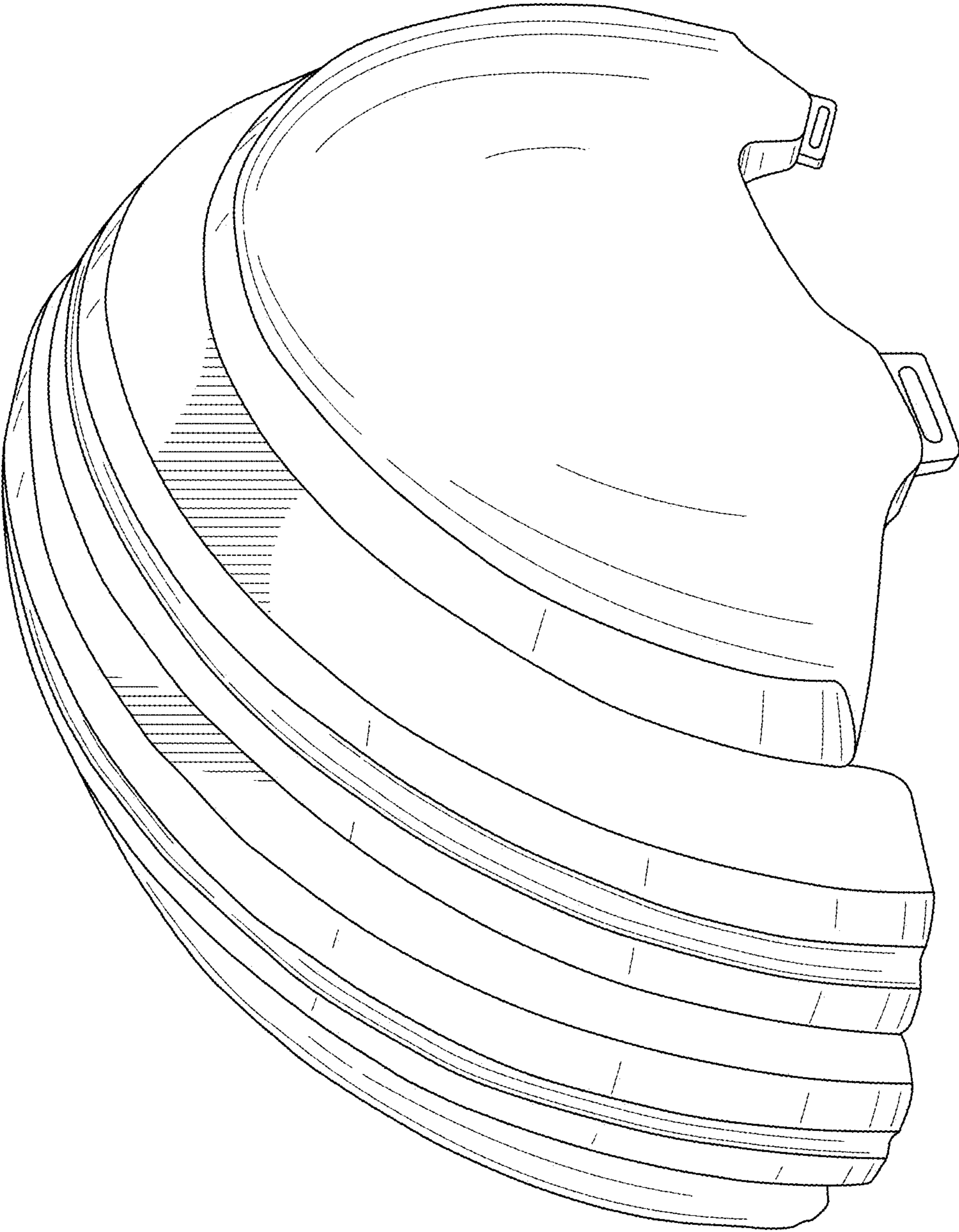

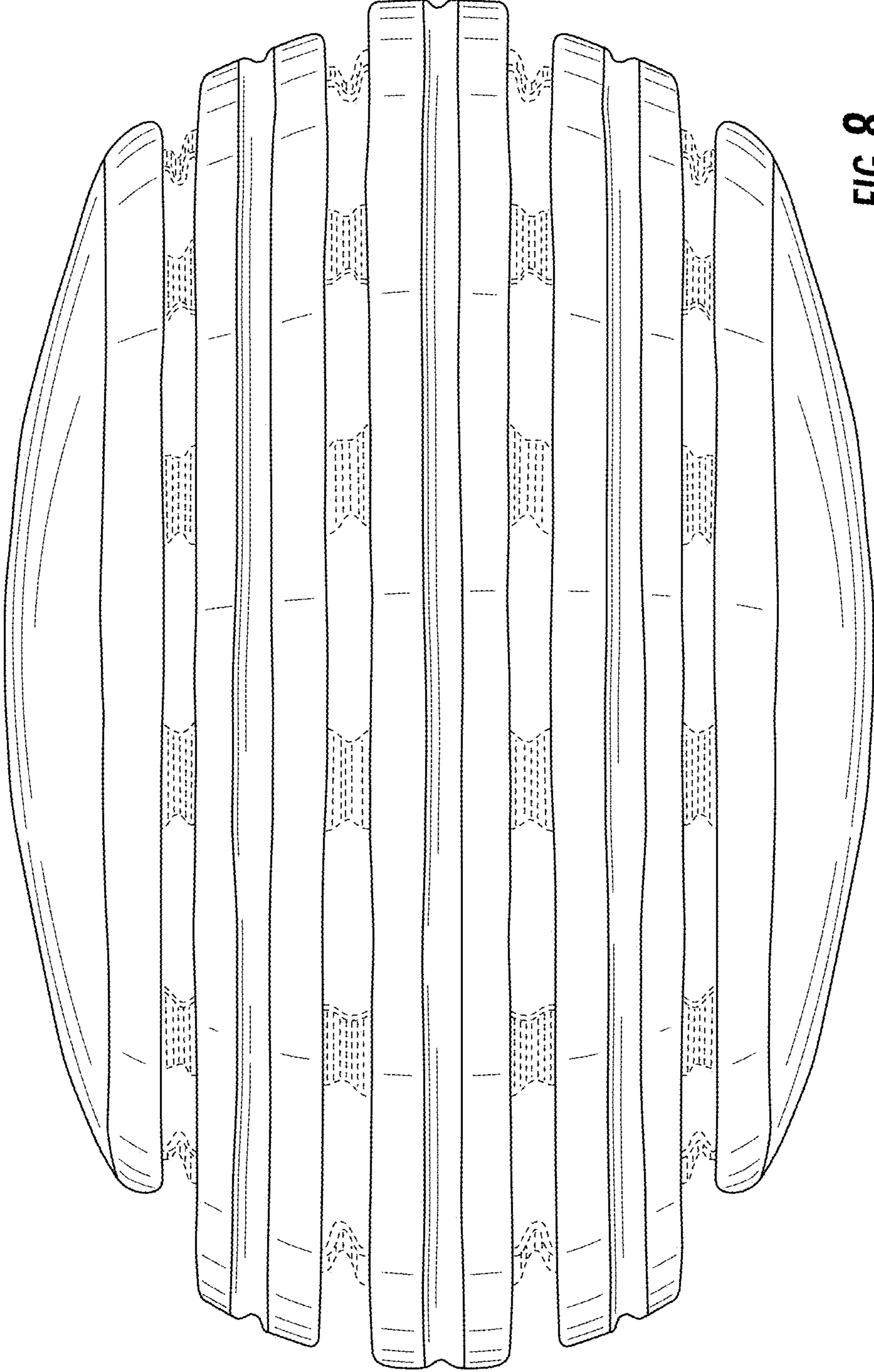

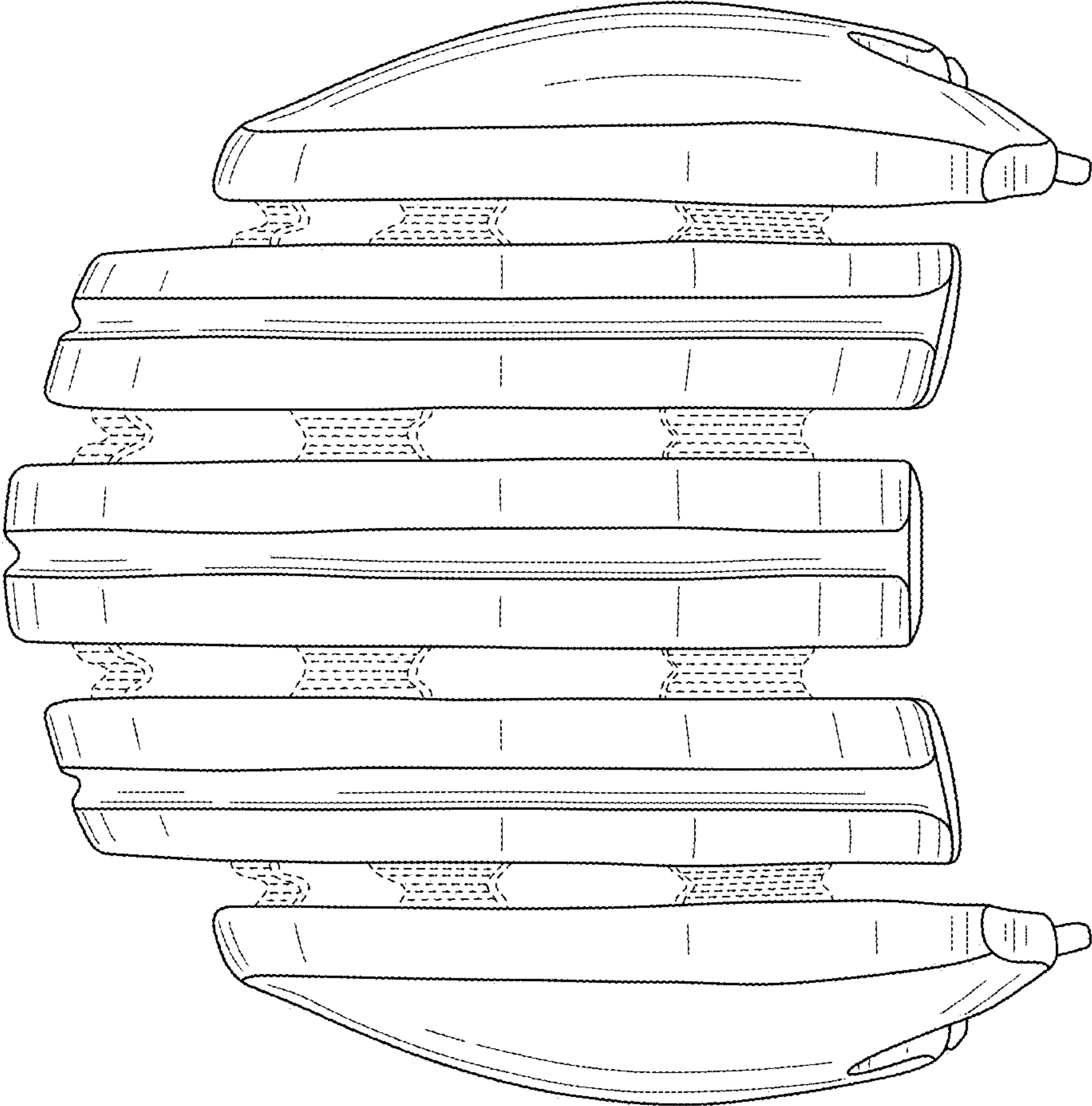

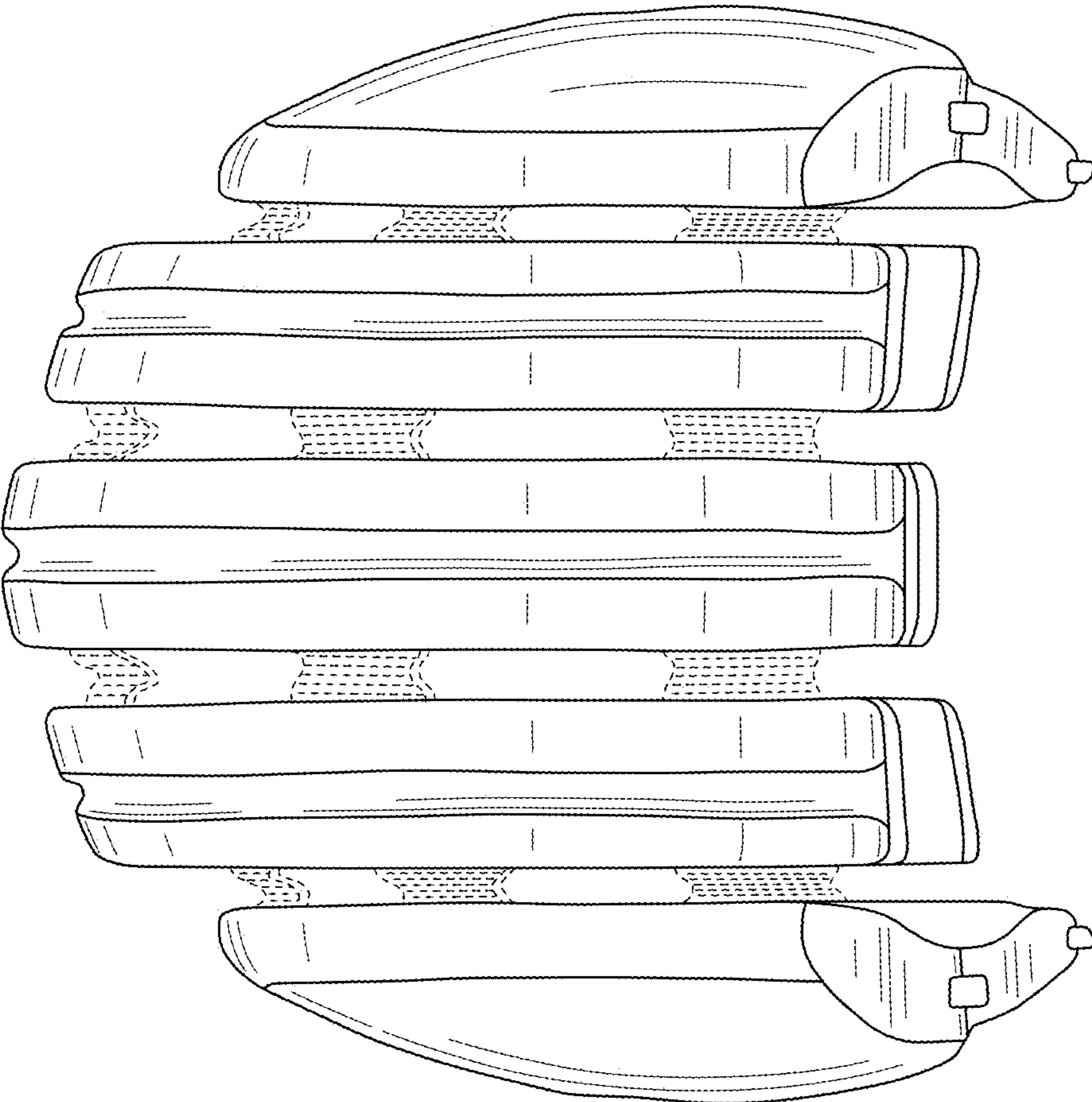

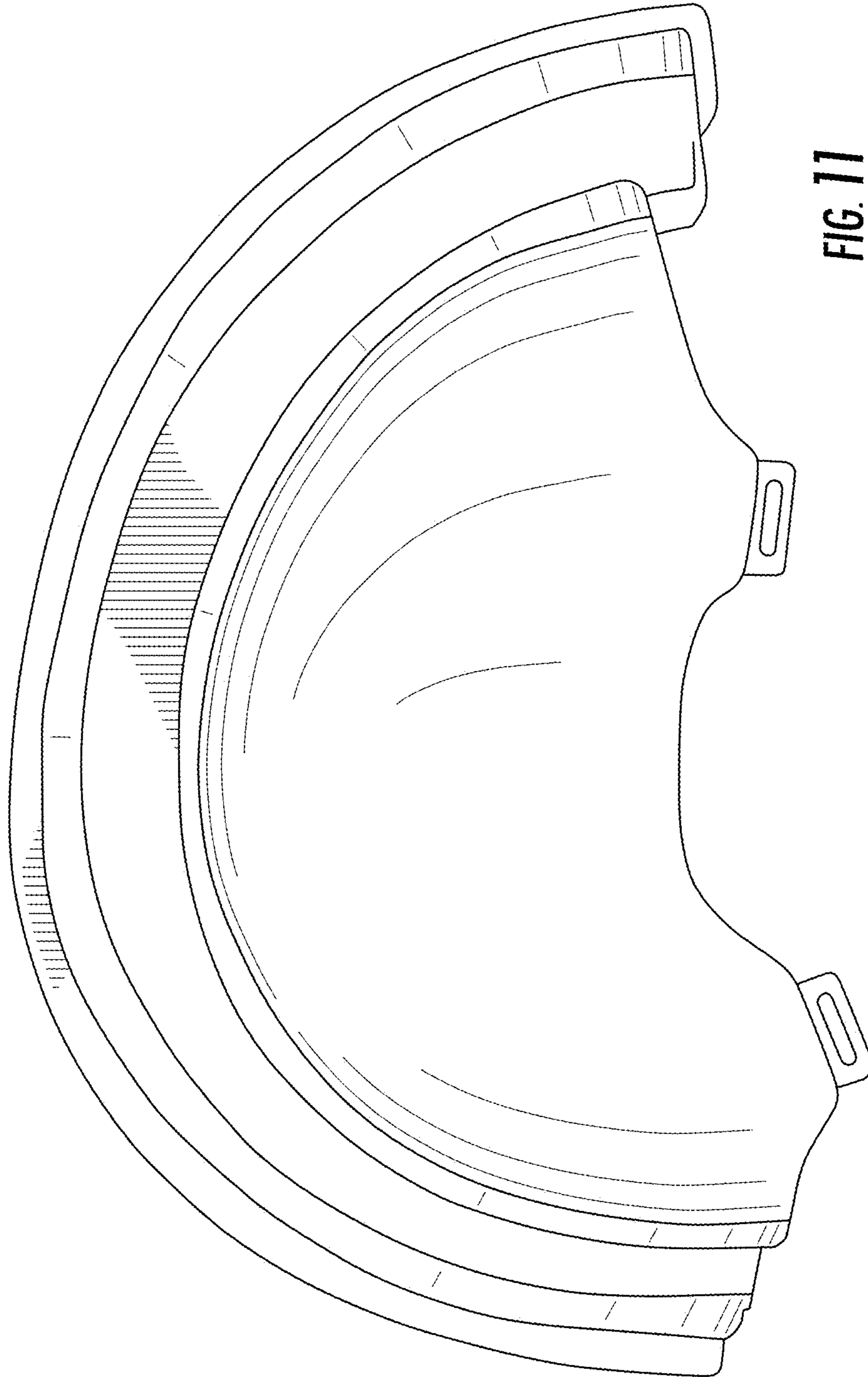

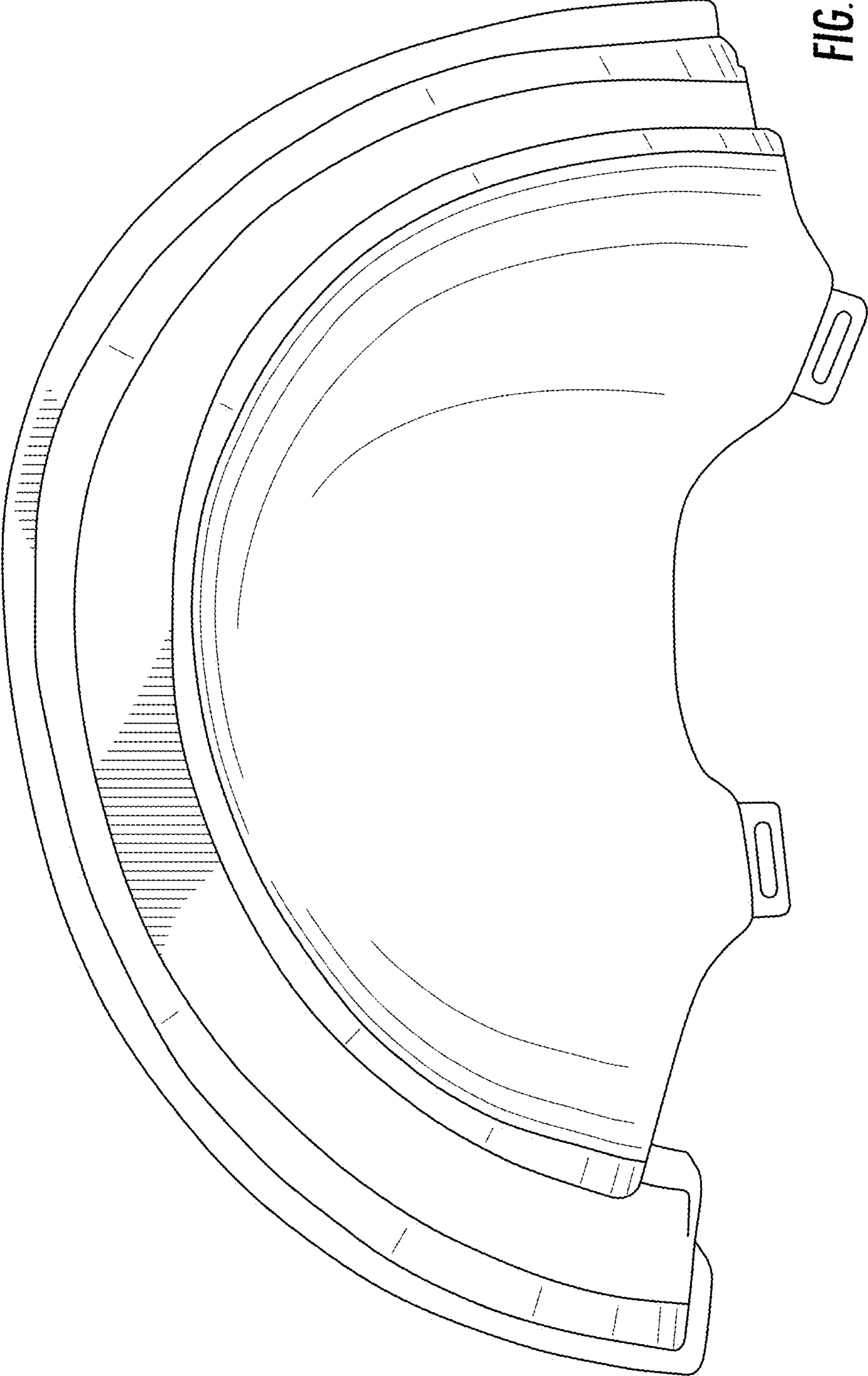
