DESCRIPTION

FIG. 1 is a front, right-hand side, top perspective view of a shoe comprising a new, original and ornamental design;

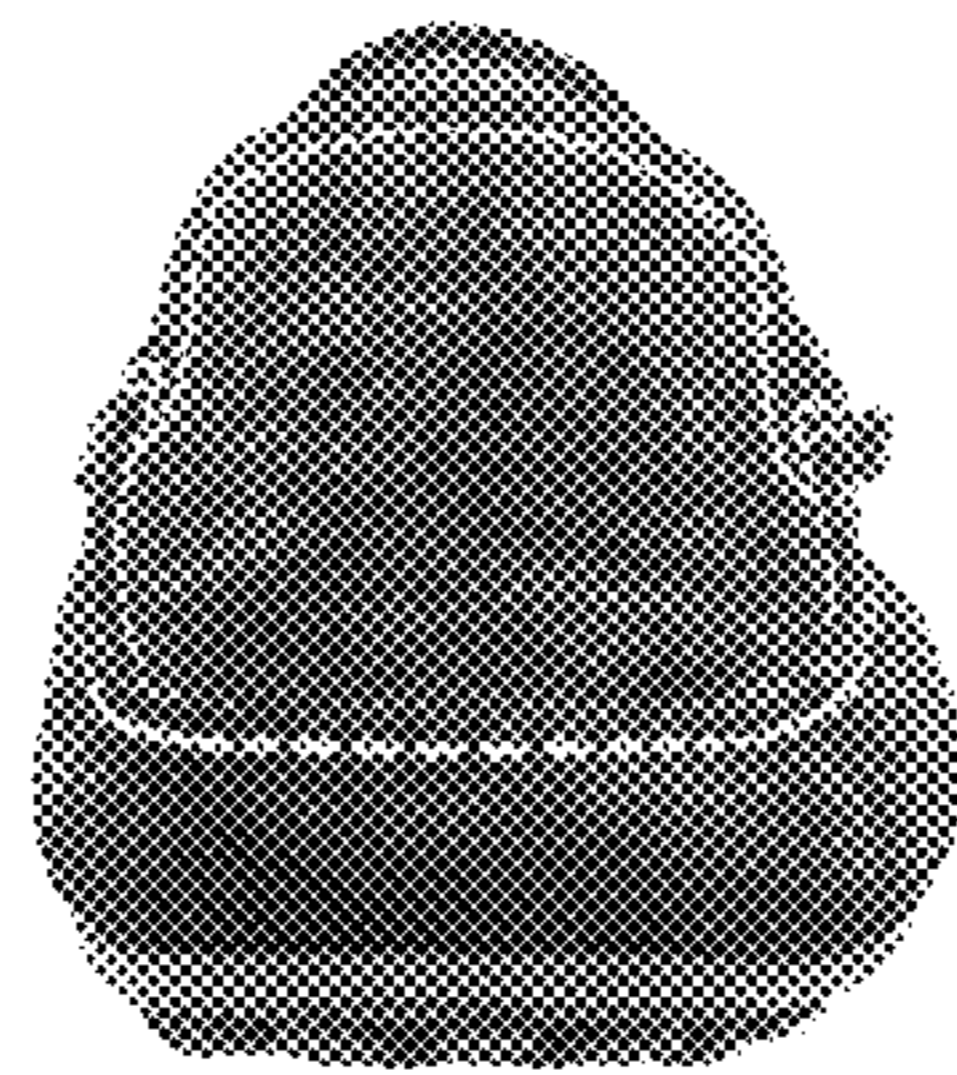

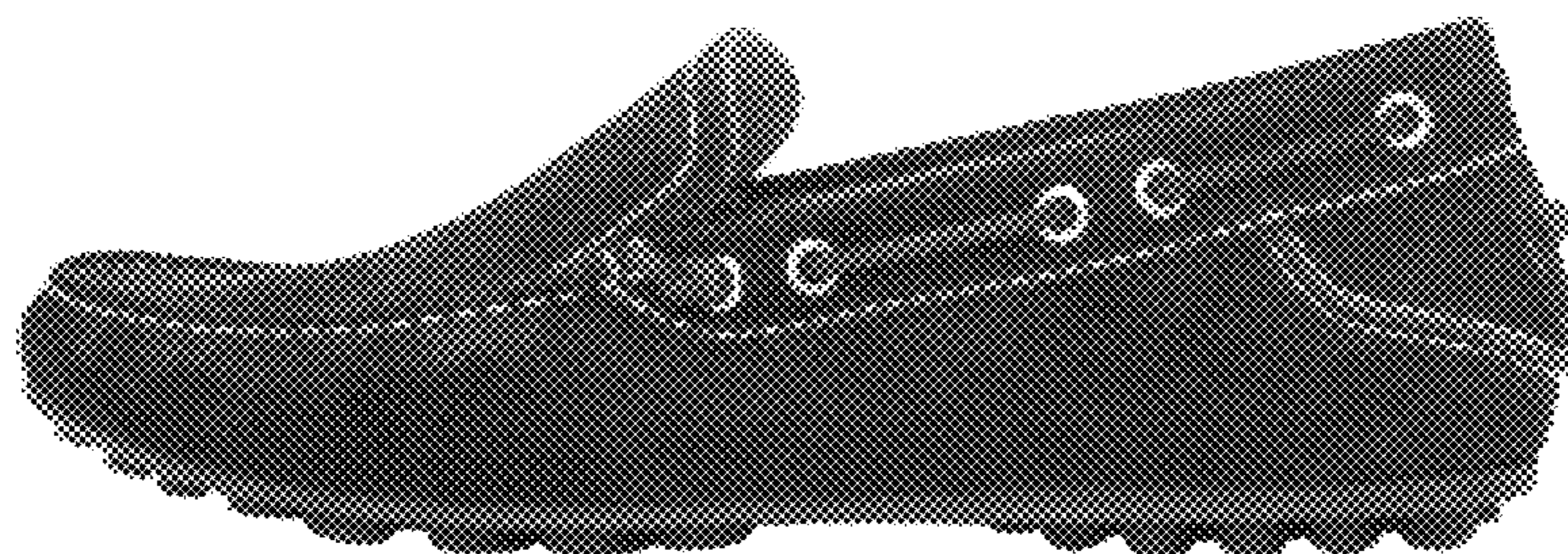

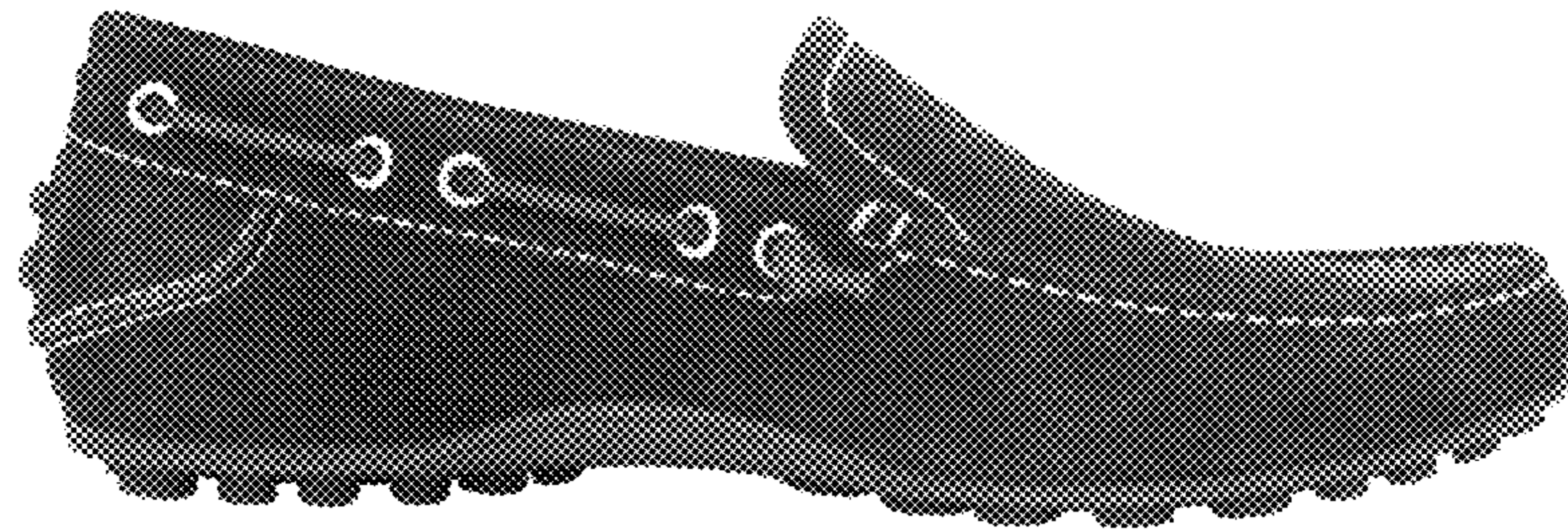

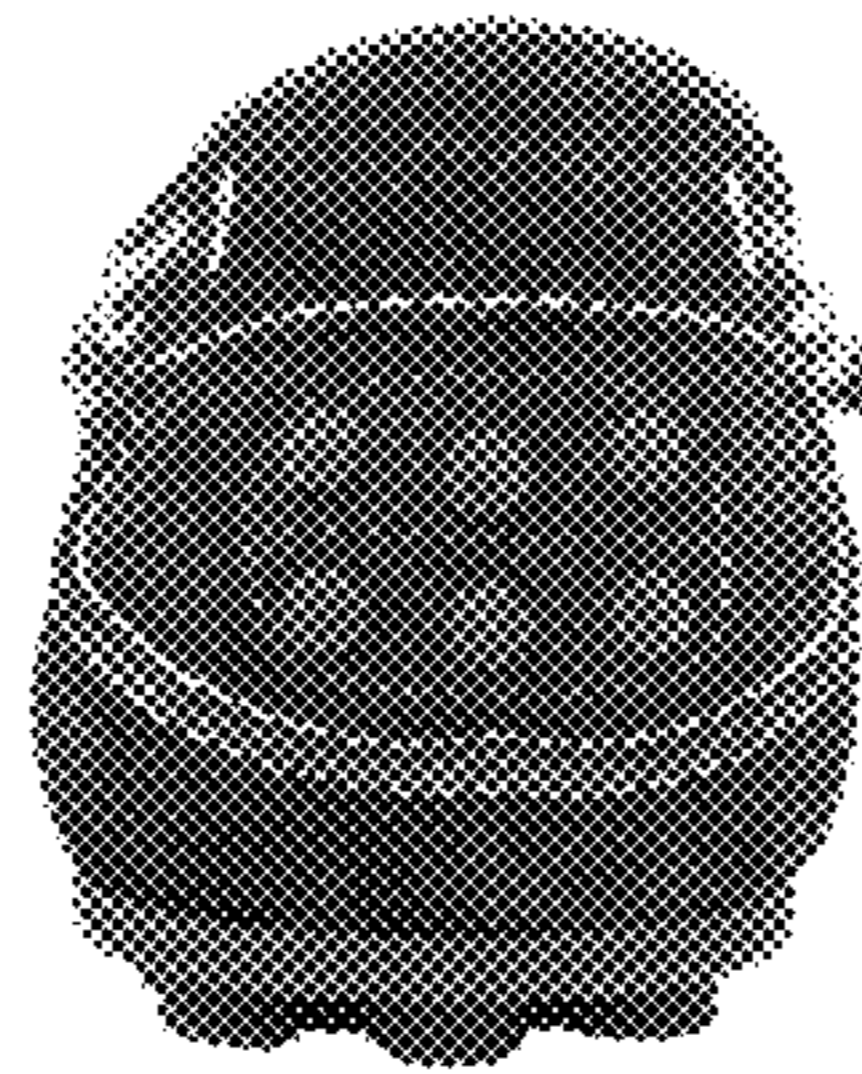

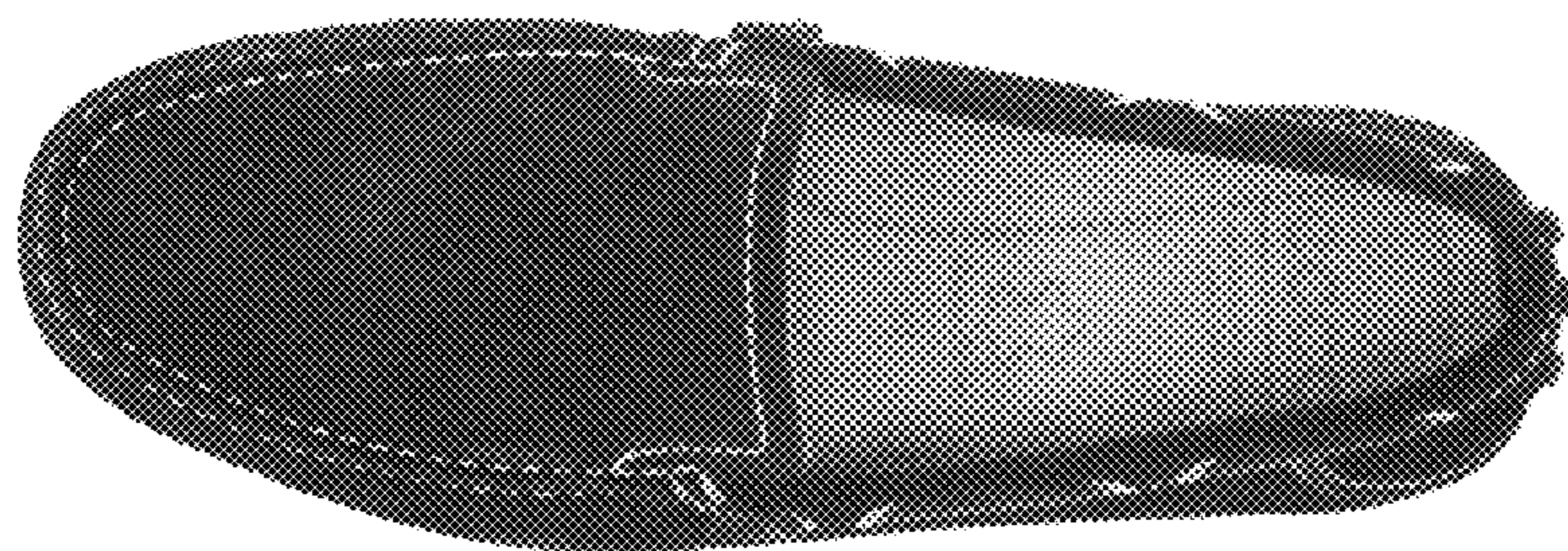

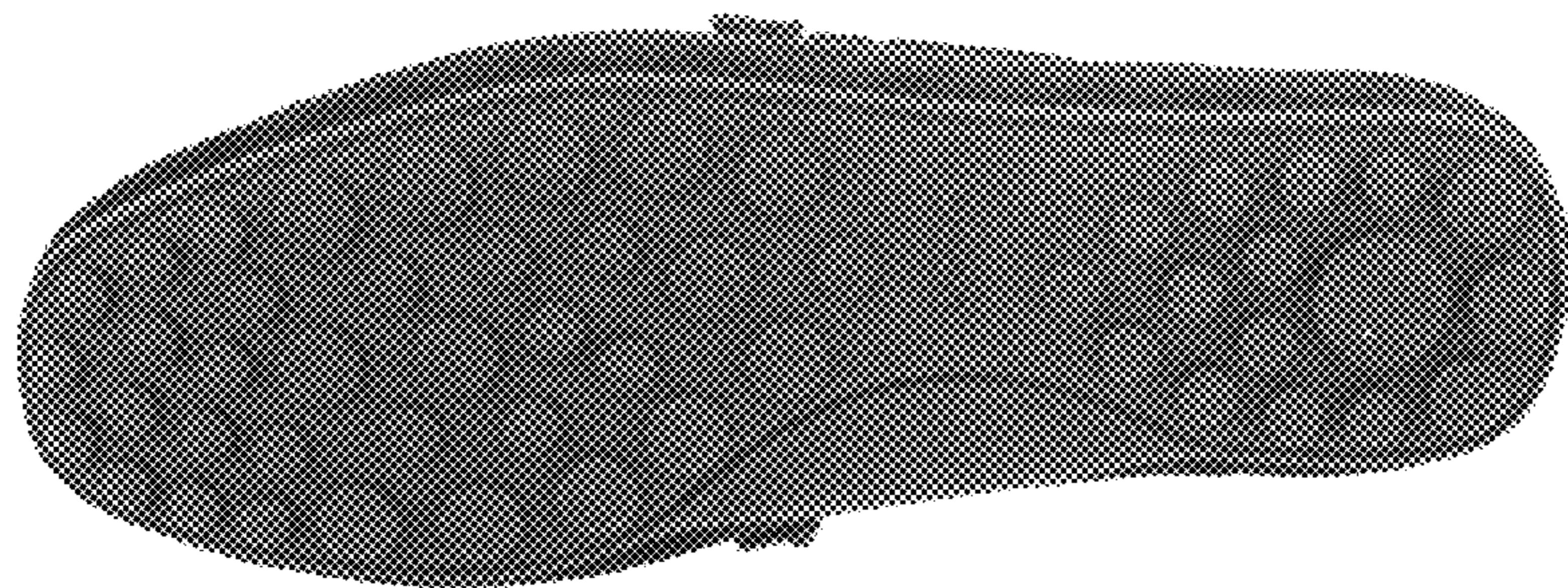
