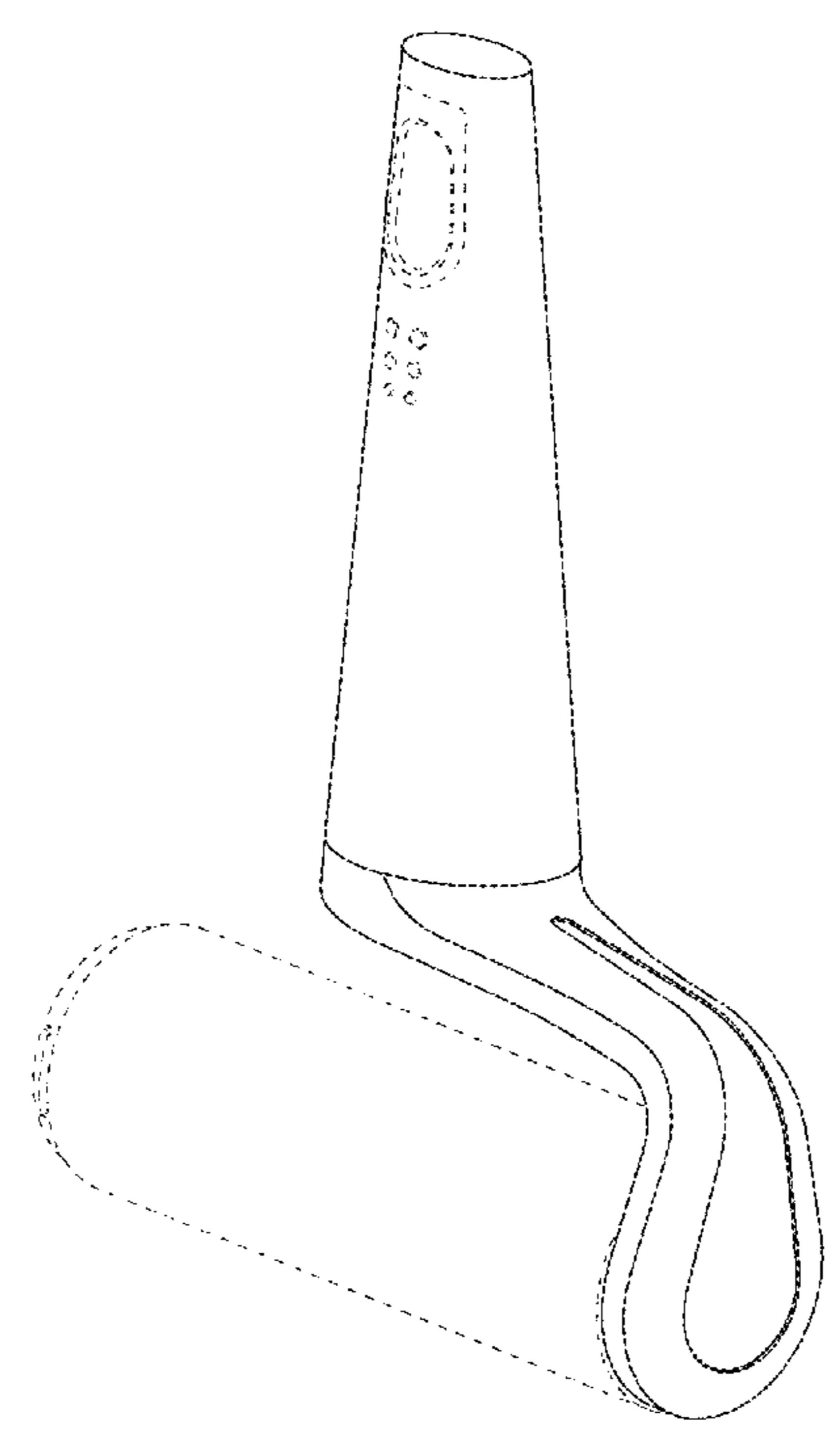
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view showing the new design for a lint roller;

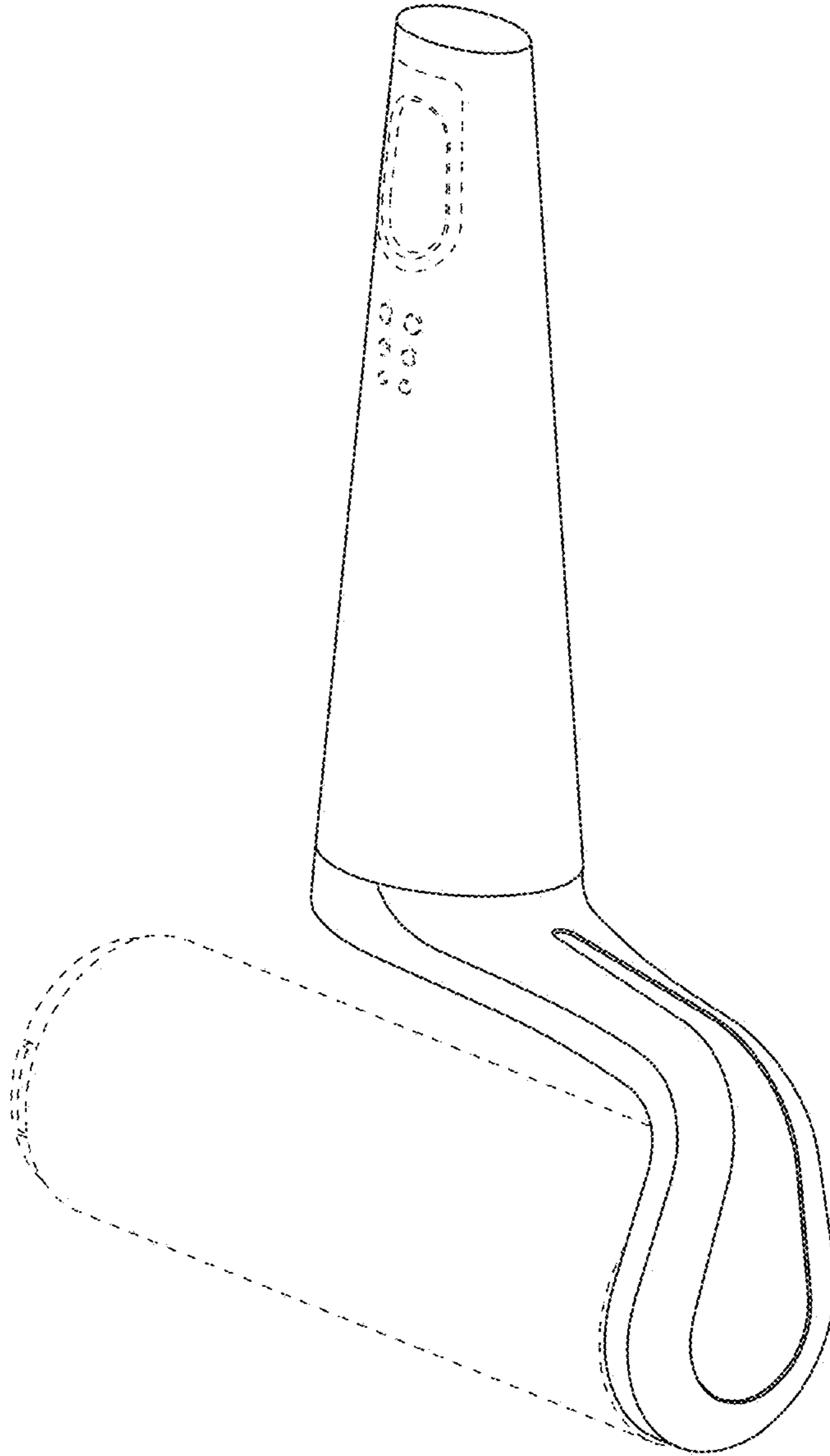

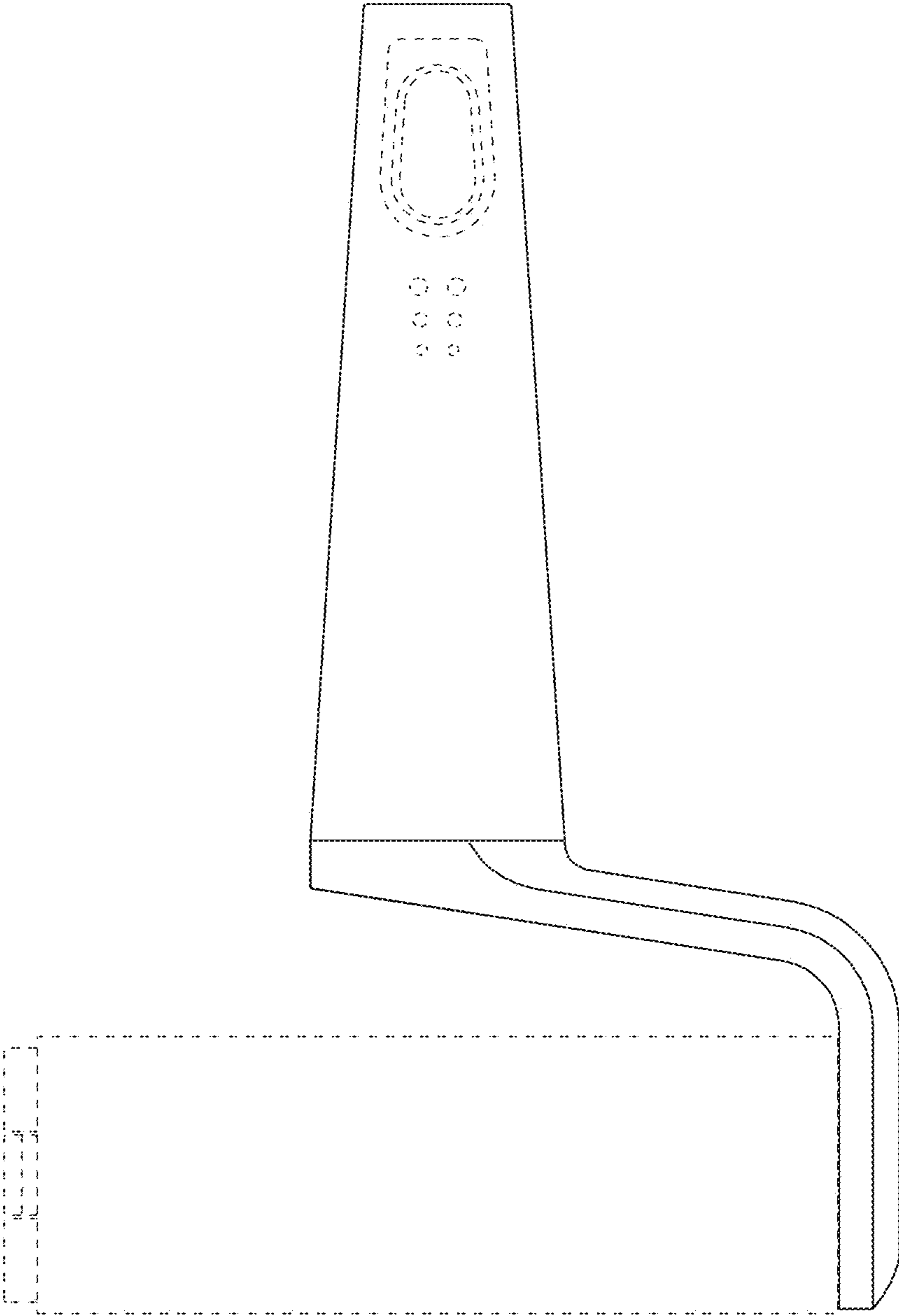

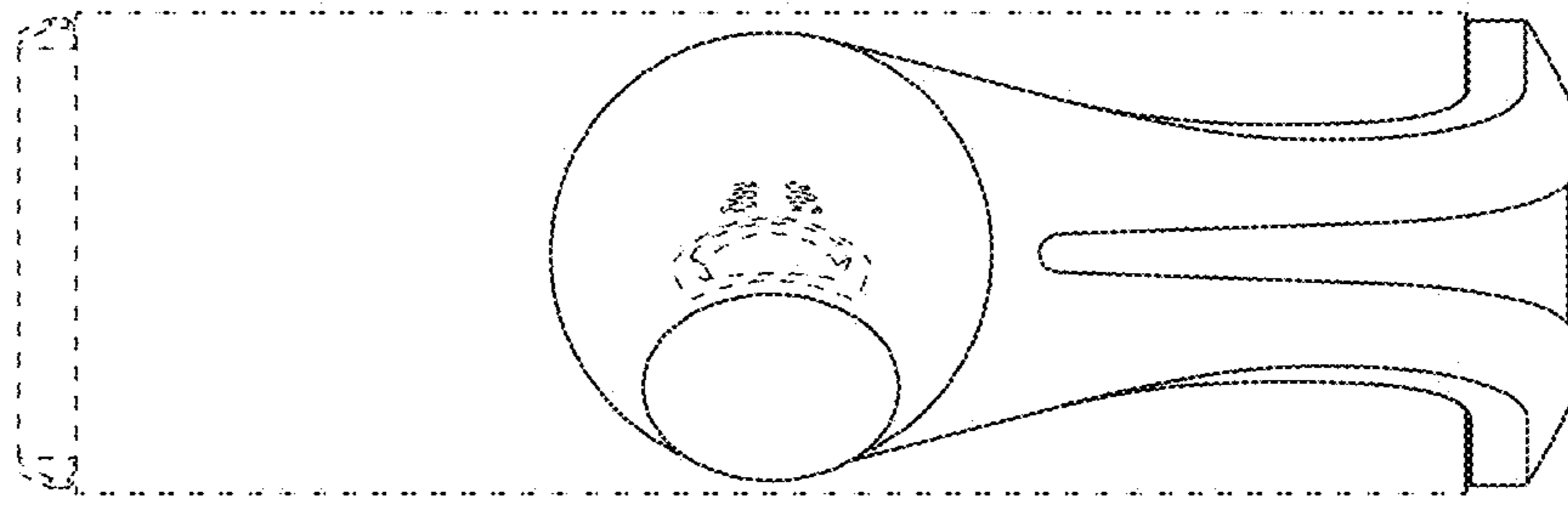

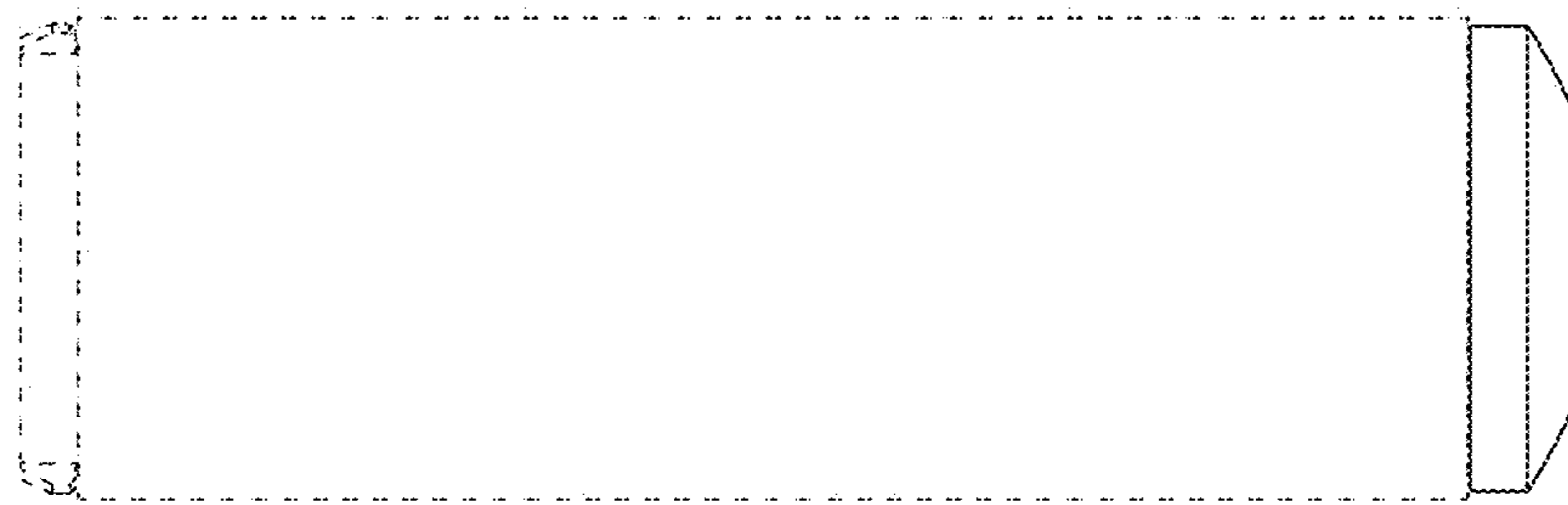

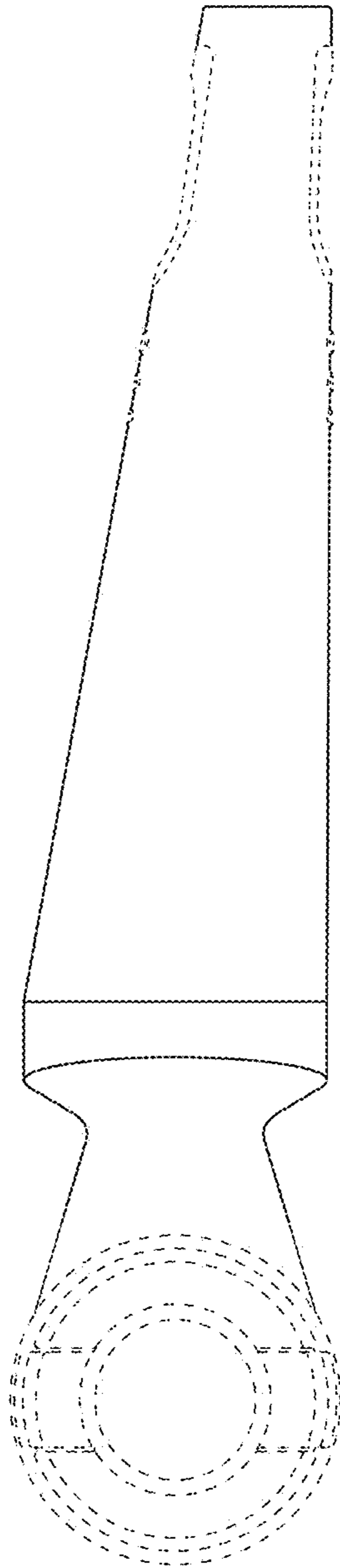

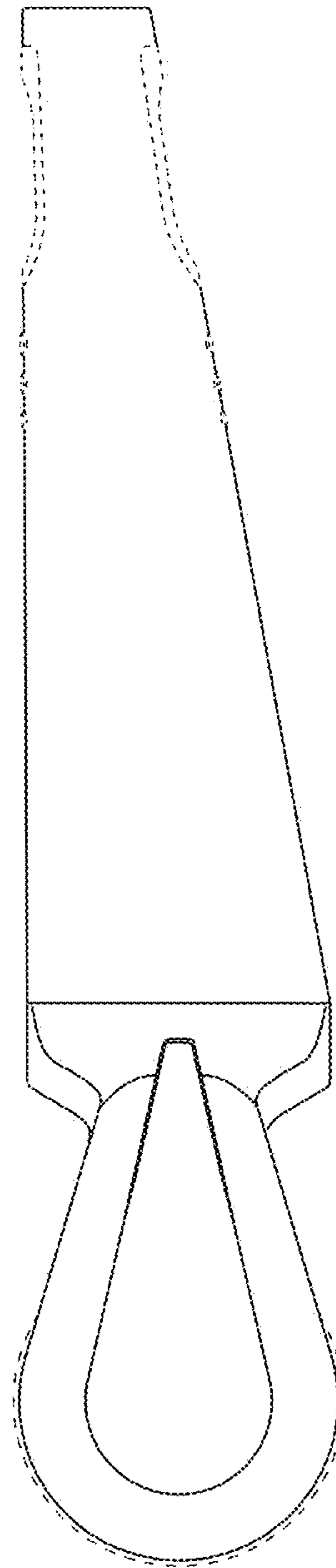

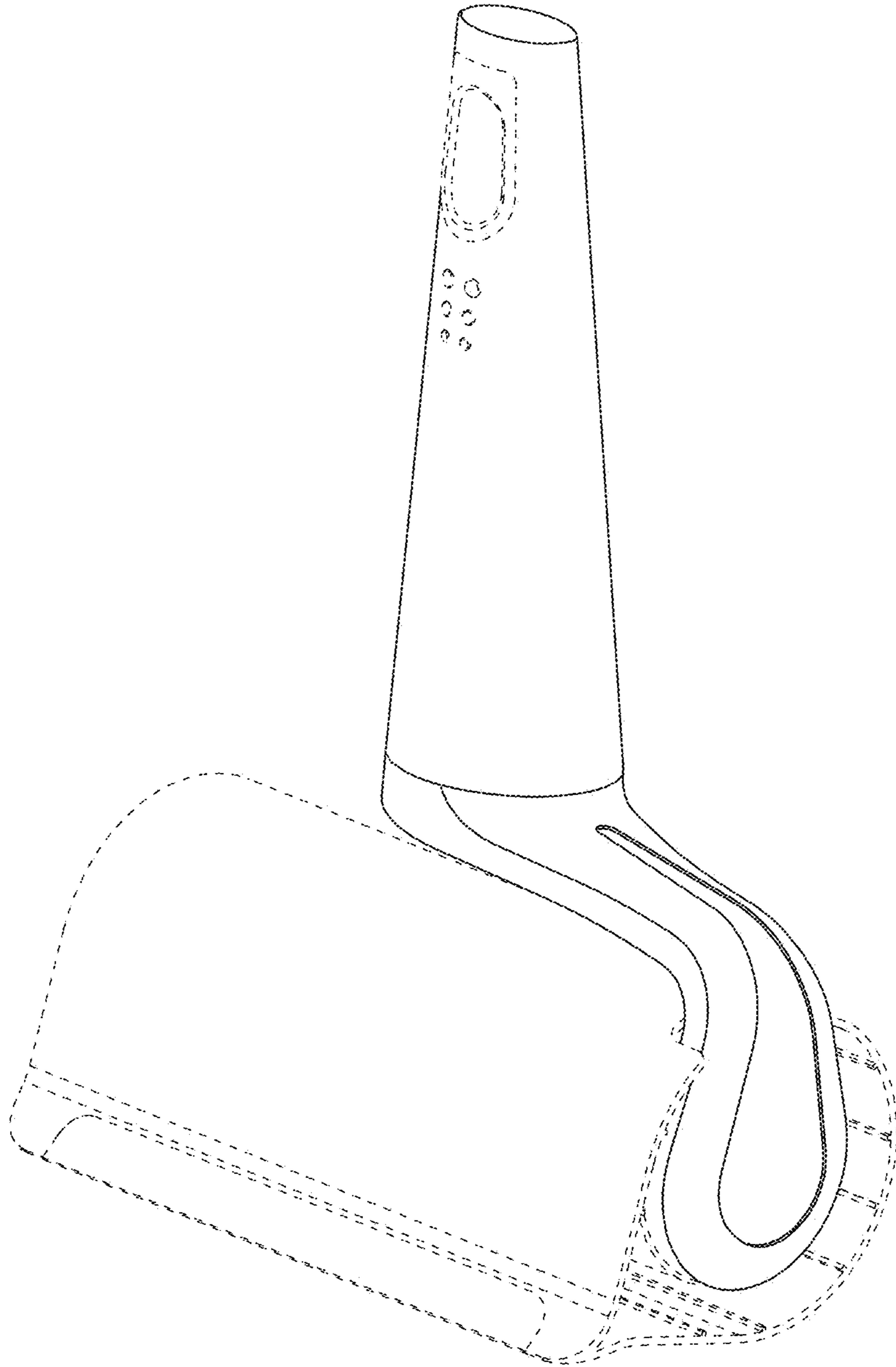
