mirror image thereof.

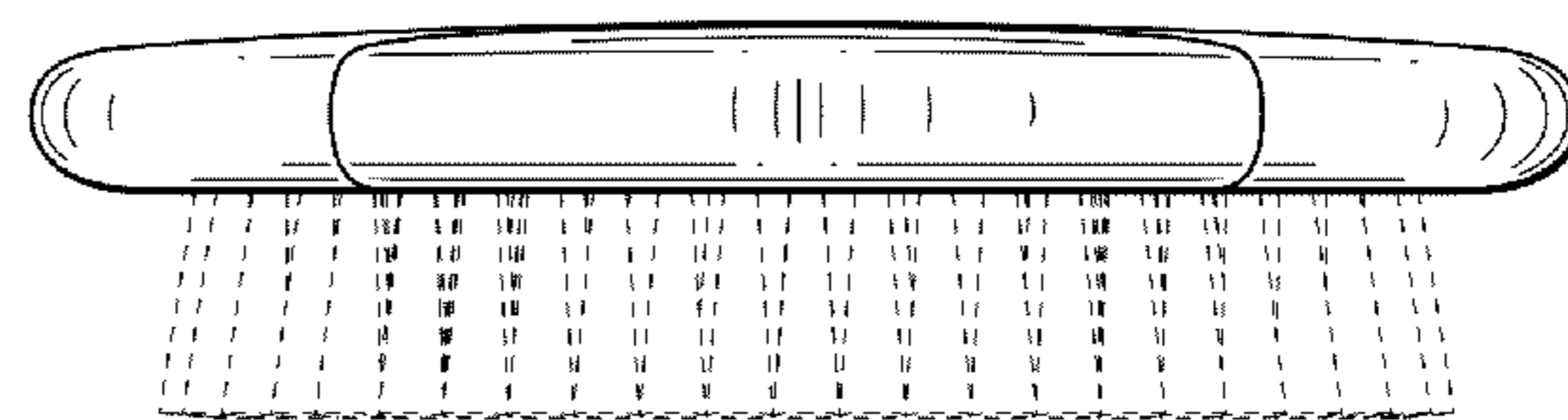
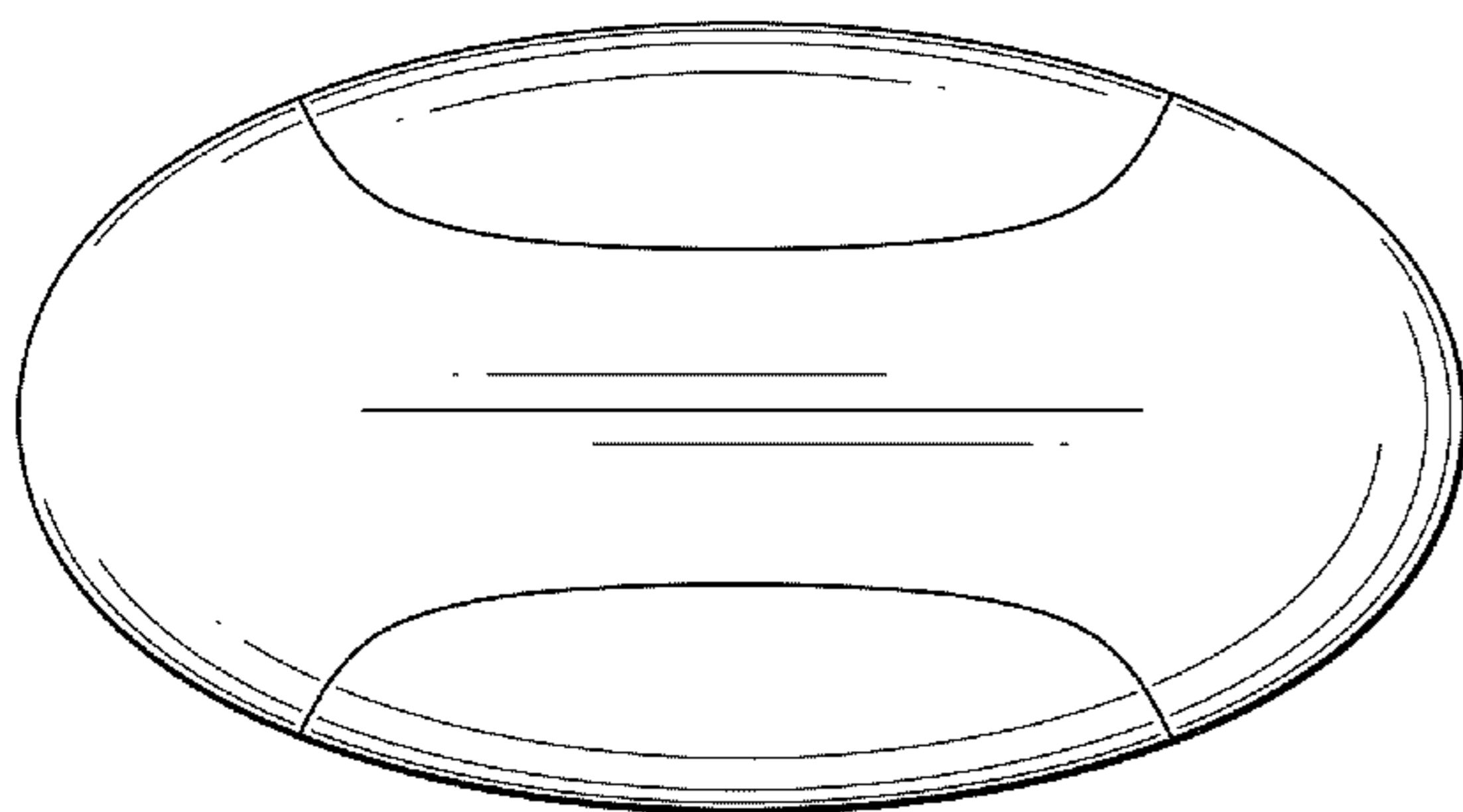
The broken lines showing bristle tufts illustrate portions of

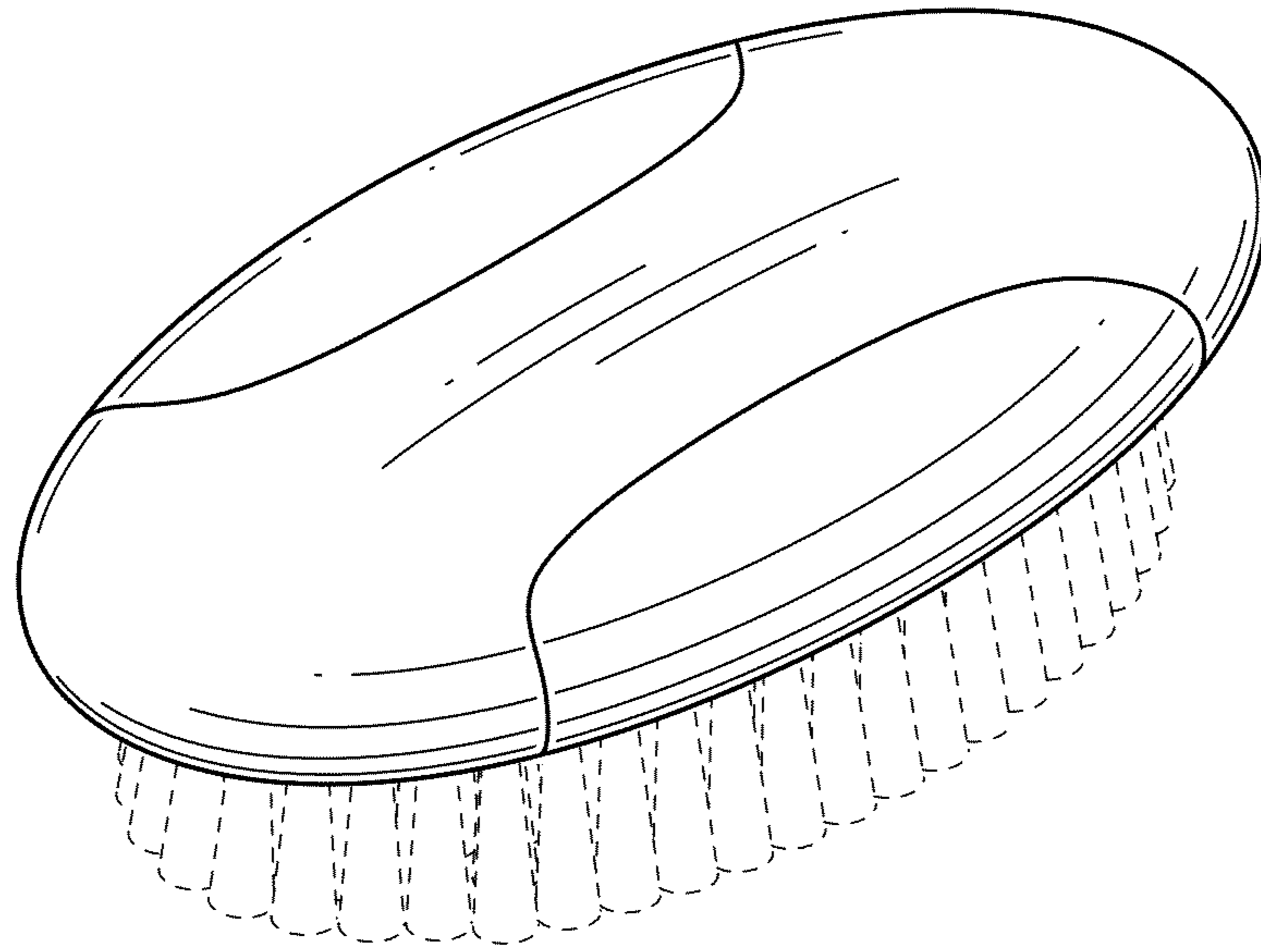

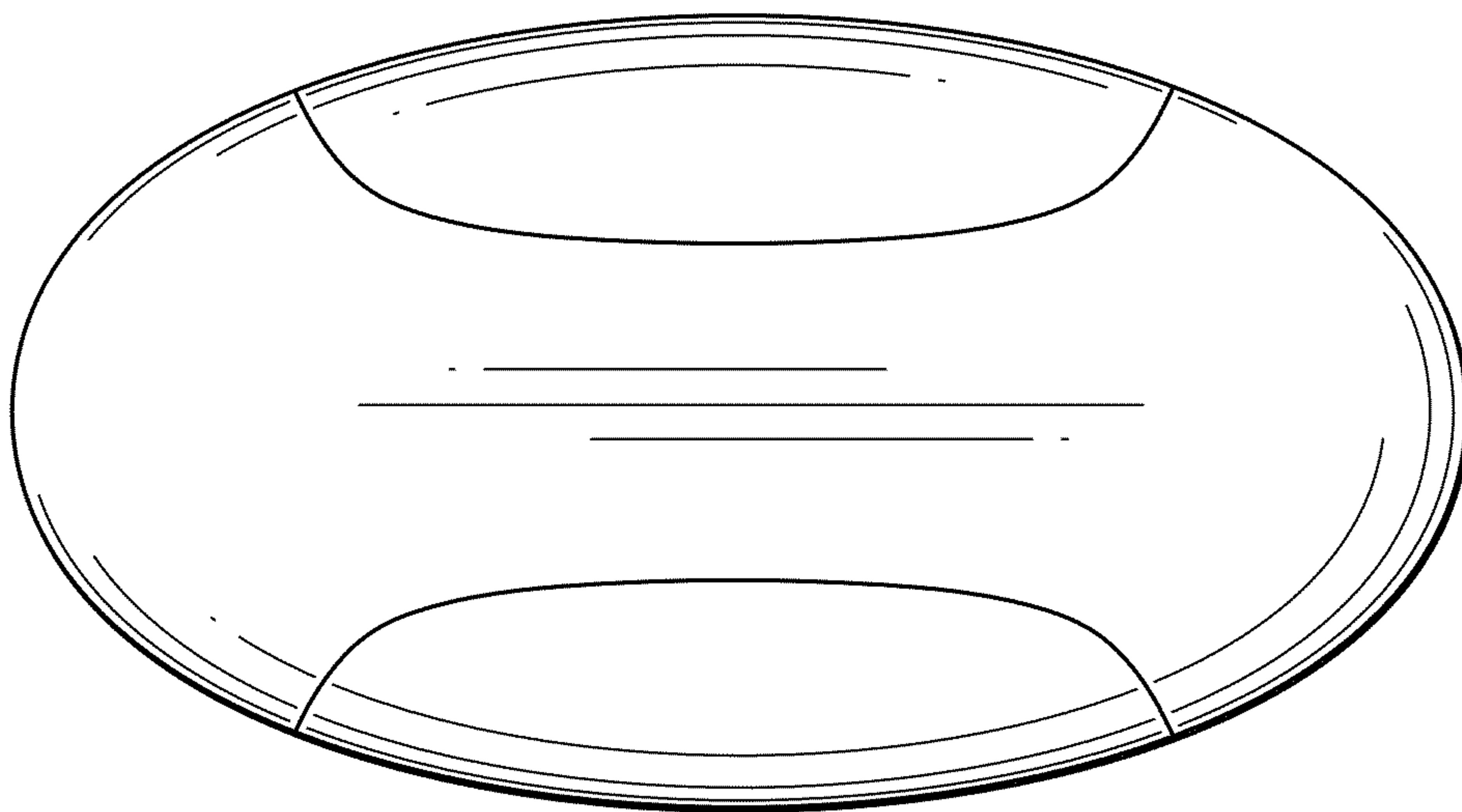

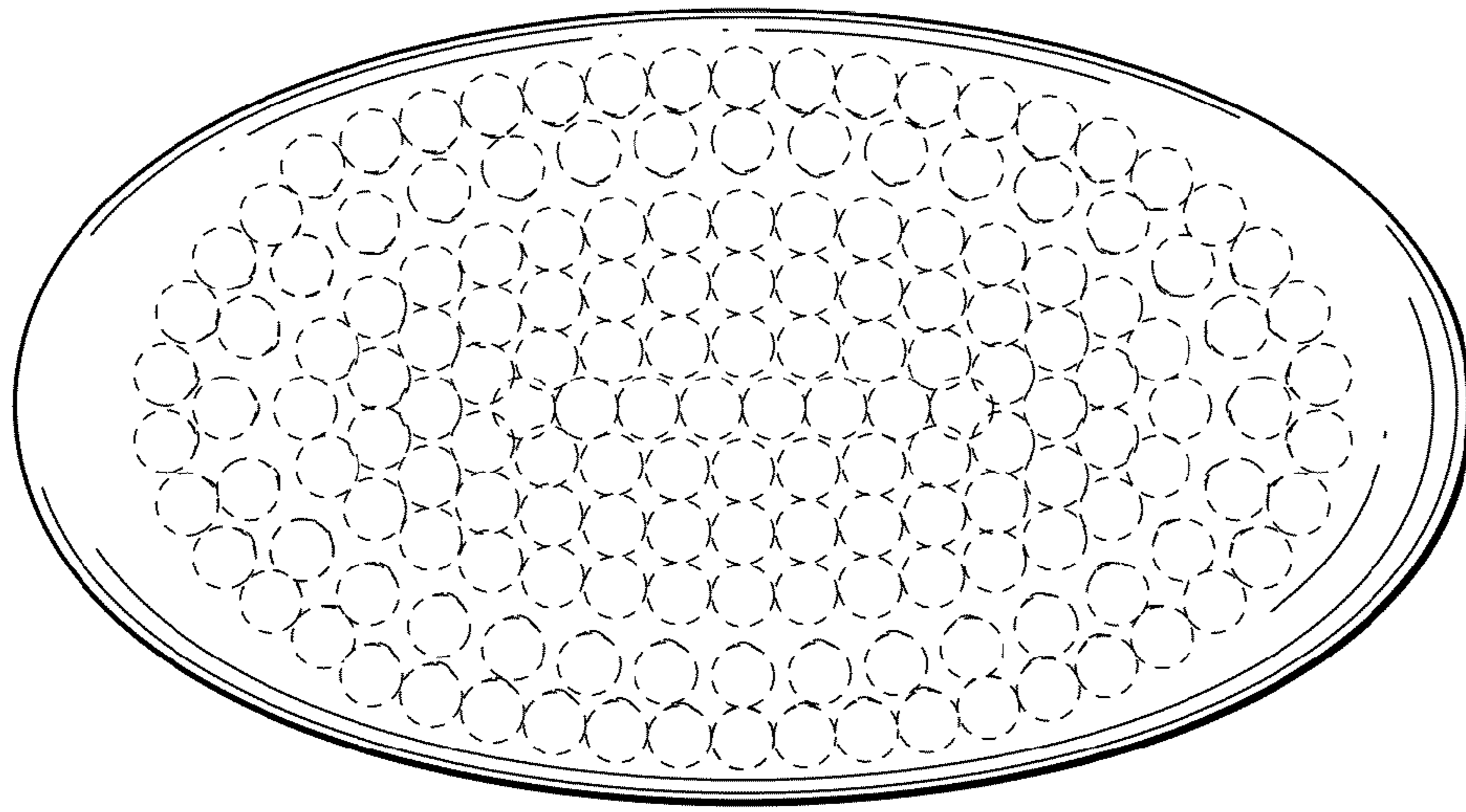

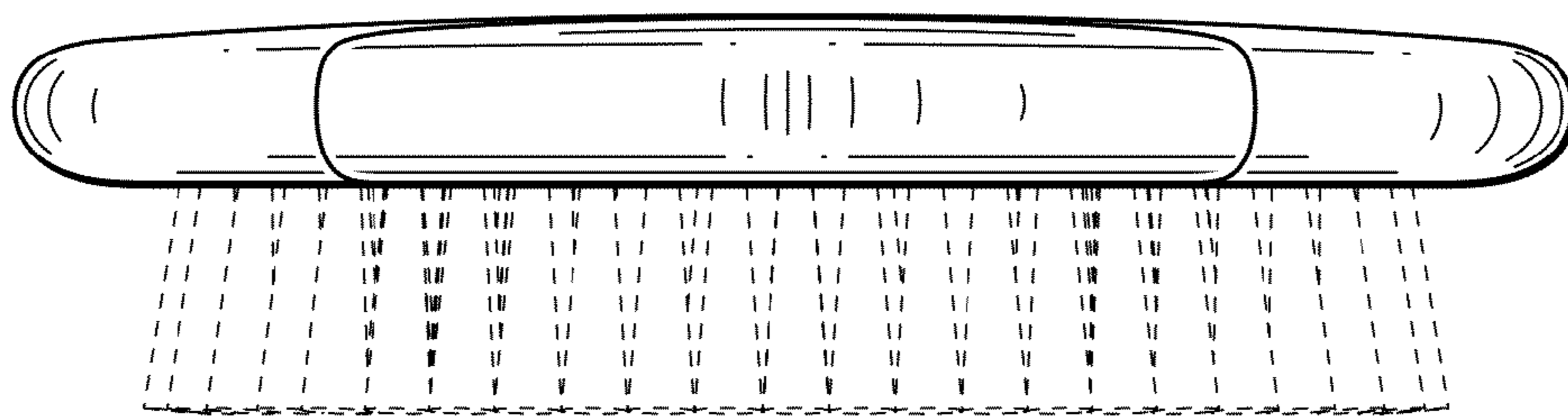

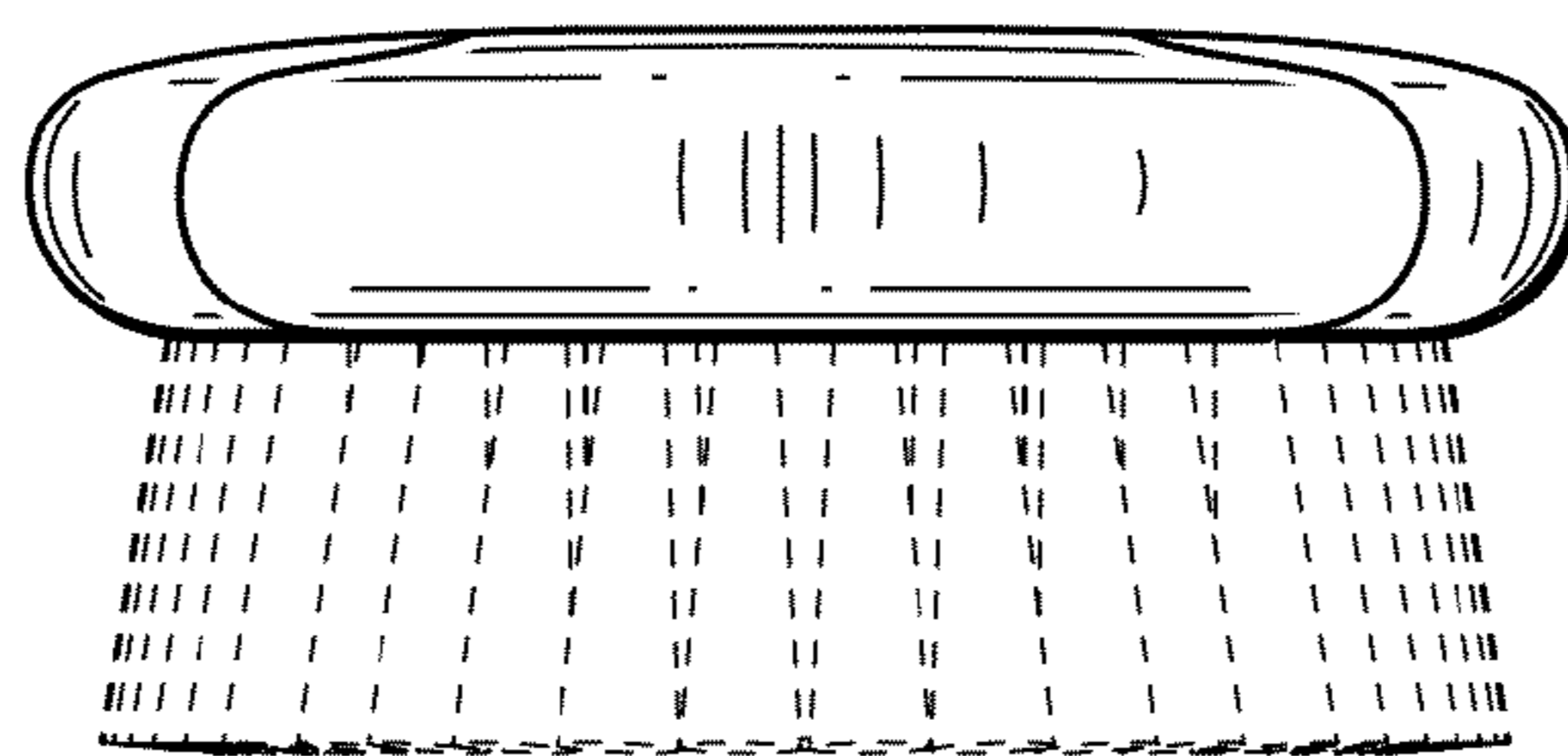
