FIG. 1 is a top plan view of an absorbent article showing my new design

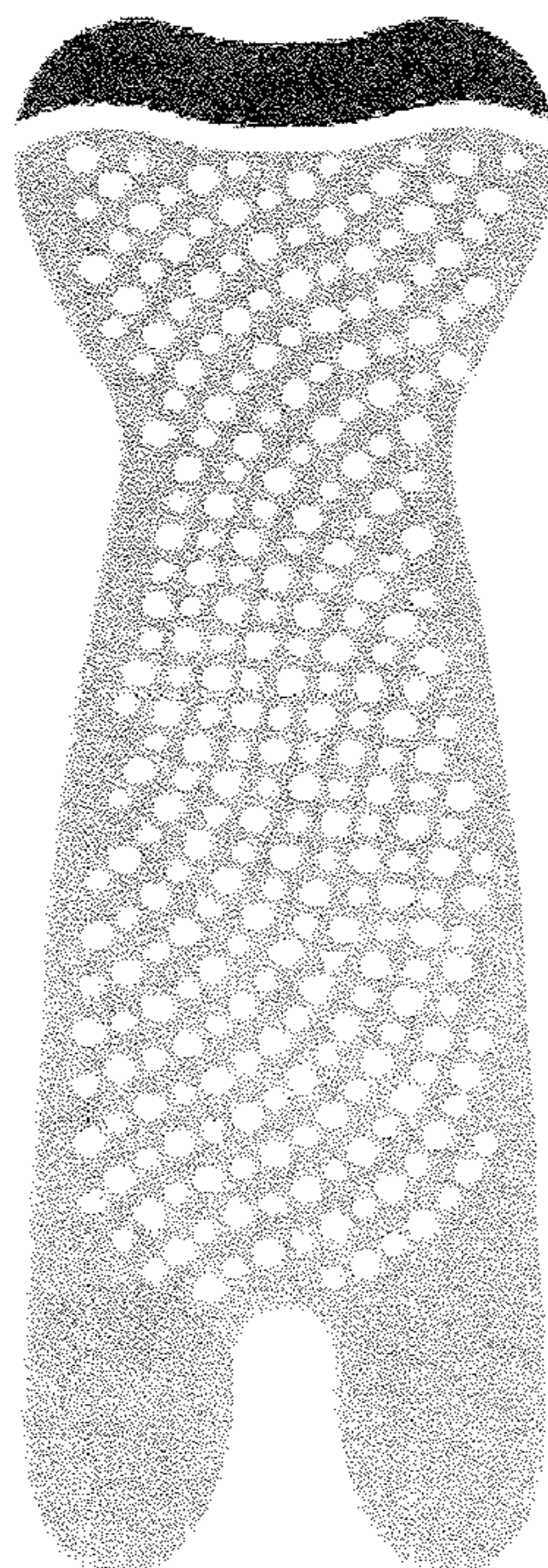
FIG. 2 is a left side view thereof;

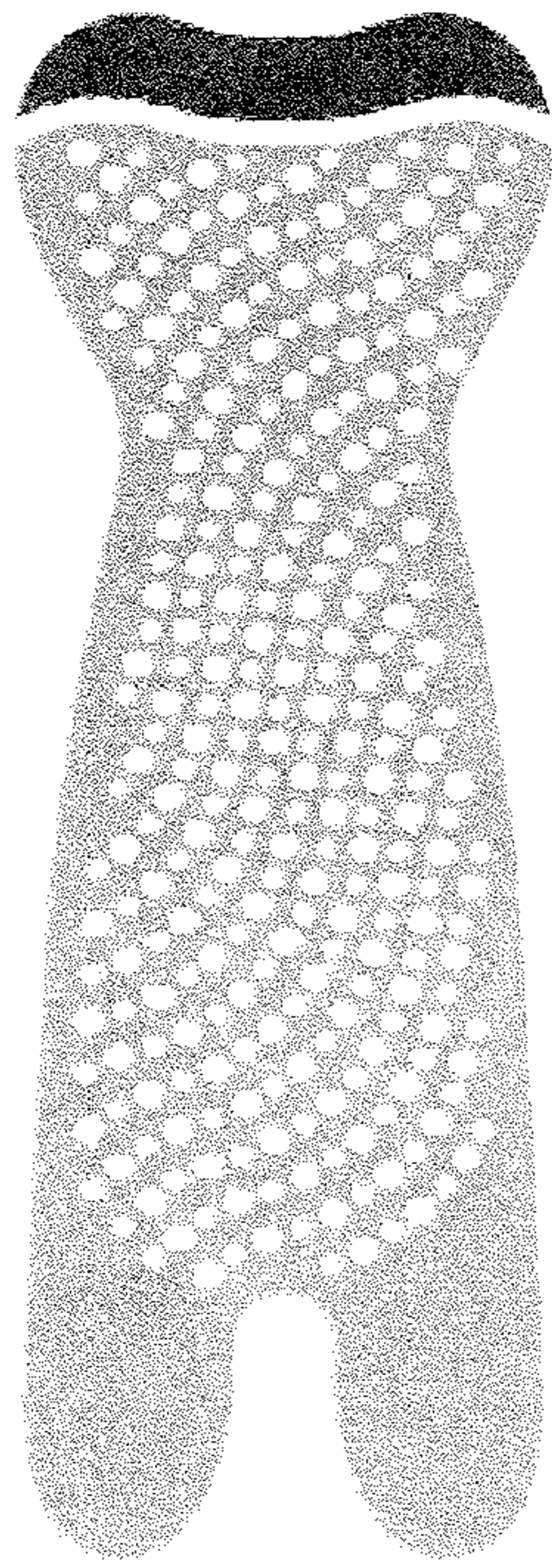

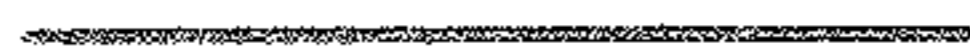
