FIG. 5 is an opposite side view of the chair in FIG. 8 thereof;

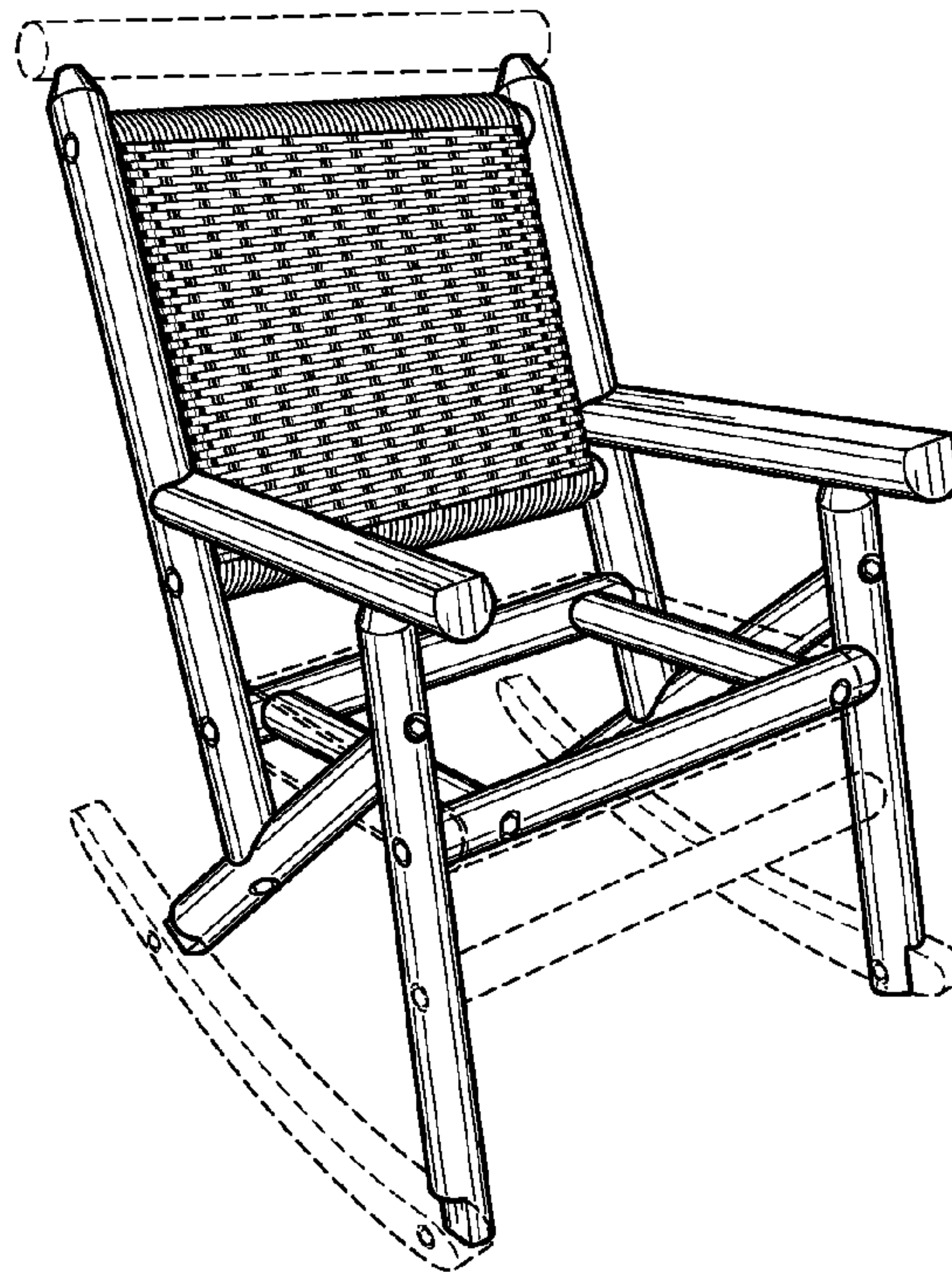
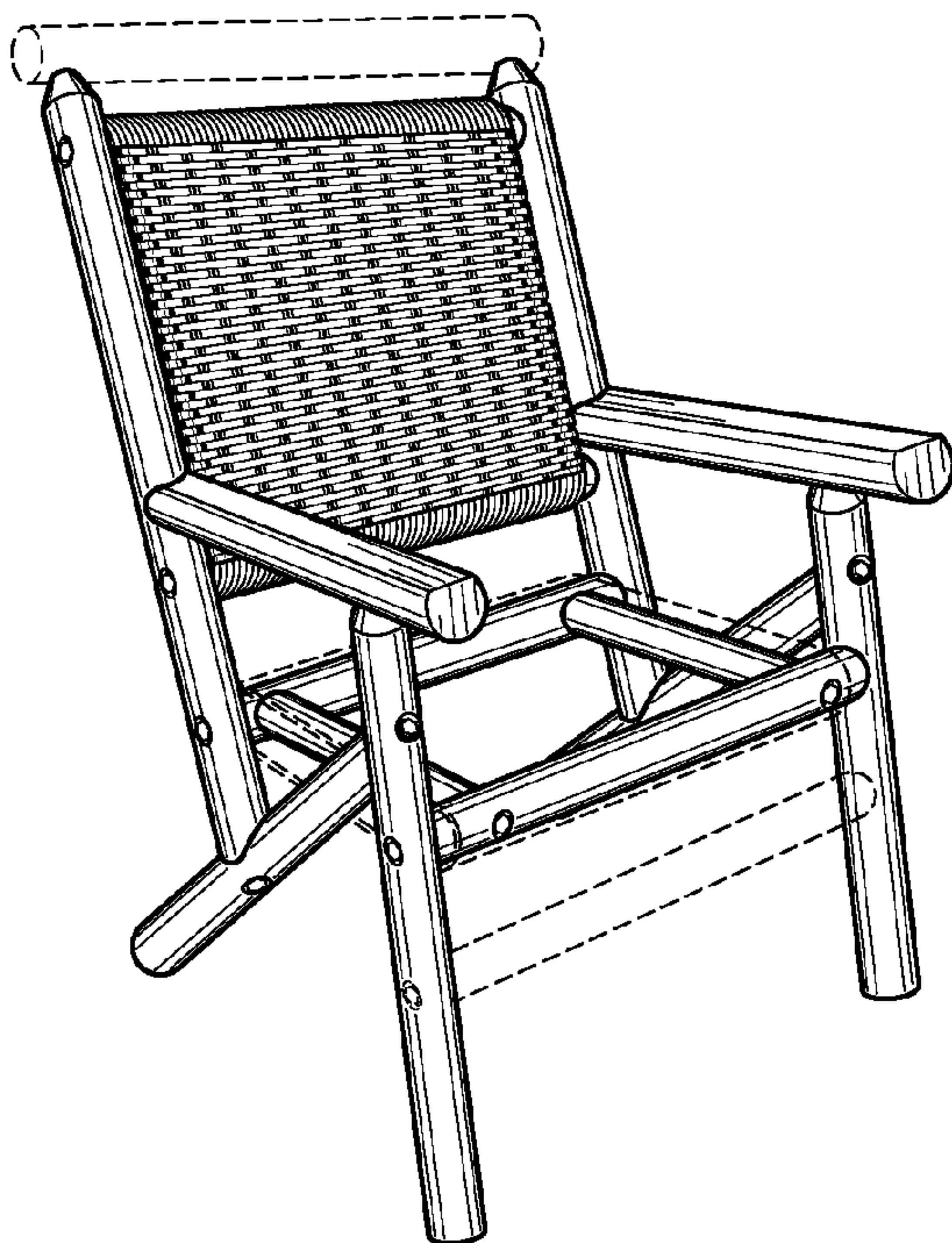
FIG. 6 is a top view thereof;

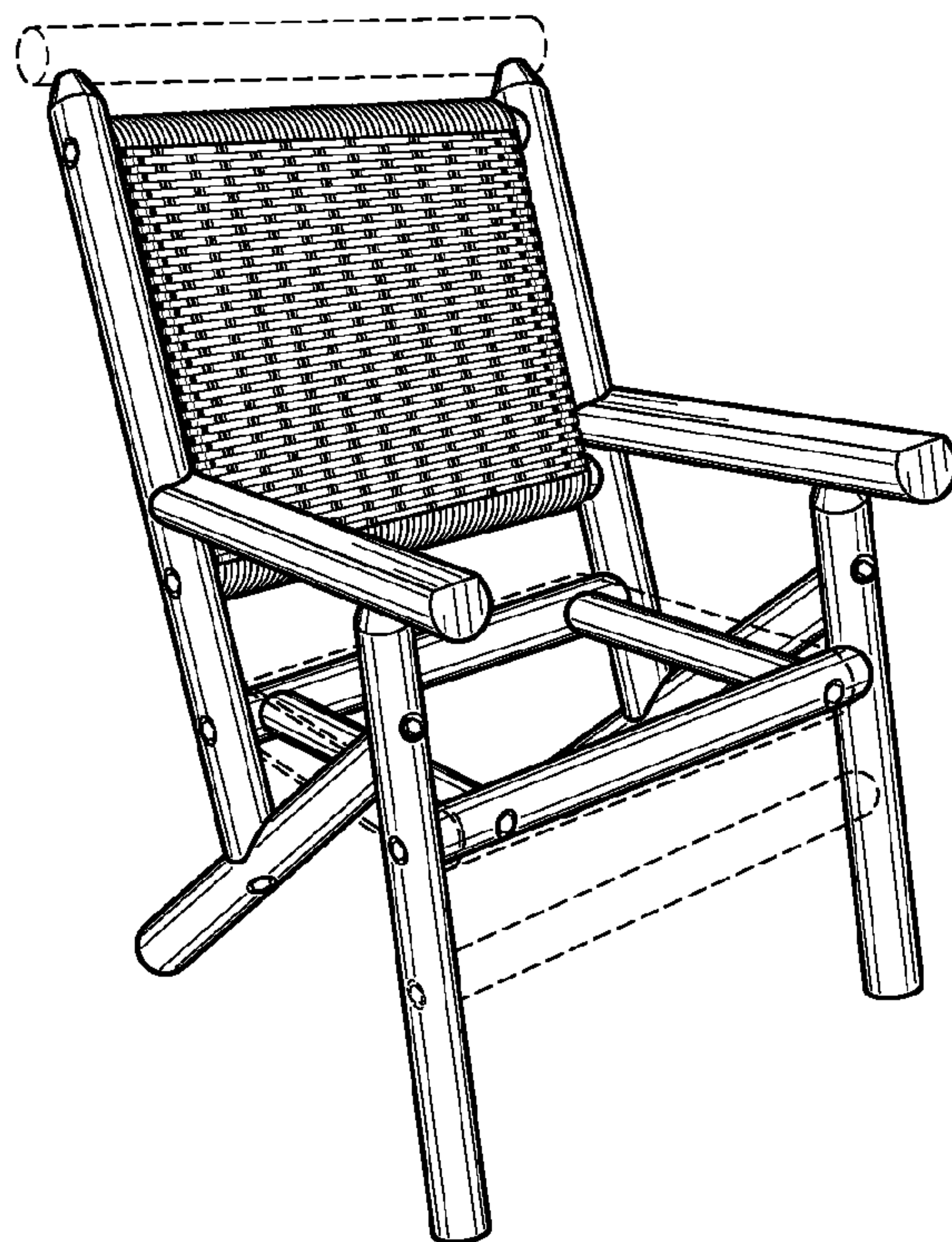

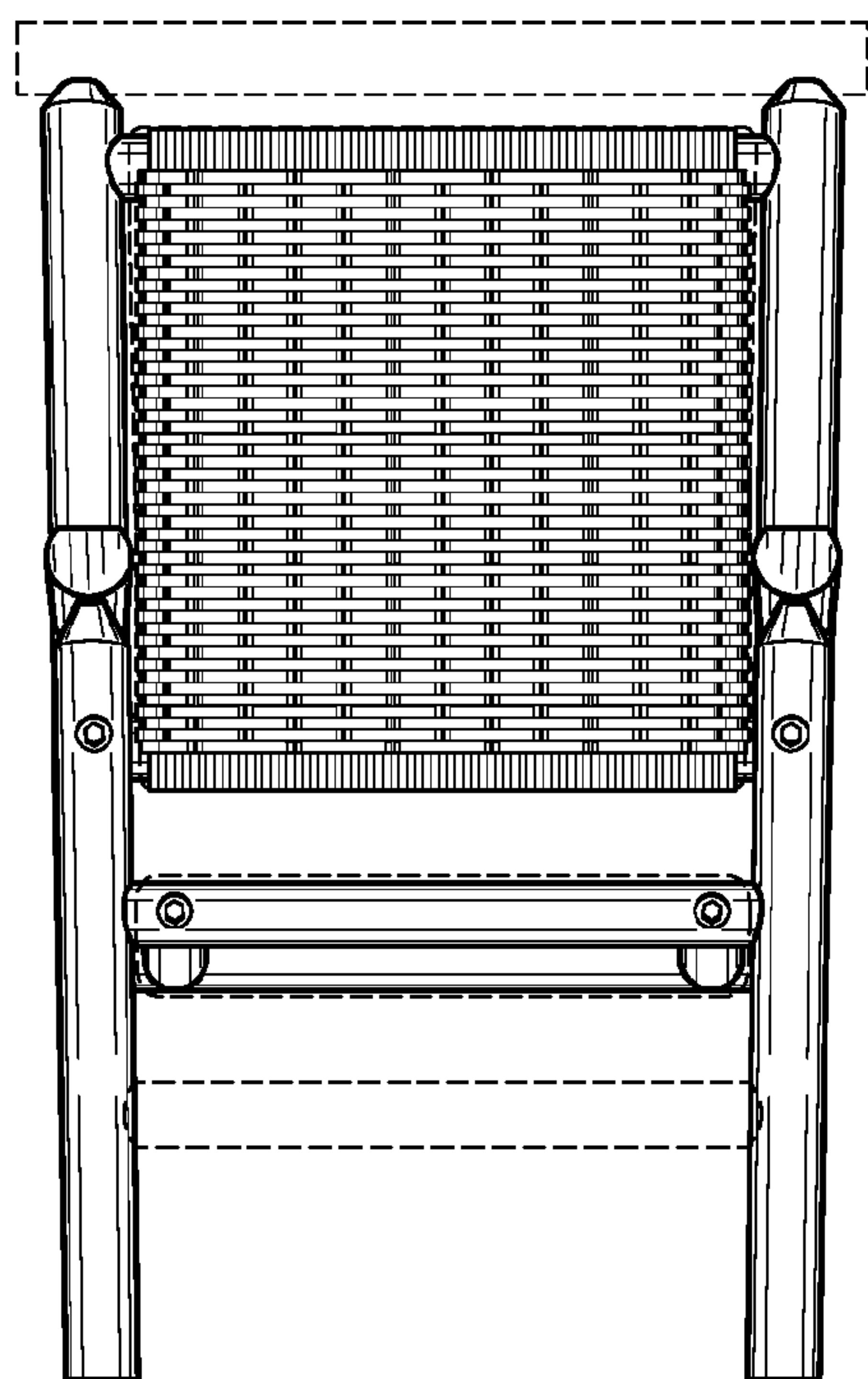

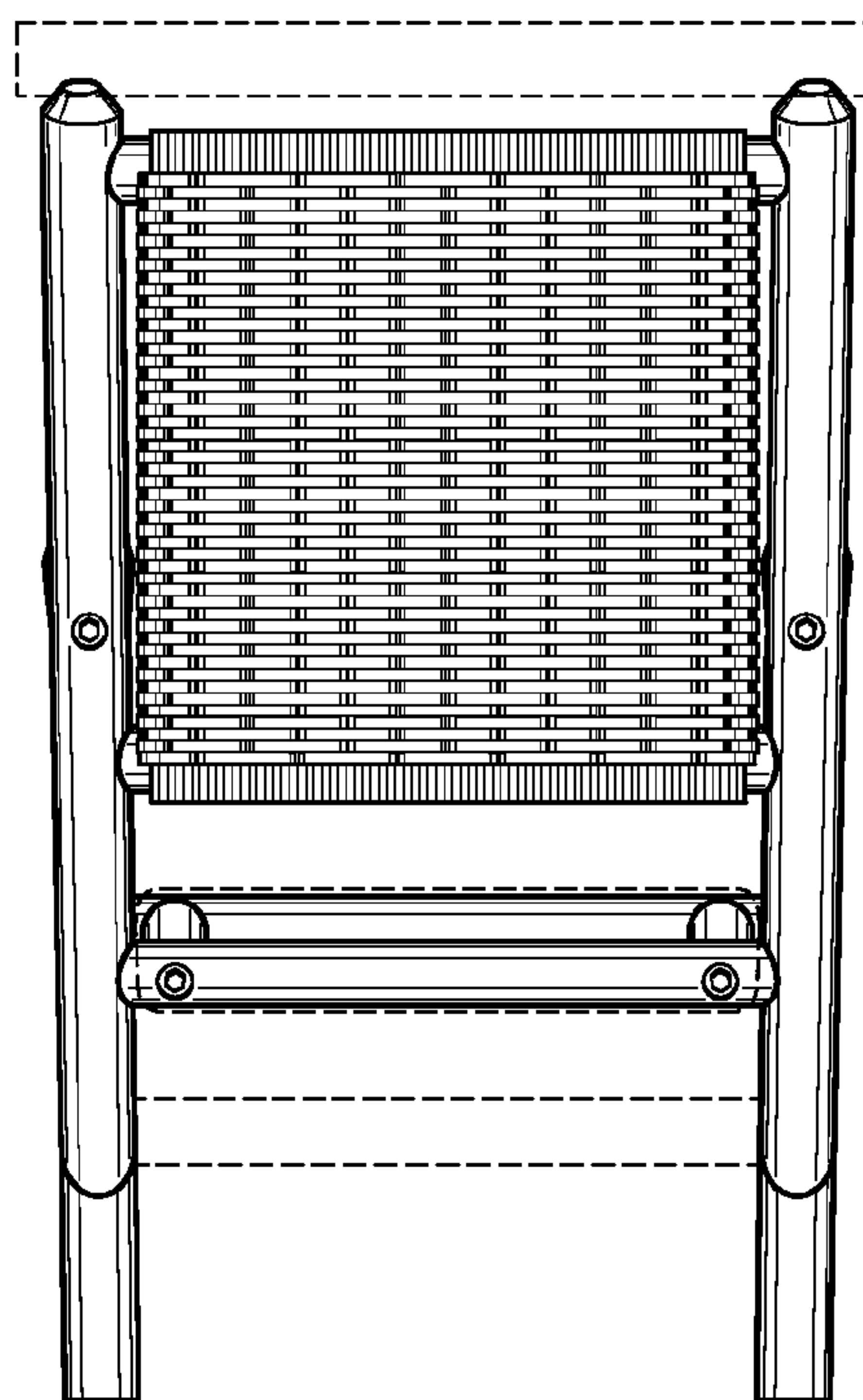

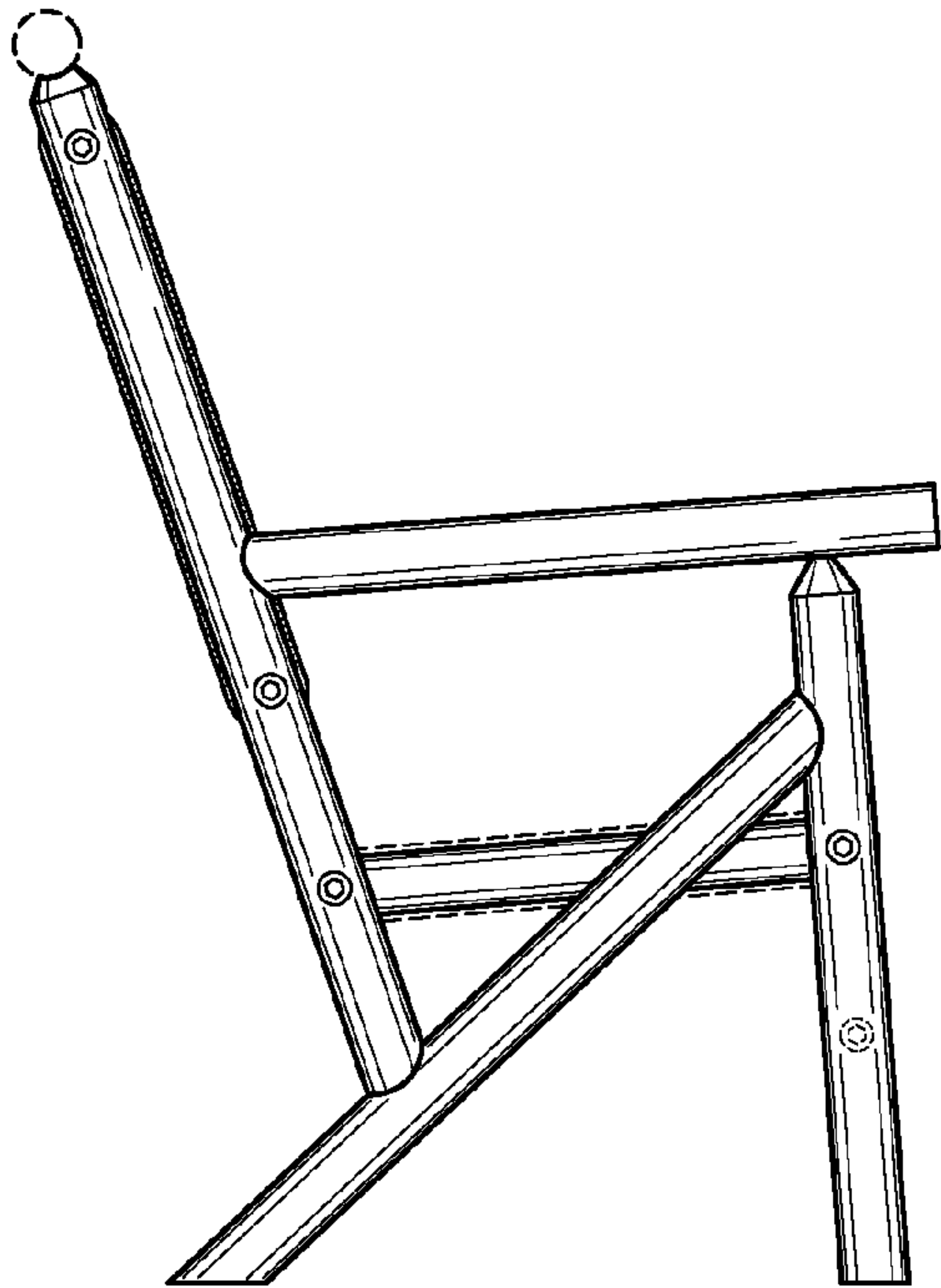

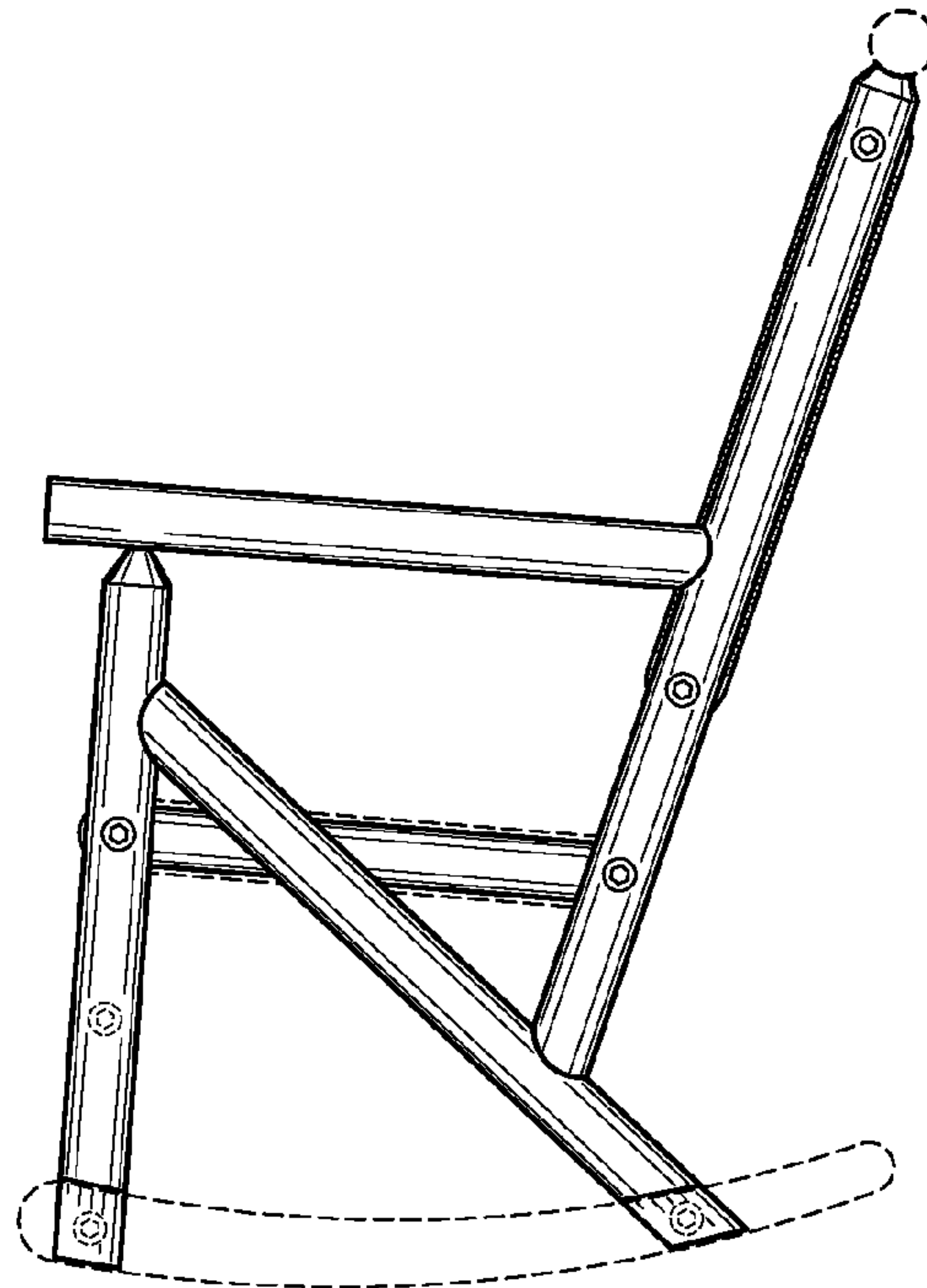

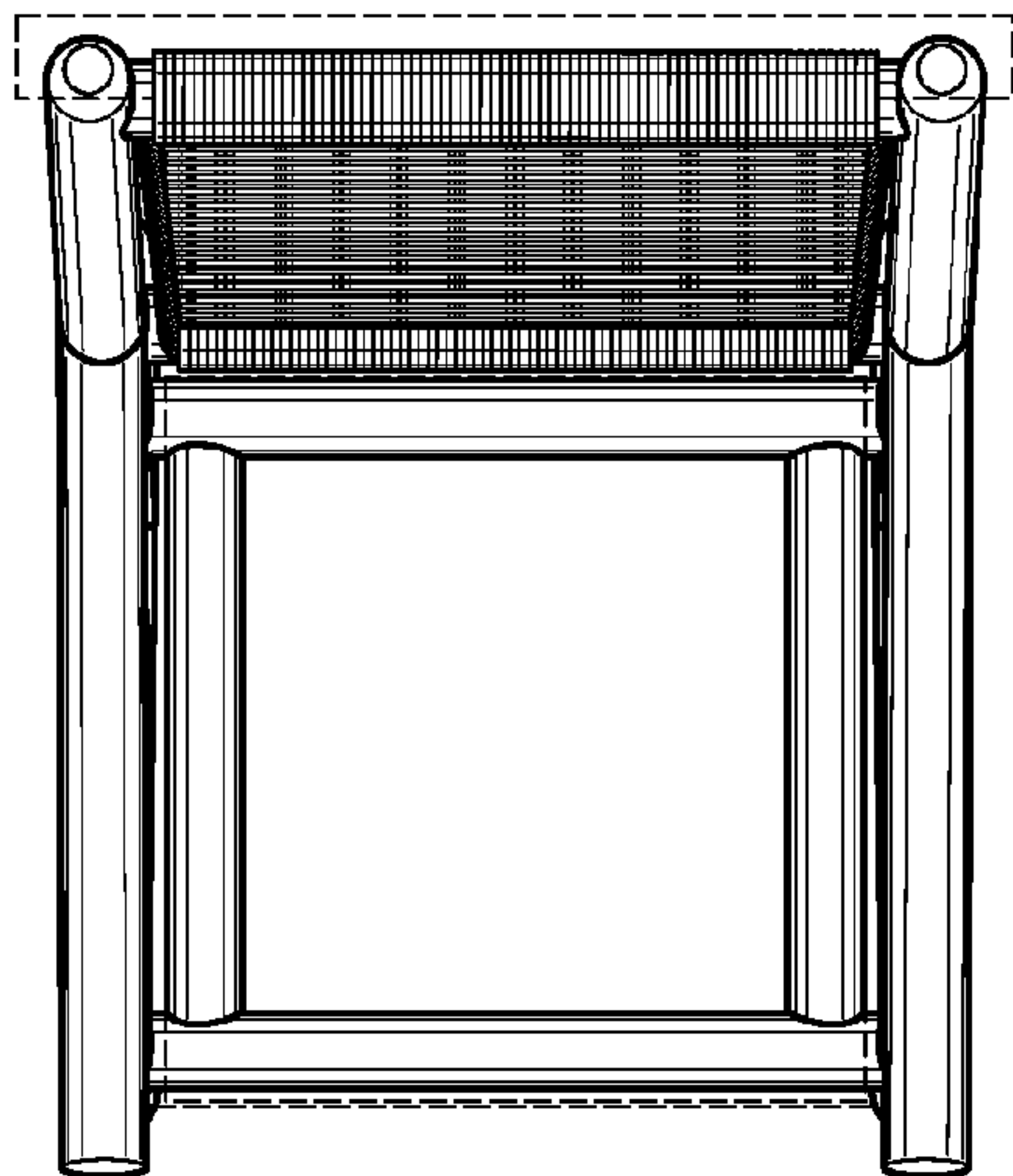

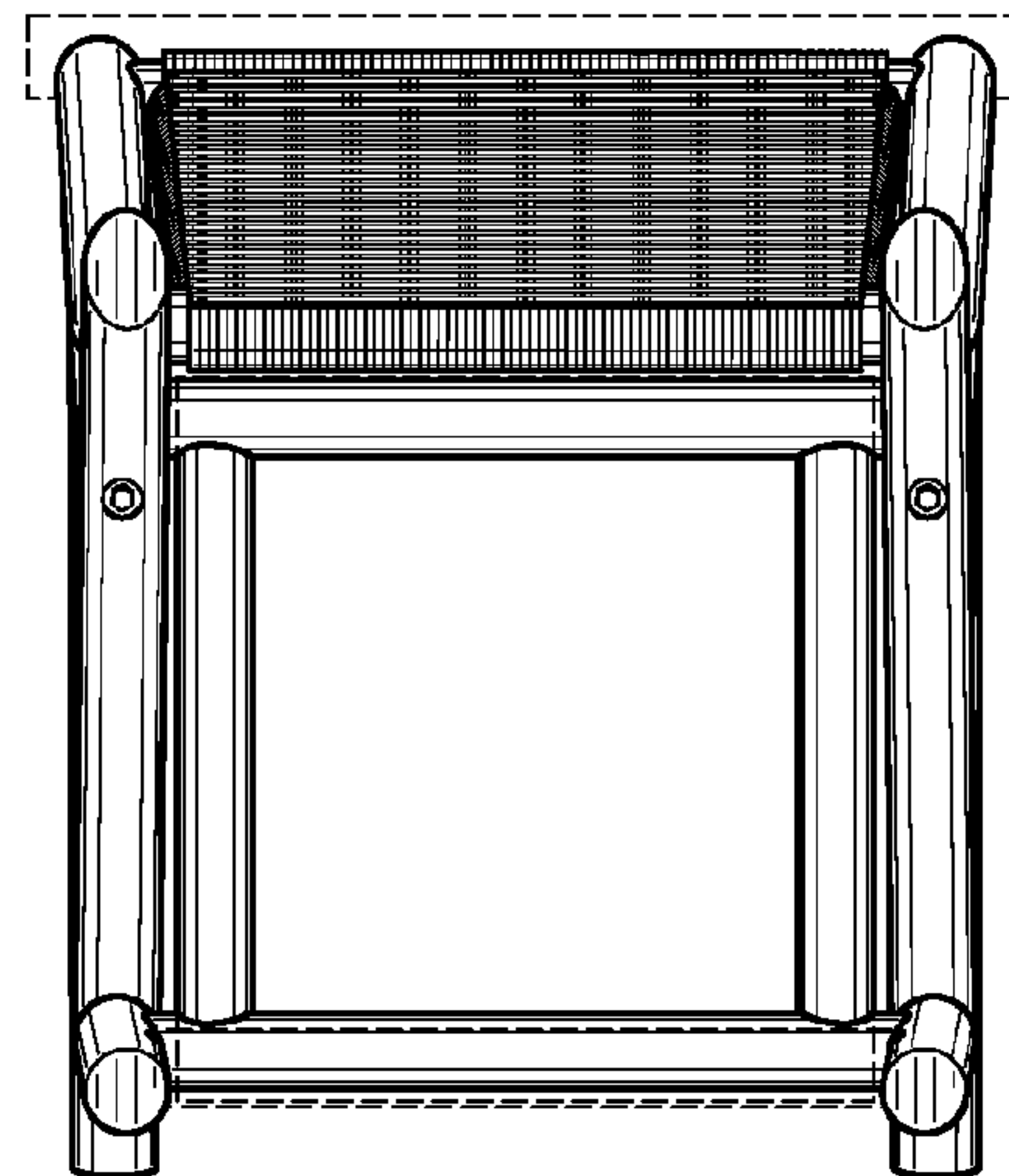
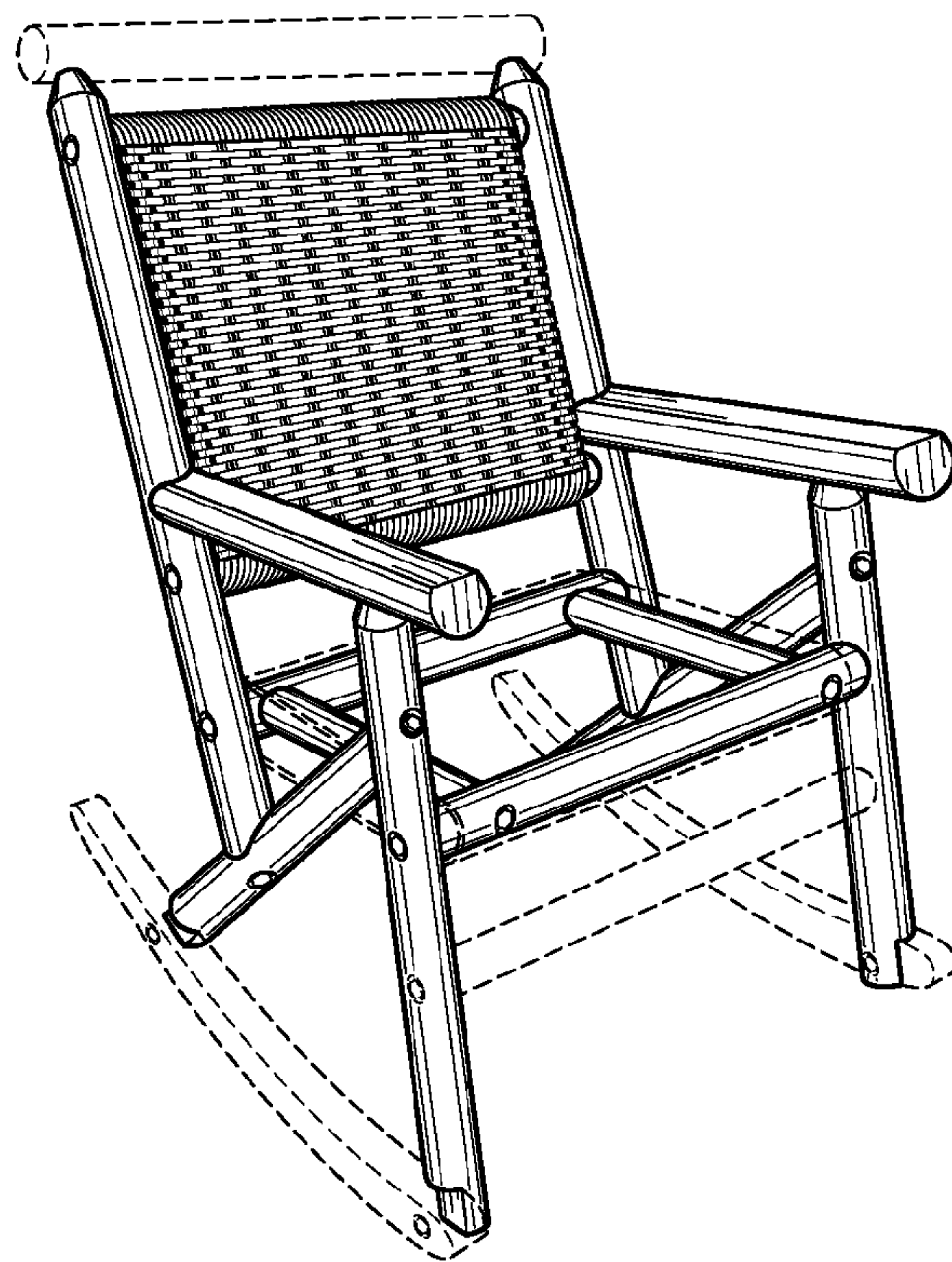
