FIG. 4 is a top view of the novelty utensil.

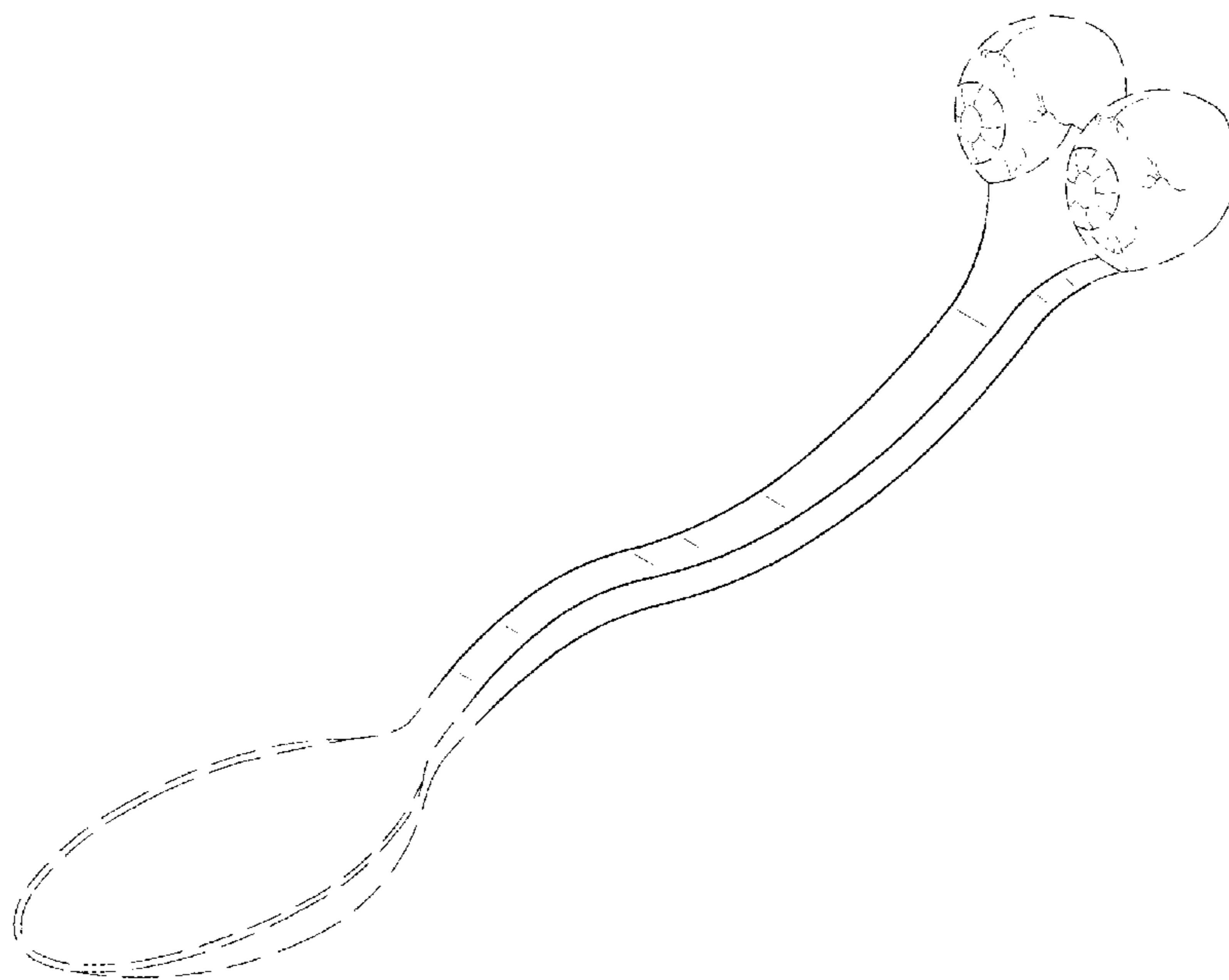
FIG. 5 is a bottom view of the novelty utensil; and,

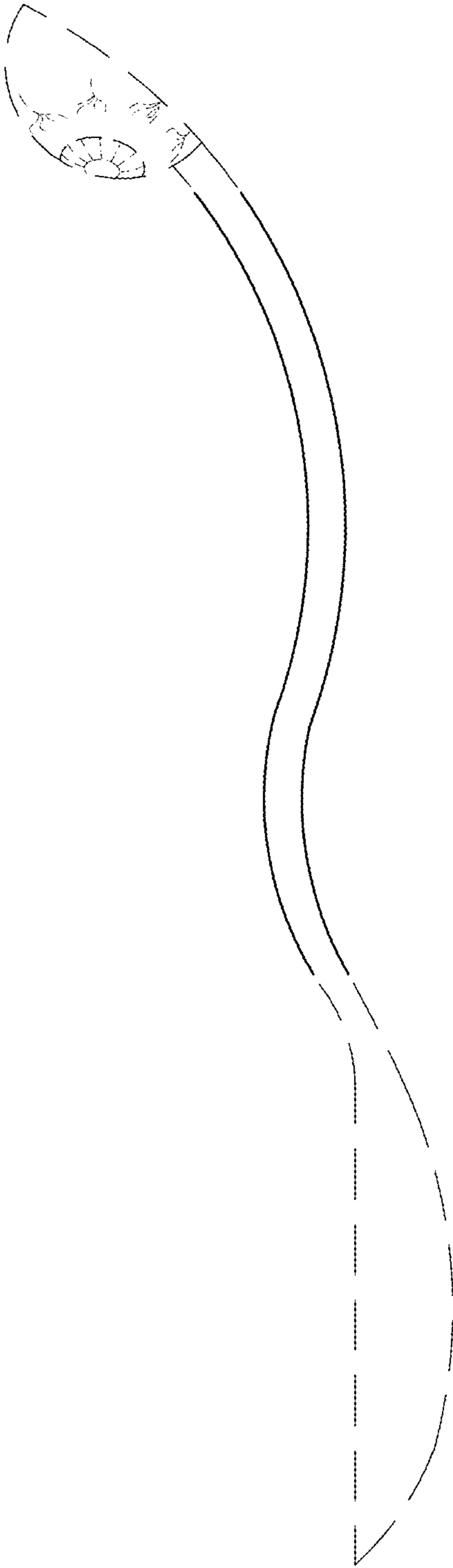

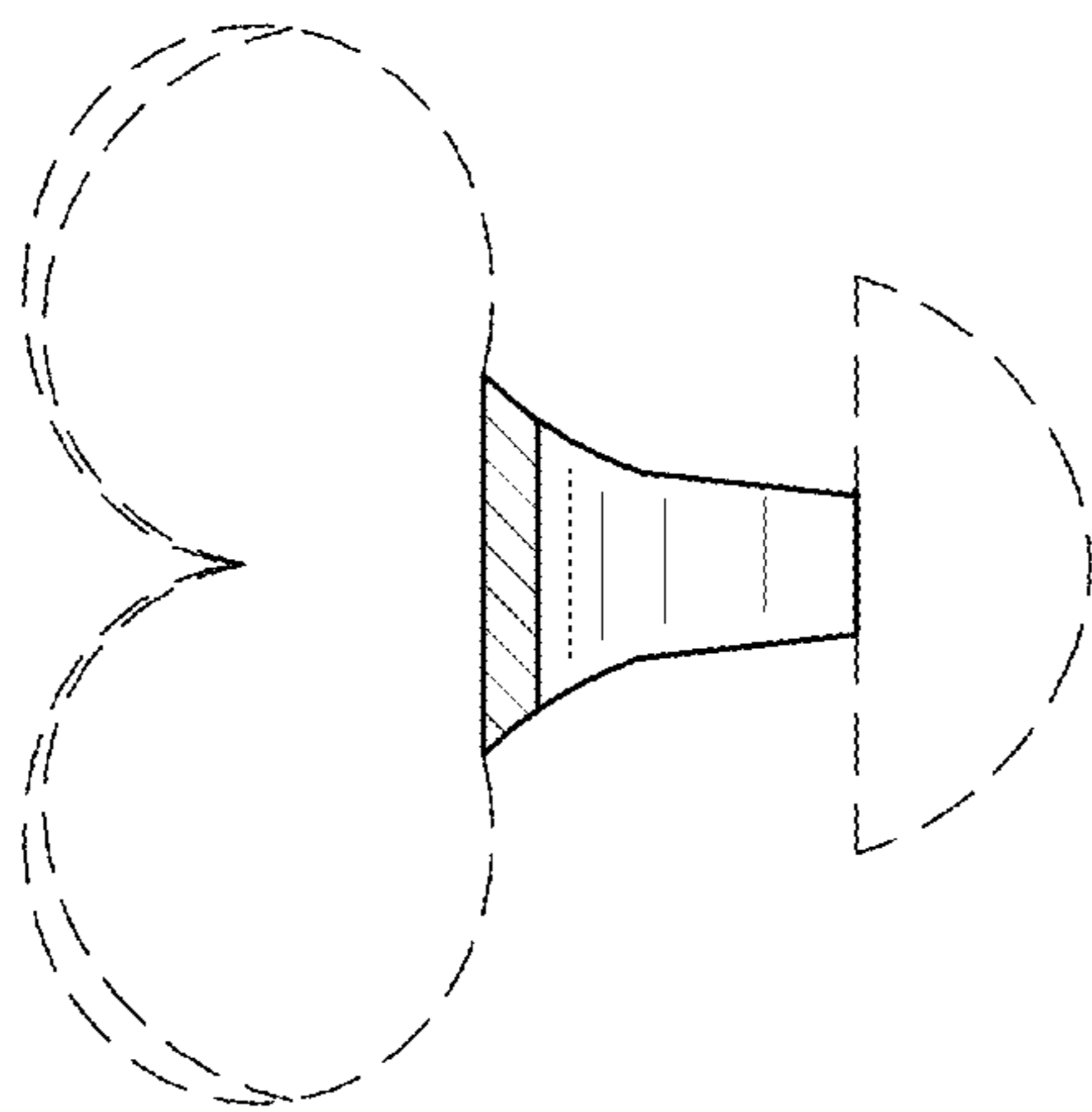

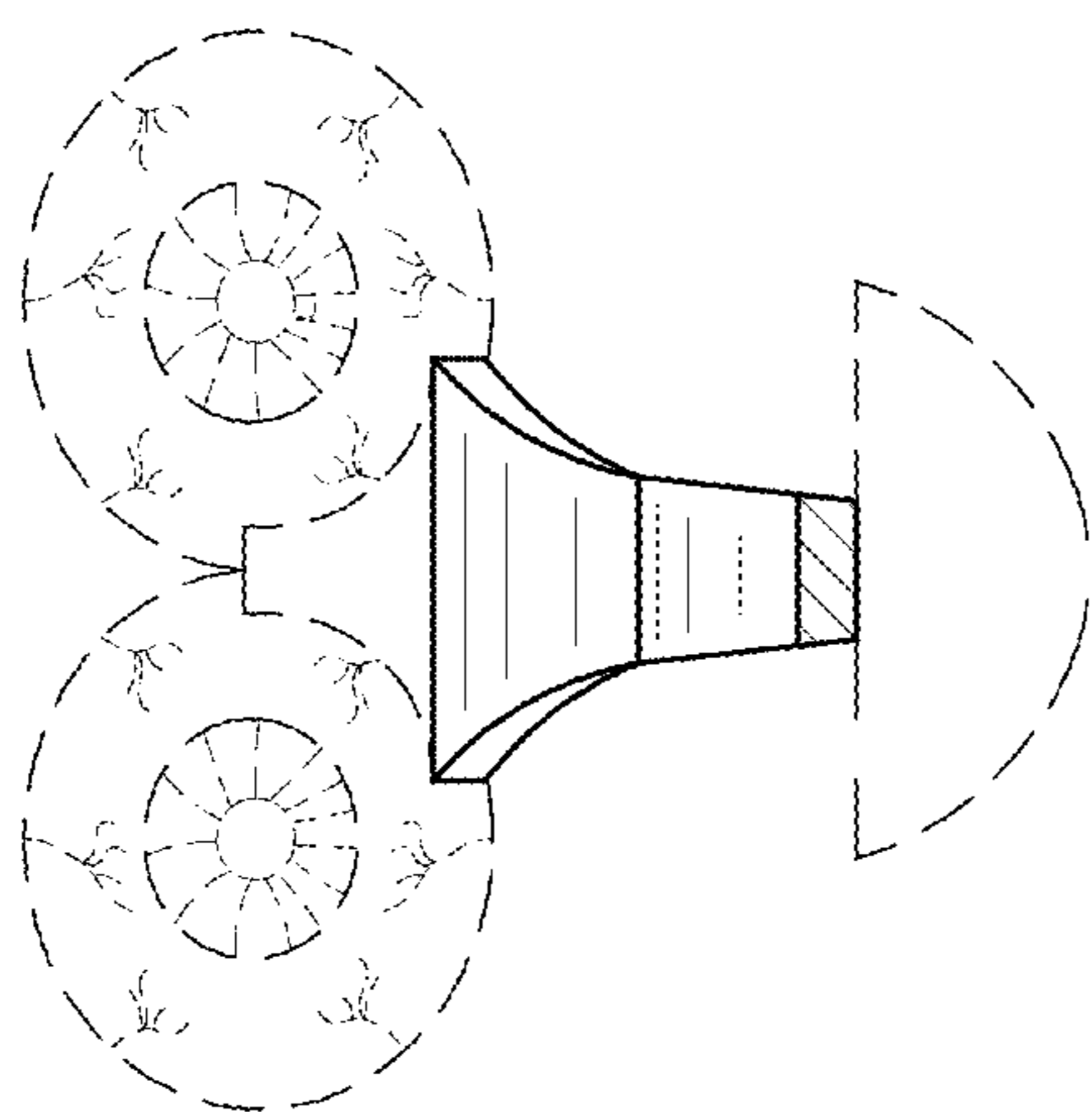

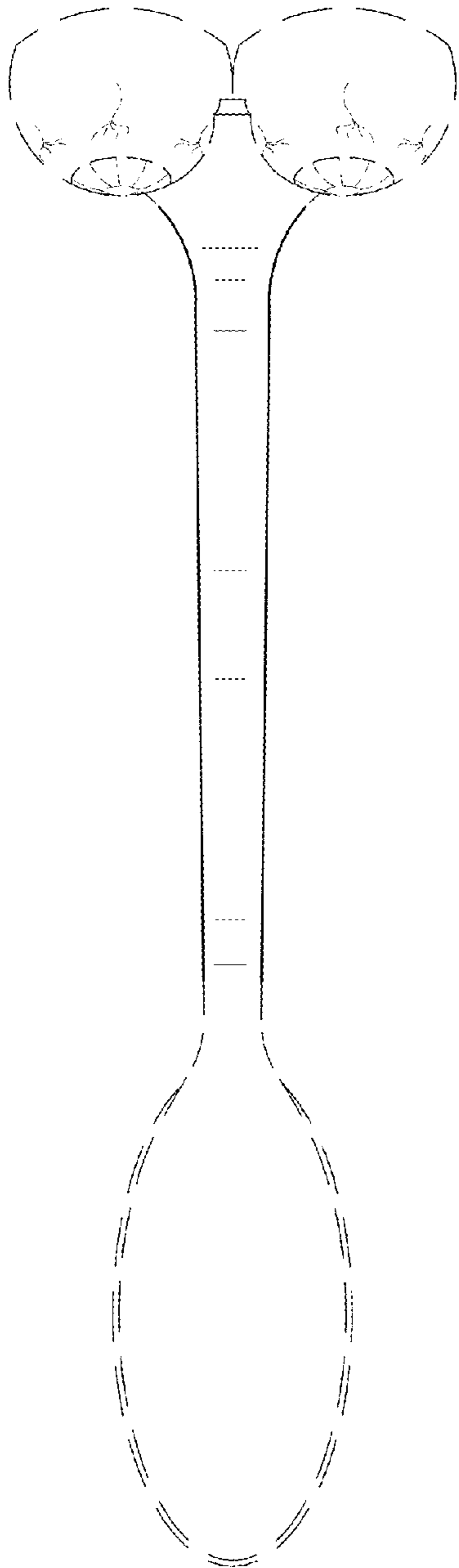

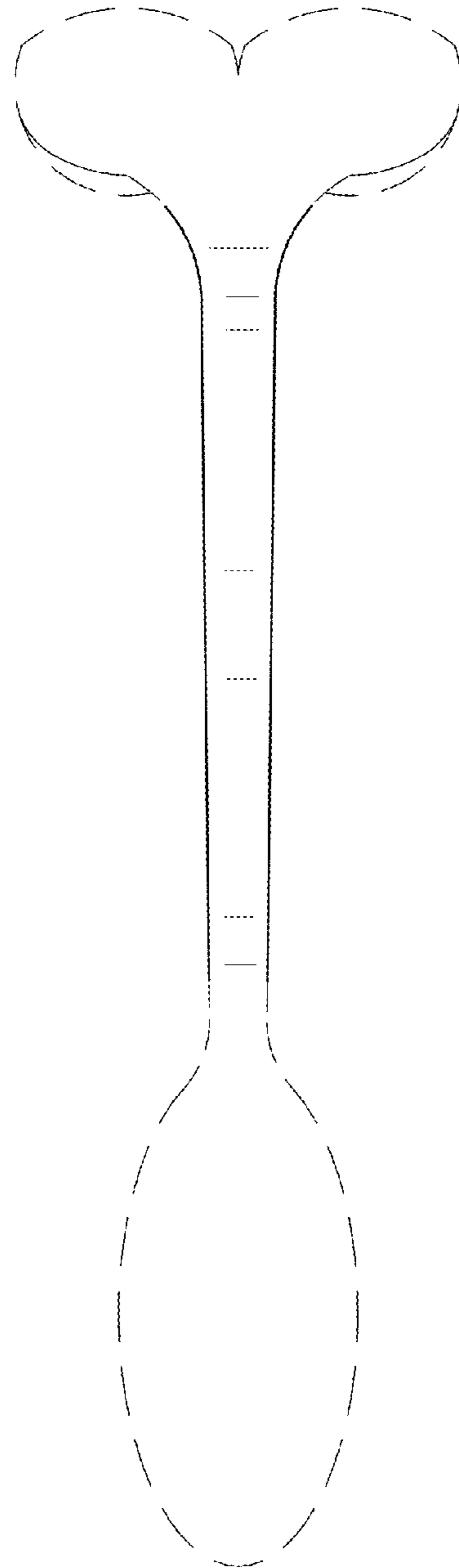

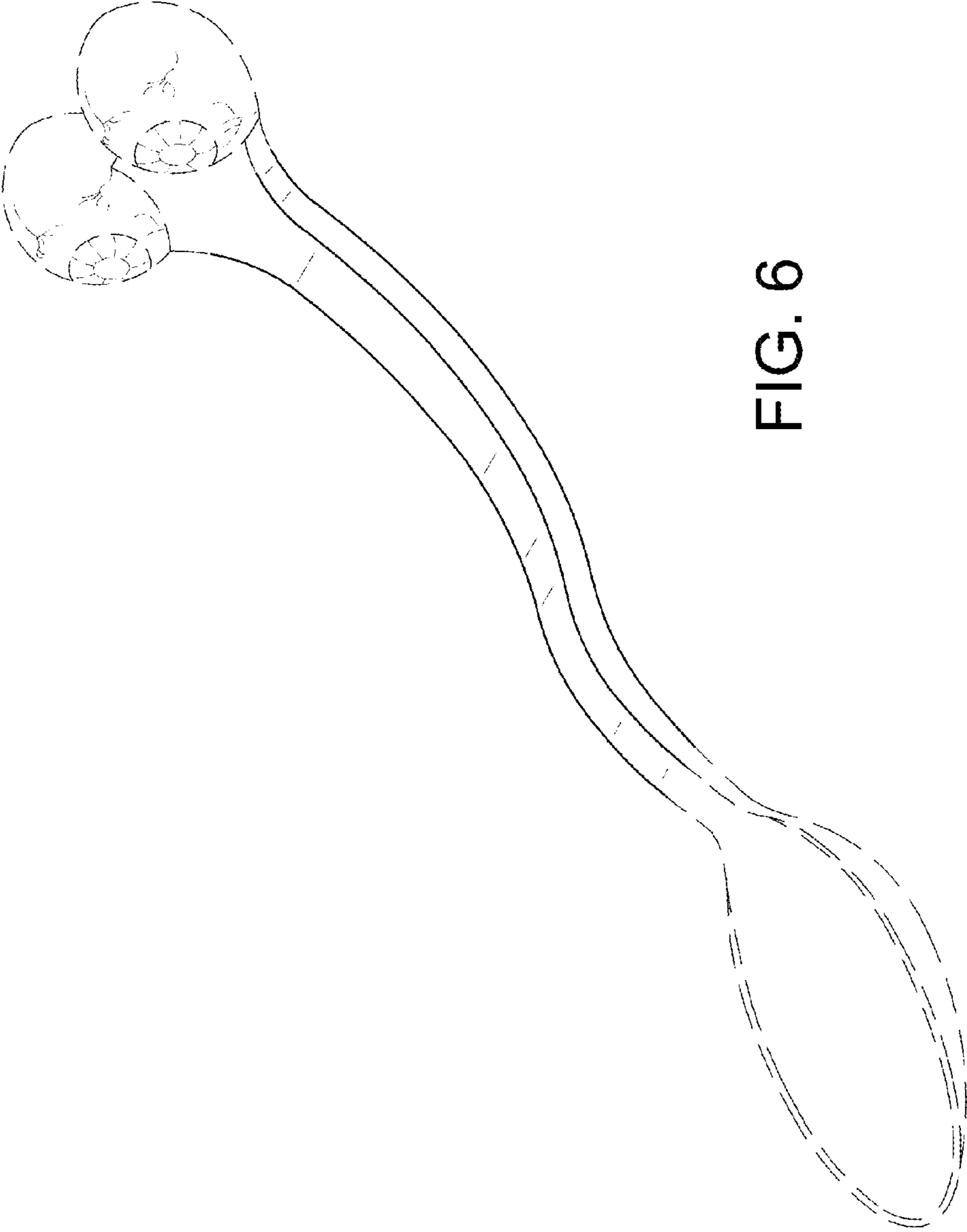
