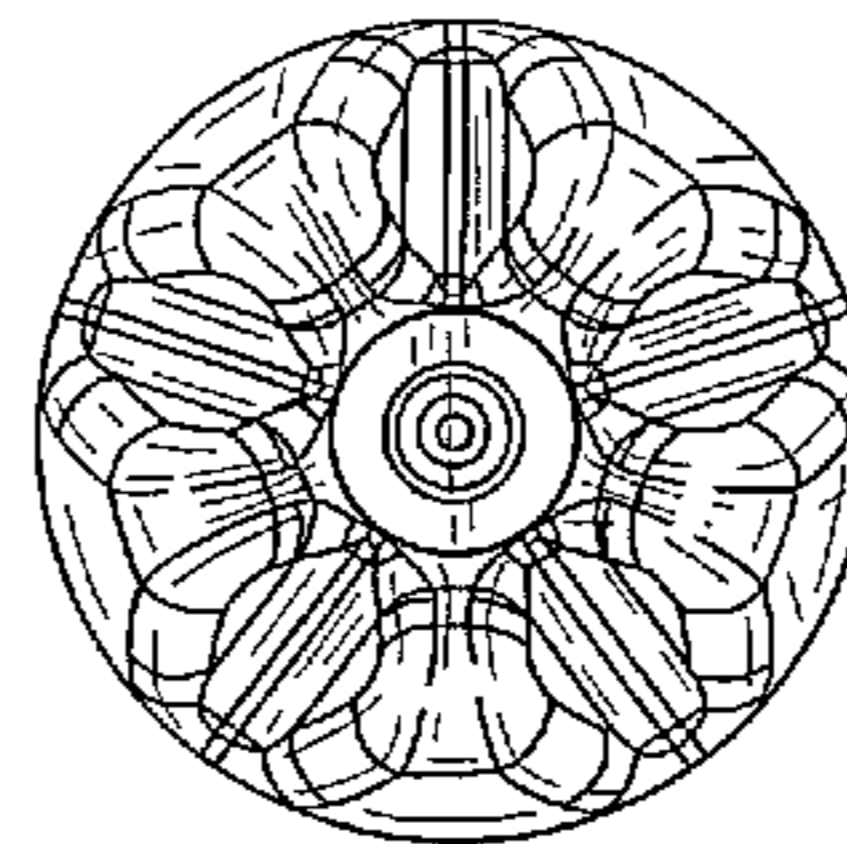
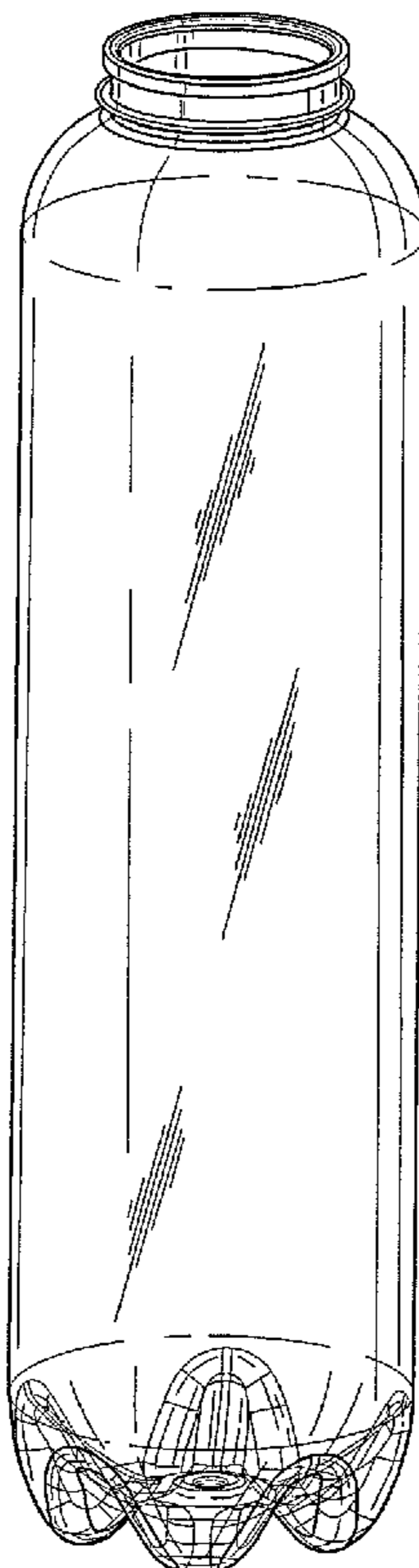
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above, to the front, and to the left side of the container embodying my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a sectional view taken on line 8-8 of FIG. 3; and, FIG. 9 is a sectional view taken on line 9-9 of FIG. 5.

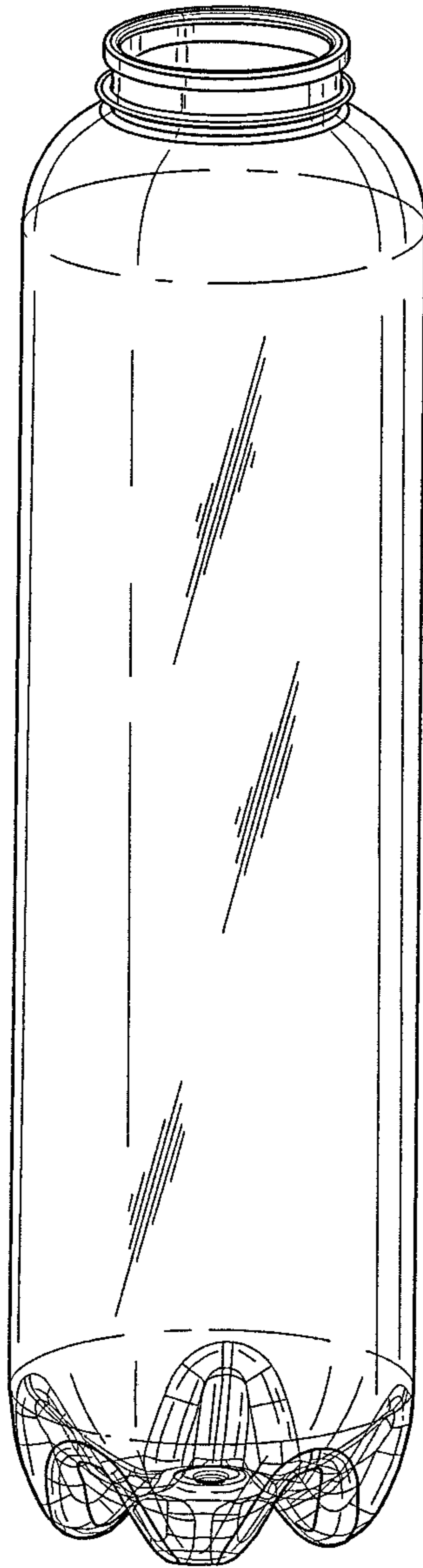

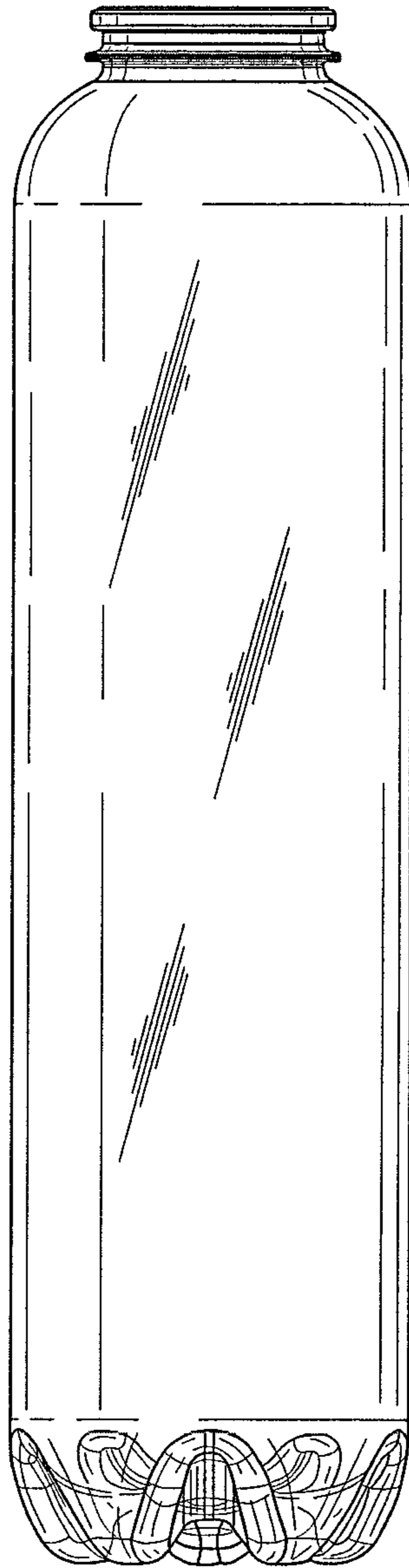

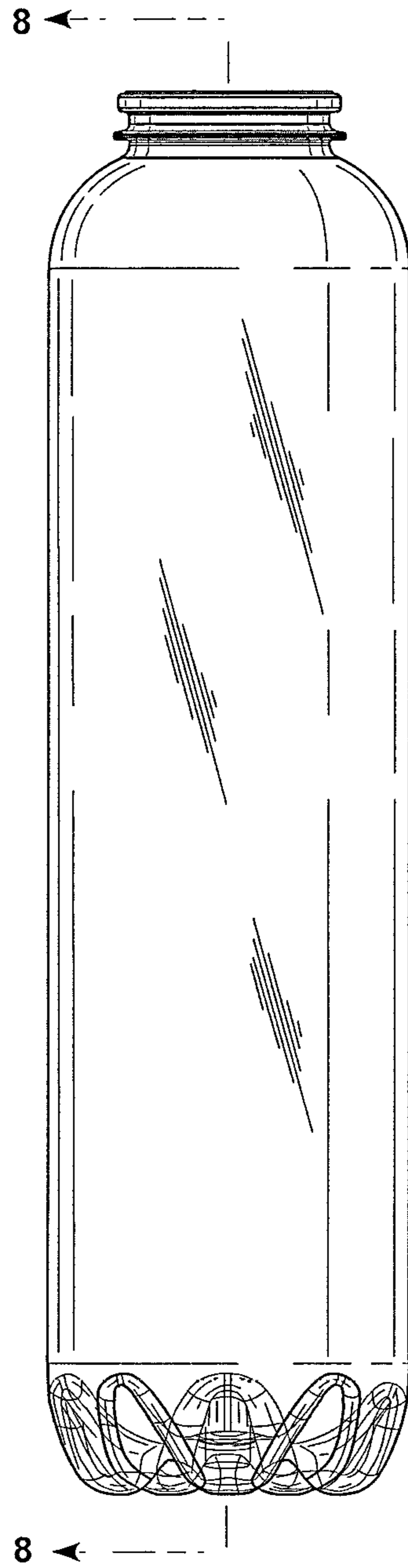

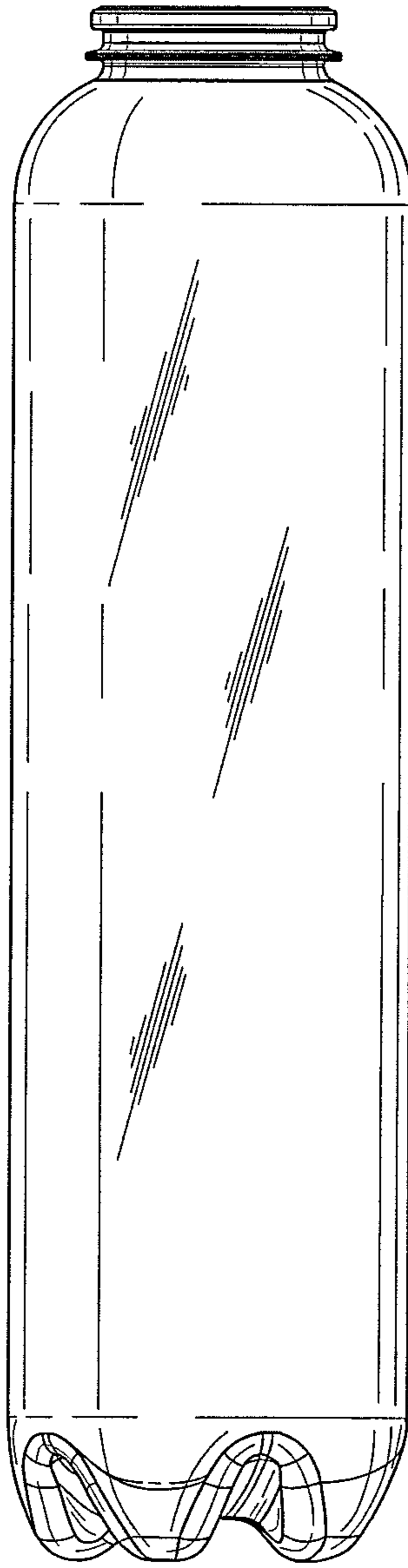

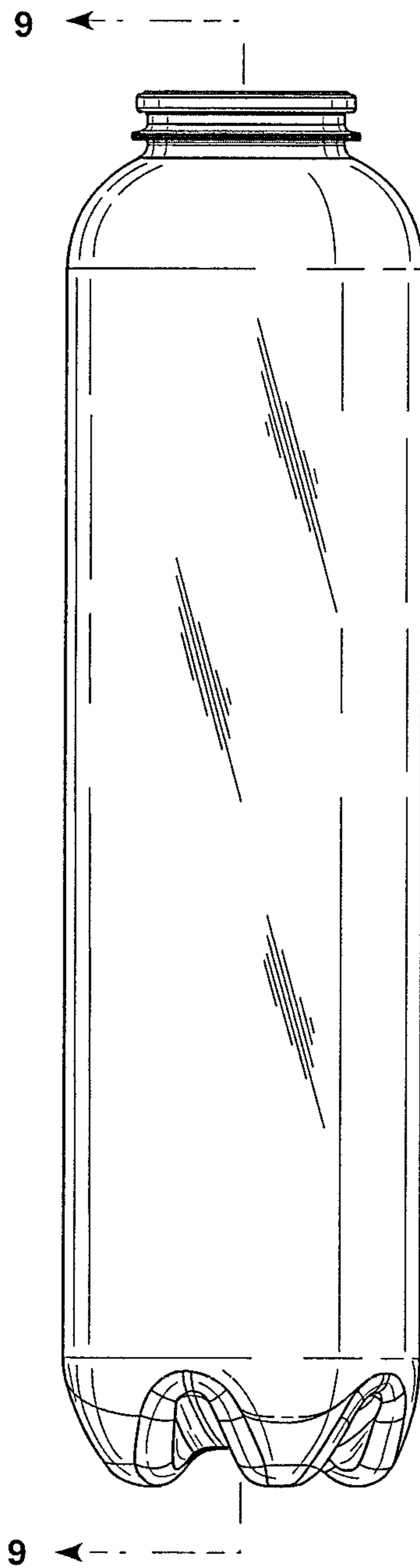

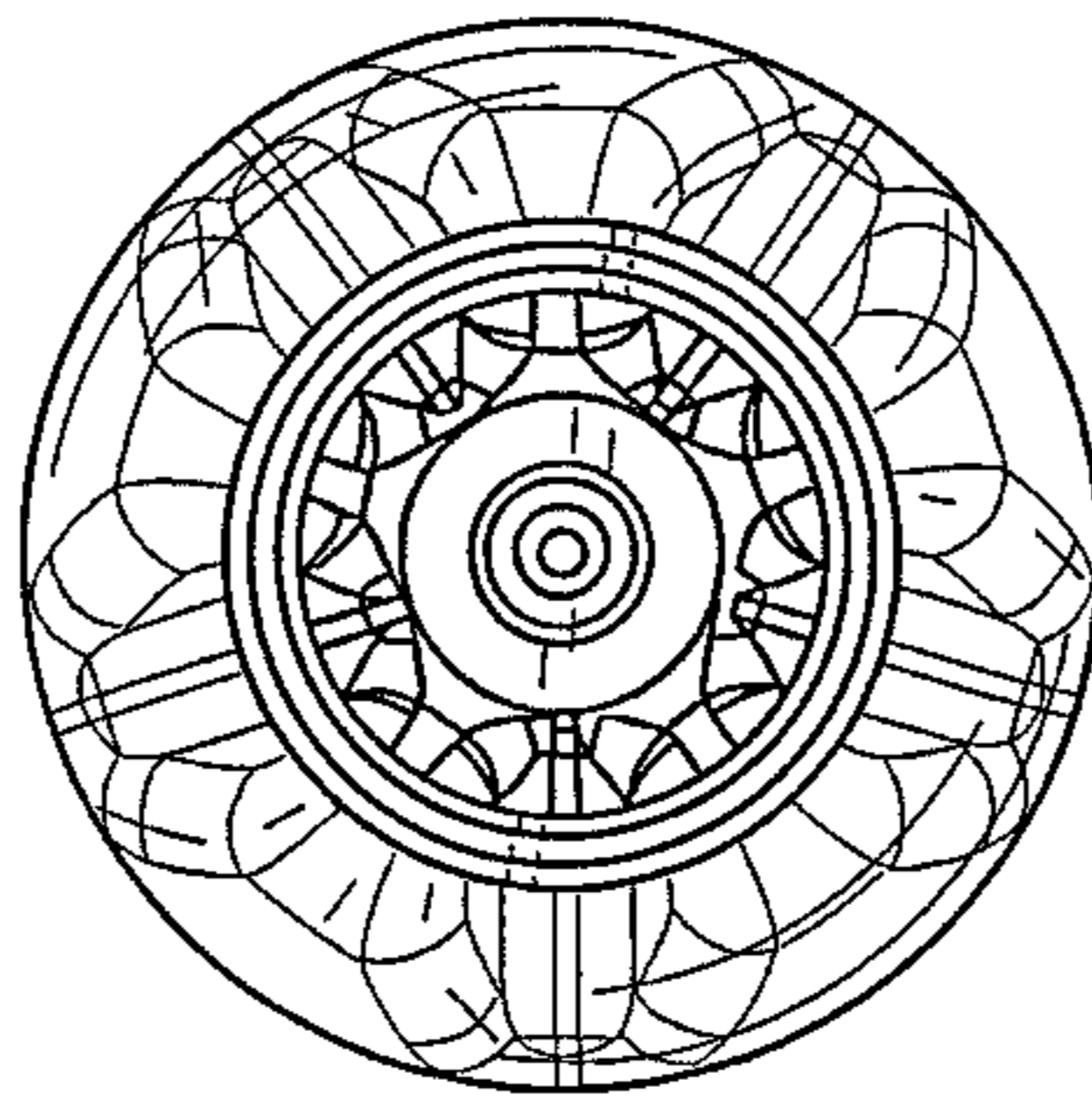

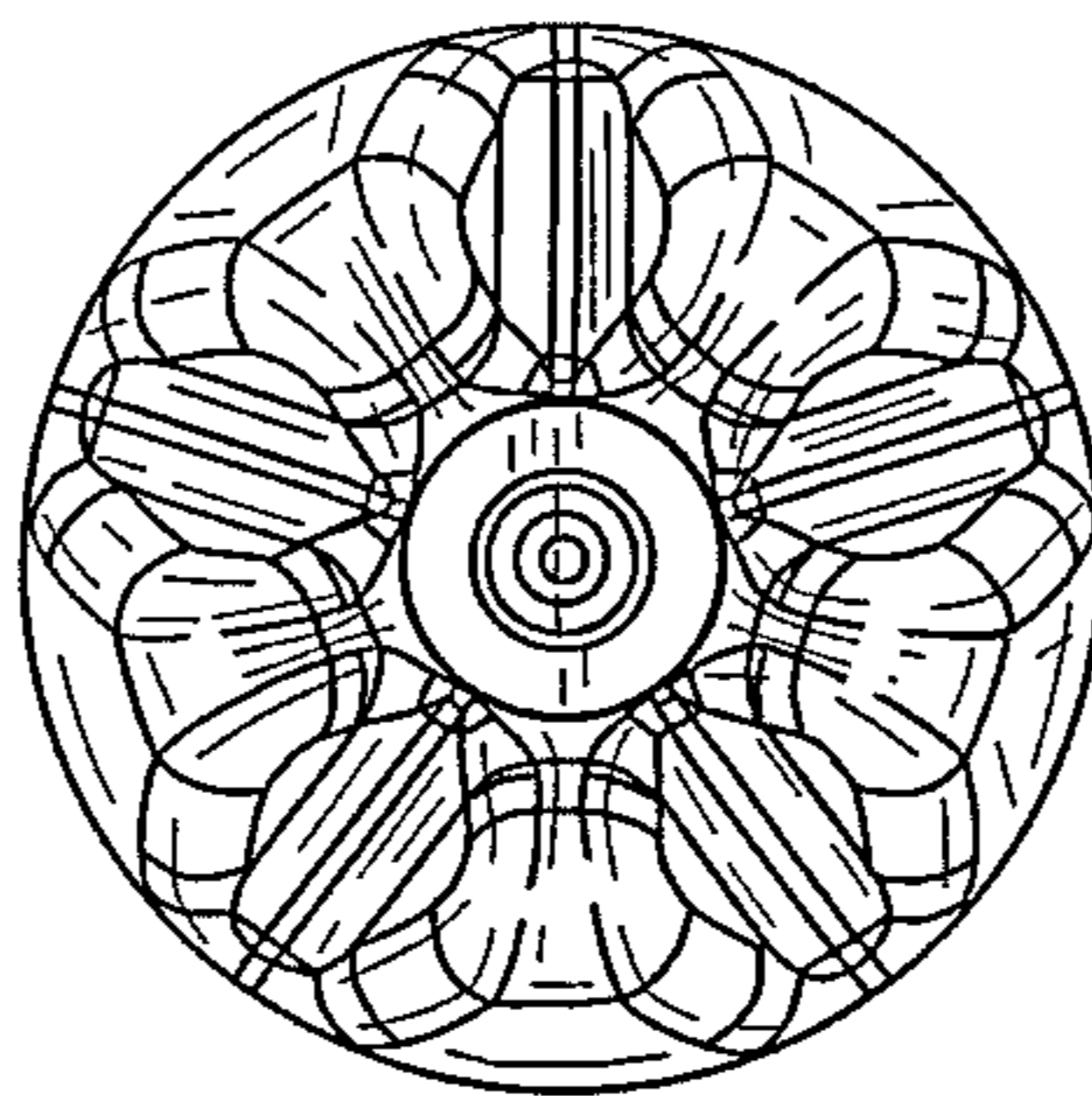

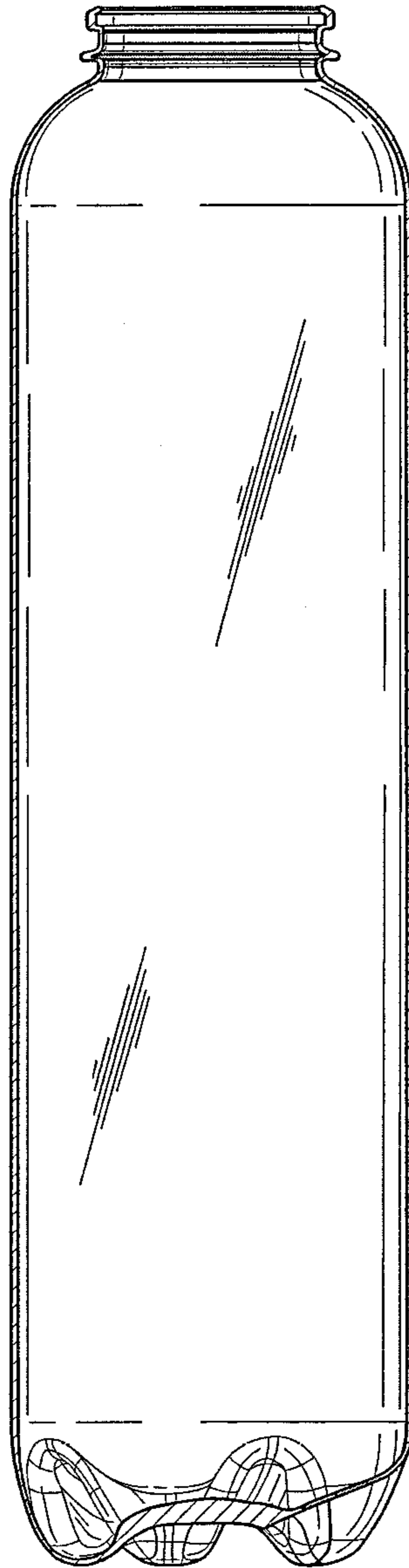

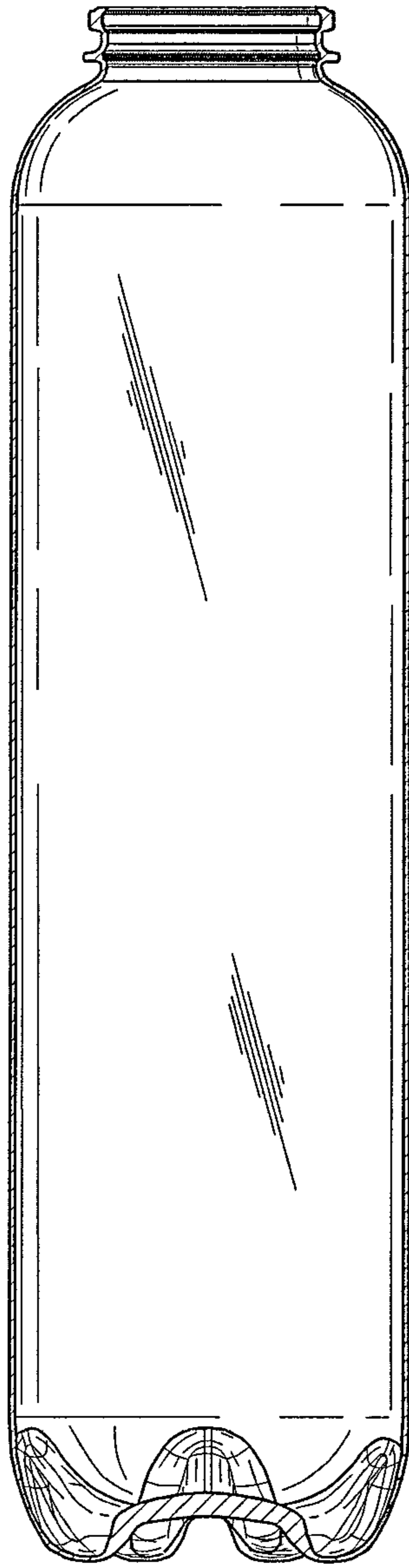
