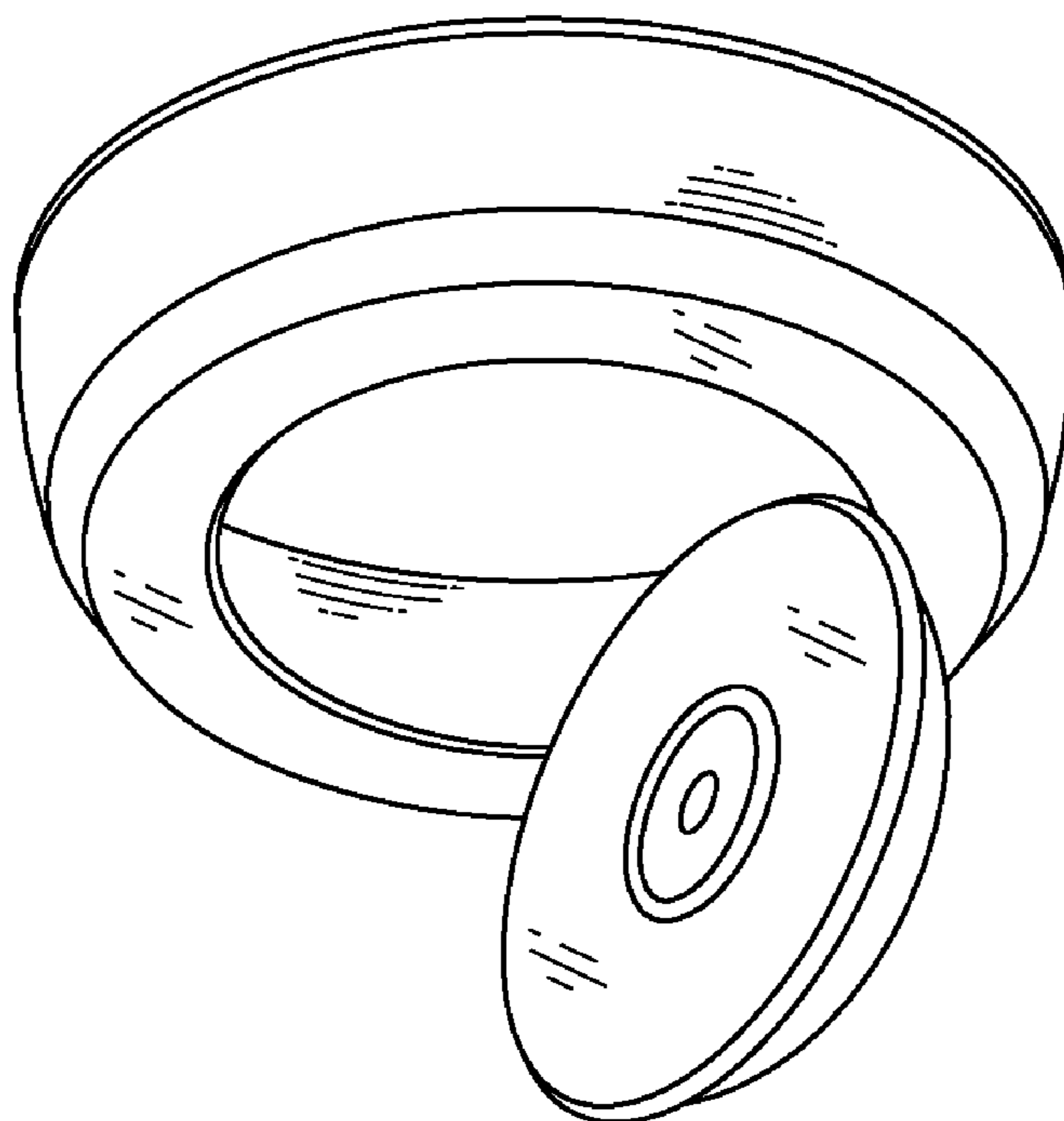
(57) **CLAIM**

The ornamental design of a directional downlight, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a directional downlight accord-
ing to the present invention in a closed position.
FIG. 2 is a side elevation view of the directional downlight
illustrated in FIG. 1.
FIG. 3 is a bottom plan view of the directional downlight
illustrated in FIG. 1.
FIG. 4 is a top plan view of the directional downlight illus-
trated in FIG. 1.
FIG. 5 is a perspective view of the directional downlight
illustrated in FIG. 1 positioned in an open position.
FIG. 6 is a side perspective and elevation view of the direc-
tional downlight illustrated in FIG. 5.
FIG. 7 is a bottom plan view of the directional downlight
illustrated in FIG. 5; and,
FIG. 8 is an exploded perspective view of directional down-
light illustrated in FIG. 1.

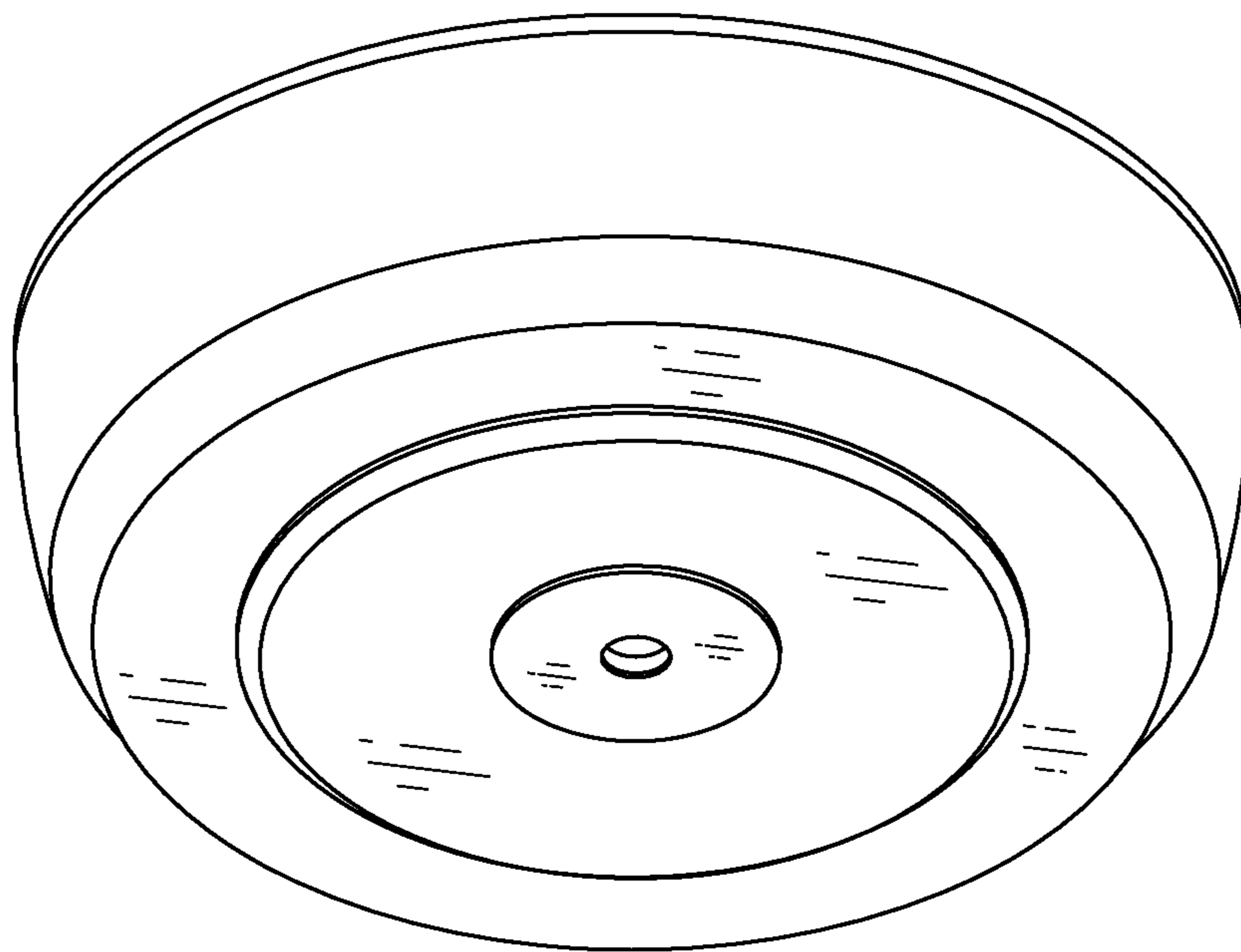

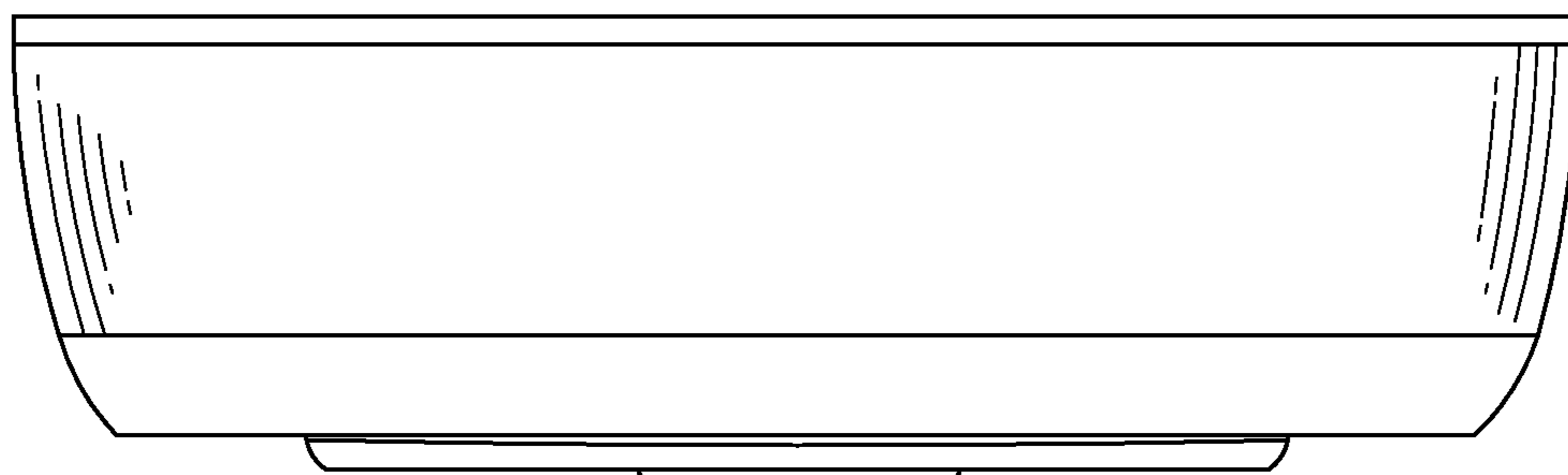

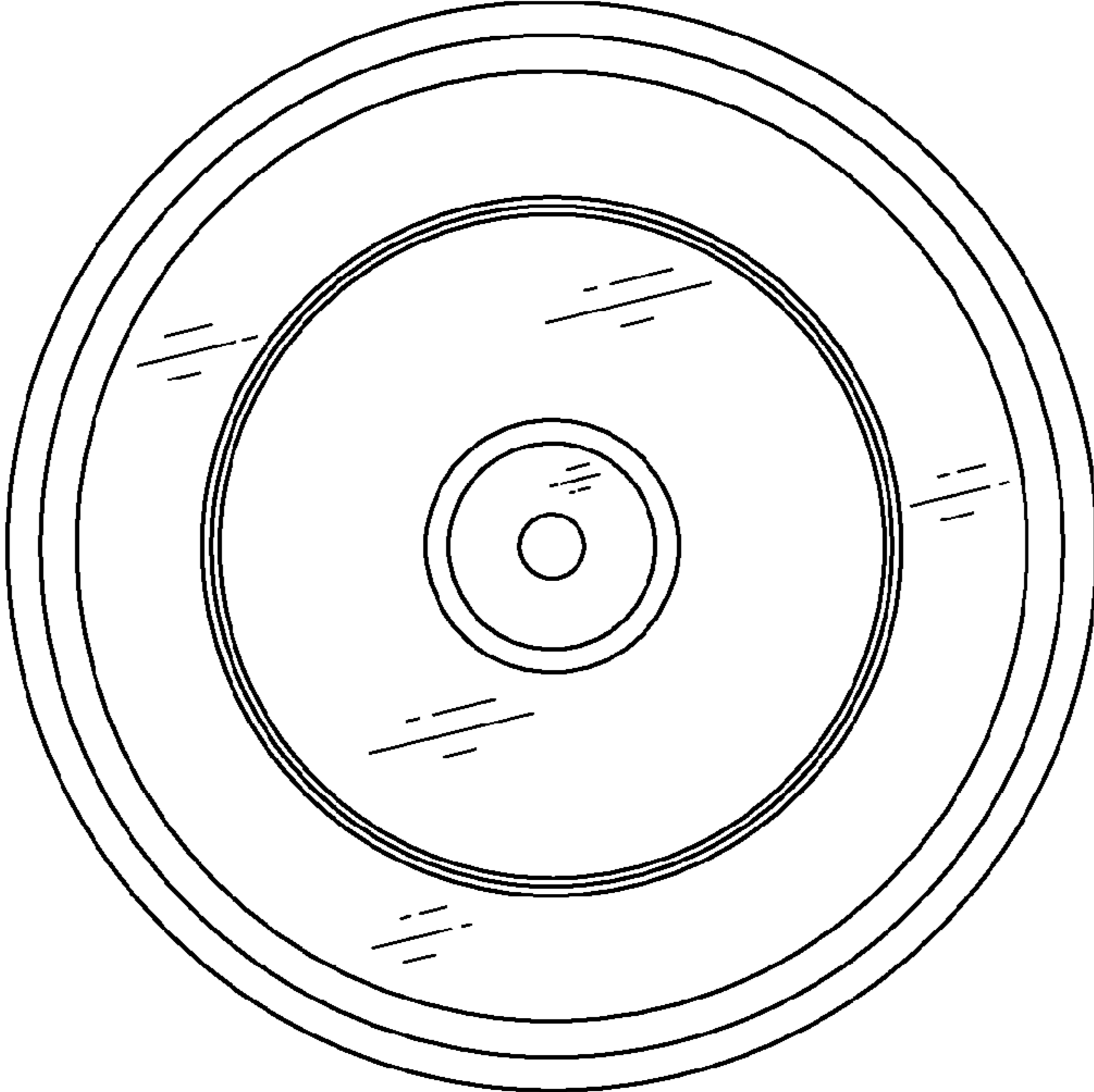

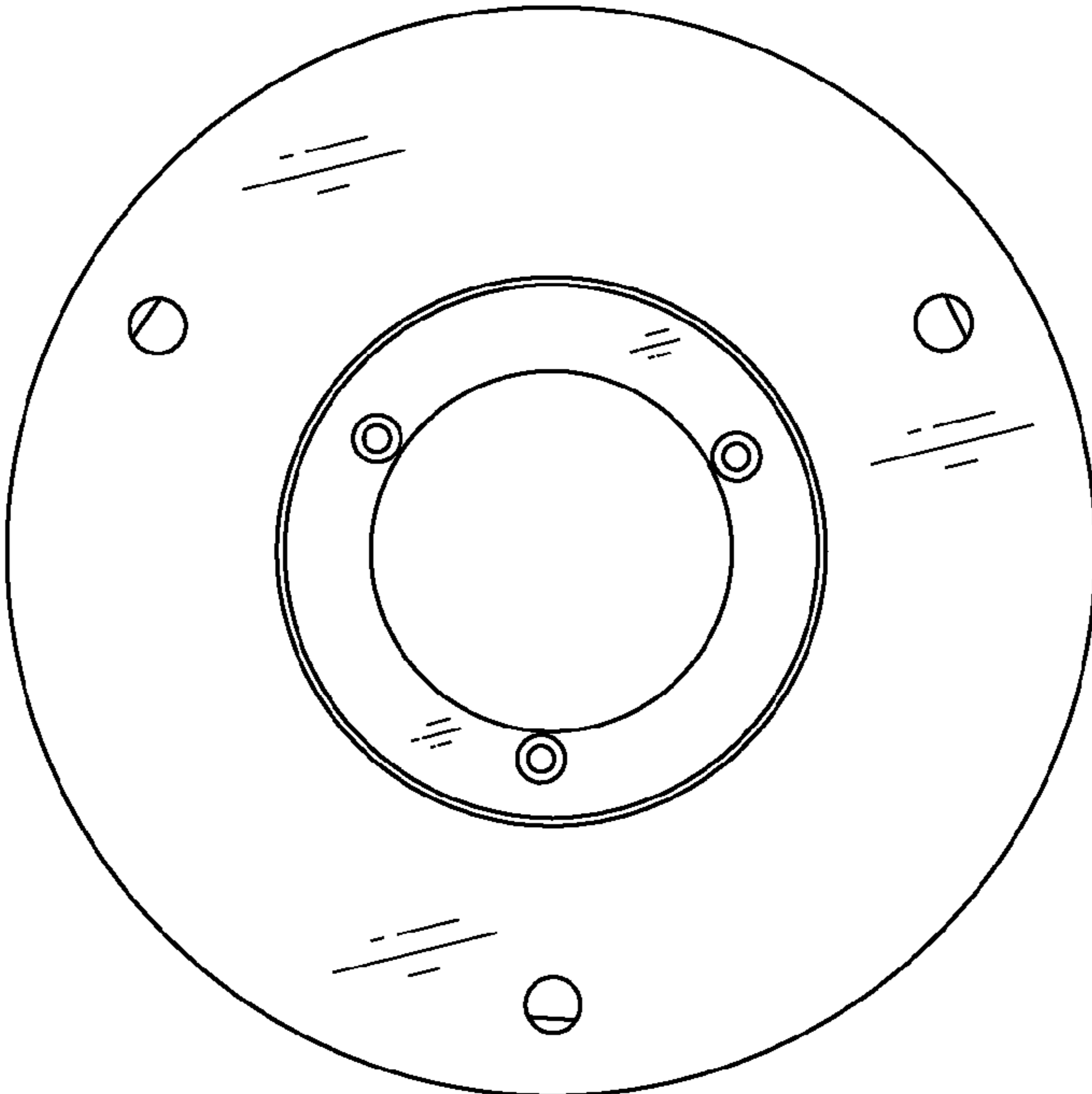

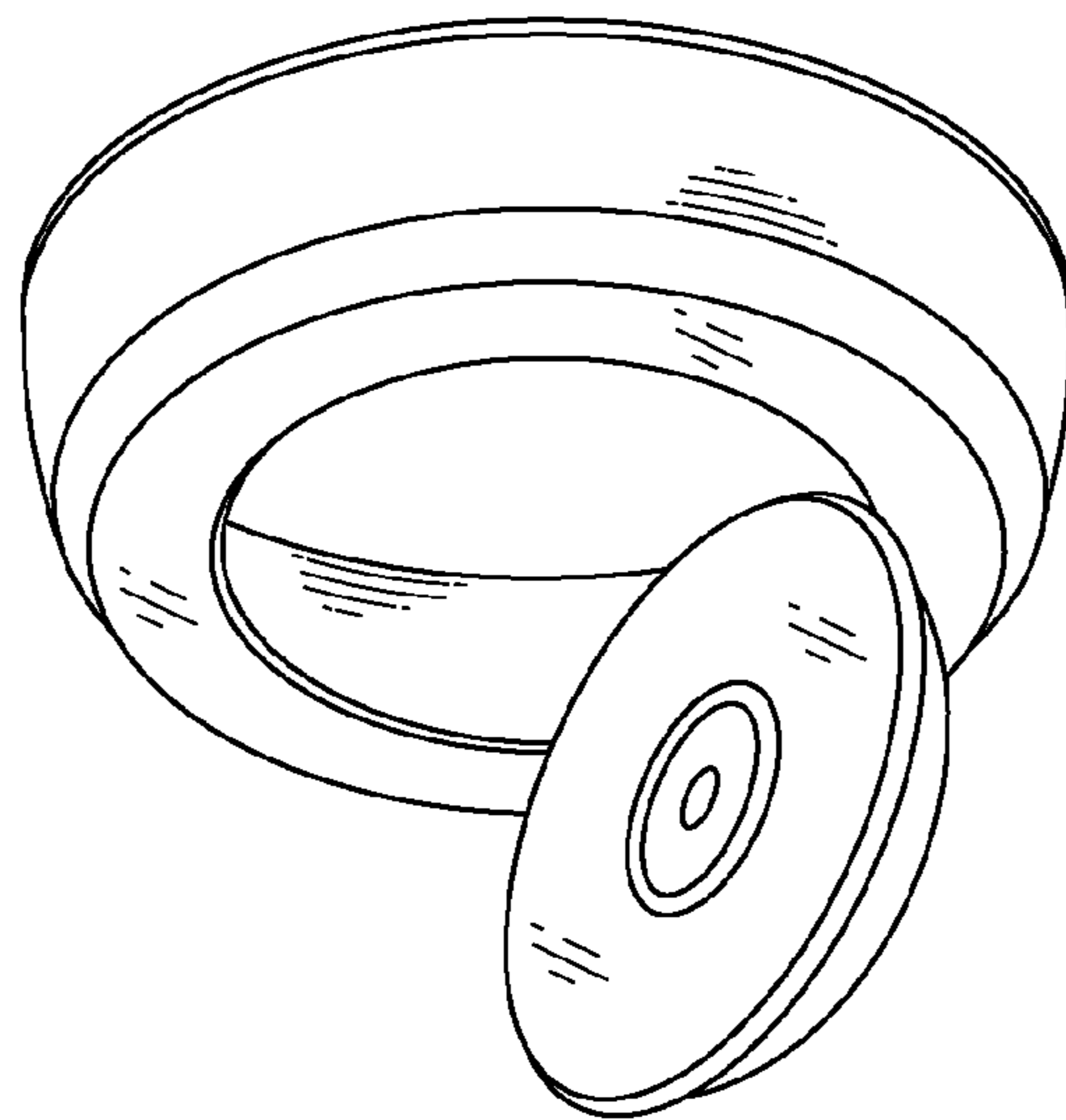

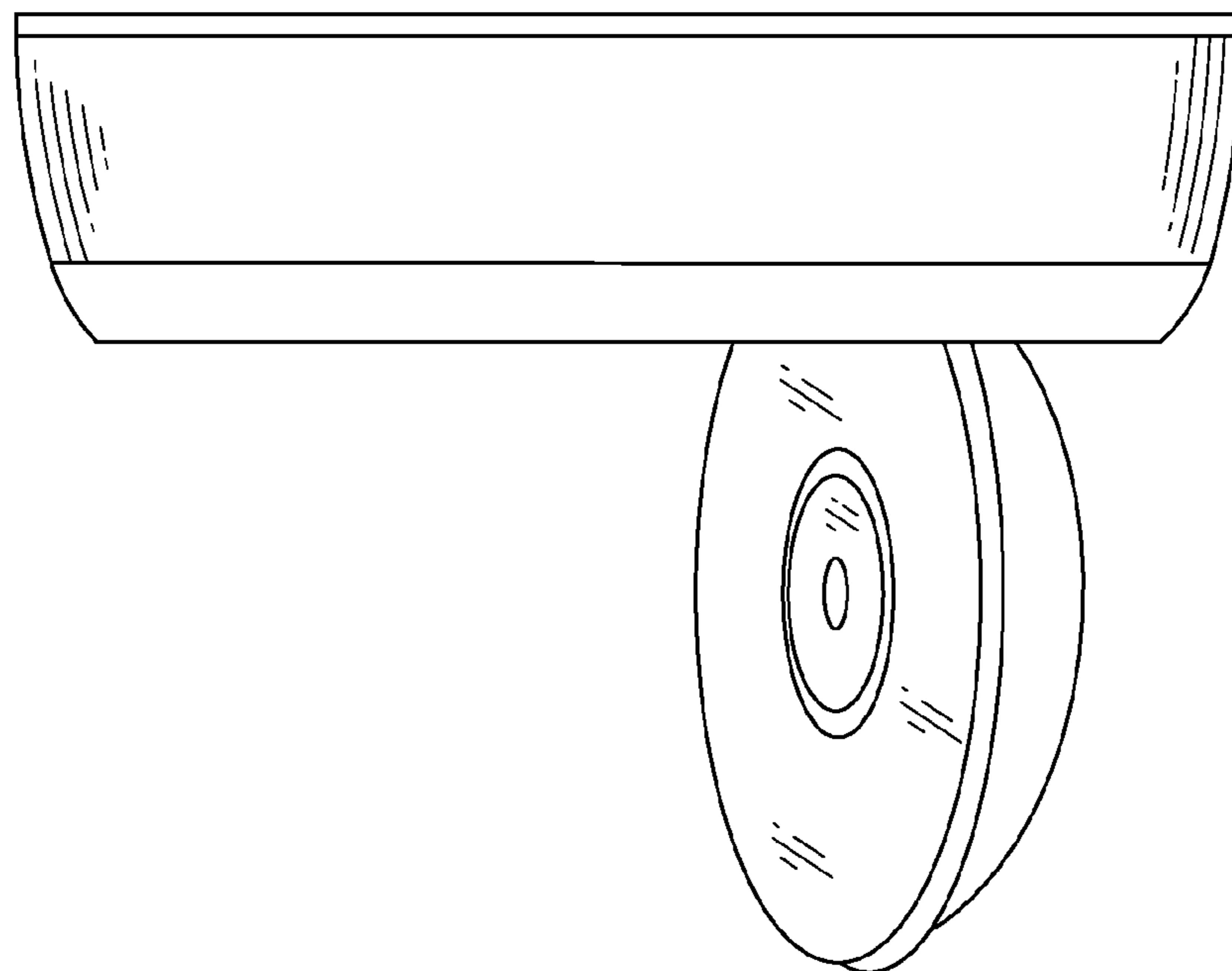

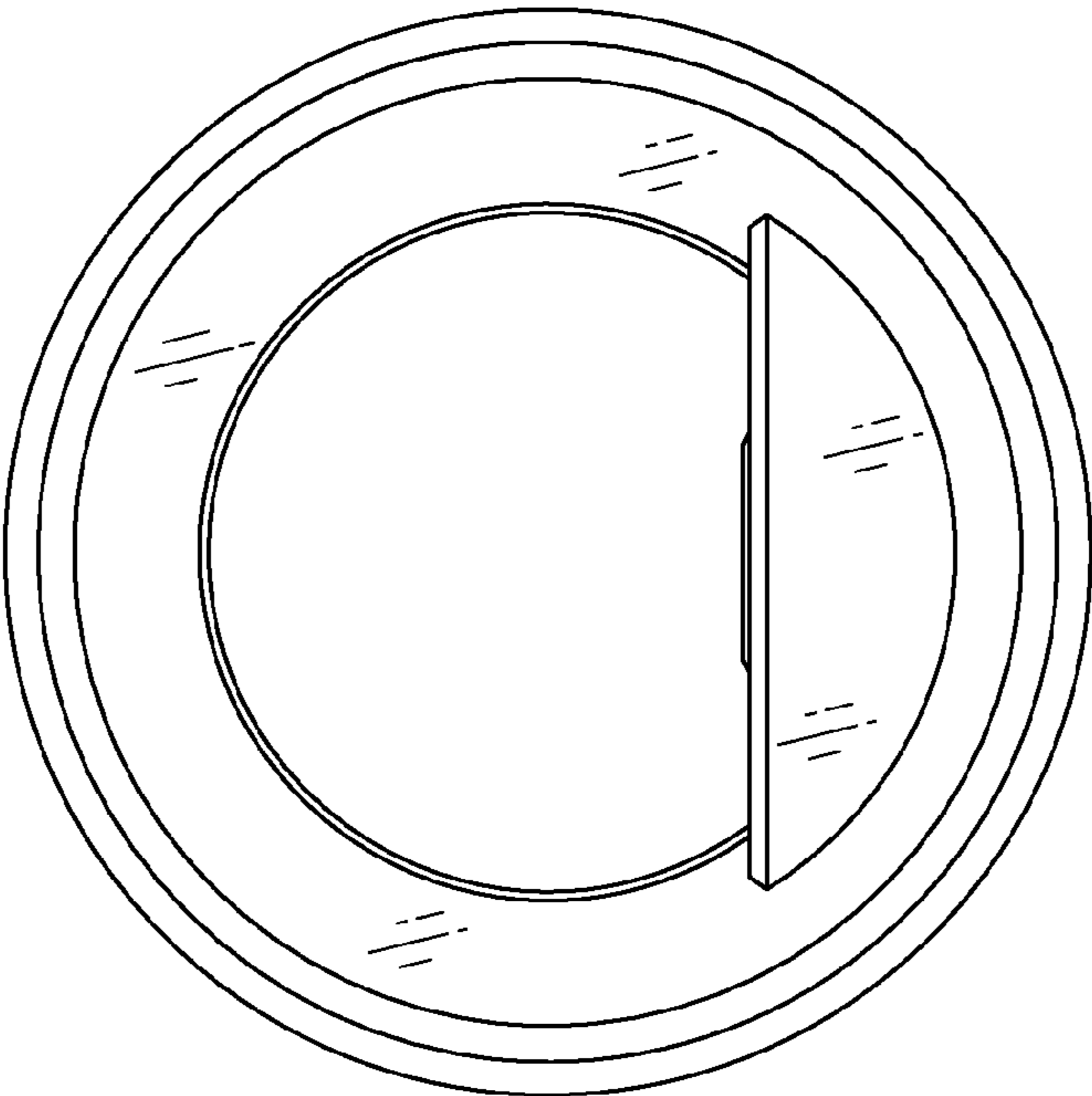

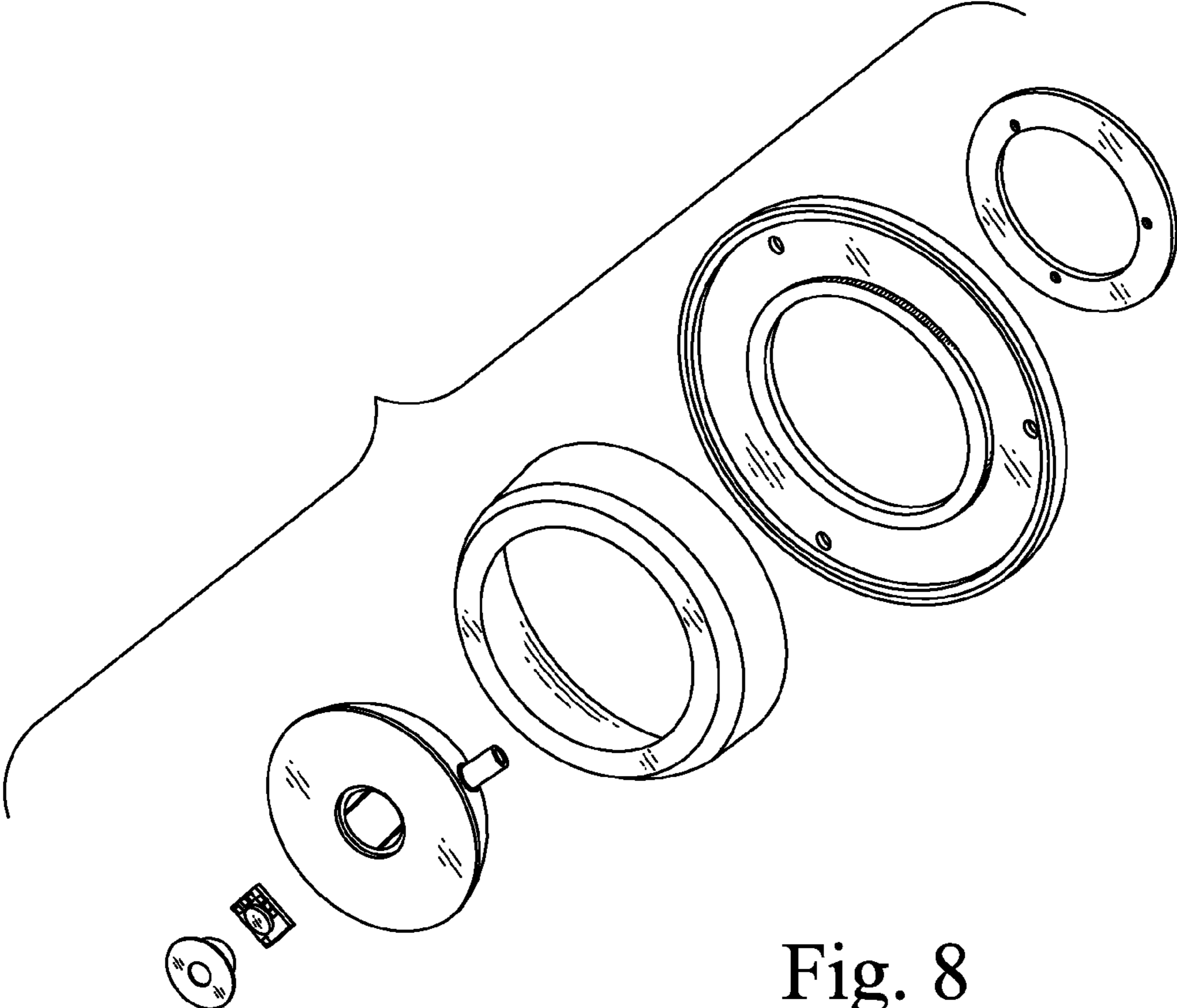
