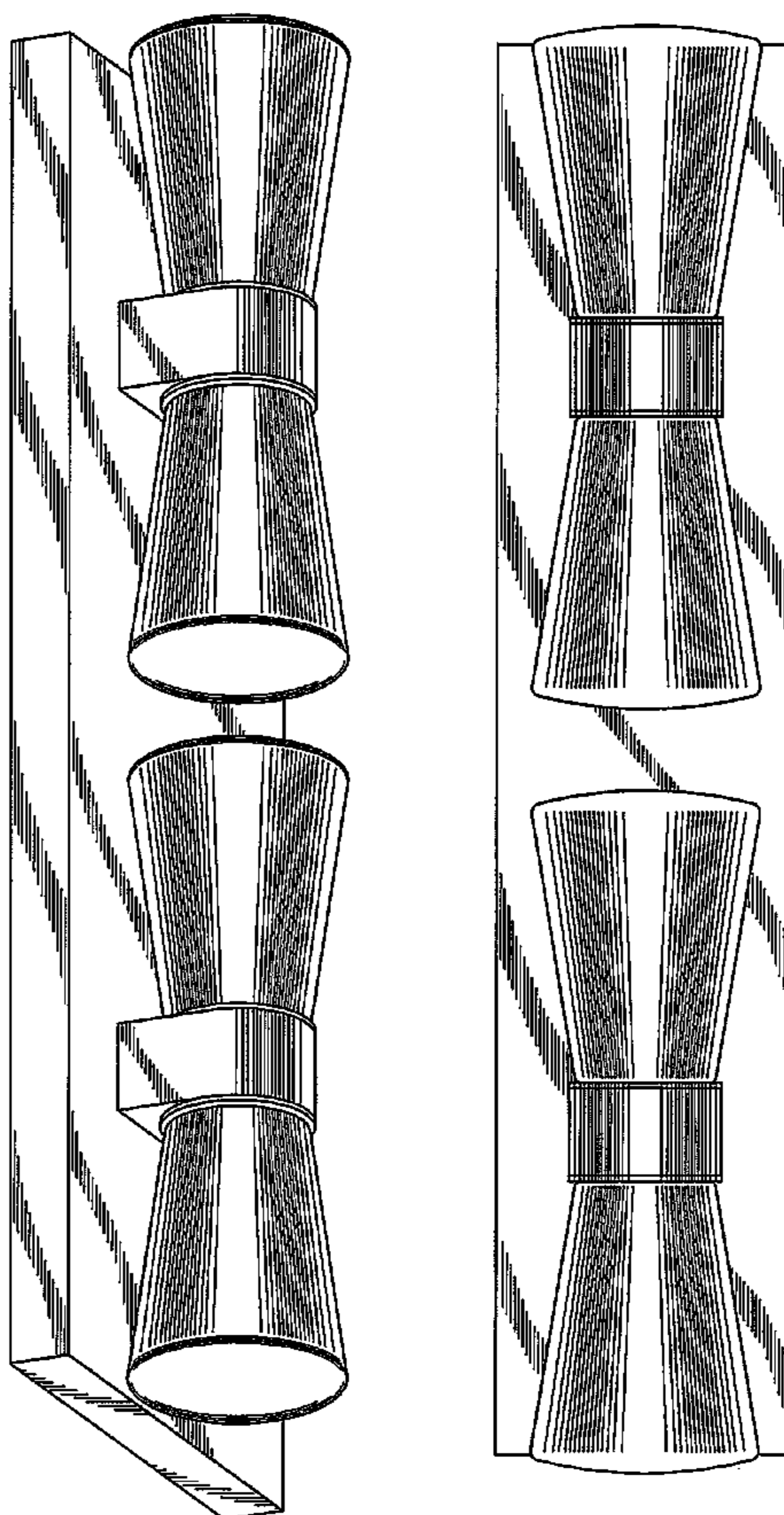

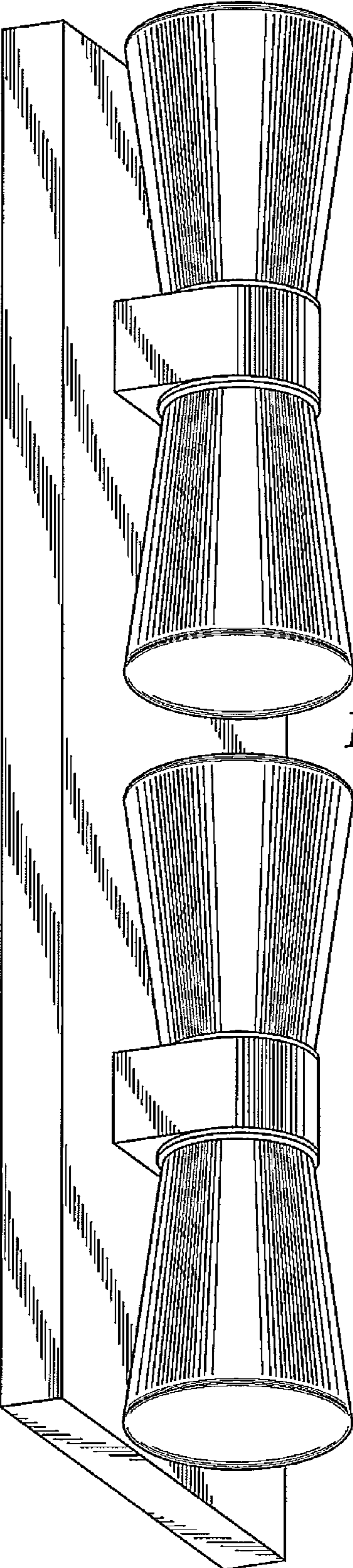
The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

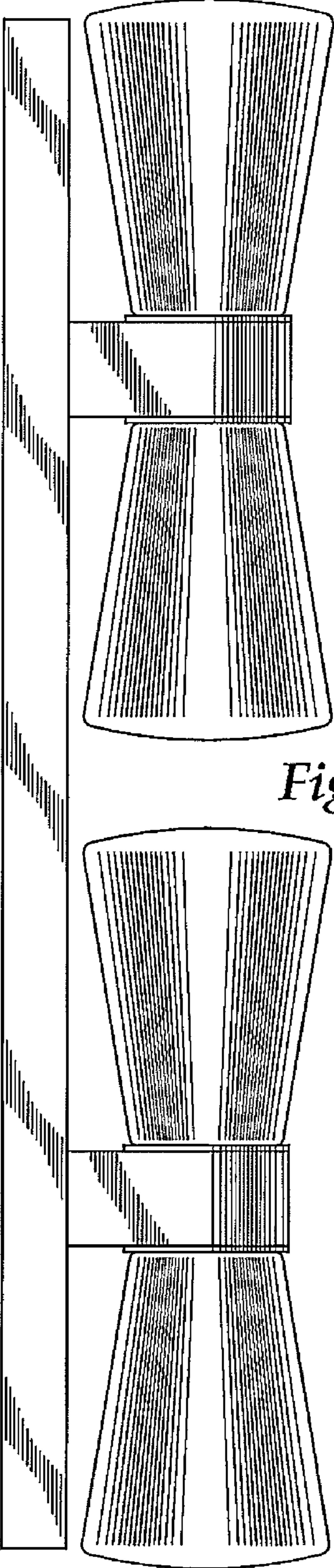
FIG. 1 is a perspective view of a light fixture in accordance with my design;

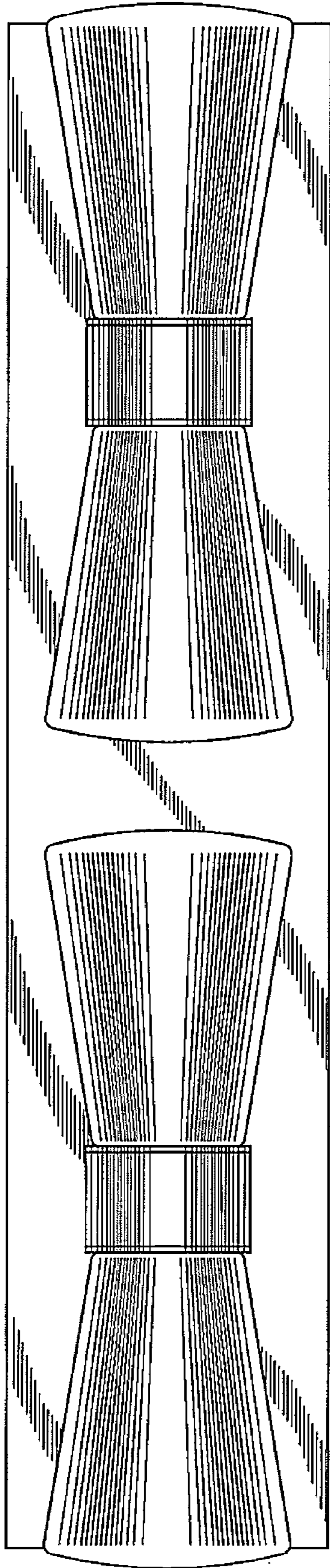




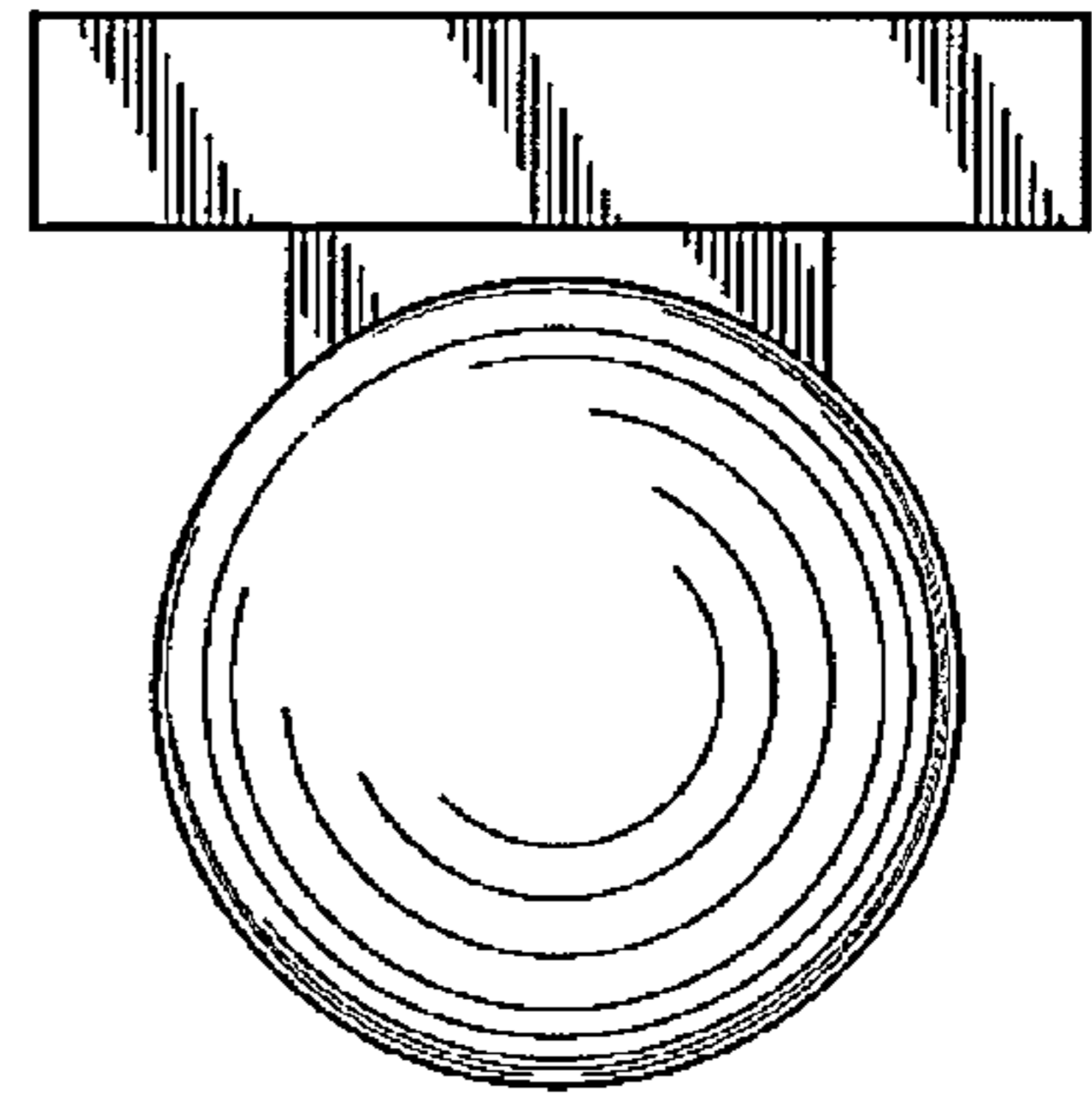
