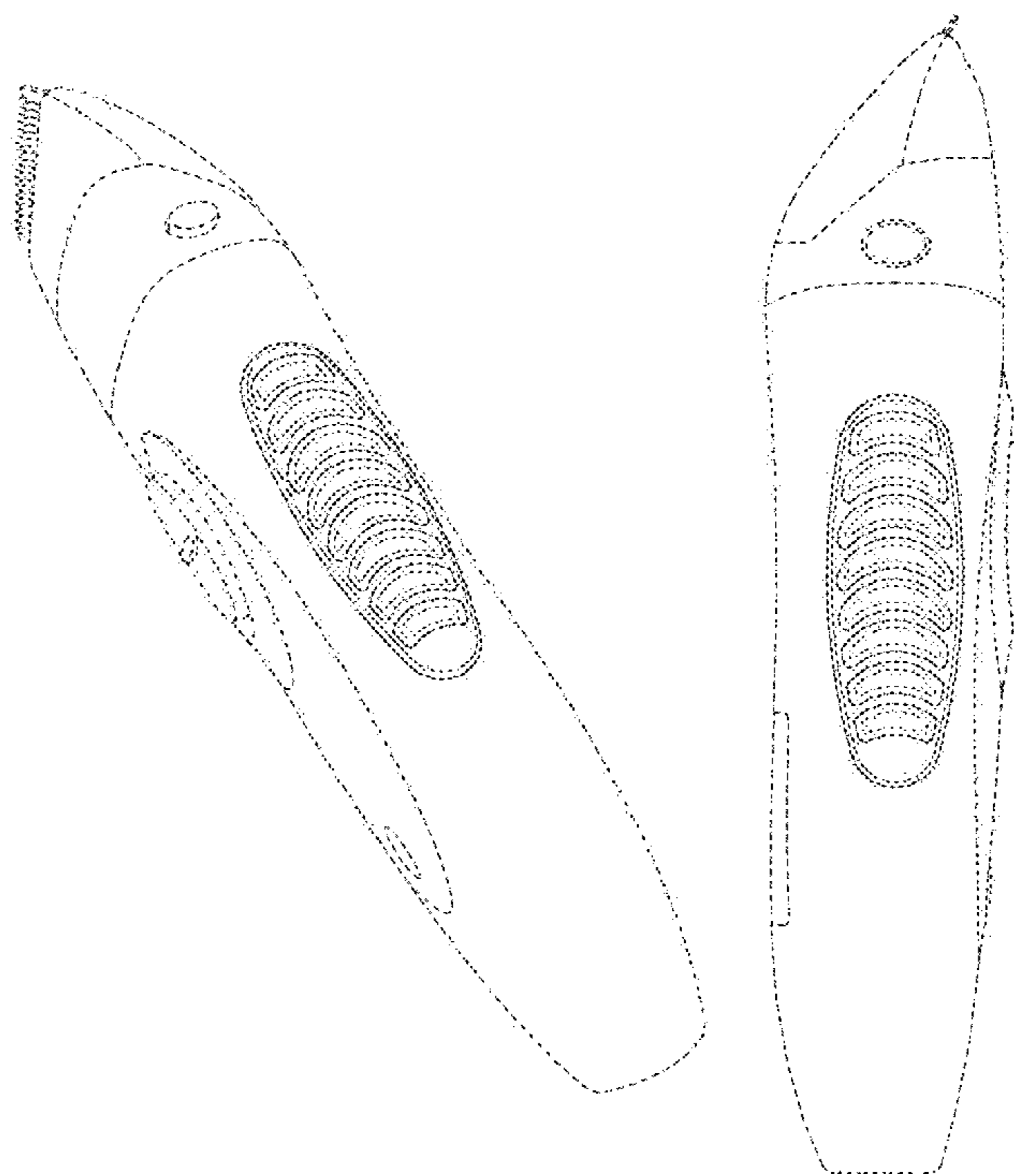
(57) **CLAIM**

The ornamental design for a clipper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a clipper showing our new design;  
FIG. 2 is a front view of the design shown in FIG. 1;  
FIG. 3 is a back view of the design shown in FIG. 1;  
FIG. 4 is a left side view of the design shown in FIG. 1; the right side view being a mirror image thereof;

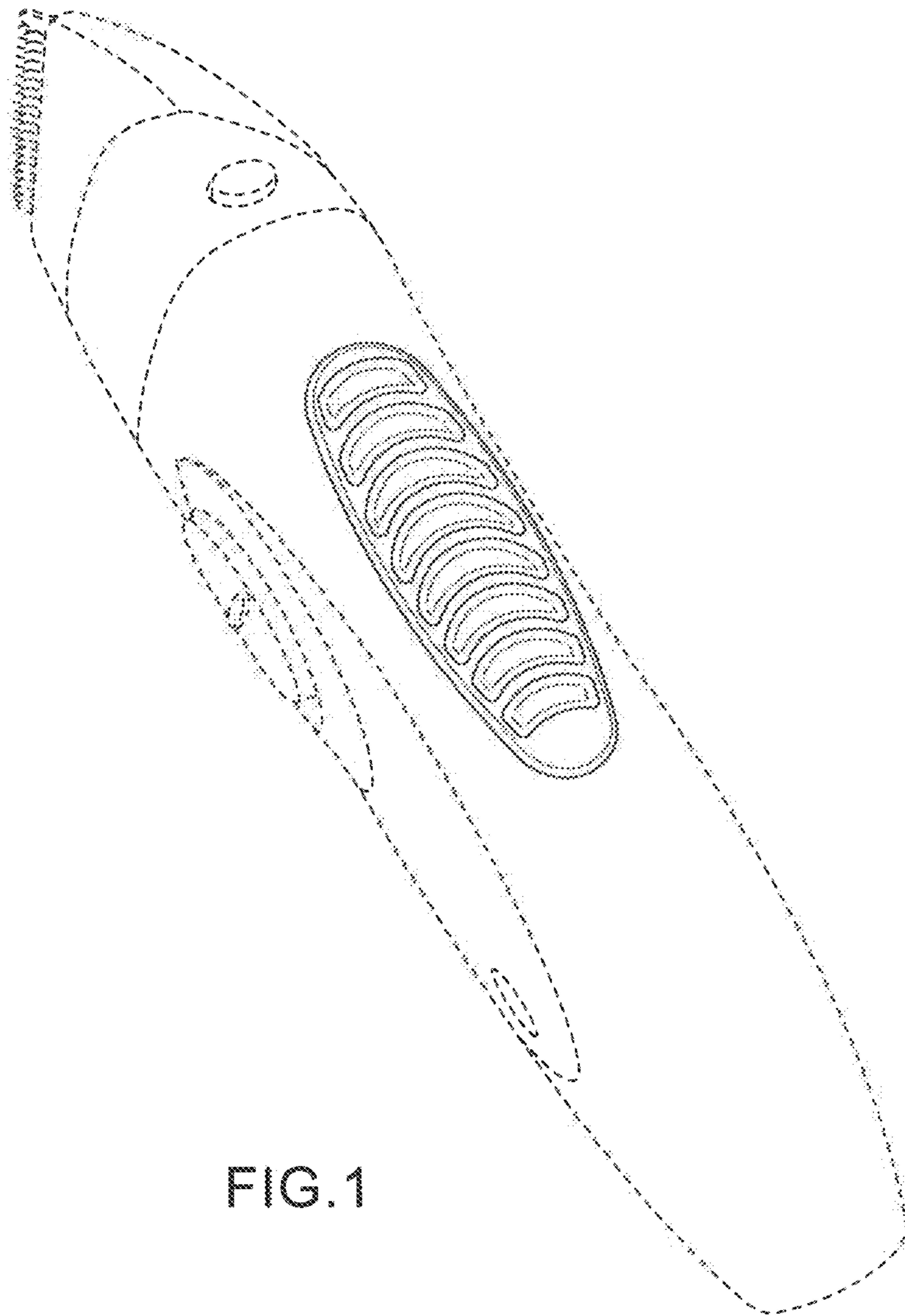

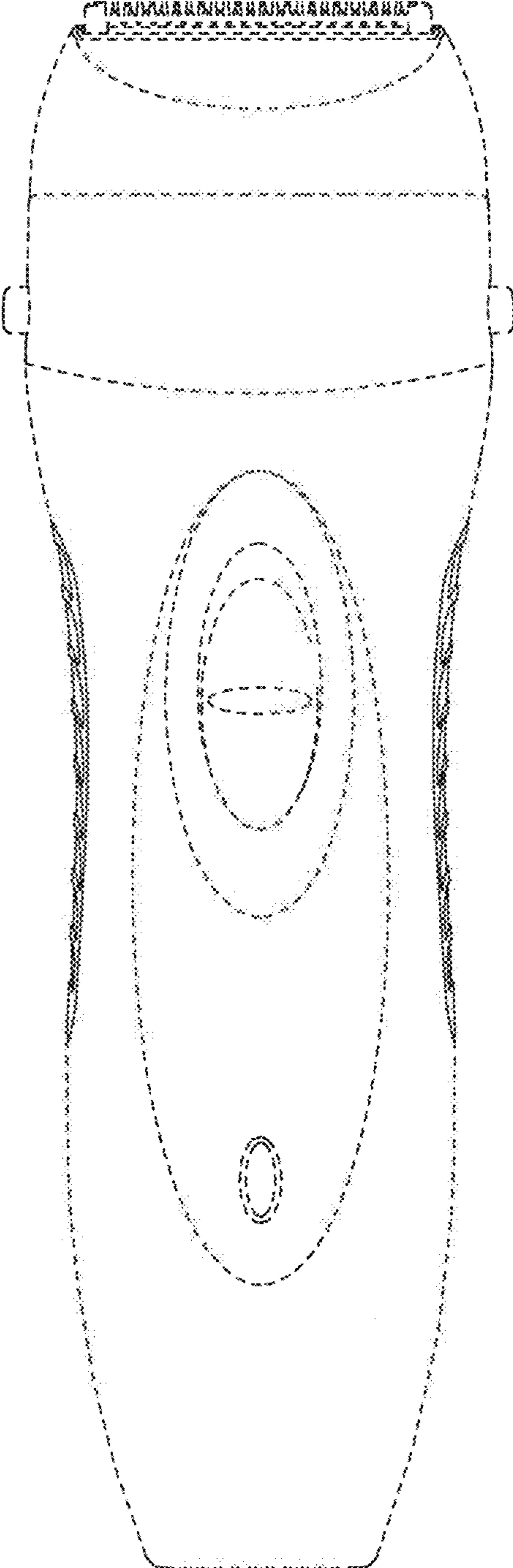

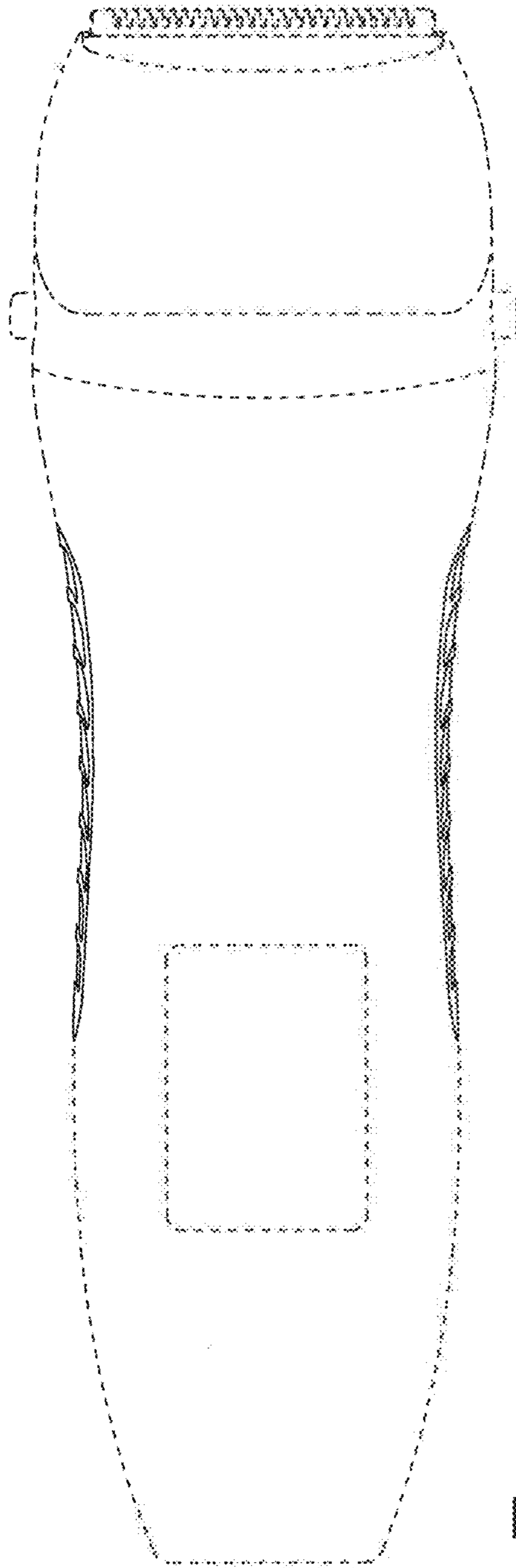

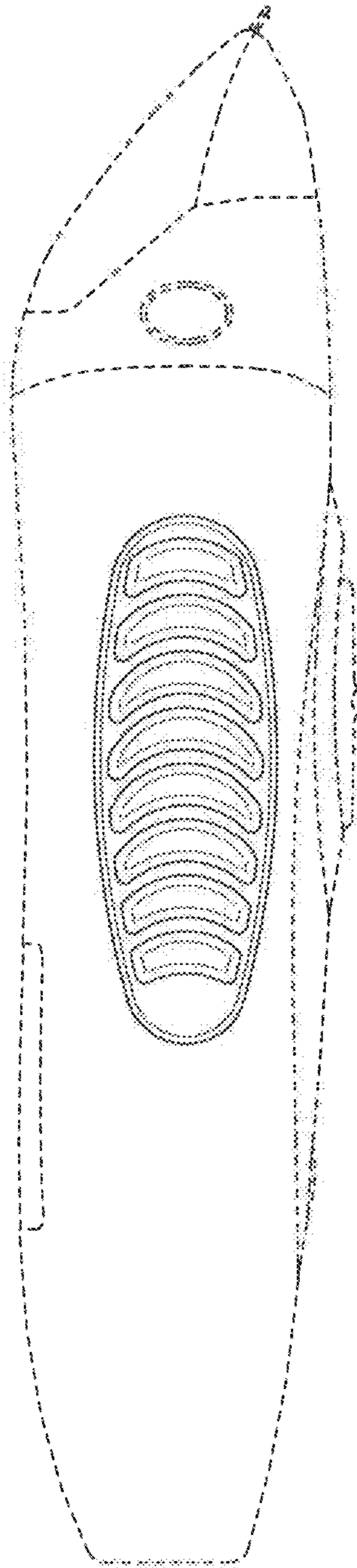

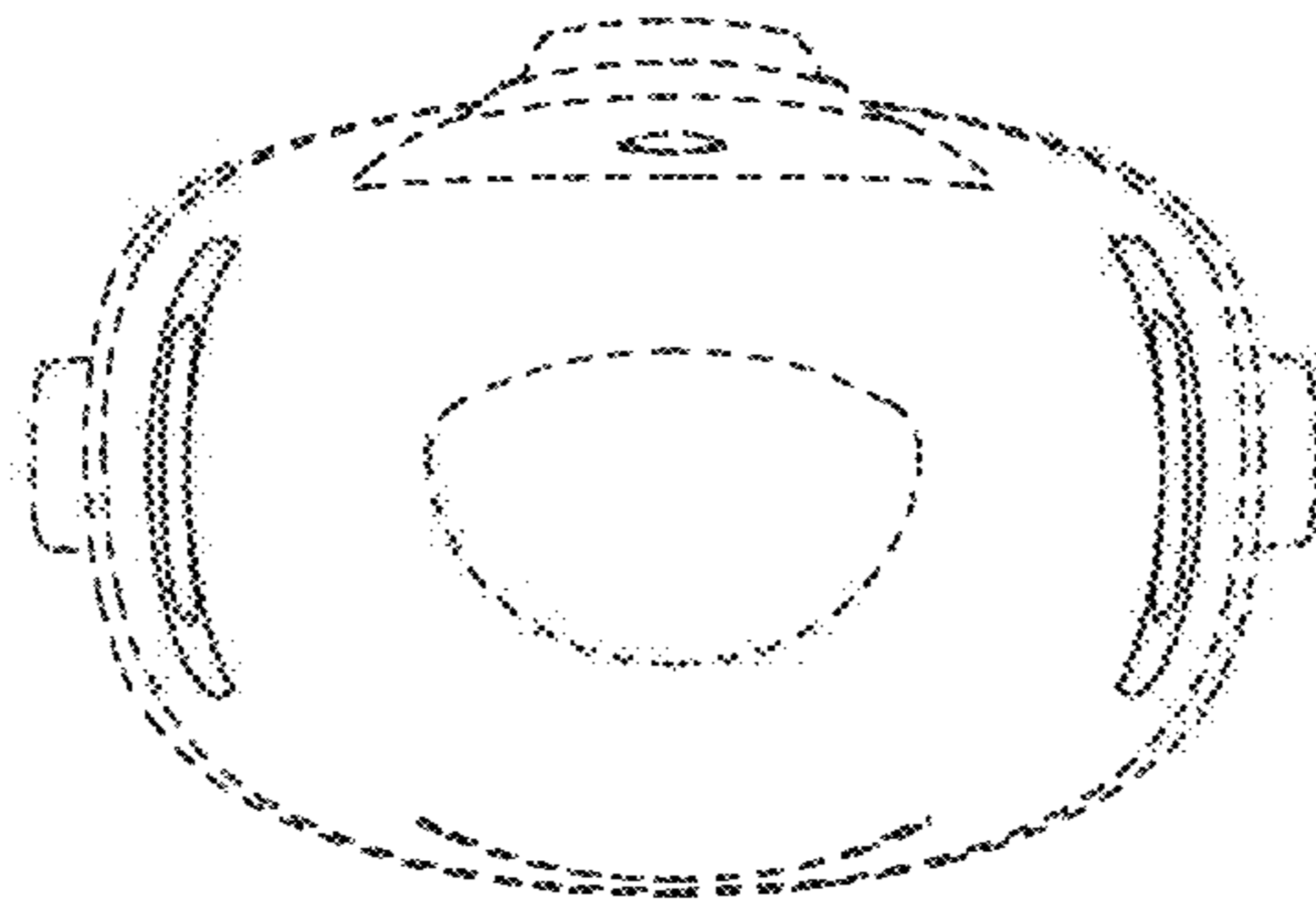

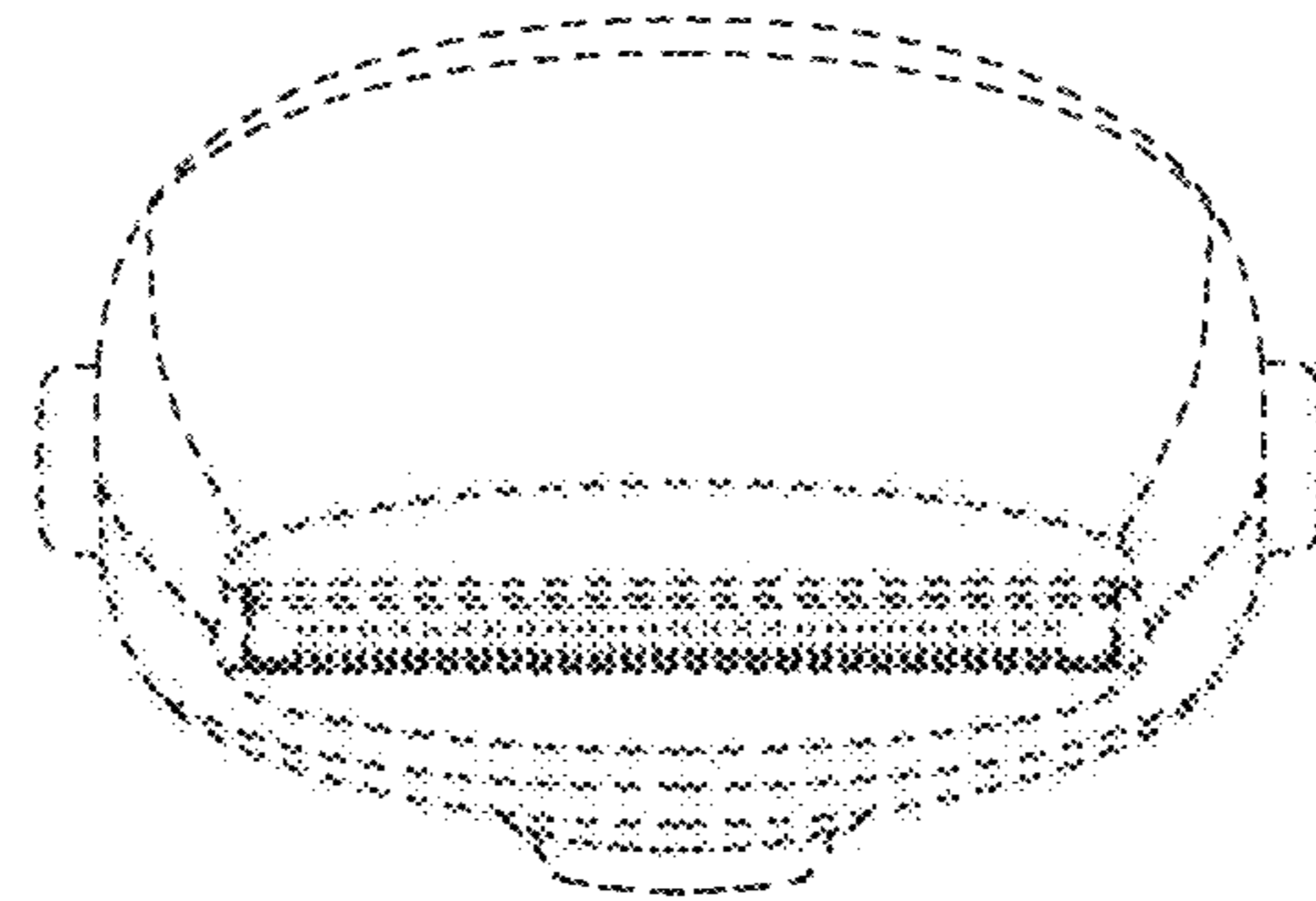
