The ornamental design for wire crate with blow molded base, as shown and described.

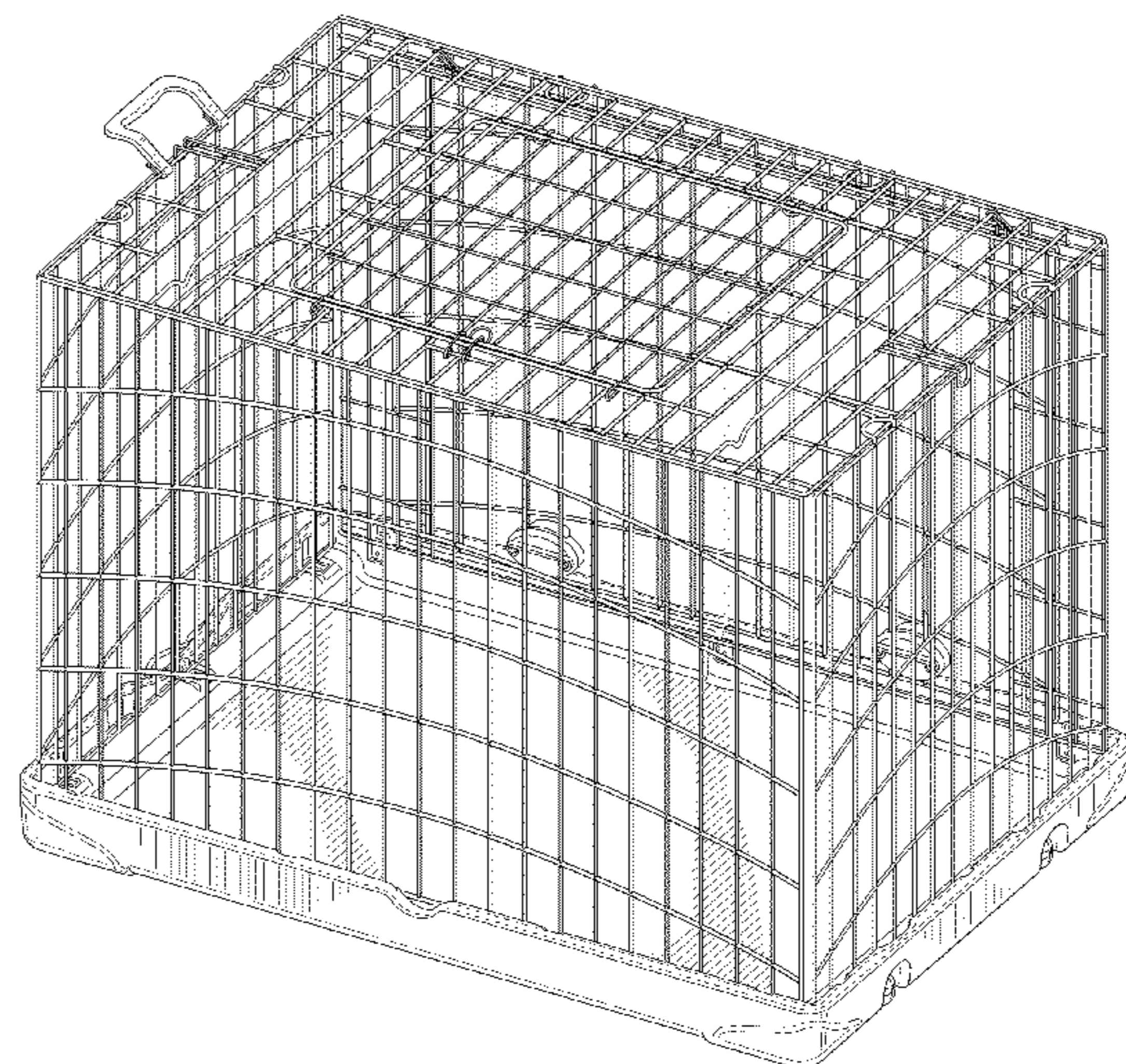
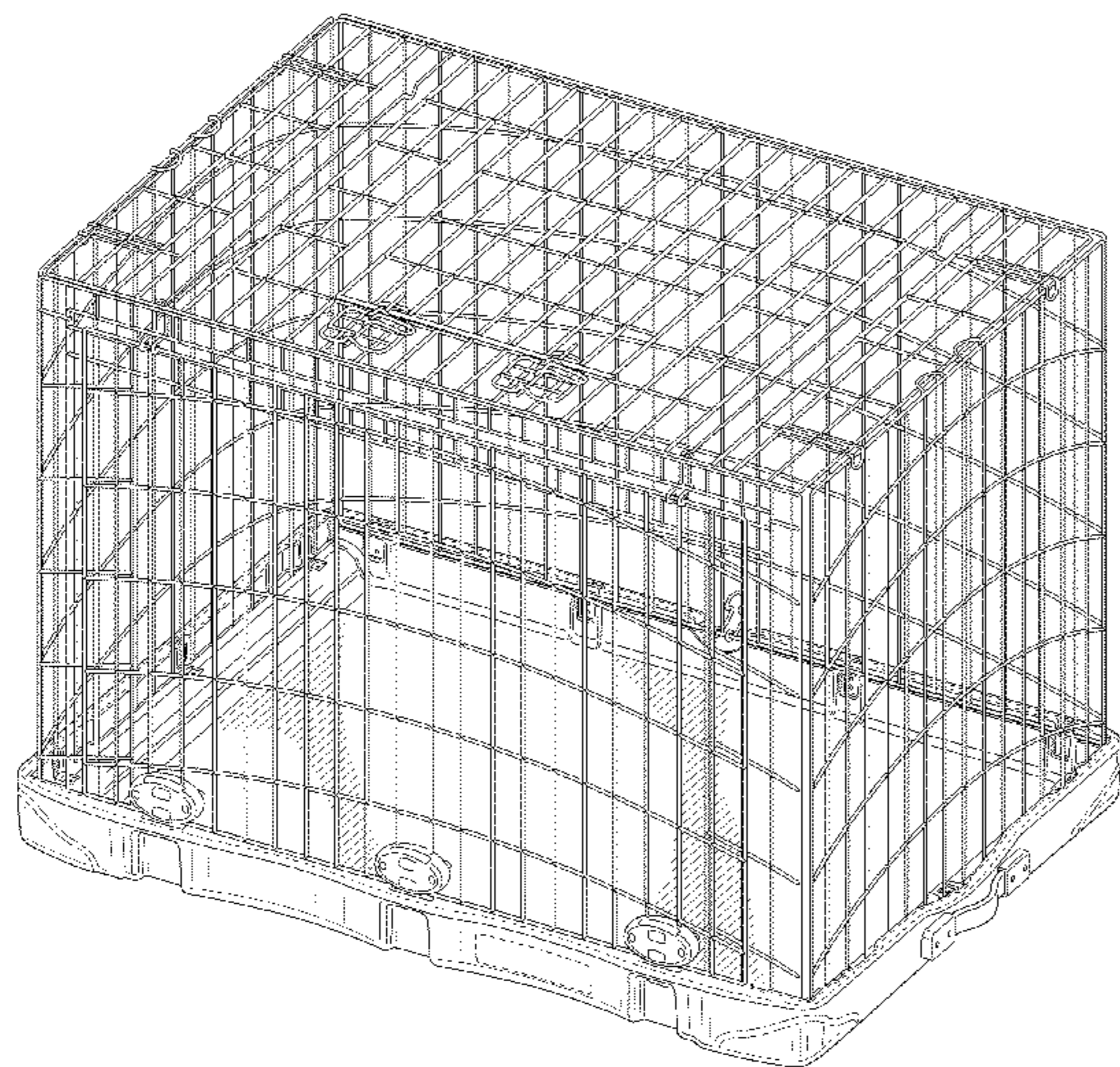
DESCRIPTION

FIG. 1 is a top rear perspective view of a first embodiment of a wire crate with blow molded base in accordance with our new design;

FIG. 2 is a top front perspective thereof;
FIG. 3 is a bottom rear perspective thereof;
FIG. 4 is a bottom front perspective thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a right side elevational view thereof;
FIG. 8 is a left side elevational view thereof;
FIG. 9 is a top view thereof;
FIG. 10 is a bottom view thereof;
FIG. 11 is a partial cross-section view taken along line 11-11 in FIG. 10;
FIG. 12 is a partial cross-section view taken along line 12-12 in FIG. 10;
FIG. 13 is a top rear perspective view of a second embodiment of a wire crate with blow molded base;
FIG. 14 is a top front perspective of FIG. 13;
FIG. 15 is a bottom rear perspective of FIG. 13;
FIG. 16 is a bottom front perspective of FIG. 13;
FIG. 17 is a front elevational view of FIG. 13;
FIG. 18 is a rear elevational view of FIG. 13;
FIG. 19 is a right side elevational view of FIG. 13;
FIG. 20 is a left side elevational view of FIG. 13;
FIG. 21 is a top view of FIG. 13;
FIG. 22 is a bottom view of FIG. 13;
FIG. 23 is a partial cross-section view taken along line 23-23 in FIG. 22; and,
FIG. 24 is a partial cross-section view taken along line 24-24 in FIG. 22.

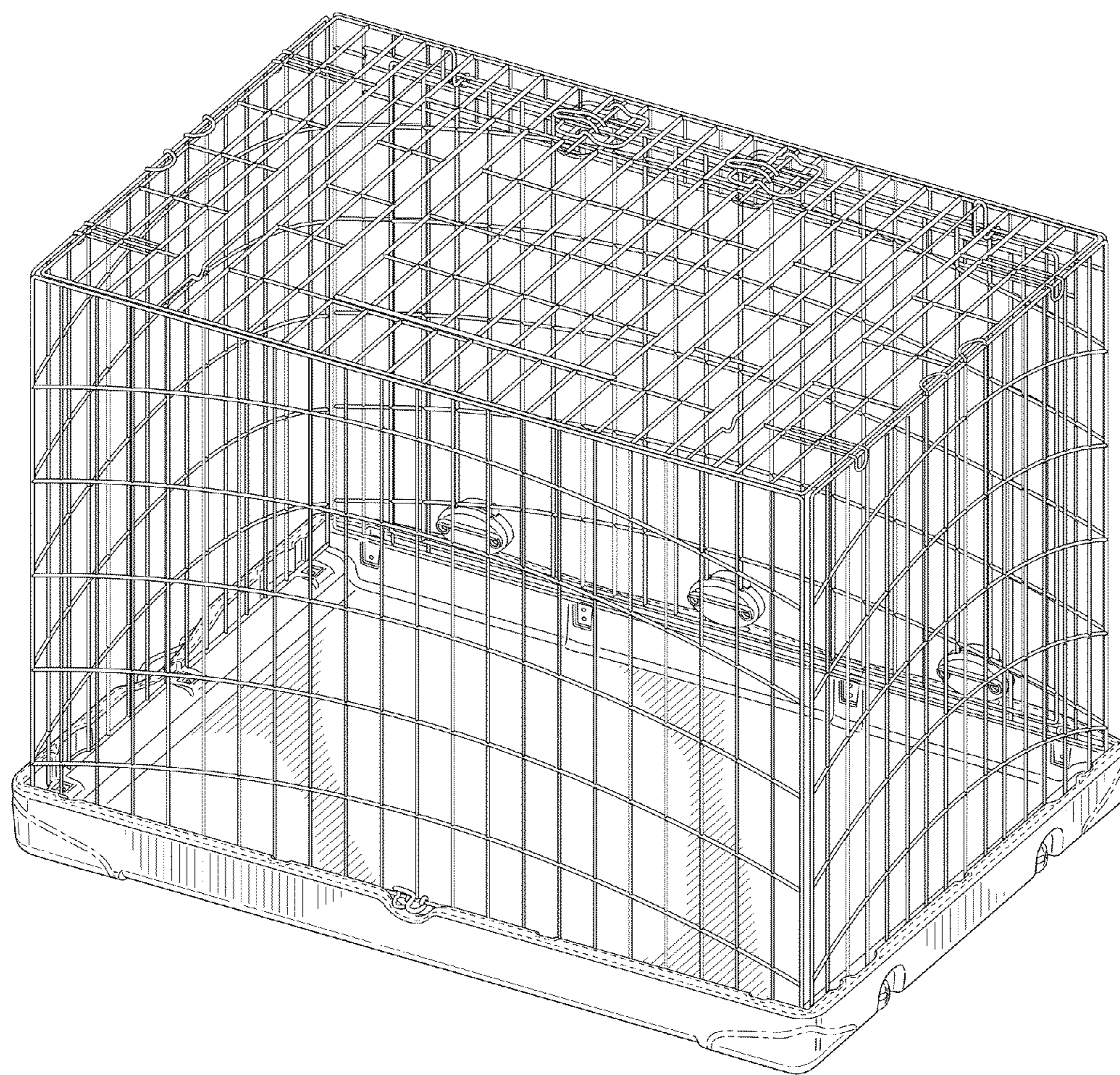

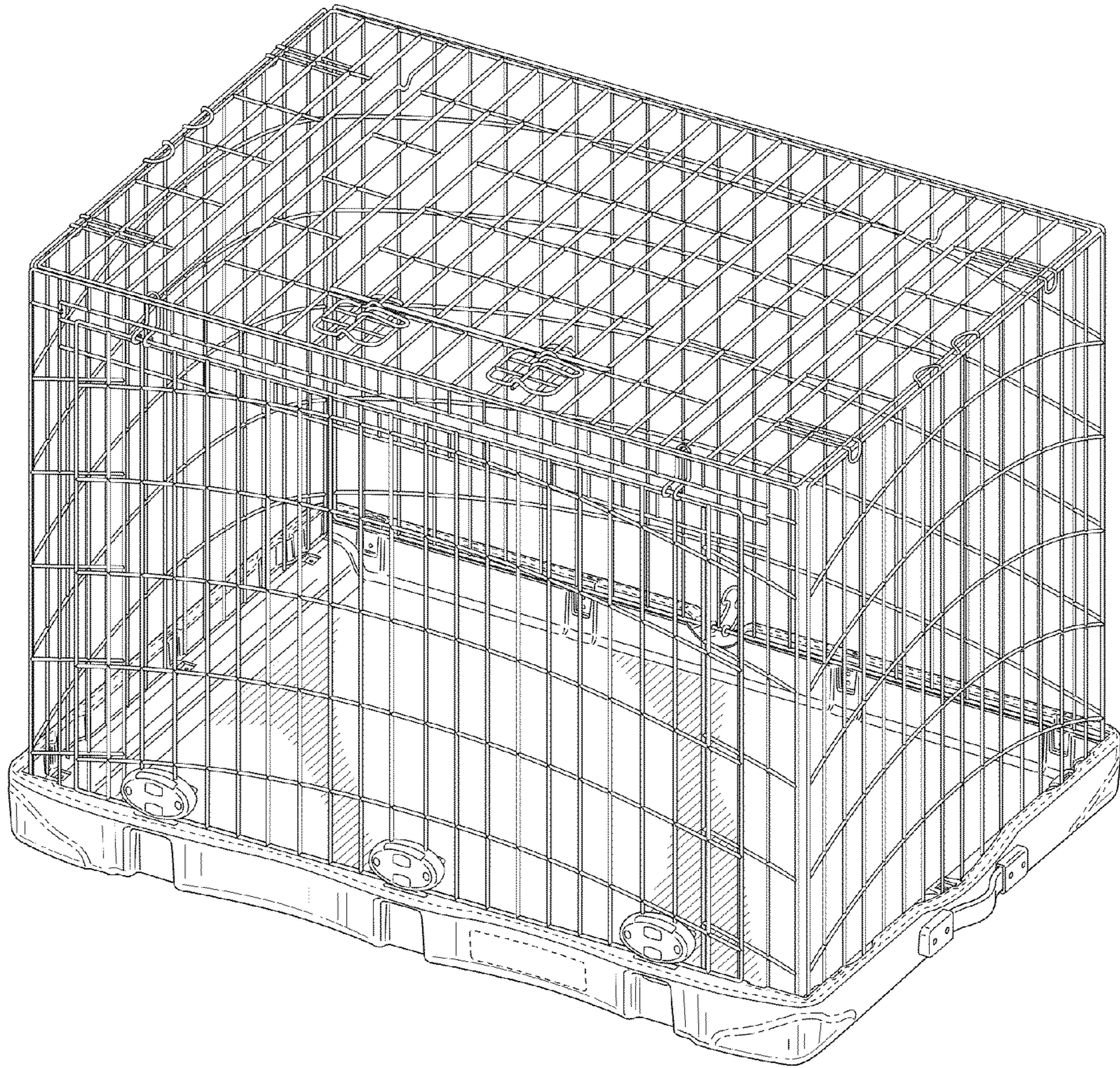

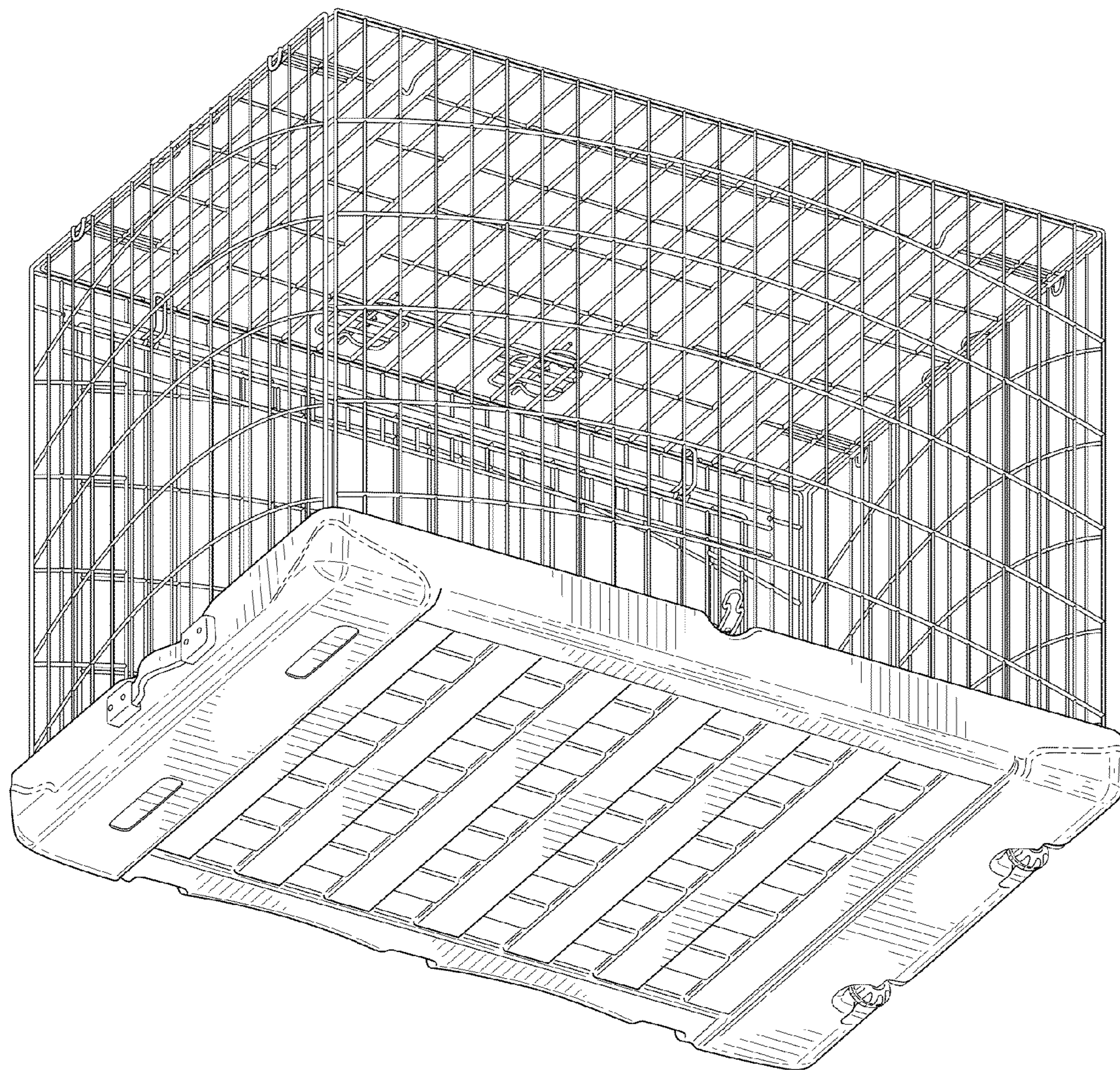

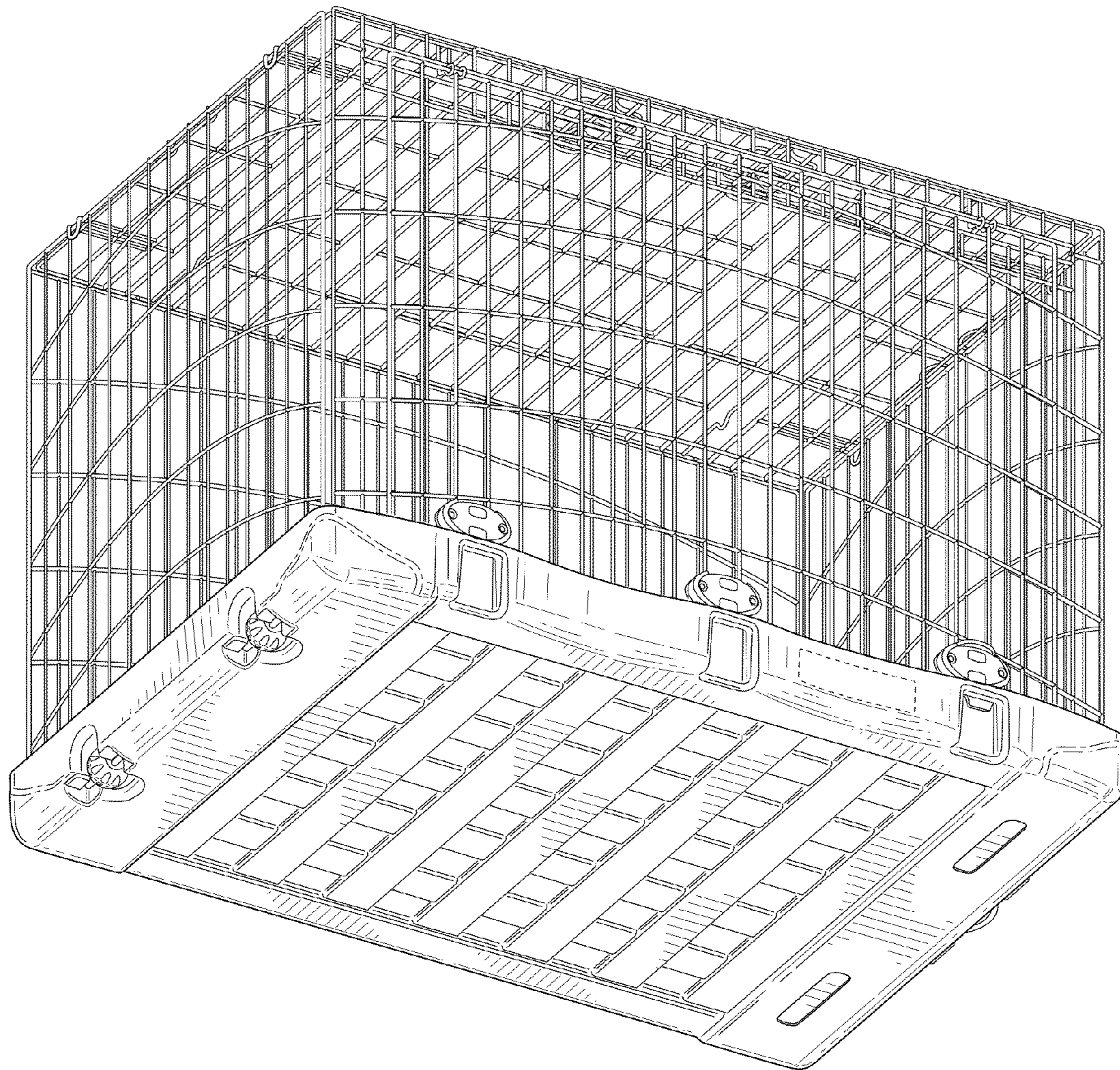

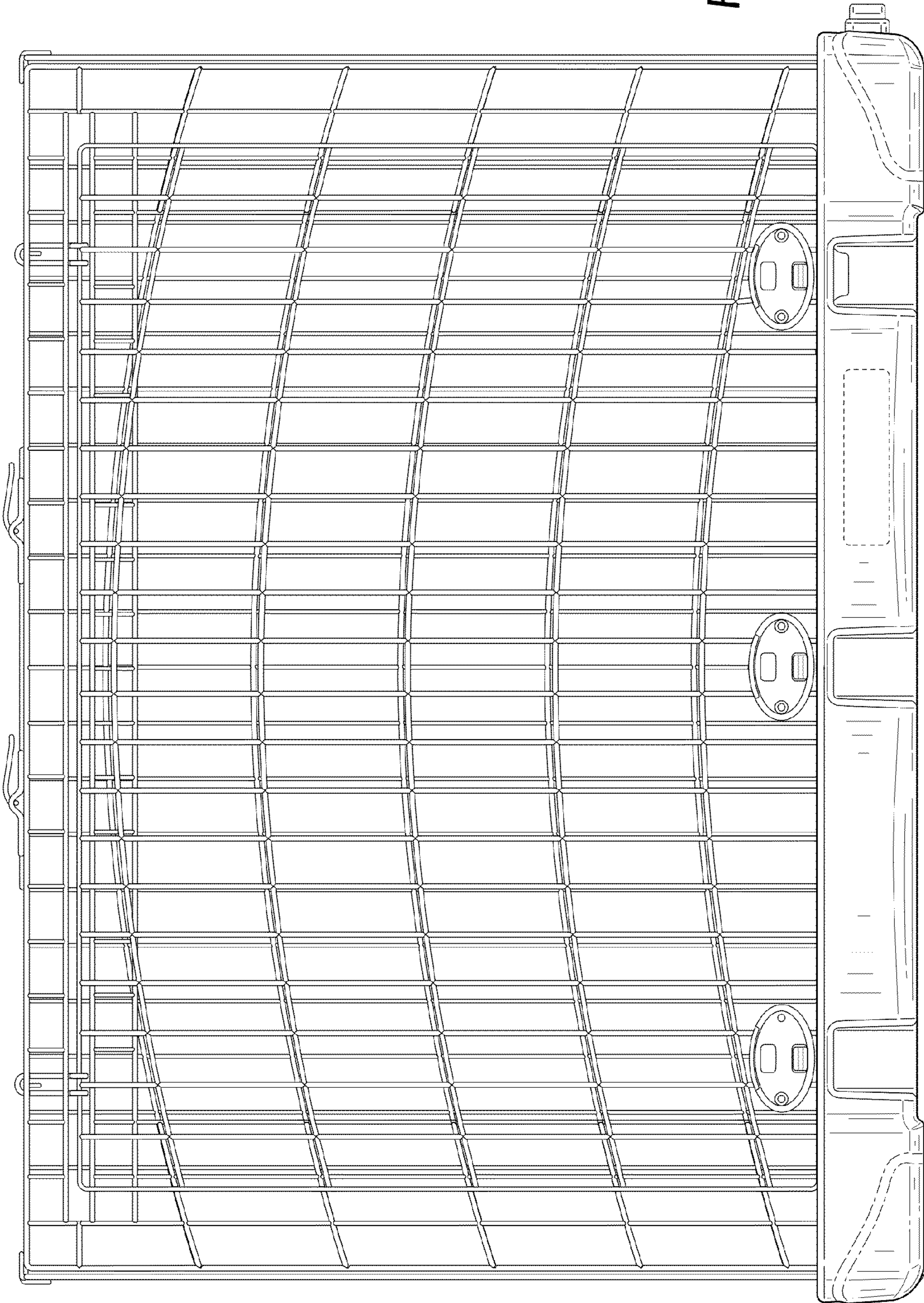
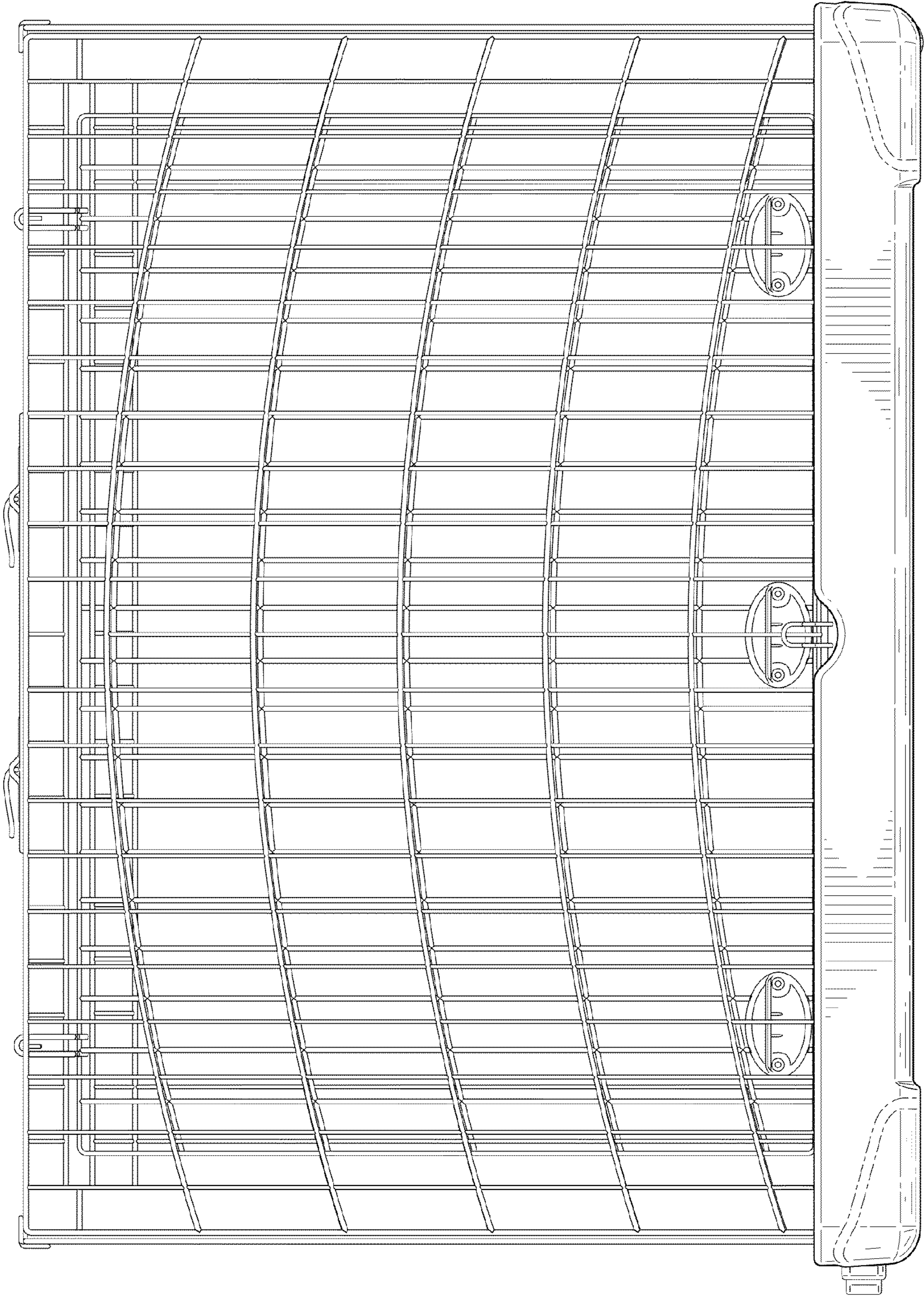

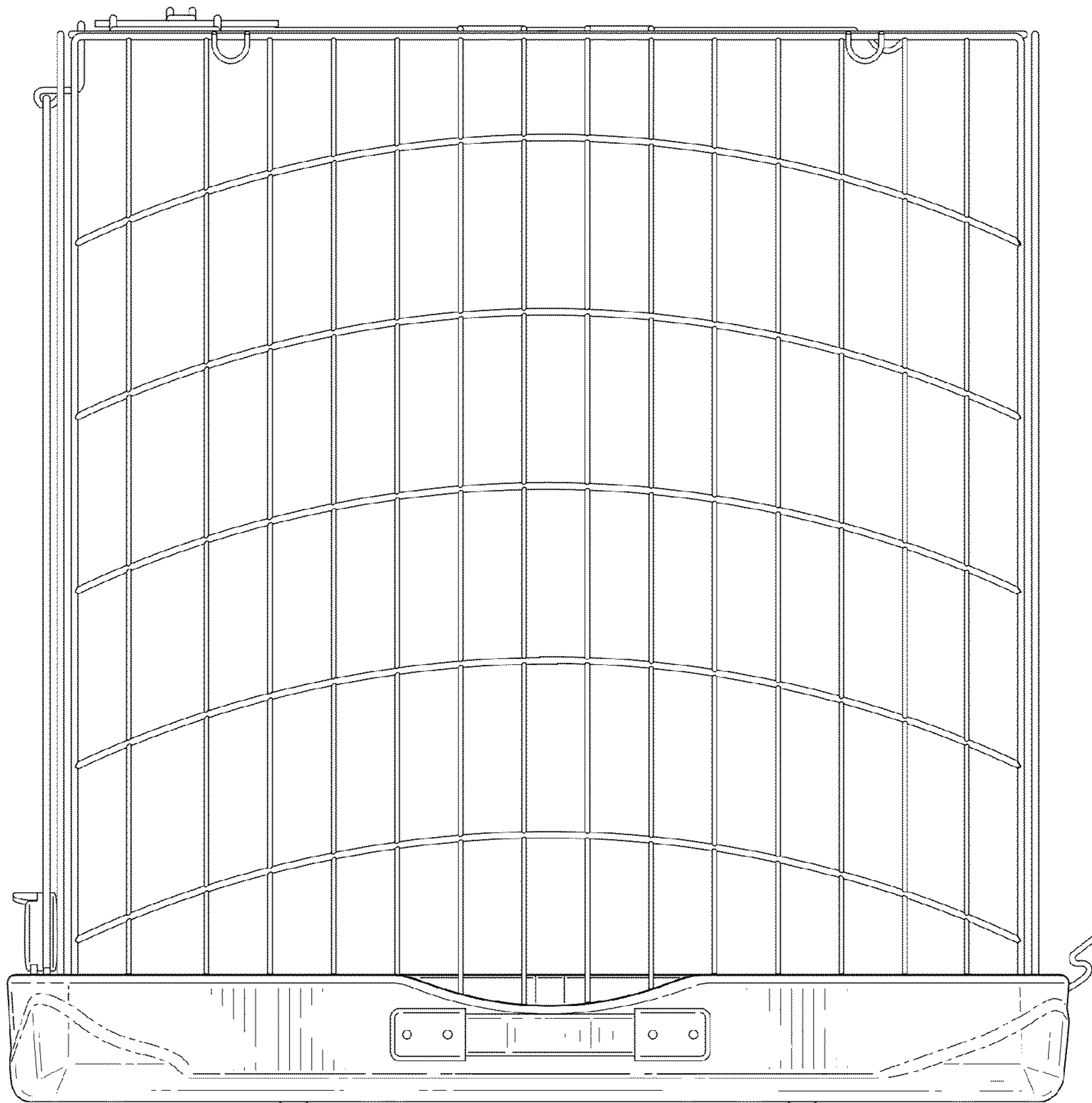

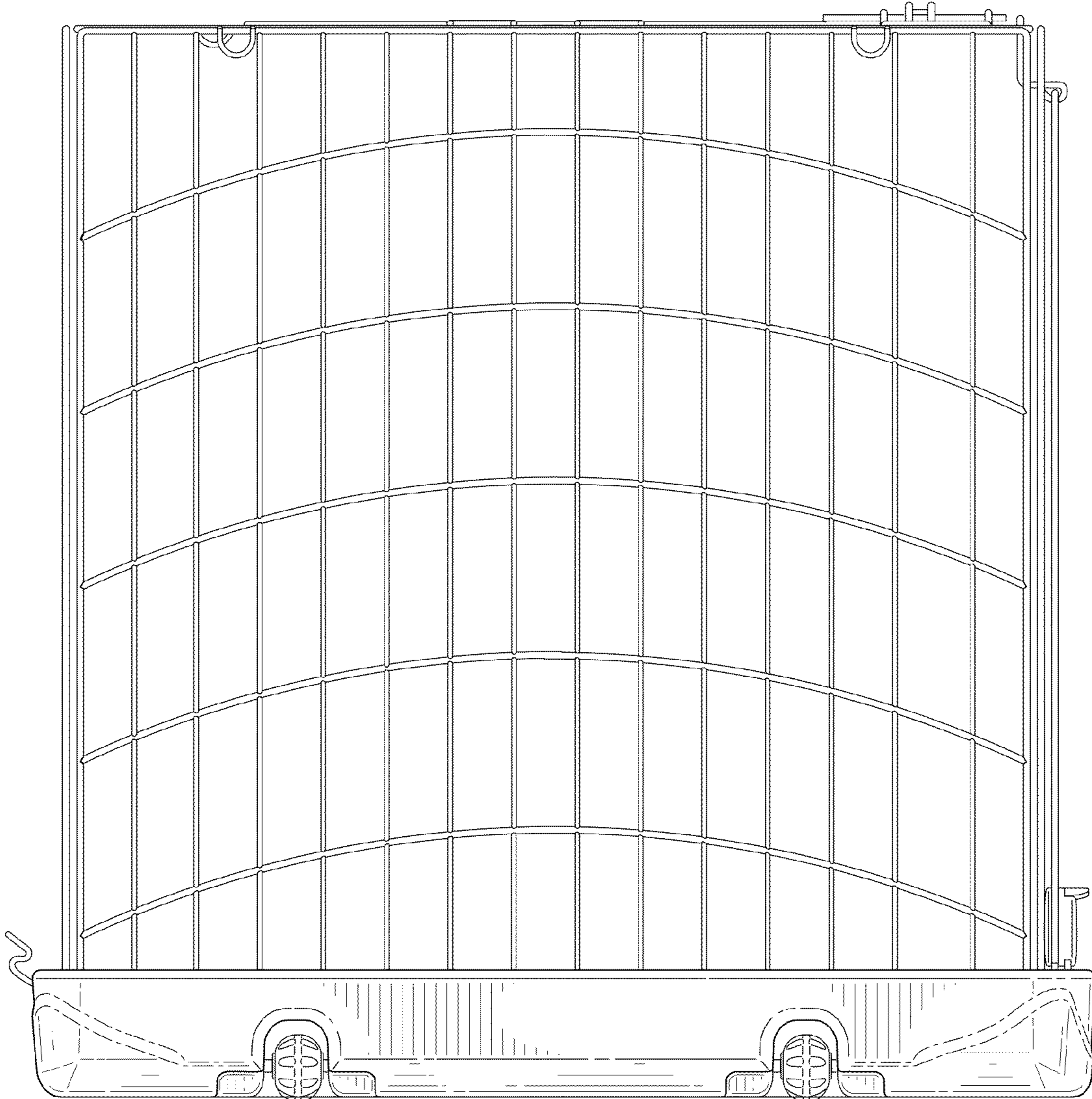

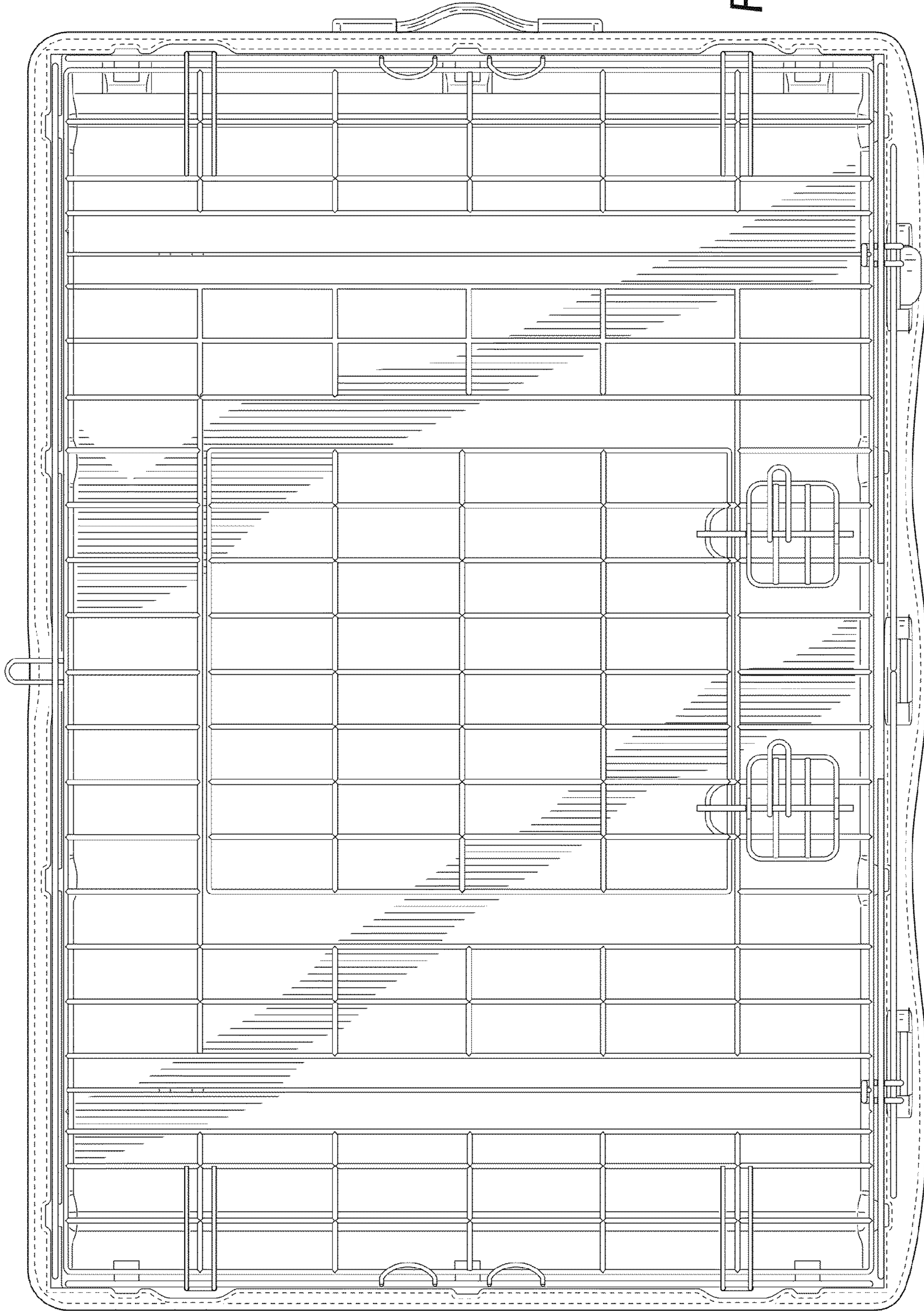
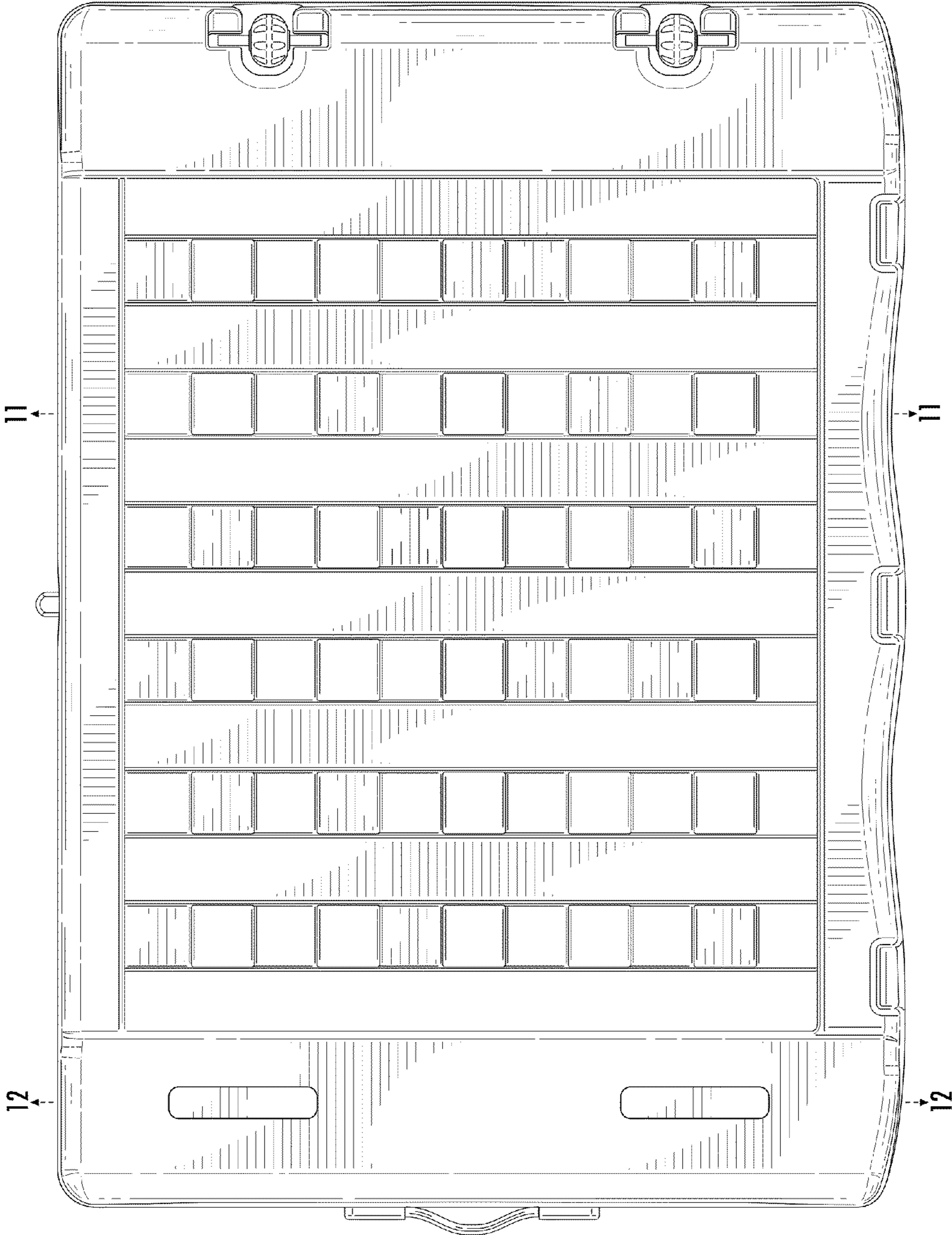

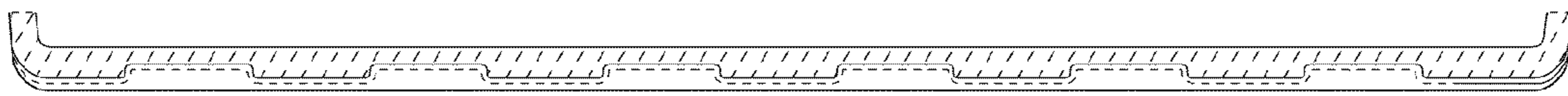

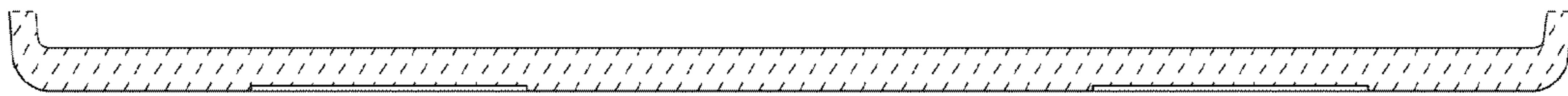

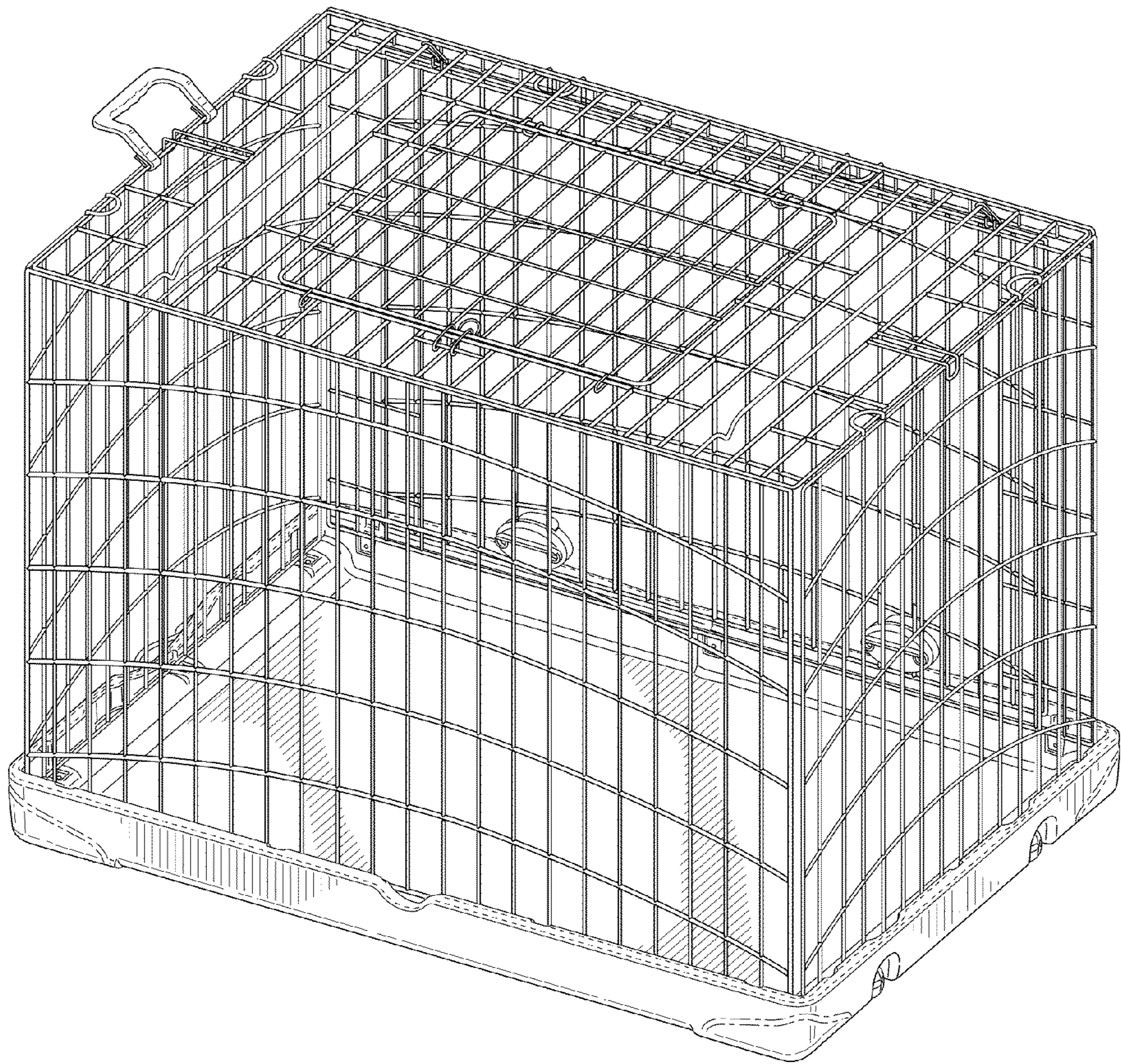

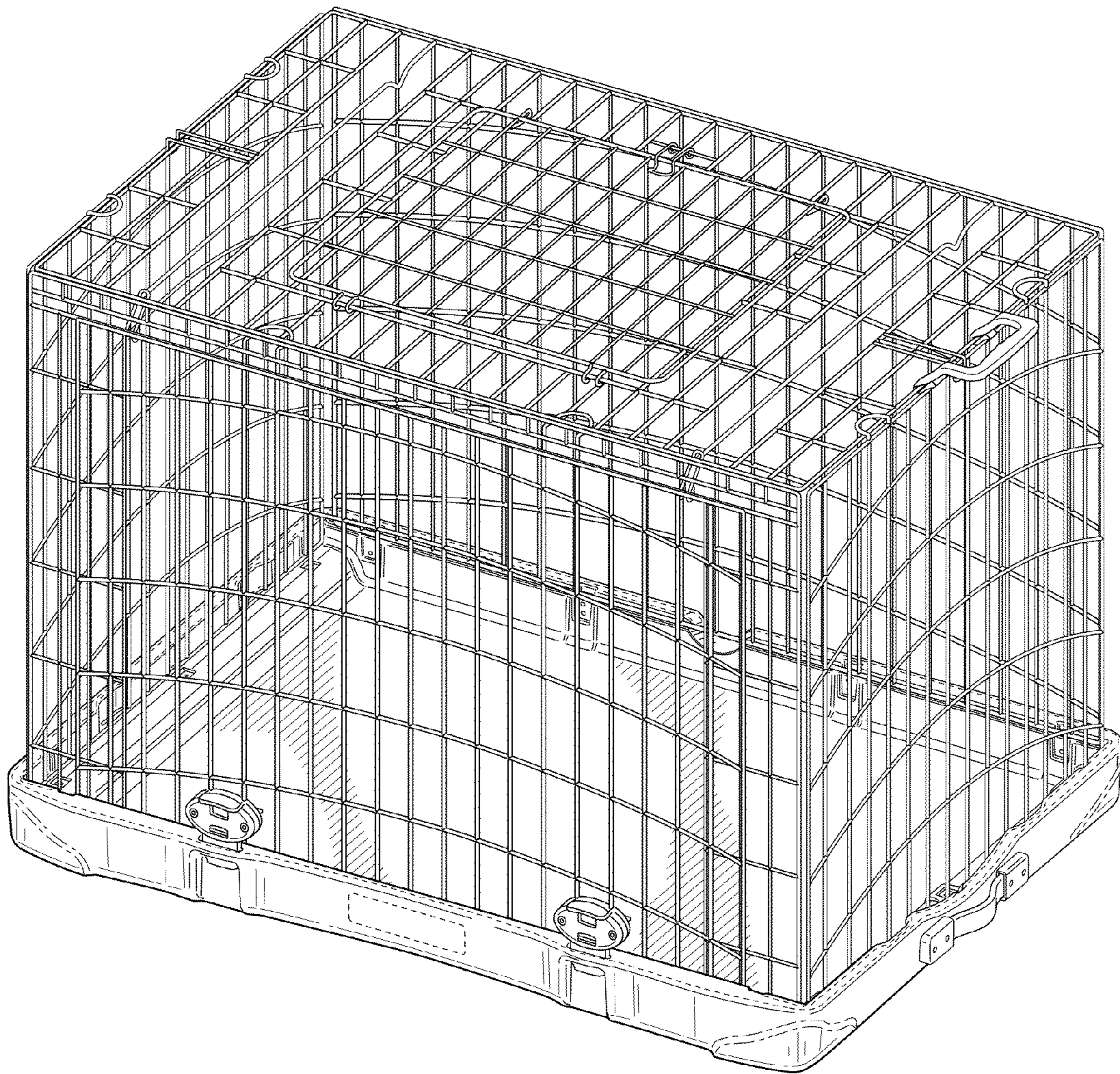

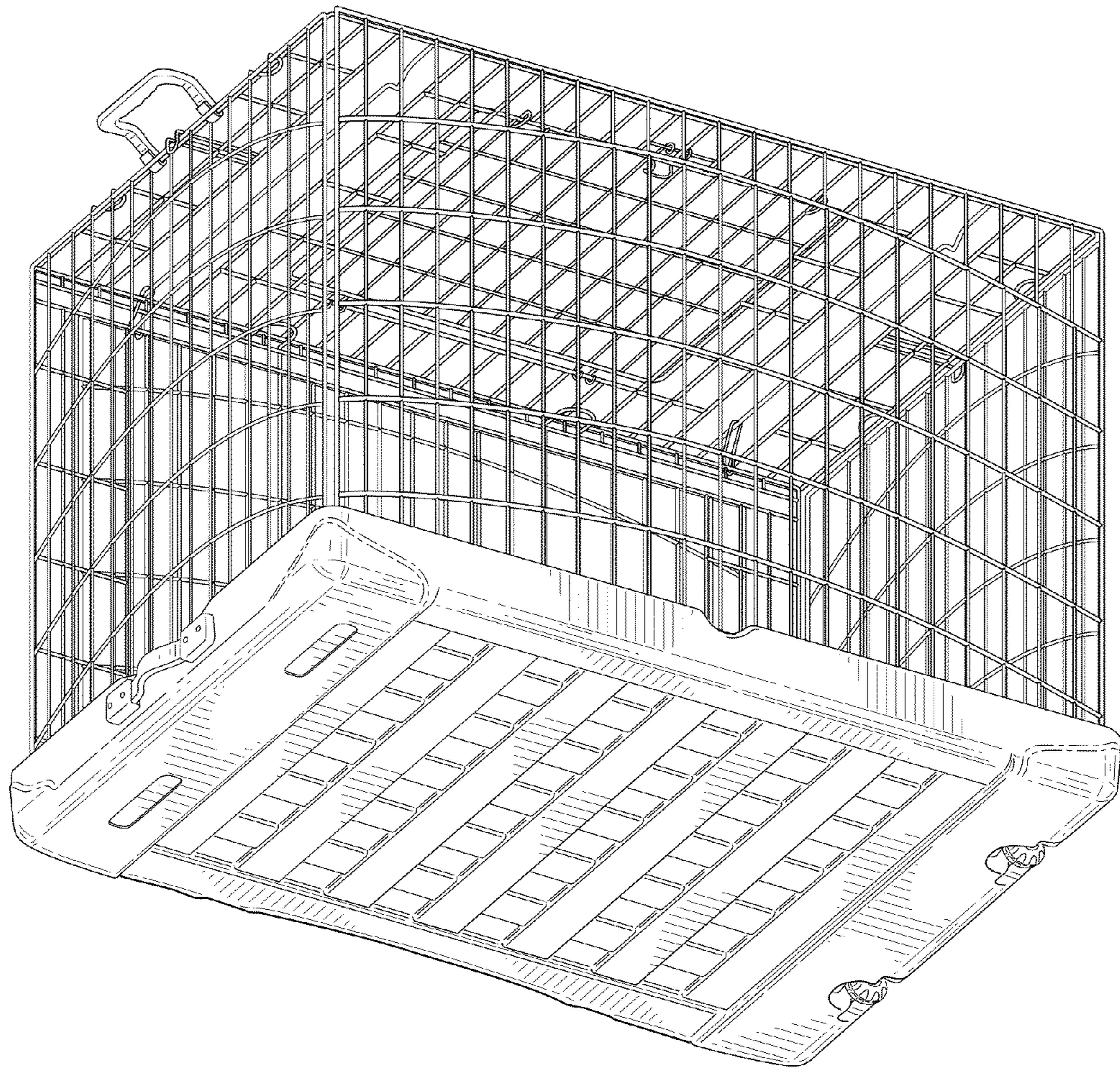

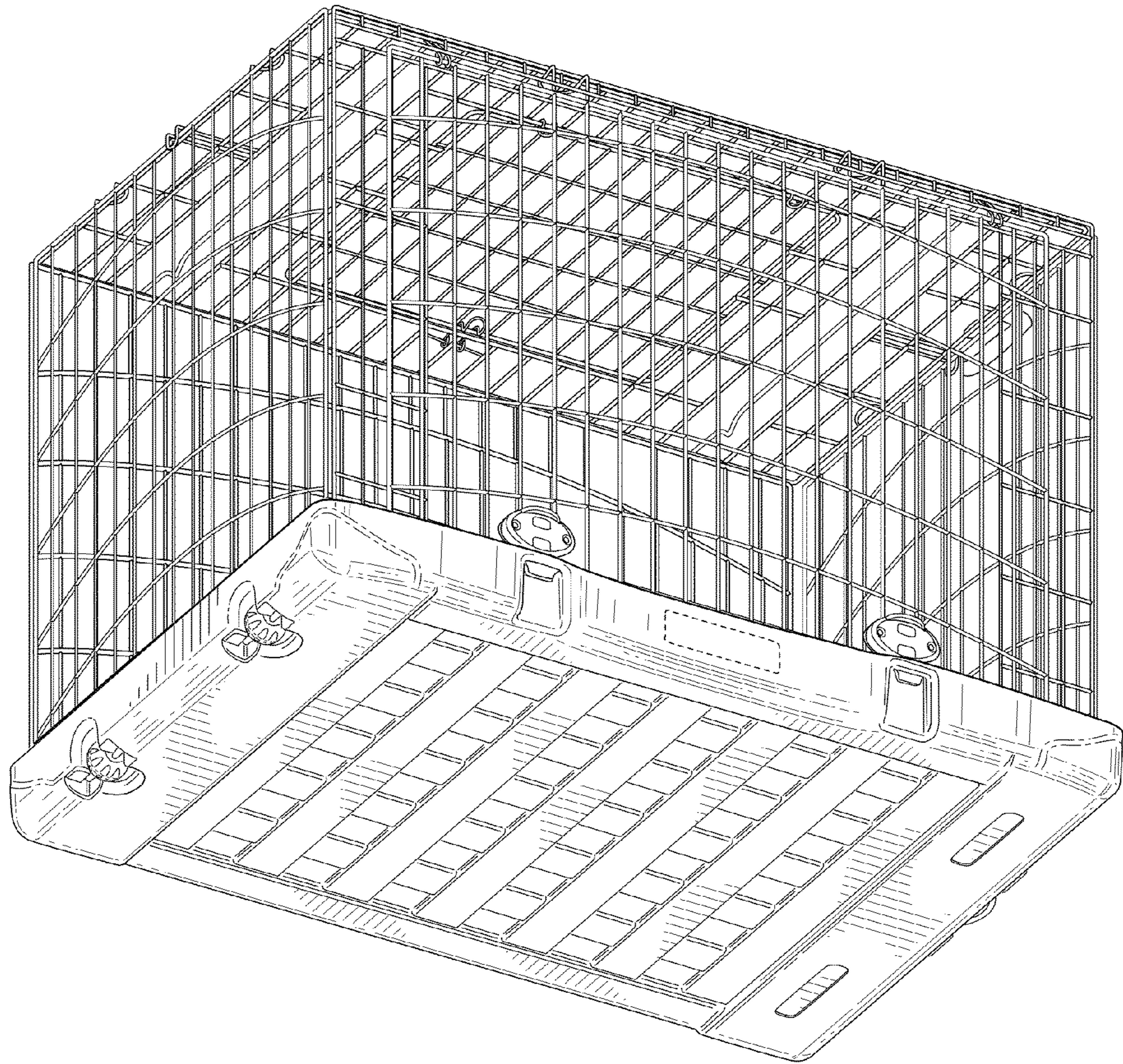

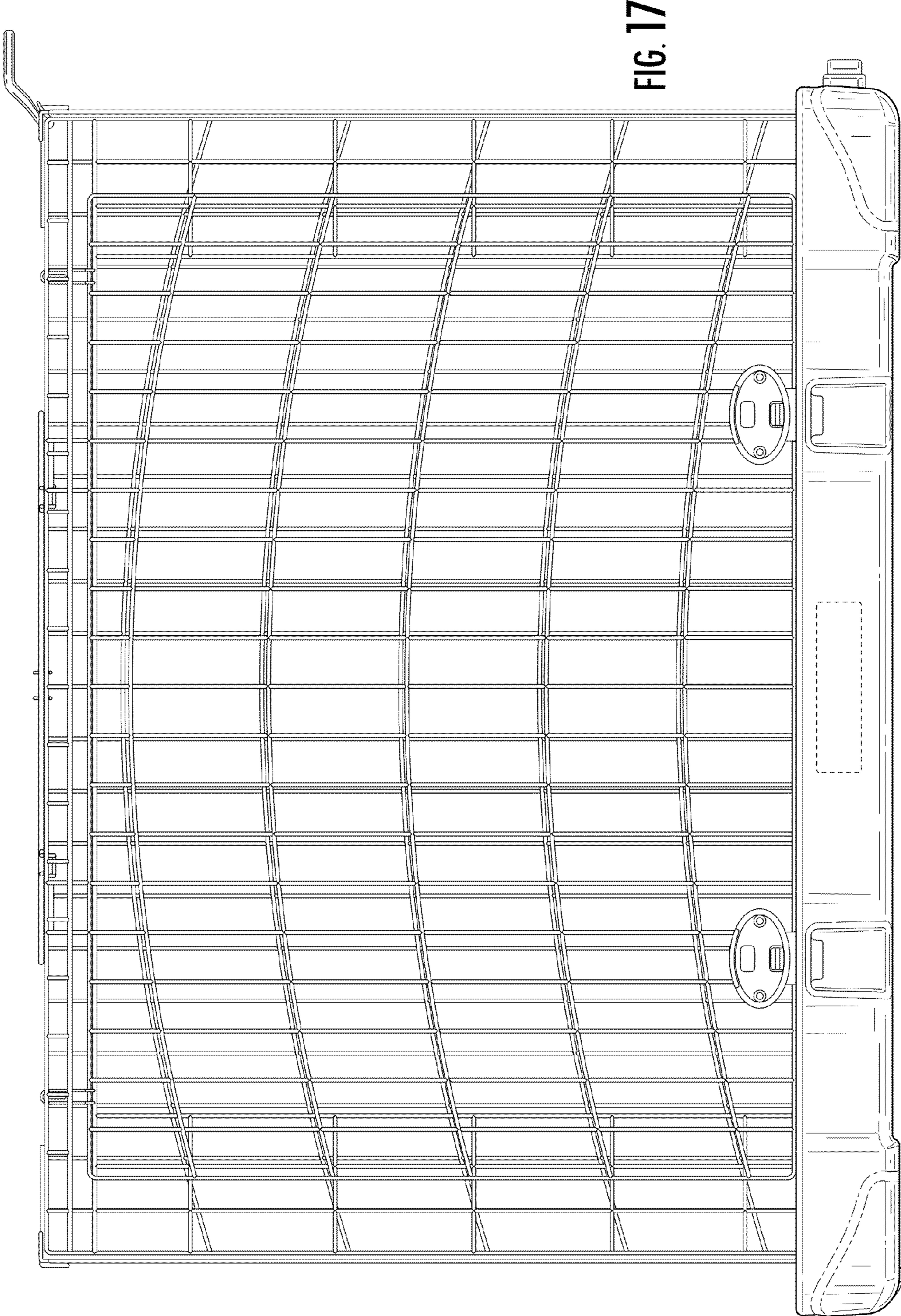
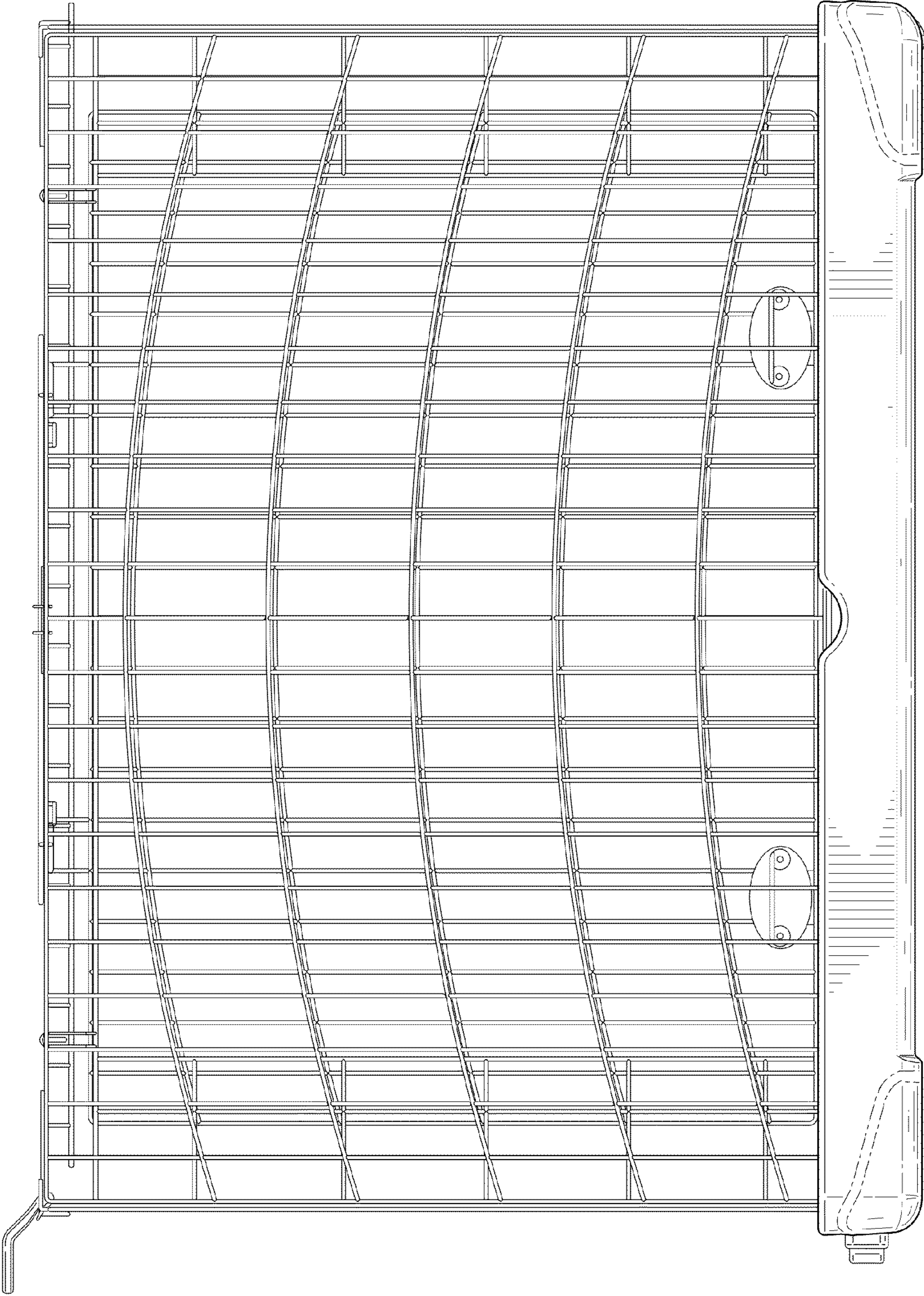

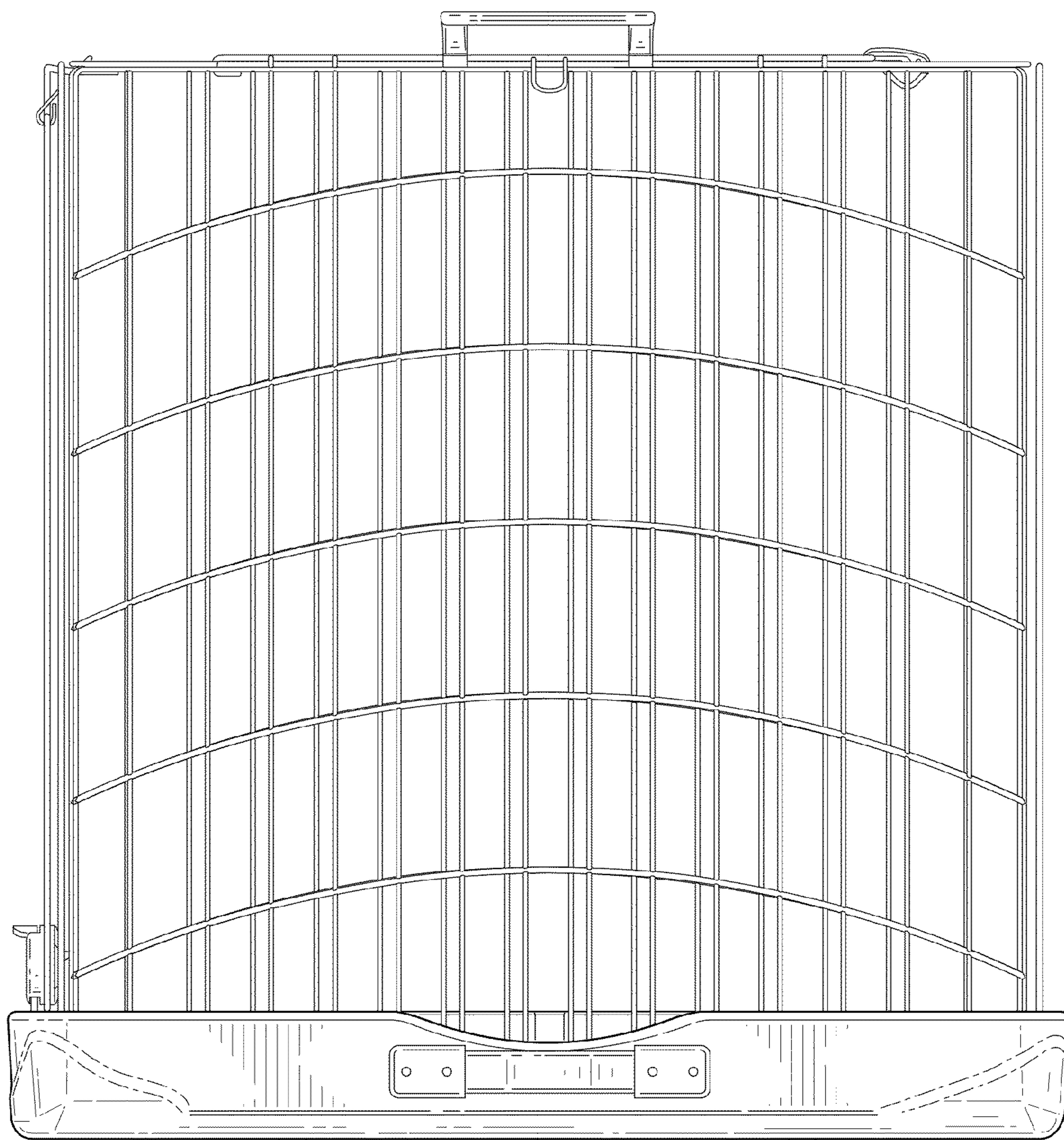

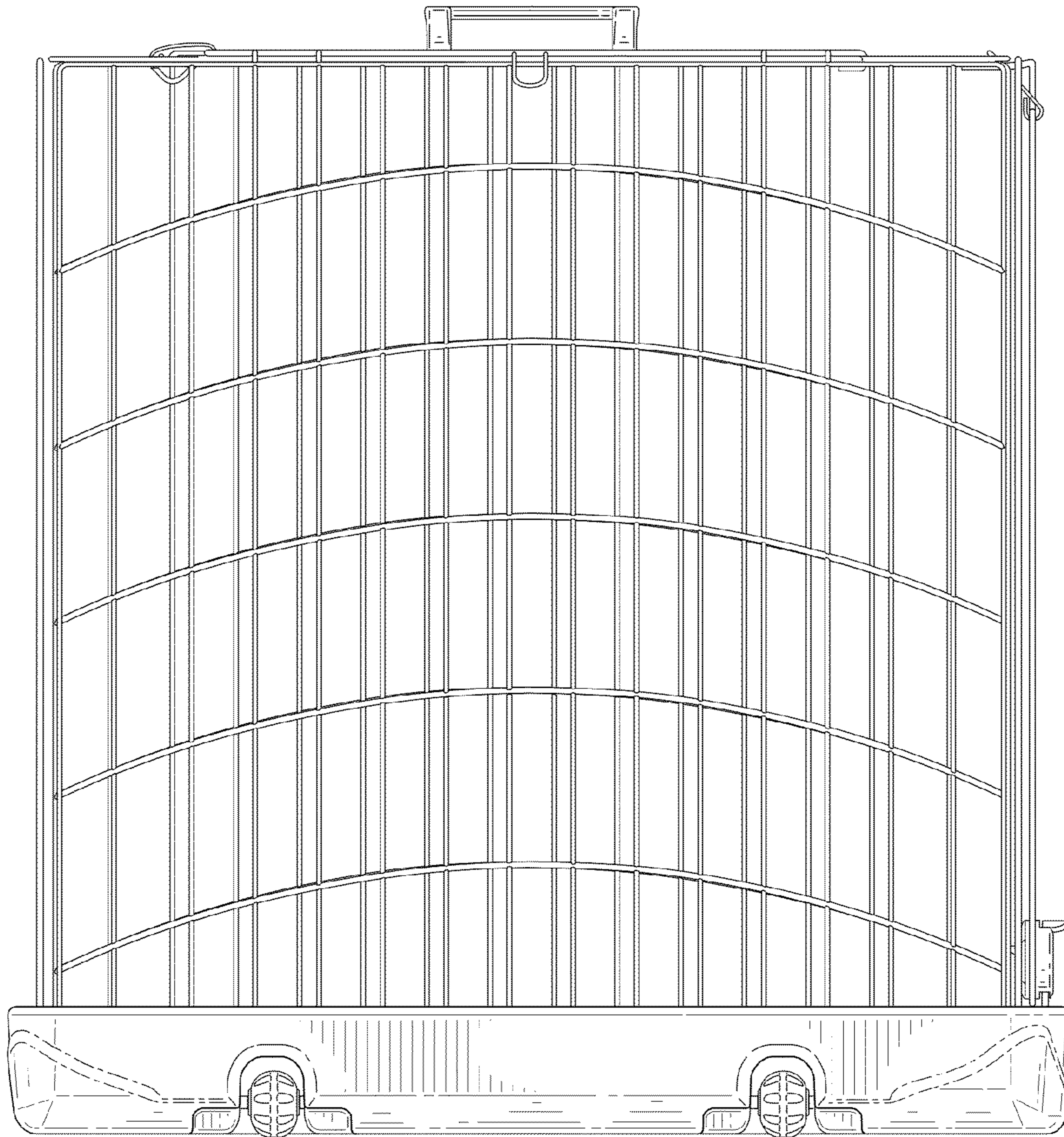
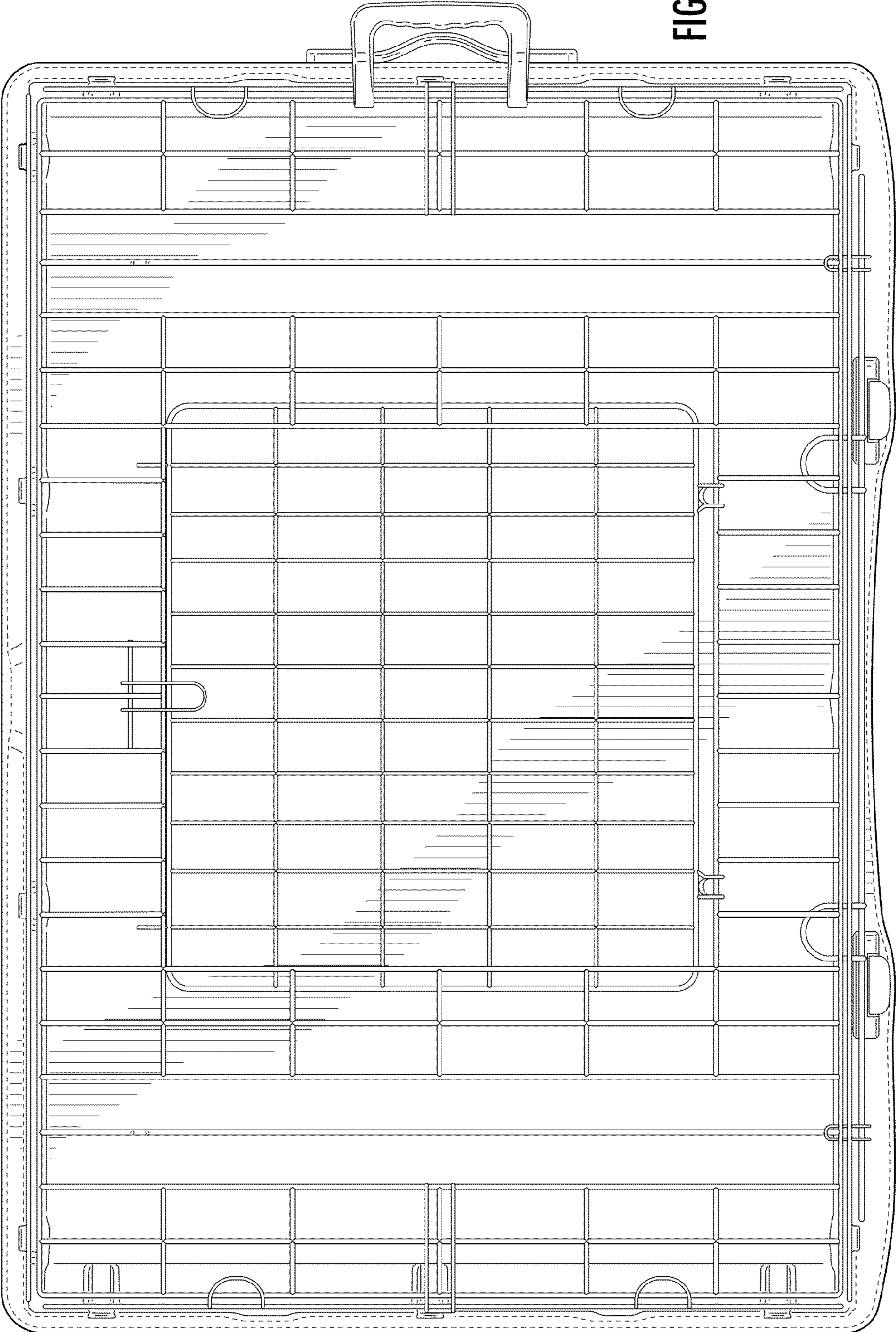
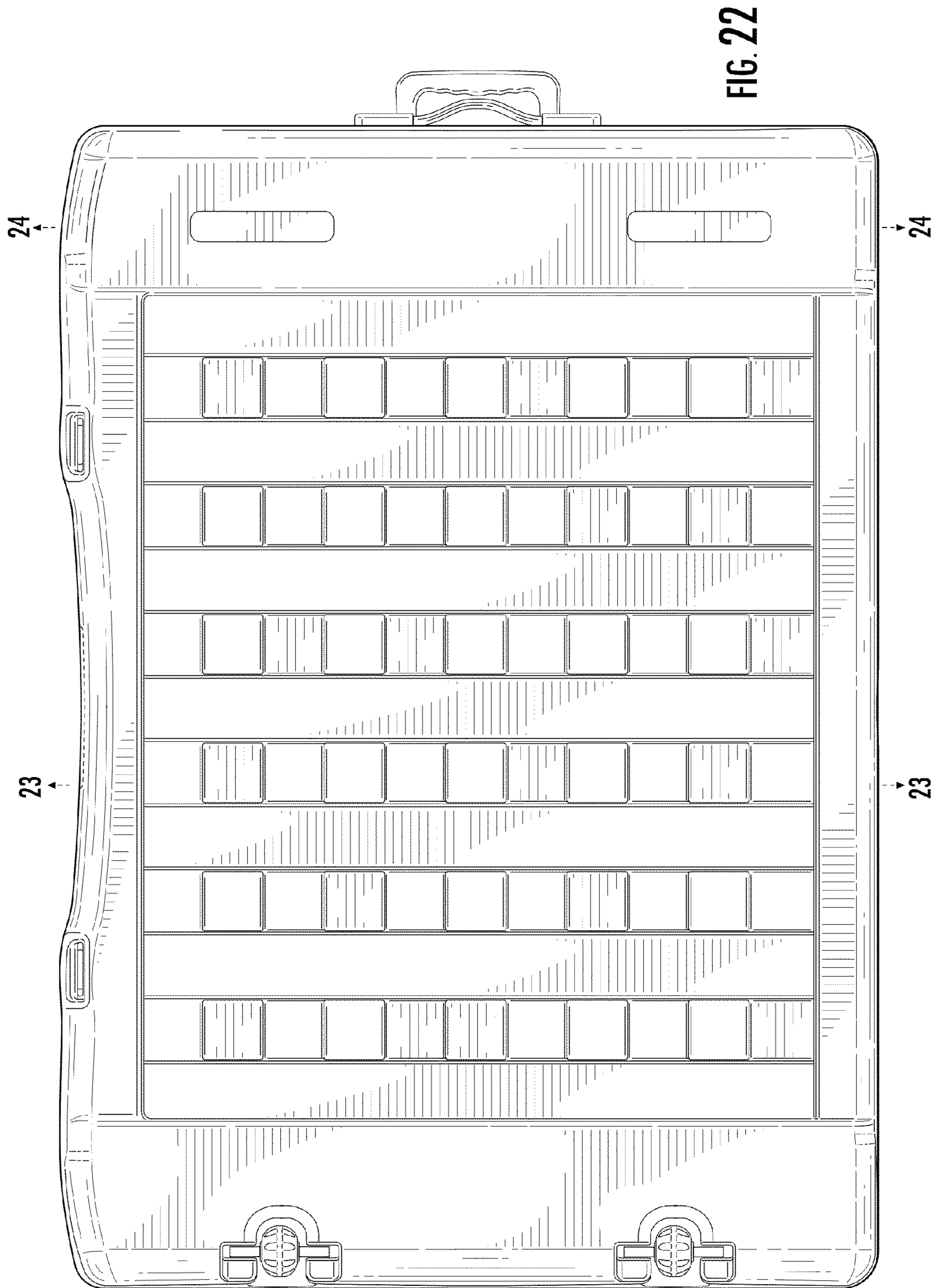

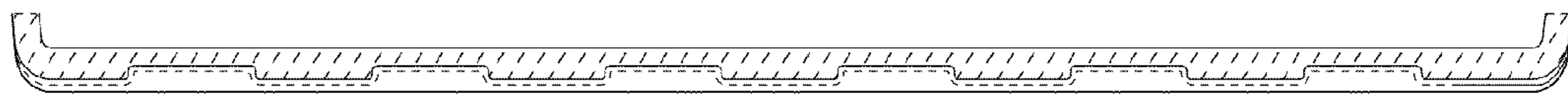

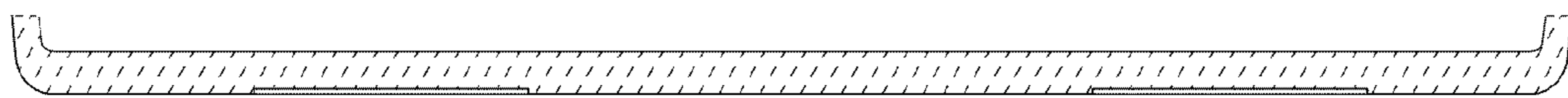
