The ornamental design for a bra, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a first embodiment of a
bra showing the design;

FIG. 2 is a front elevation view of the bra of FIG. 1;

FIG. 3 is a rear elevation view of the bra of FIG. 1;

FIG. 4 is a left side elevation view of the bra of FIG. 1;

FIG. 5 is a right side elevation view of the bra of FIG. 1;

FIG. 6 is a top plan view of the bra of FIG. 1;

FIG. 7 is a bottom plan view of the bra of FIG. 1;

FIG. 8 is a frontal perspective view of a second embodiment
of a bra showing the design;

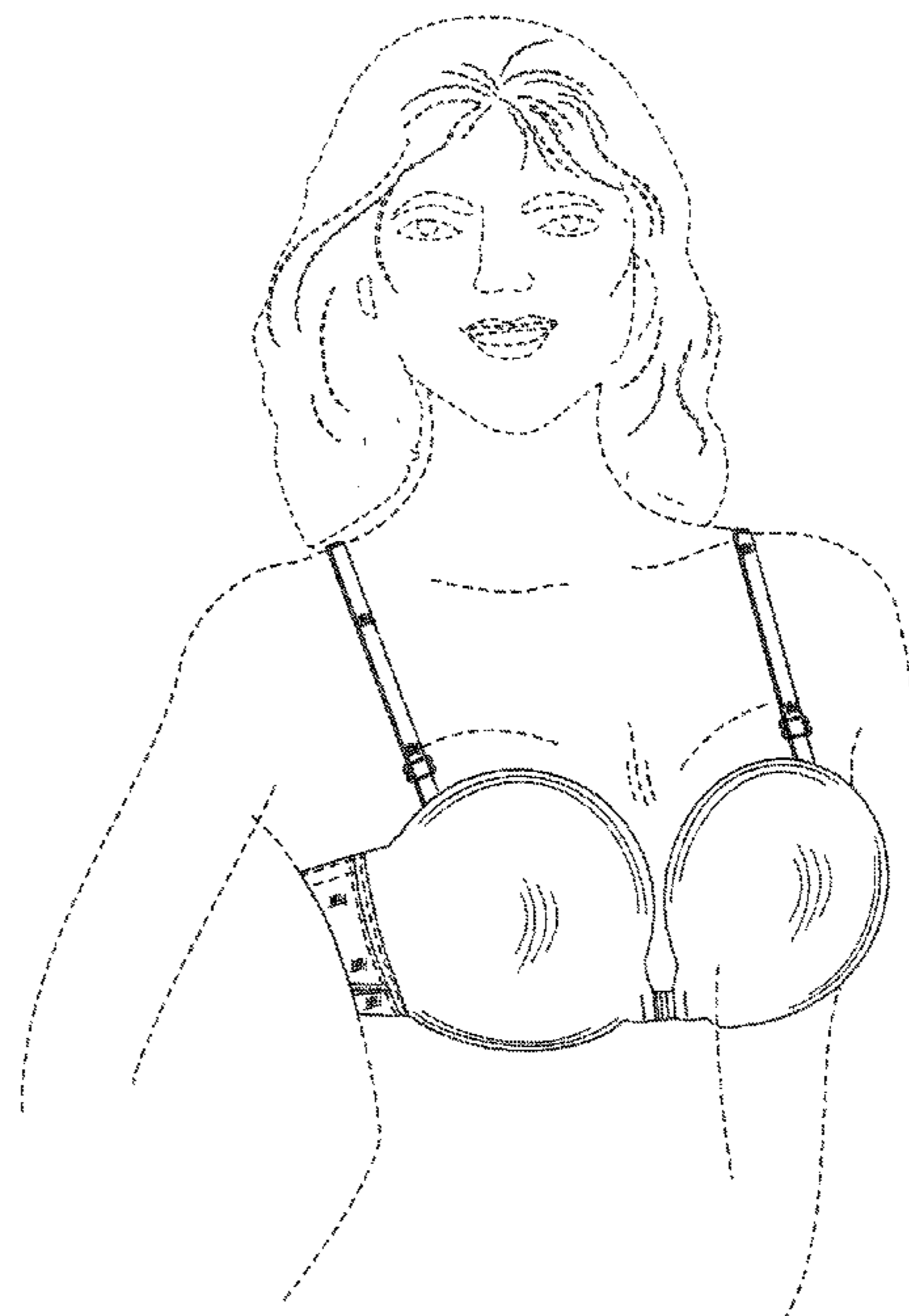
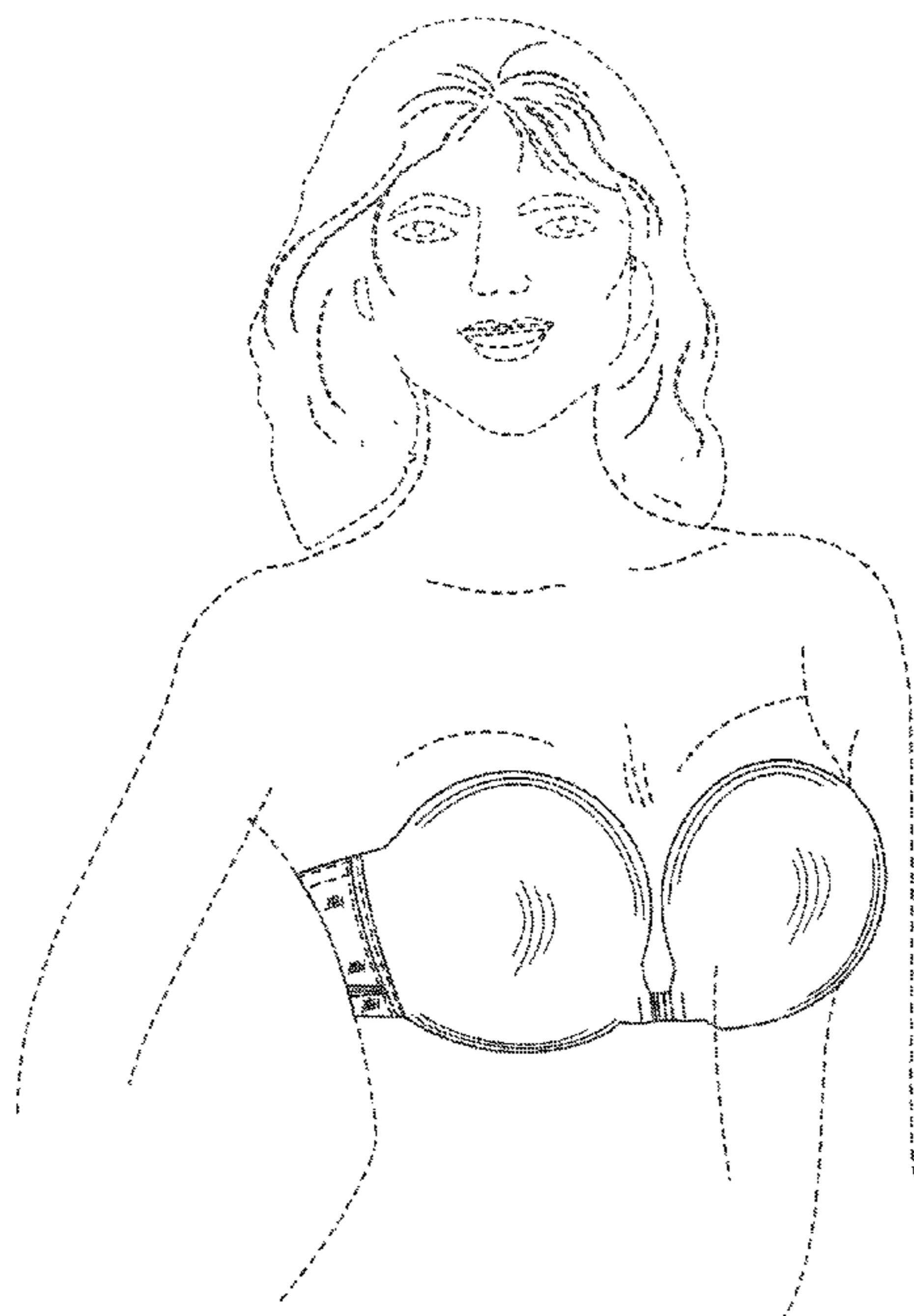
FIG. 9 is a front elevation view of the bra of FIG. 8;

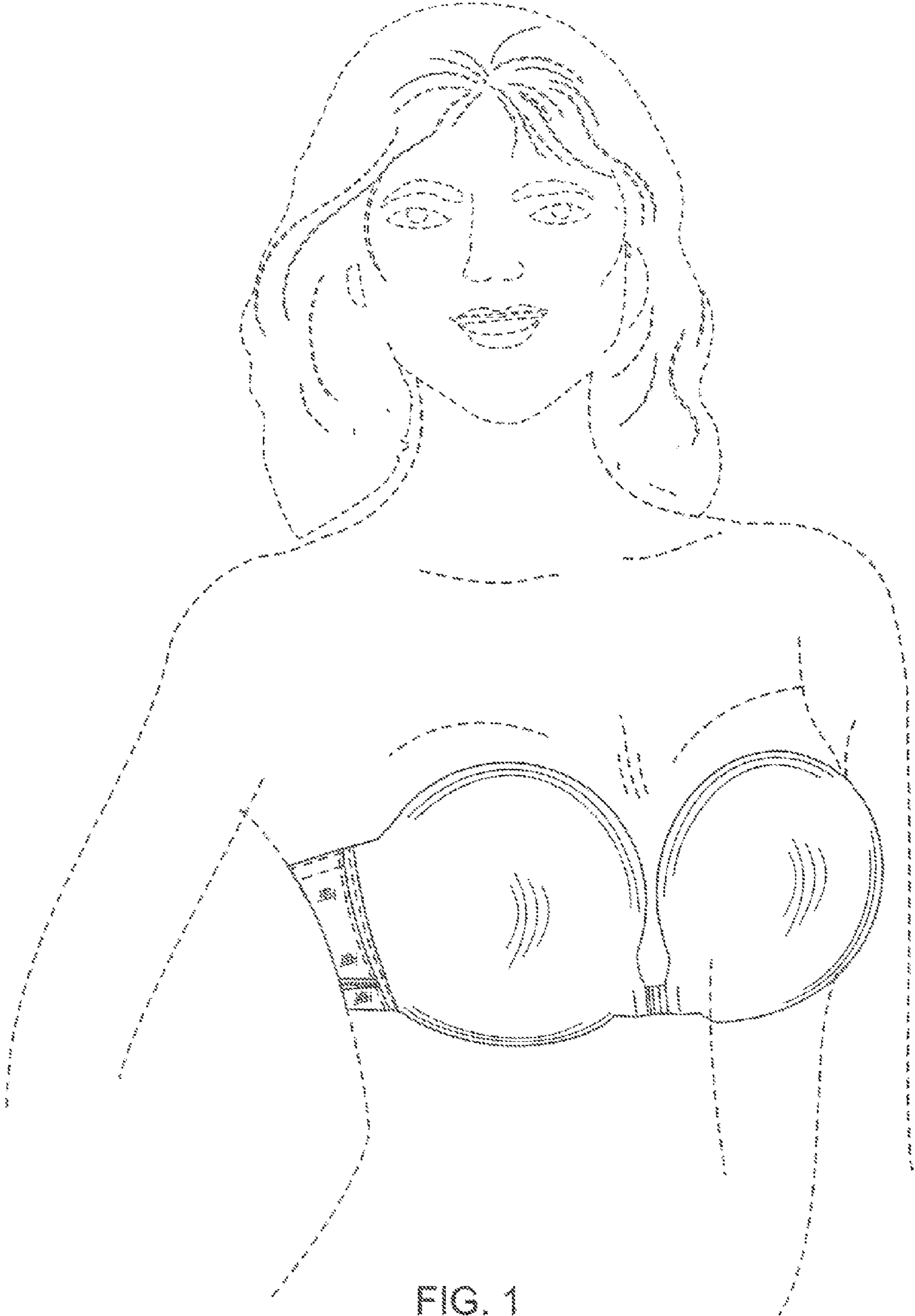

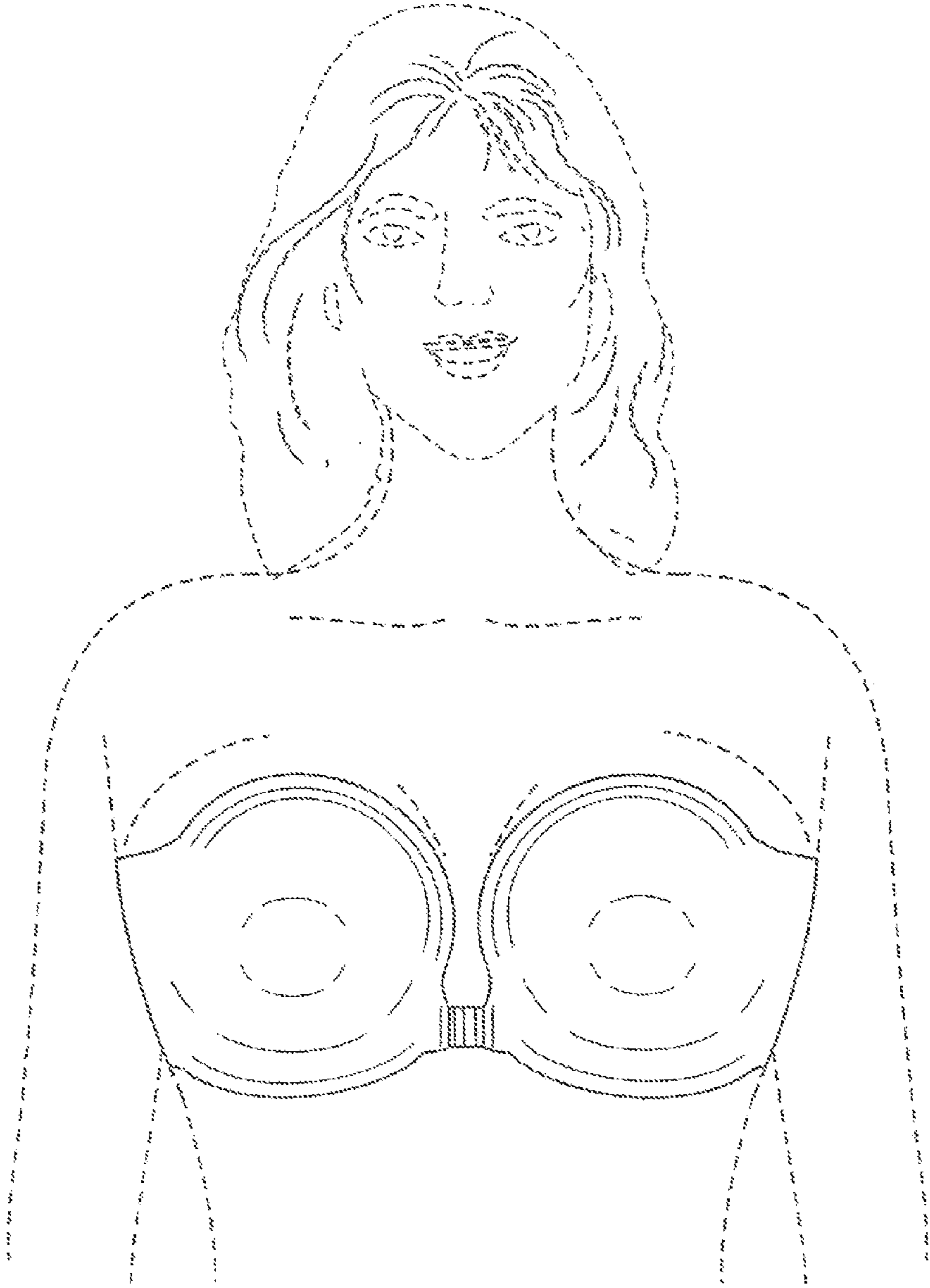

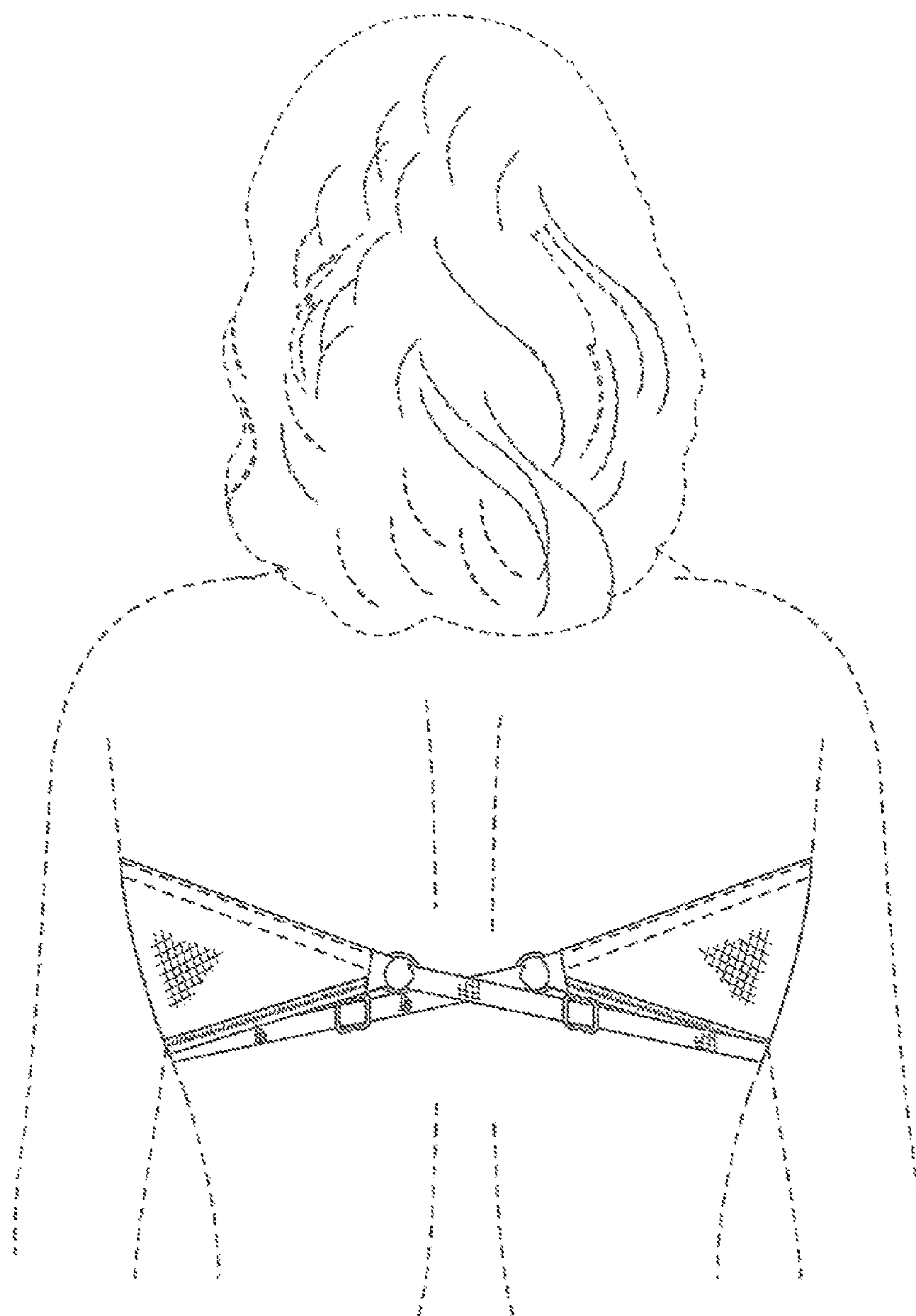

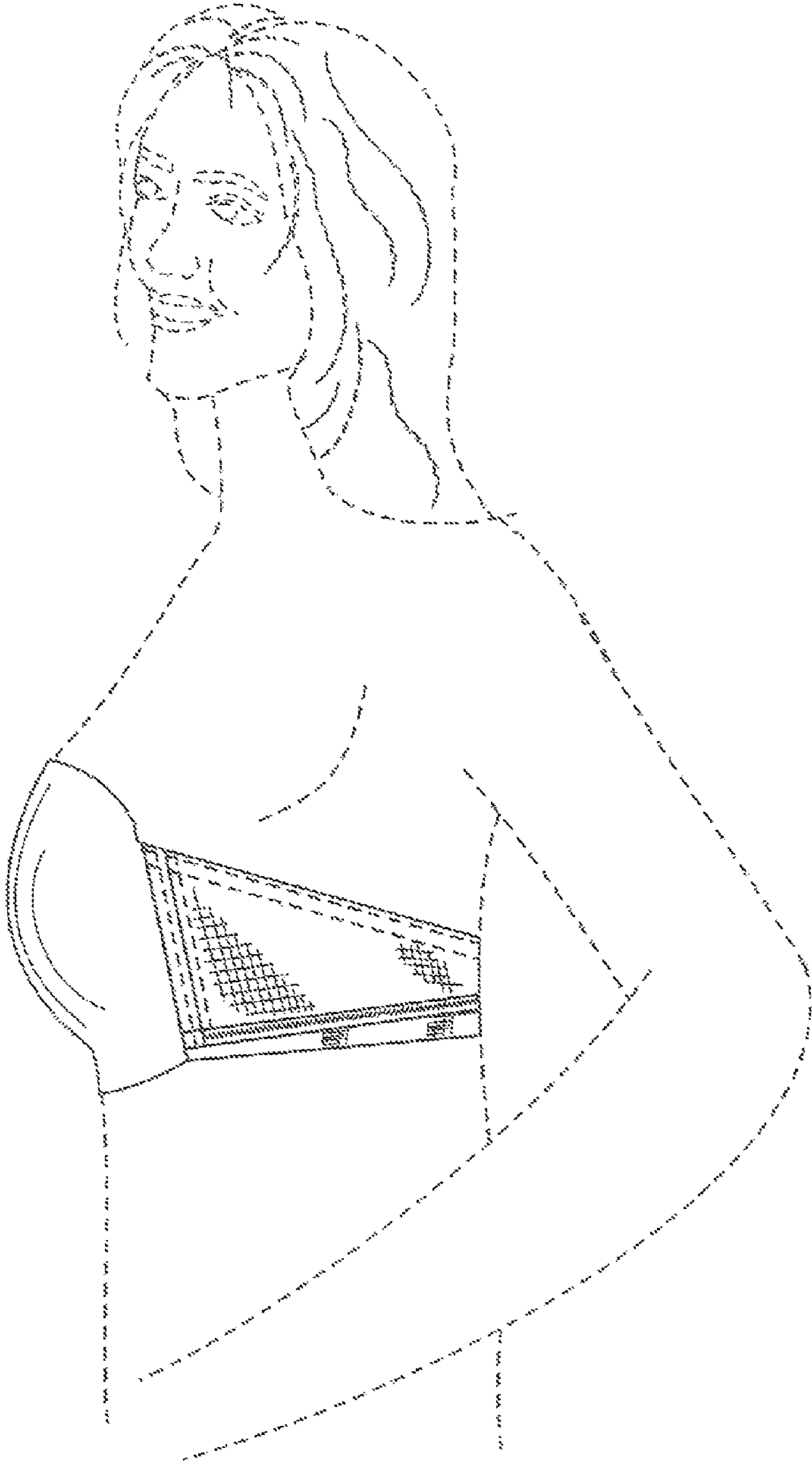

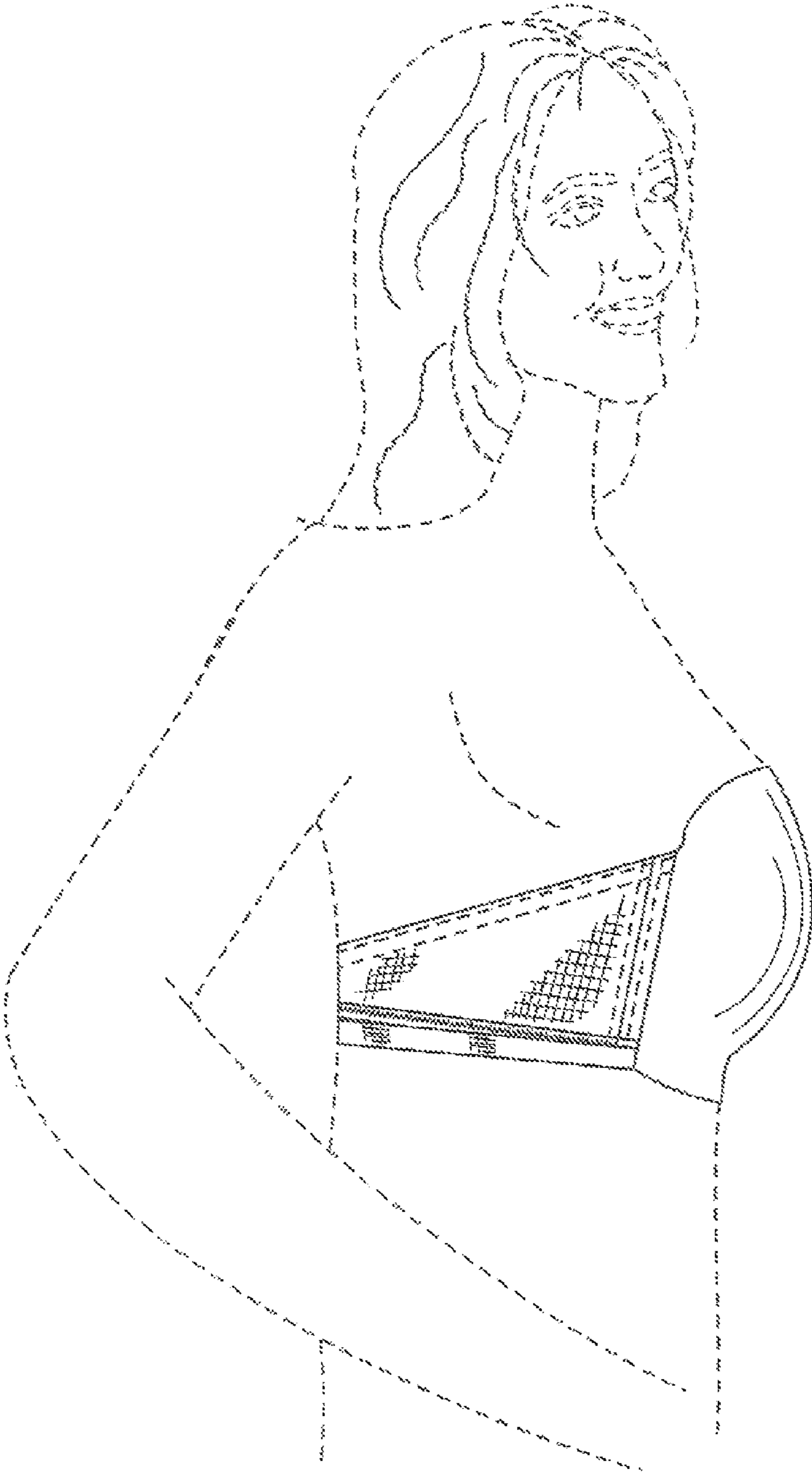

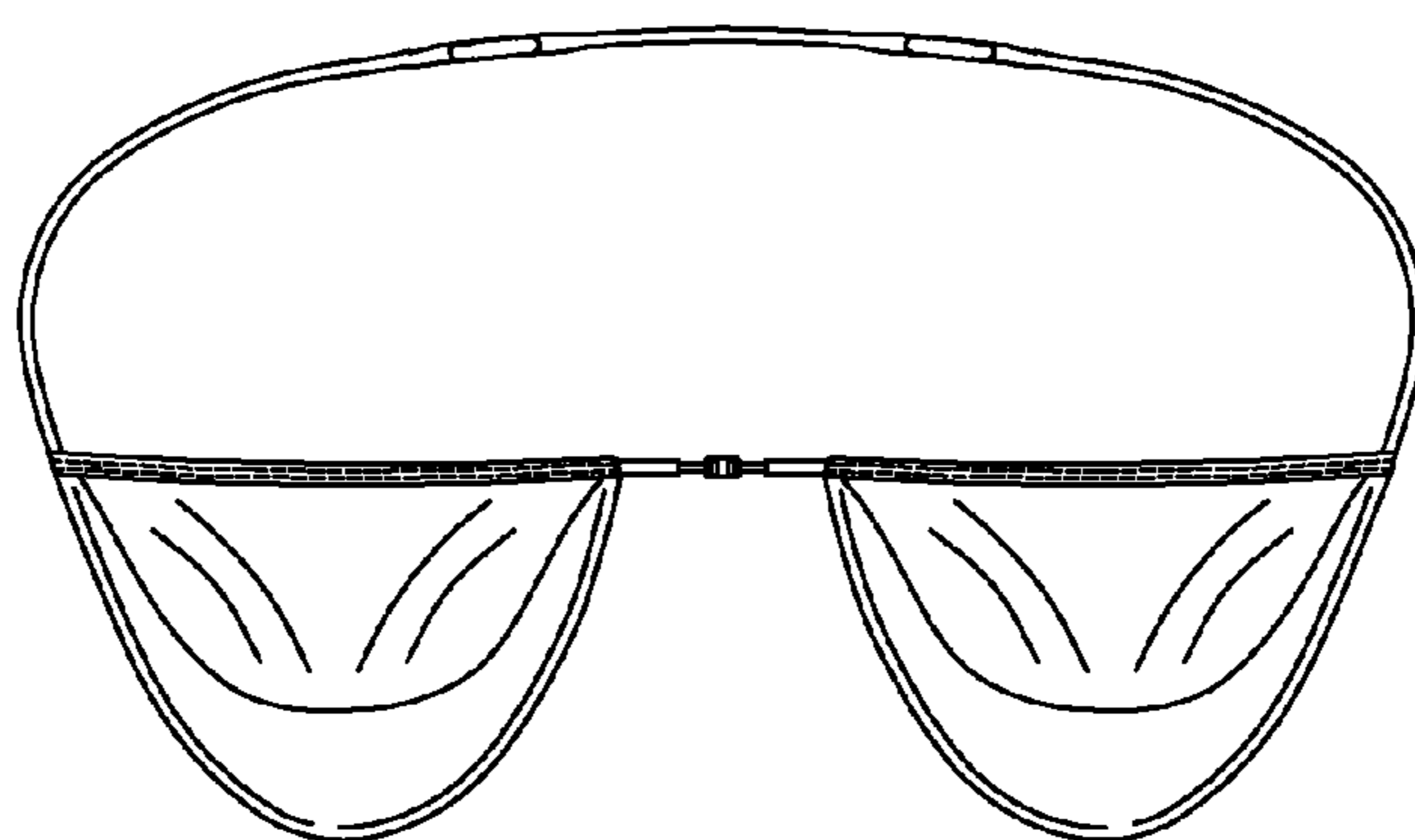

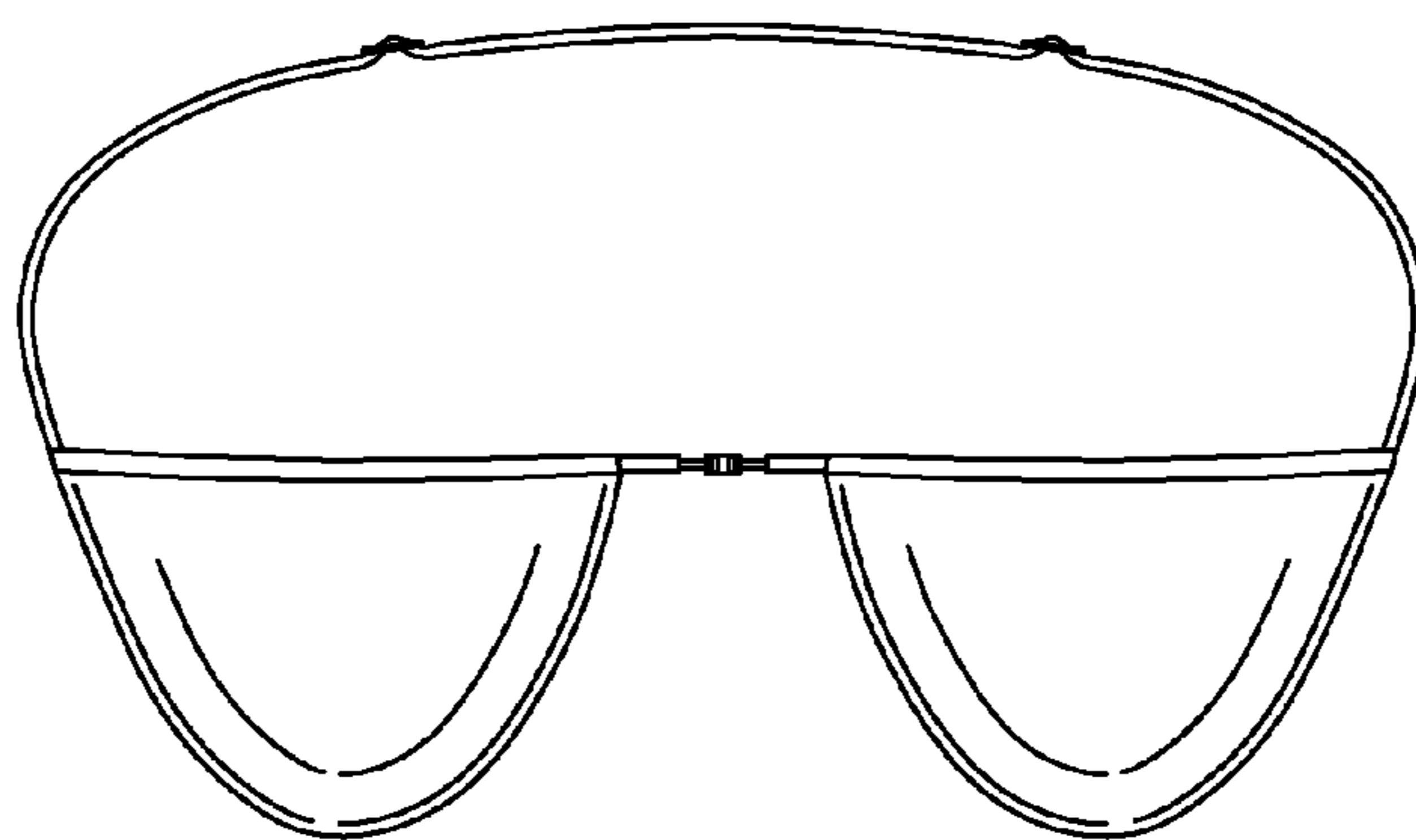

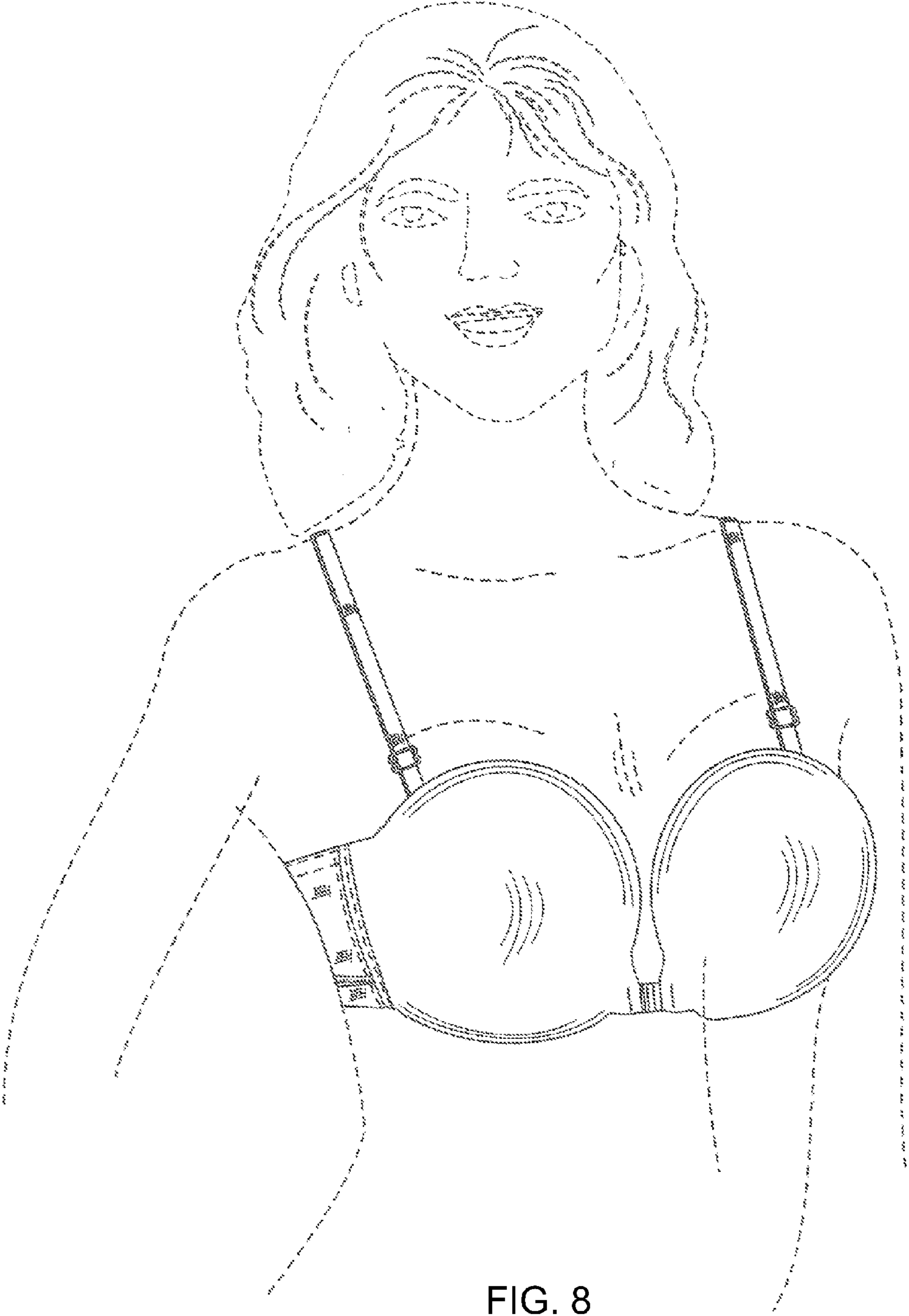

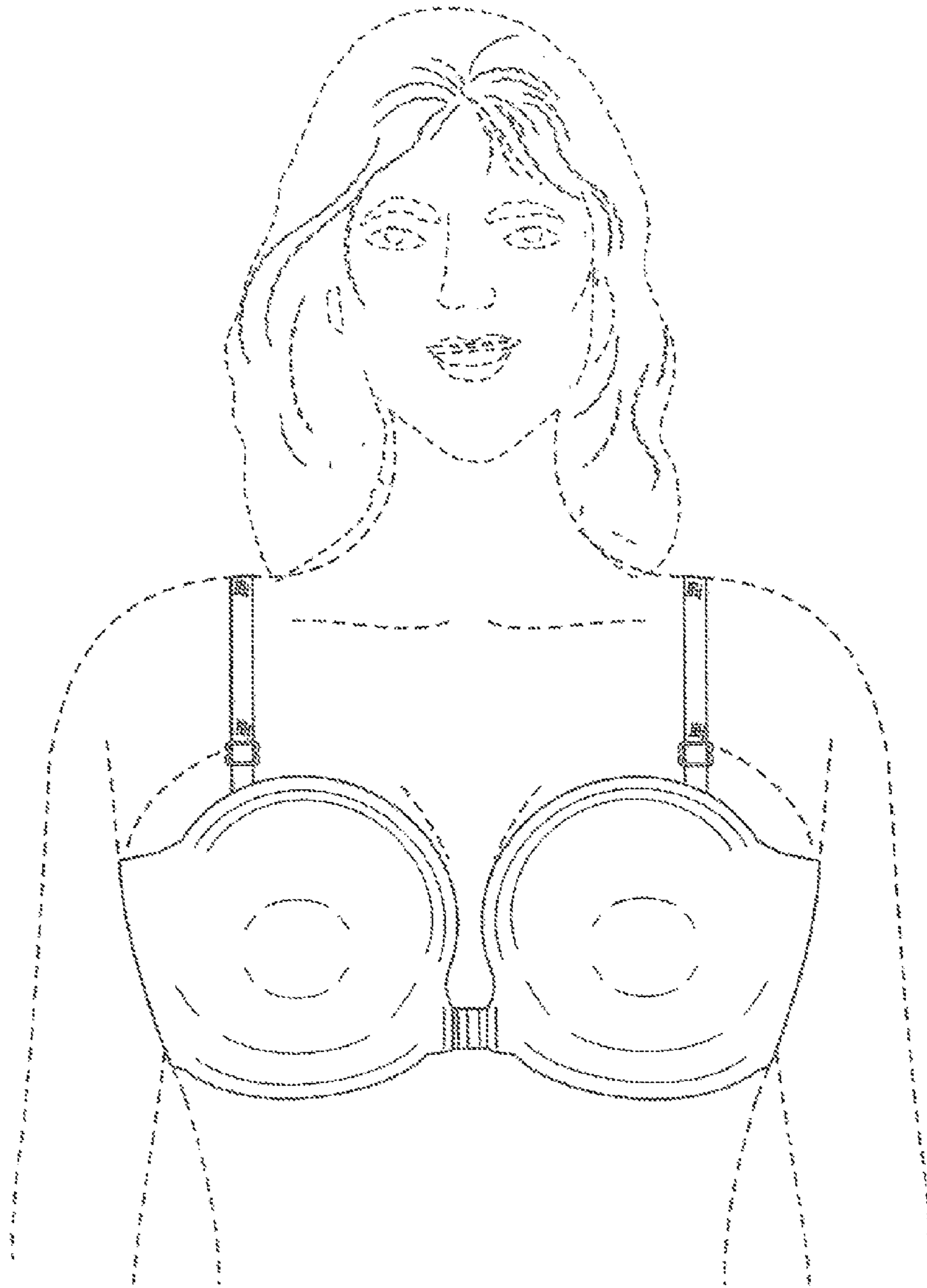

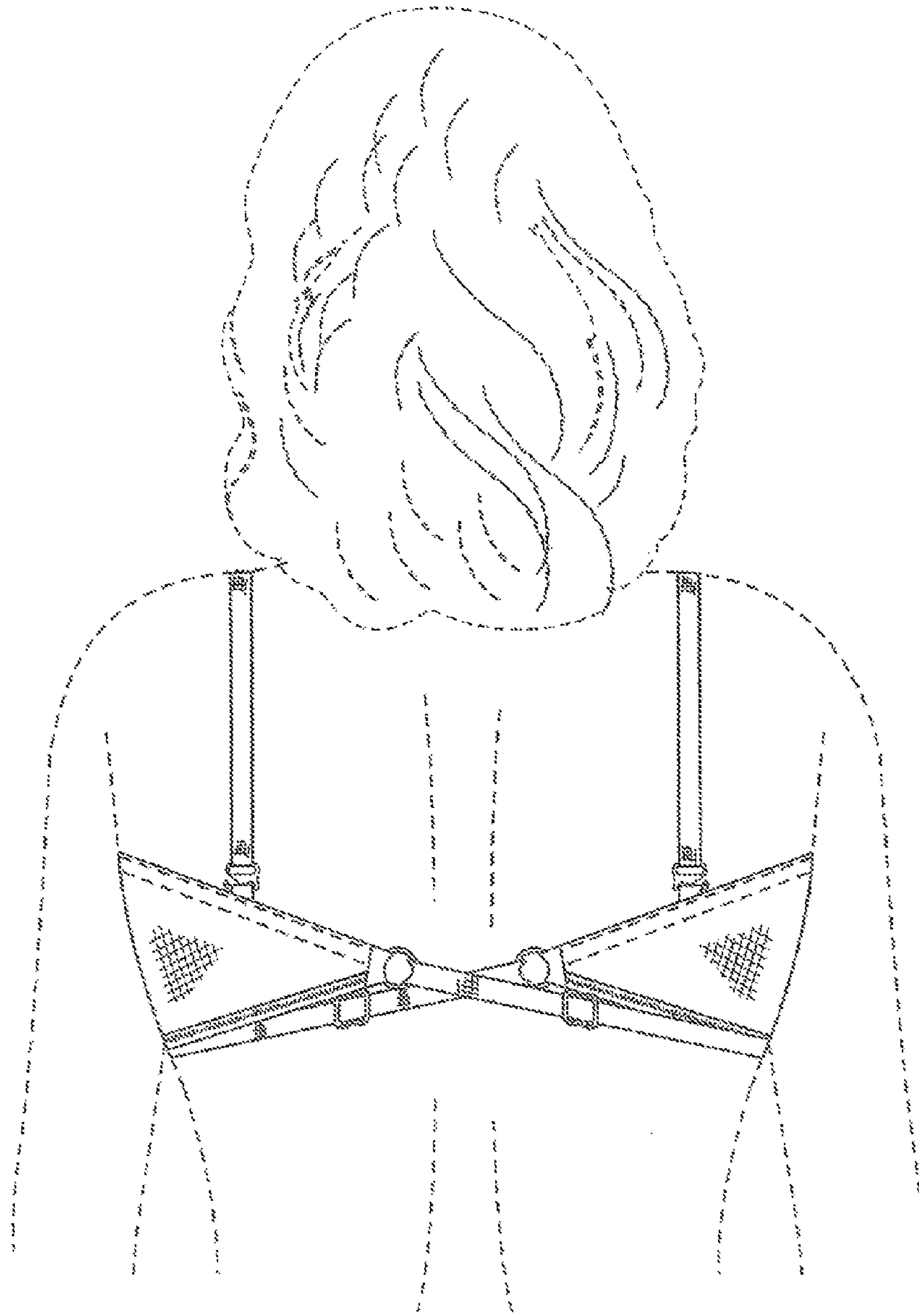

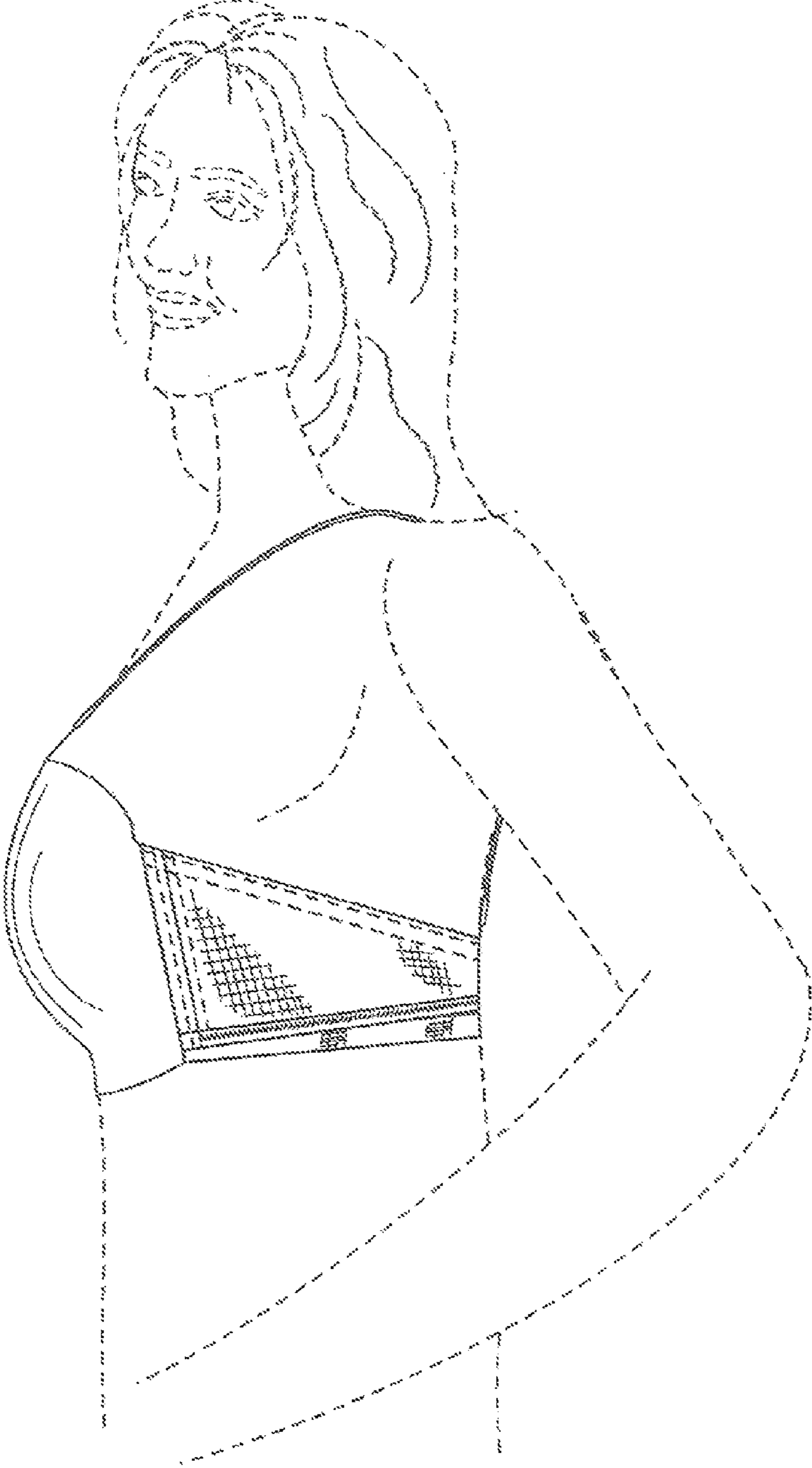

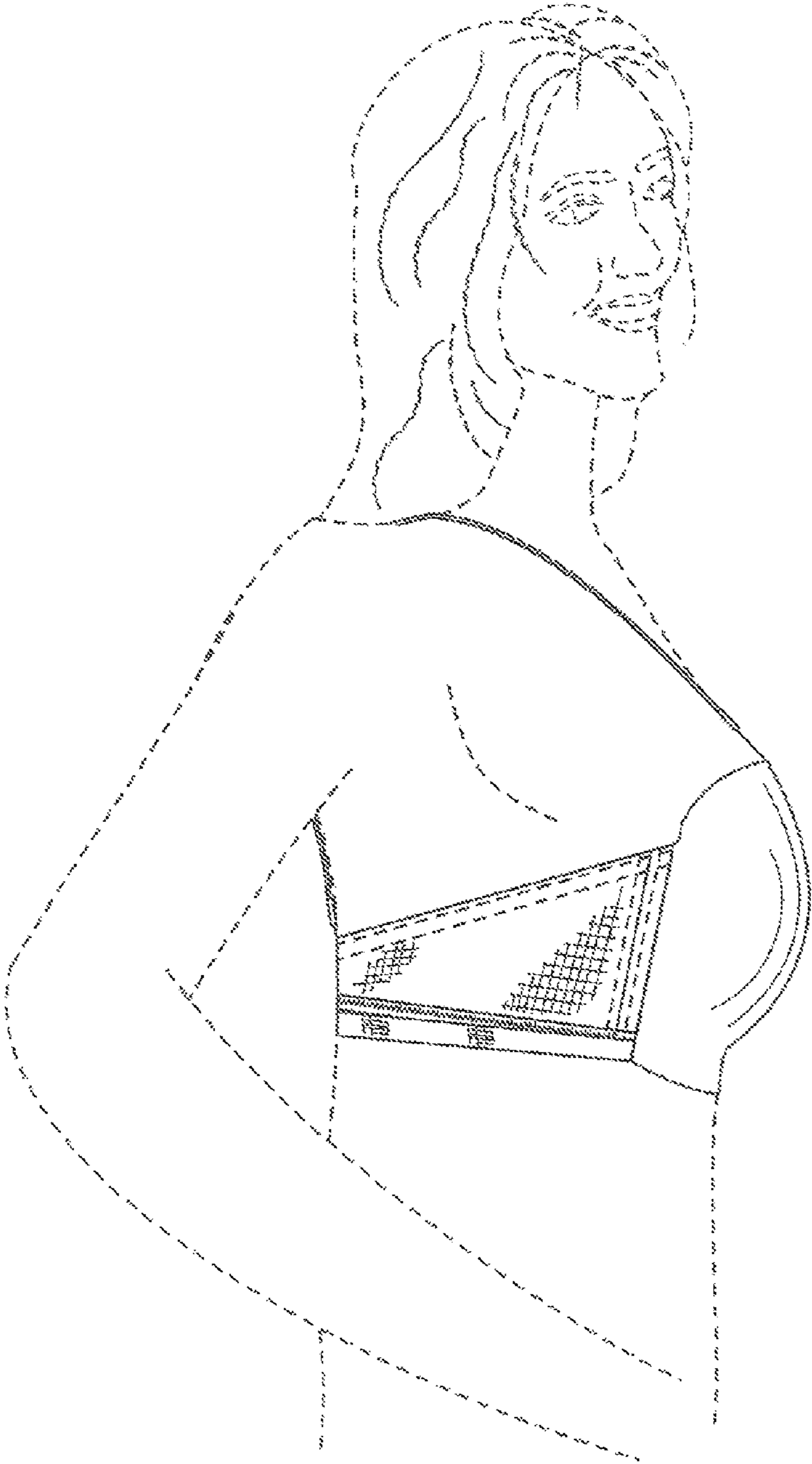
