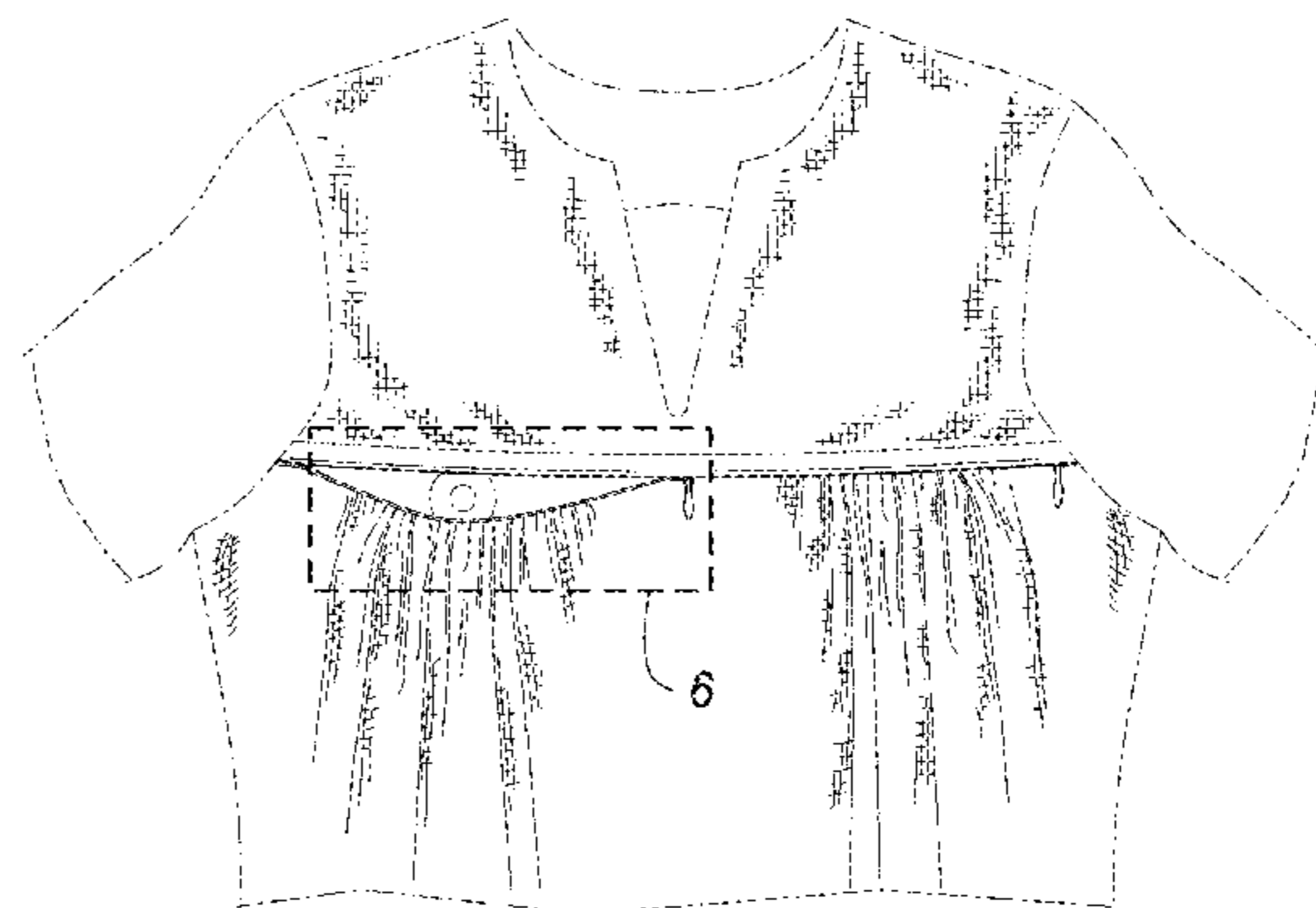
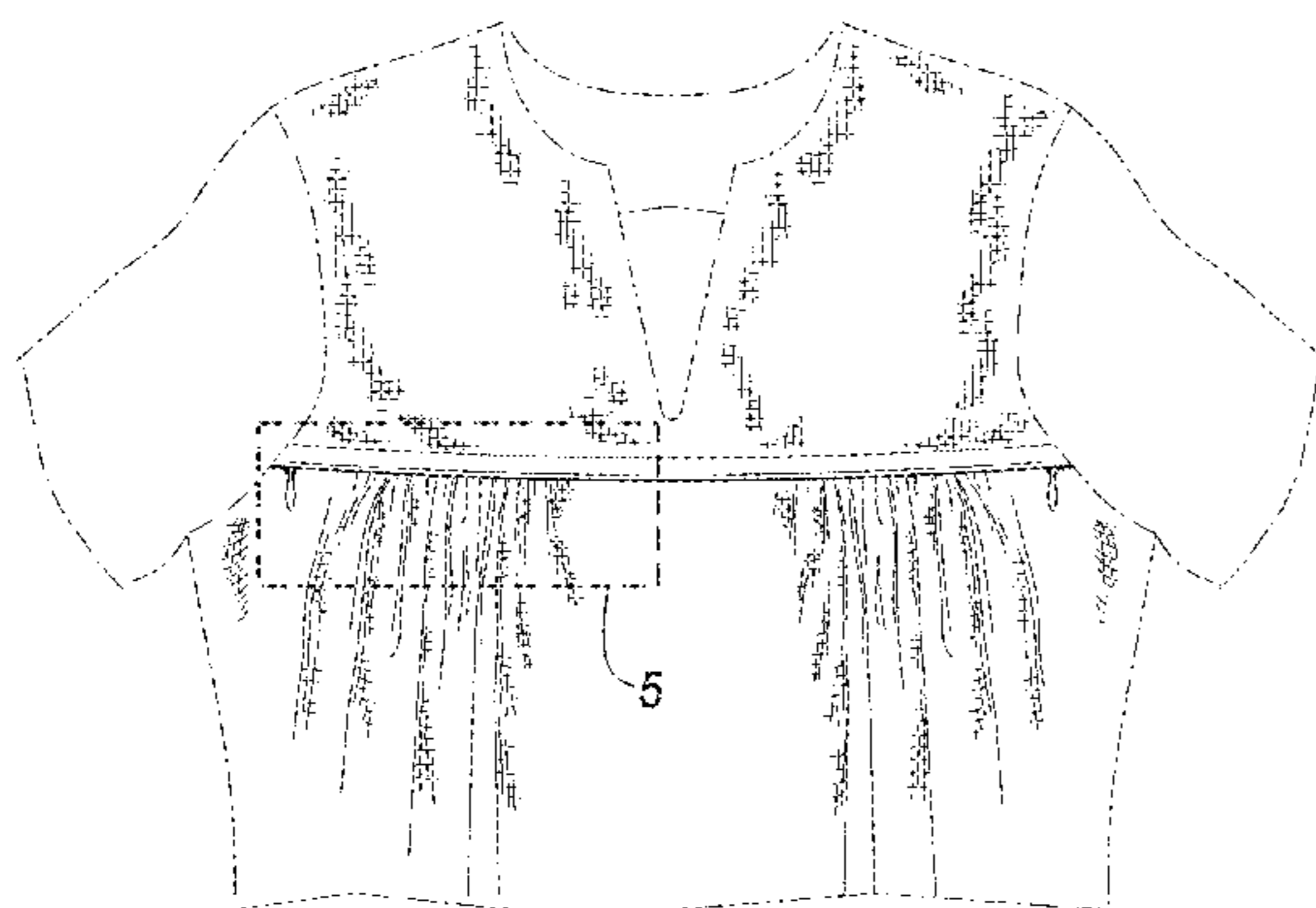
The ornamental design for a breast access garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a breast access garment, showing my new design in a closed mode;  
FIG. 2 is a front elevation view of FIG. 1 shown in a partially open mode;  
FIG. 3 is a backside elevation view of FIG. 1;  
FIG. 4 is a backside elevation view of FIG. 2;  
FIG. 5 is an enlarged sectional view taken along line 5 in FIG. 1; and,  
FIG. 6 is an enlarged sectional view taken along line 6 in FIG. 2.

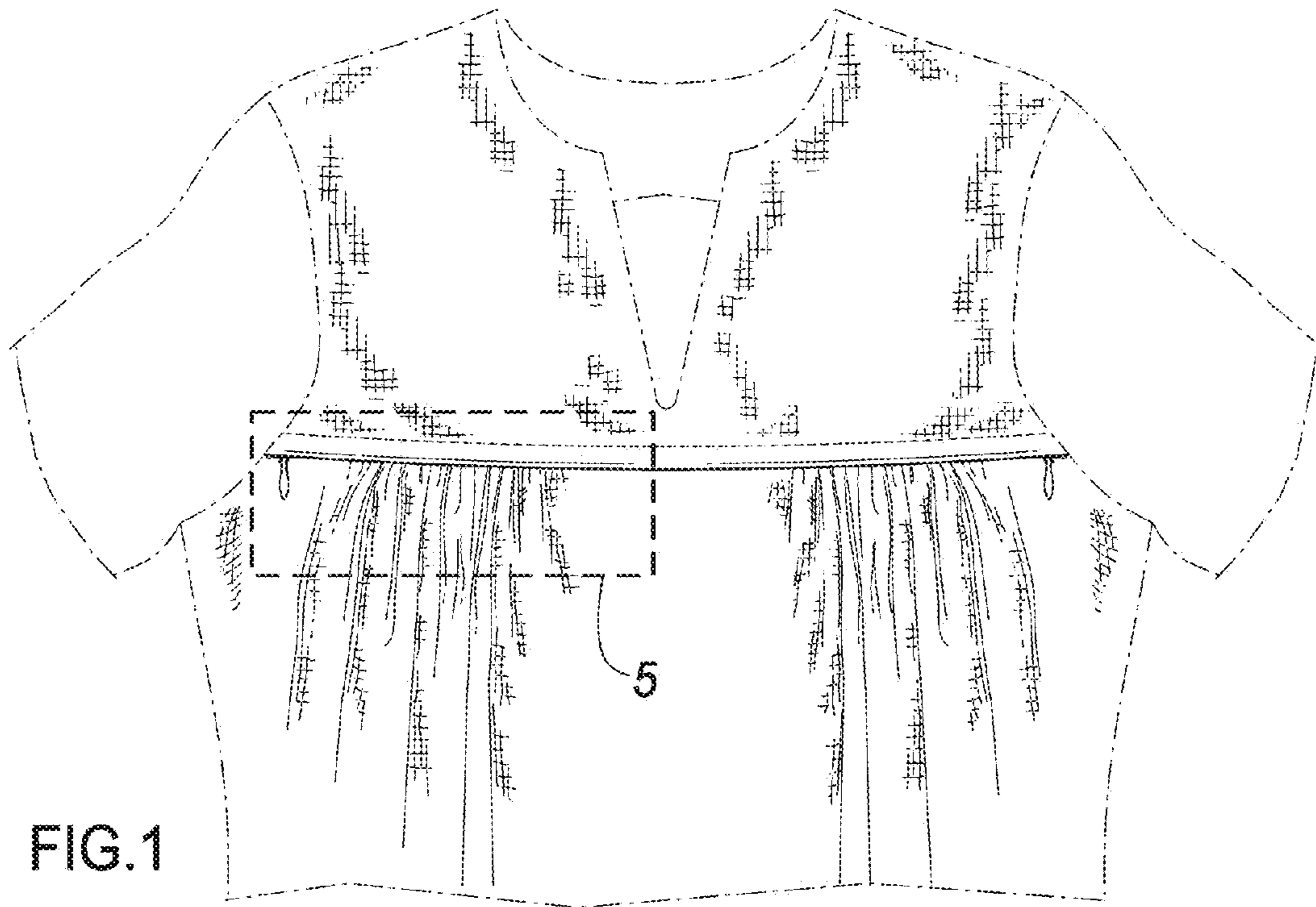

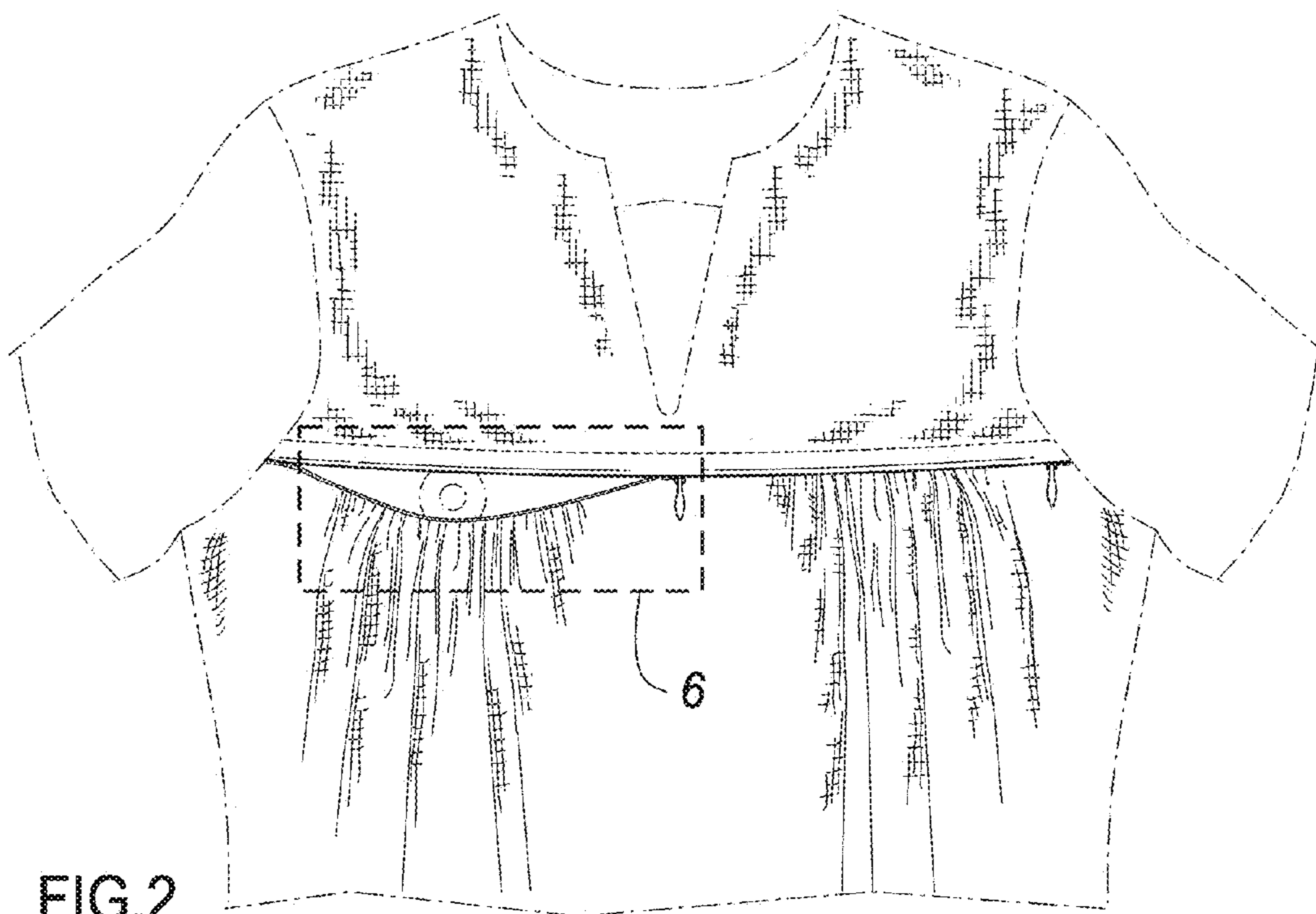

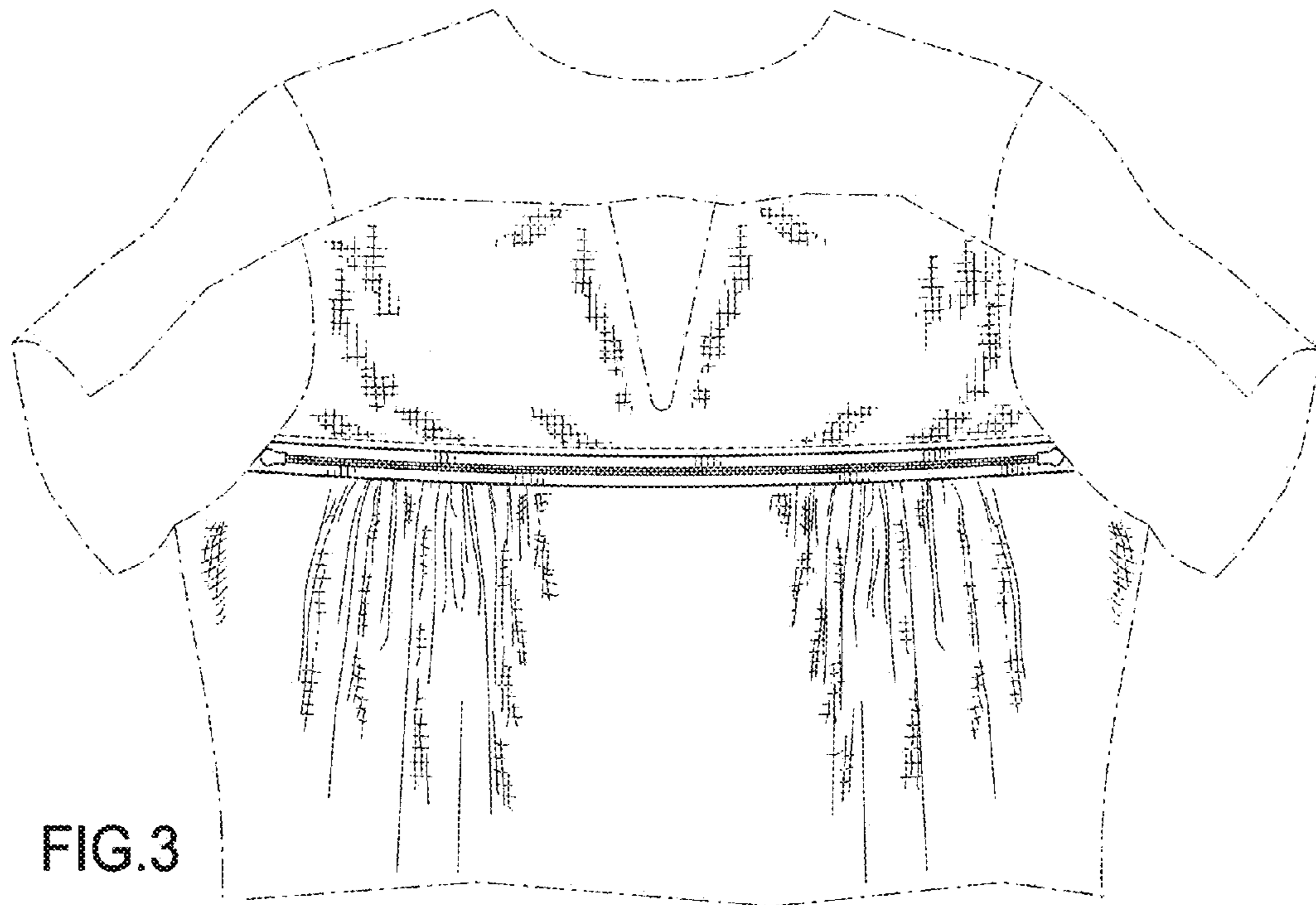

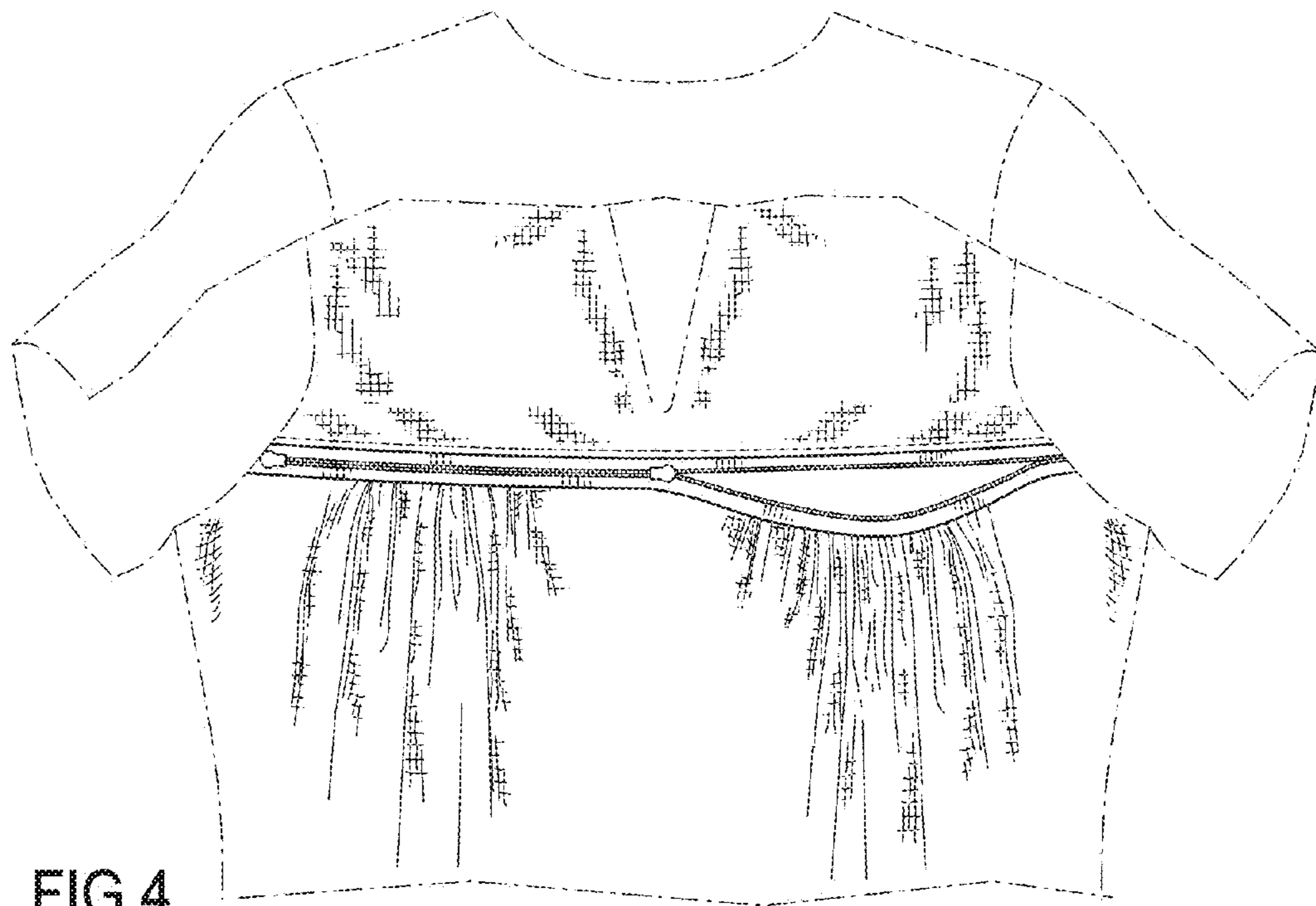

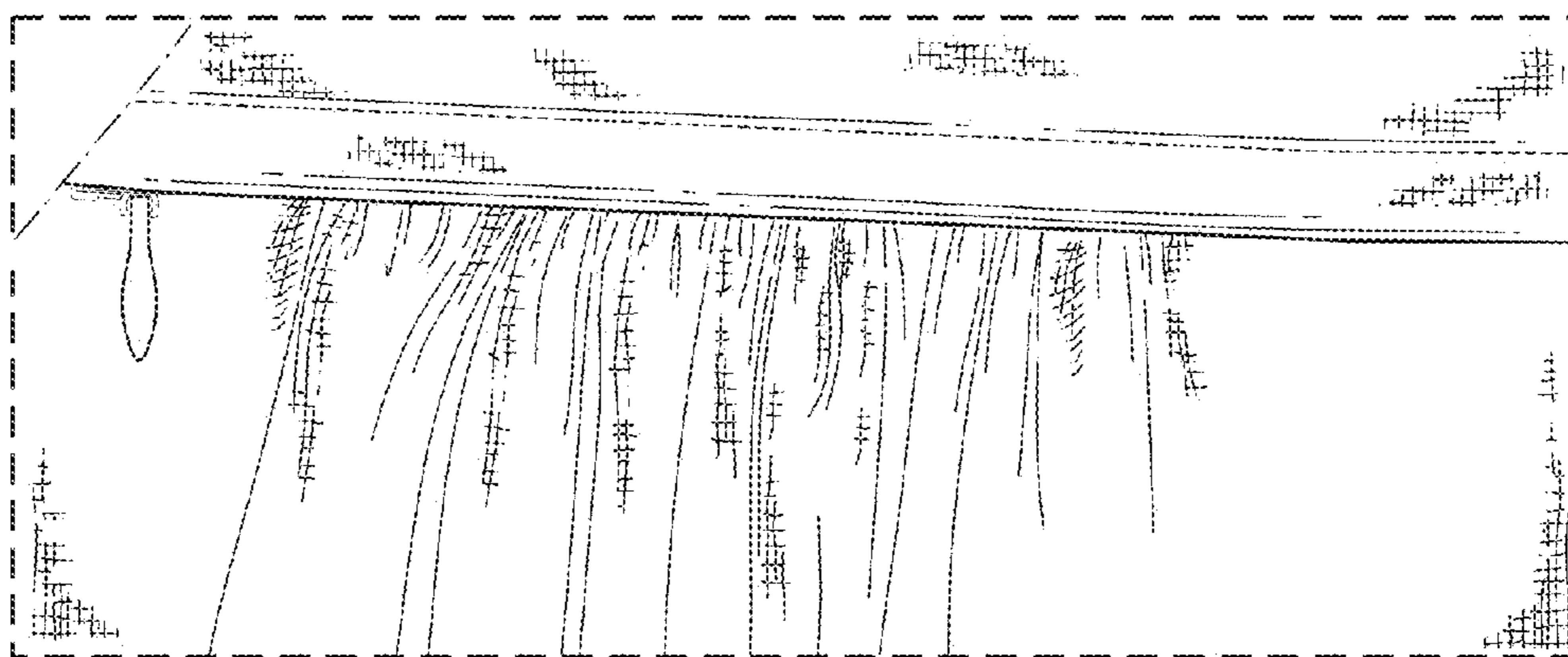

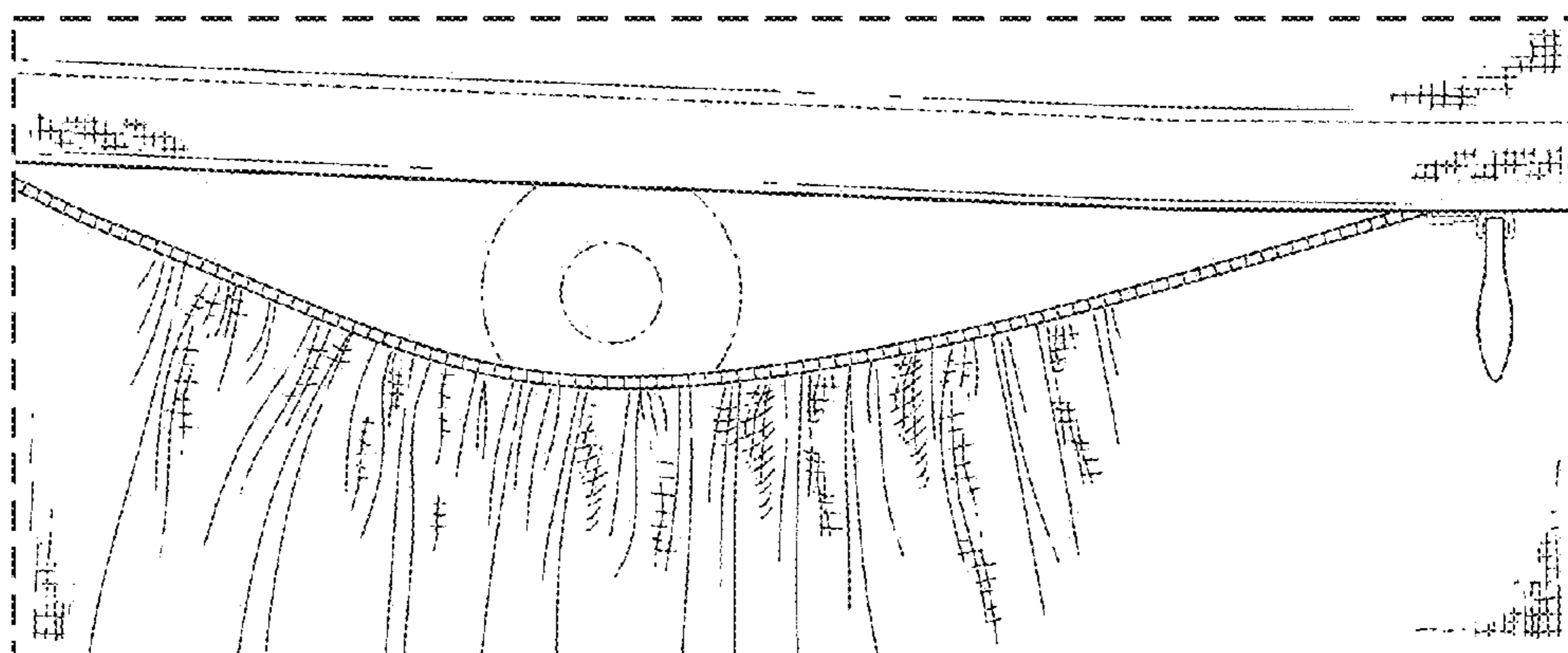
