FIG. 3 shows a reduced rear view of the toothbrush head and handle unit.

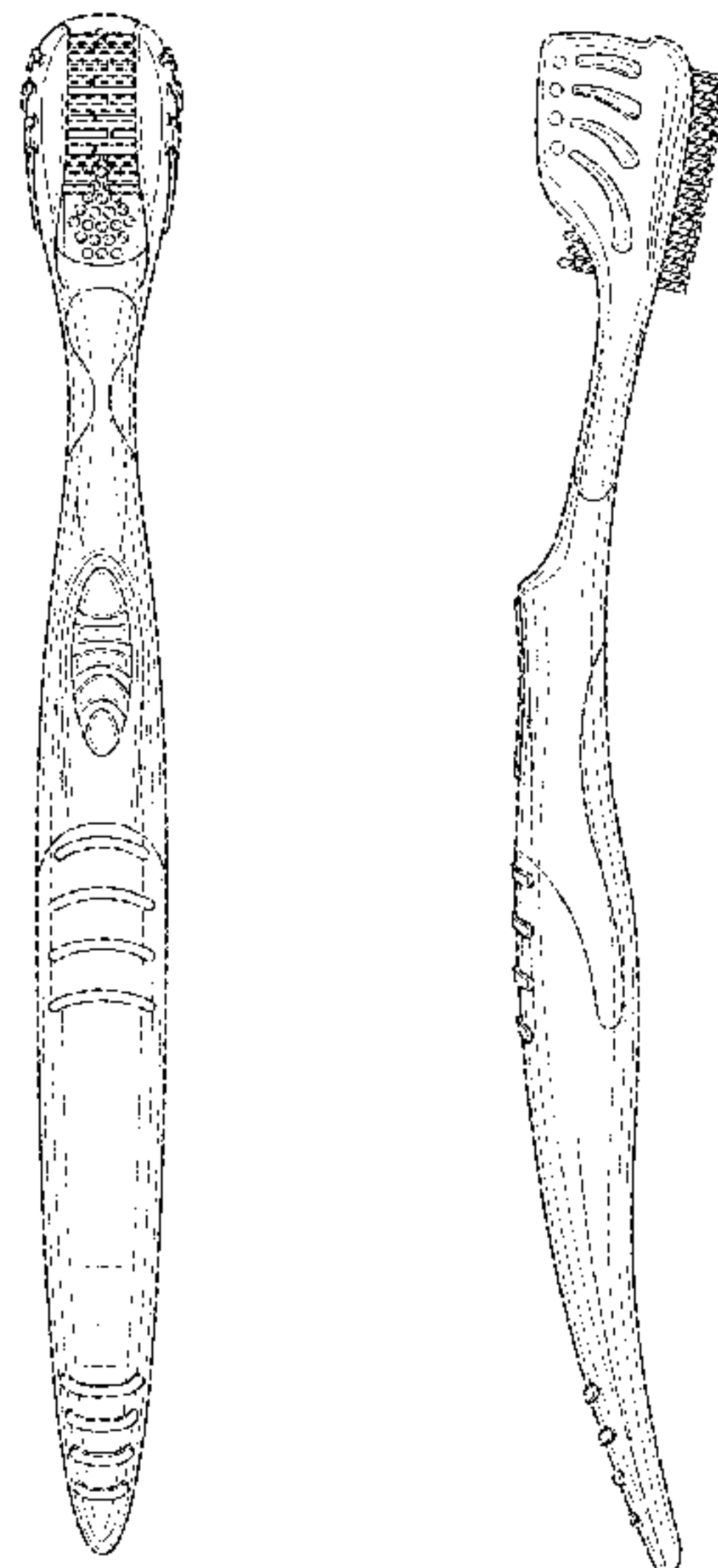
FIG. 4 shows a reduced side view of the toothbrush head and handle unit.

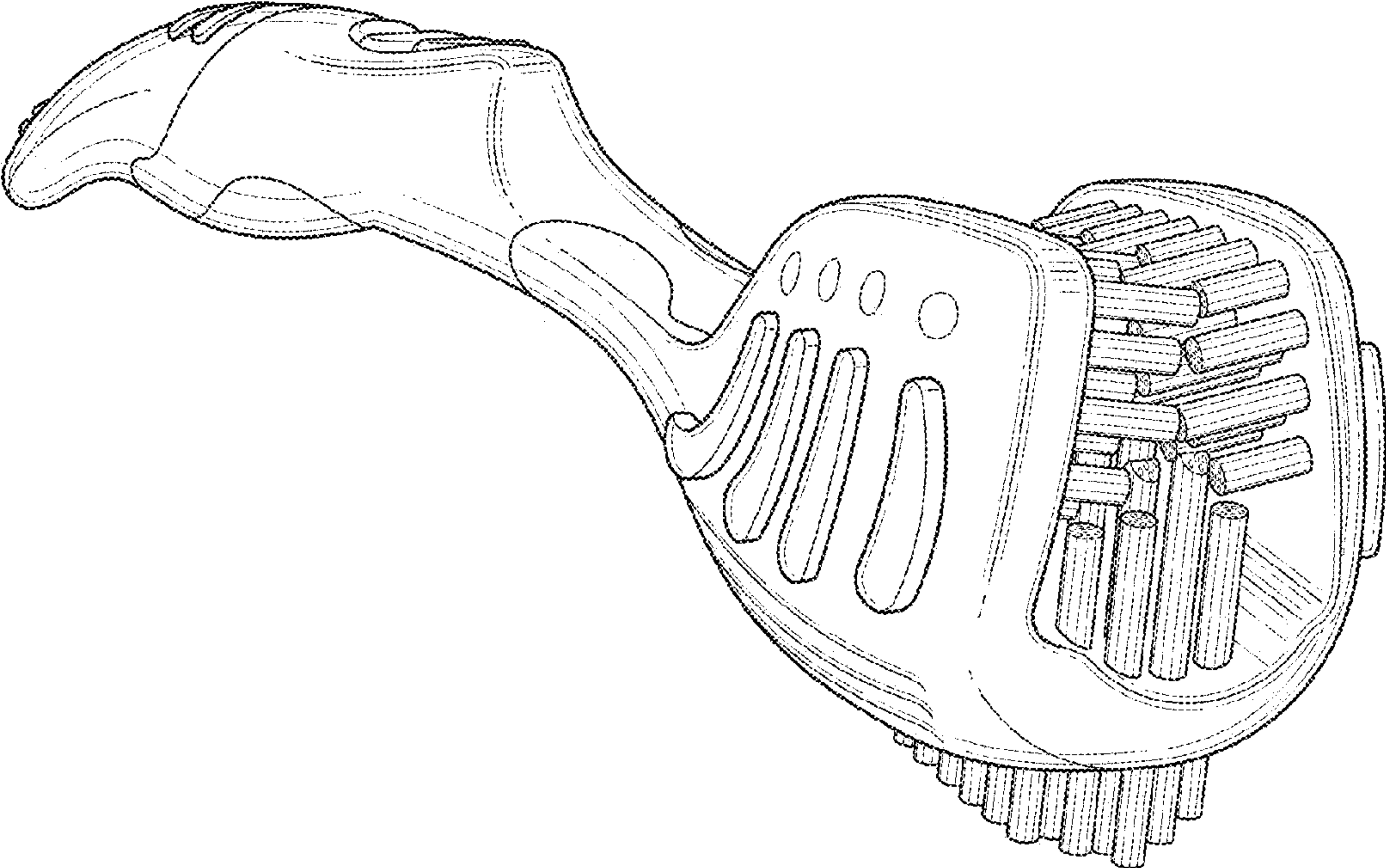

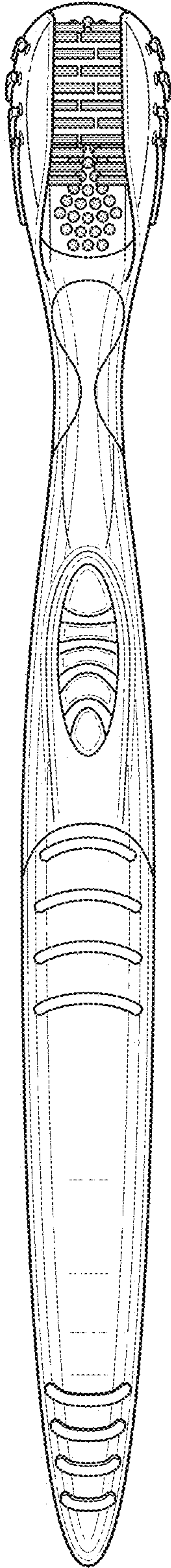

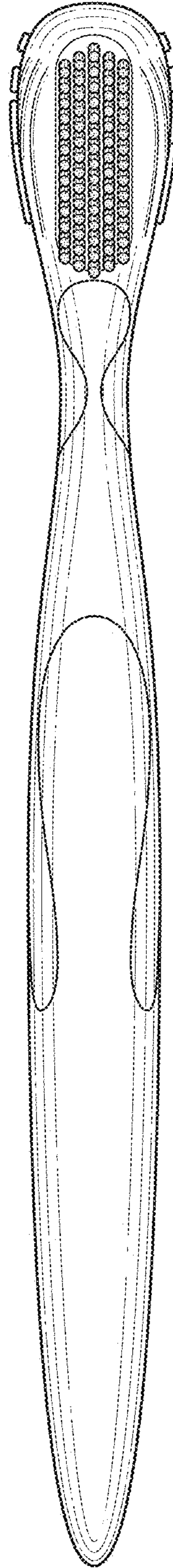

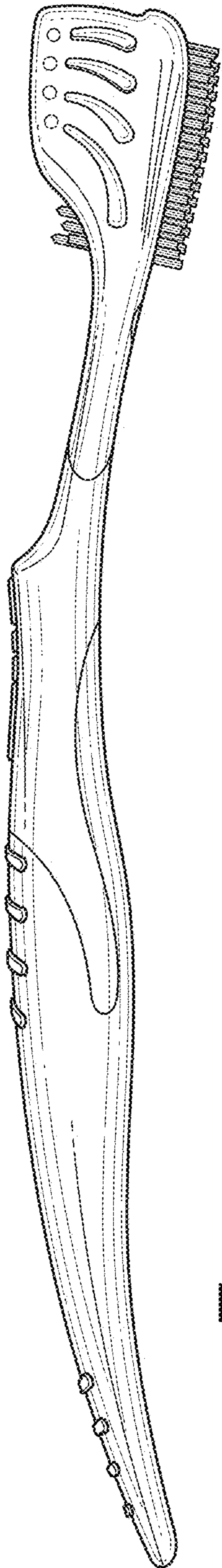

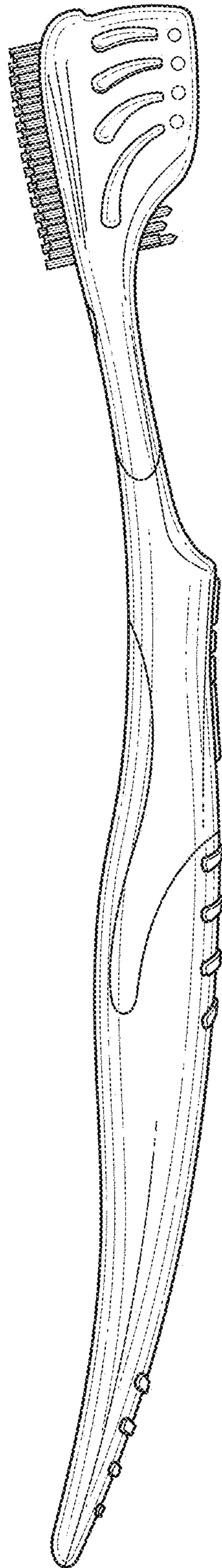

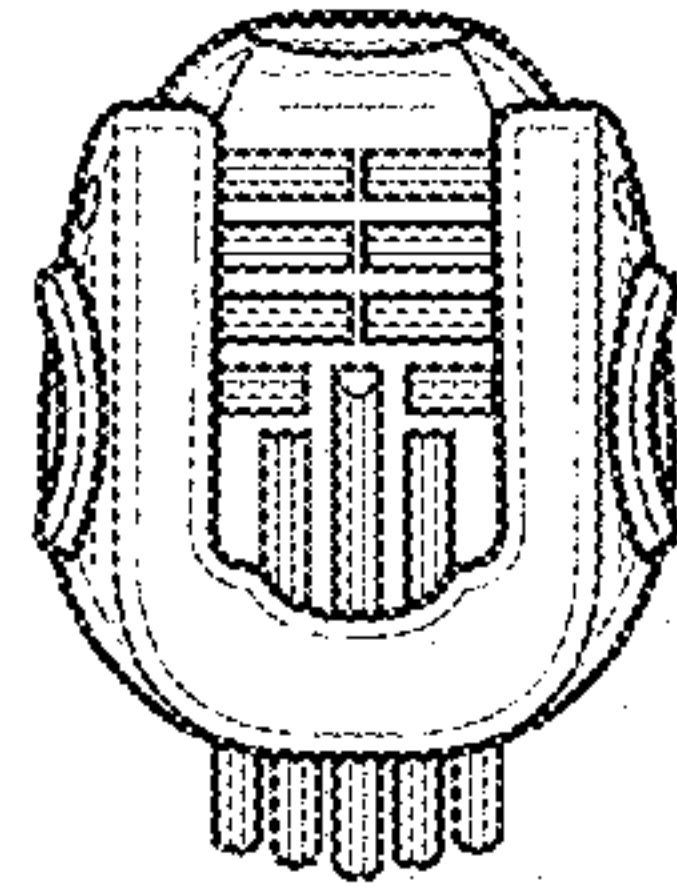

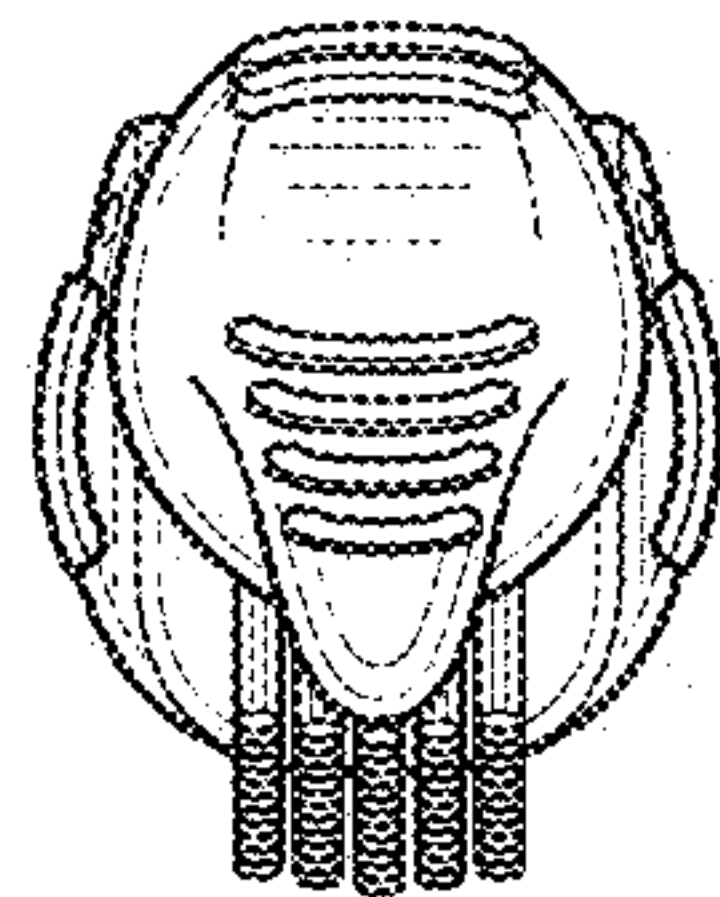
