DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a of a container body portion showing my new design;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

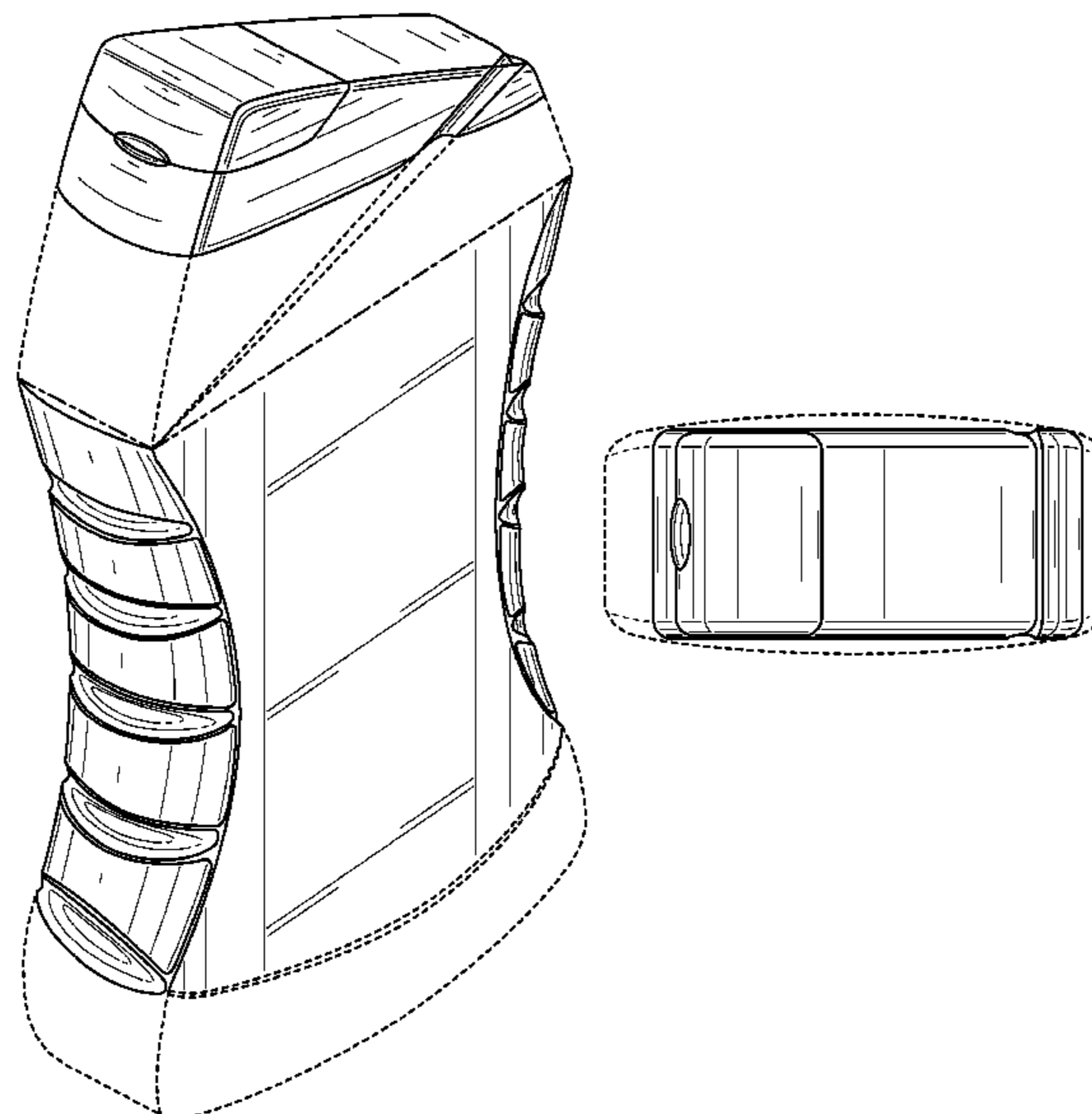
FIG. 6 is a top plan view thereof; and,

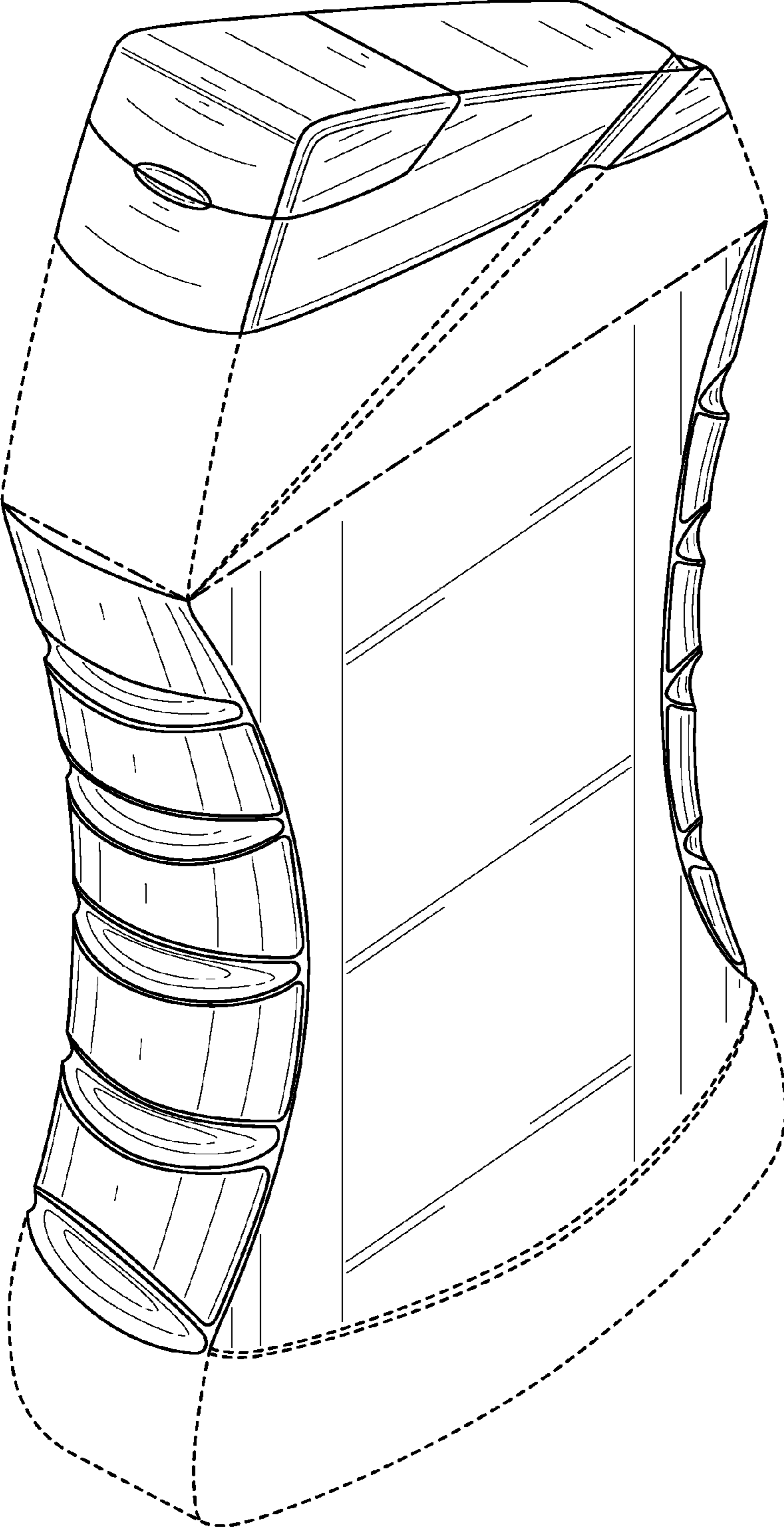

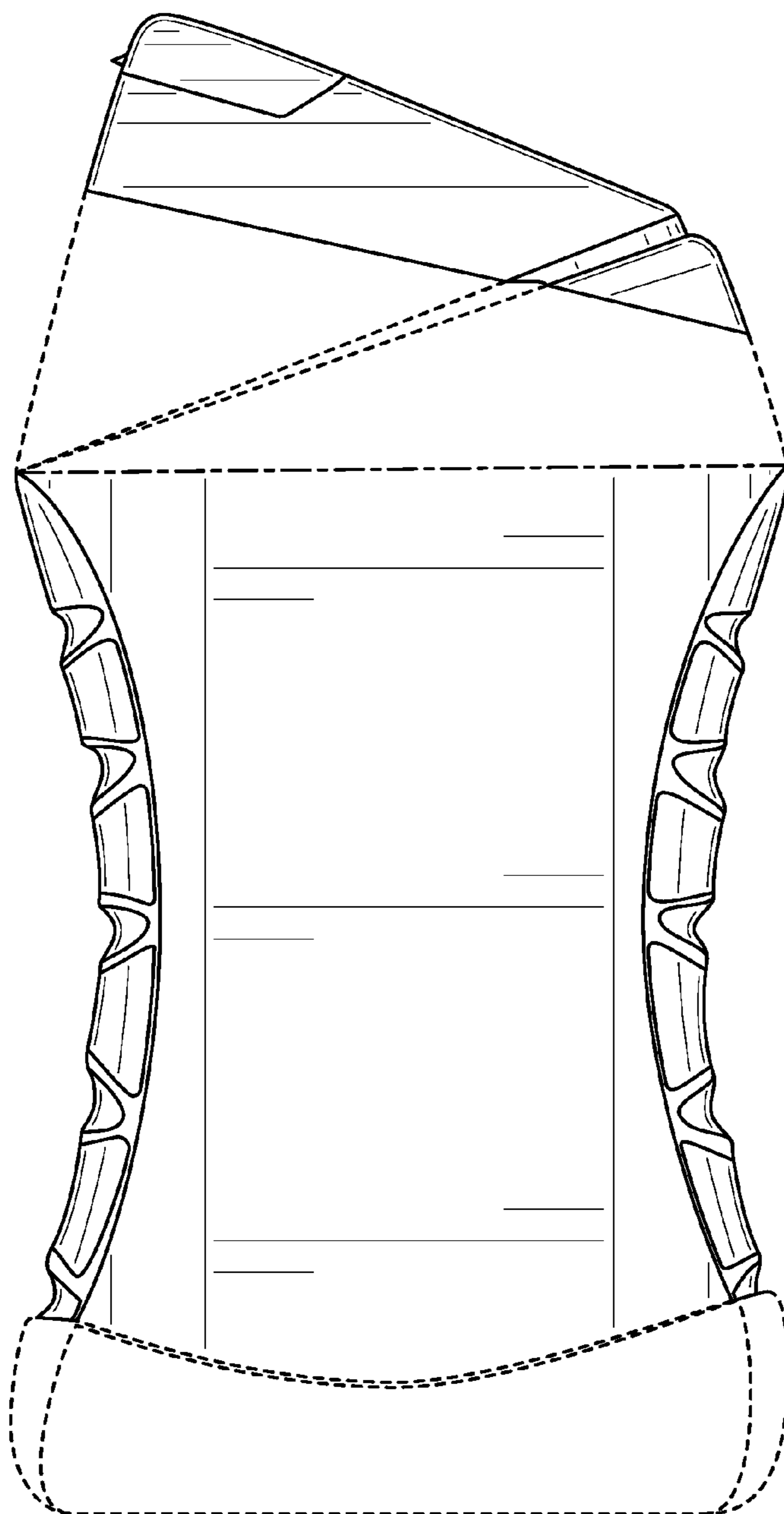

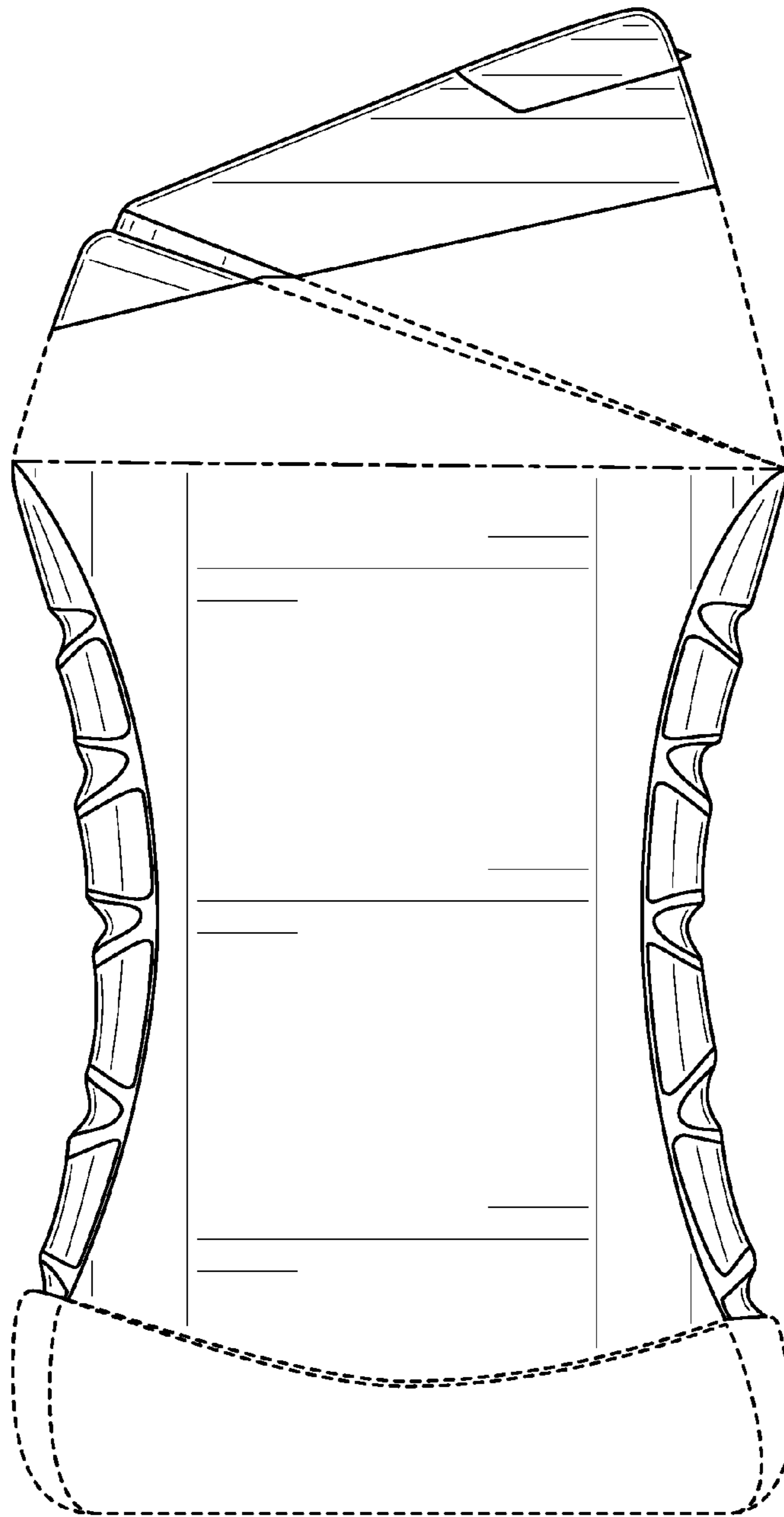

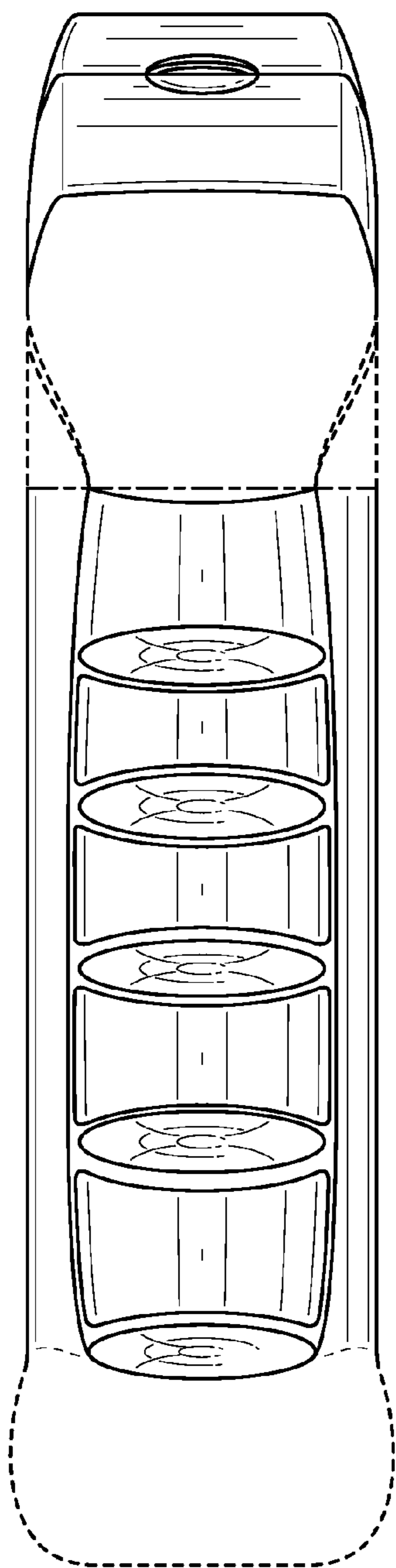

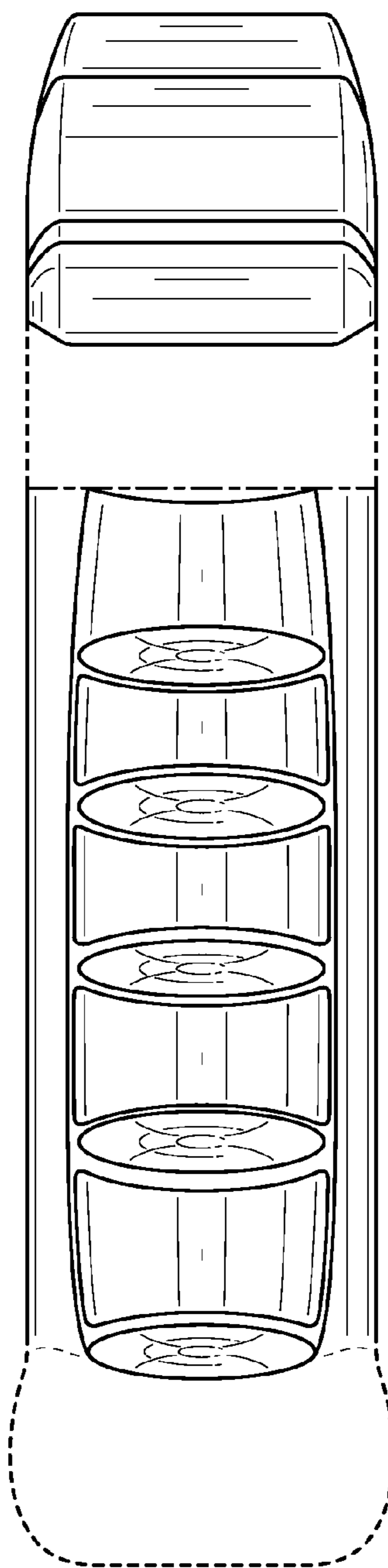

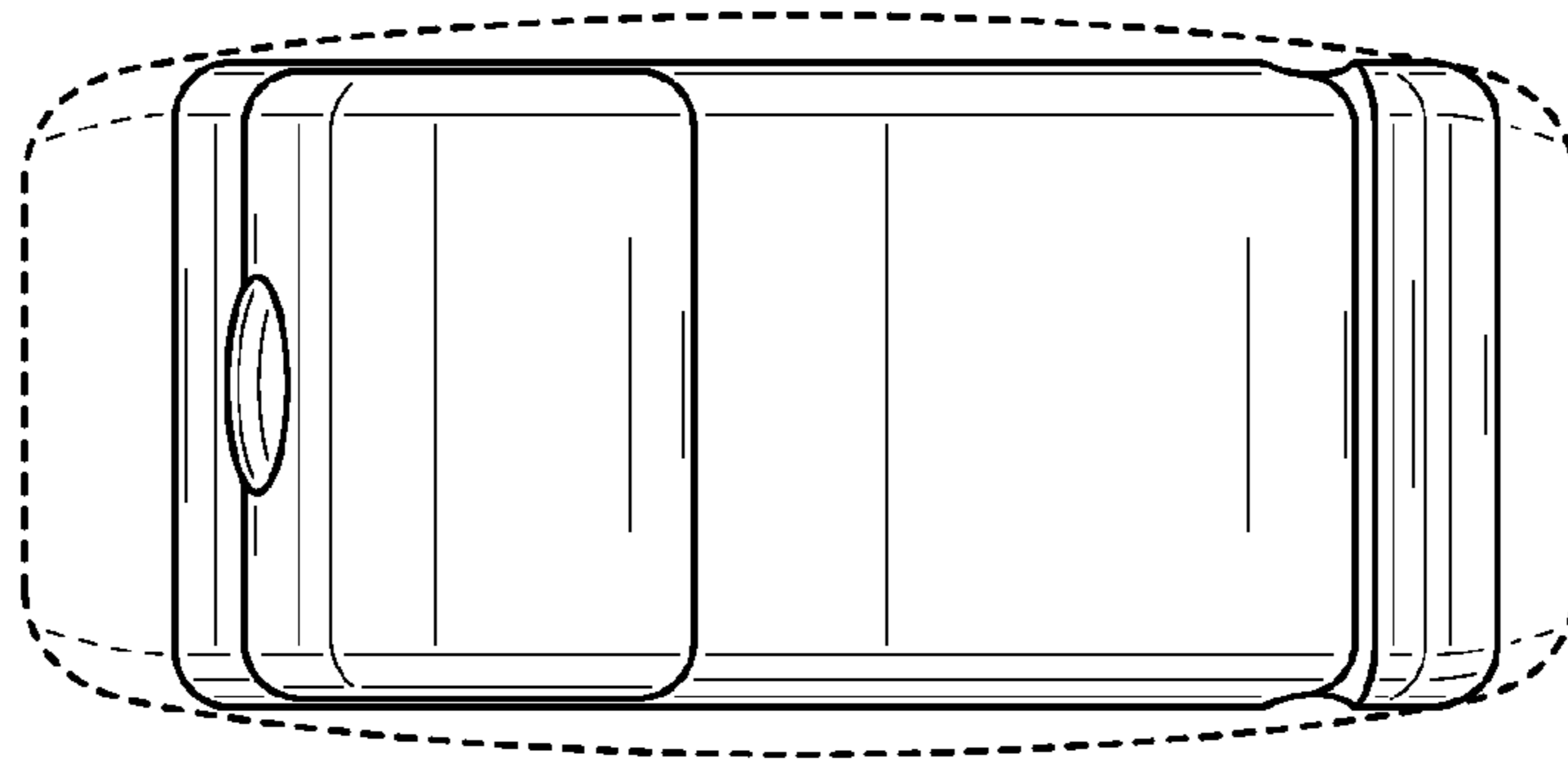

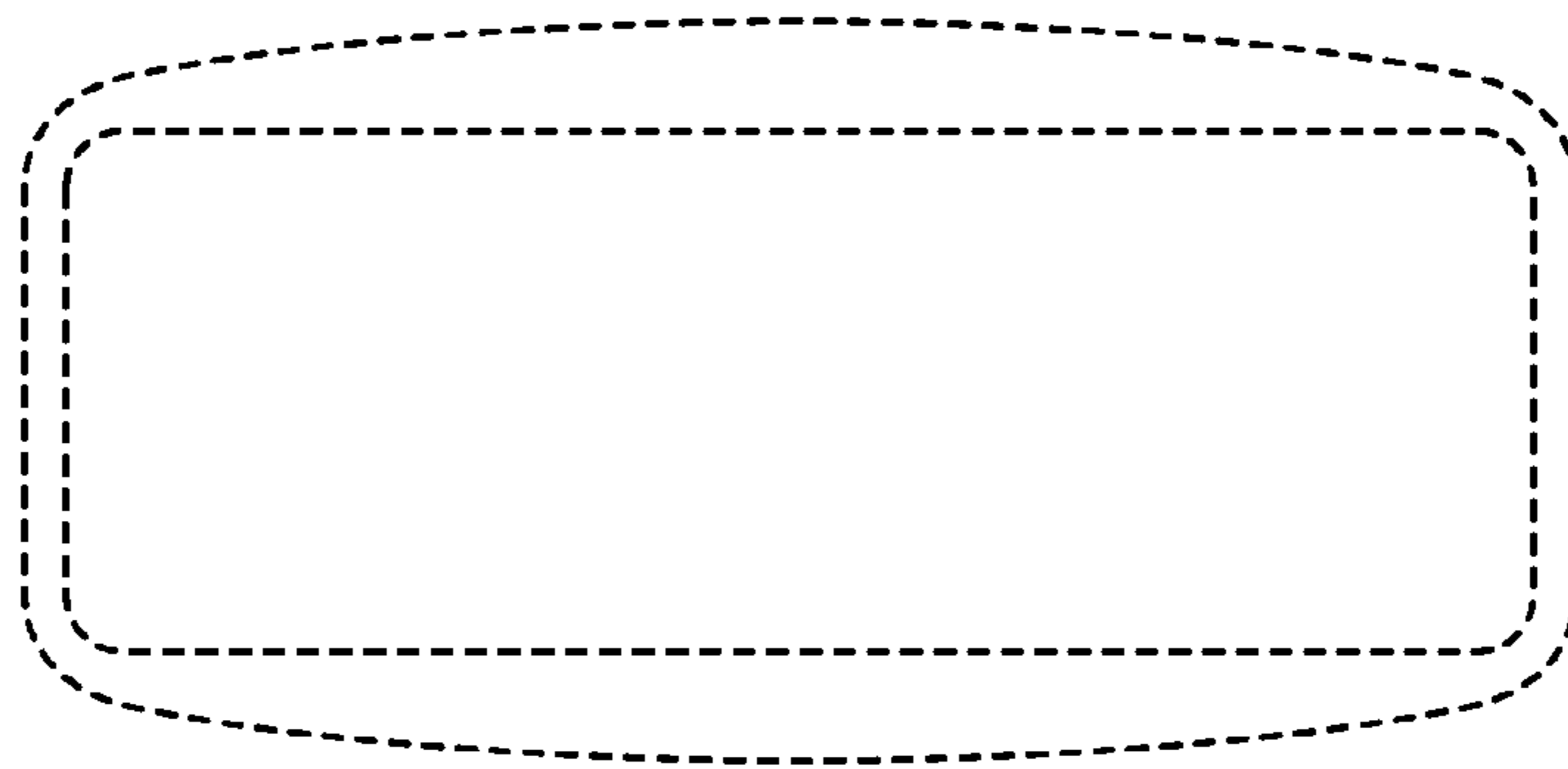
