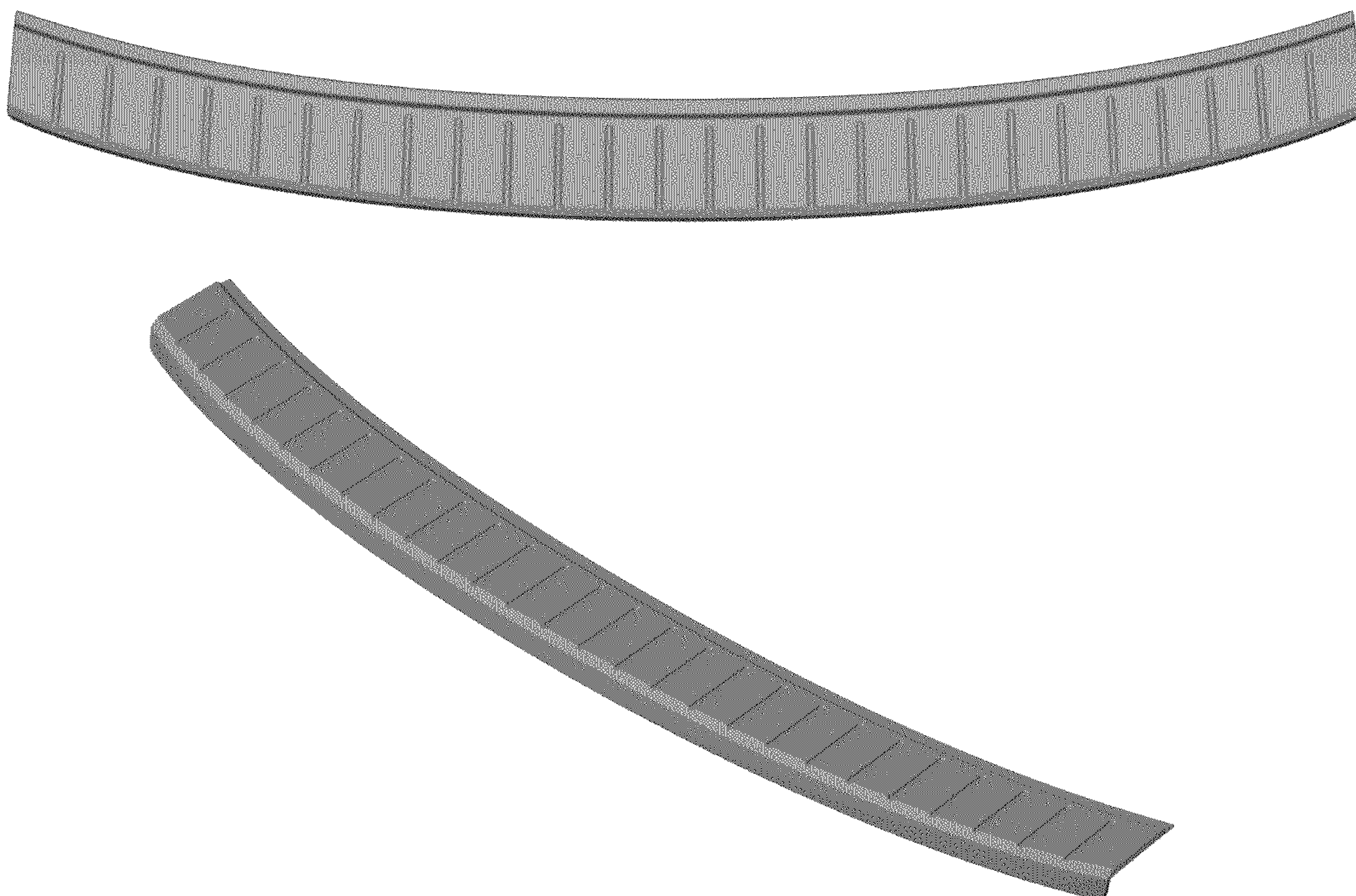
(57) **CLAIM**

The ornamental design for a vehicle rear bumper cover step, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a vehicle rear bumper cover step; FIG. 2 is a bottom plan view of the vehicle rear bumper cover step; FIG. 3 is a front elevational view of the vehicle rear bumper cover step; FIG. 4 is a left side elevational view of the vehicle rear bumper cover step; FIG. 5 is a right side elevational view of the vehicle rear bumper cover step; FIG. 6 is a perspective view of the vehicle rear bumper cover step; and, FIG. 7 is another perspective view of the vehicle rear bumper cover step.

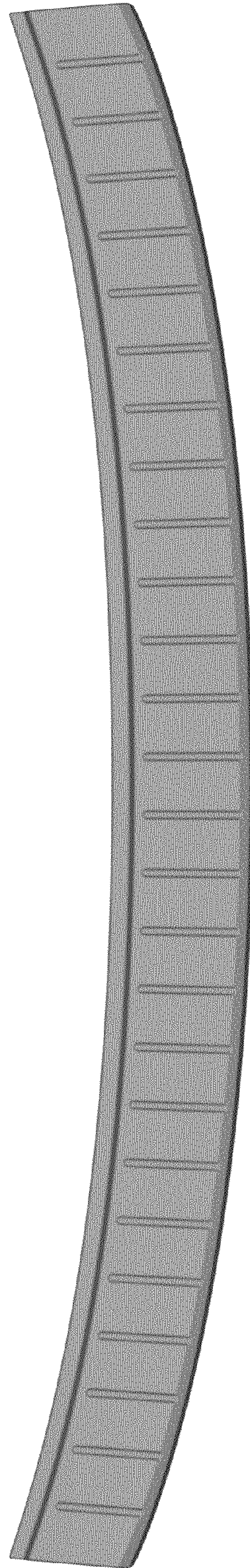
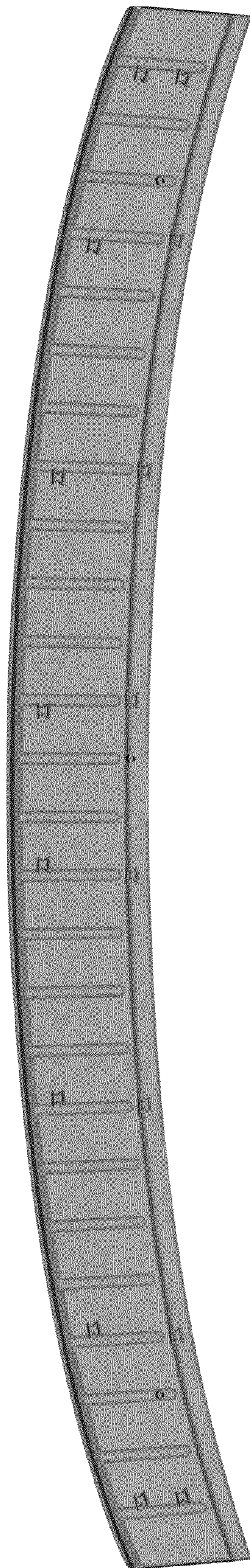

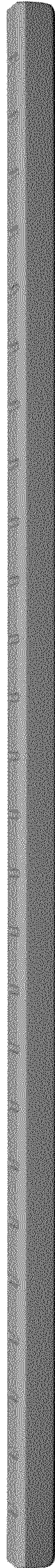

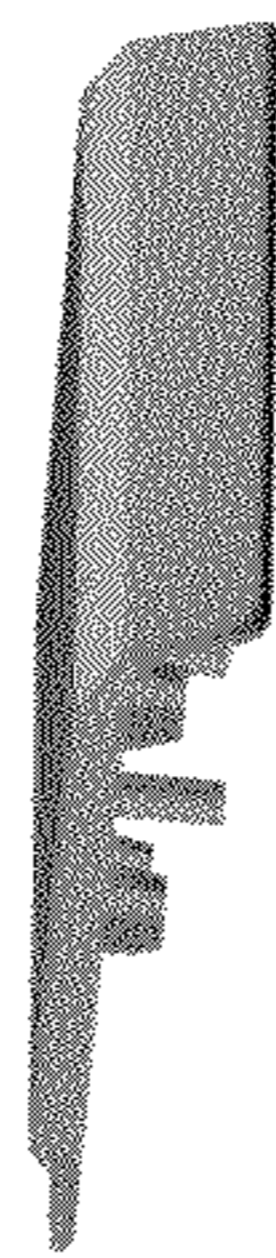

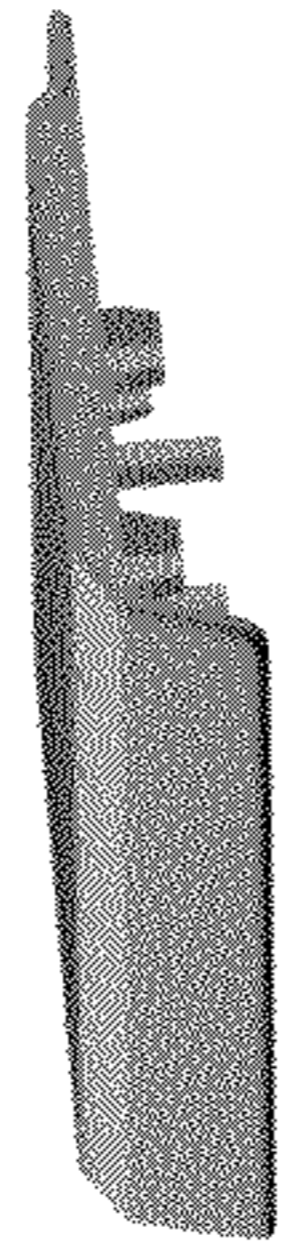

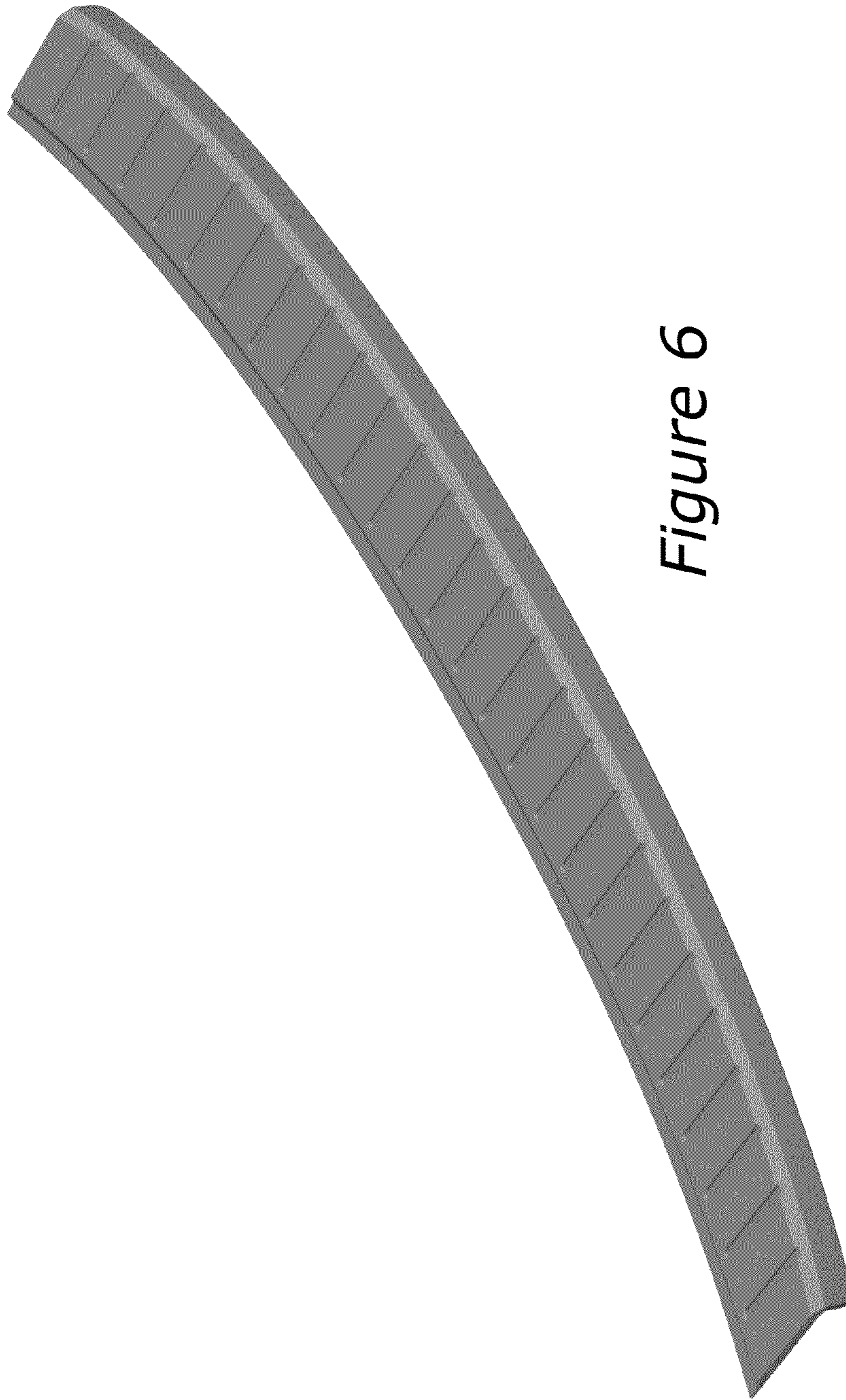

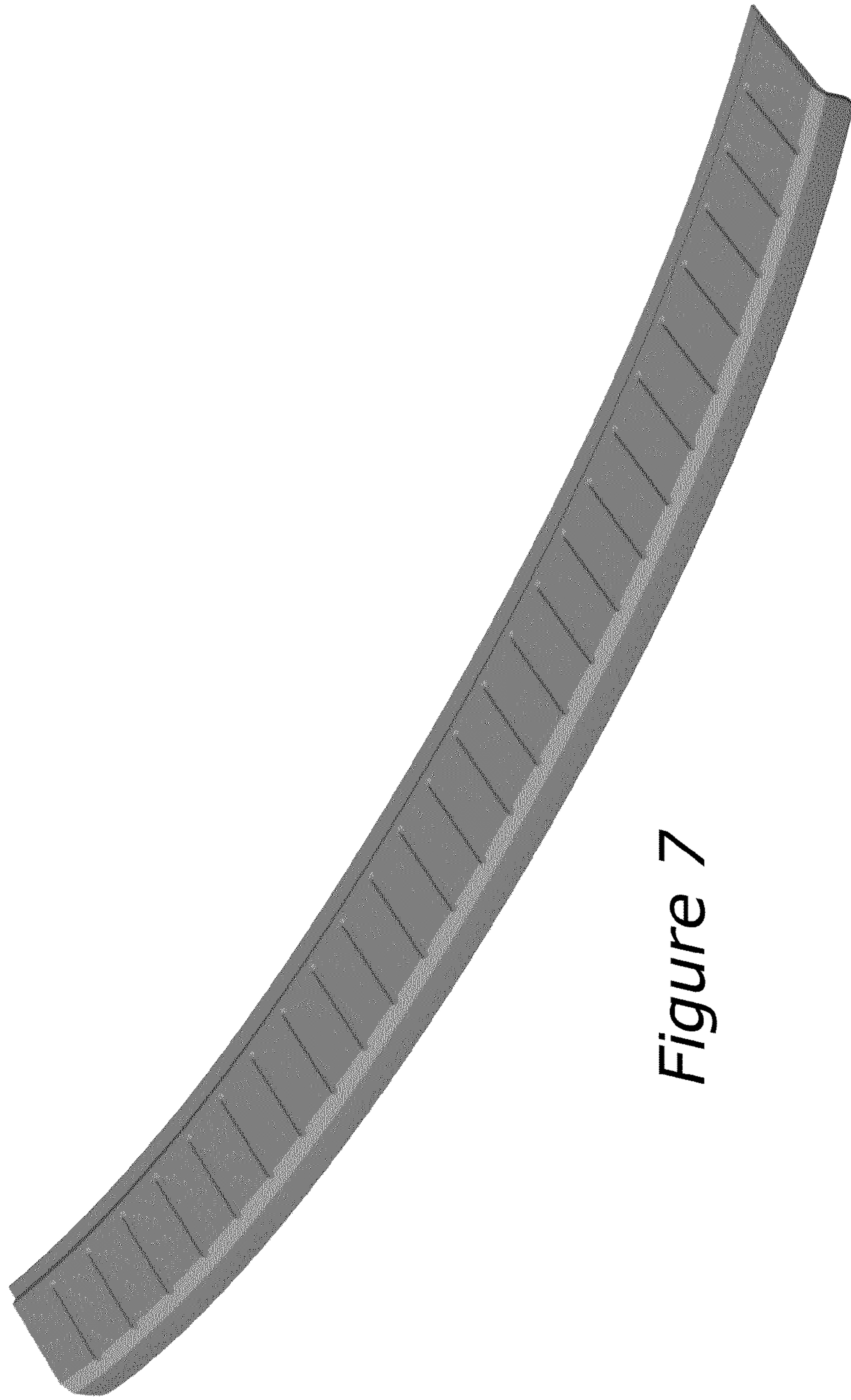
