FIG. 25 is a front elevational view thereof.

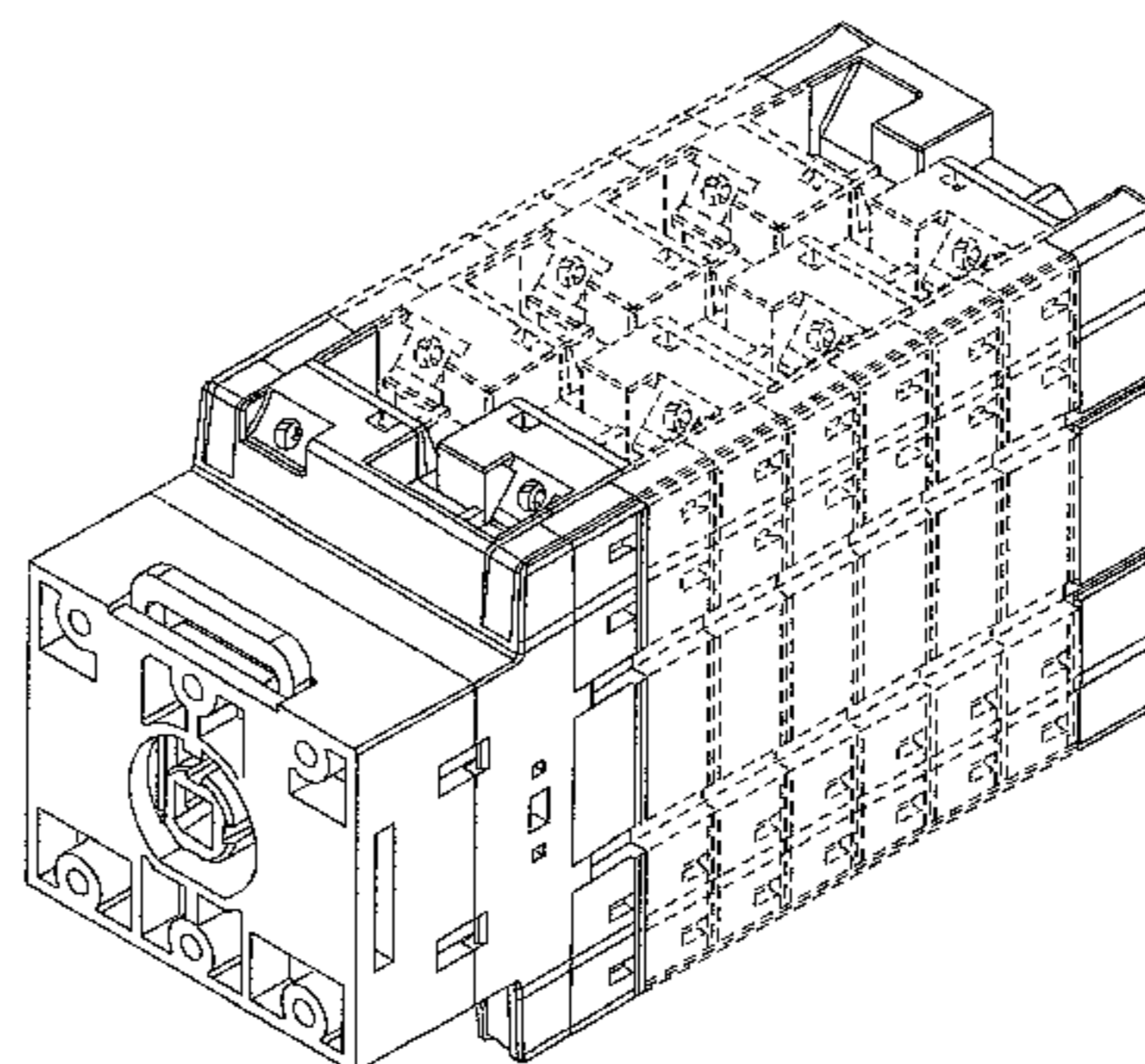
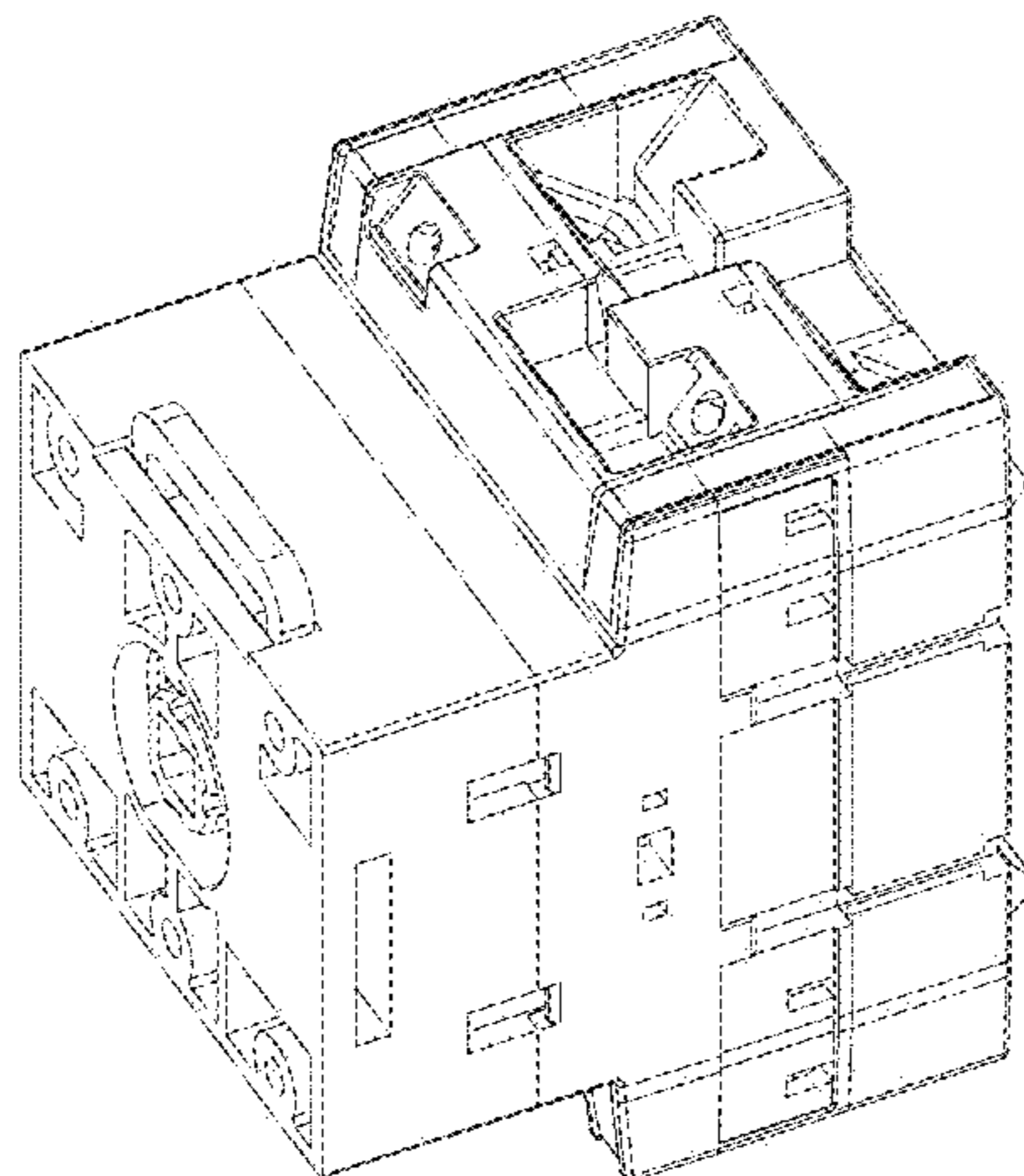

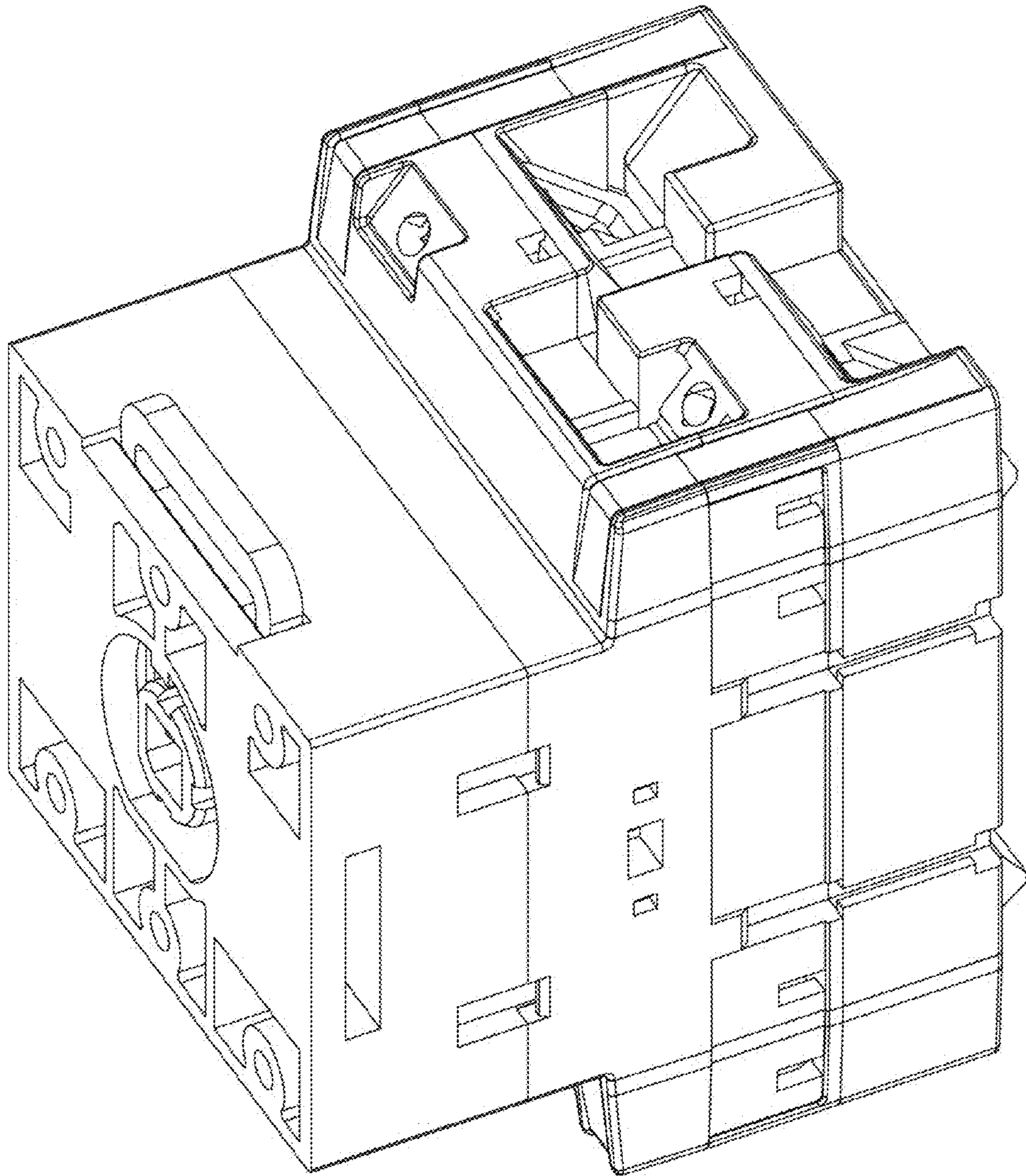

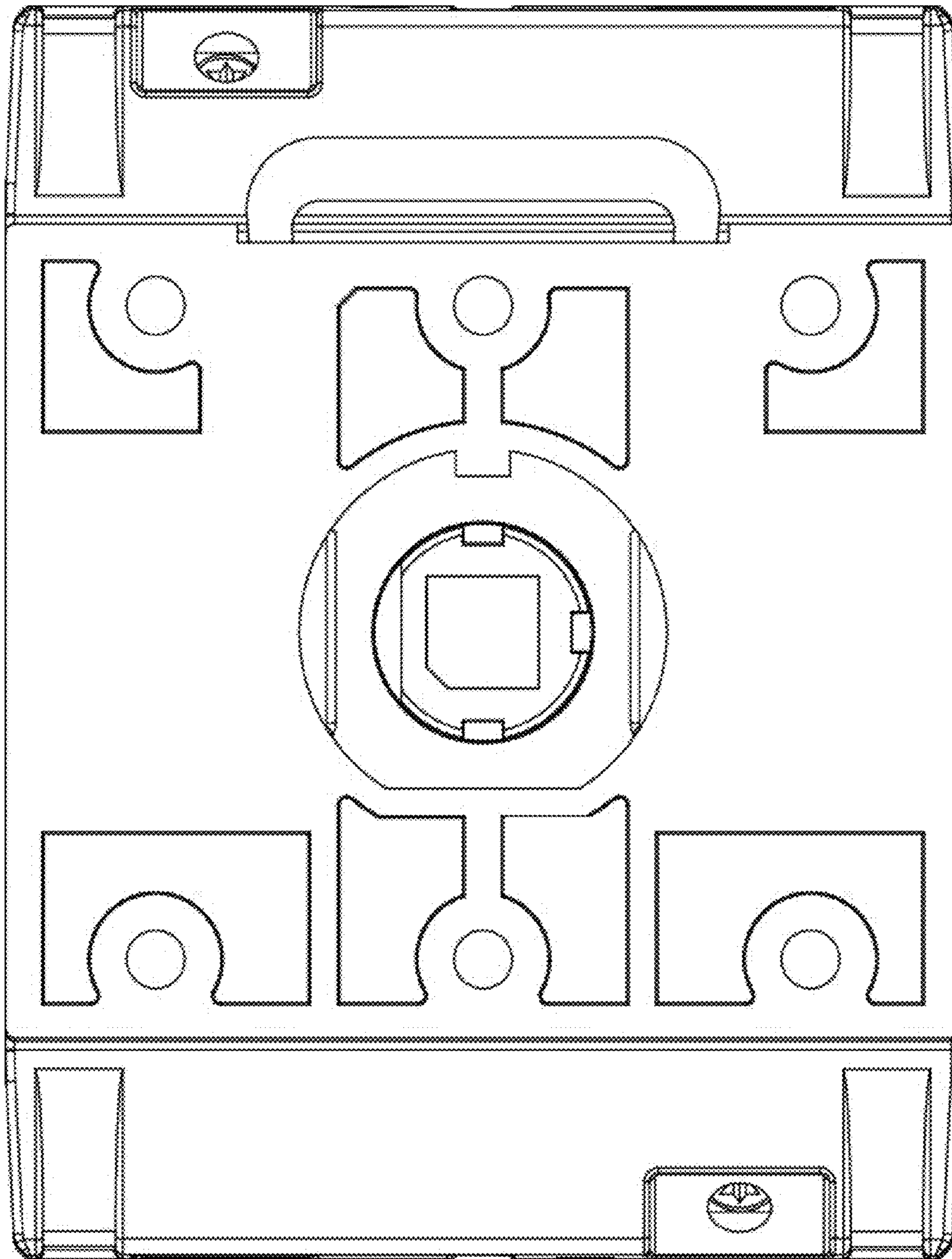

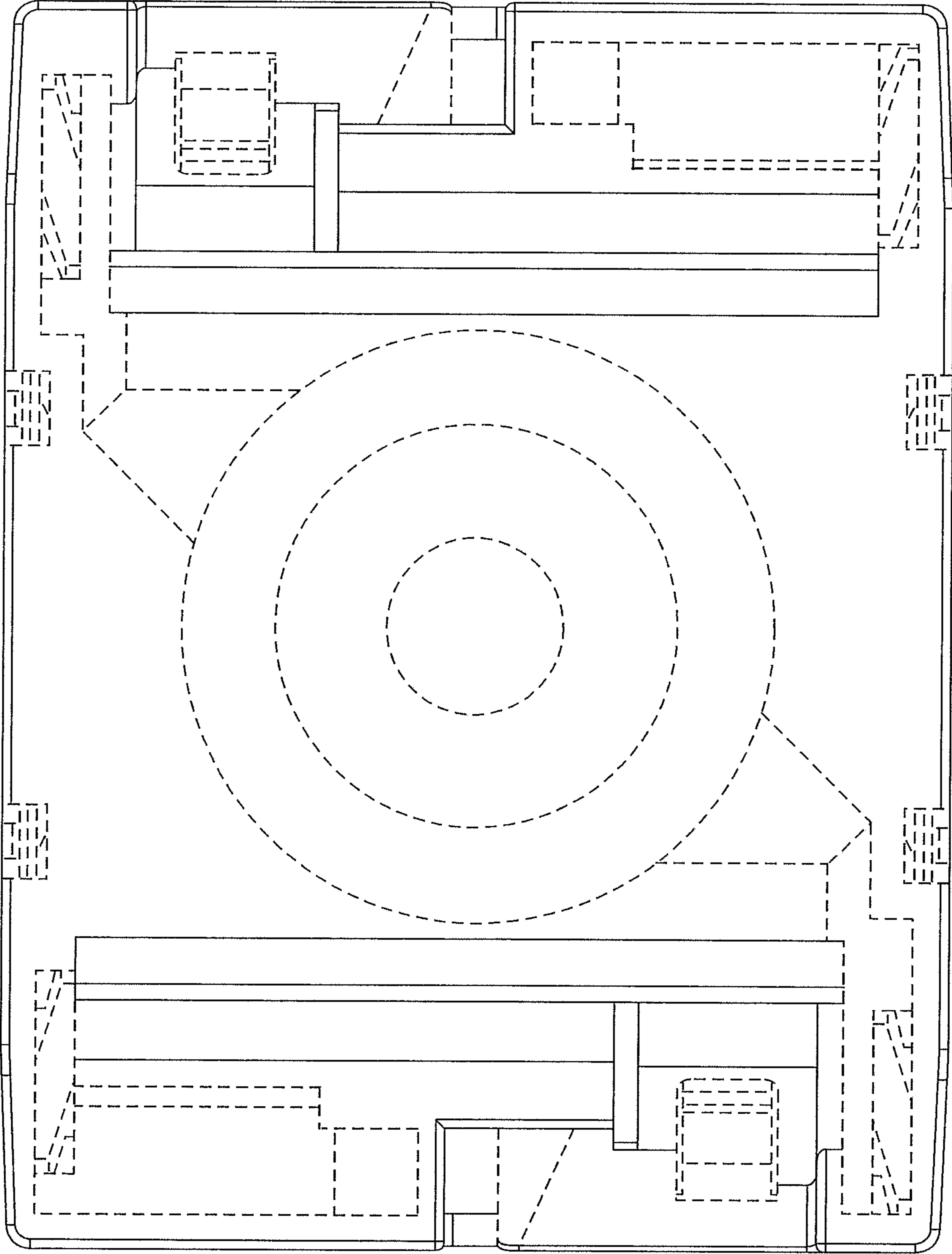

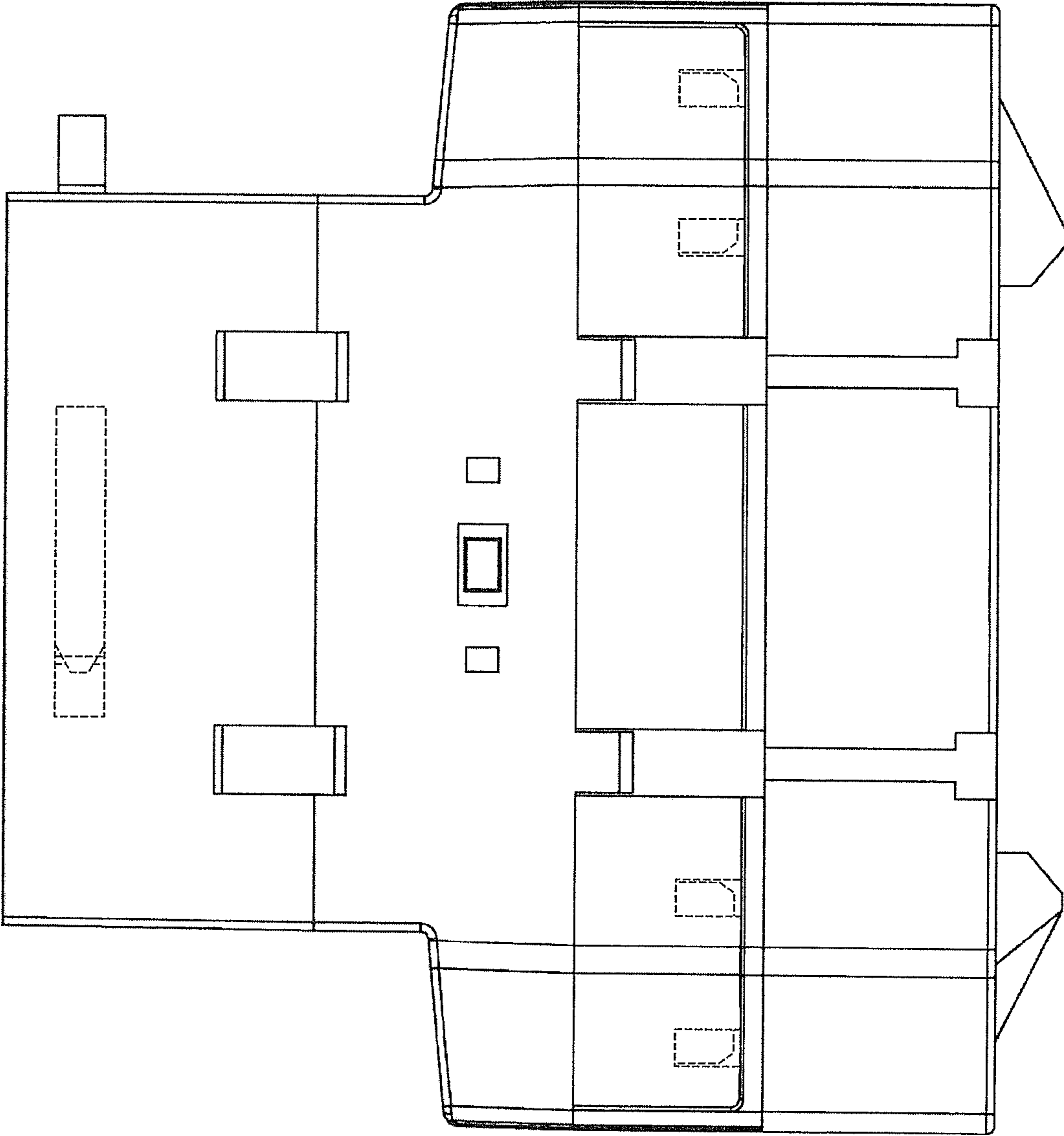

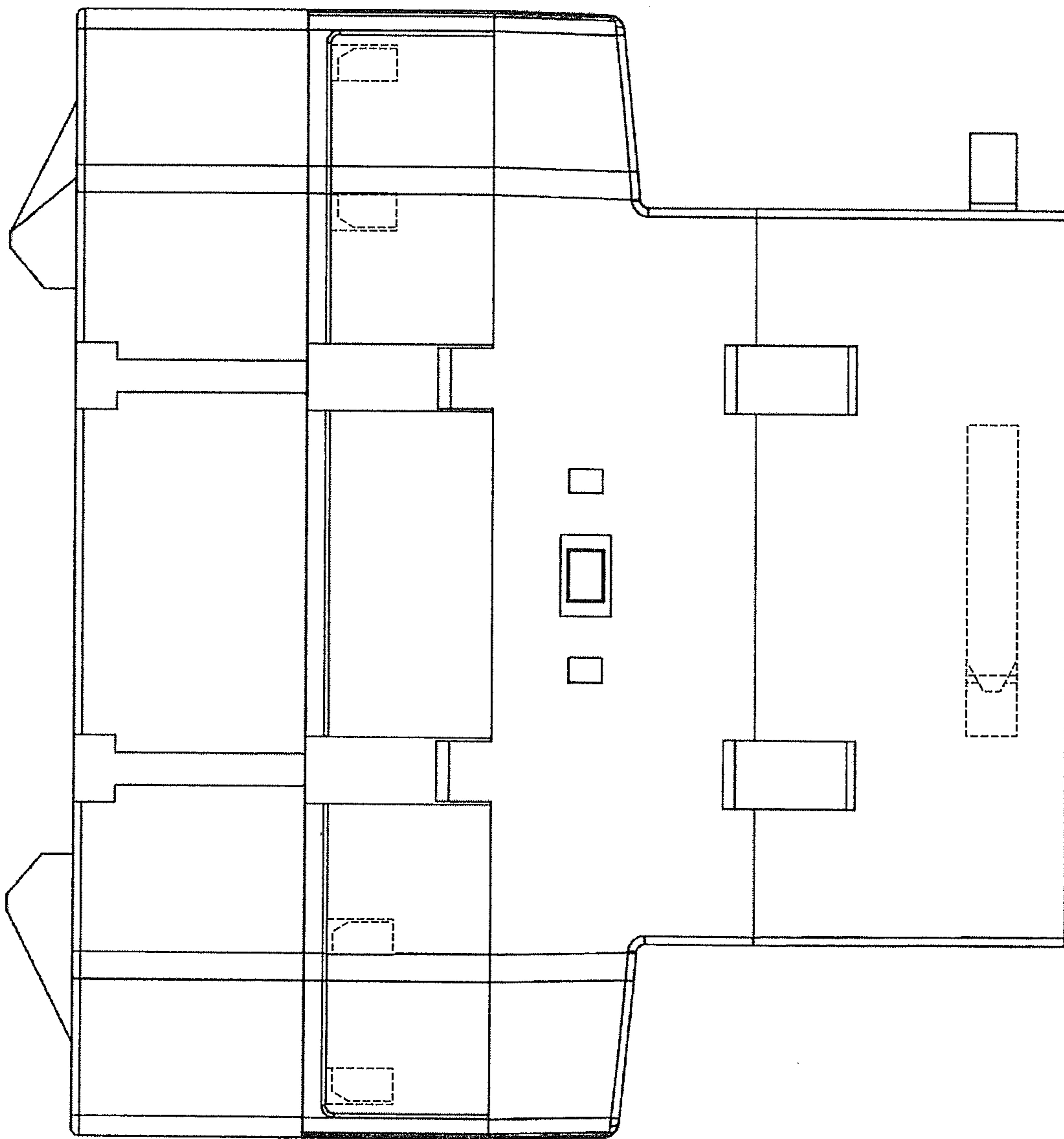

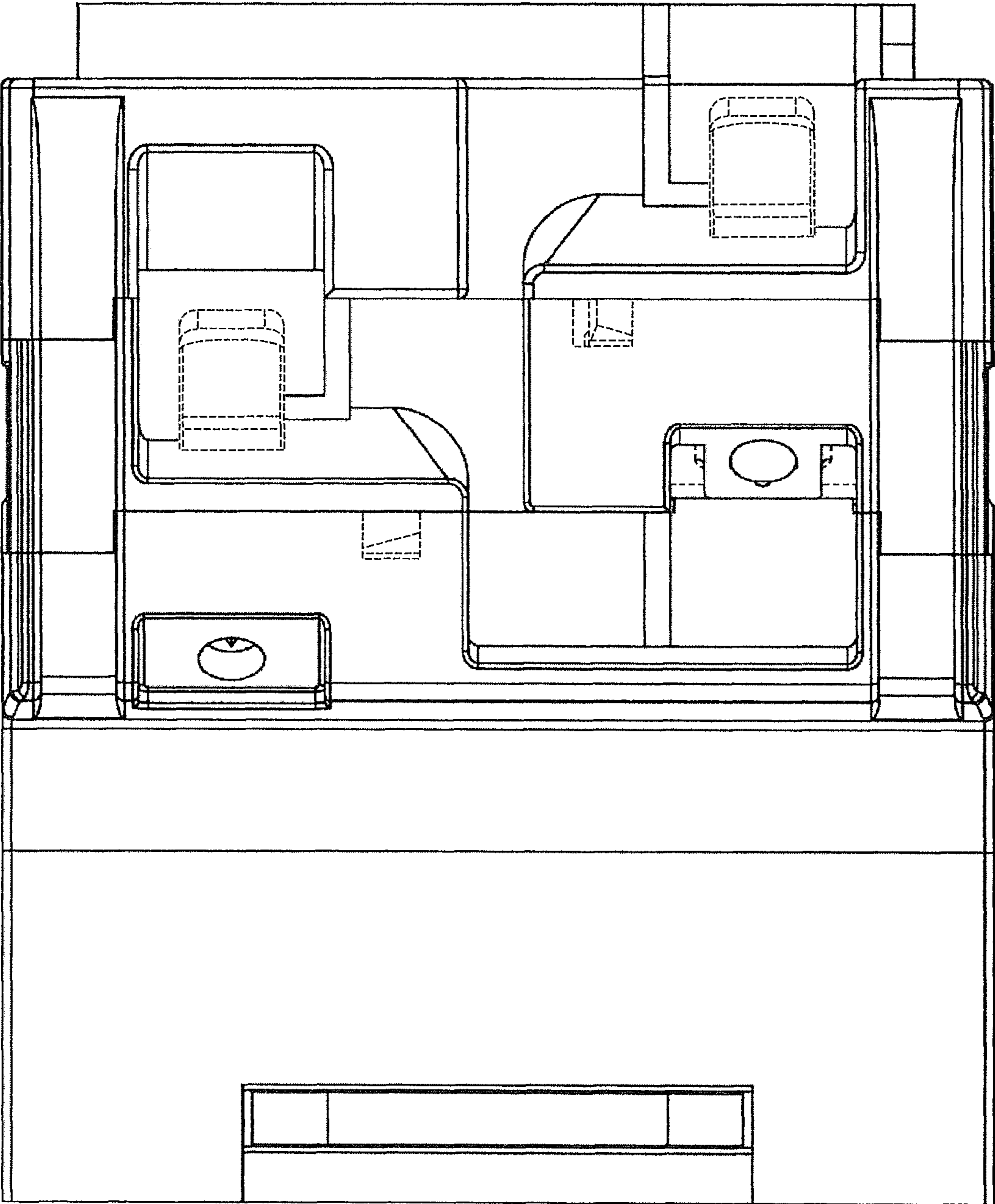

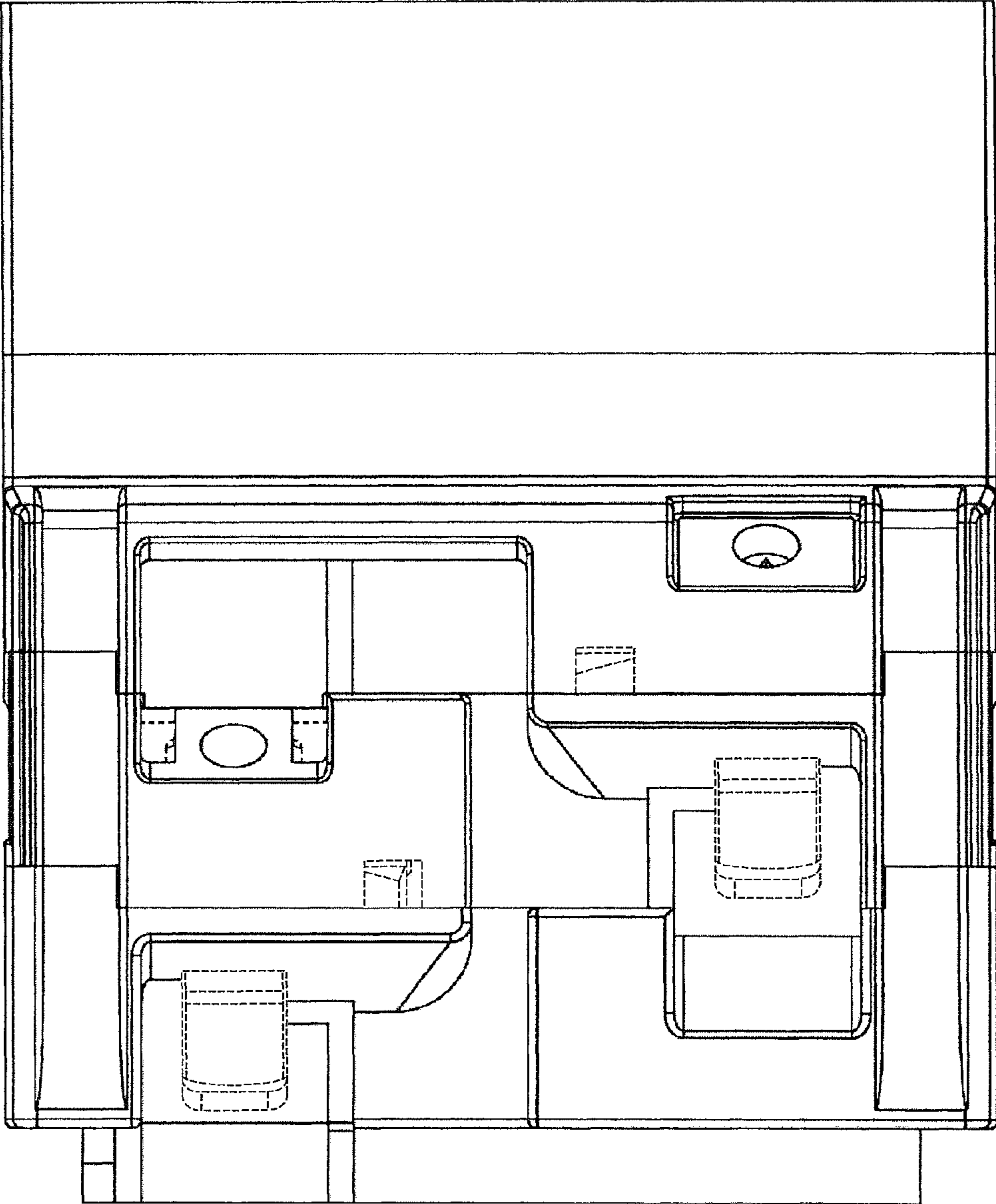

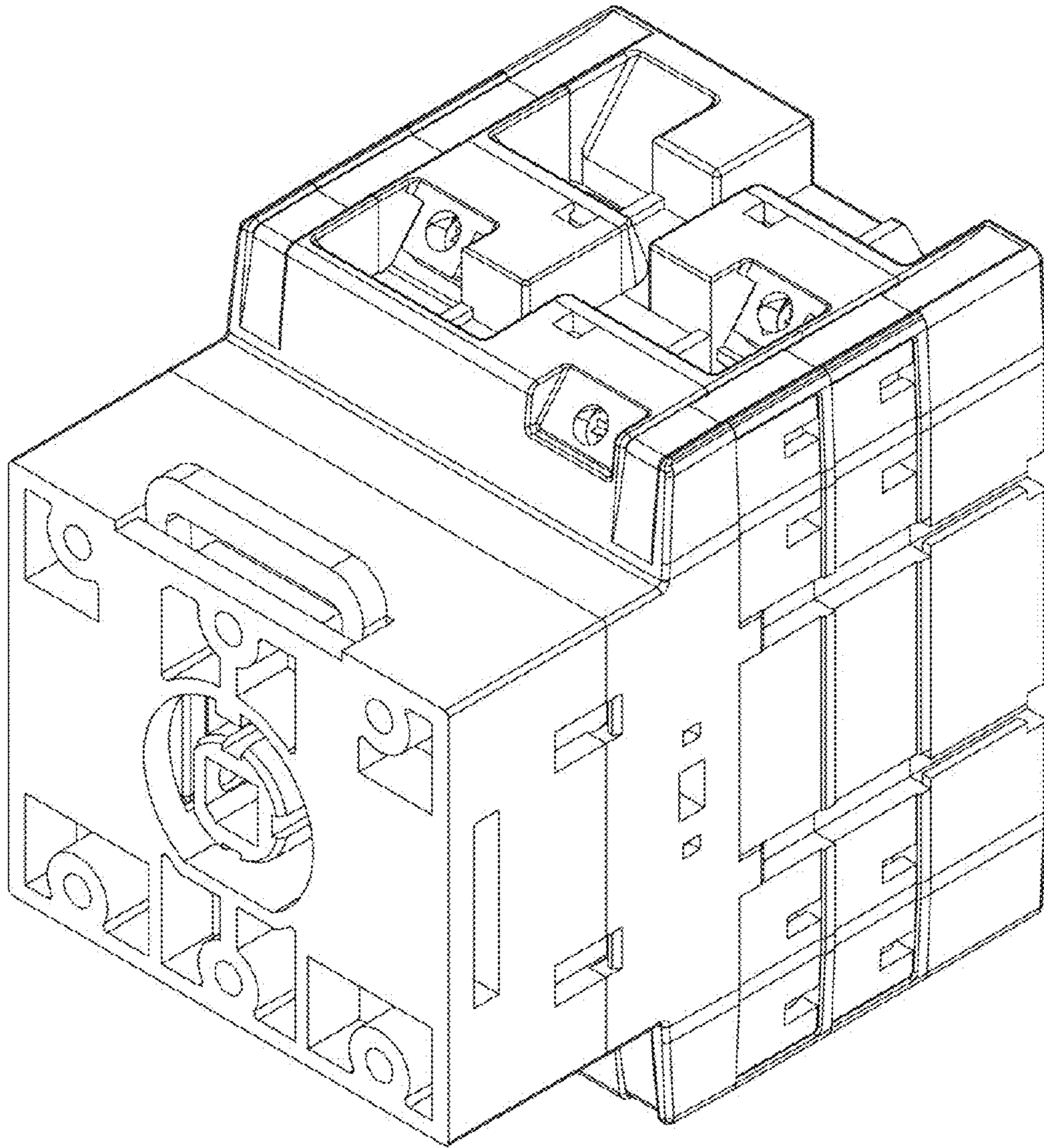

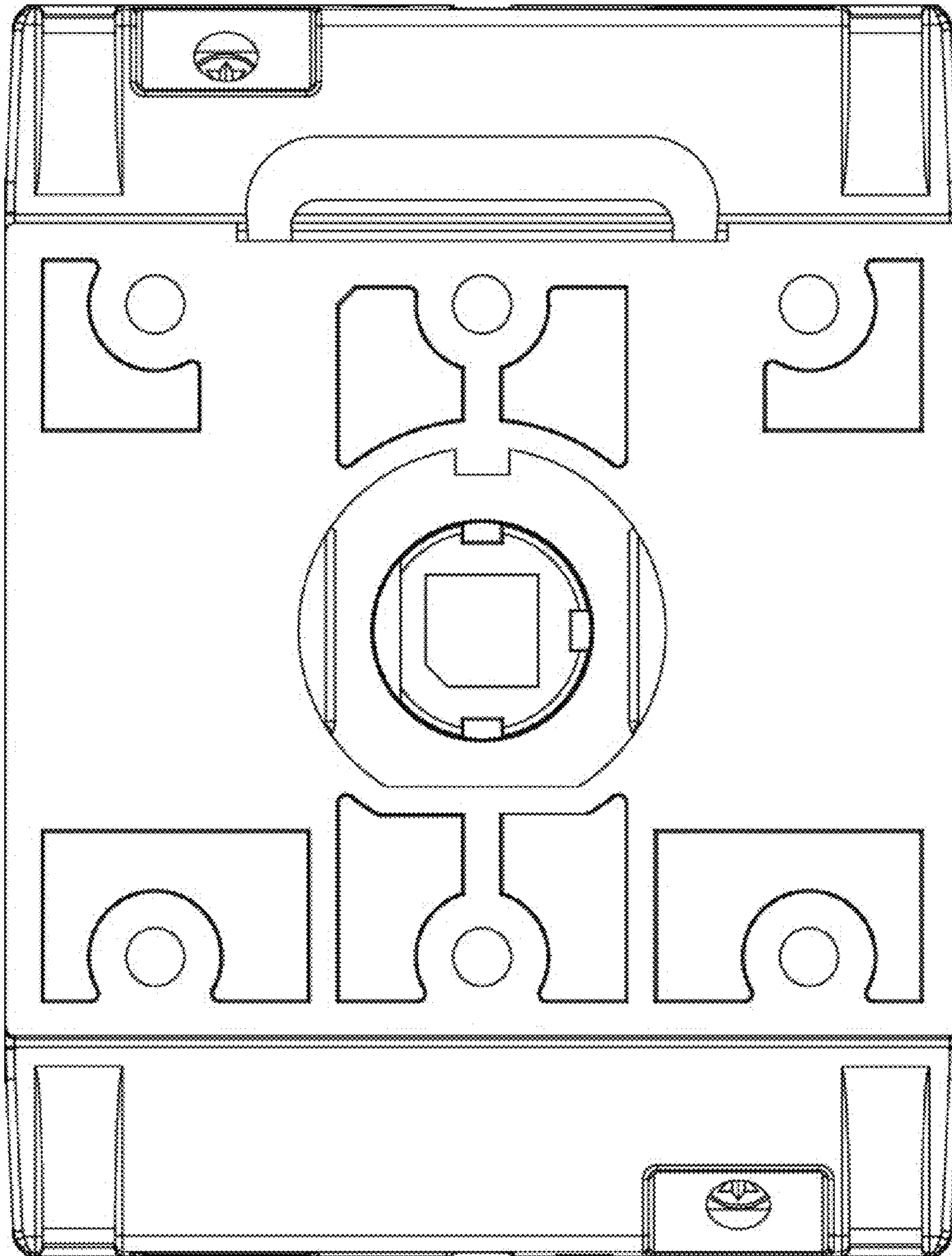

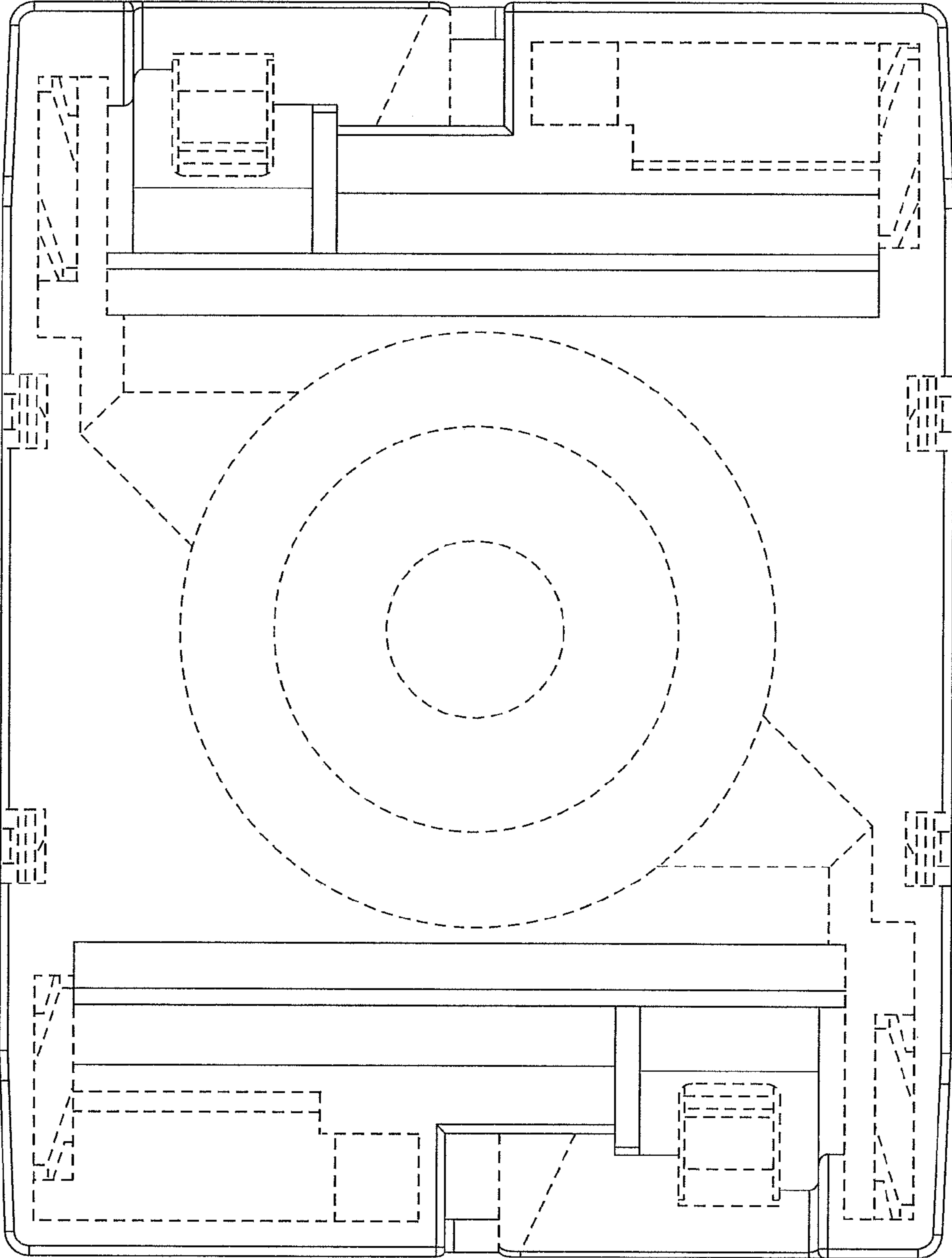

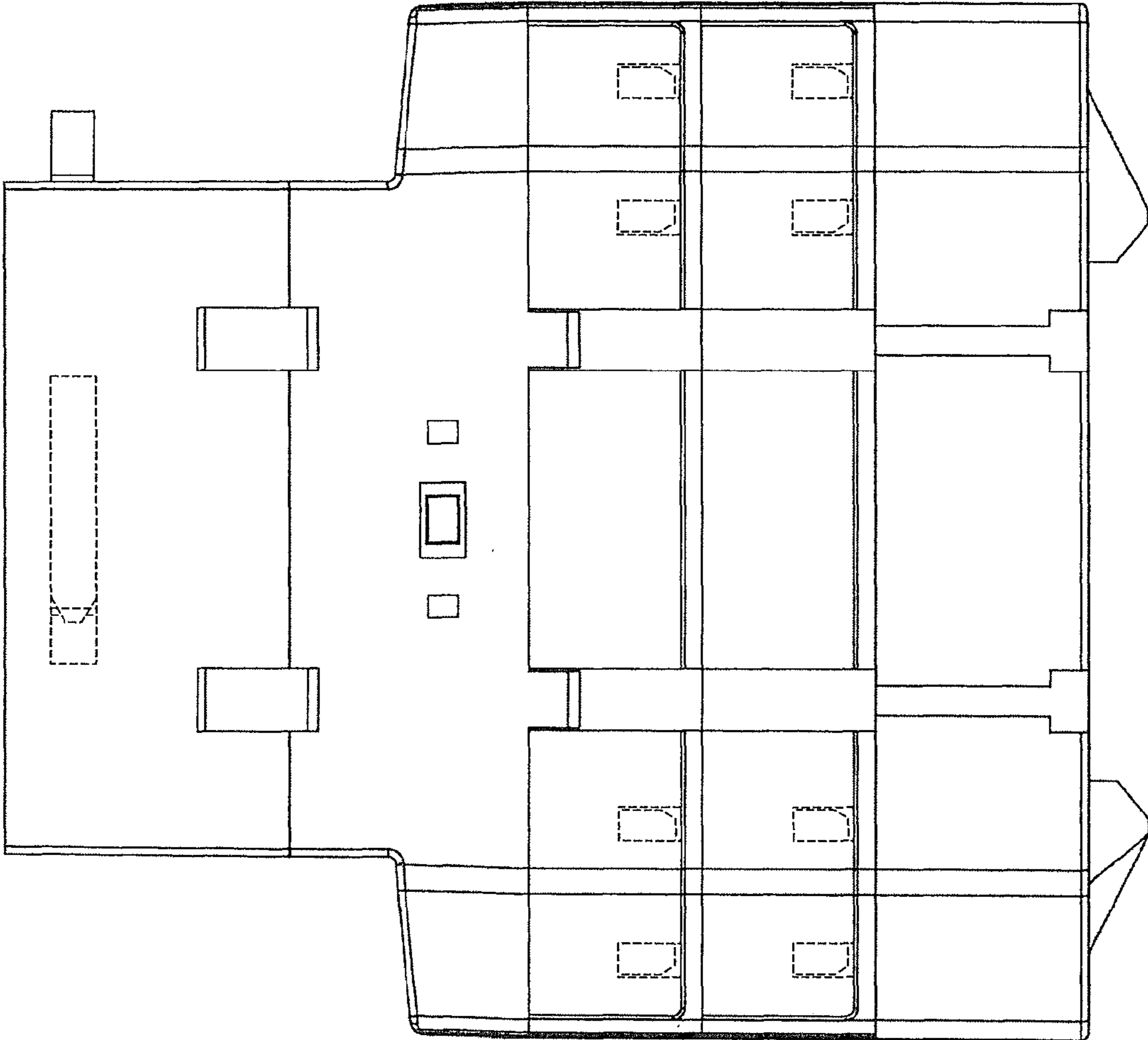

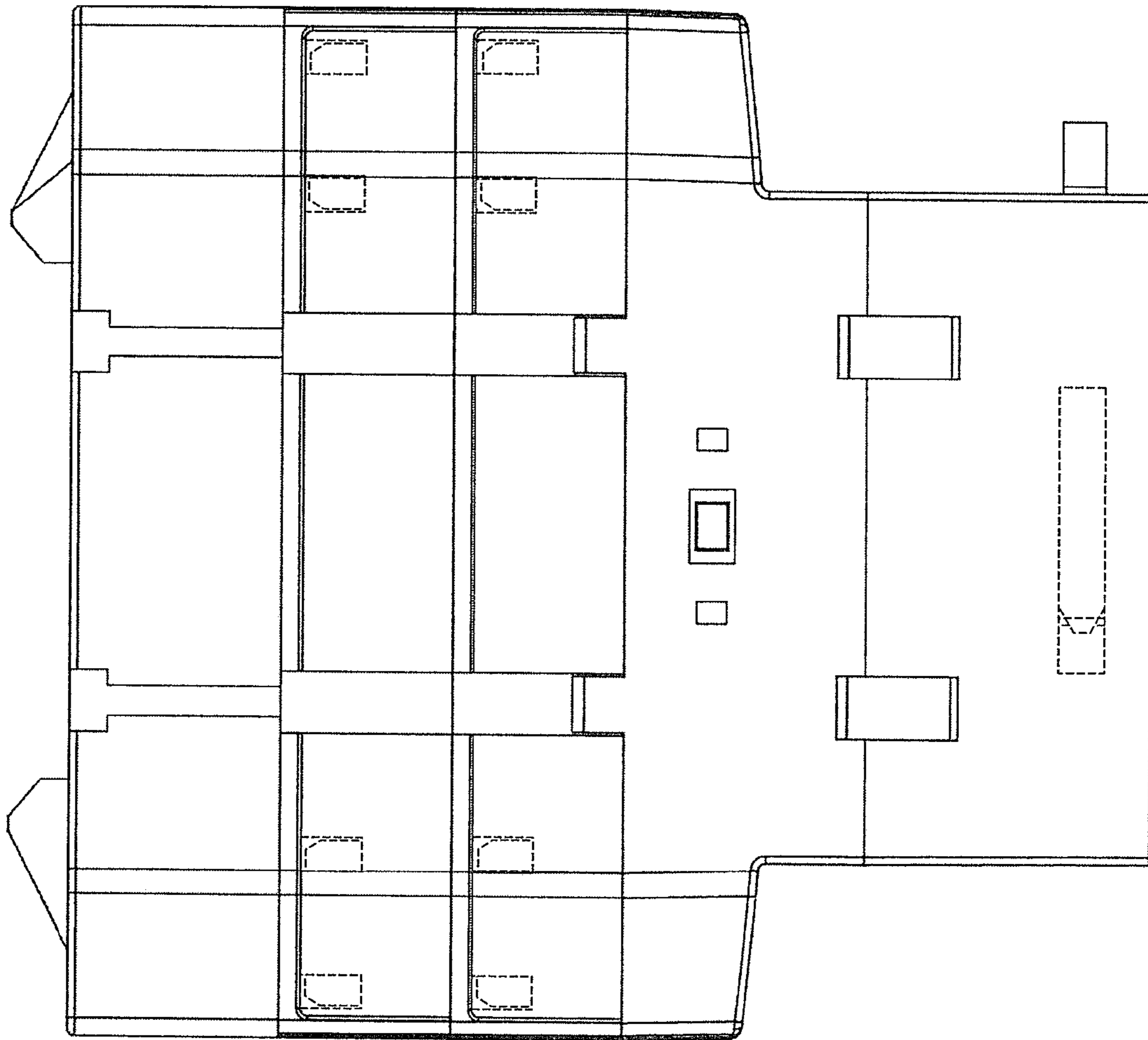

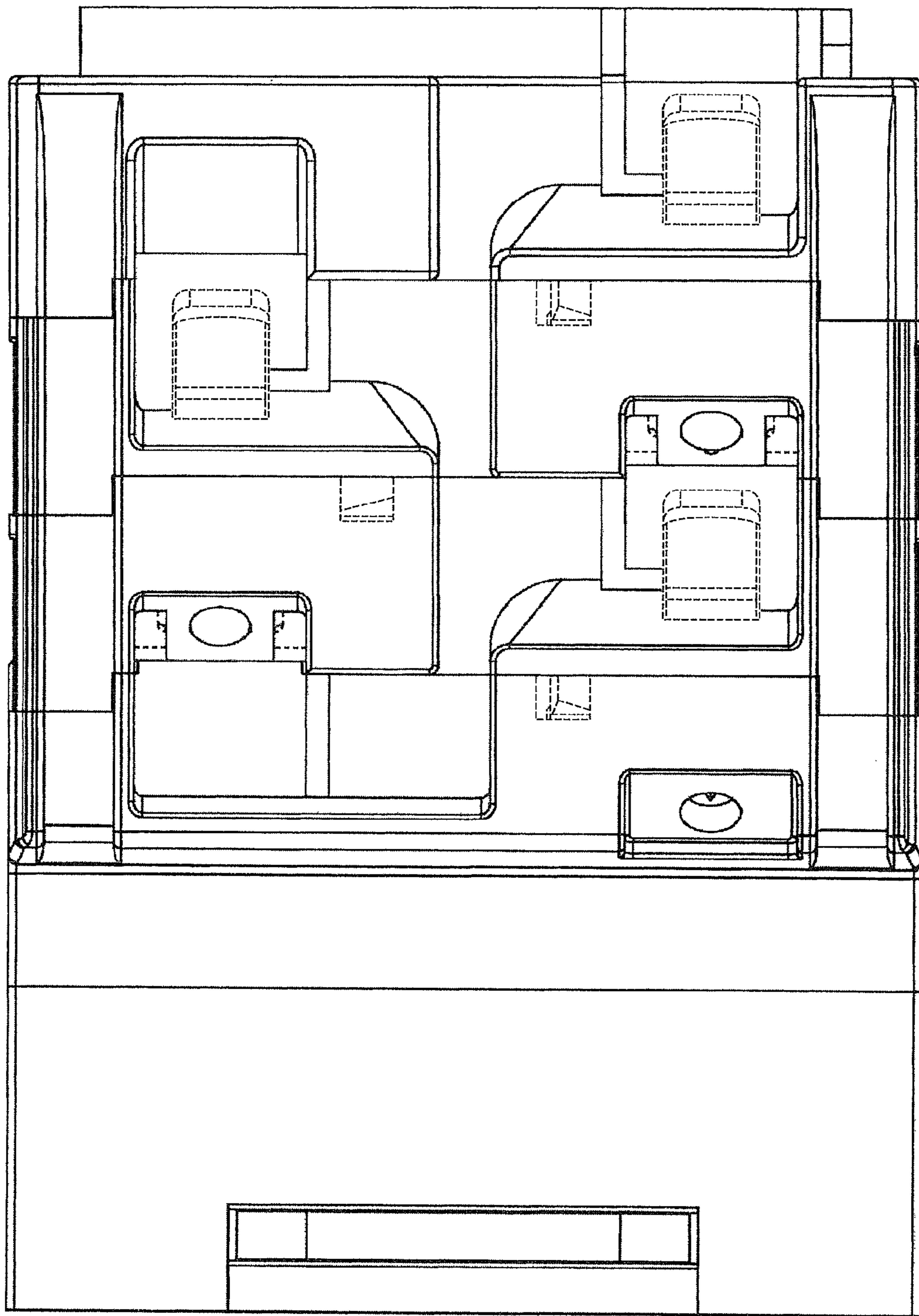

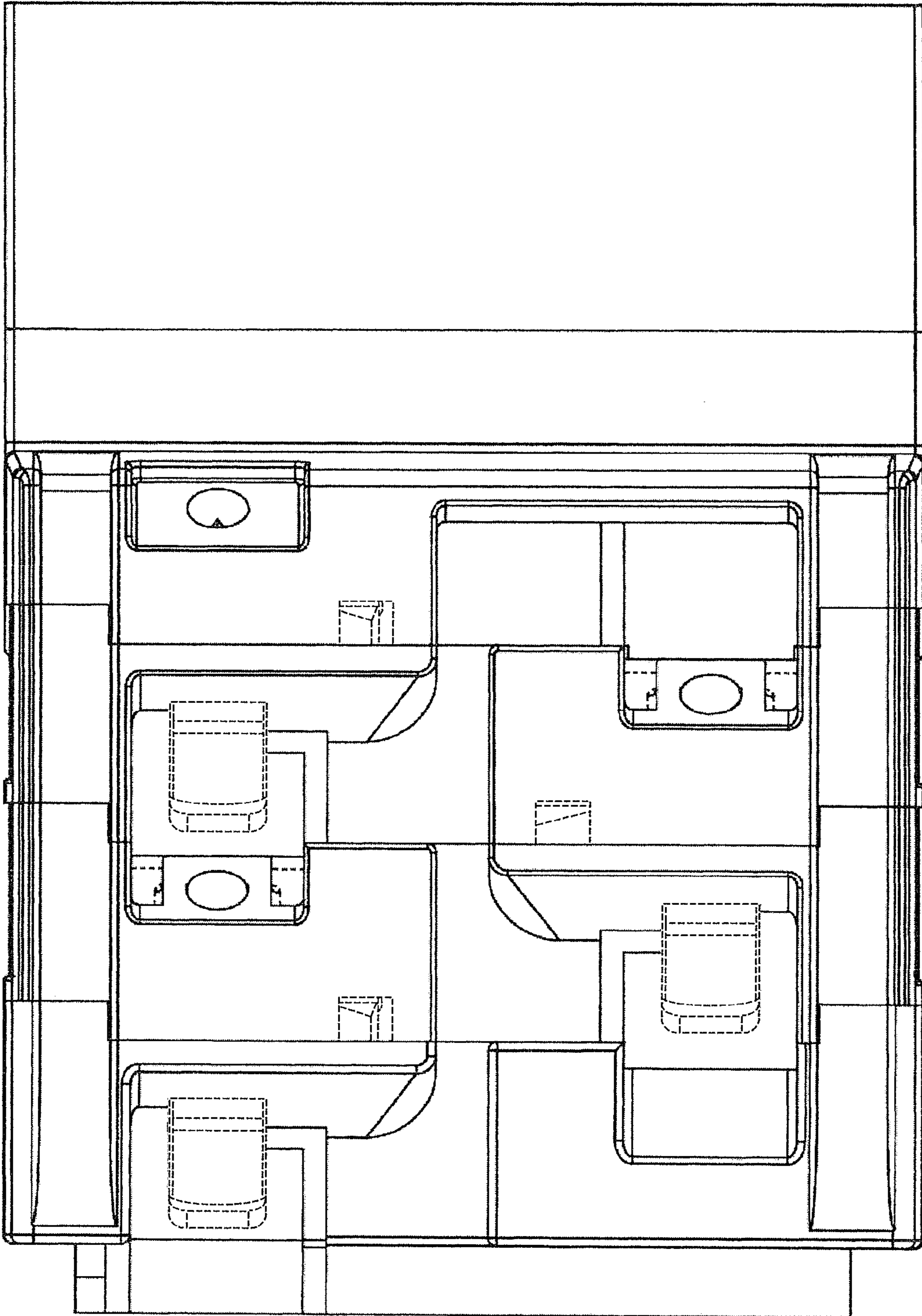

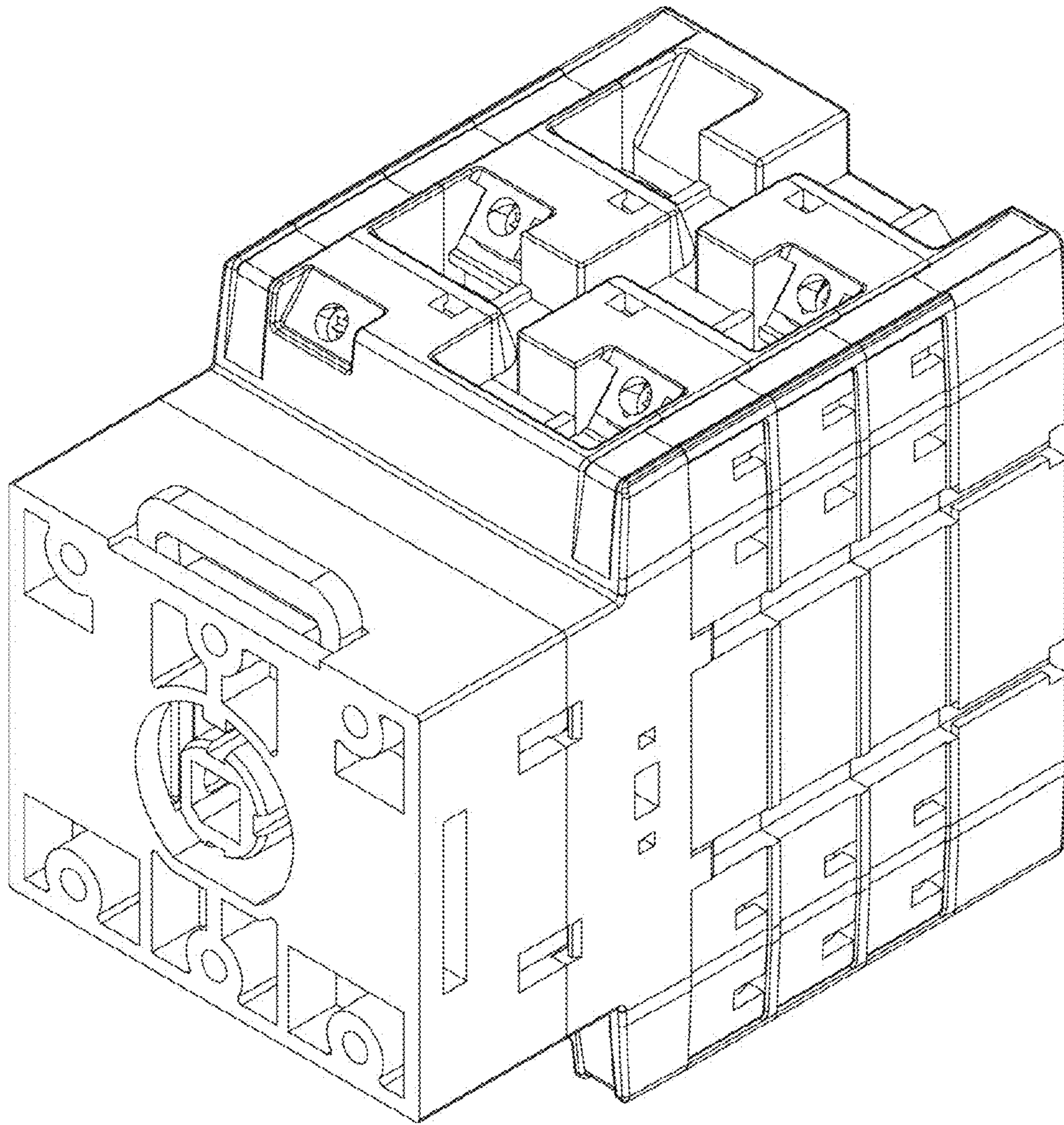

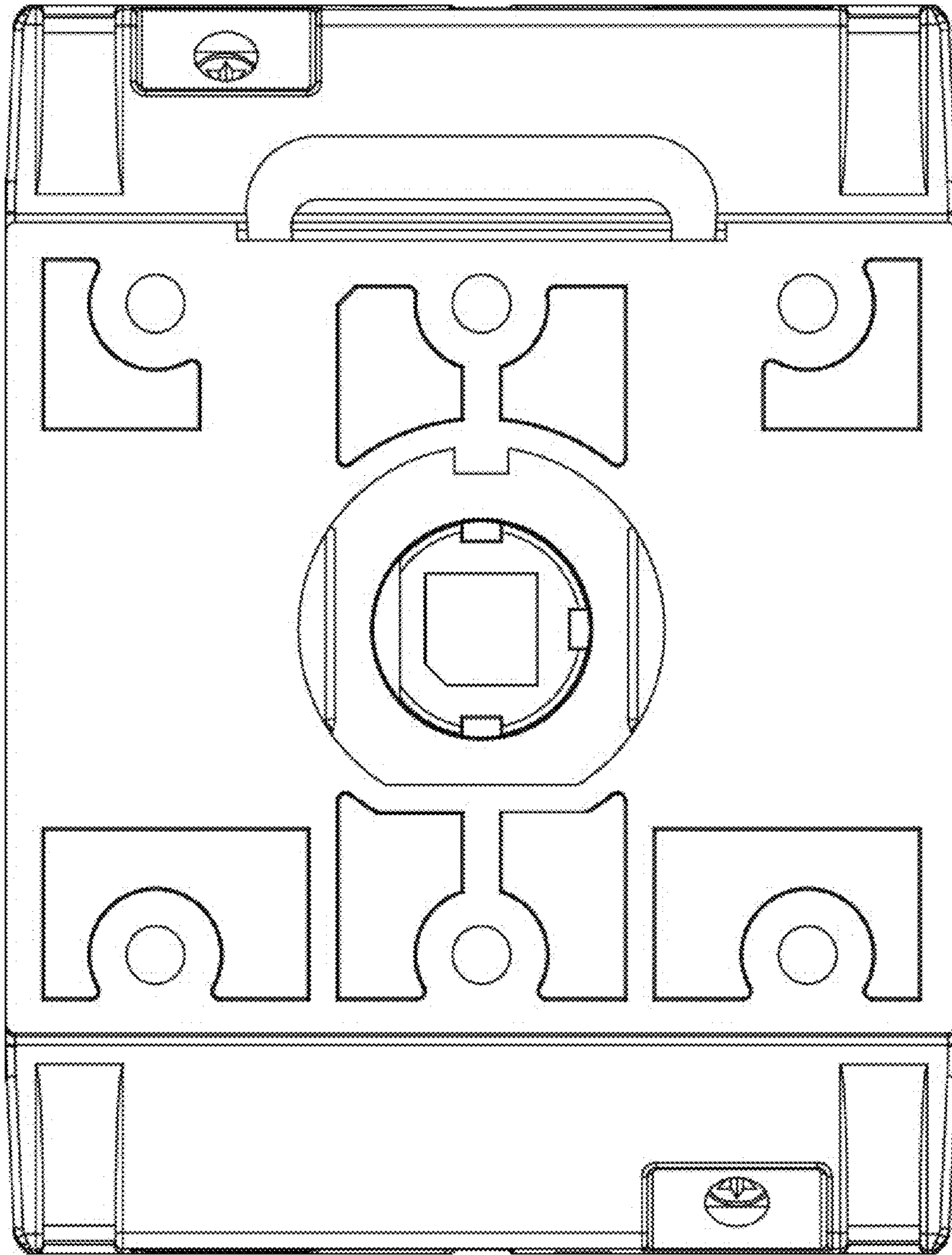

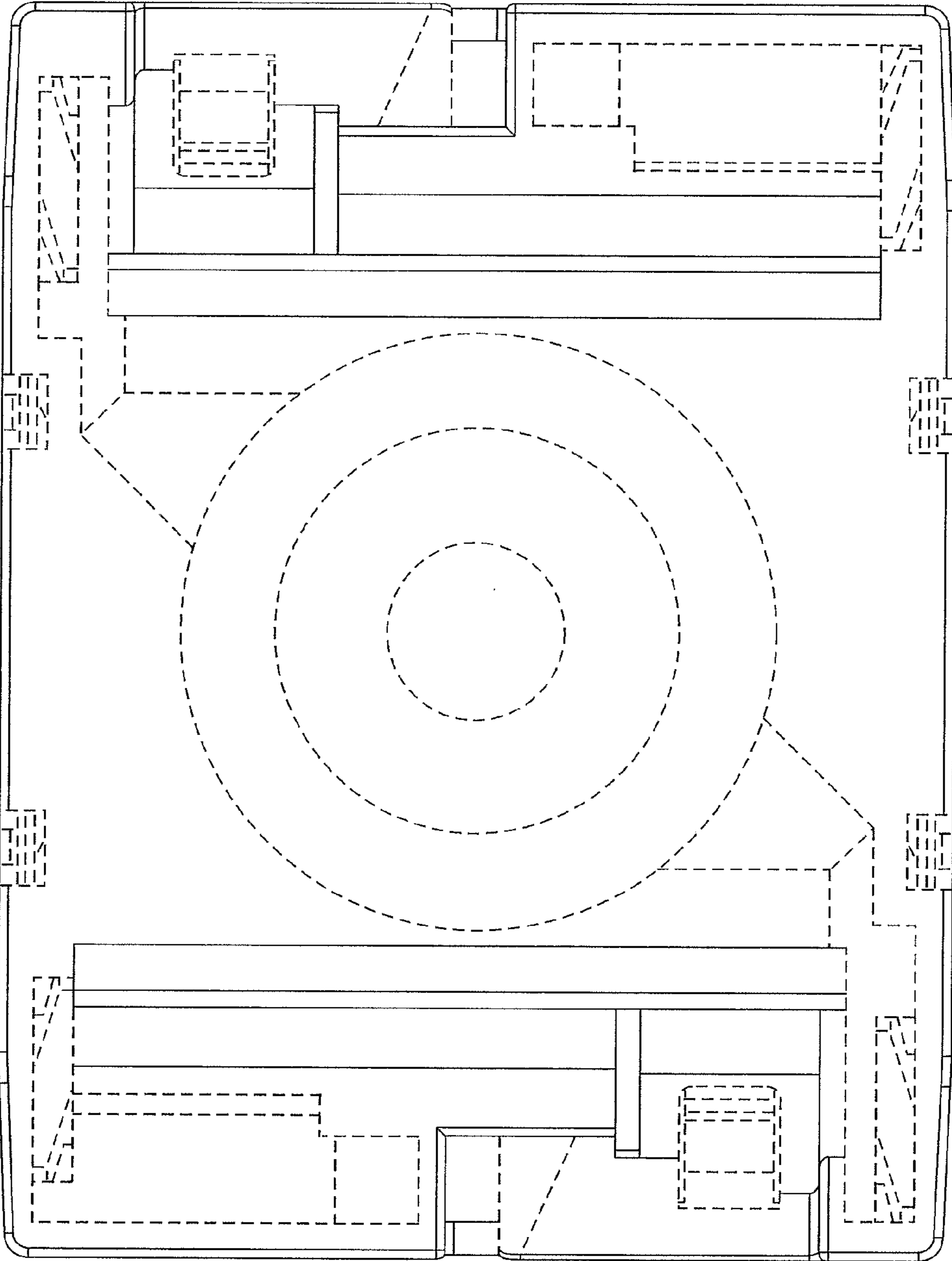

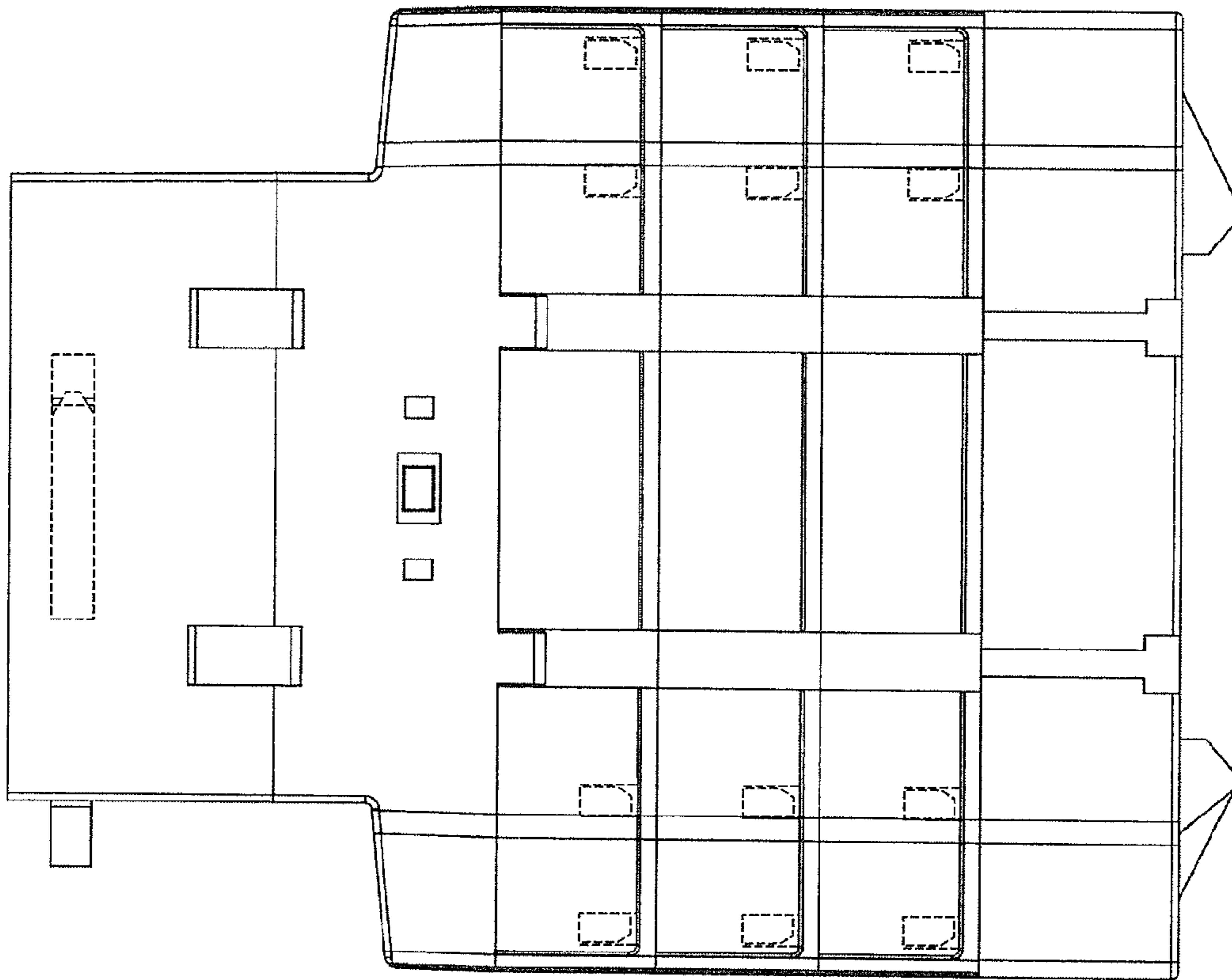

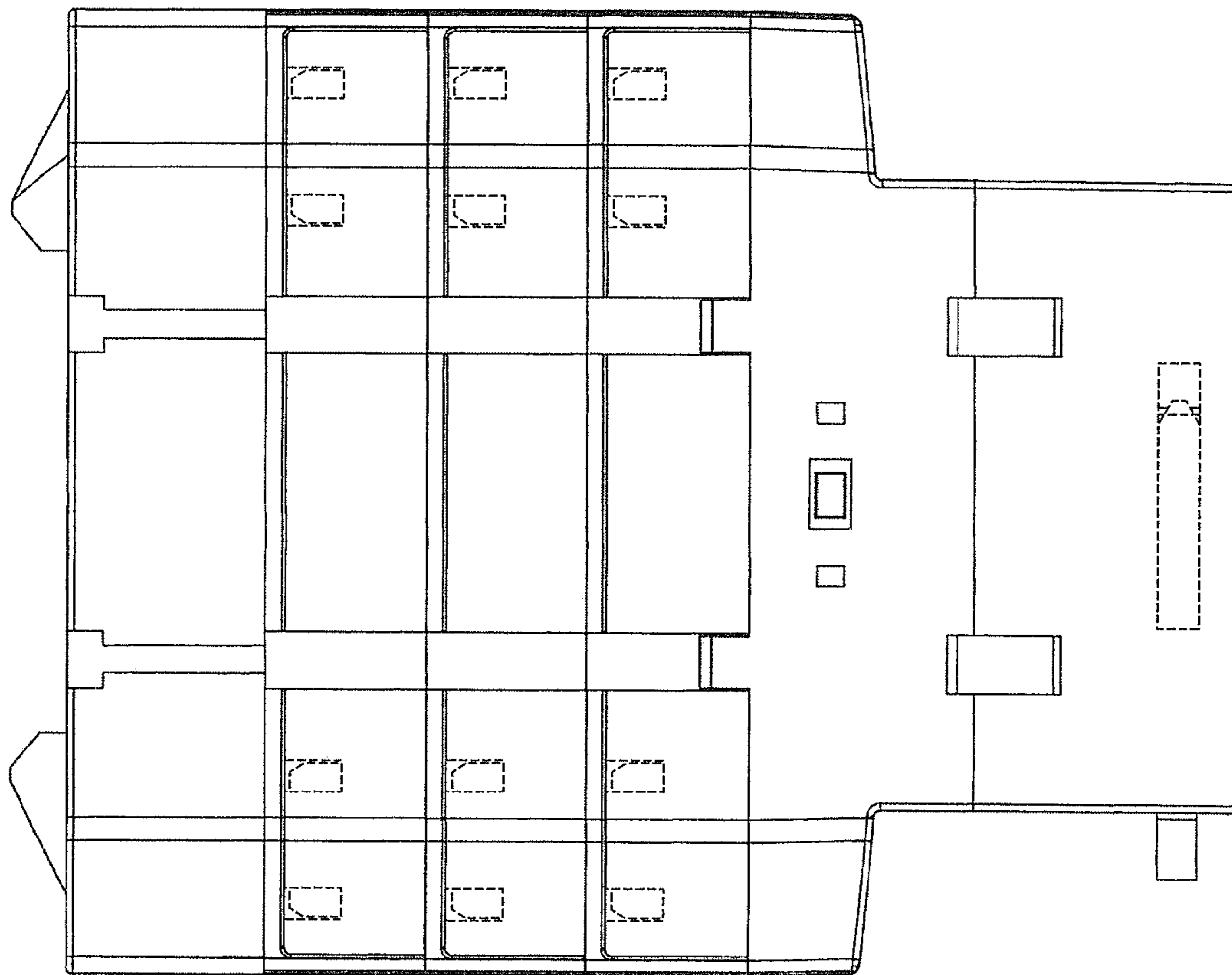

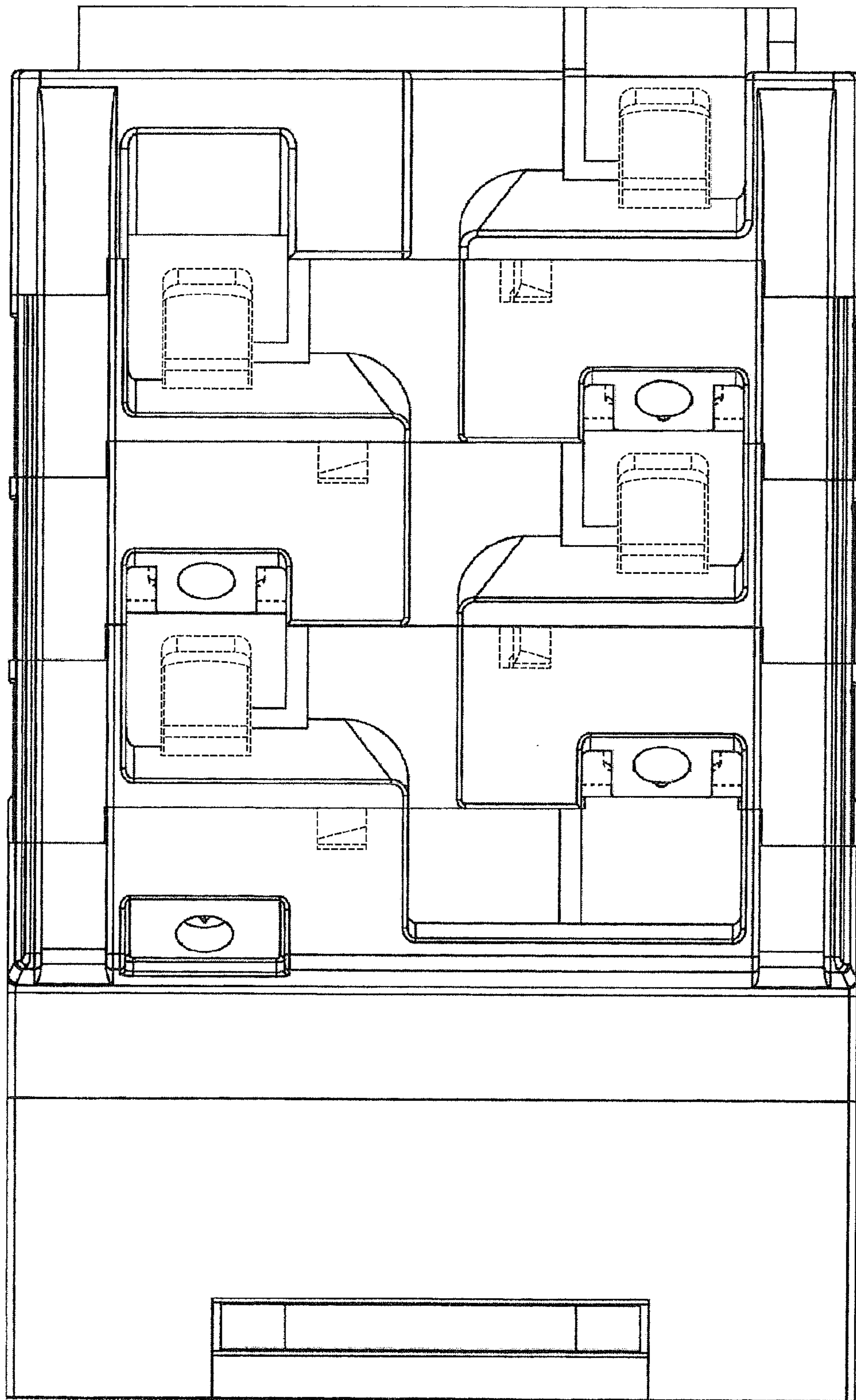

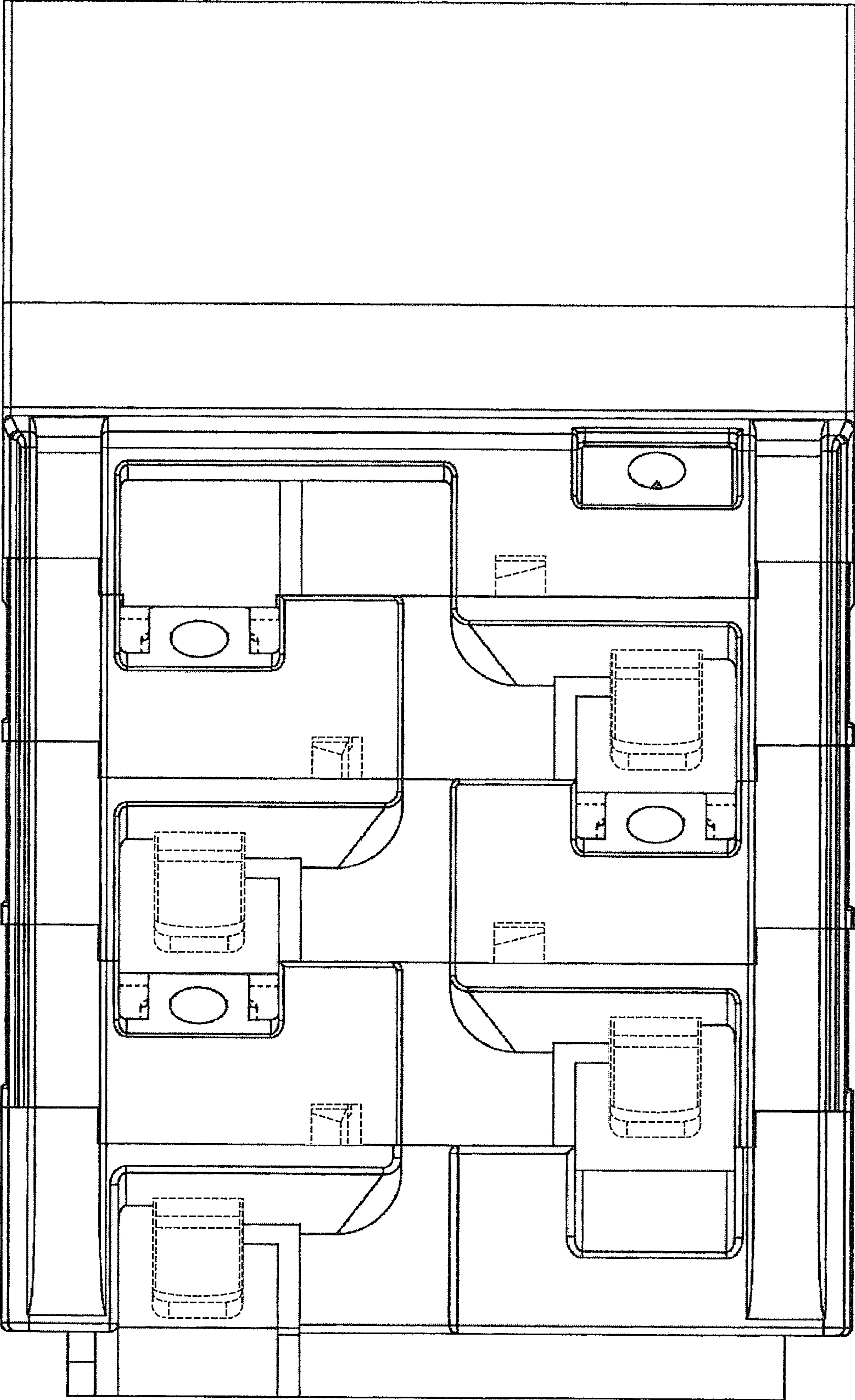

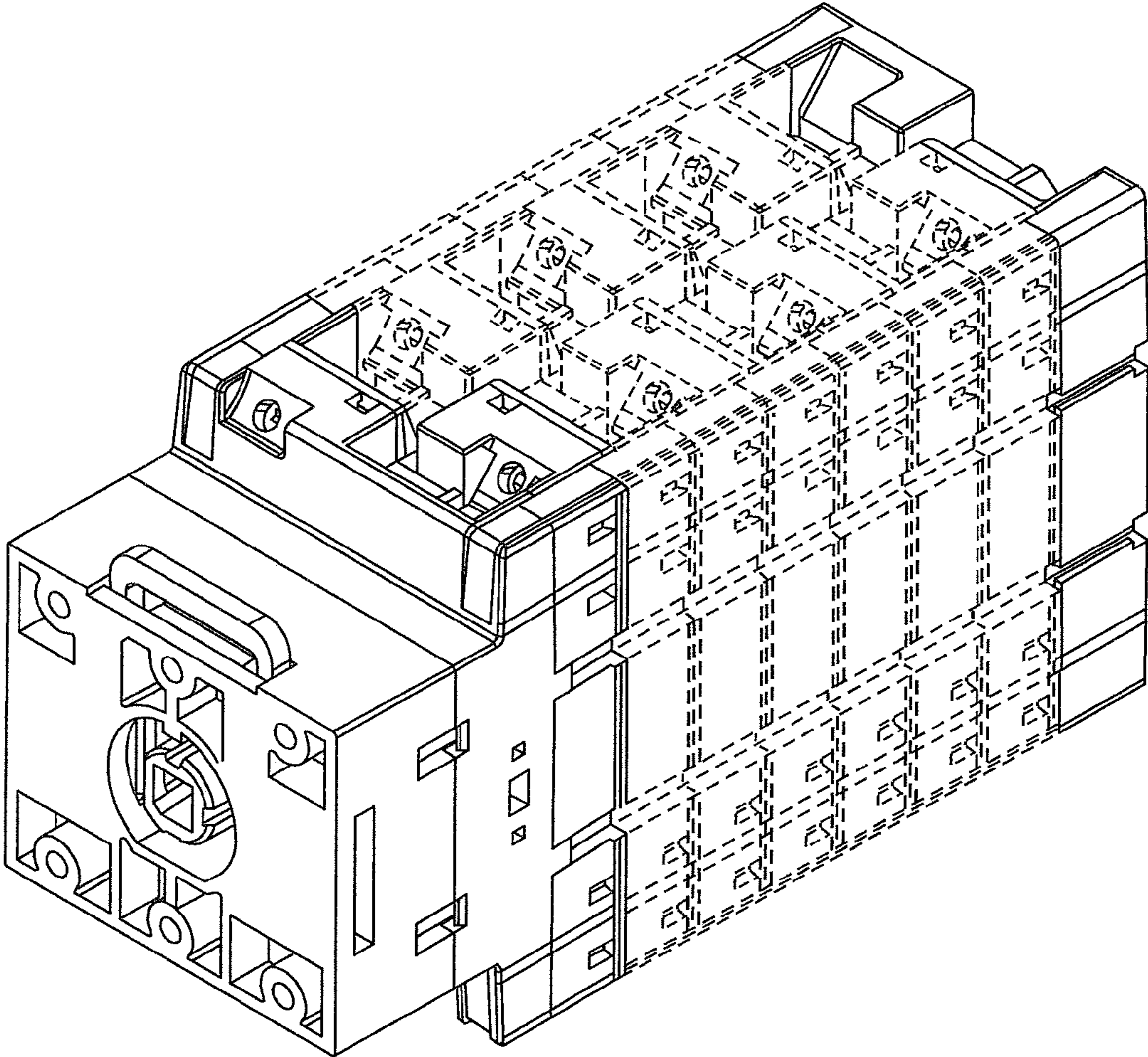

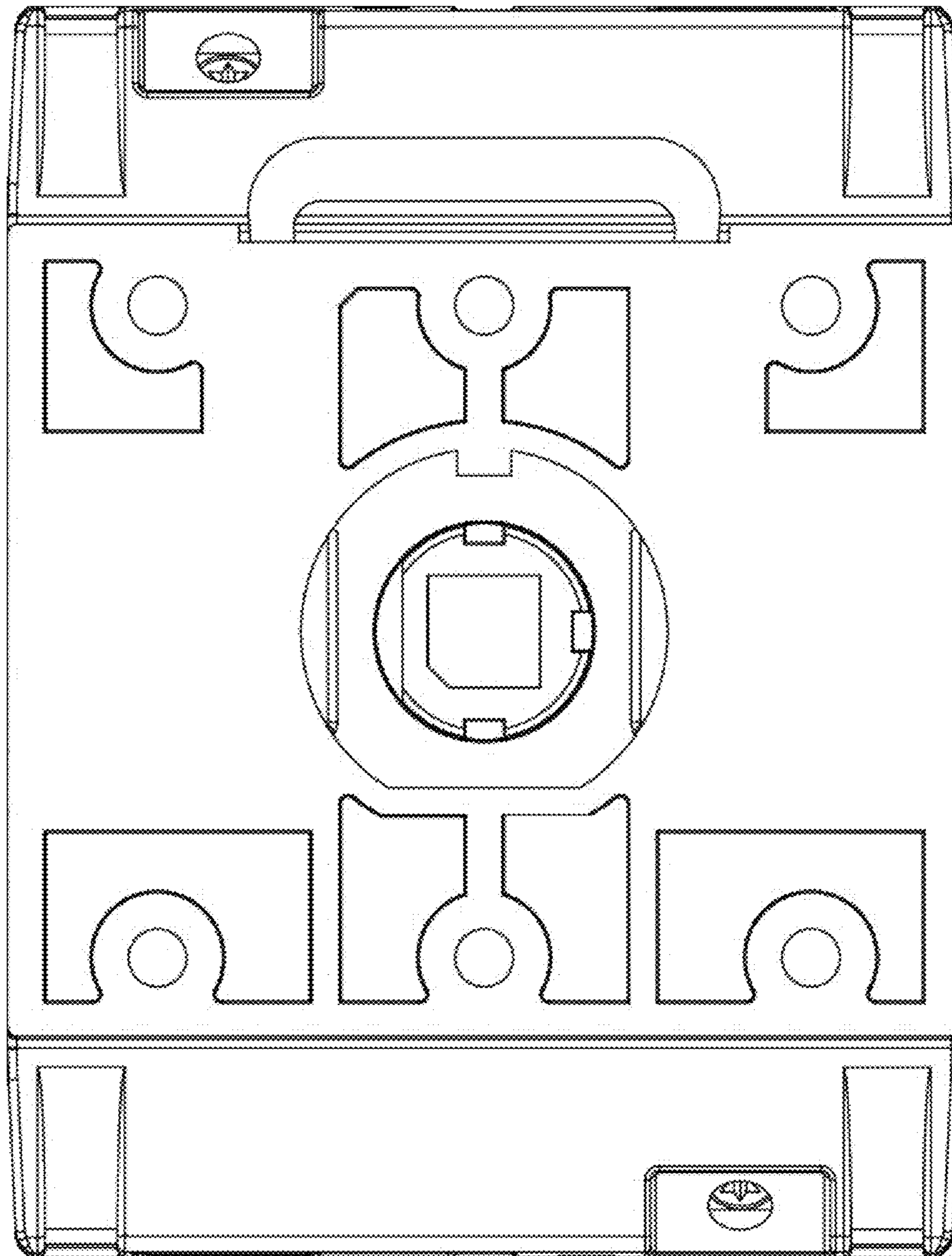

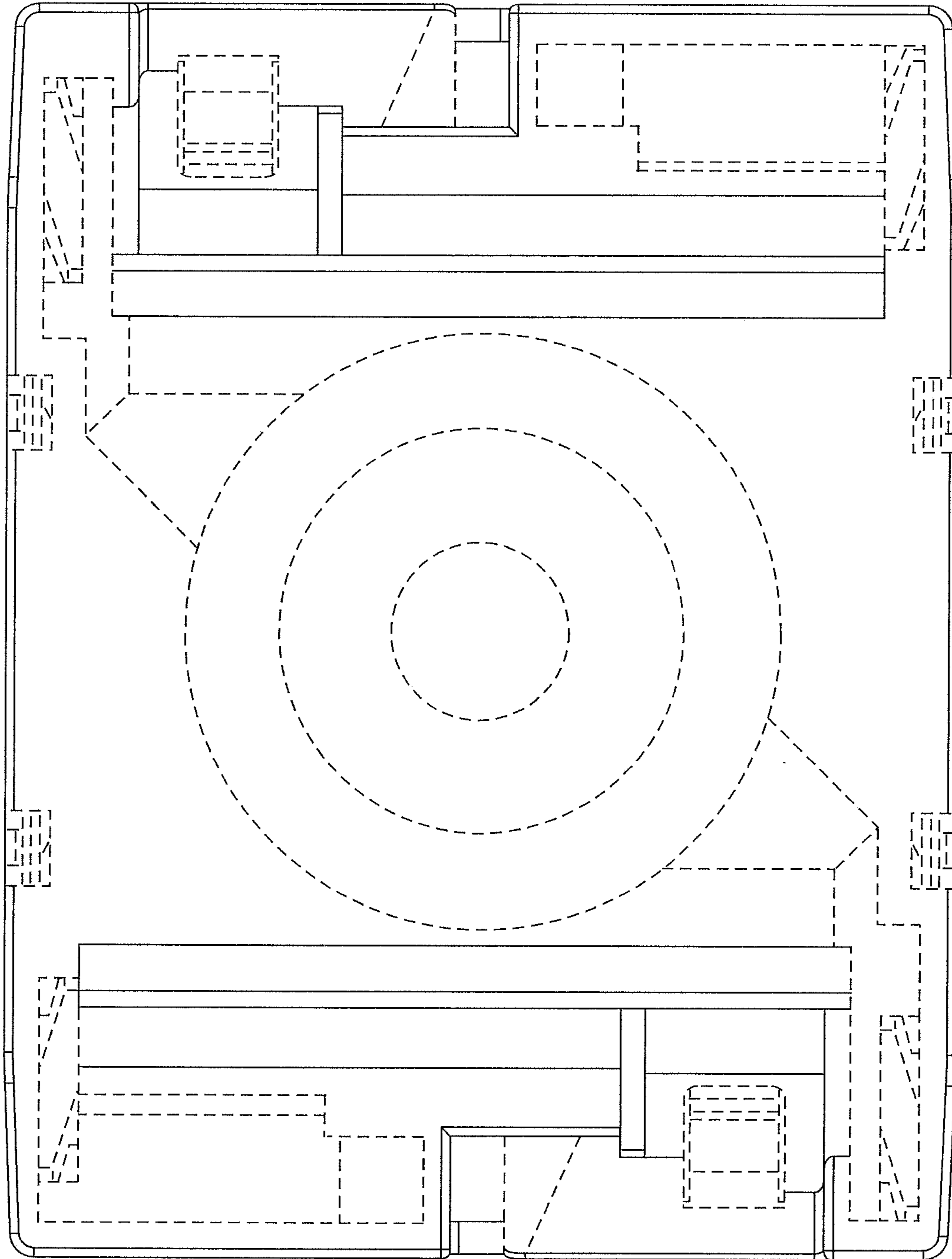

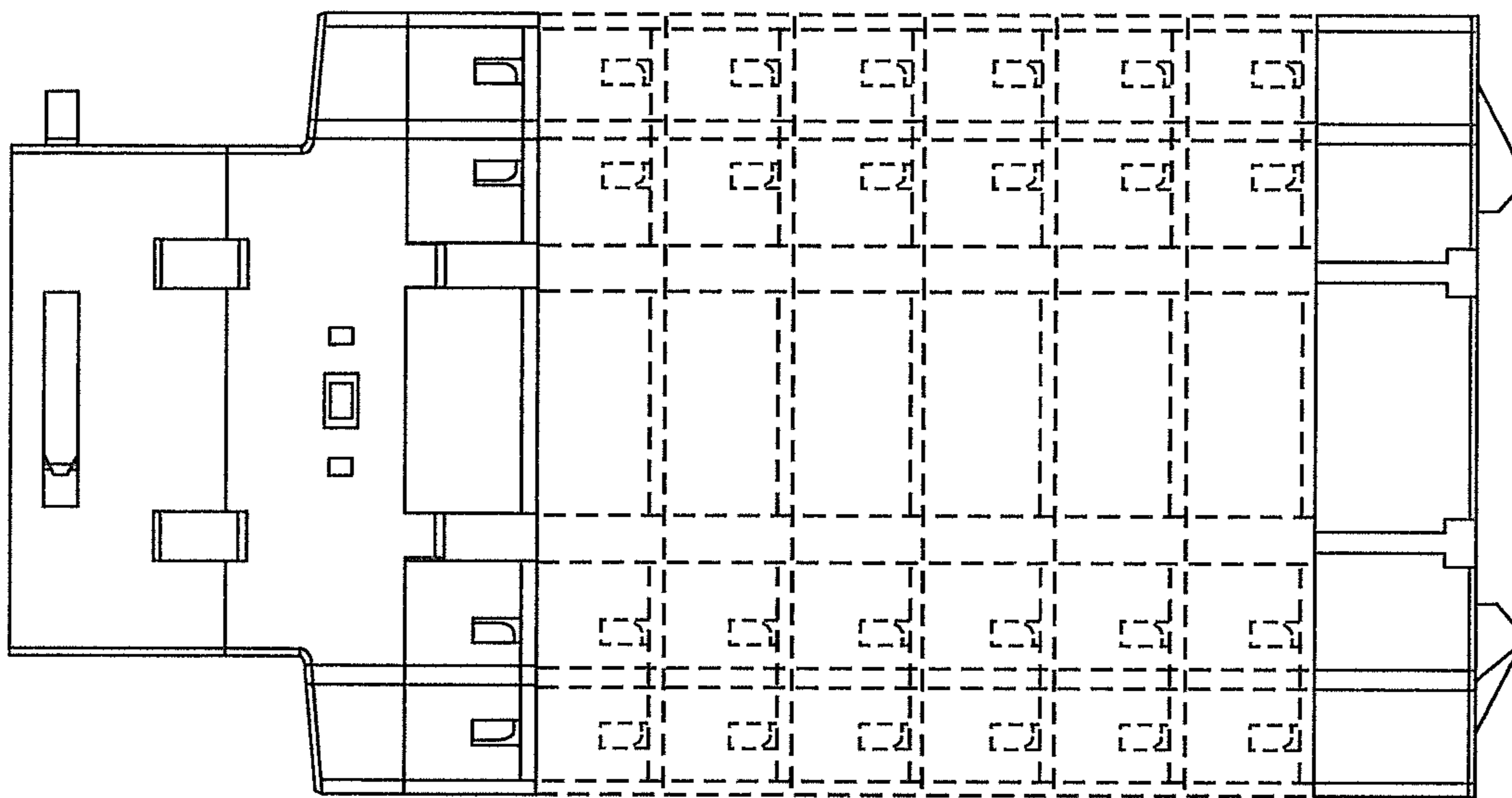
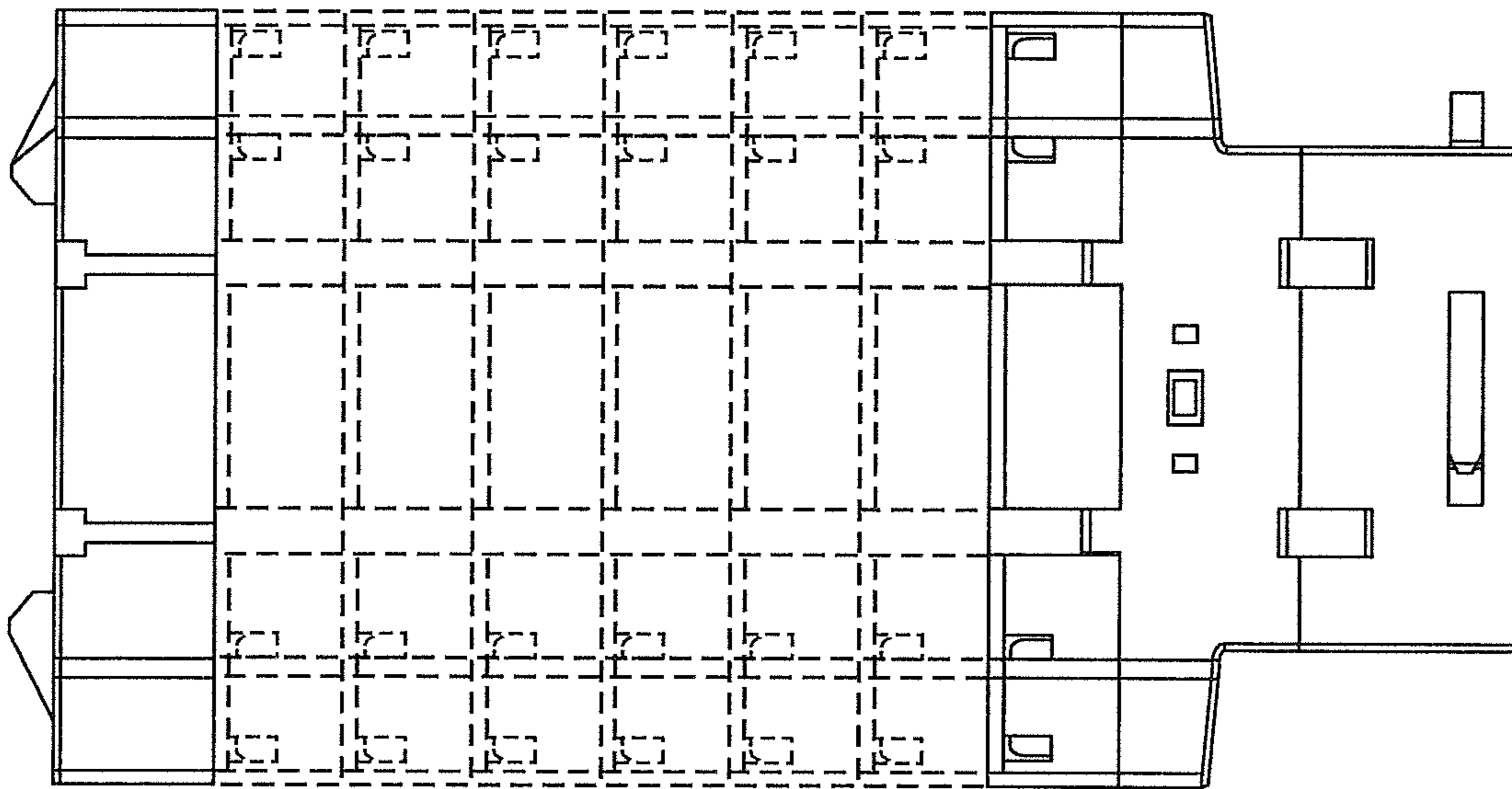

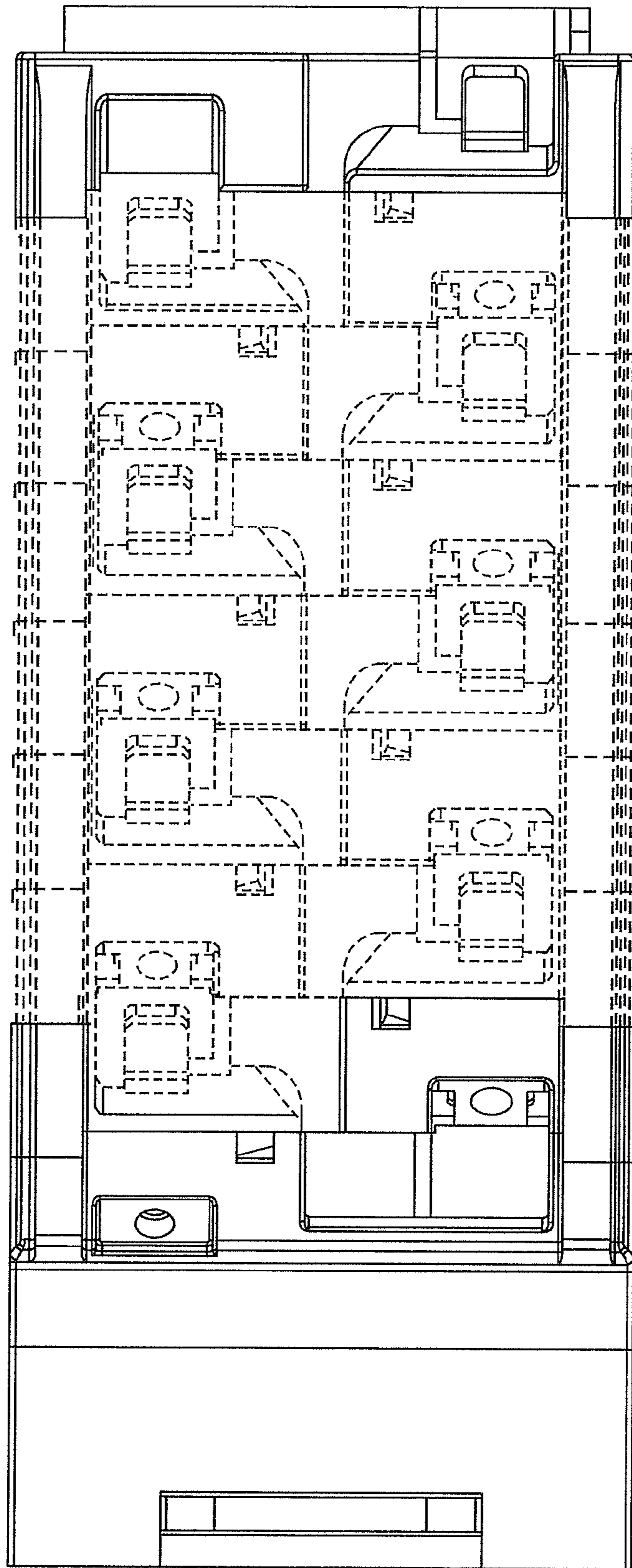

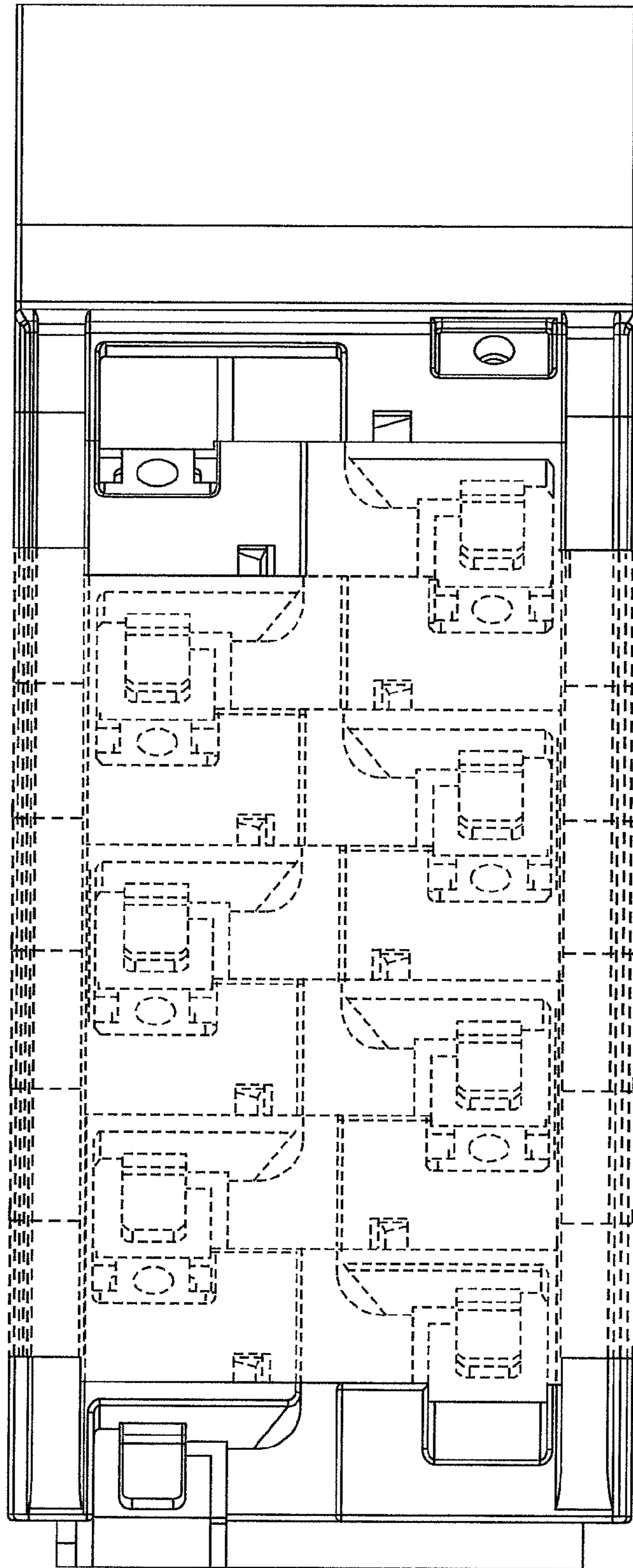
