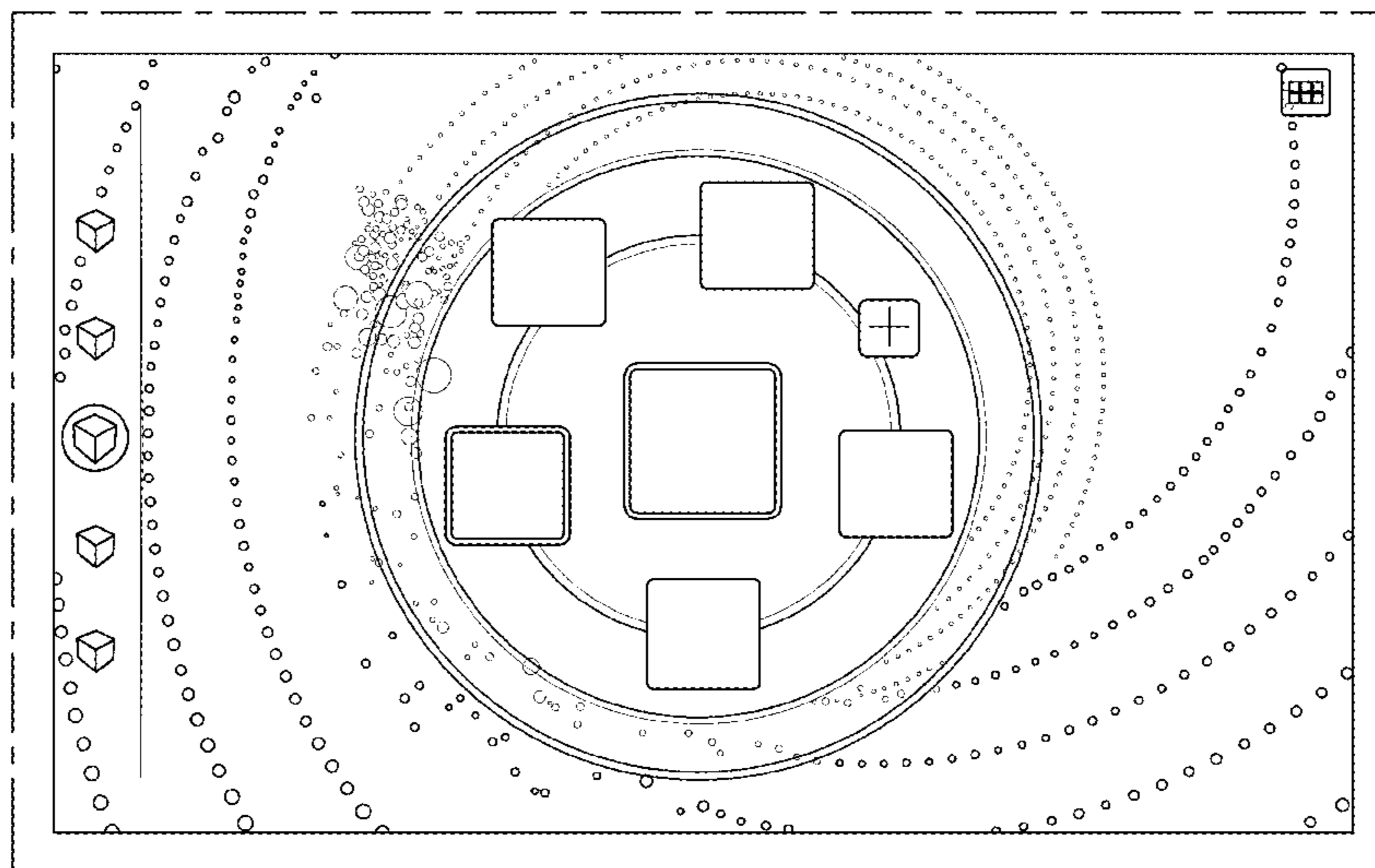
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing my new design; FIG. 2 is a front view thereof, in which a mobile terminal in broken lines is provided to illustrate an example environment; FIG. 3 is a front view of a second embodiment of the invention, in which a mobile terminal in broken lines is provided to illustrate an example environment; and, FIG. 4 is a front view of a third embodiment of the invention, in which a mobile terminal in broken lines is provided to illustrate an example environment. The broken line drawing of the mobile terminal, and the symbol and otherwise images shown in broken lines in the generated image of FIGS. 1, 2, 3, and 4 are for illustrative purposes only and form no part of the claimed design.

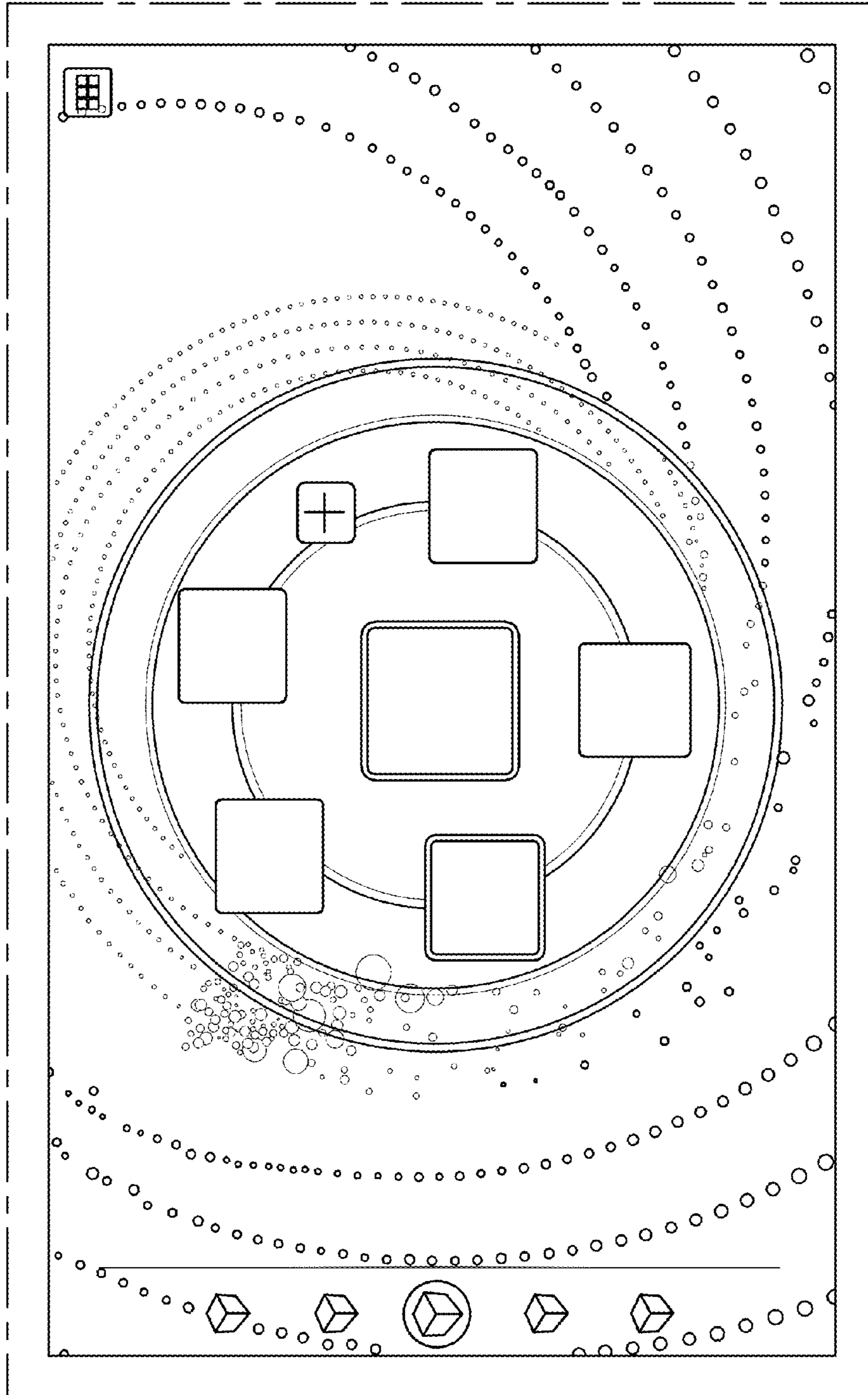

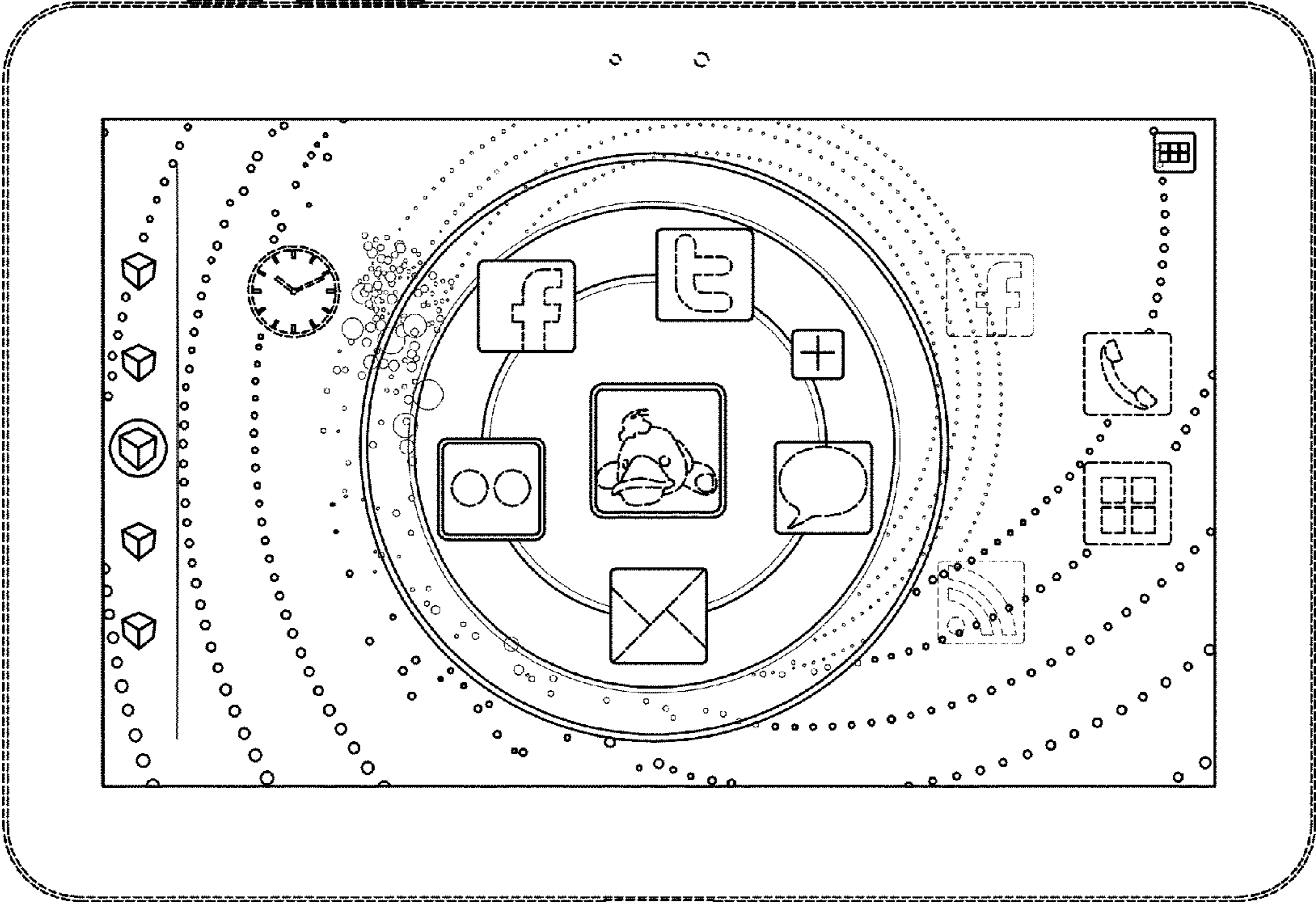

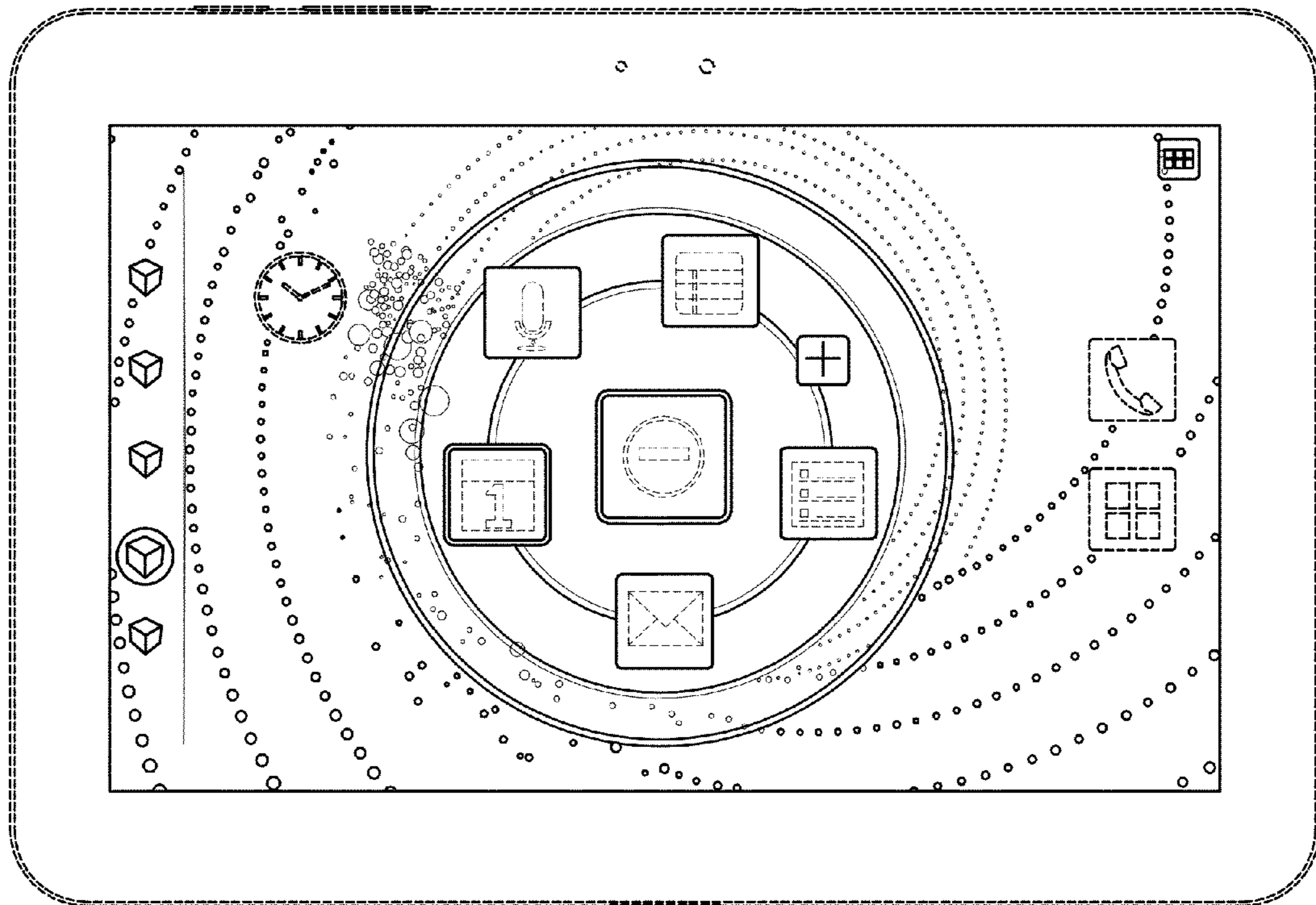
