The ornamental design for a massage tool applicator holder, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of a massage tool applicator holder showing my new design.
FIG. 2 is a top plan view thereof.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a left side elevation view thereof.

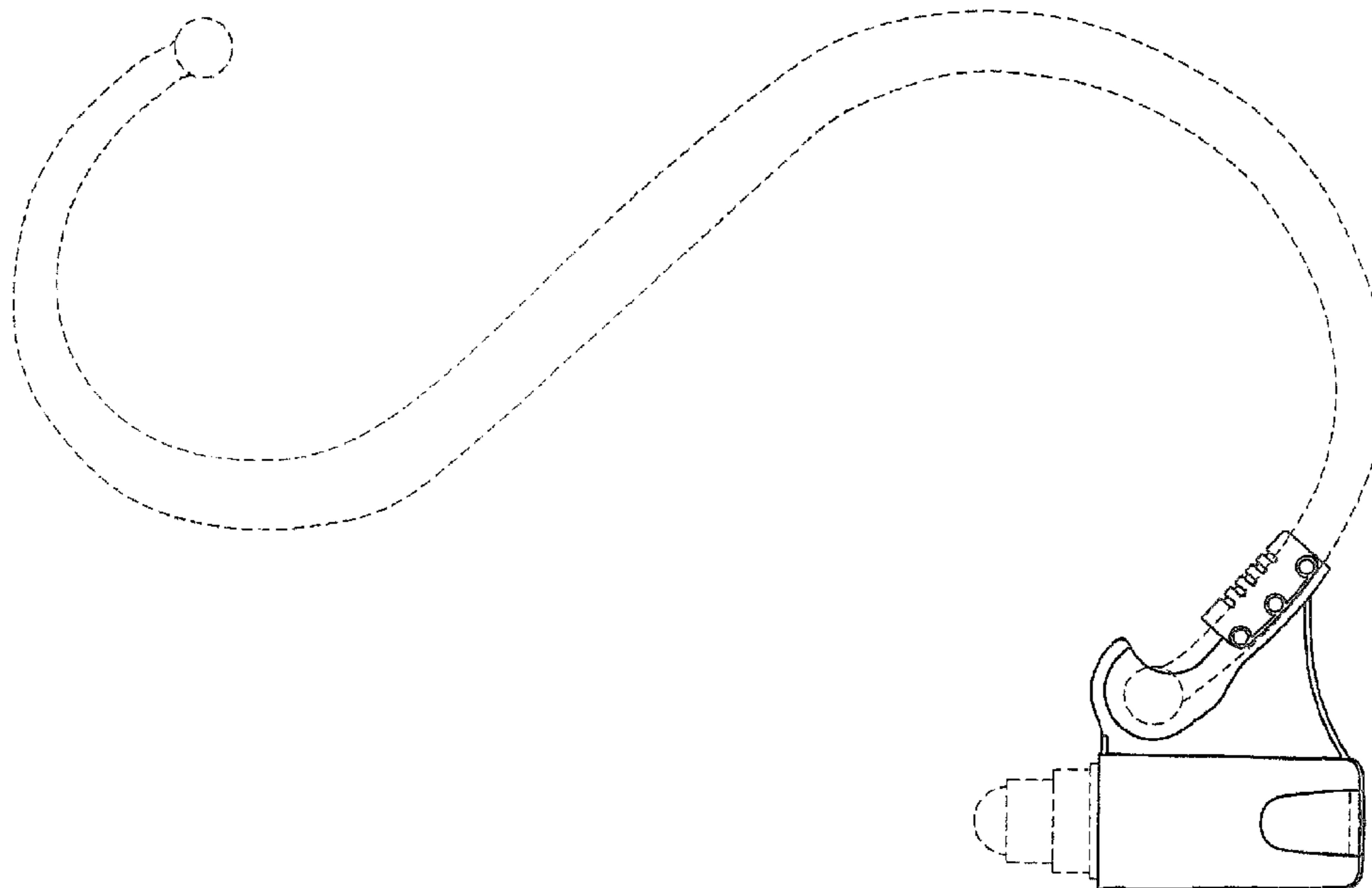

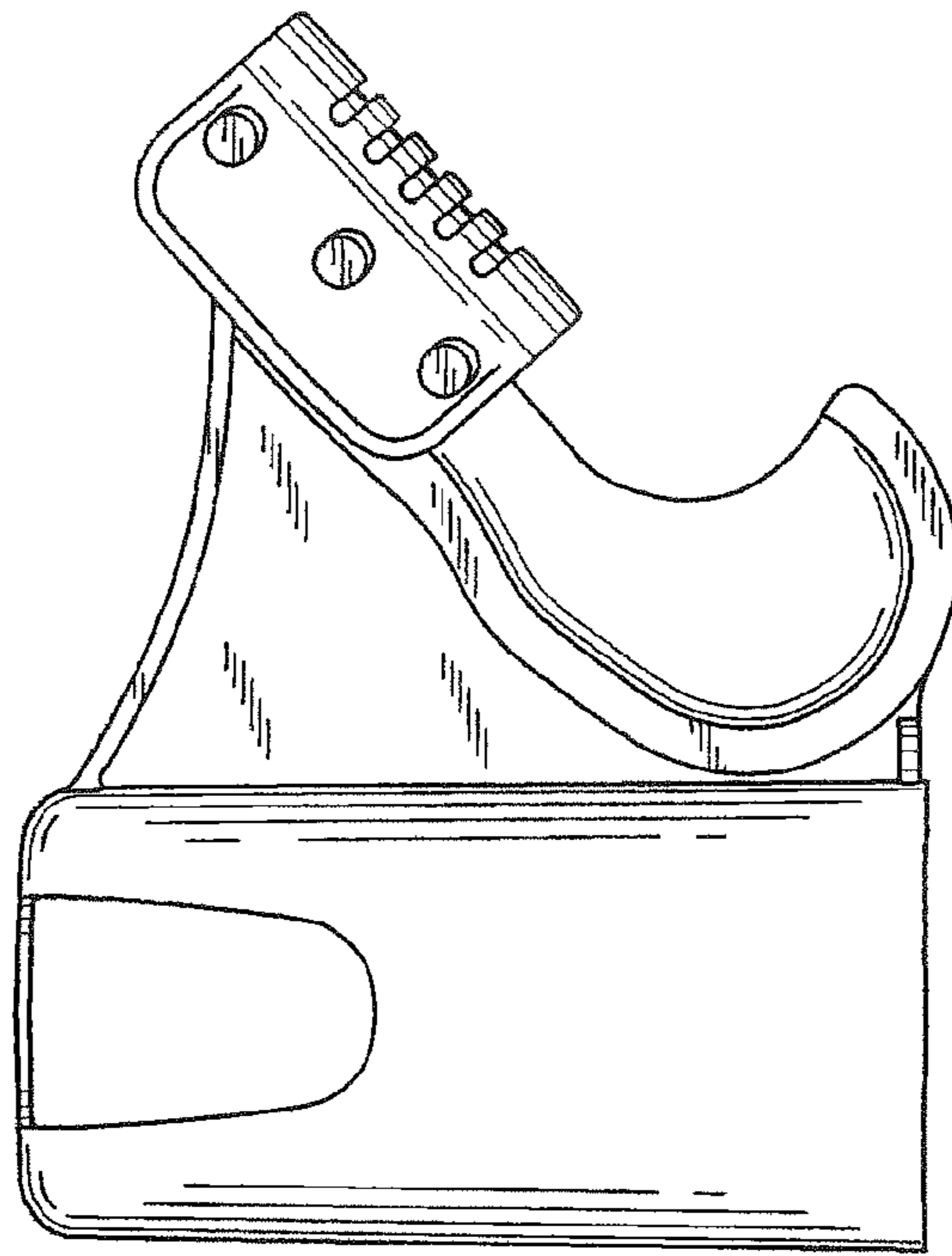

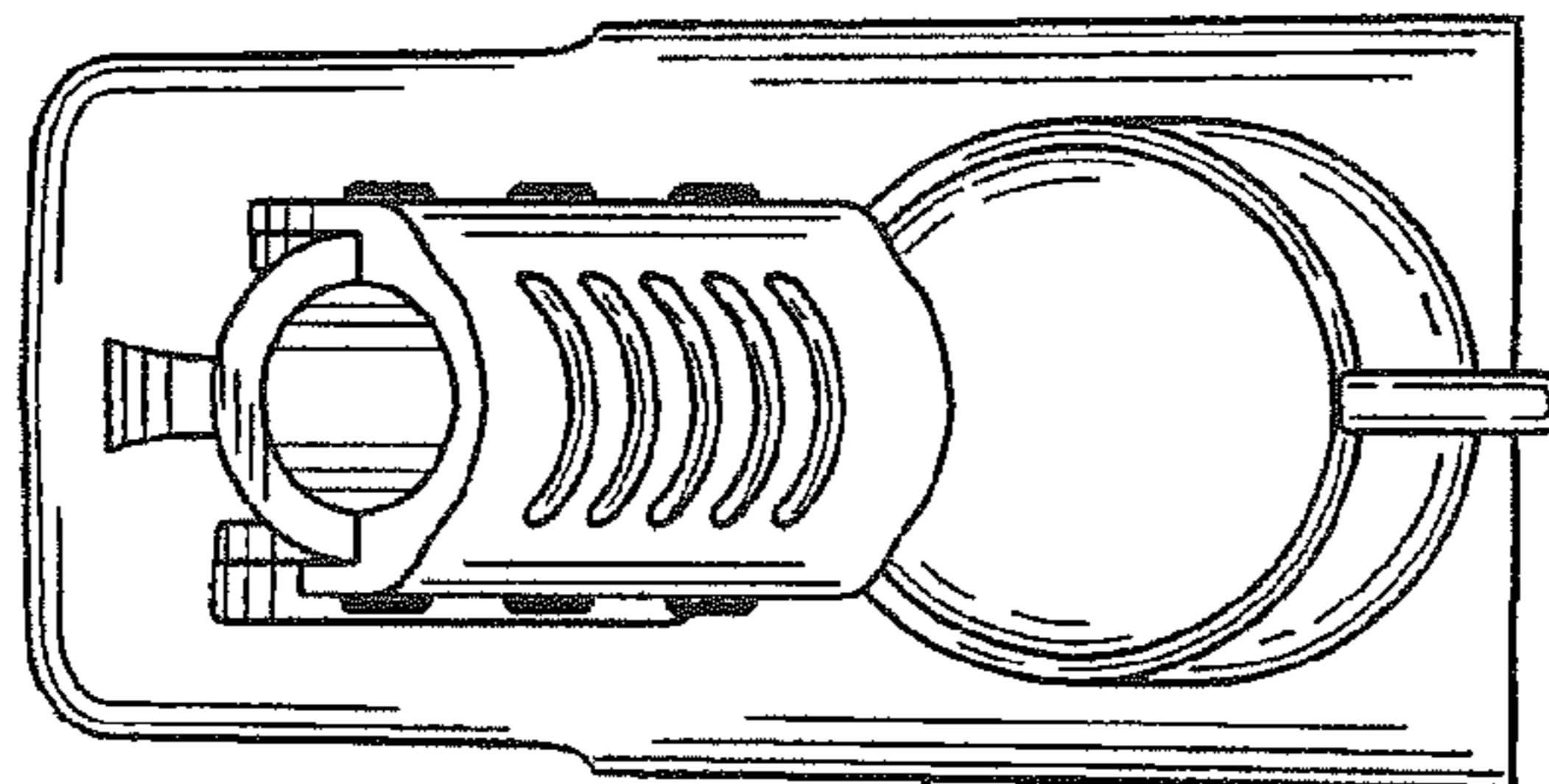

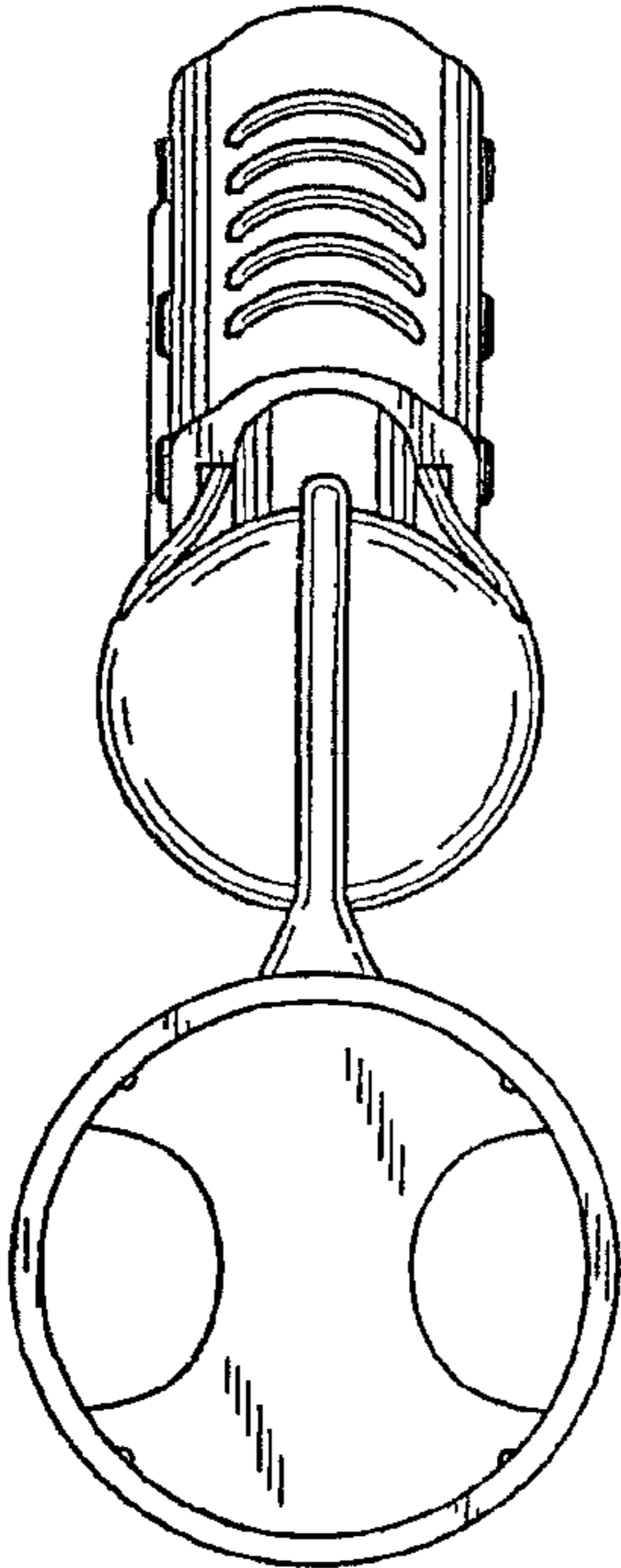

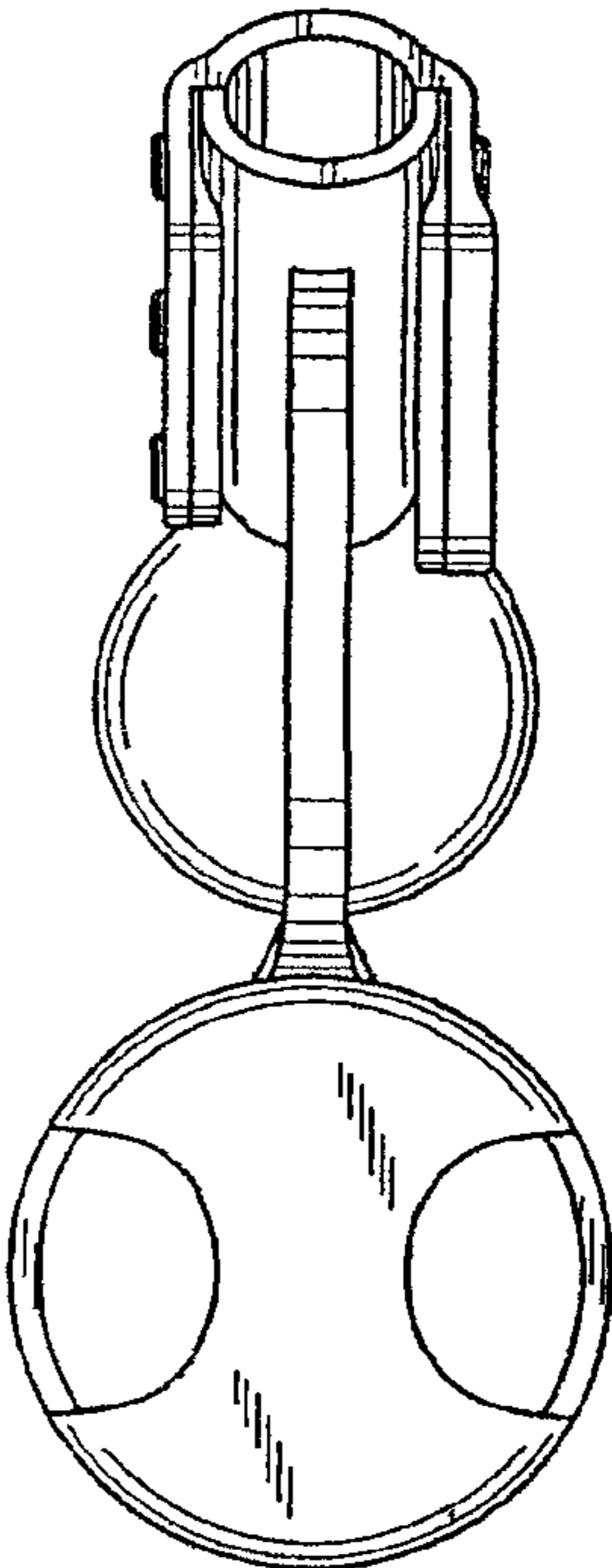

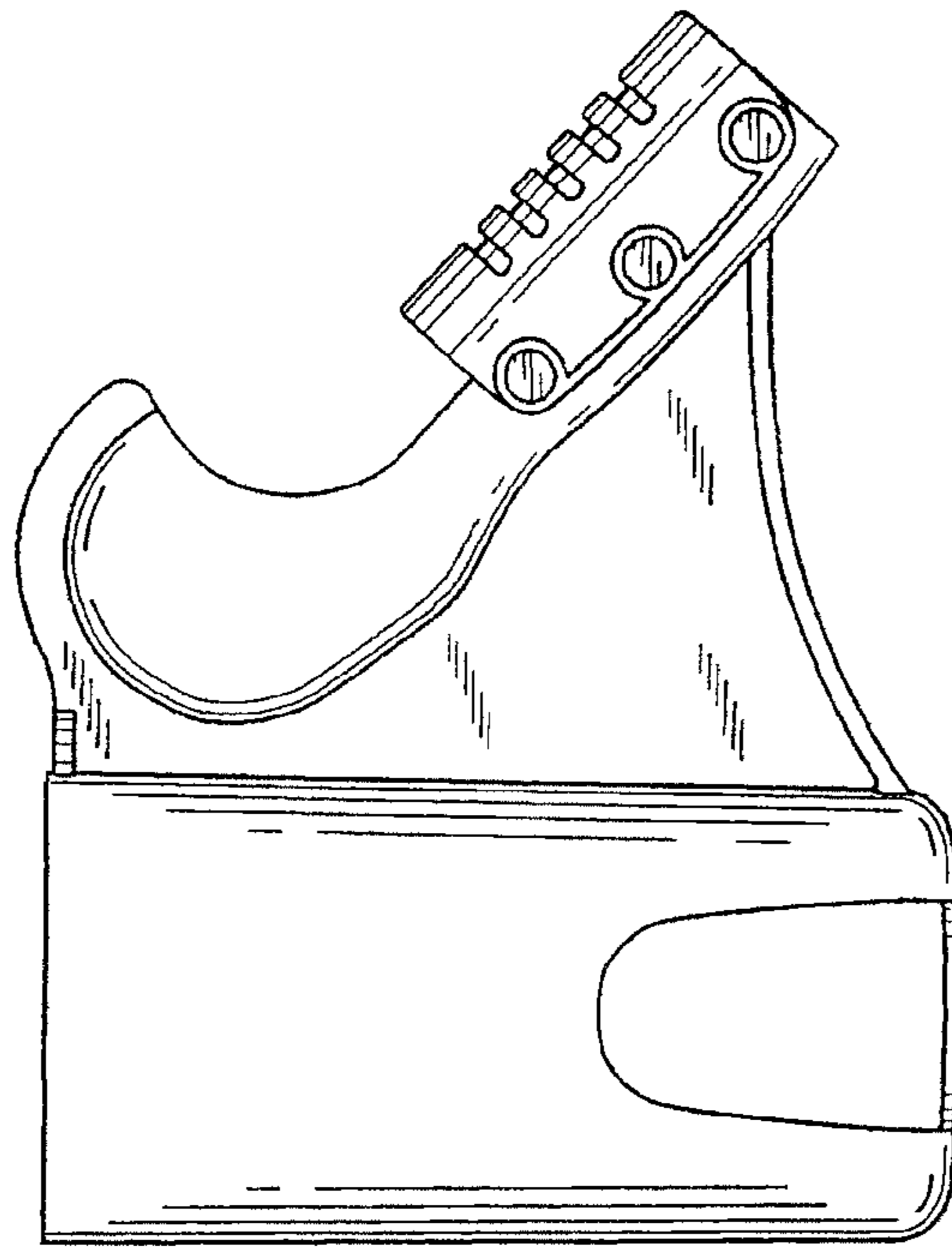

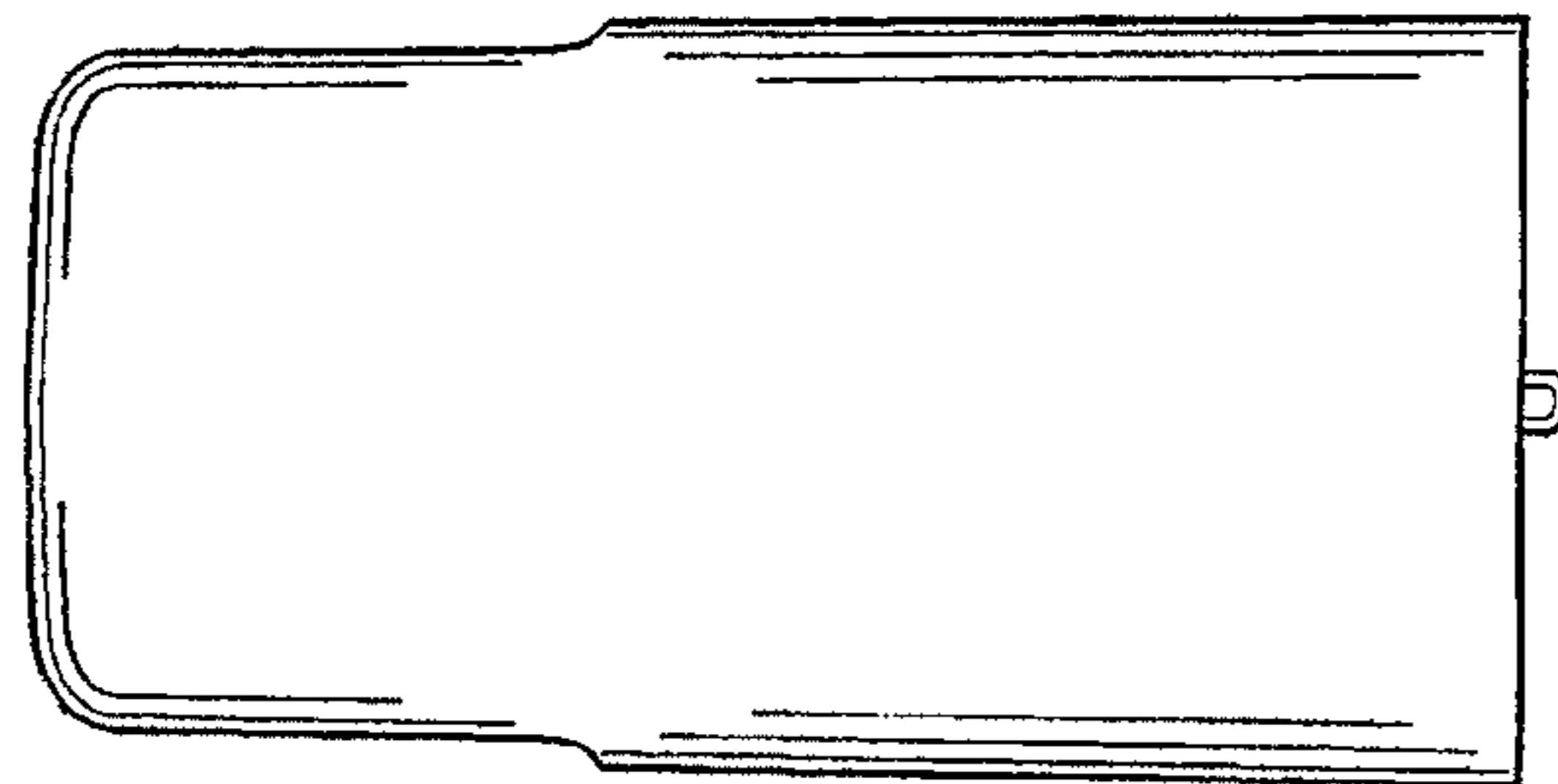
