DESCRIPTION

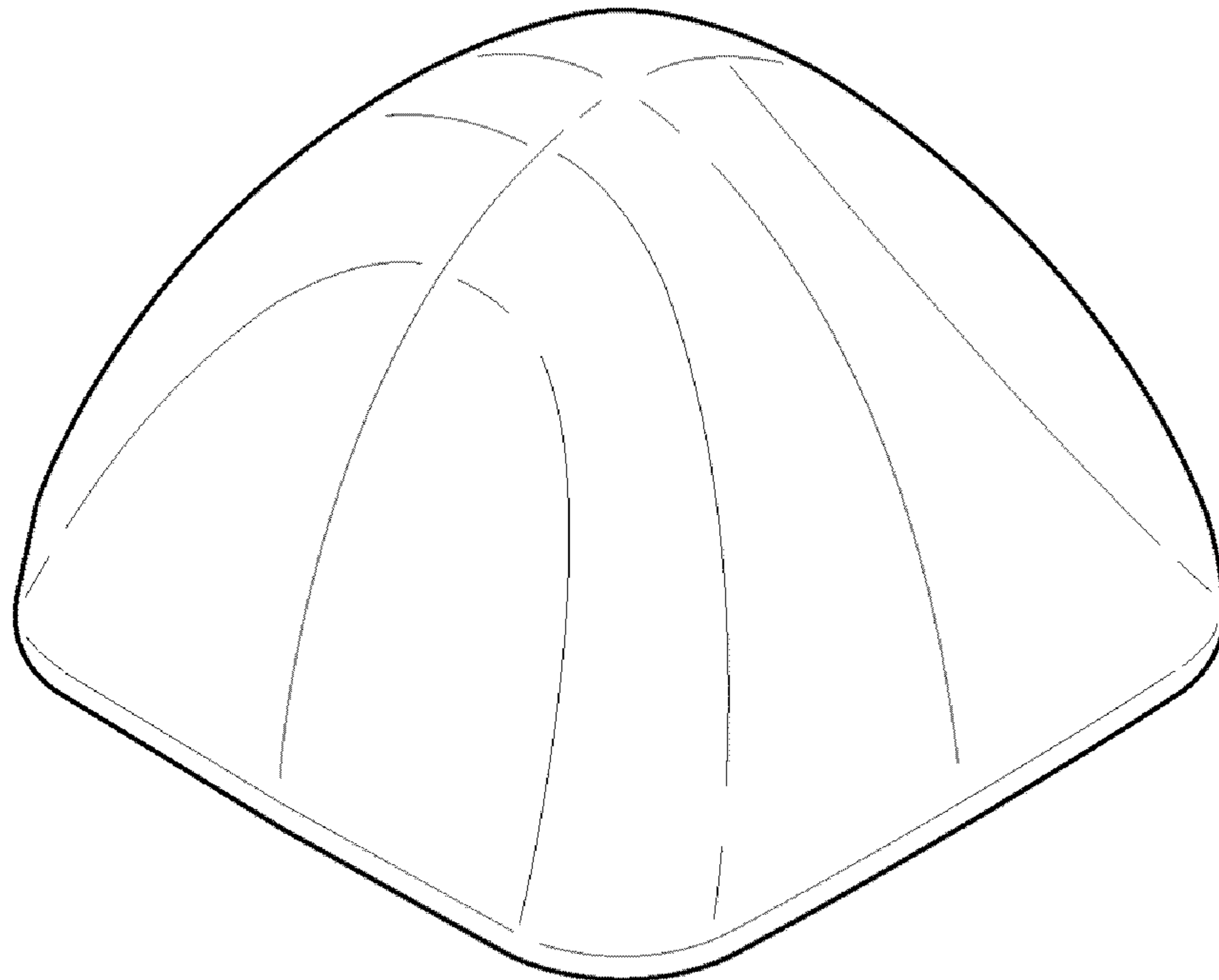
FIG. 1 is a perspective view of a neuromuscular therapy device, showing the design according to my invention;

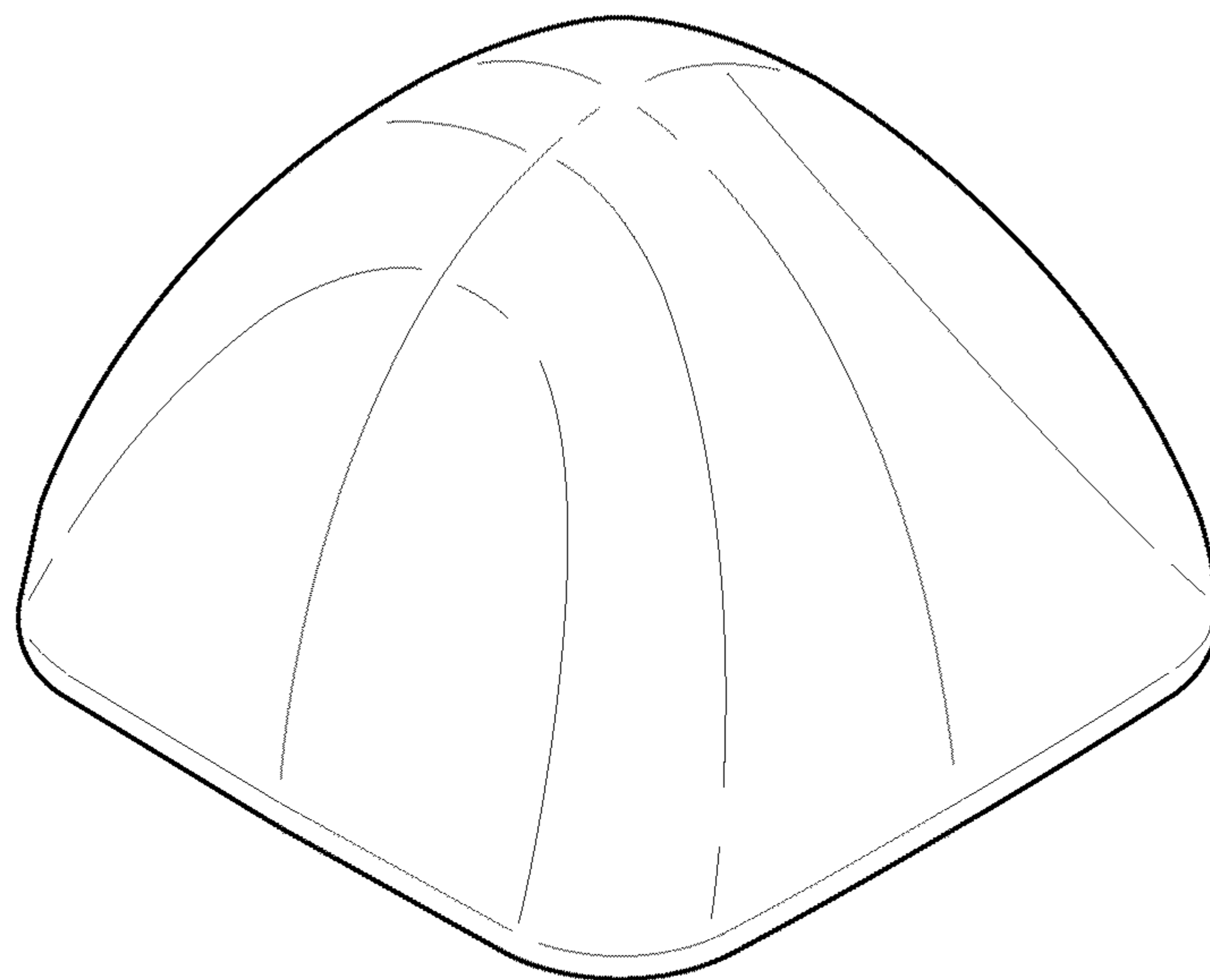

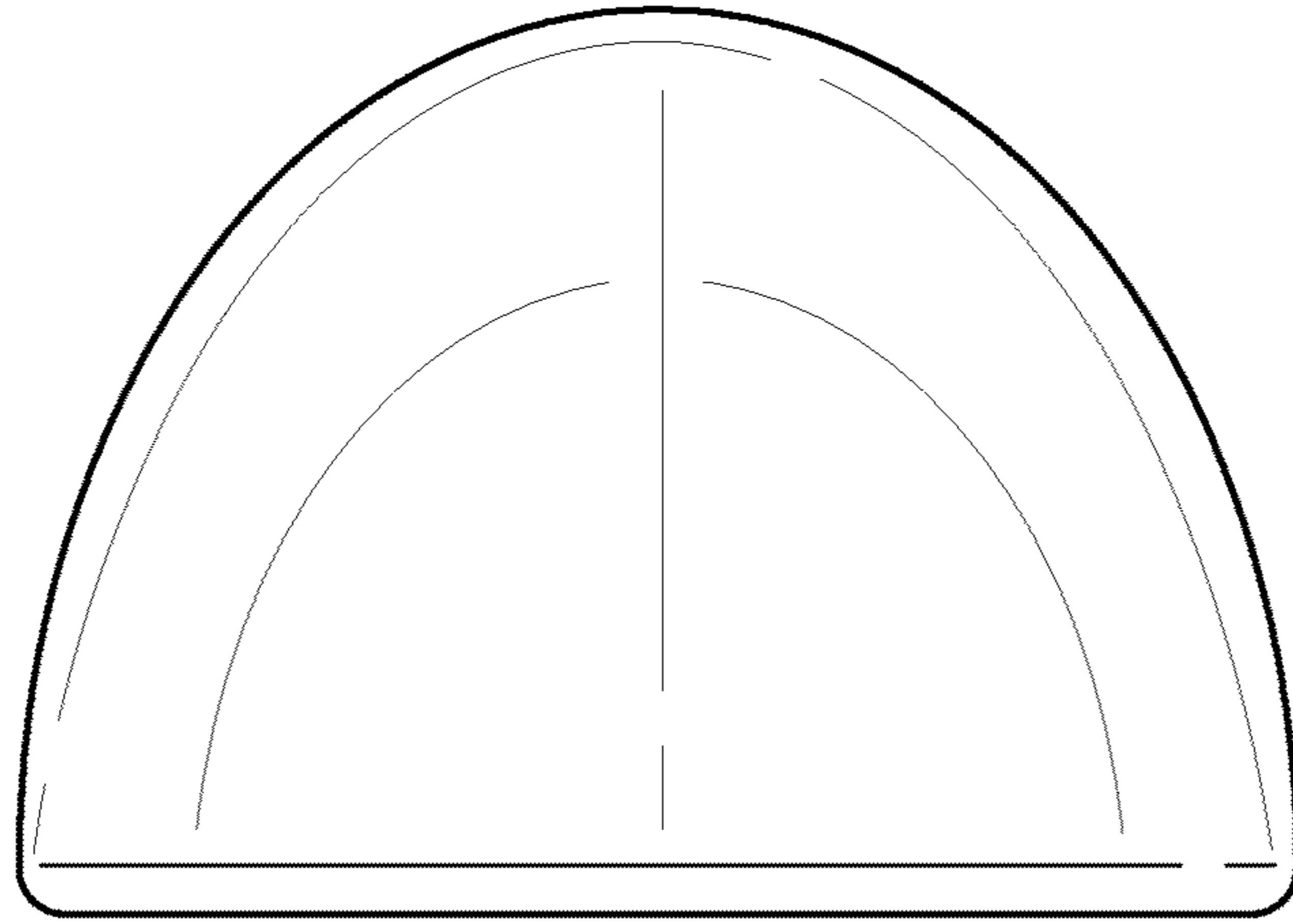

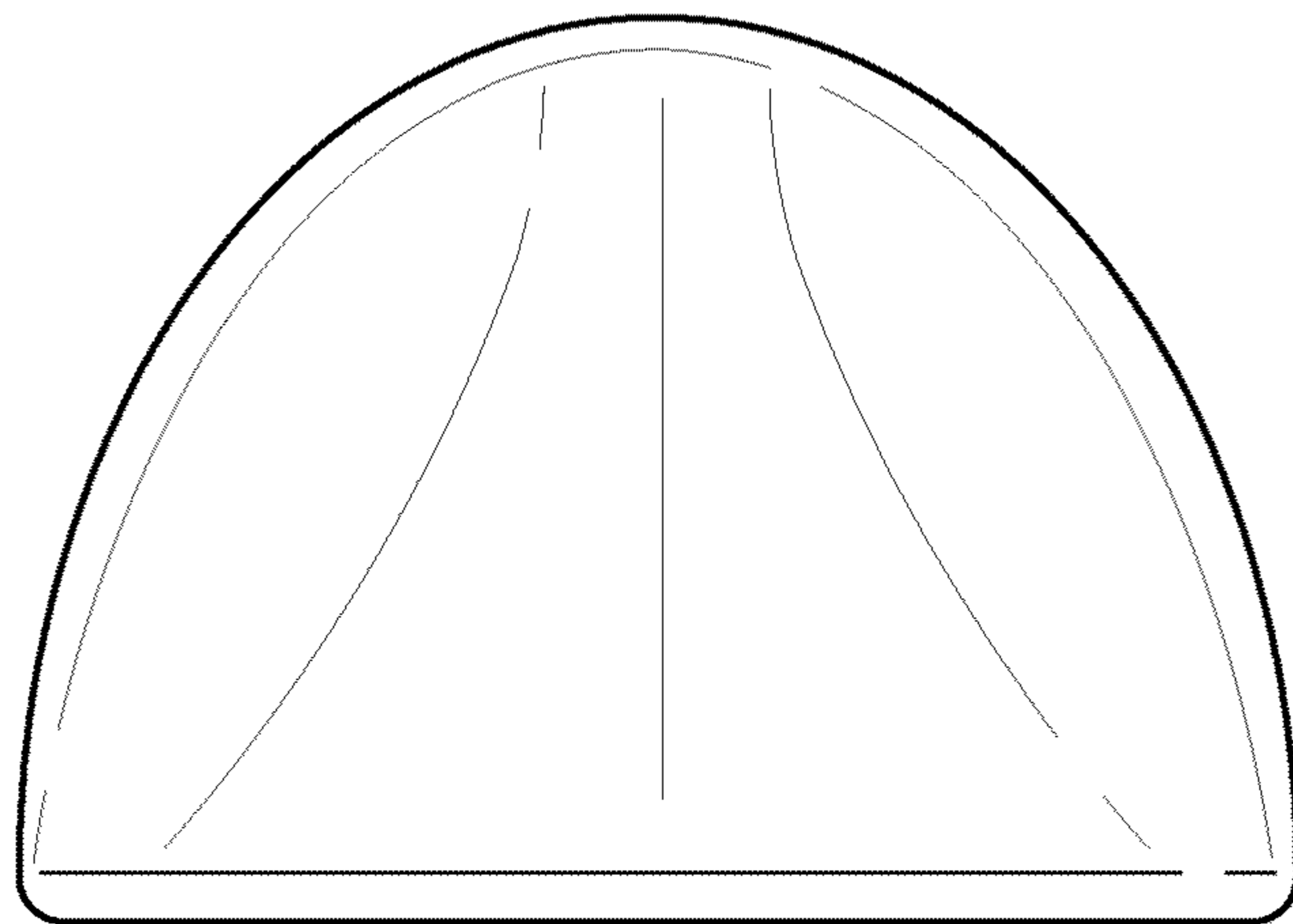

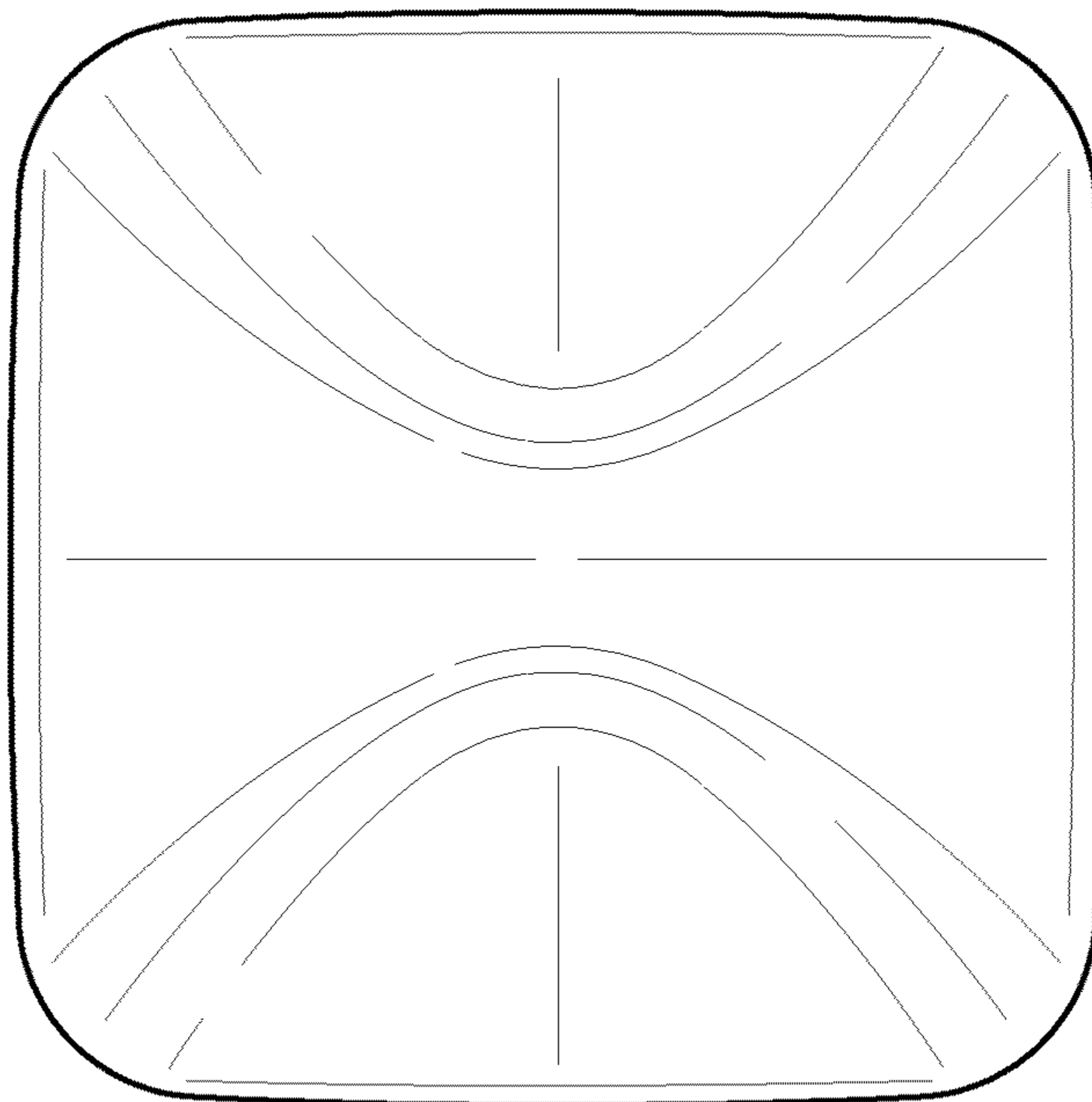
