(57) **CLAIM**

We claim the ornamental design for a frame for washing machine, as shown and described.

DESCRIPTION

FIG. 1 is a front/right-side/top perspective view of a frame for washing machine showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
Features shown in broken lines are disclaimed and form no part of the claimed design.
The chain lines (dot-dash-dot) shown in FIGS. 1 and 5 represent the side panel border forming no part of the claimed design.

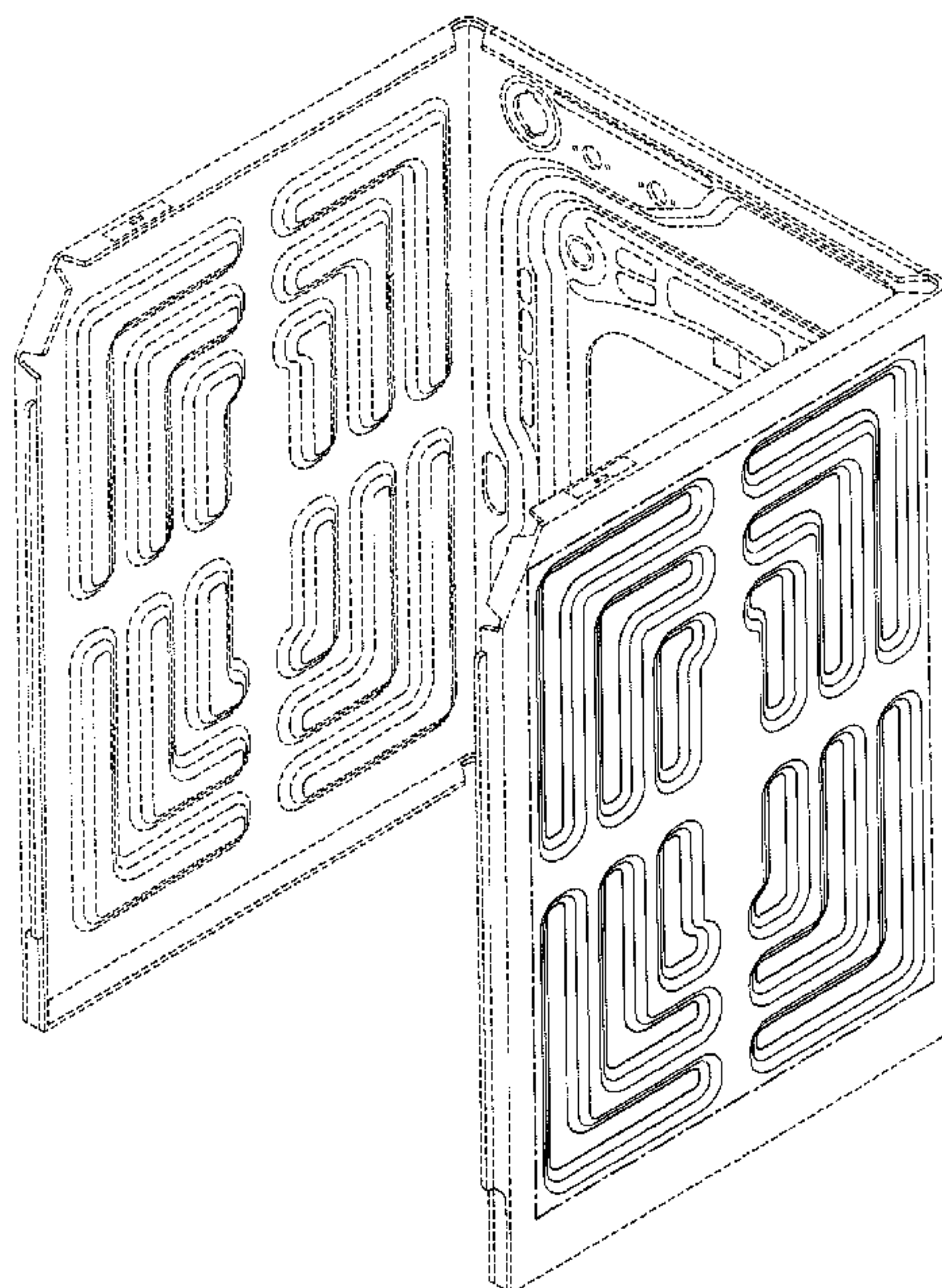

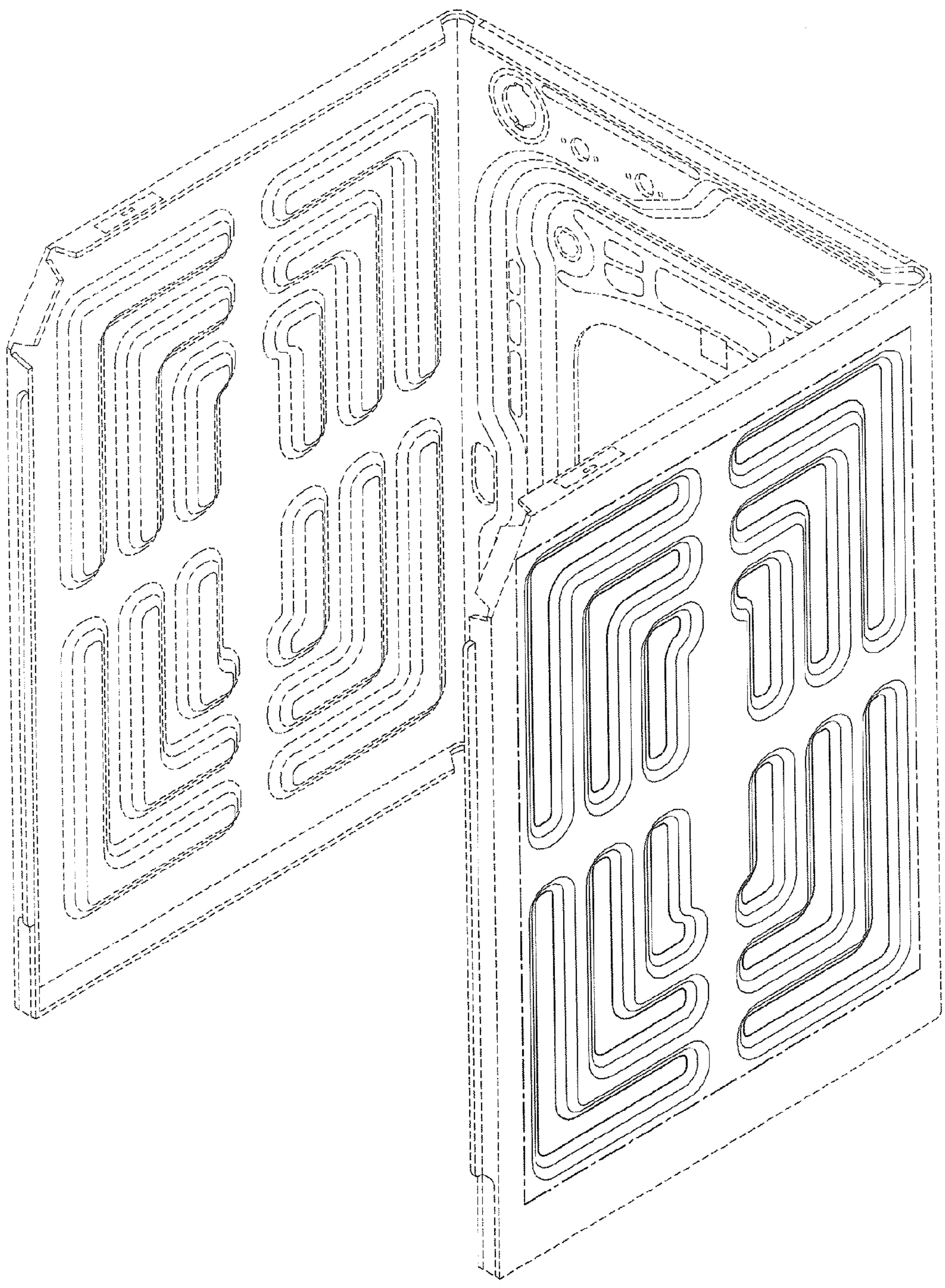

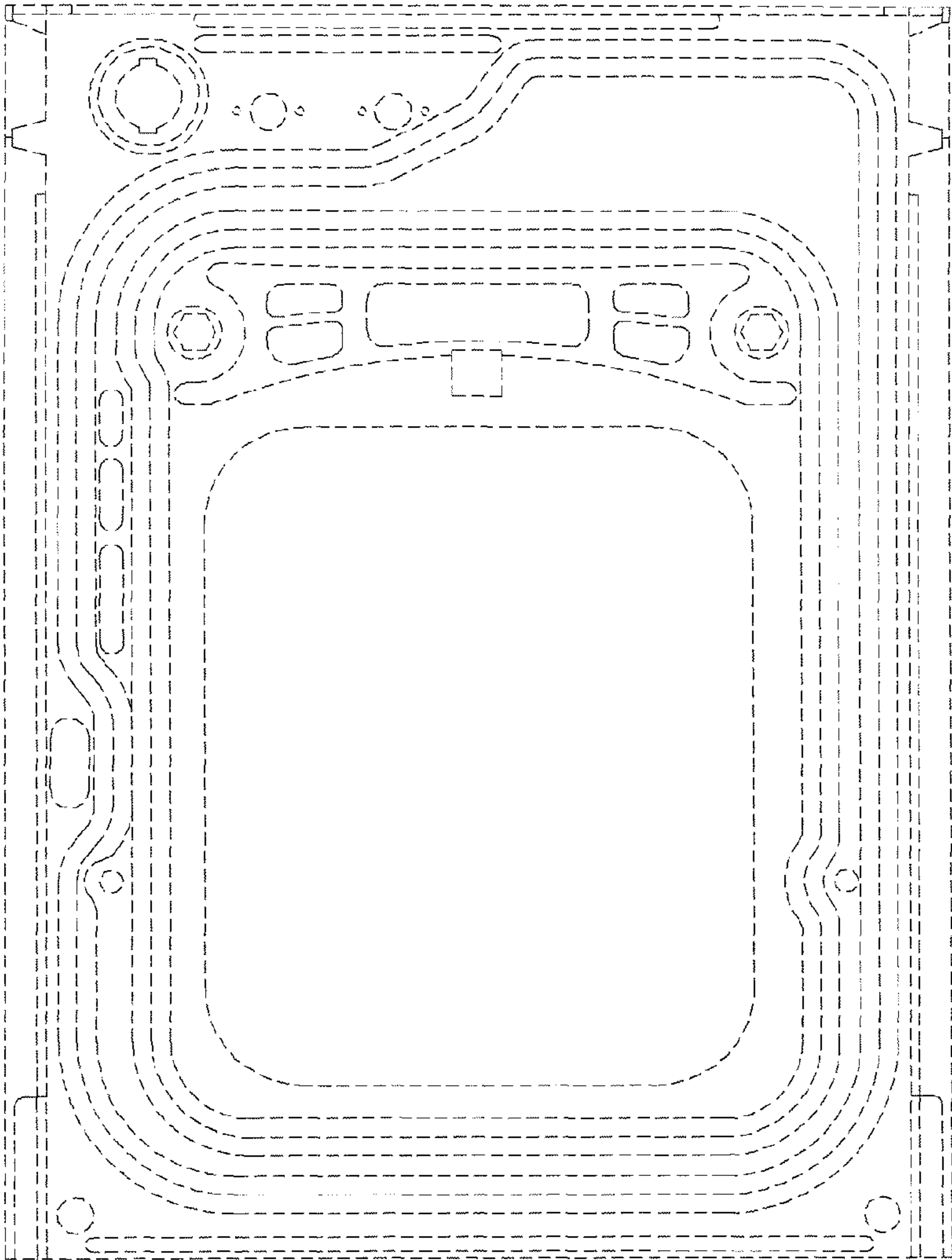

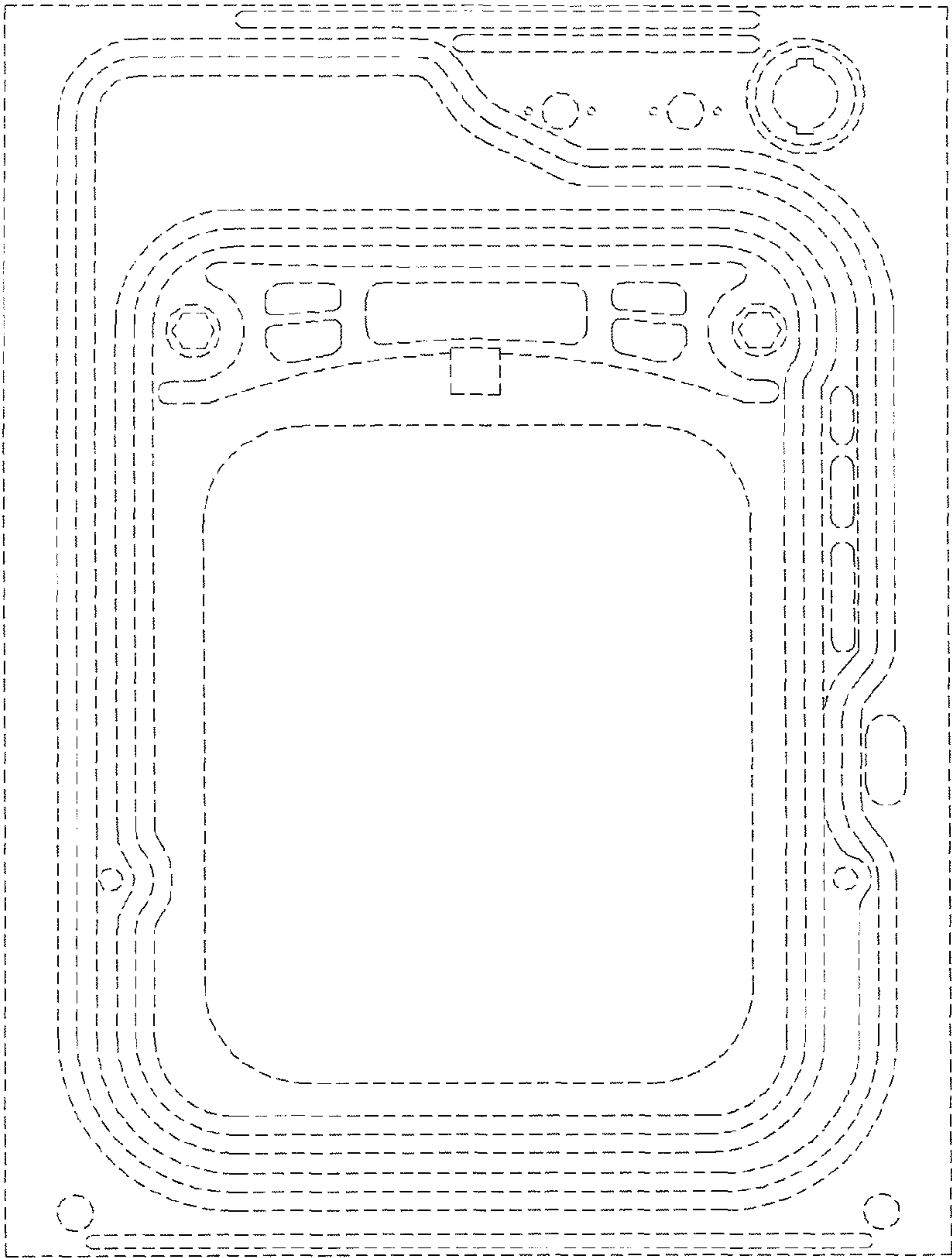

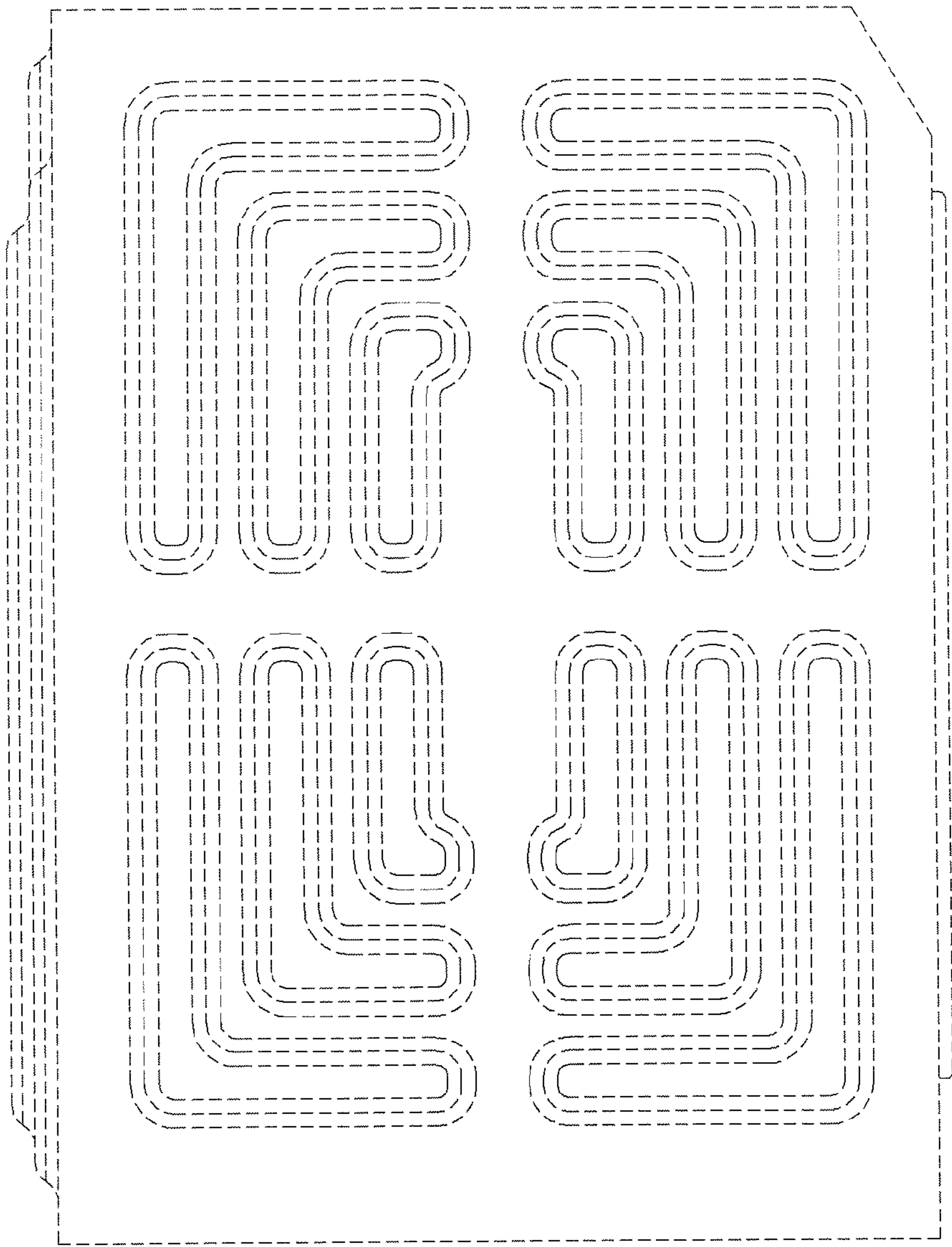

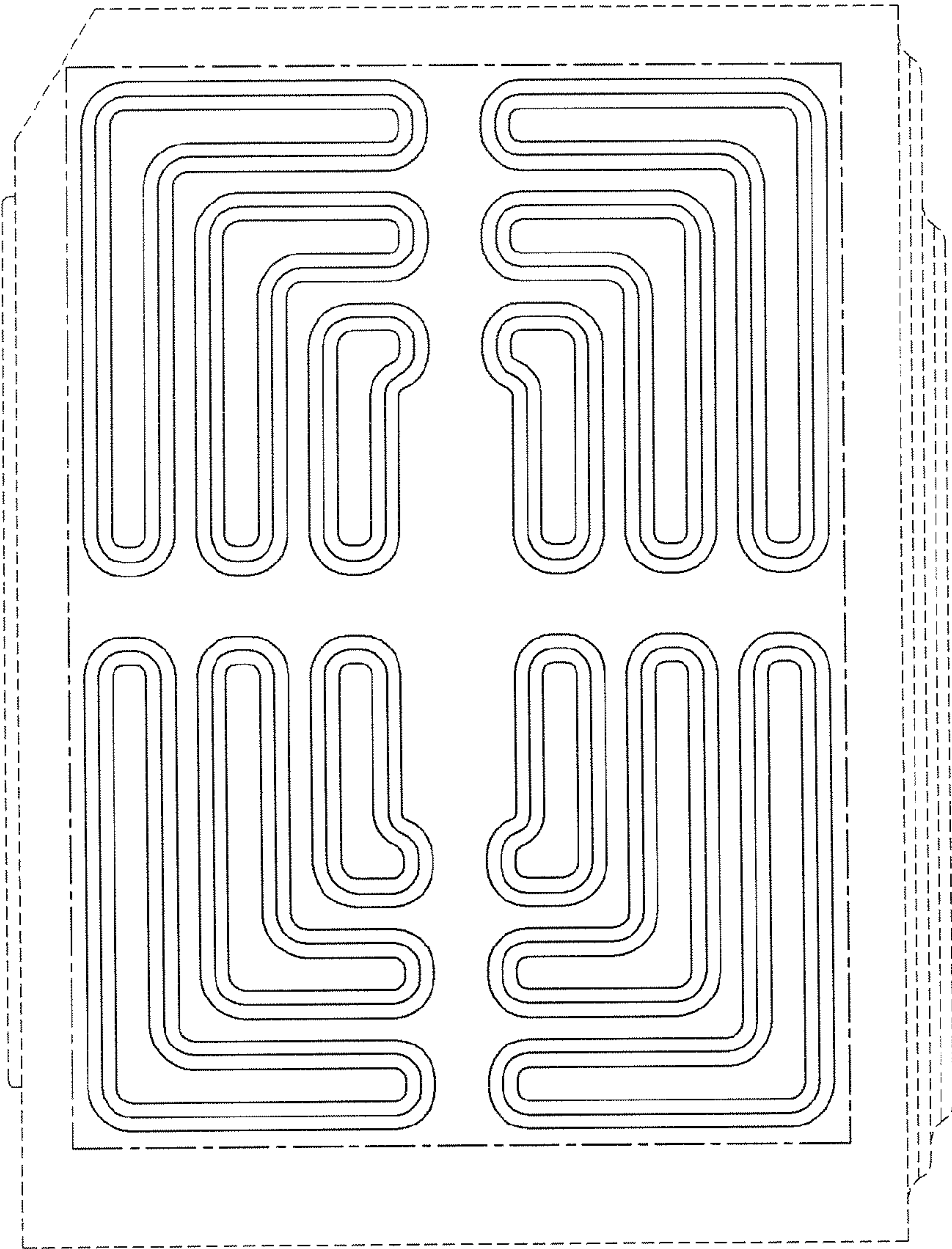

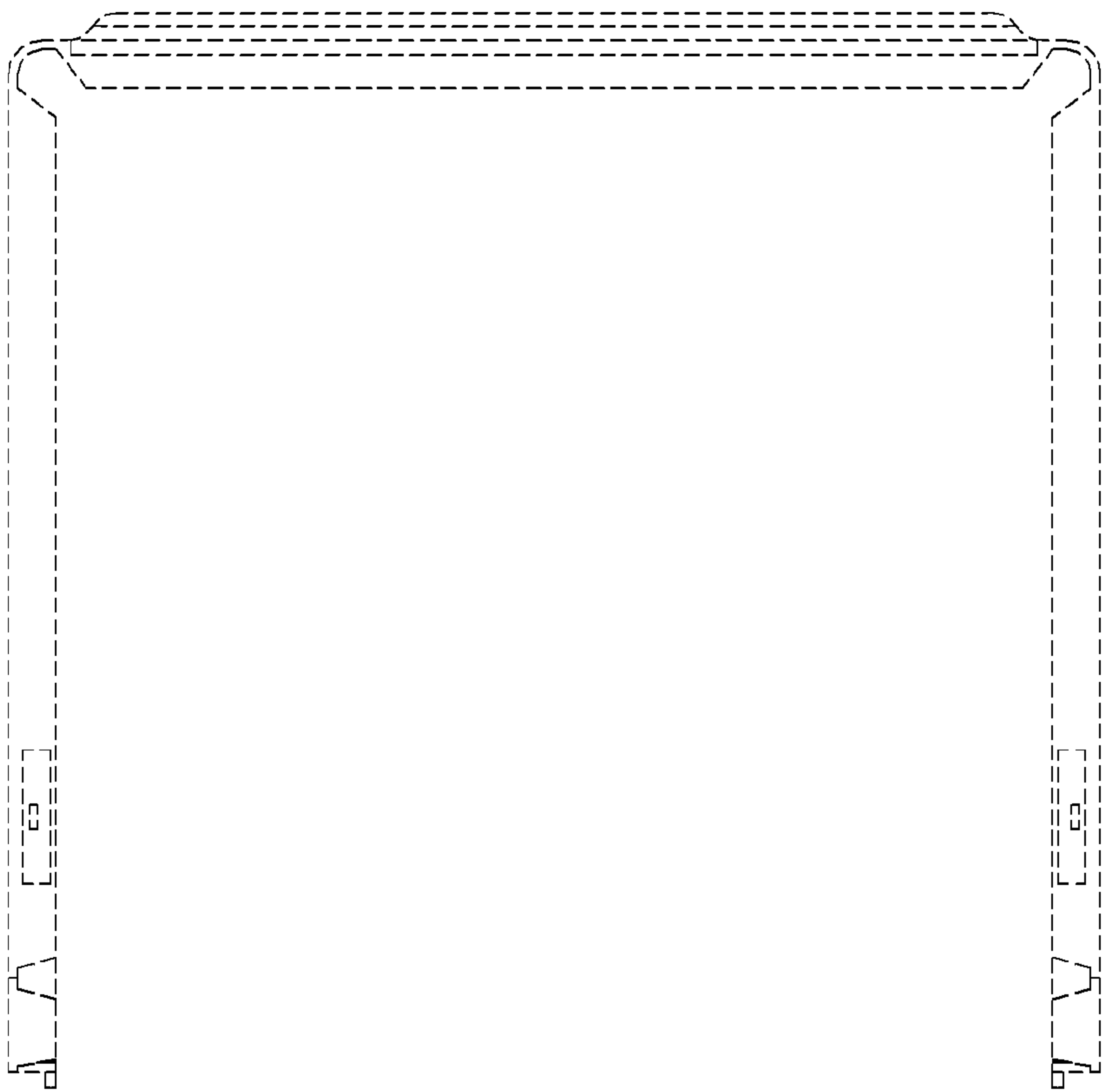
