The ornamental design for a shooting jacket, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a shooting jacket showing my new design;
FIG. 2 is a rear elevation view thereof;

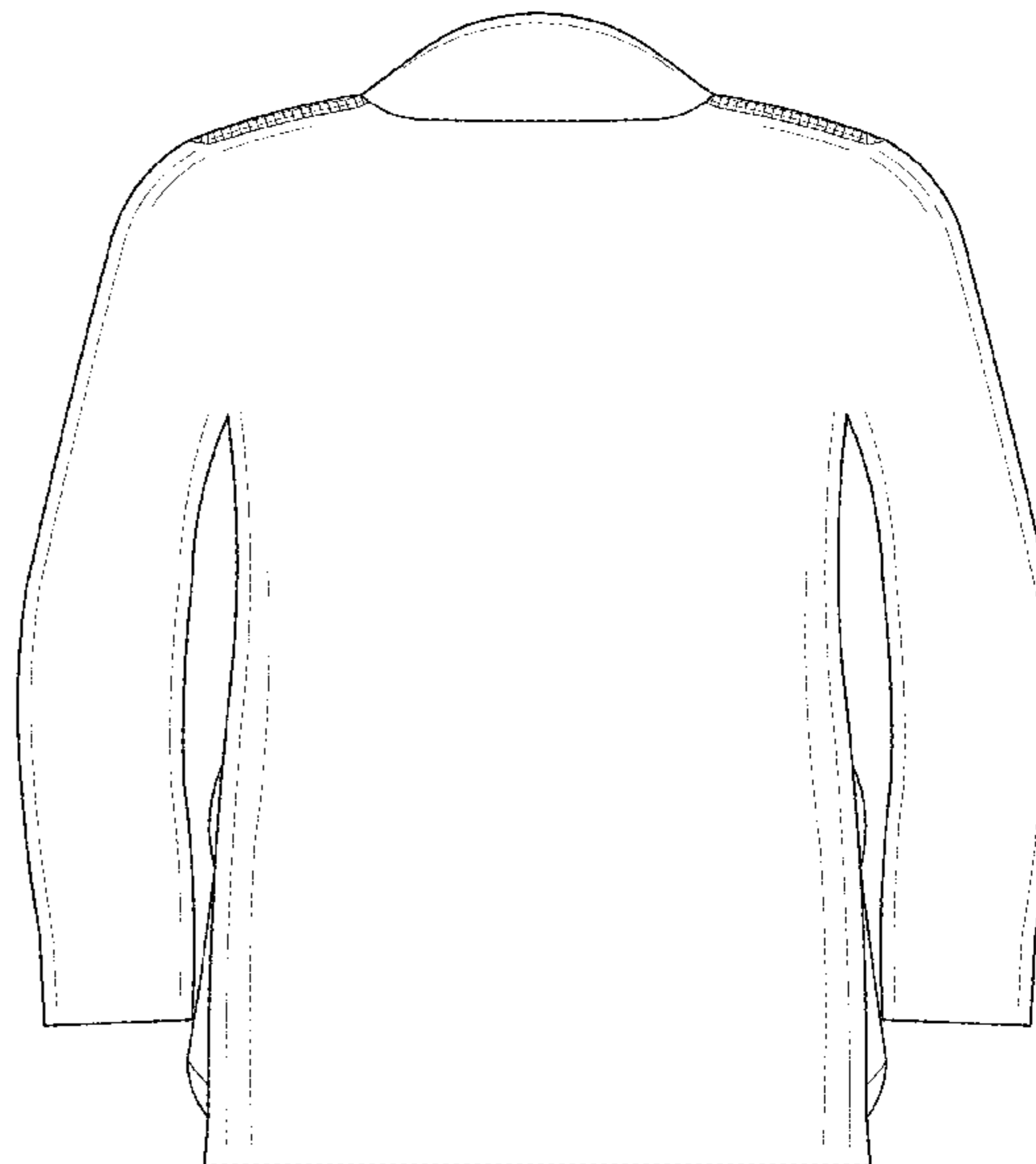

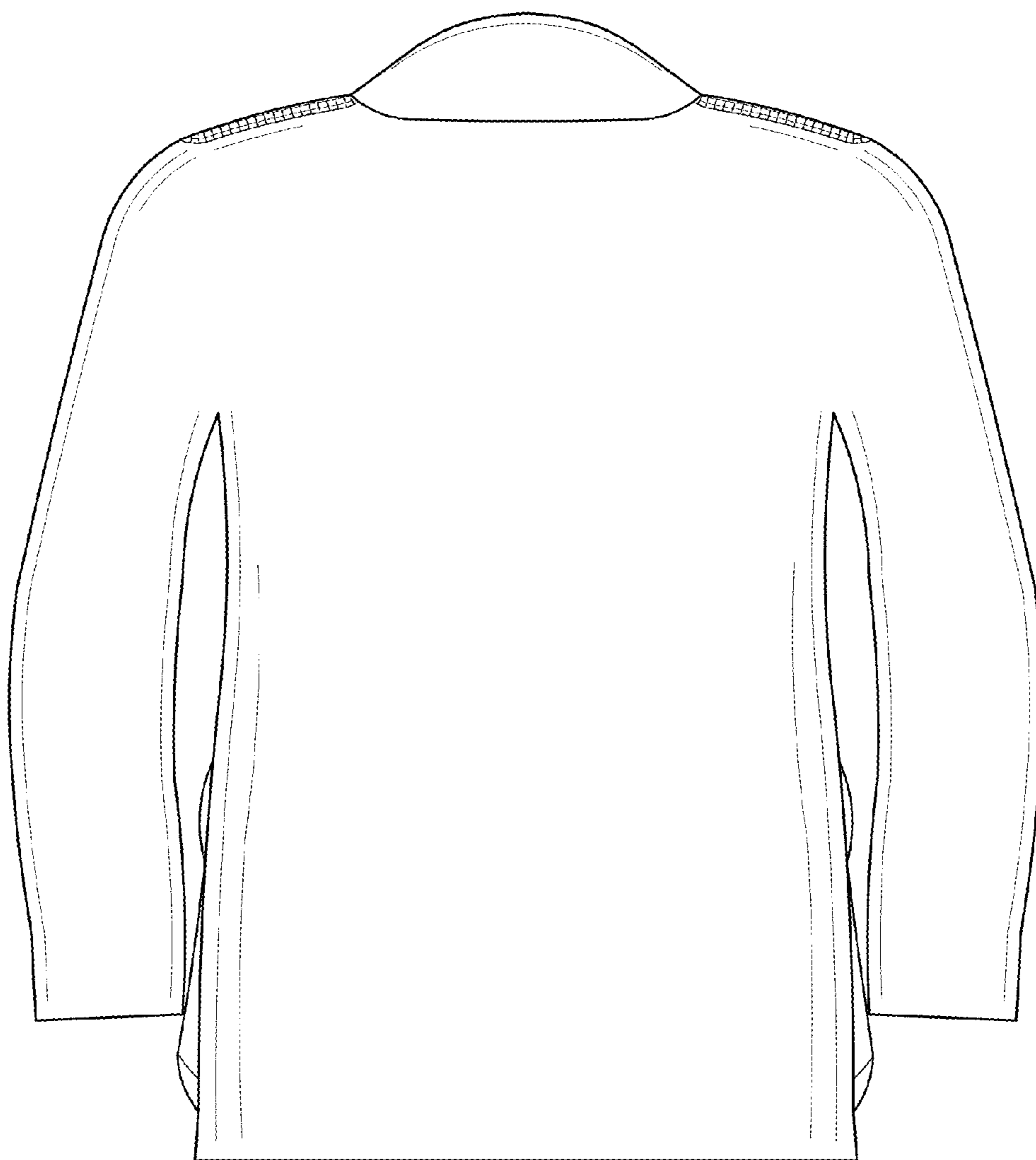

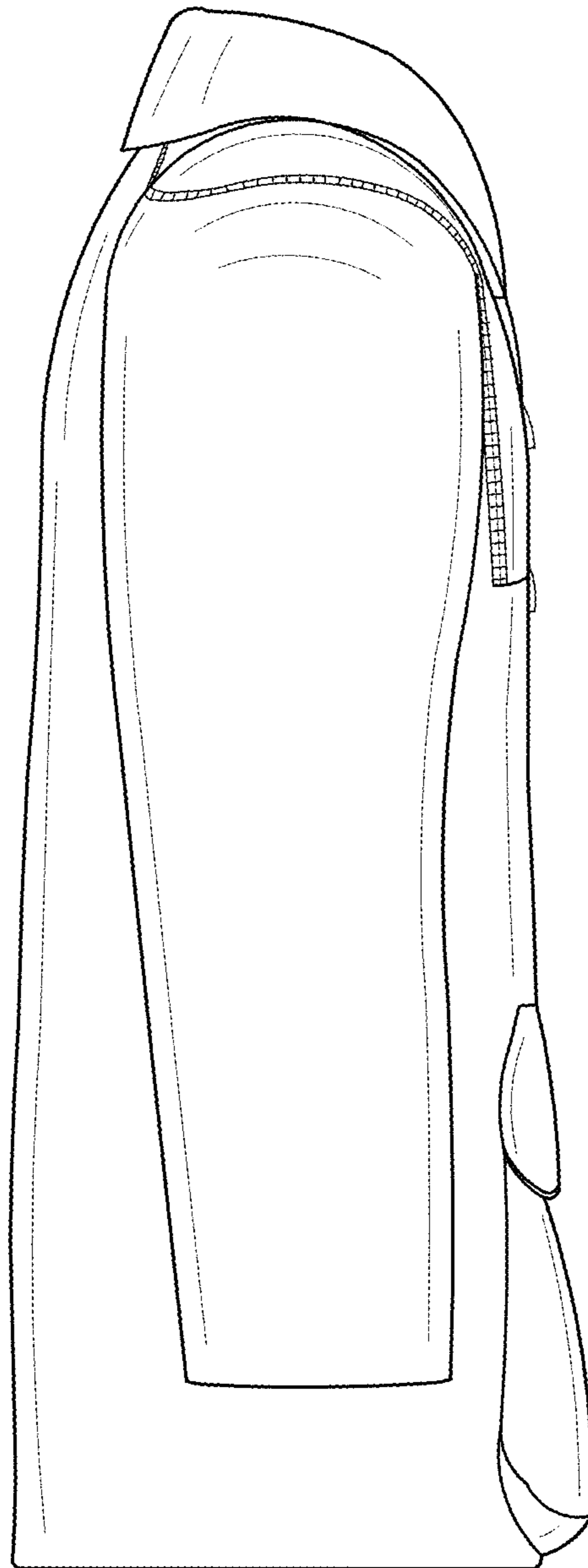

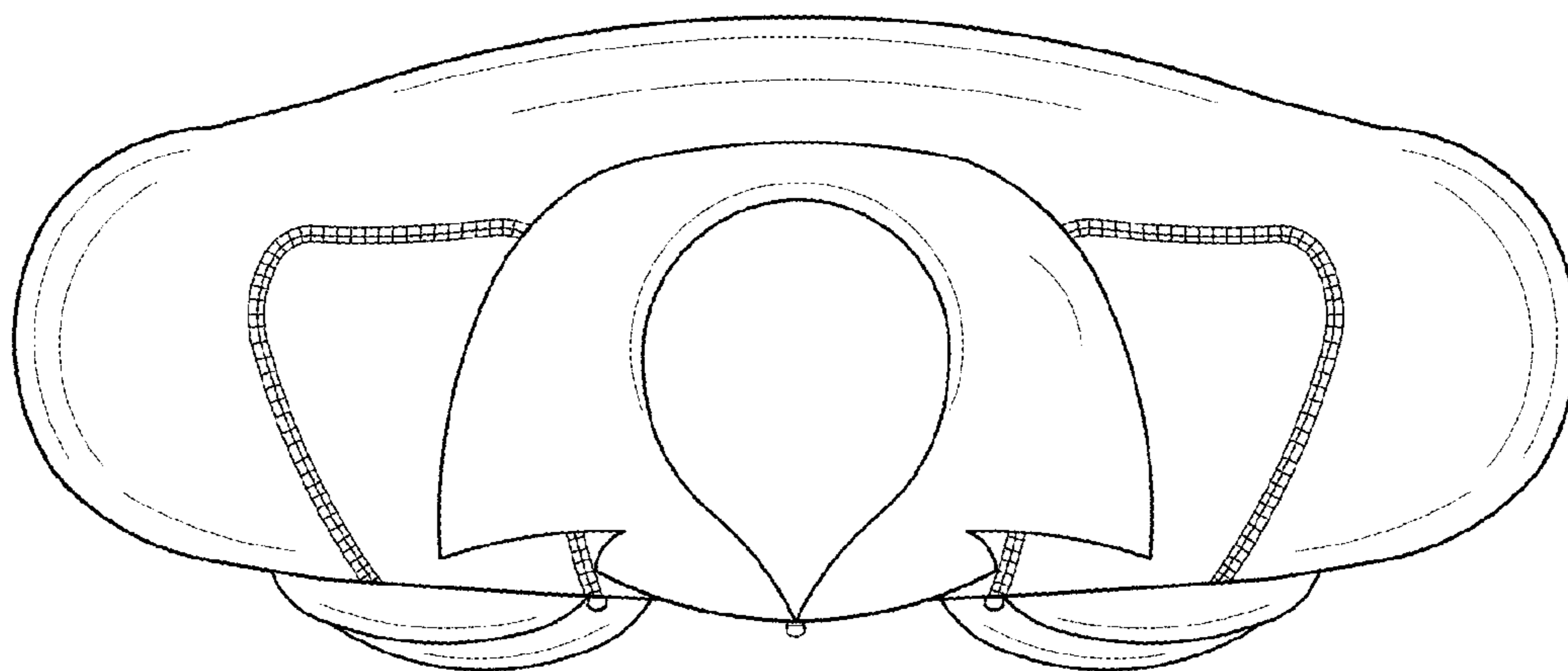

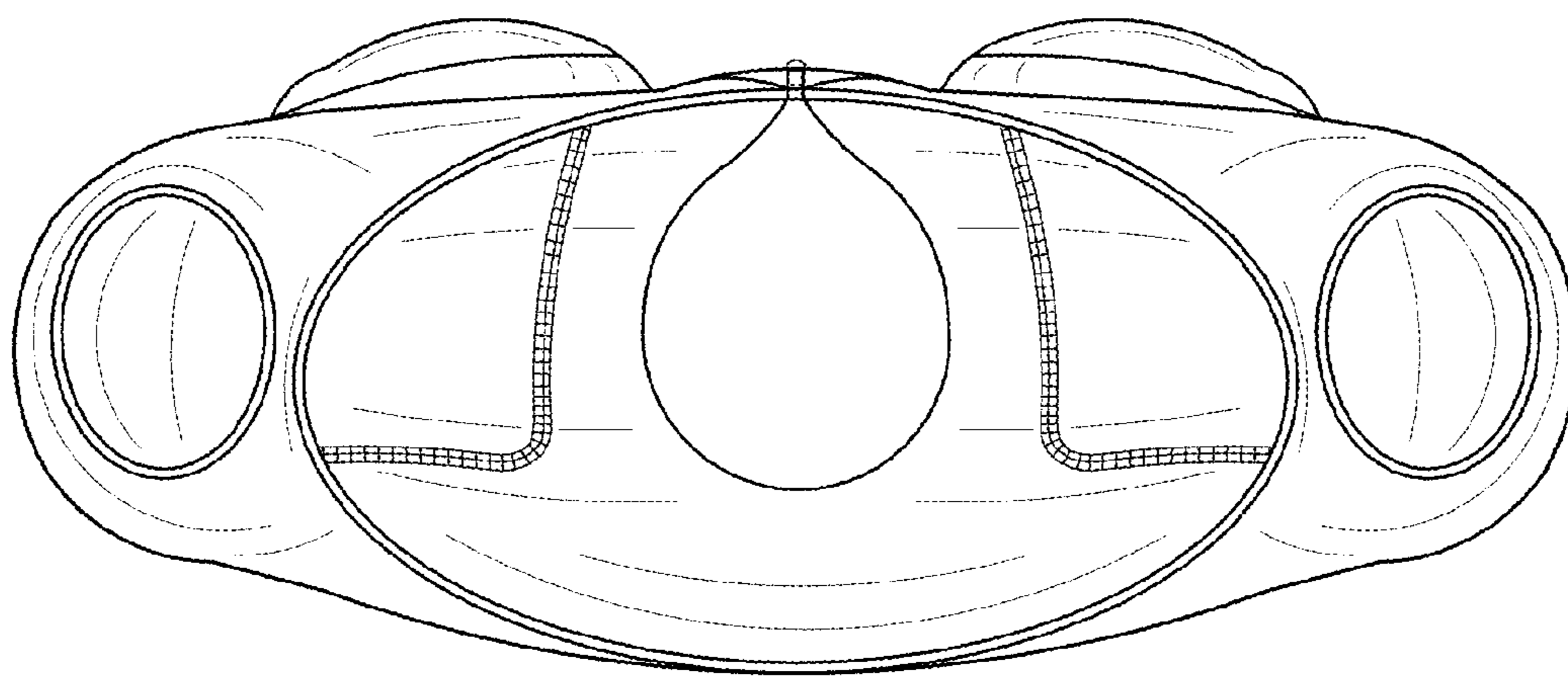
