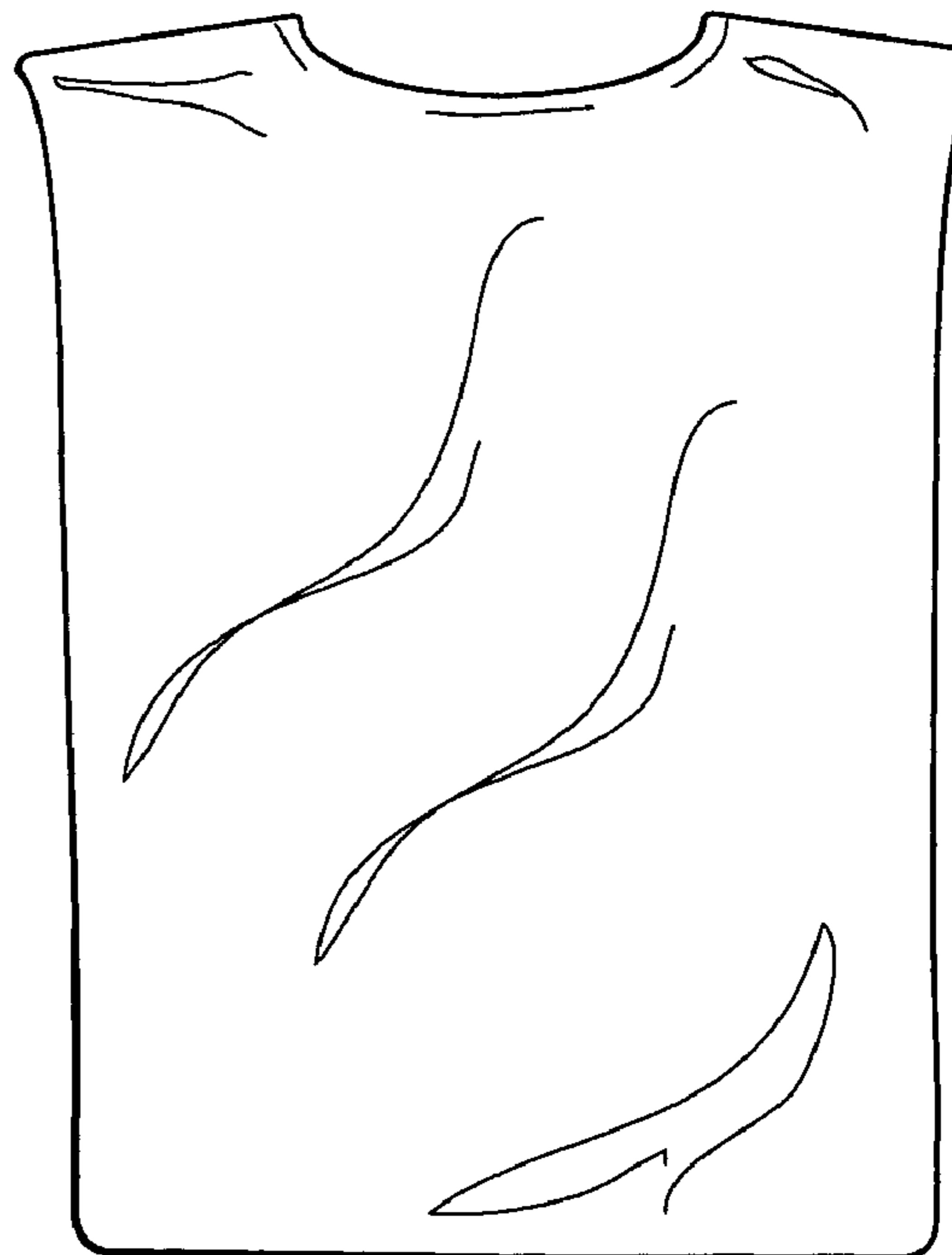
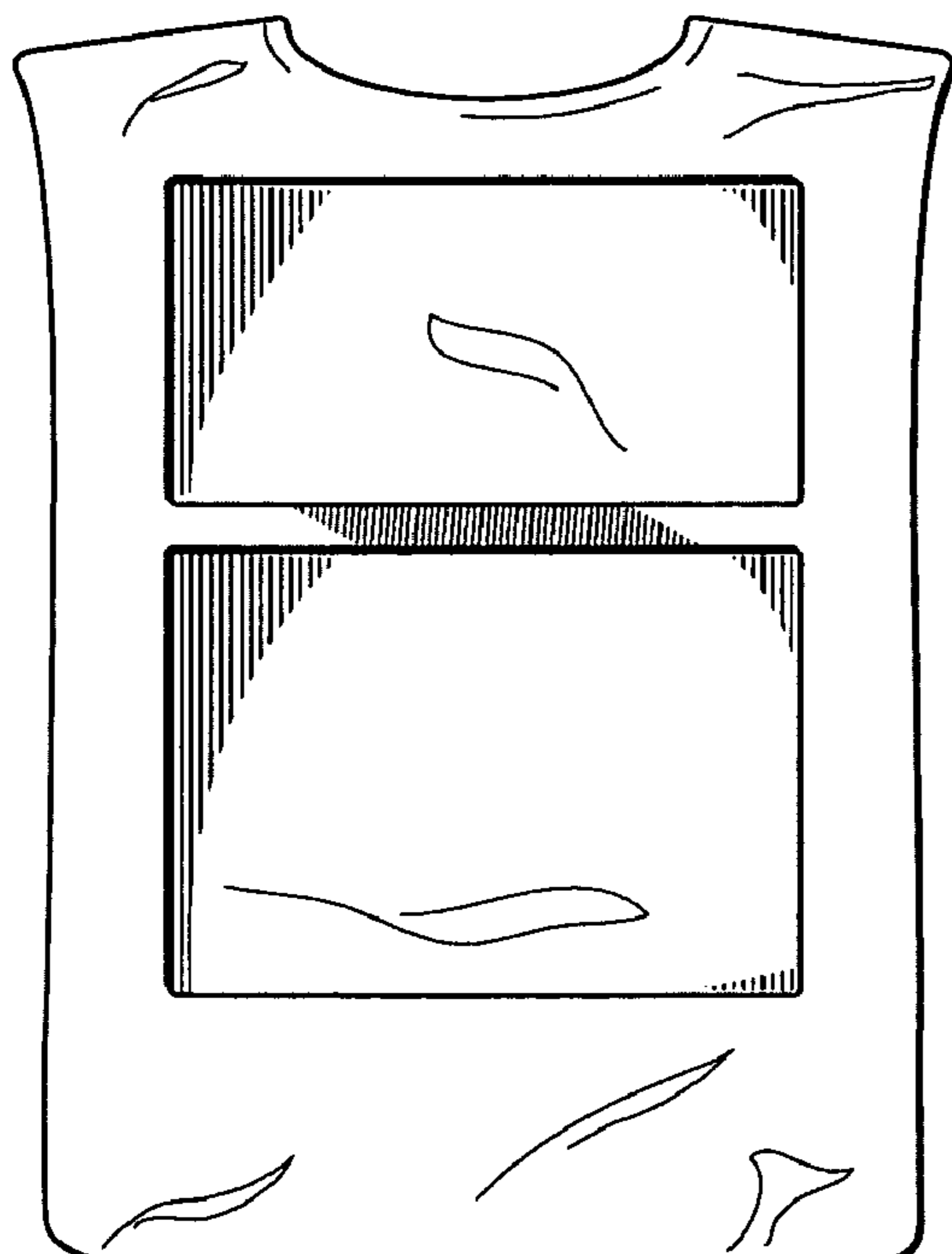

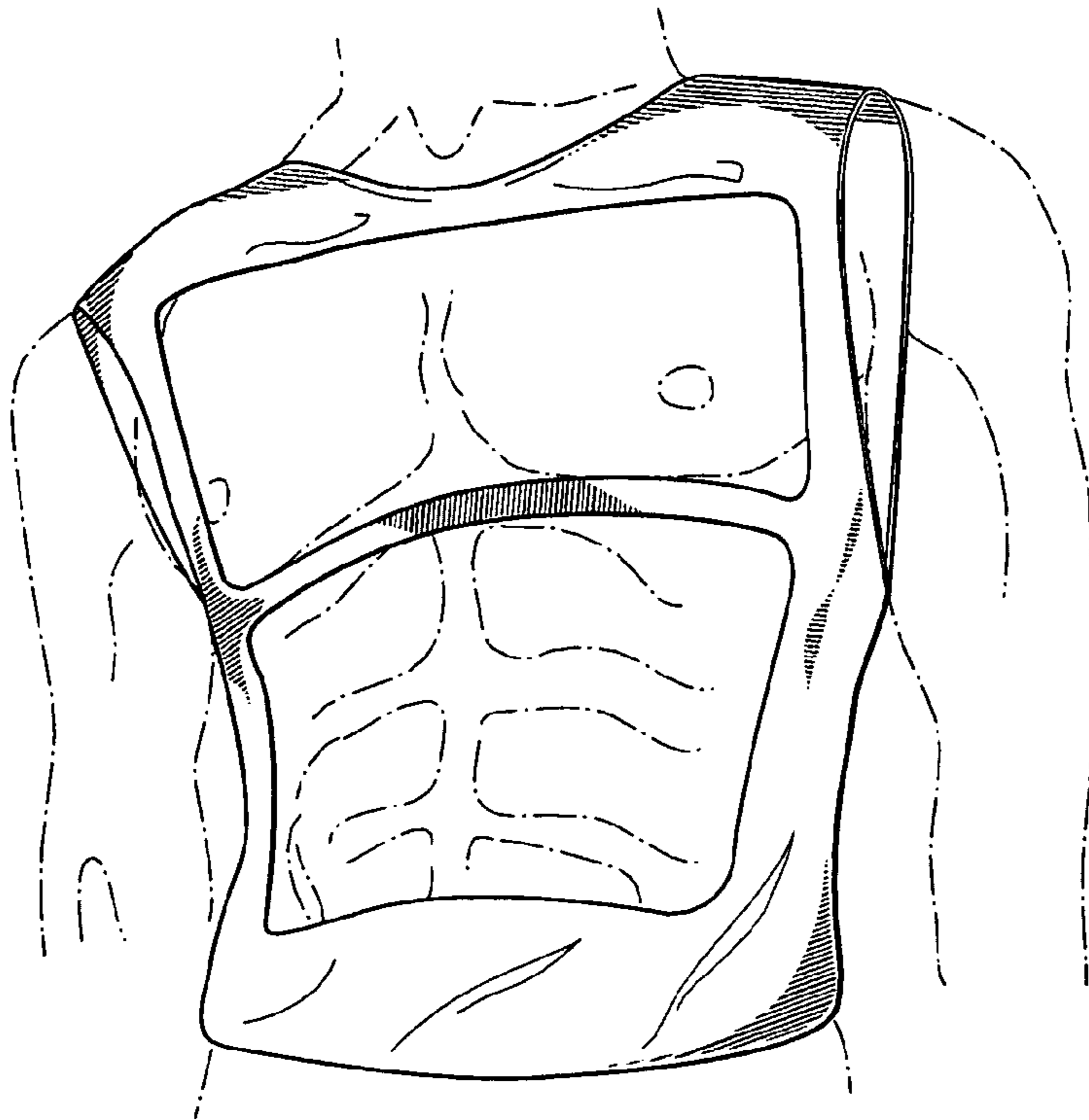
(57) **CLAIM**

**DESCRIPTION**

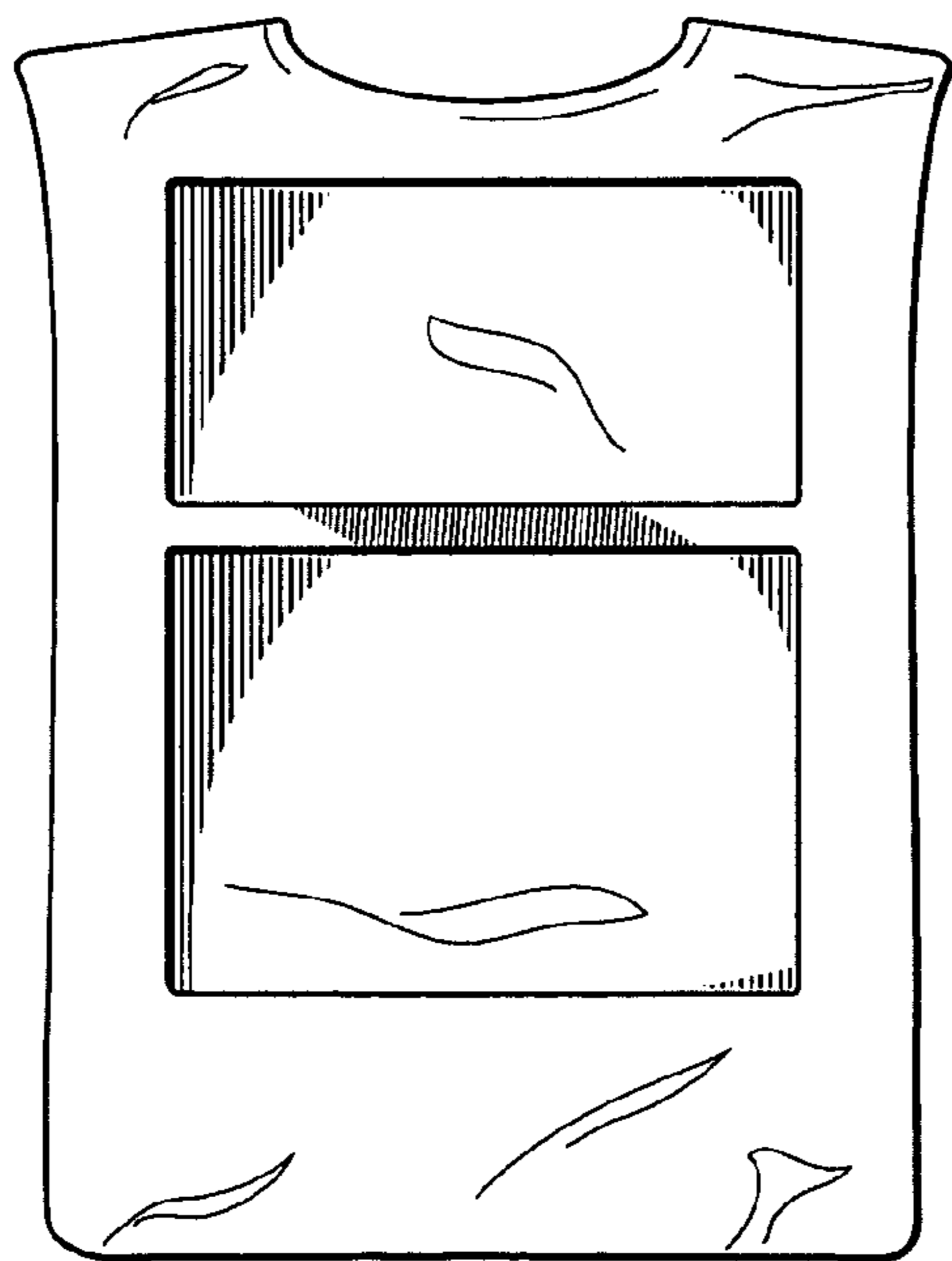
FIG. 1 is a perspective view of shirt showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view, the left side view being a mirror image thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof. The broken lines showing portions of the human figure show the shirt as worn and form no part of the claimed design.

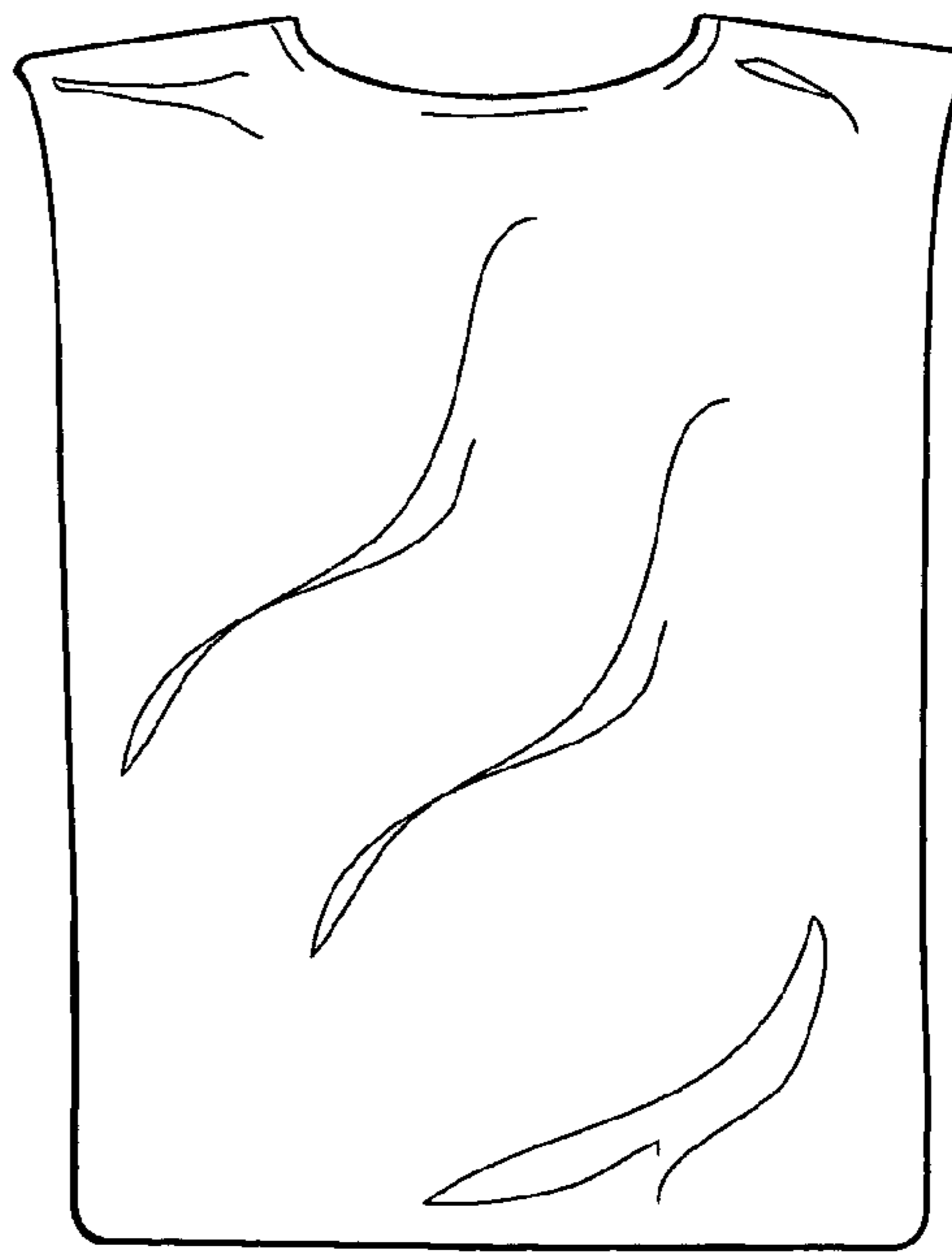




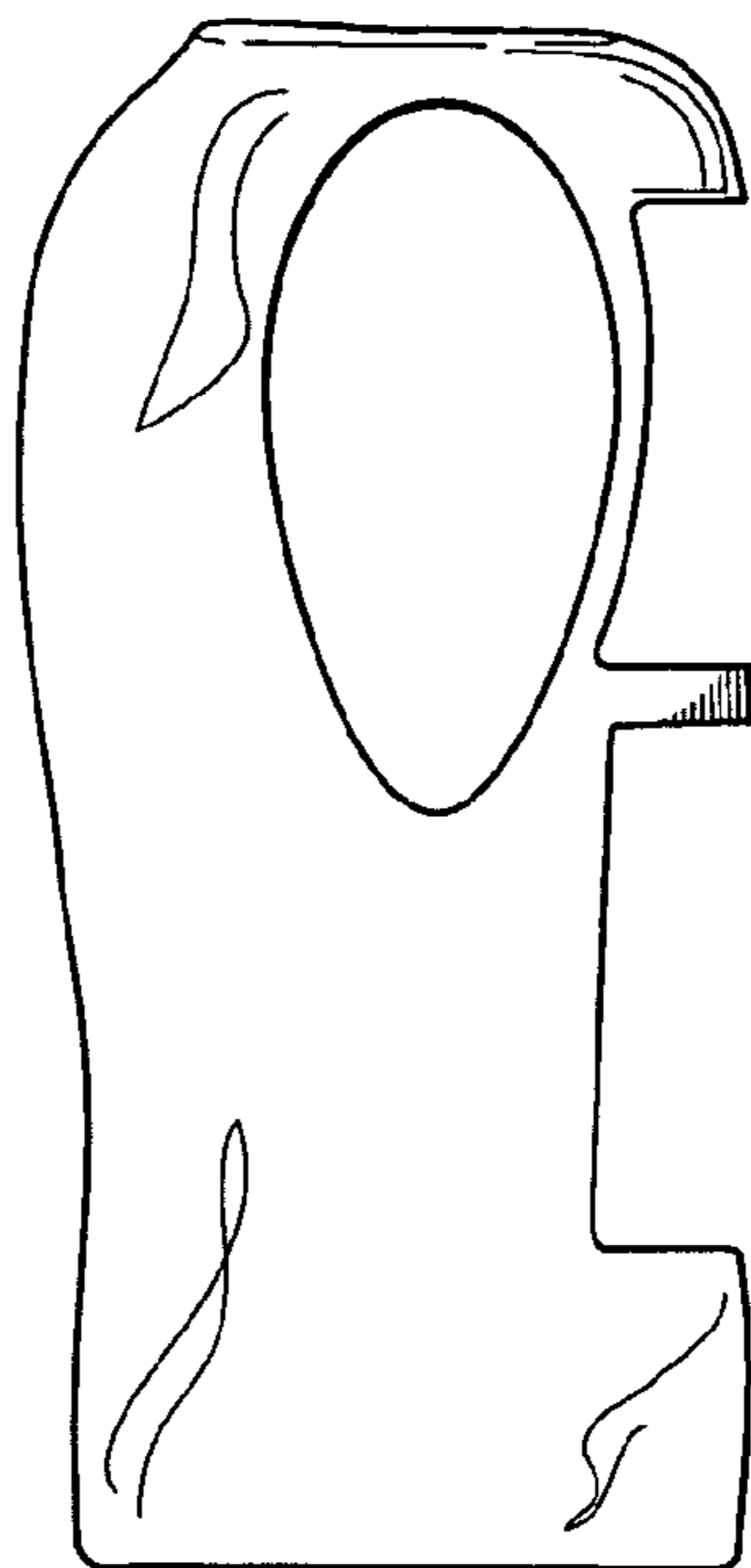

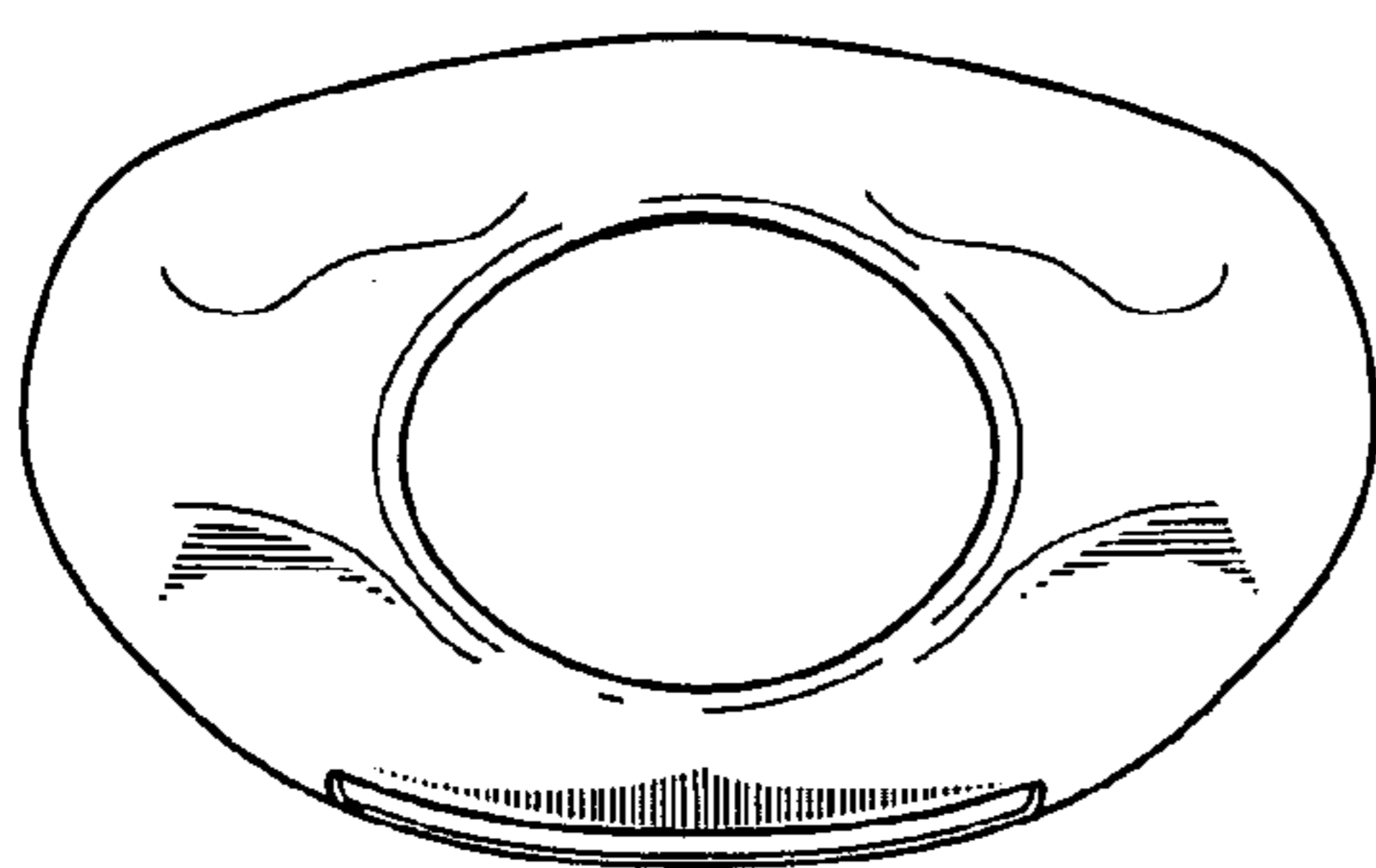

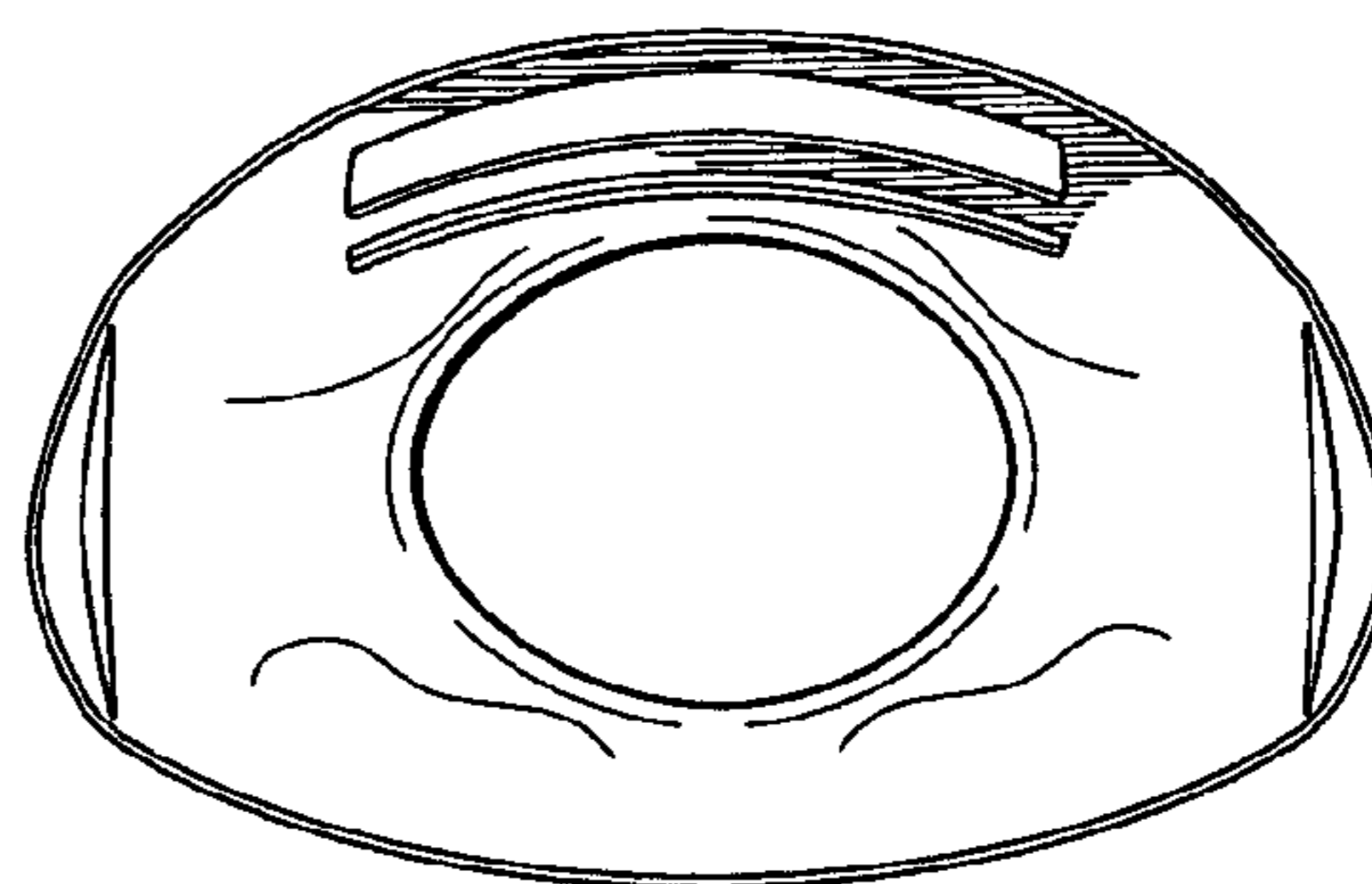
