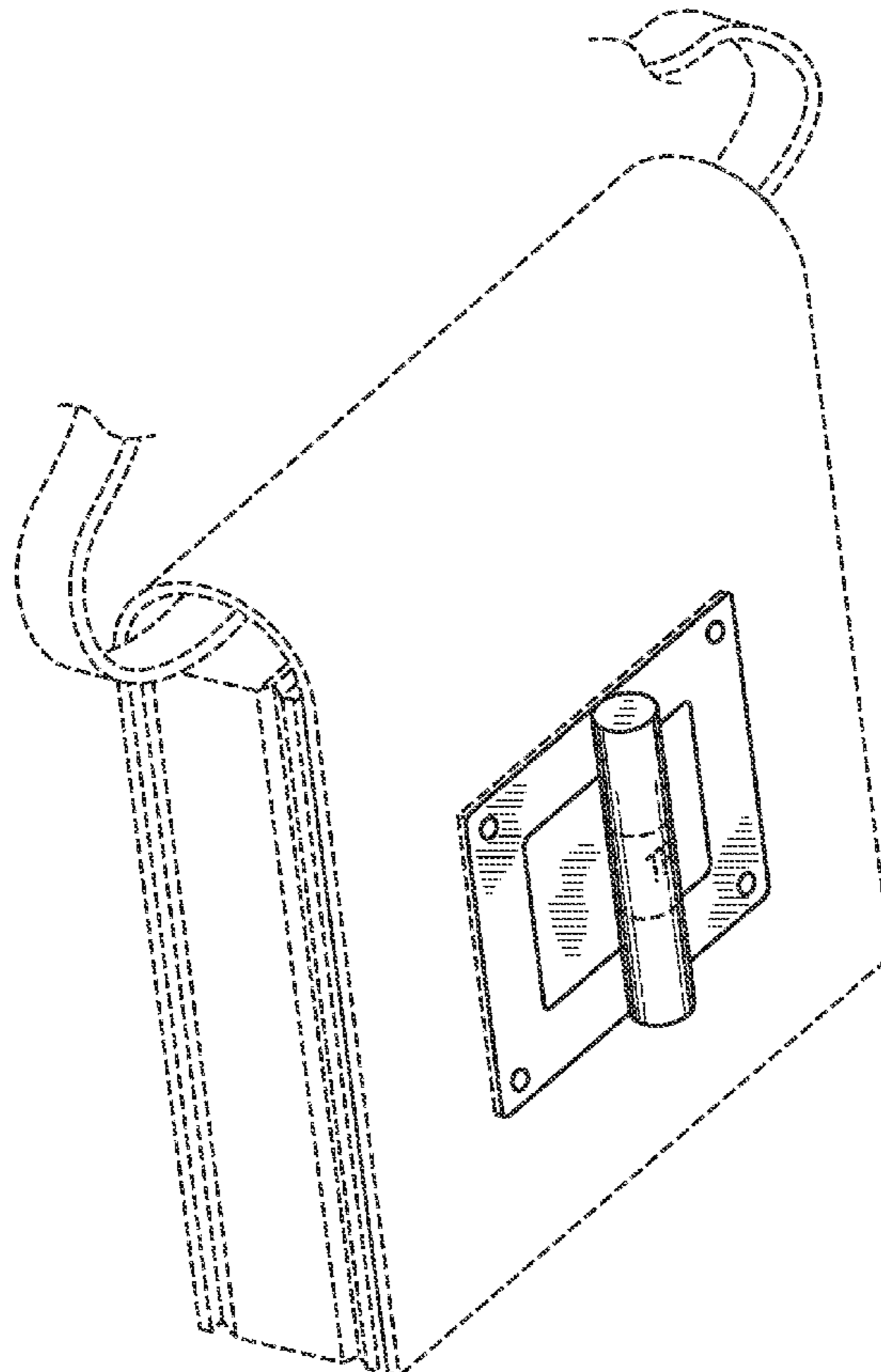
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a handbag with clasp in a first position;
 FIG. 2 is a front view of the handbag with clasp in the first position;

 FIG. 4 is a left side view of the handbag with clasp in the first position;

 FIG. 8 is a rear view of the handbag with clasp.

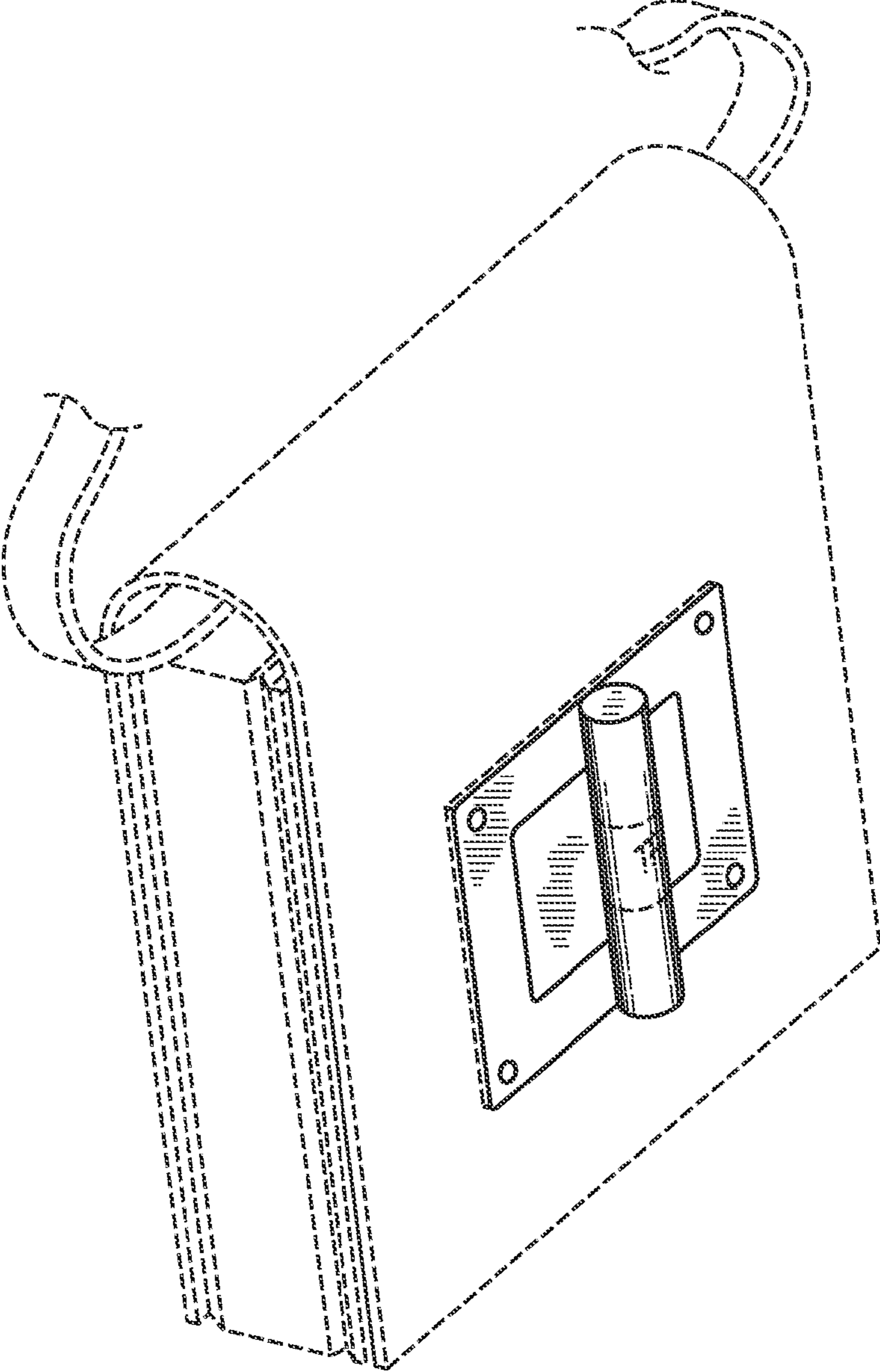

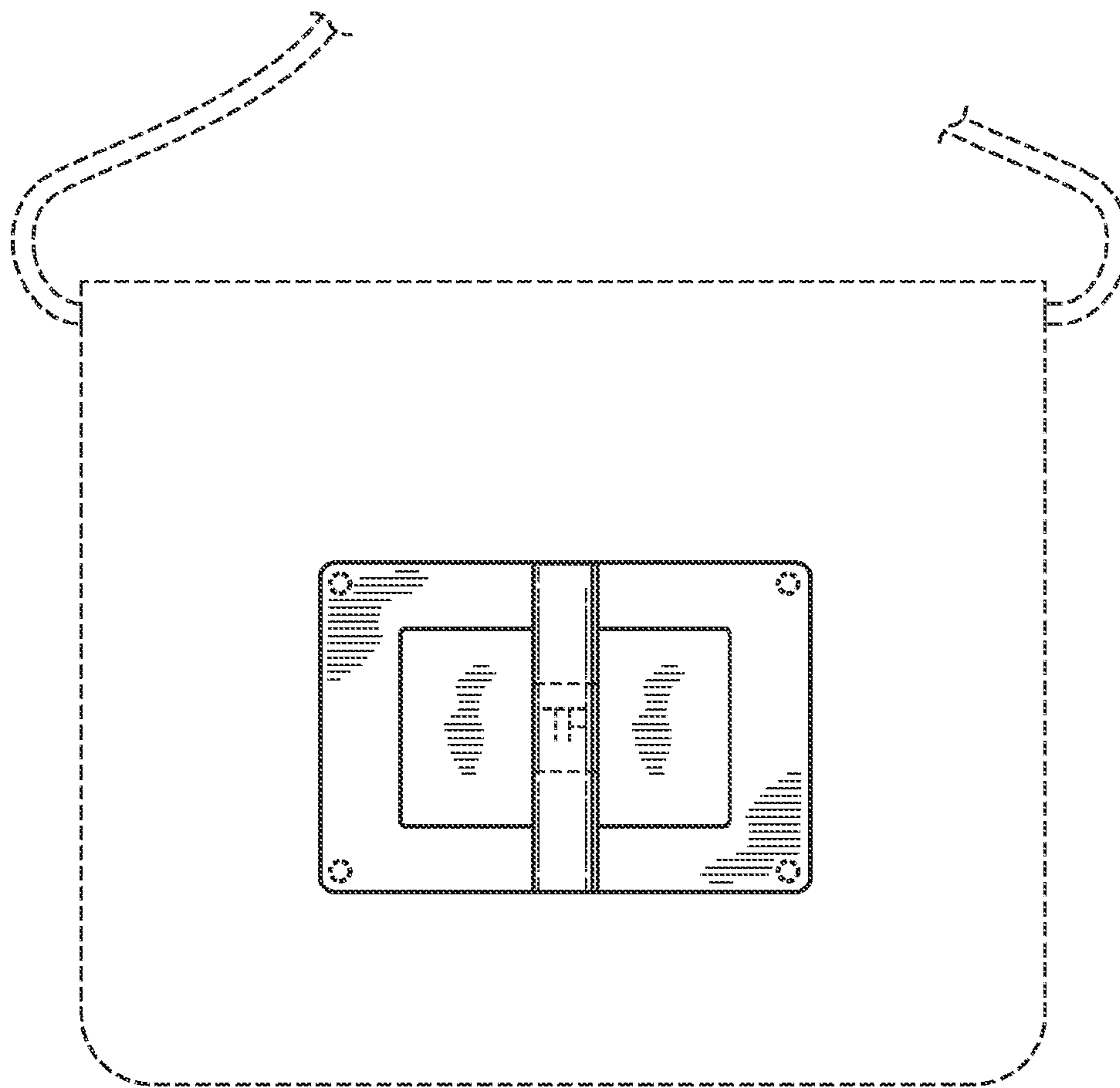

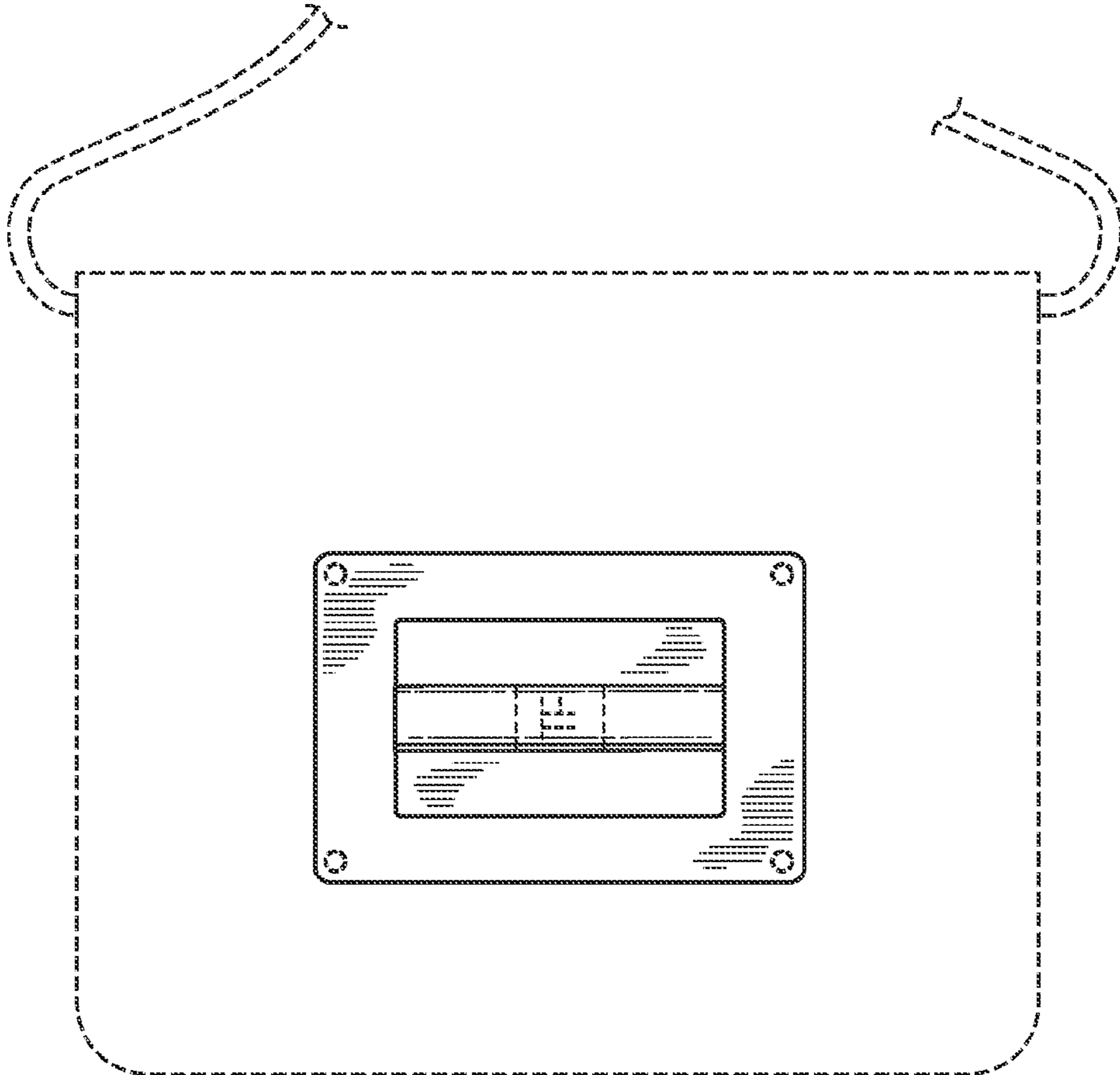

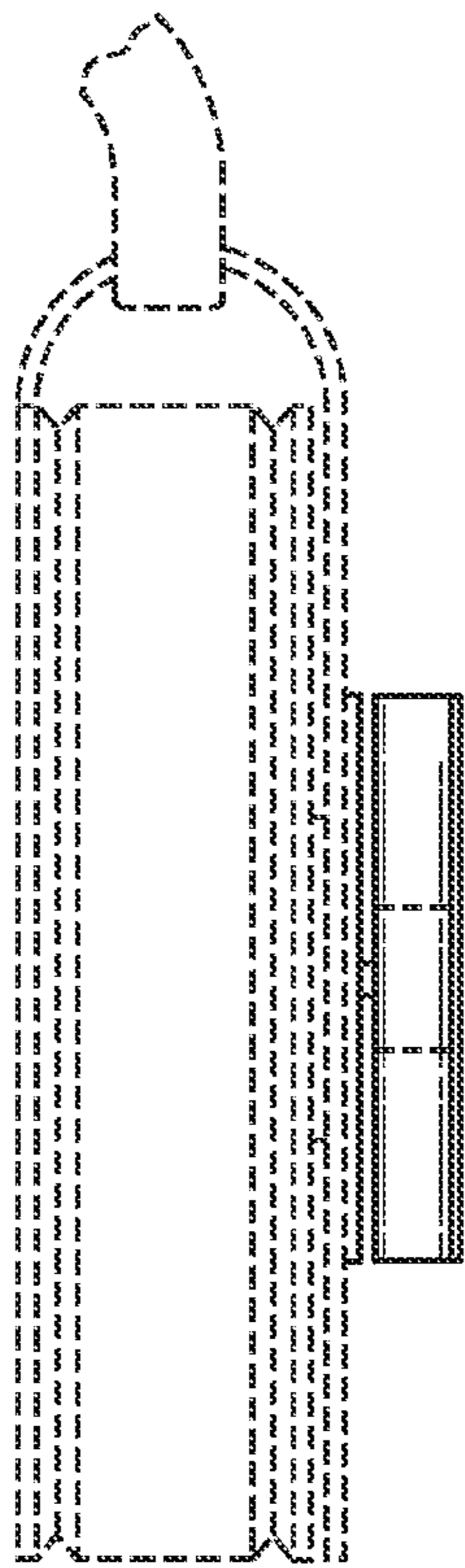

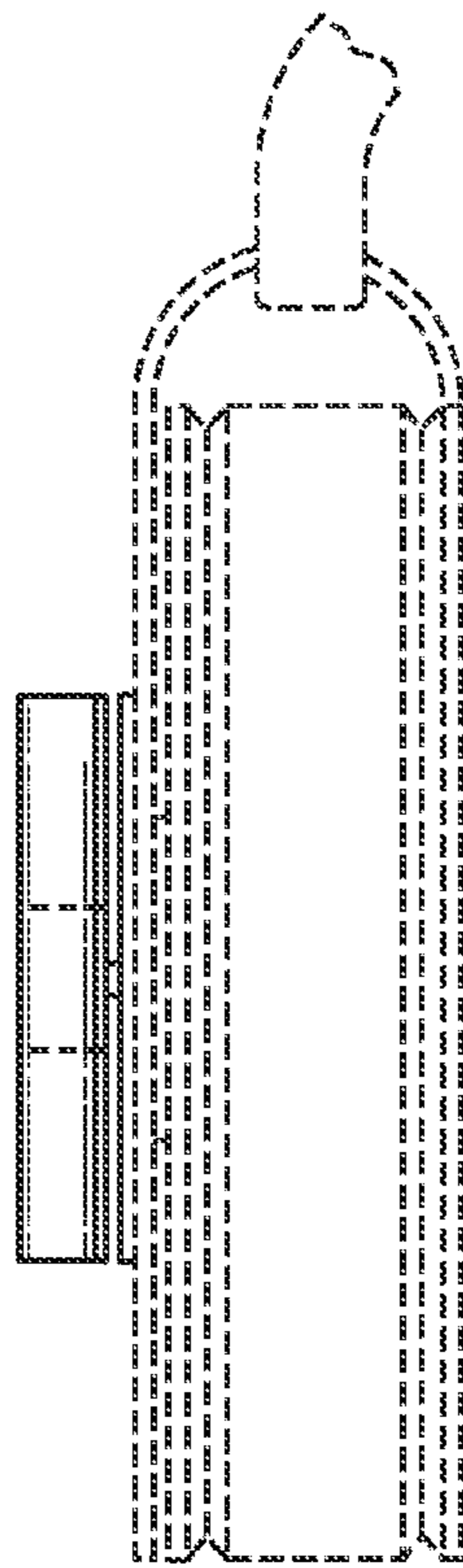

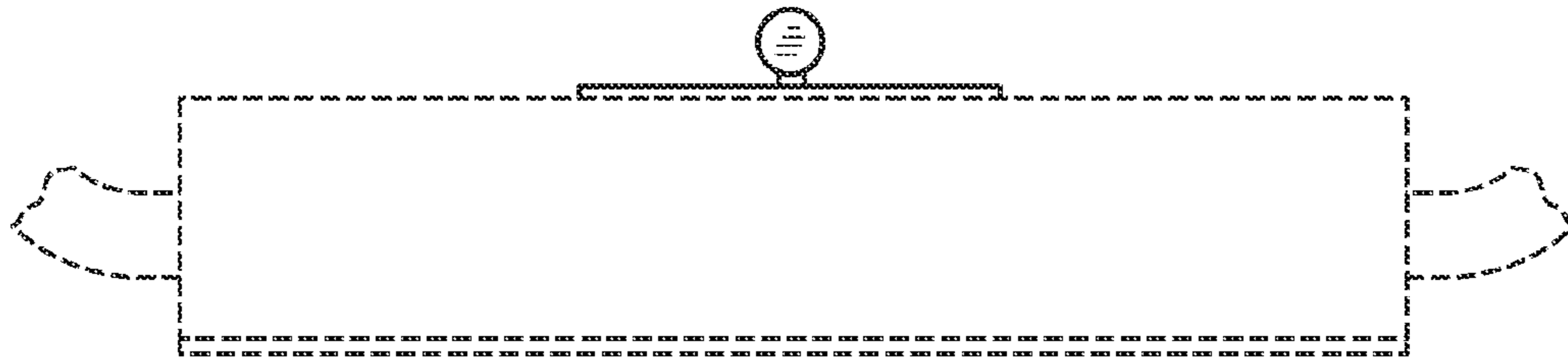

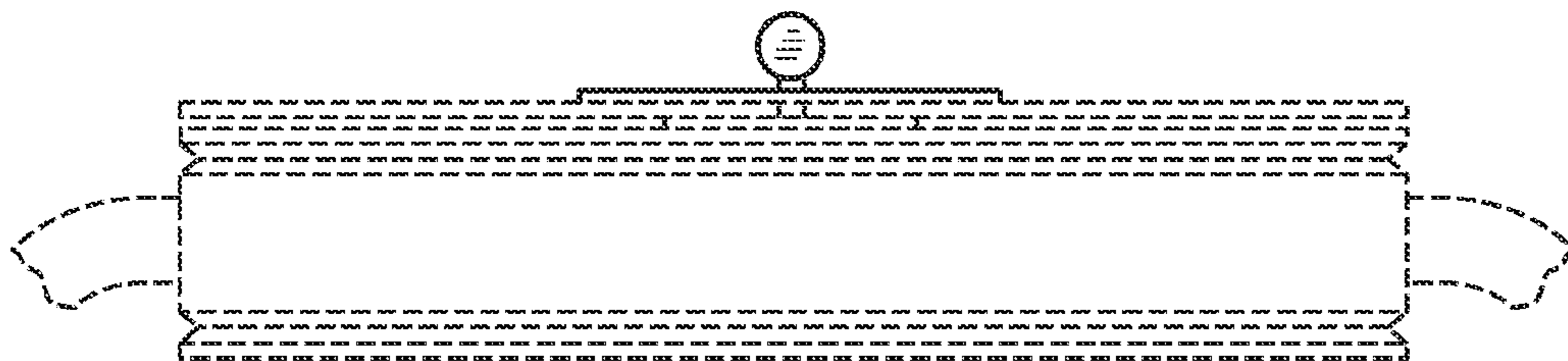

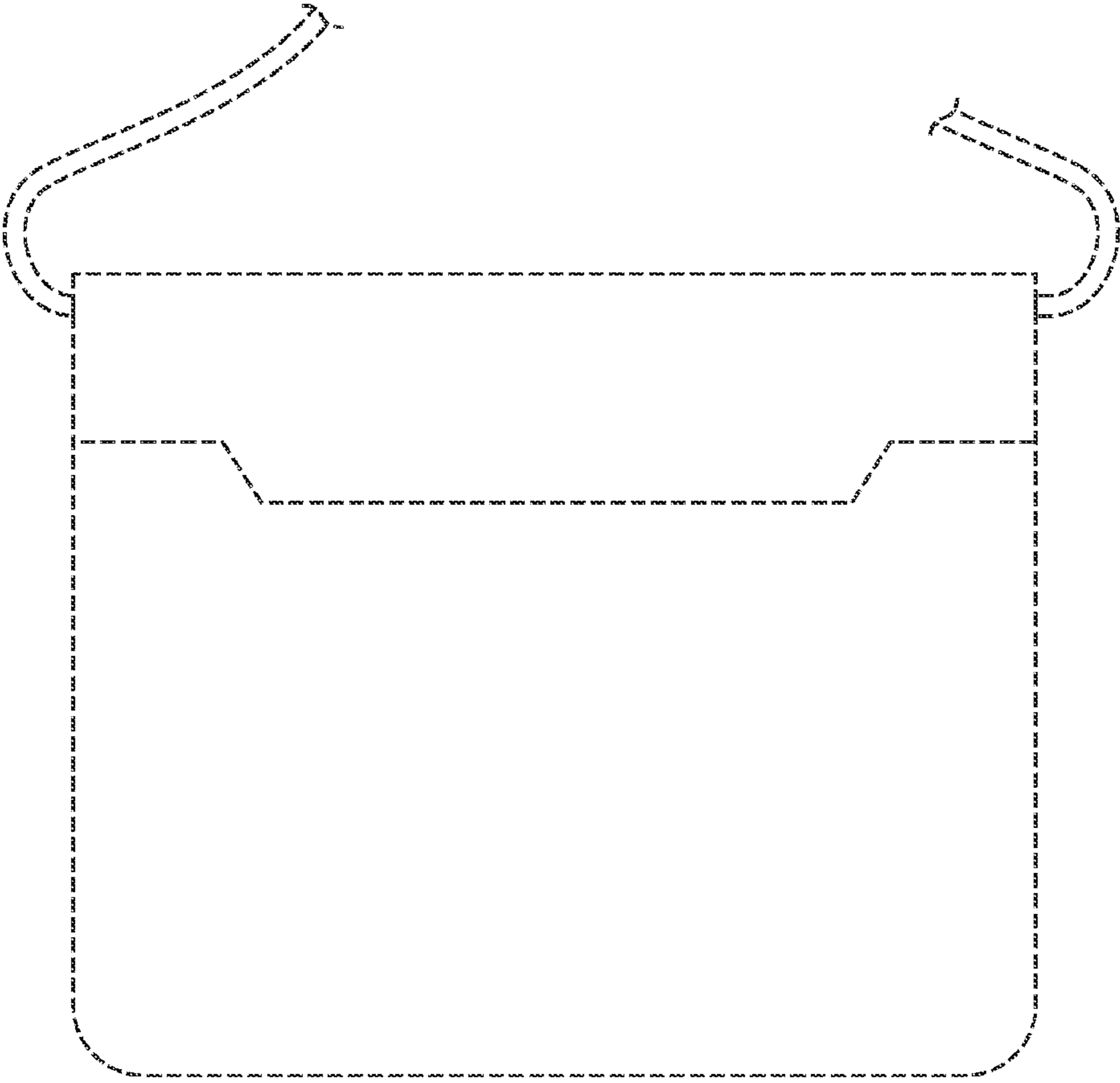
