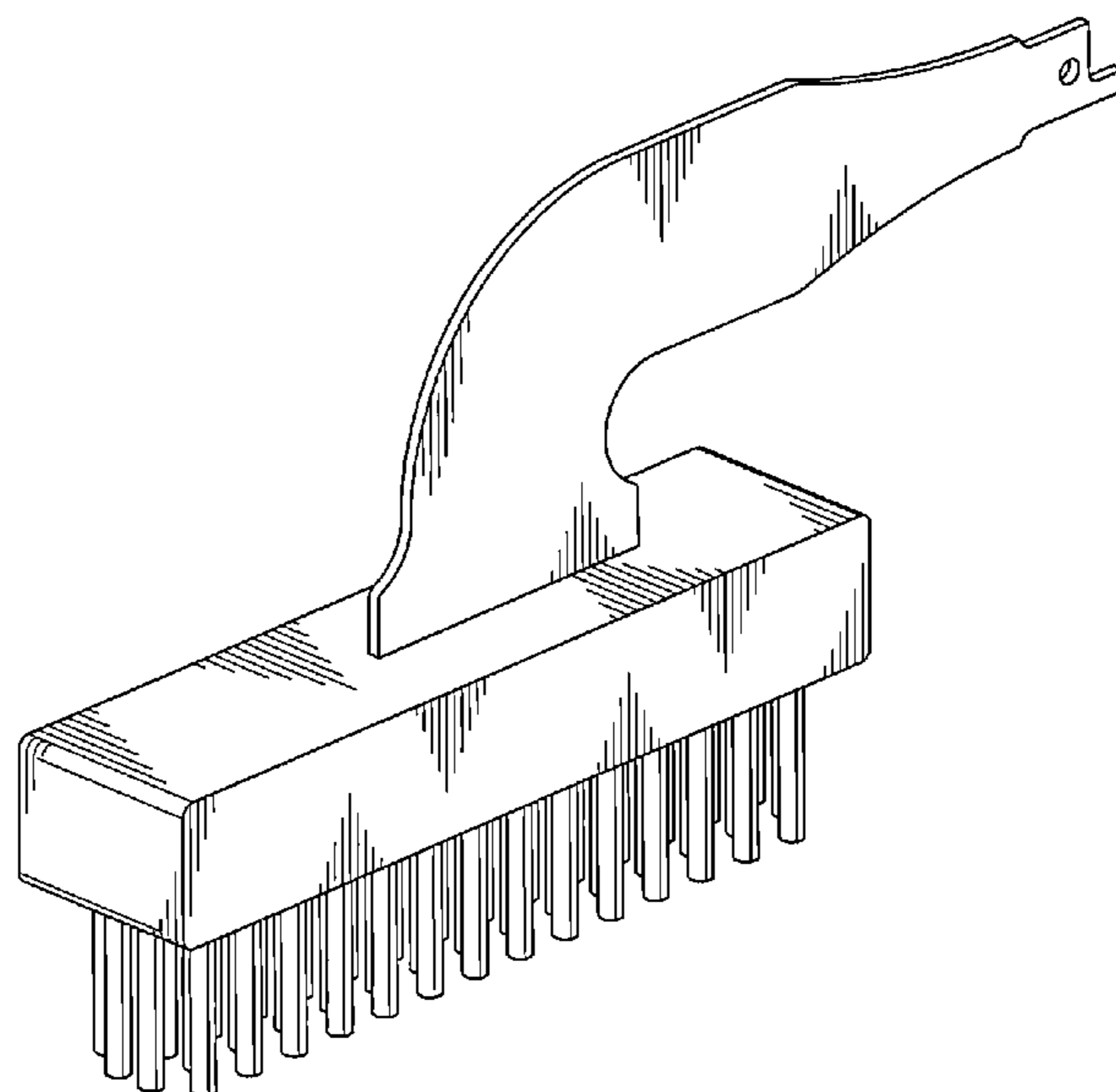
(57) **CLAIM**

The ornamental design for a brush, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the brush; FIG. 2 is a front elevational view of the brush of FIG. 1; FIG. 3 is a rear elevational view of the brush of FIG. 1; FIG. 4 is a top plan view of the brush of FIG. 1; FIG. 5 is a bottom plan view of the brush of FIG. 1; and, FIG. 6 is a left side elevational view of the brush of FIG. 1. The right side view of the brush is symmetrical to the view shown in FIG. 6.

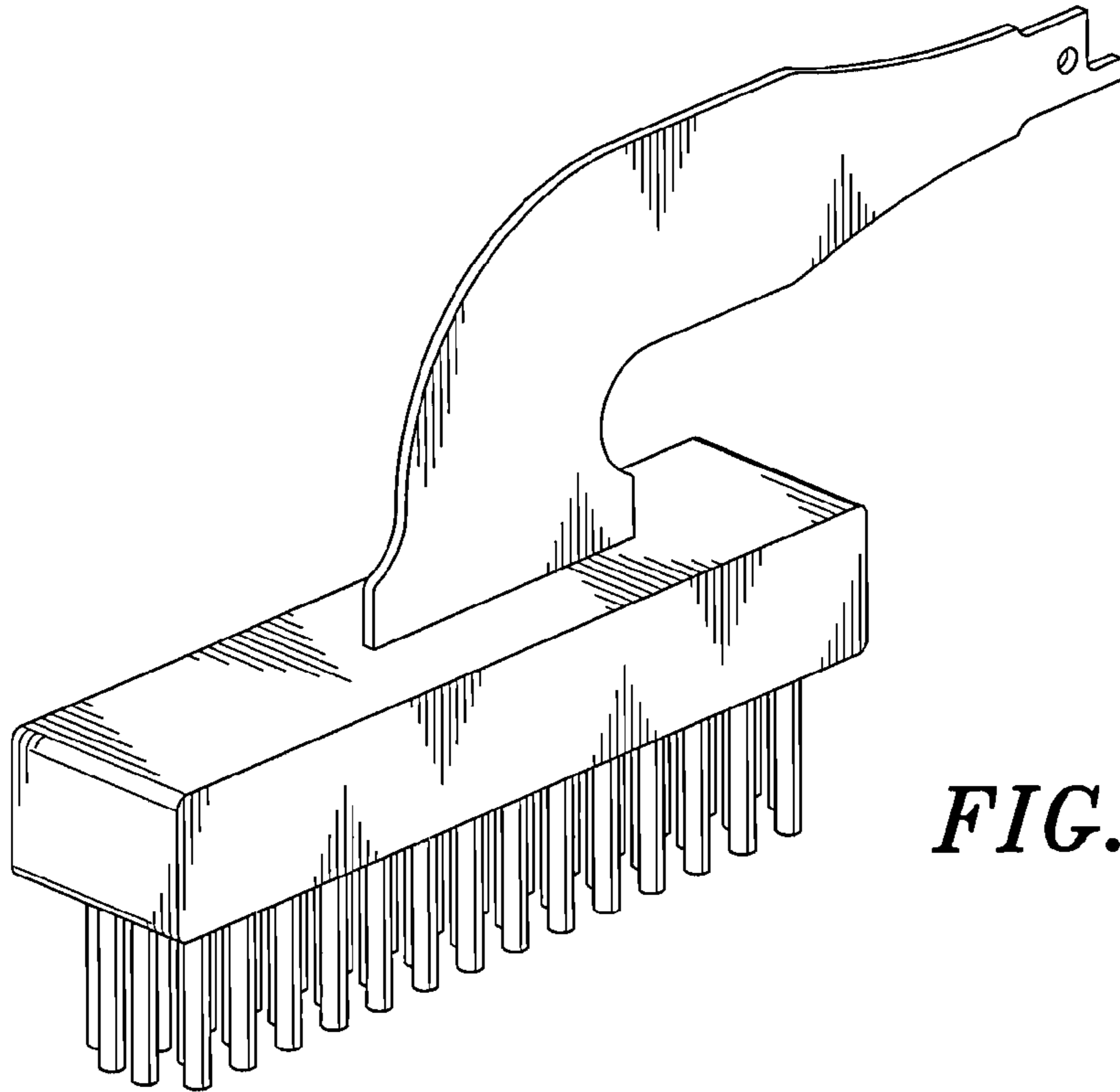

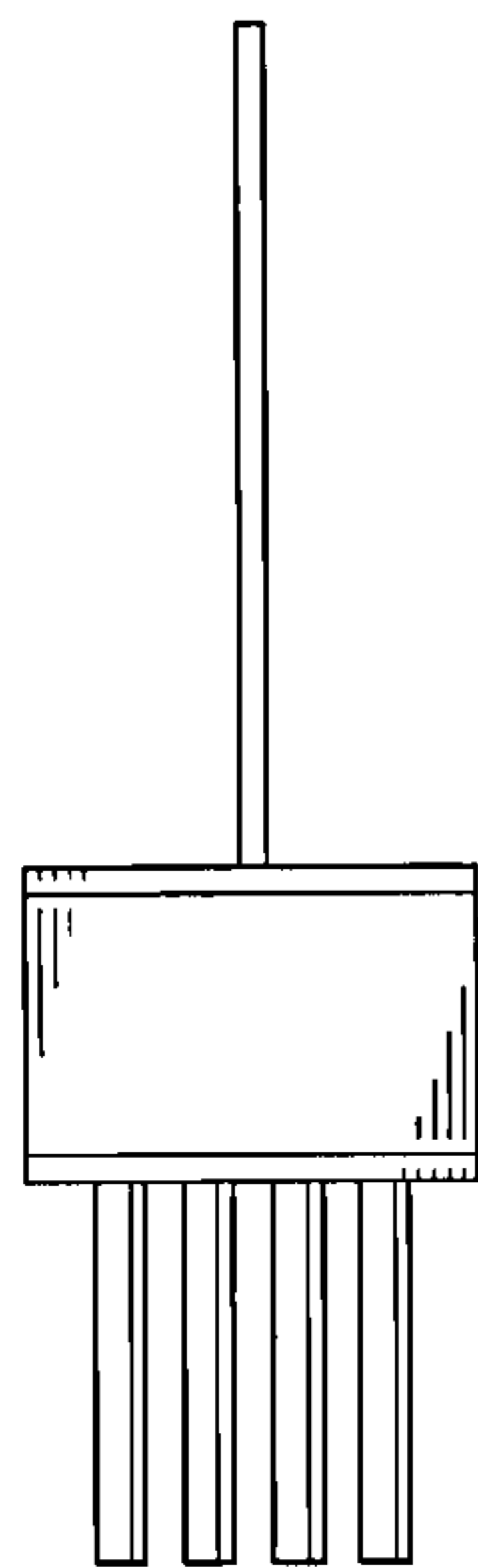

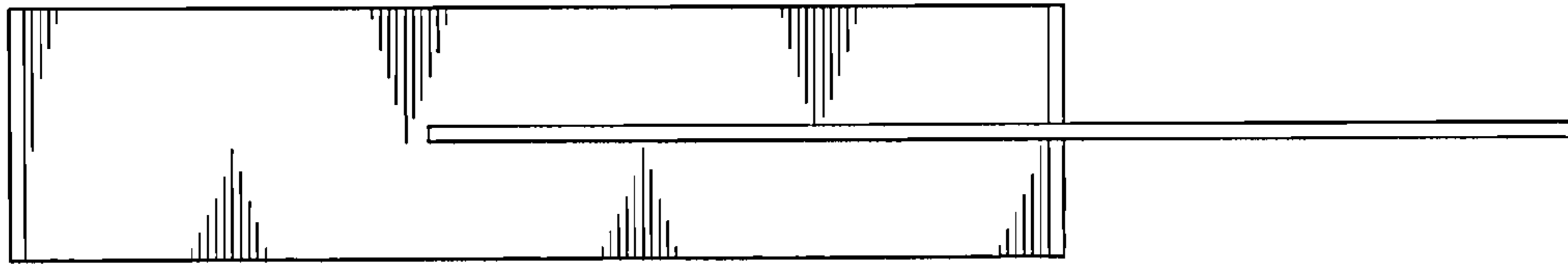

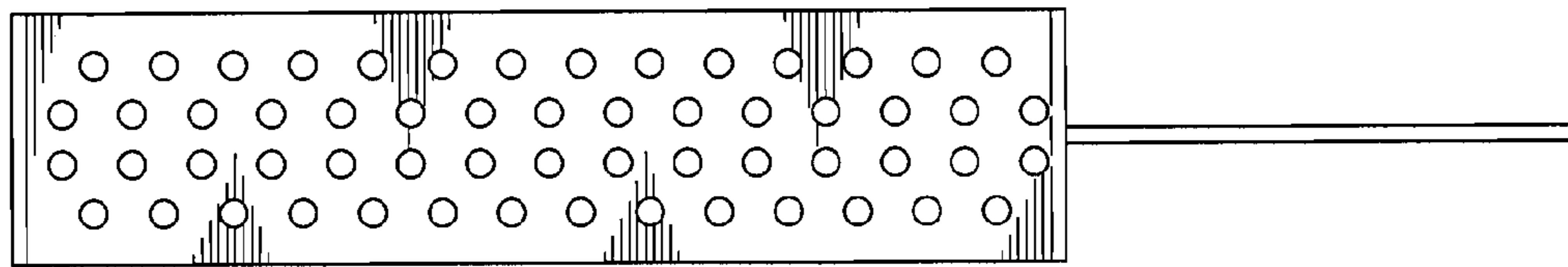

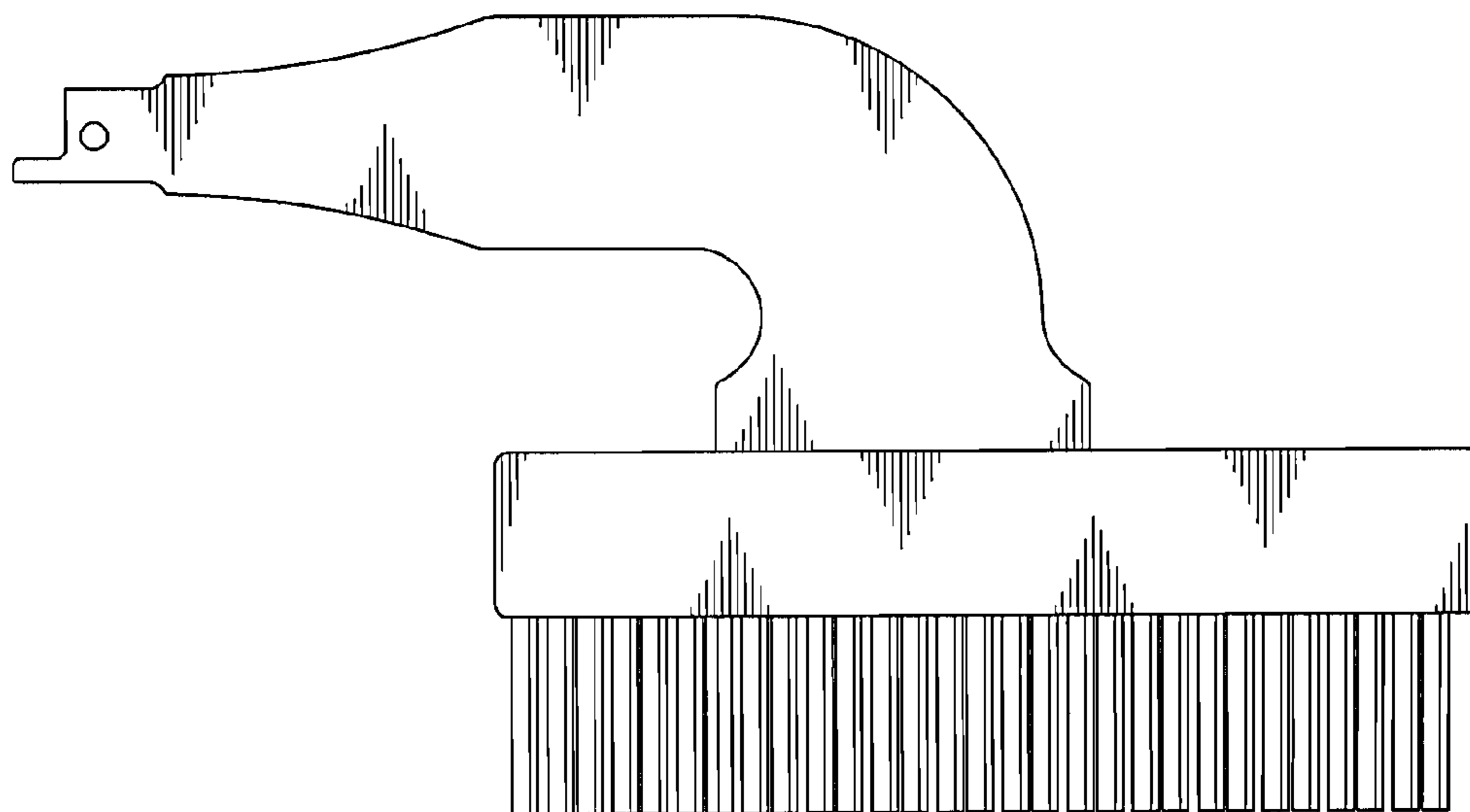
