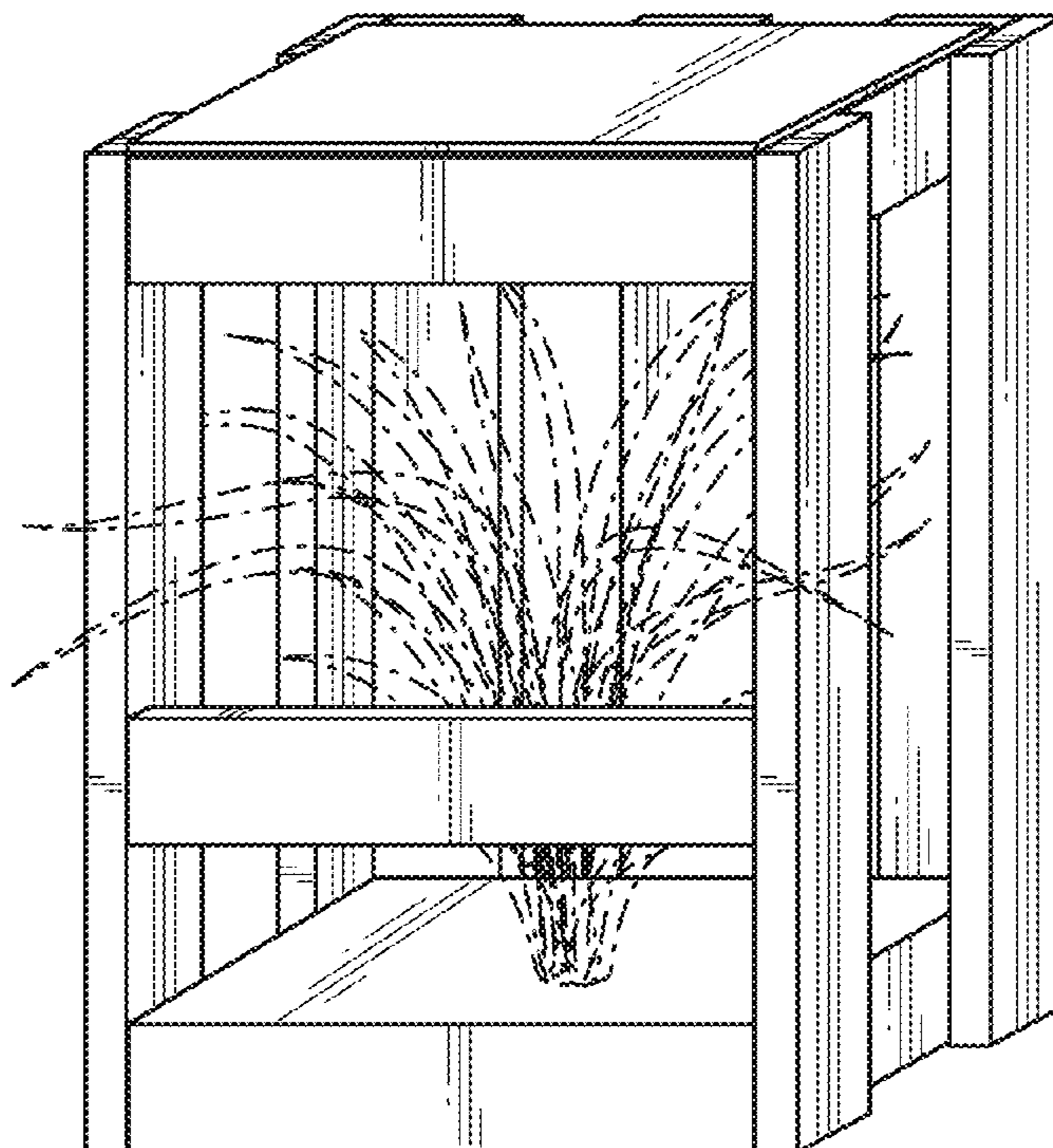
(57) **CLAIM**

The ornamental design for a plant storage crate, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of an ornamental design for a plant storage crate;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is top plan view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a right side elevation view thereof; and,
FIG. 7 is a left side elevation view thereof.

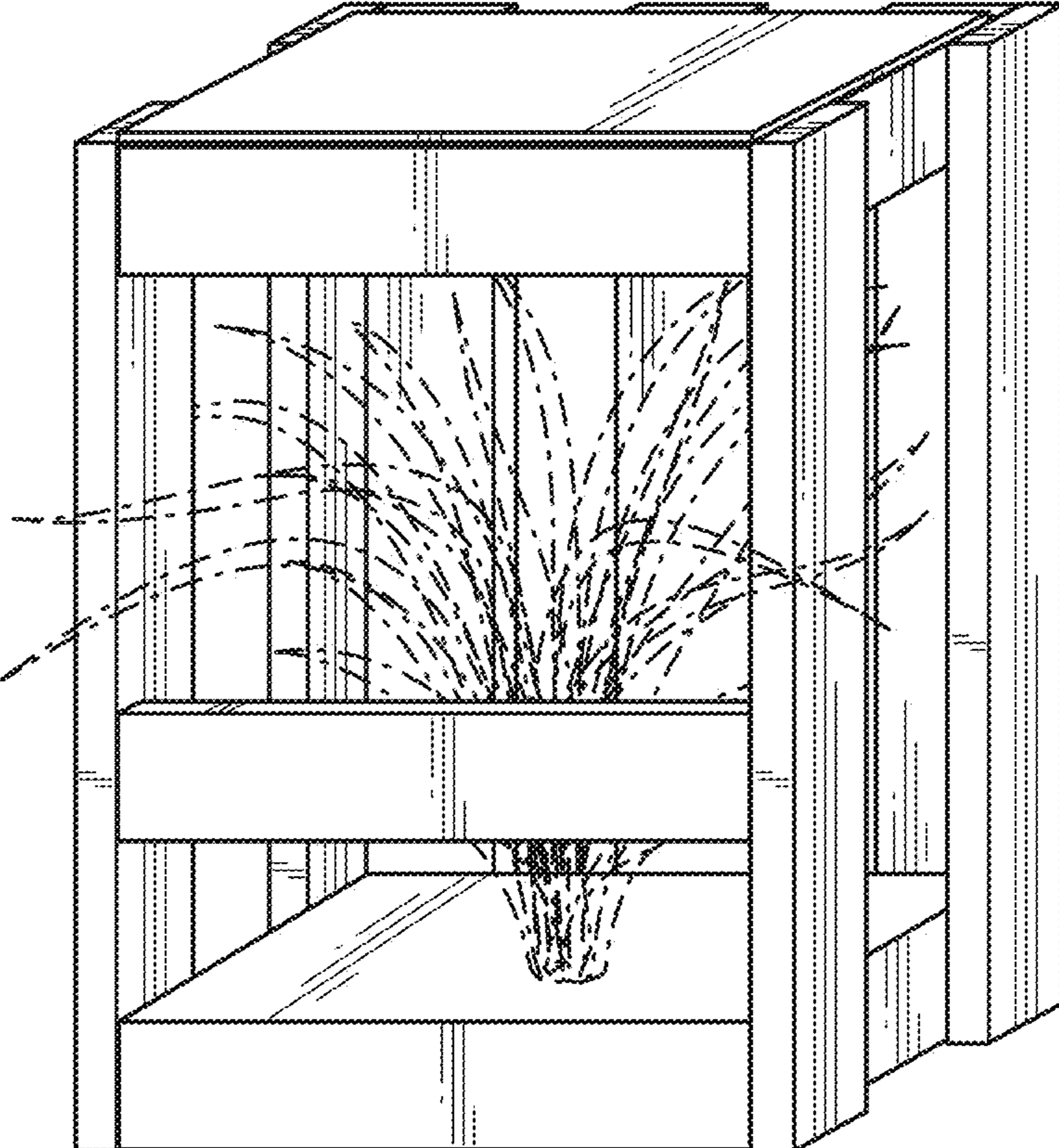

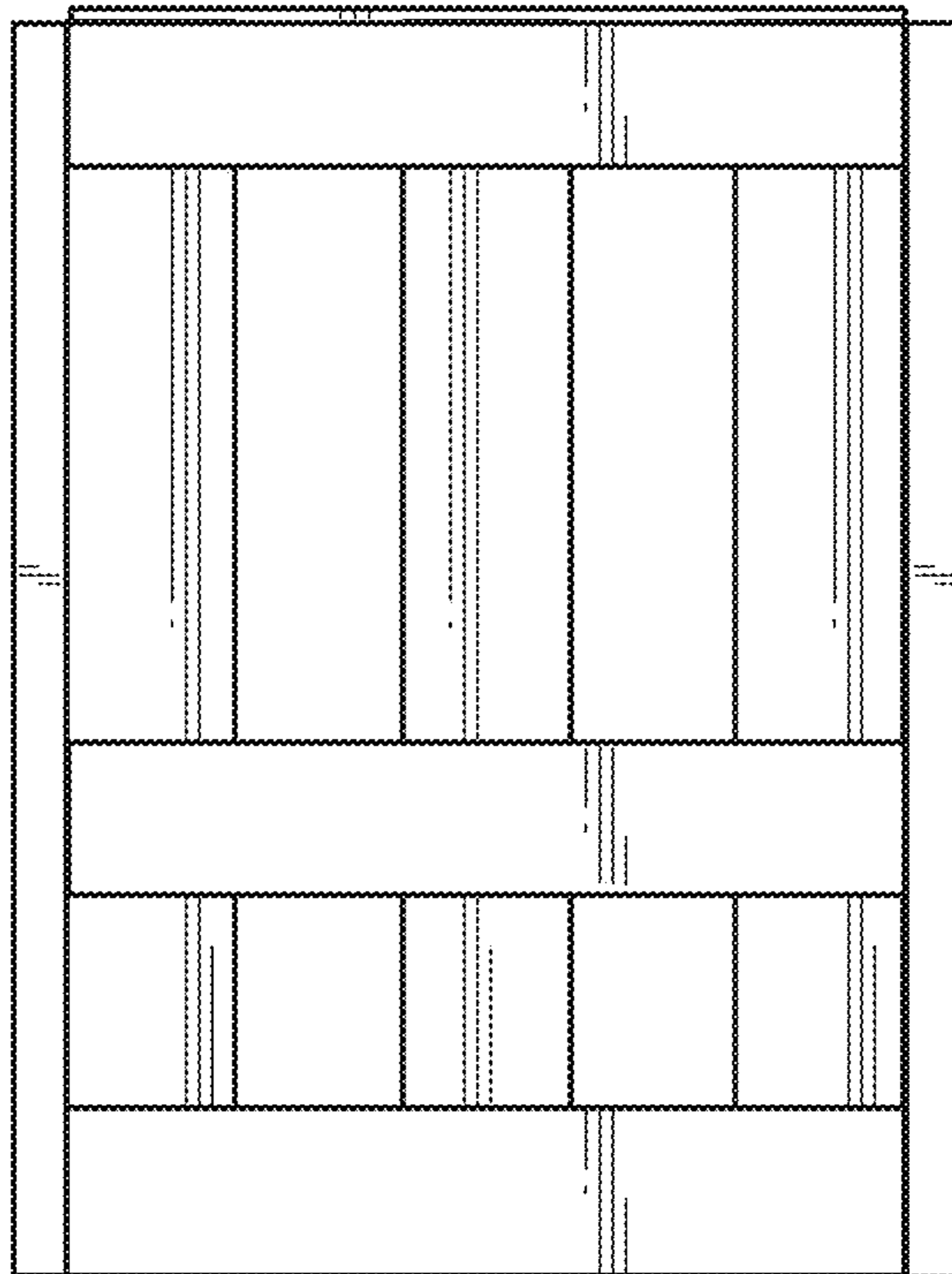

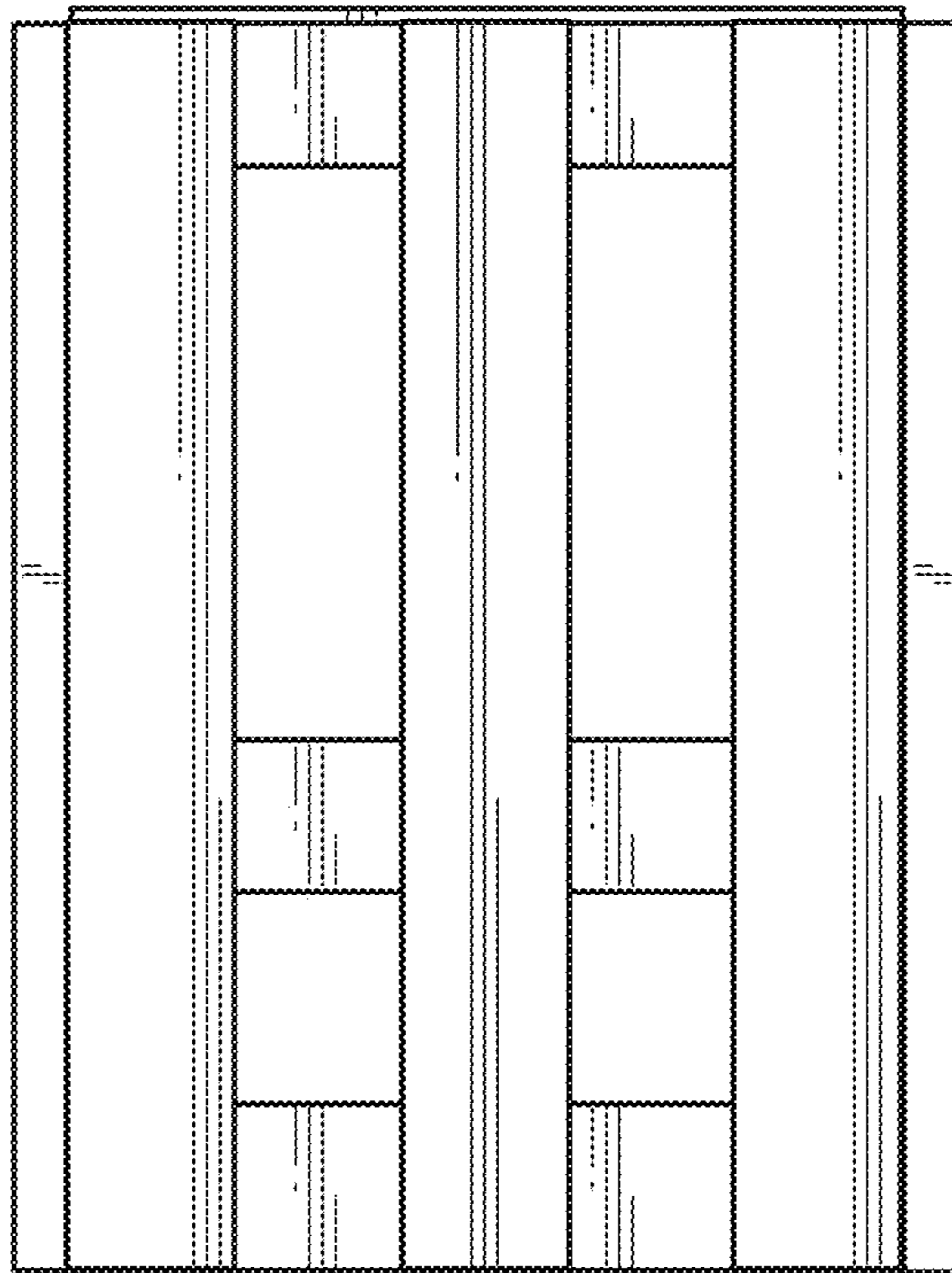

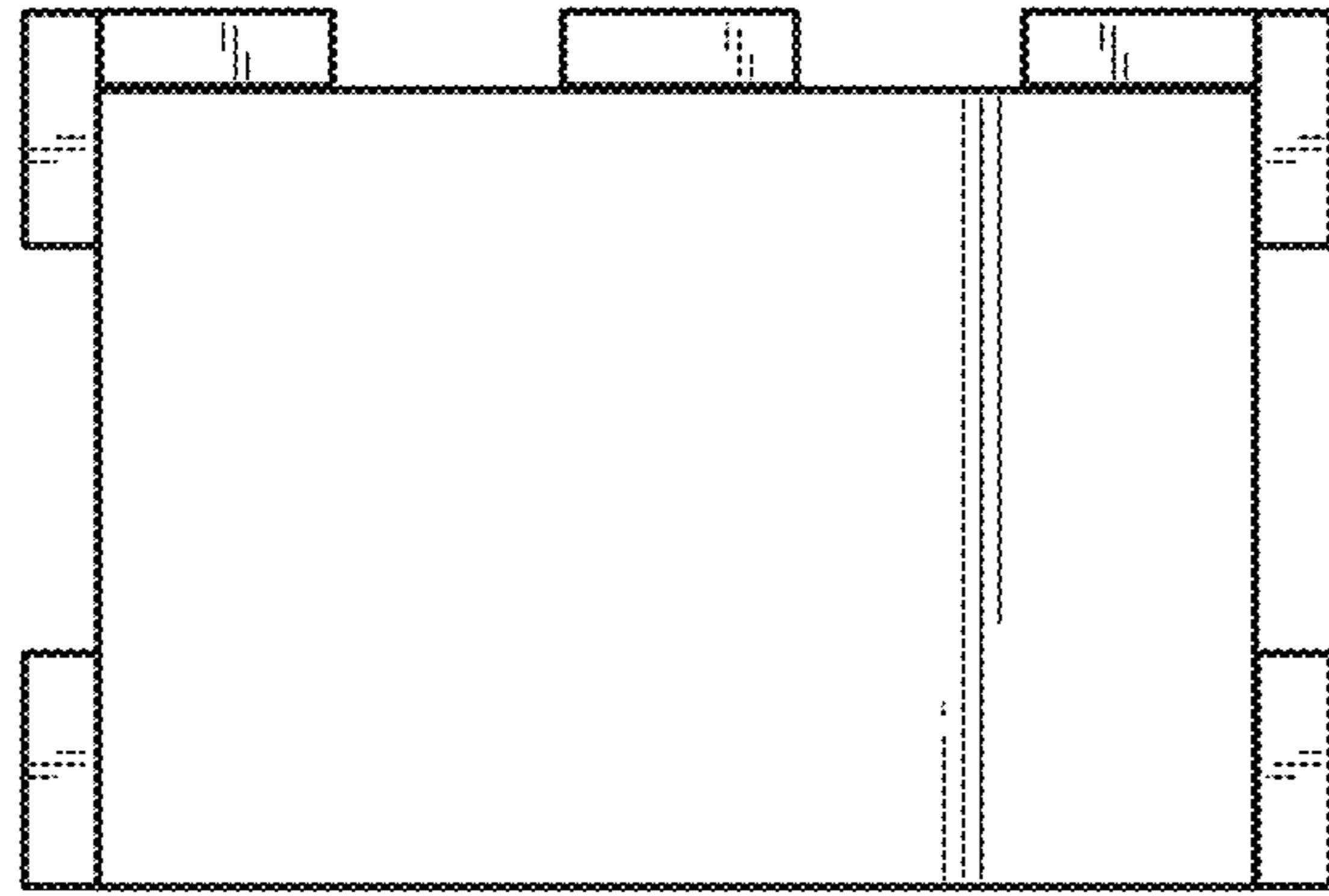

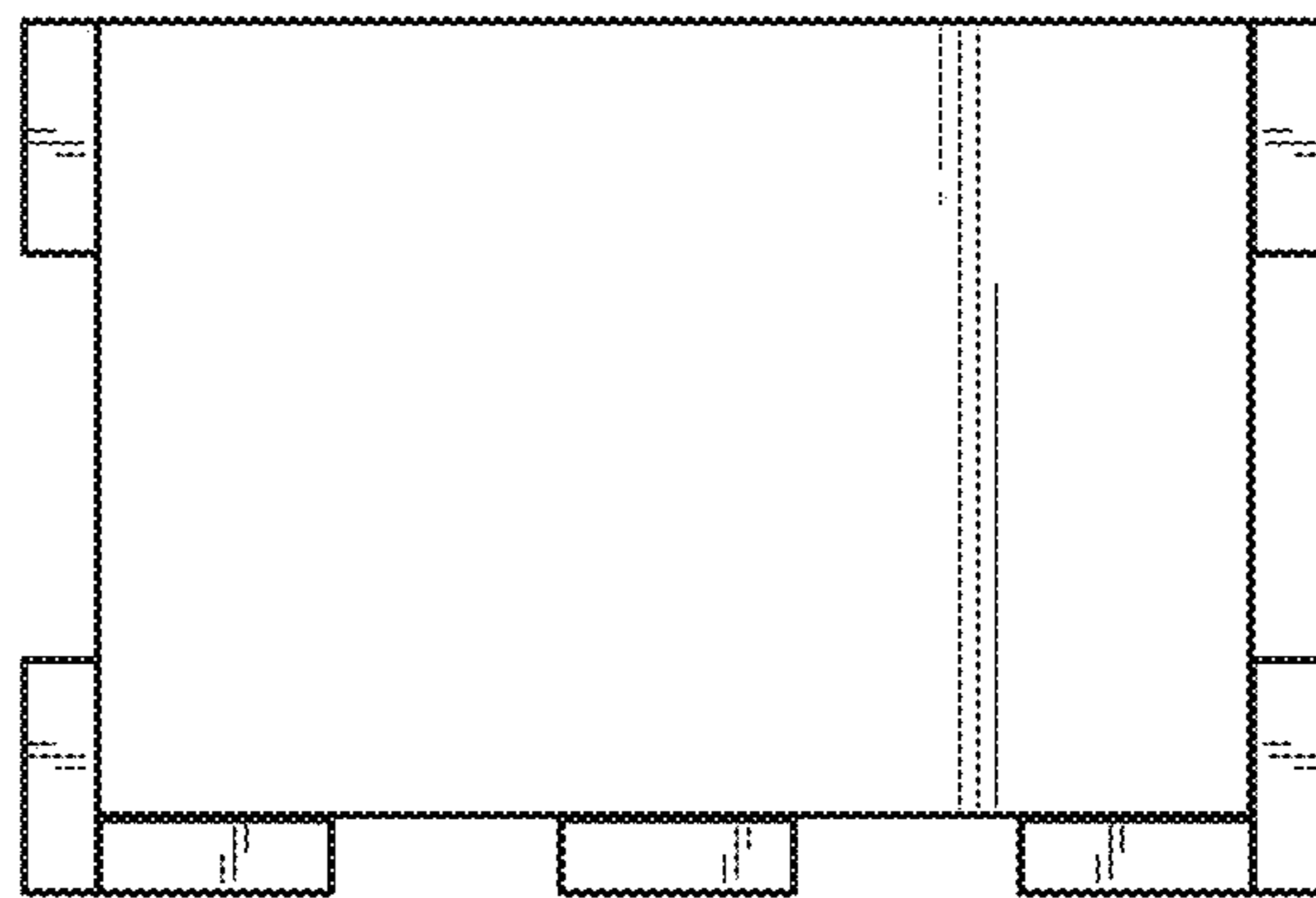

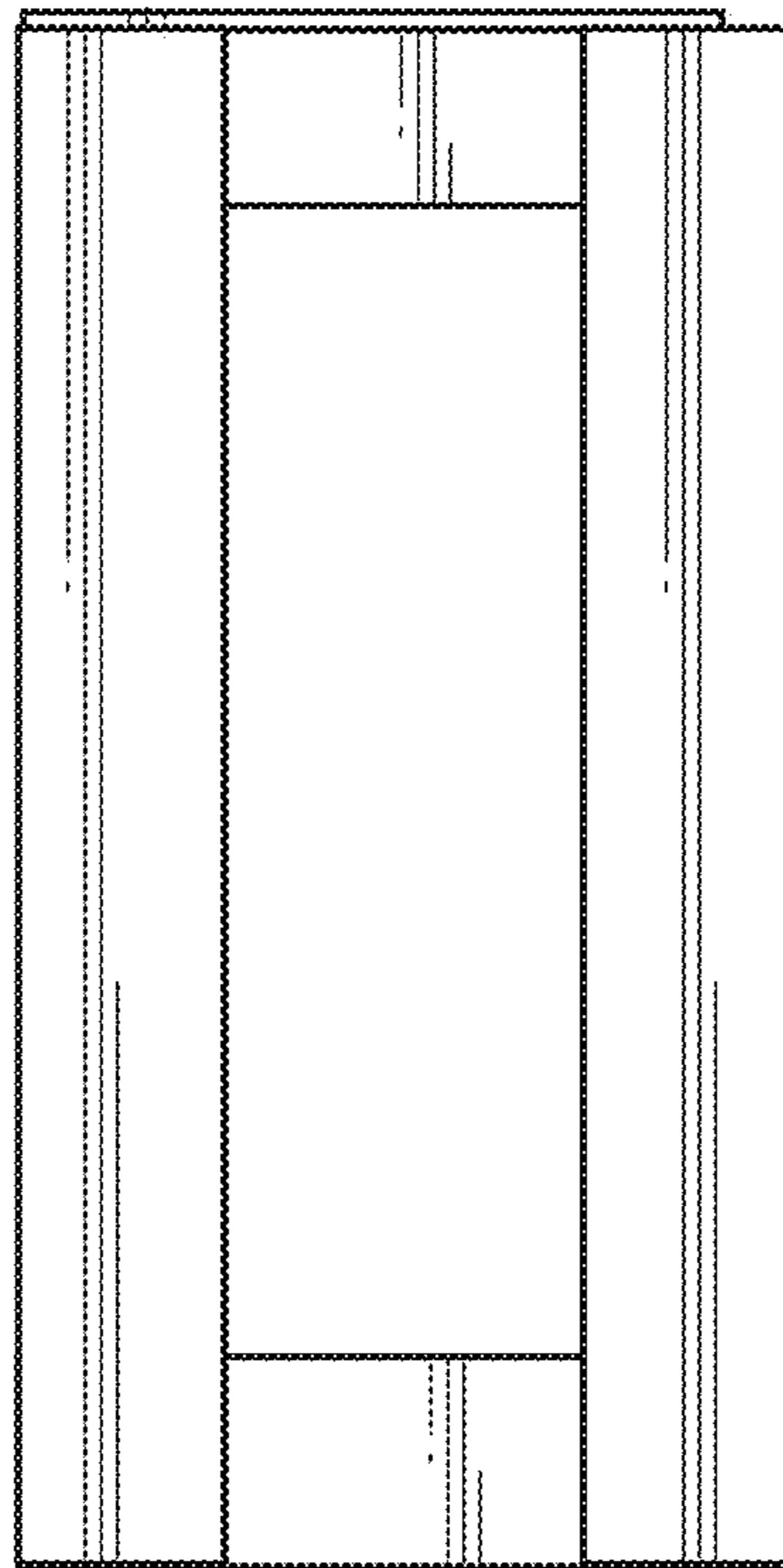

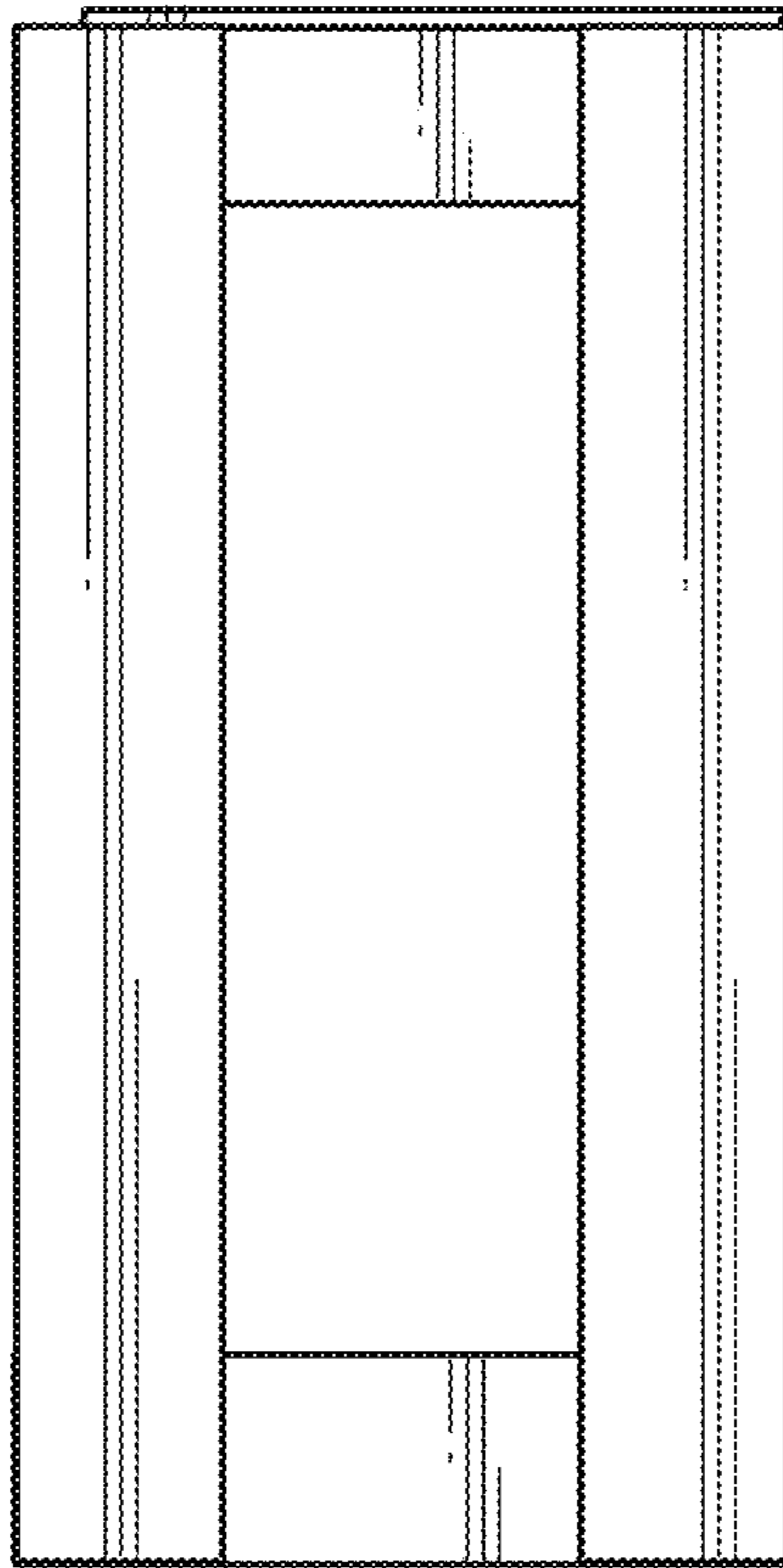
