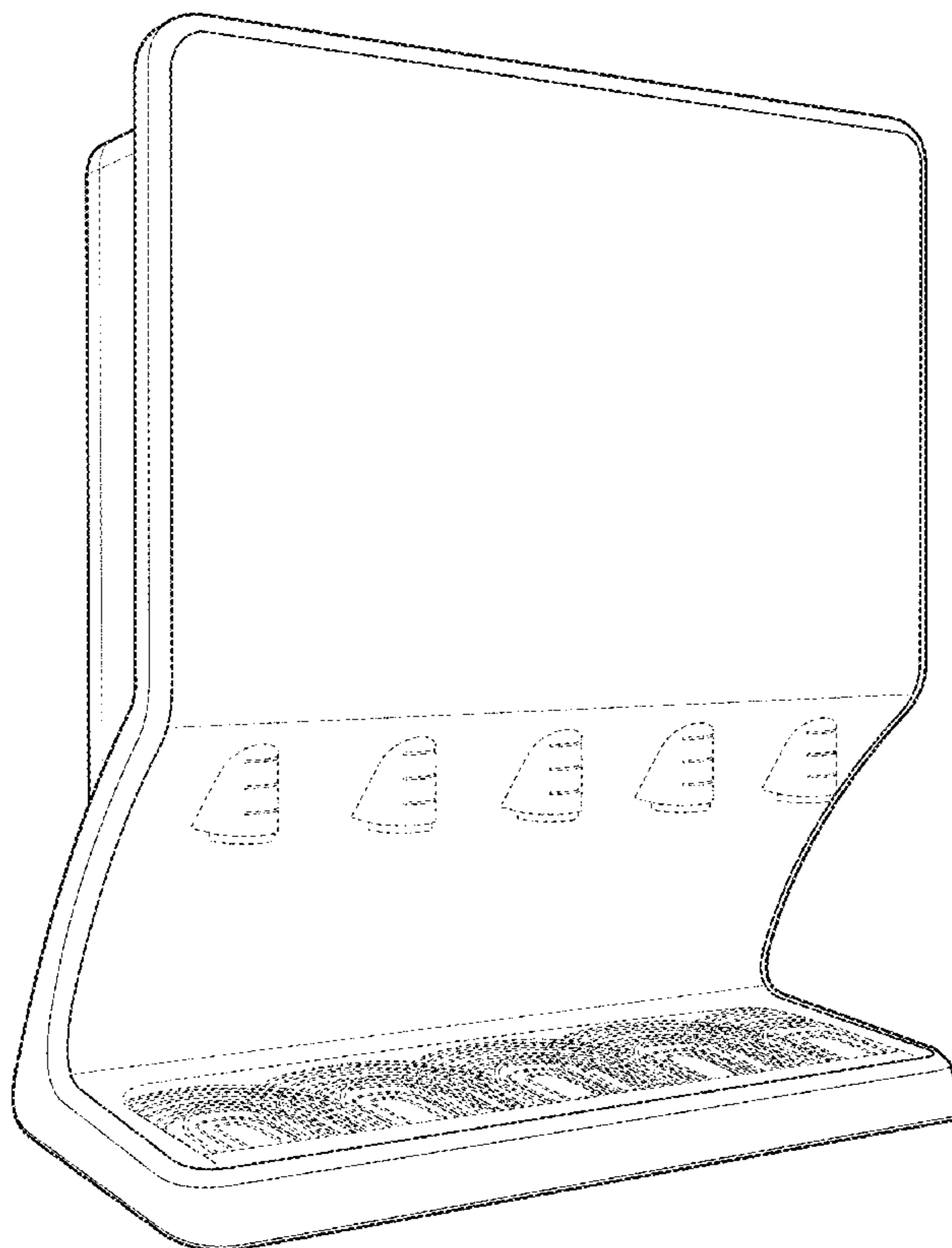
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front left perspective view of a beverage dispenser  
showing our new design;  
FIG. 2 is a right side elevational view thereof;

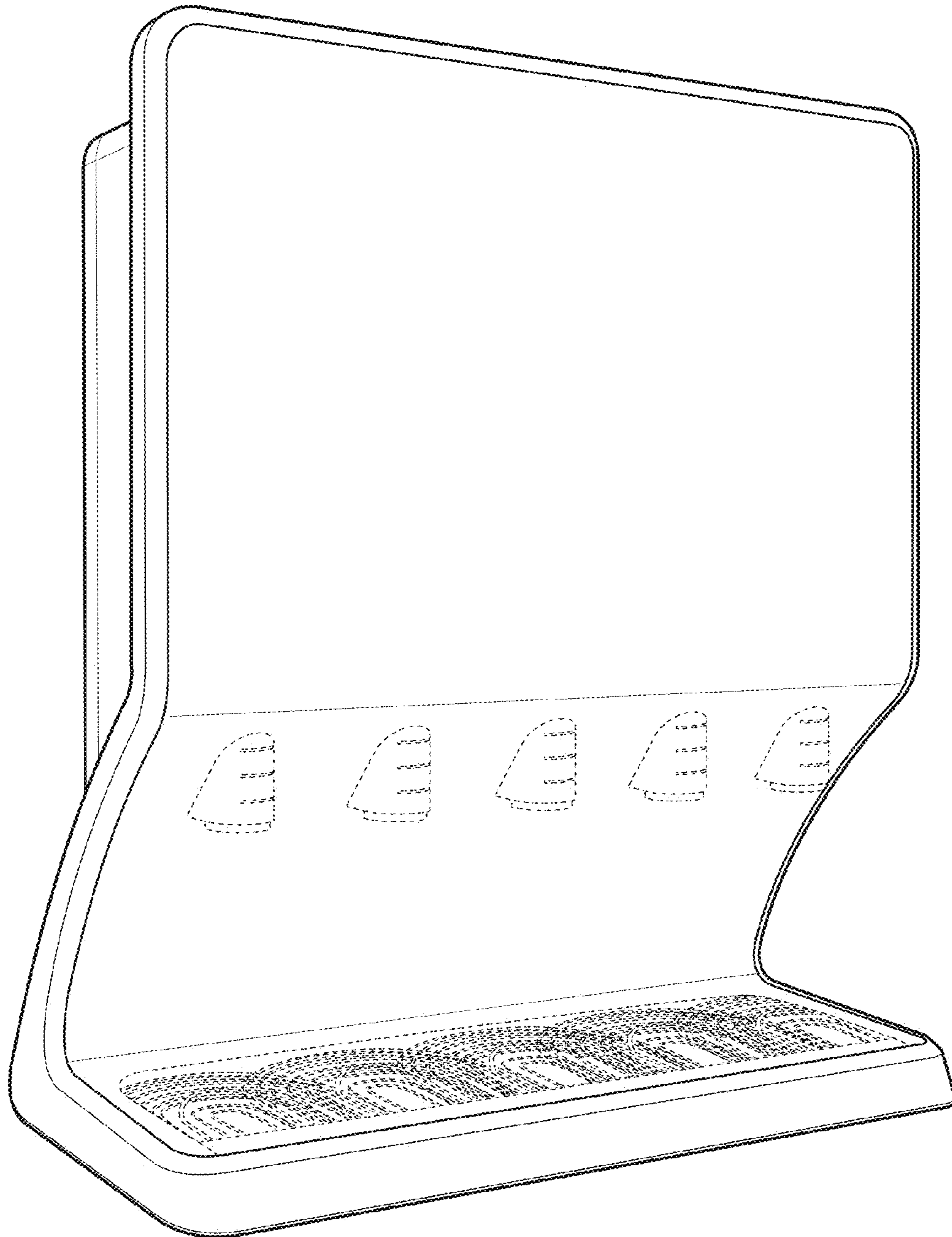

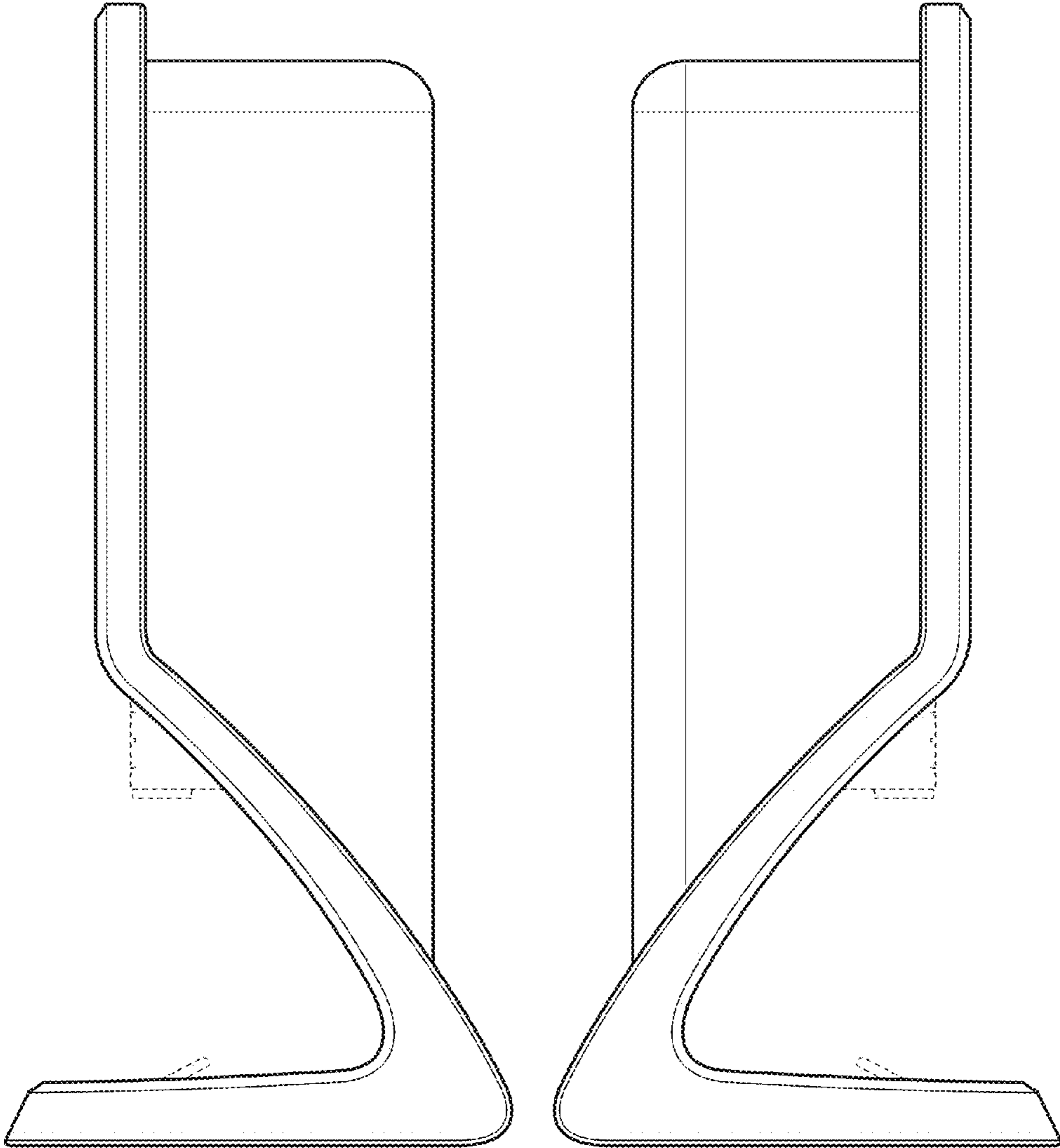

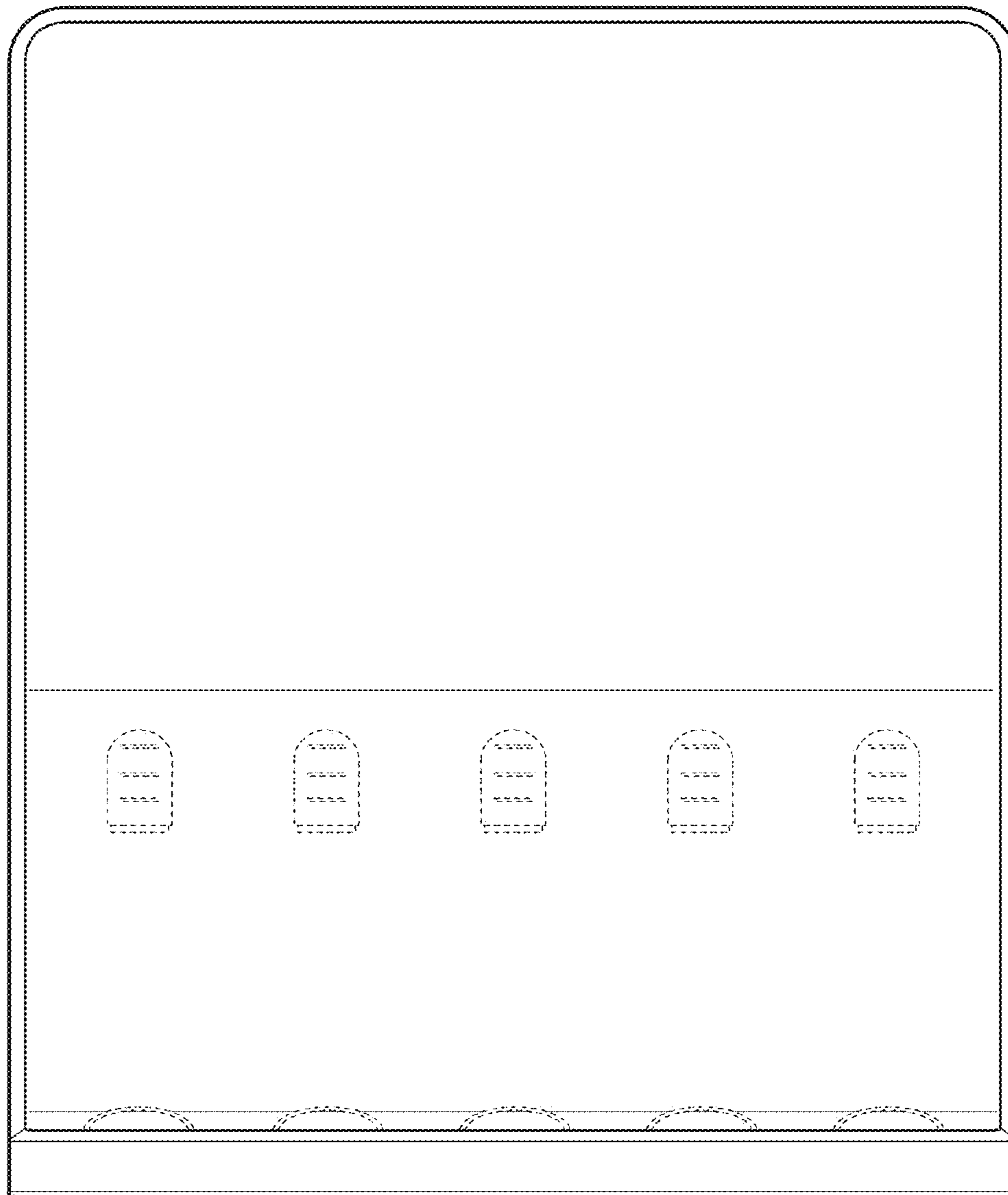

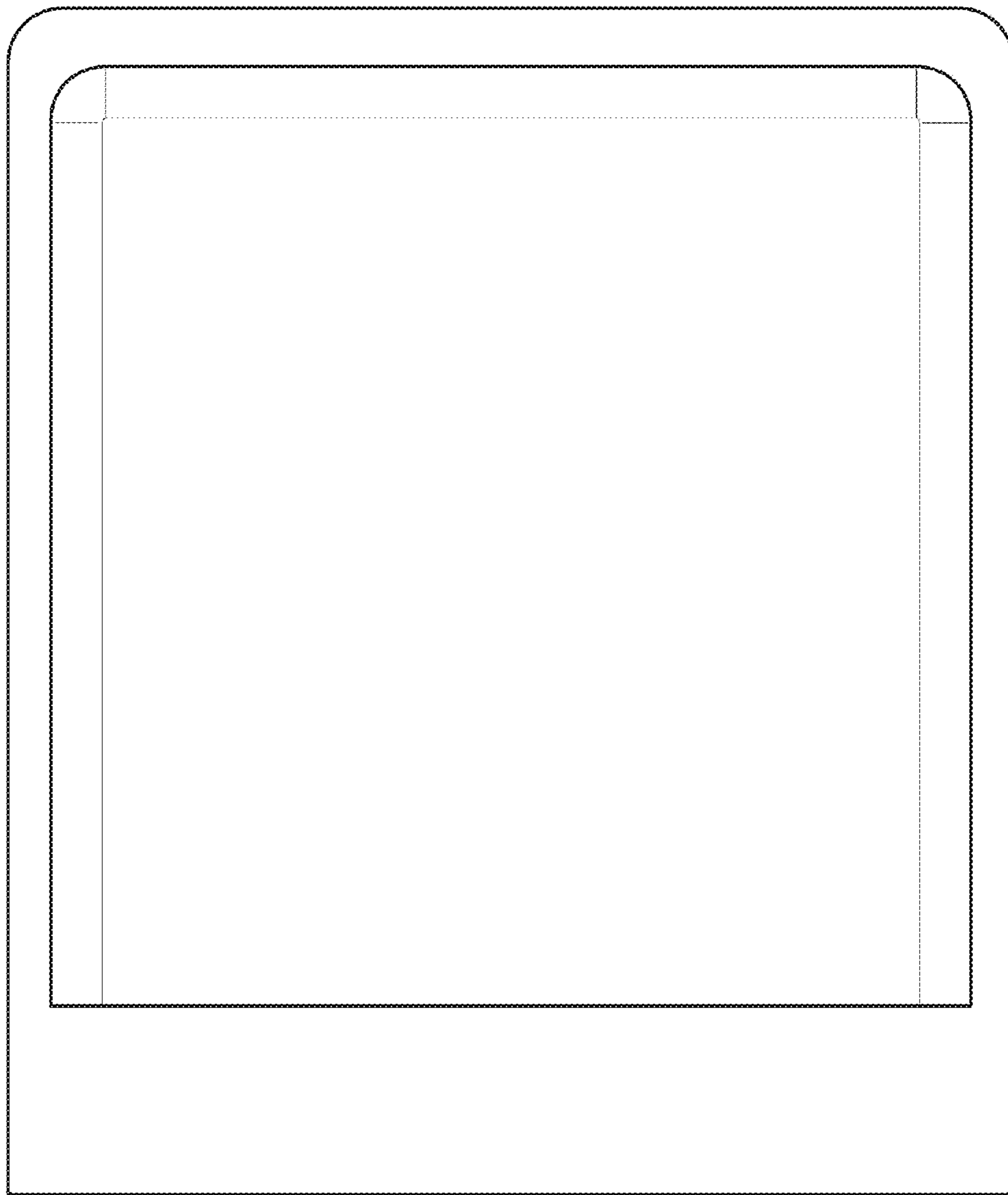

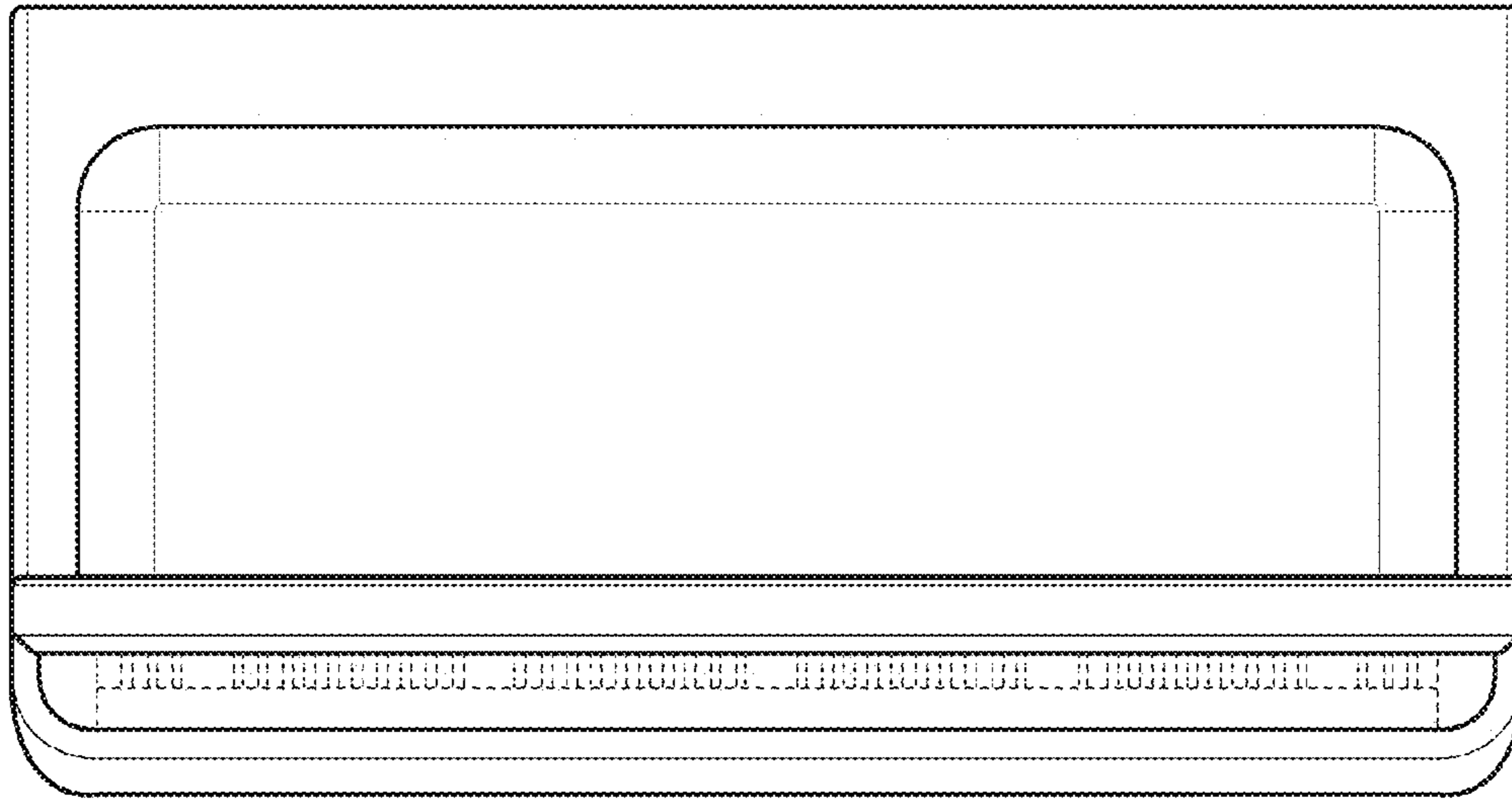

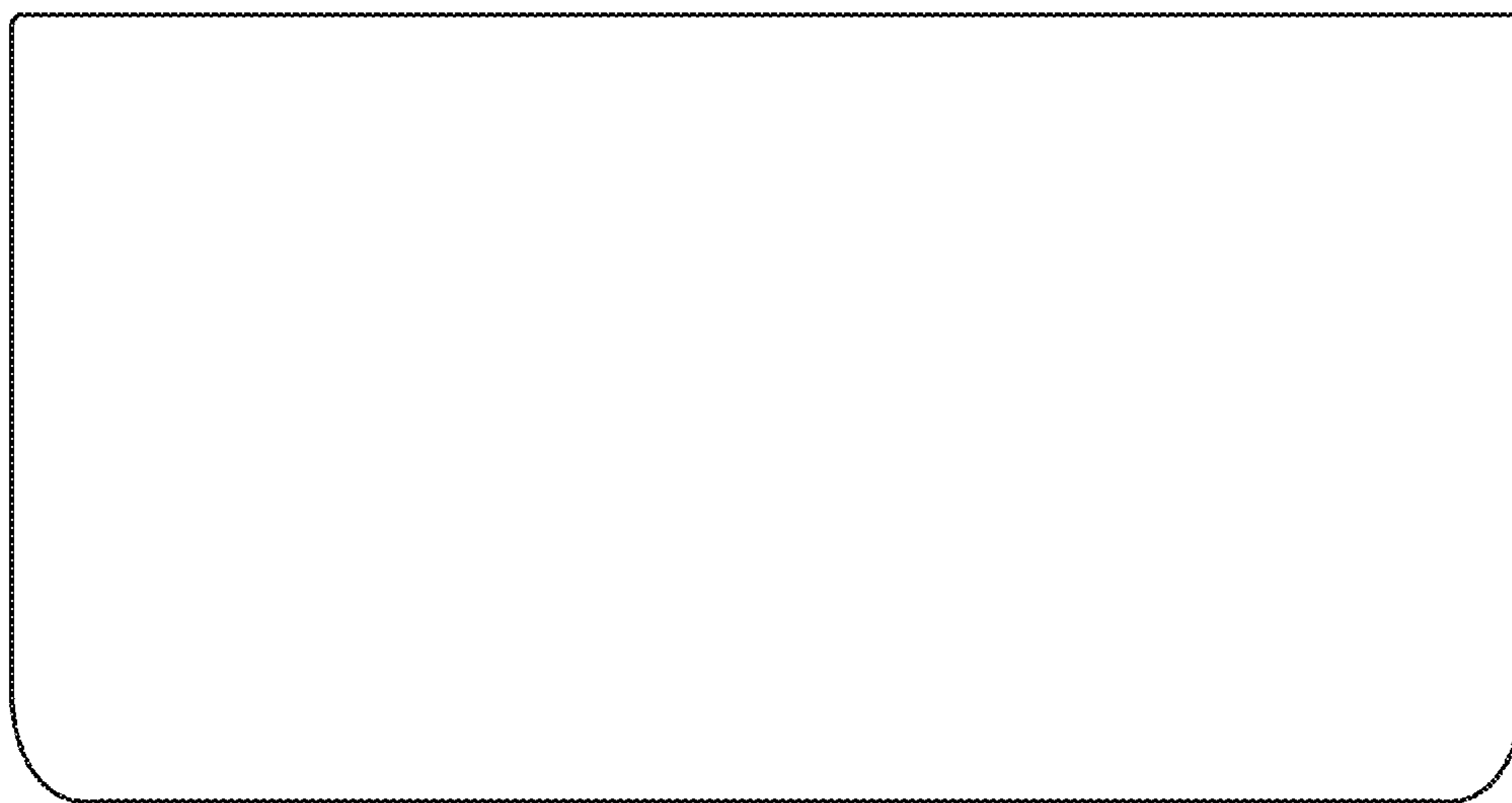
