FIG. 15 is a bottom plan view of FIG. 11.

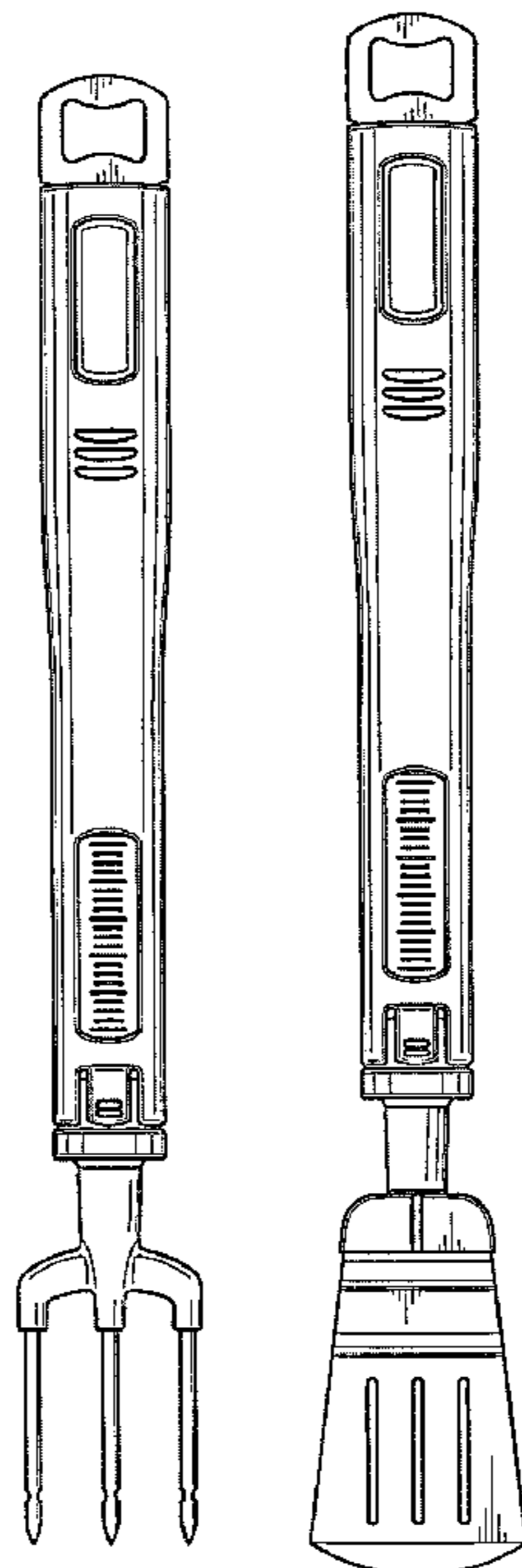

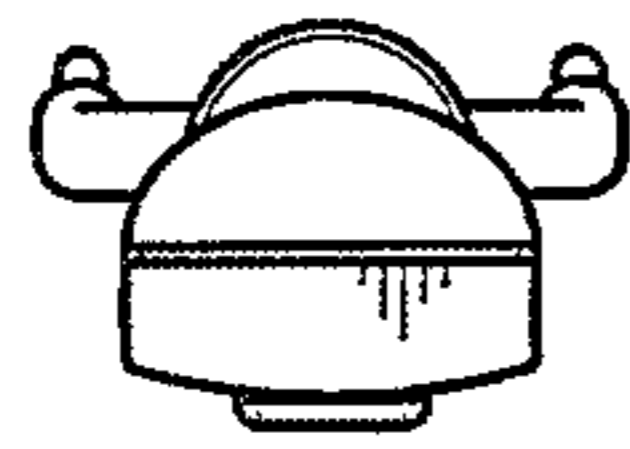

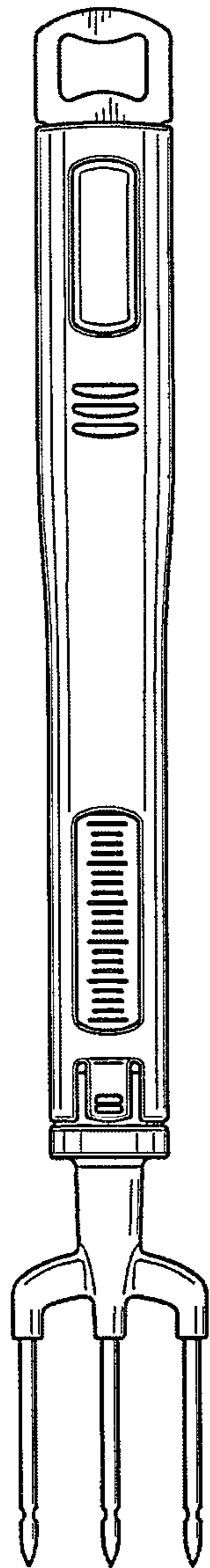

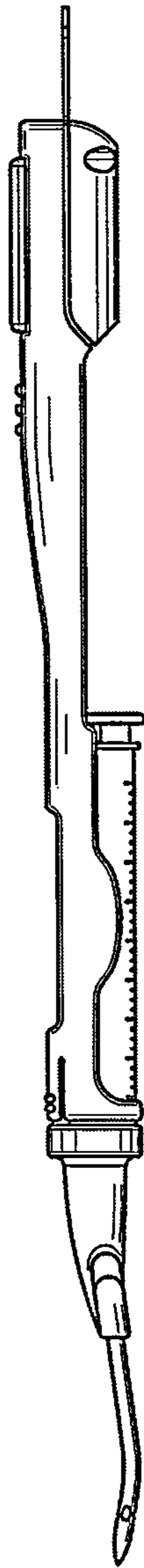

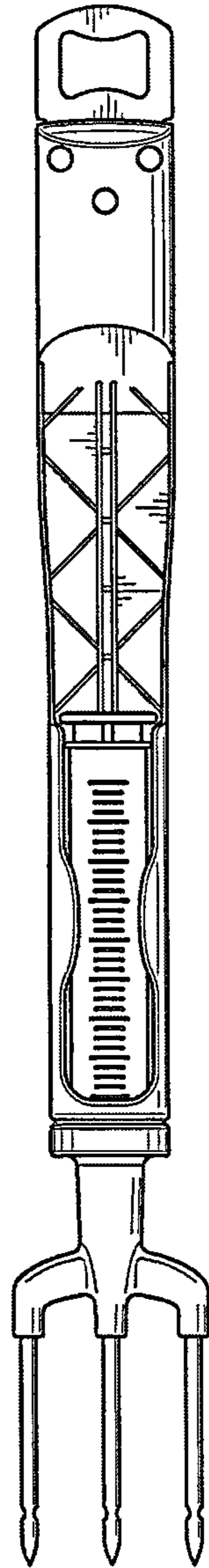

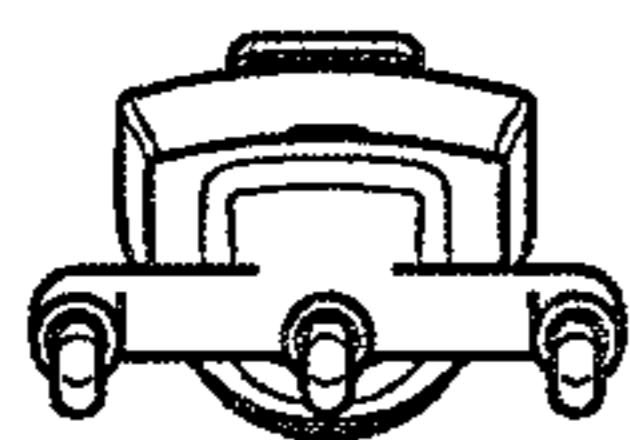

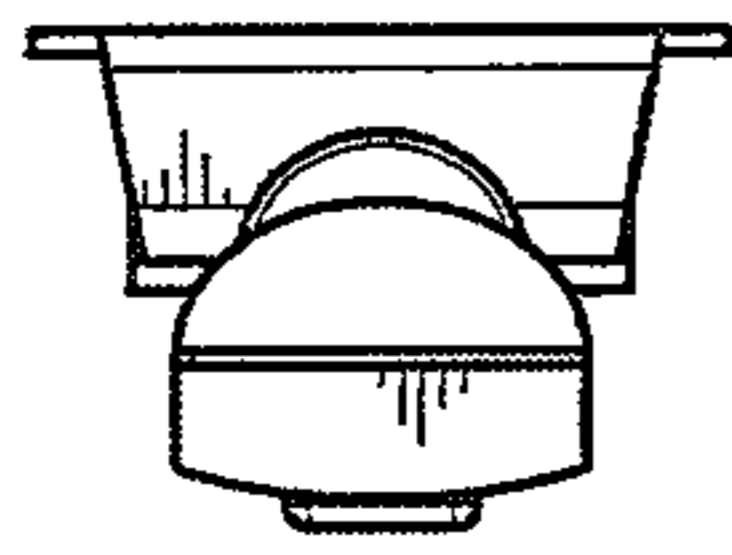

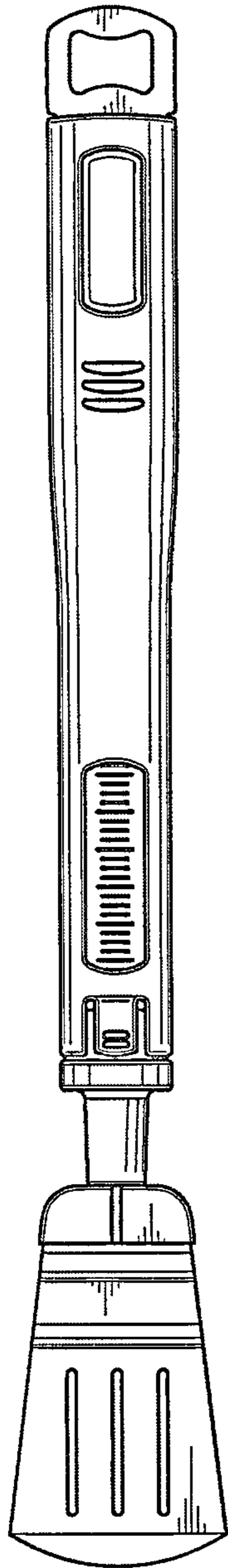

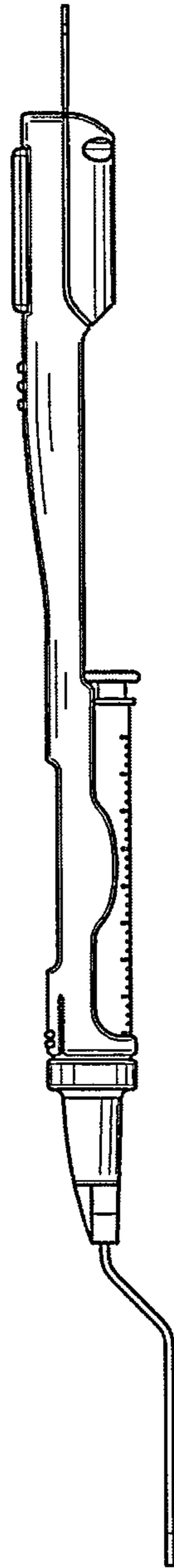

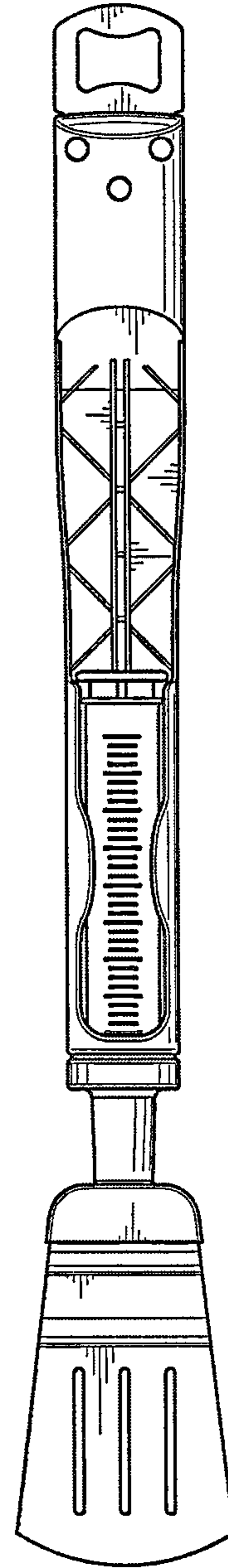

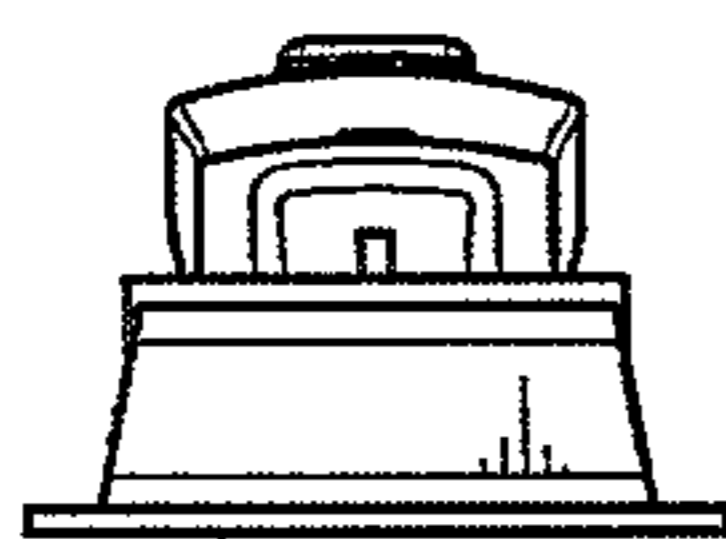

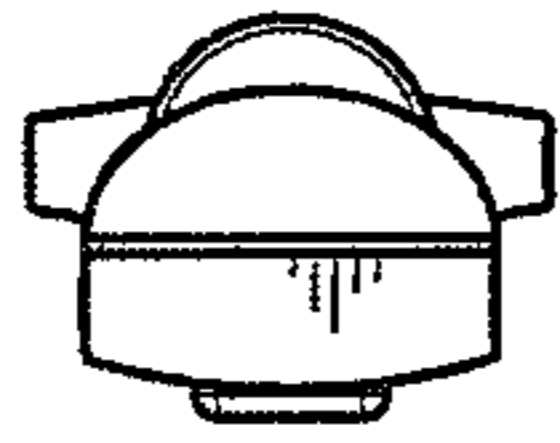

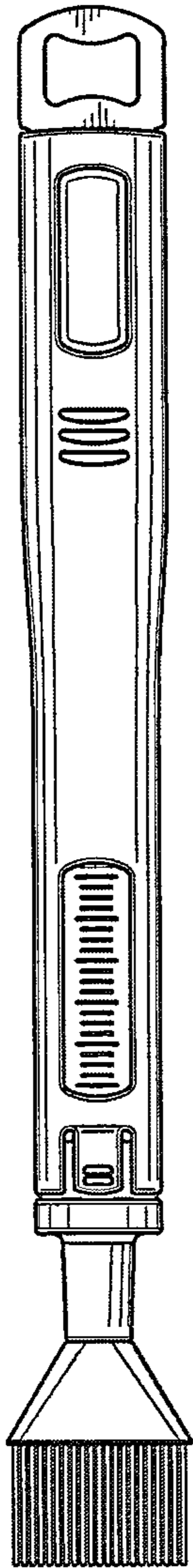

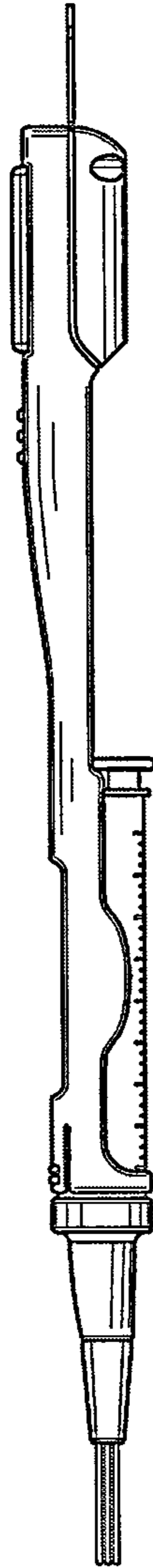

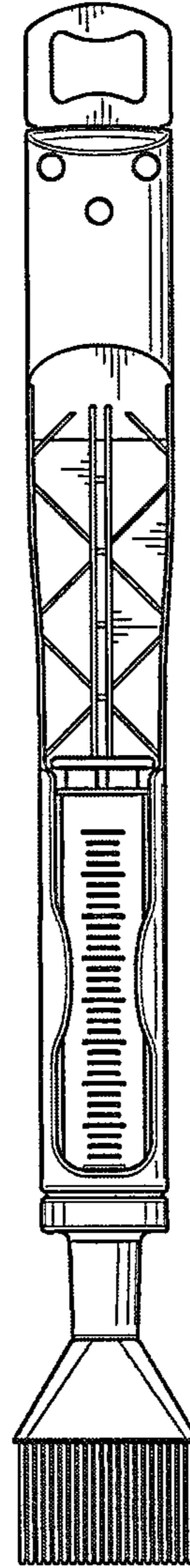

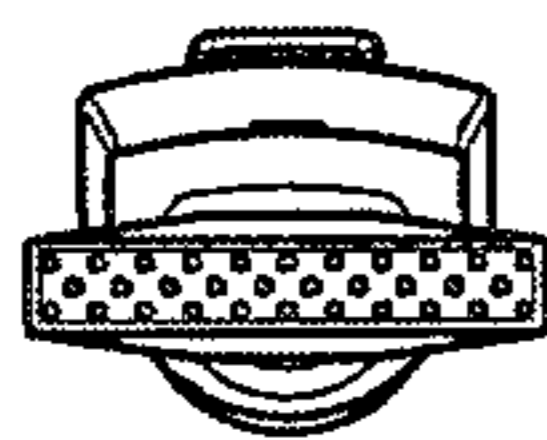
