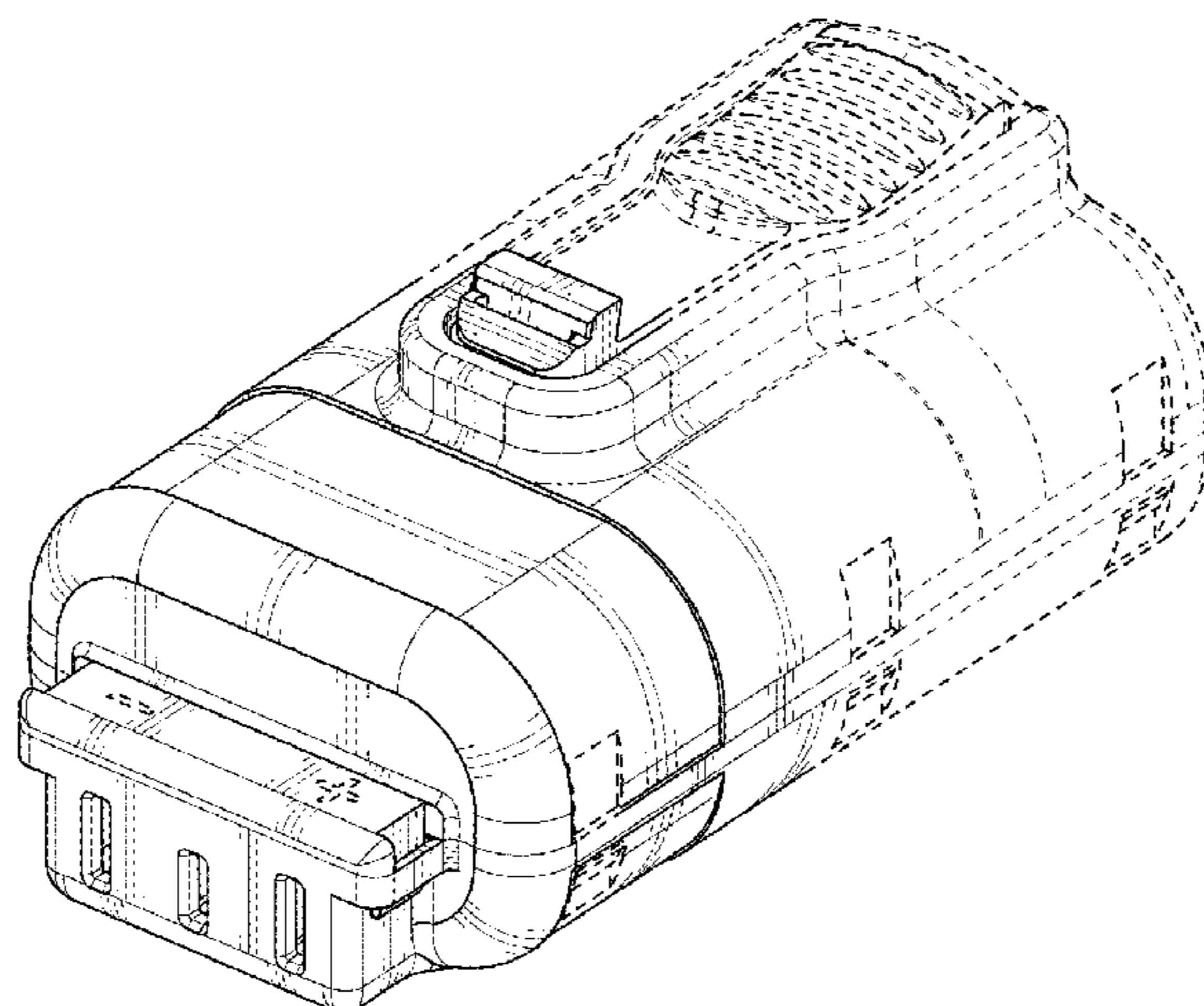
(57) **CLAIM**

The ornamental design for a battery pack for a combustion tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of present battery pack; FIG. 2 is a right side view of the battery pack of FIG. 1; FIG. 3 is a left side view of same; FIG. 4 is a front view of the battery pack of FIG. 1; FIG. 5 is a rear view of same; FIG. 6 is top view of the battery pack of FIG. 1; and, FIG. 7 is a bottom view of same.

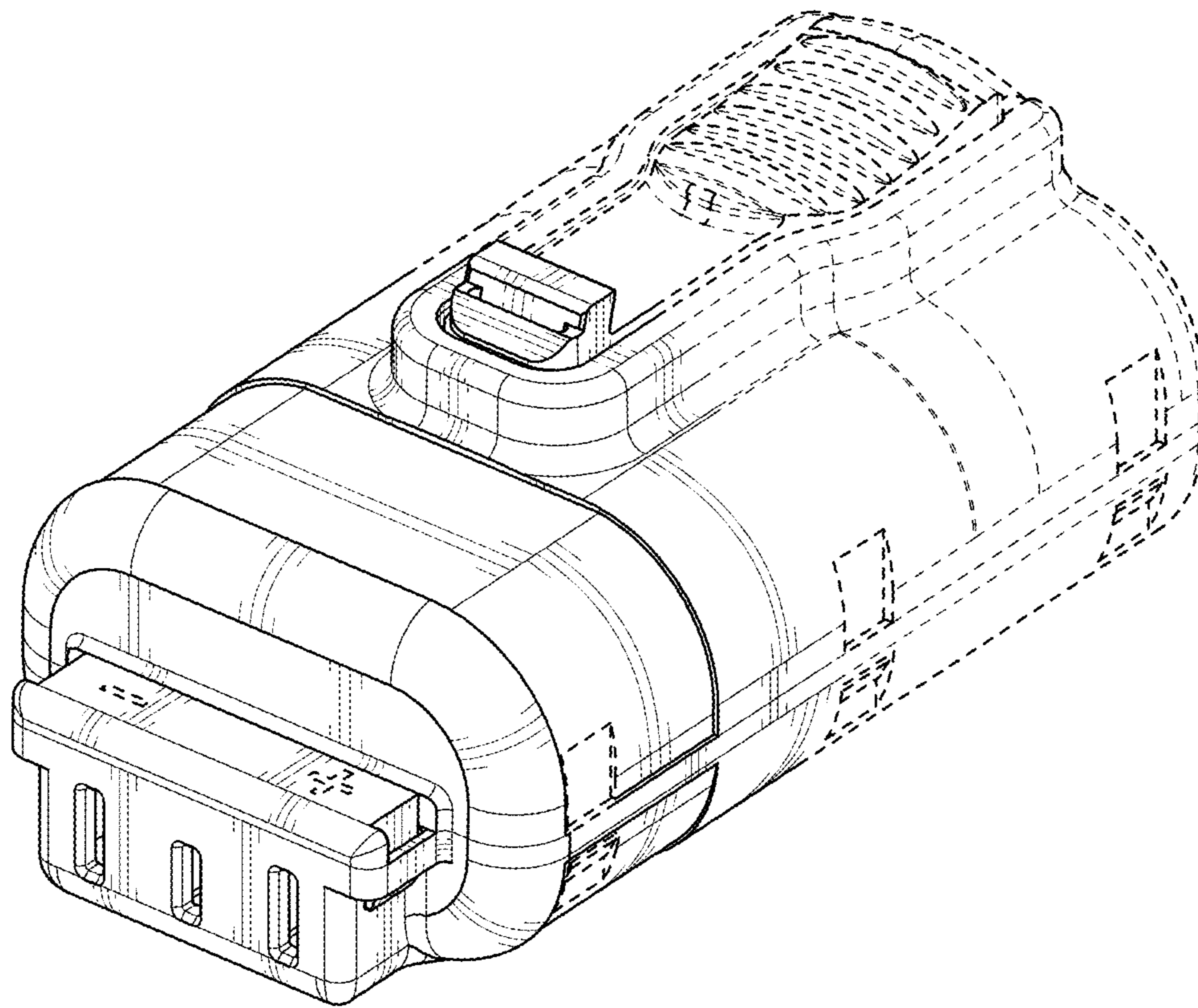

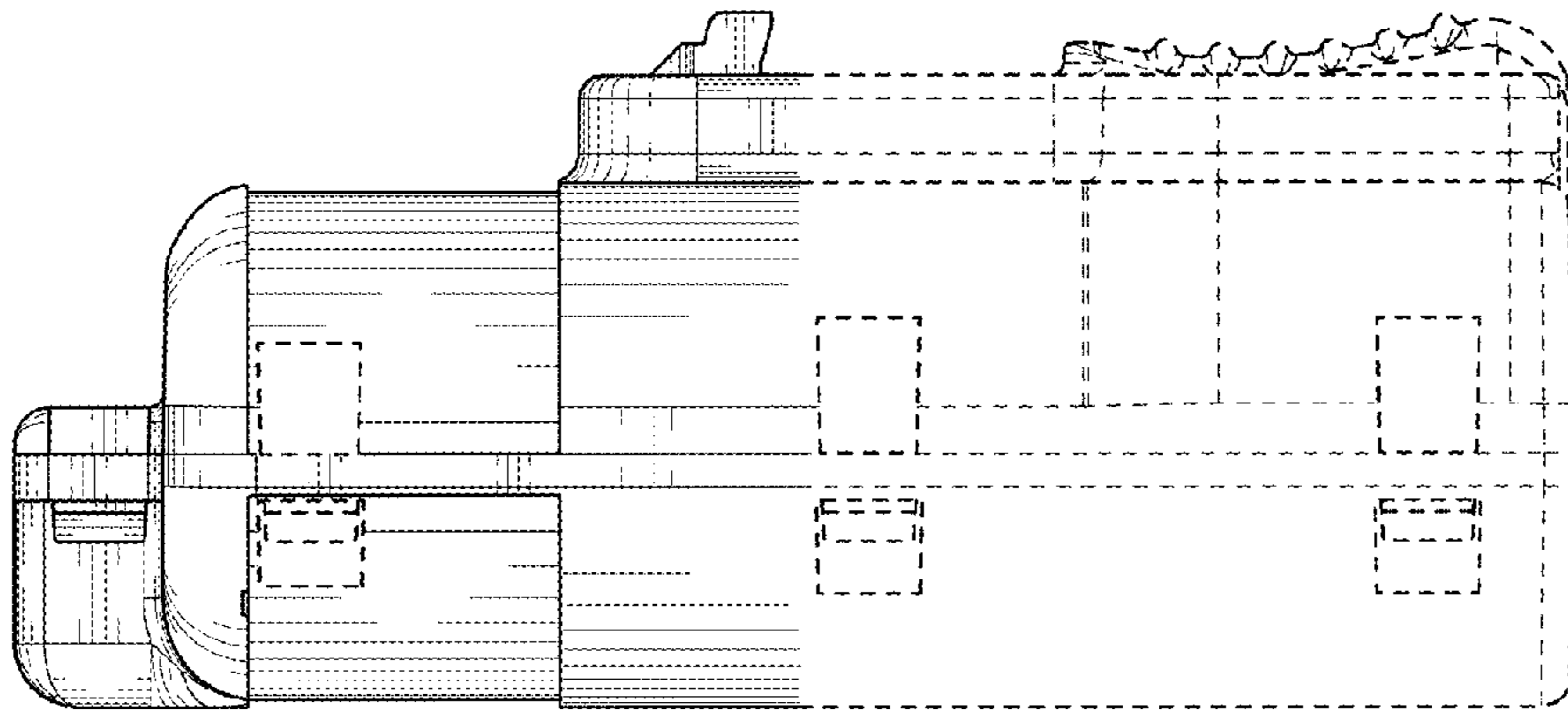

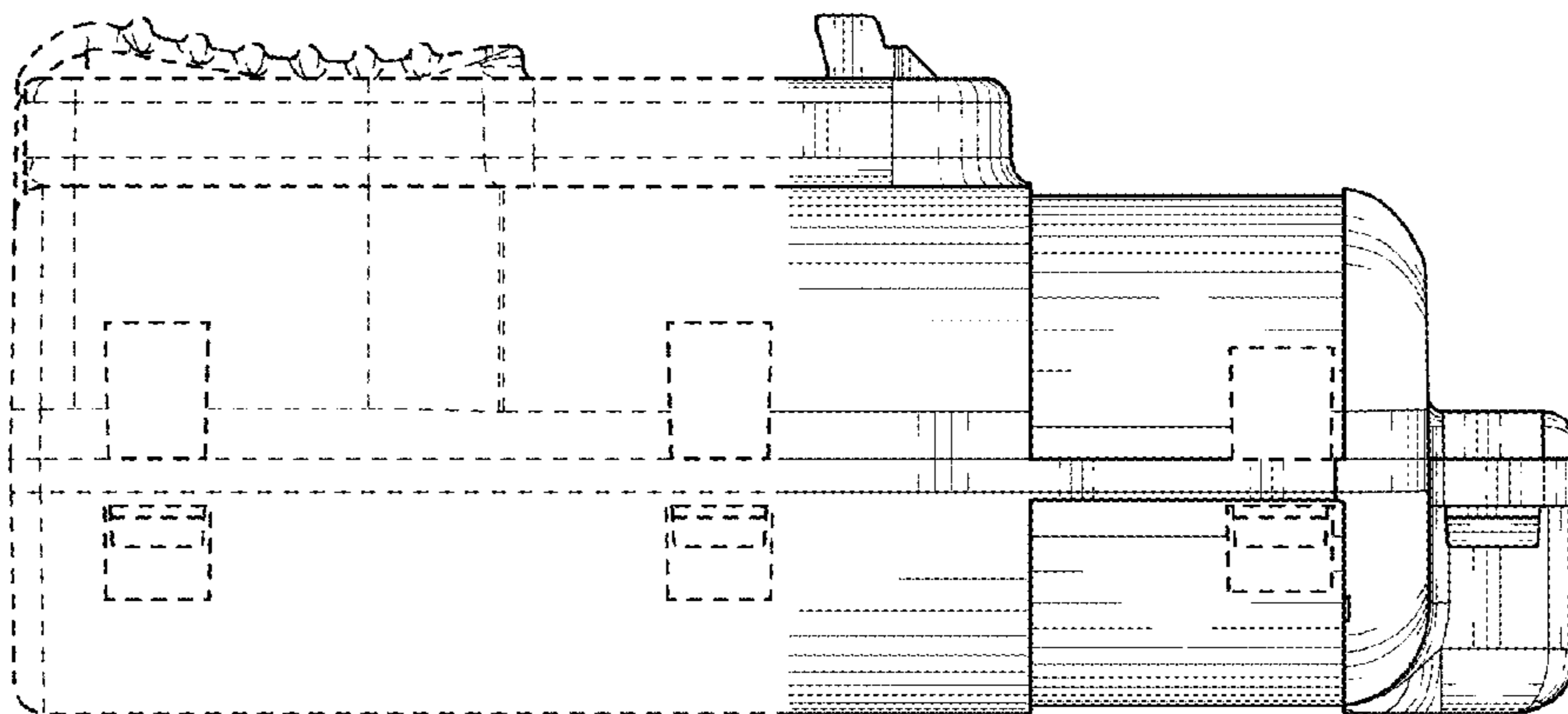

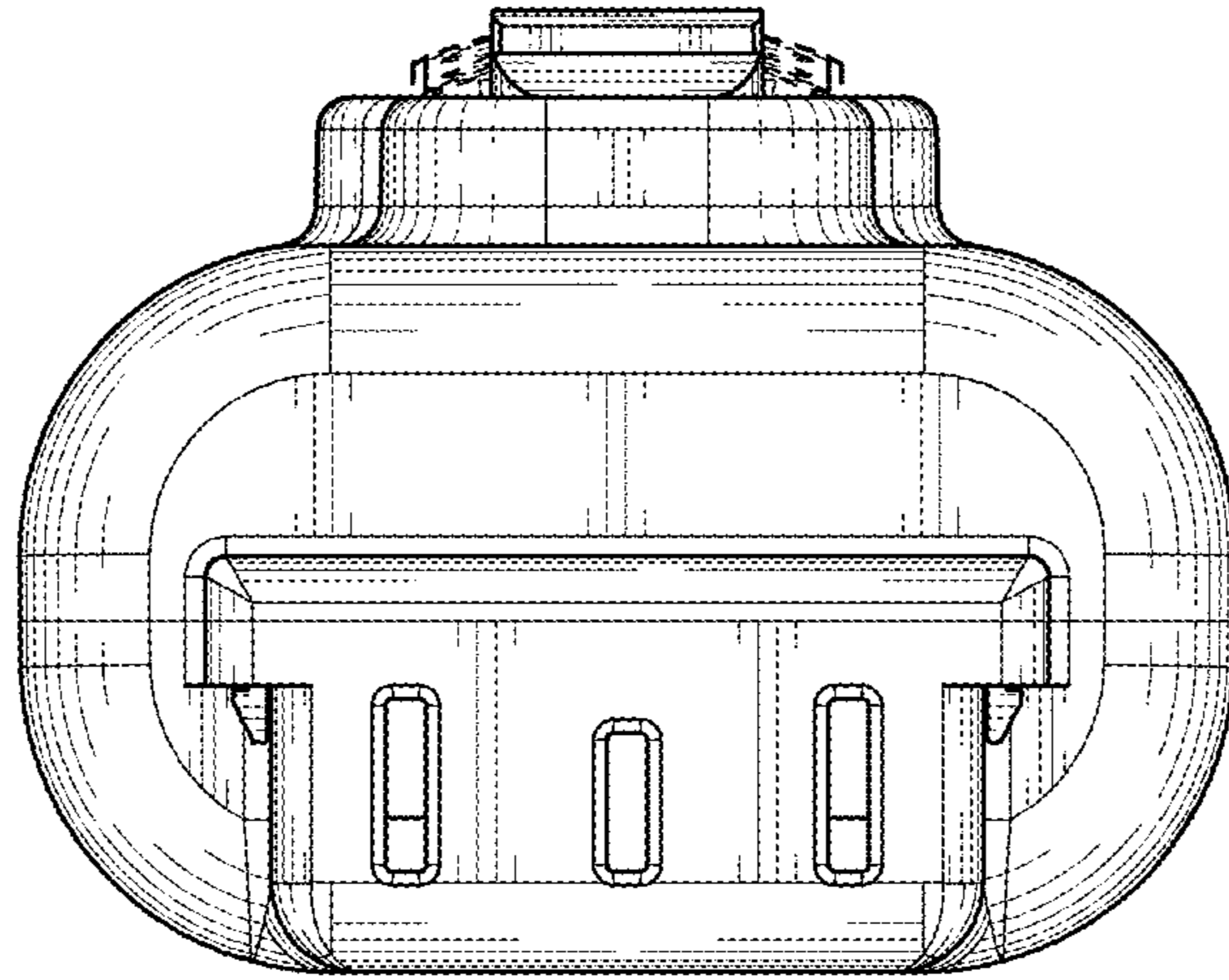

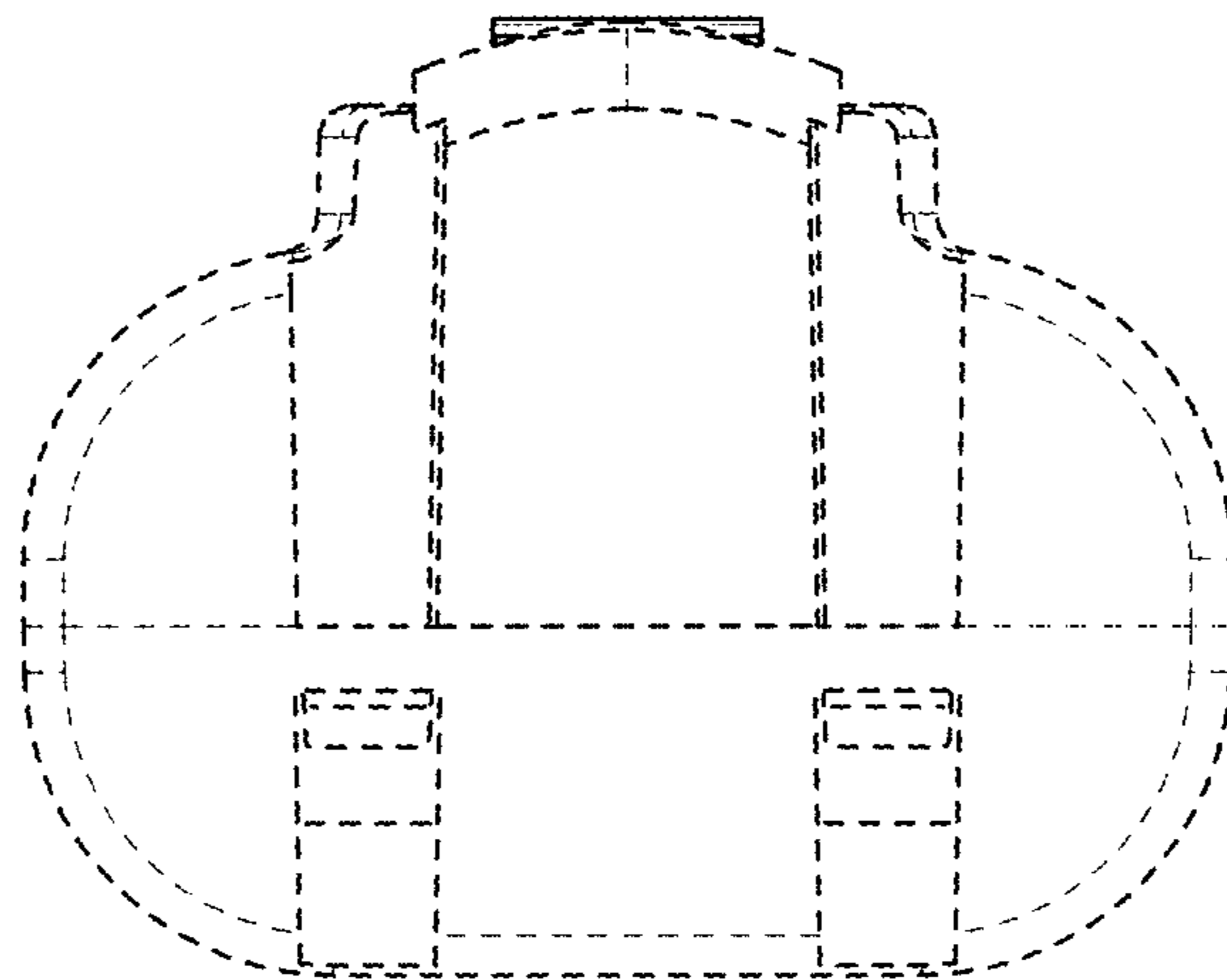

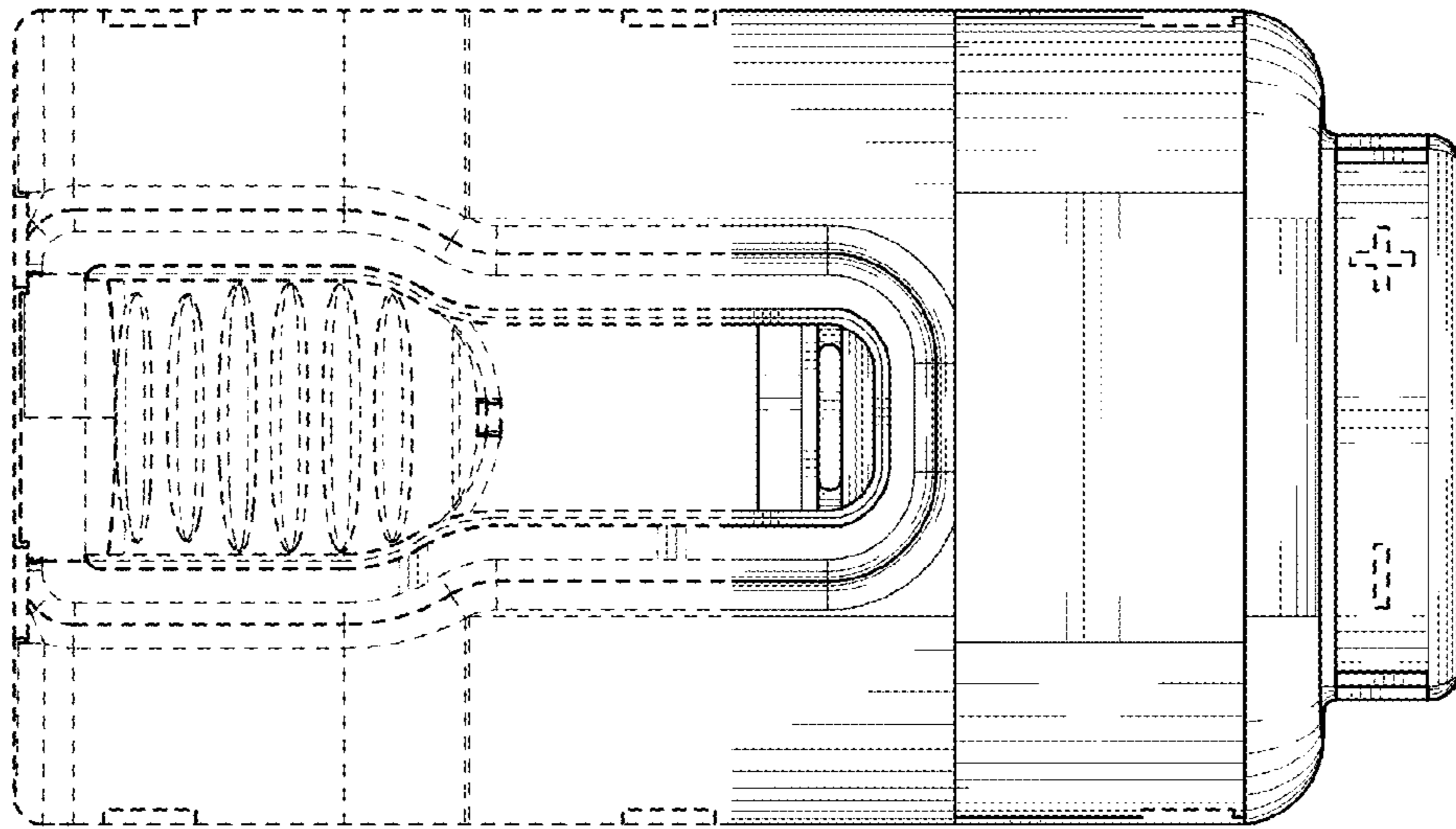

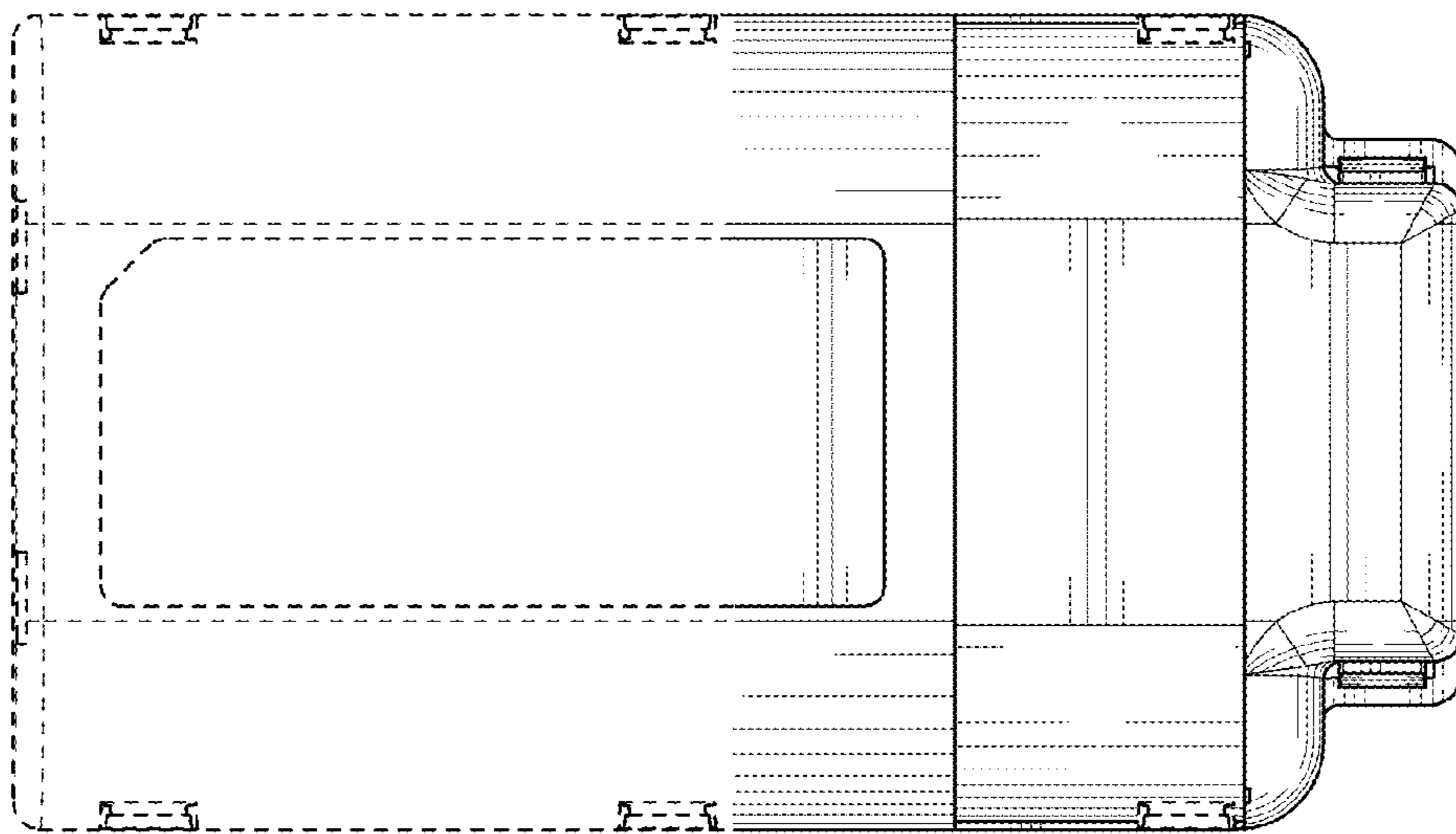
