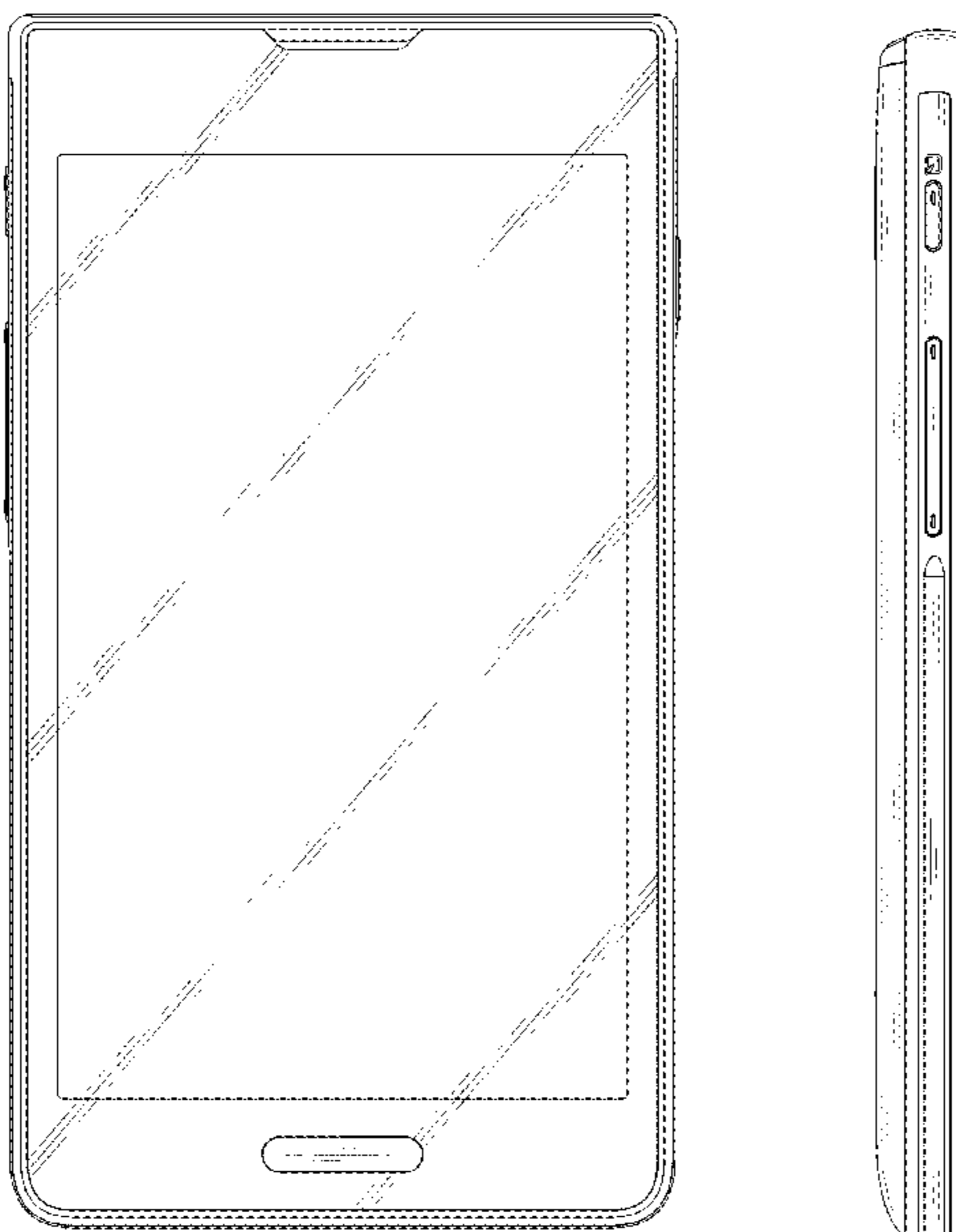

DESCRIPTION

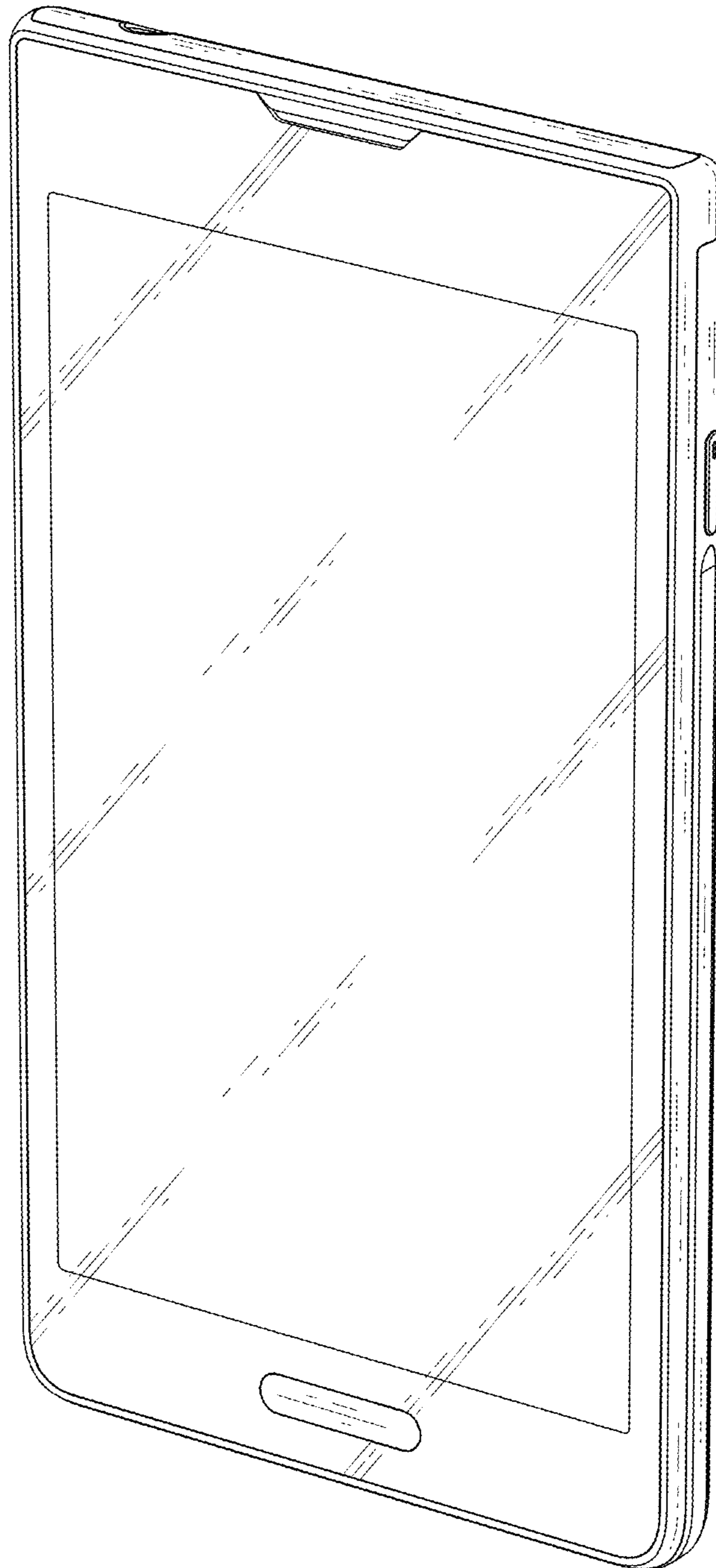

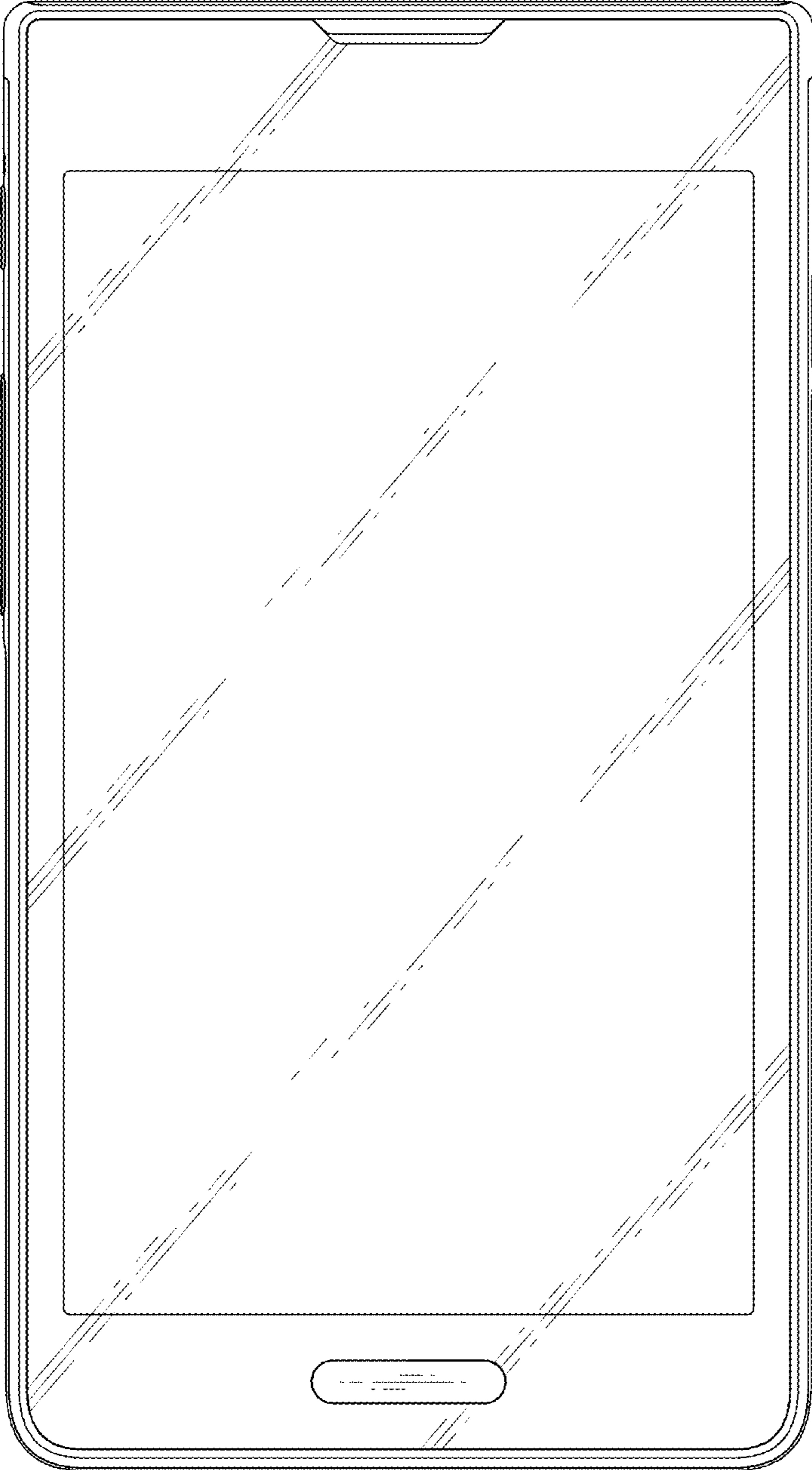

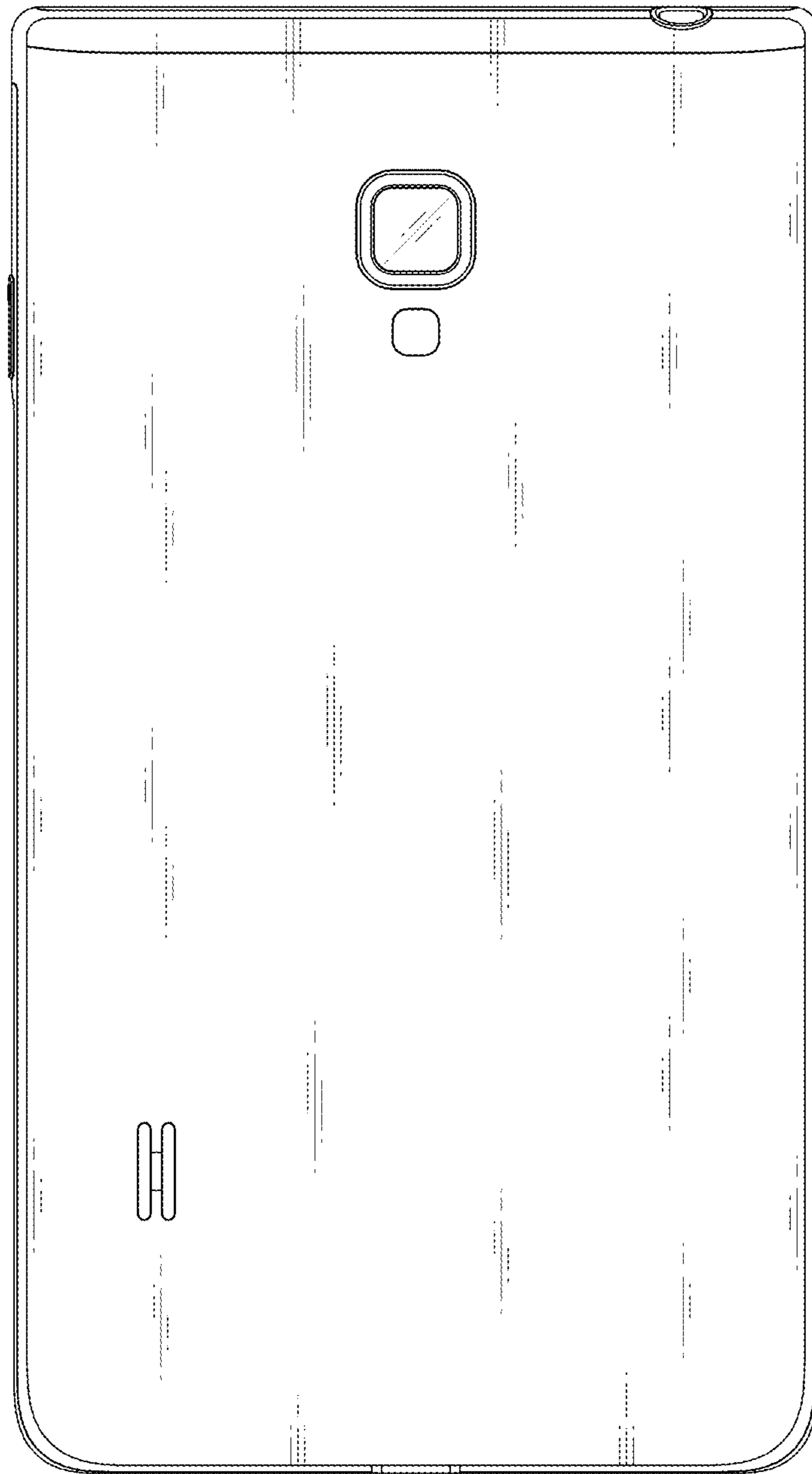

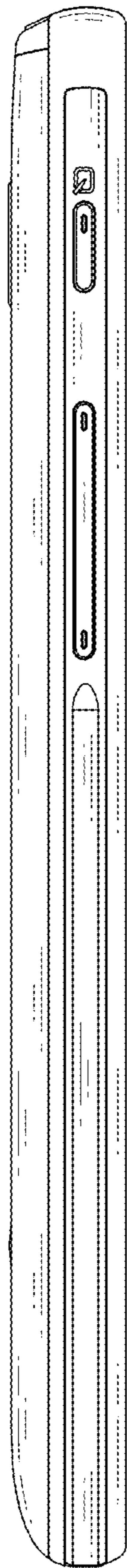

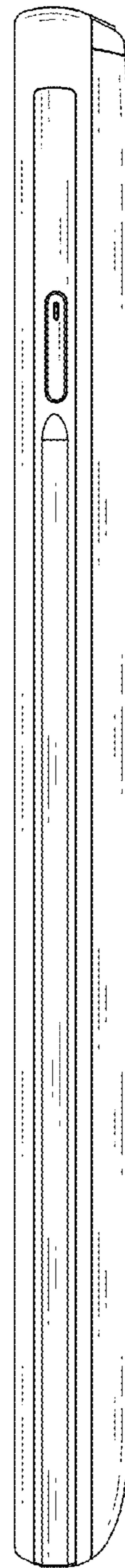

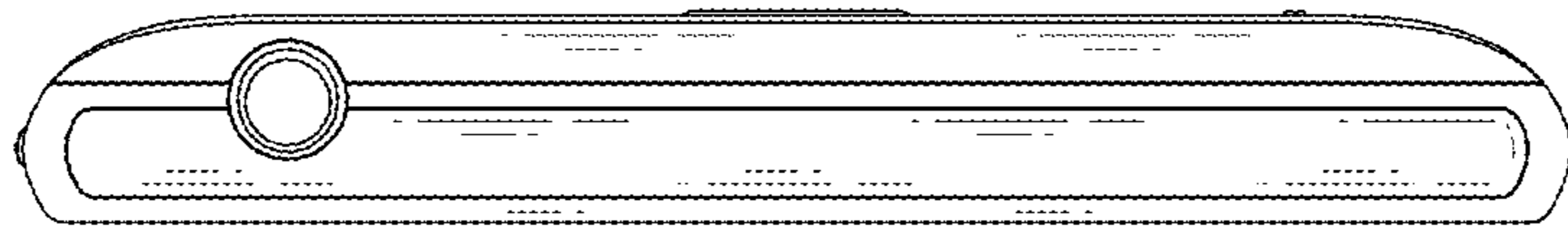
