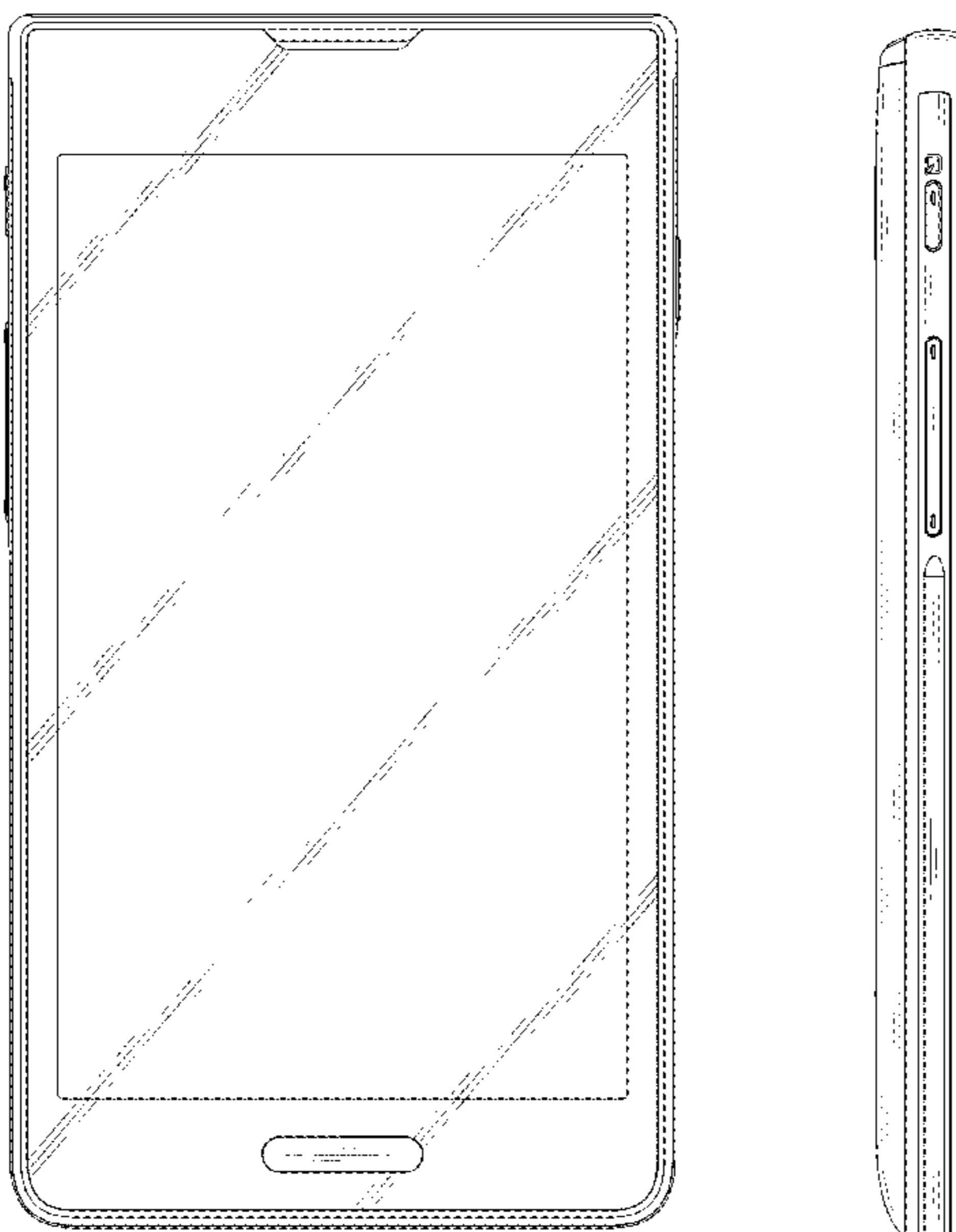

DESCRIPTION

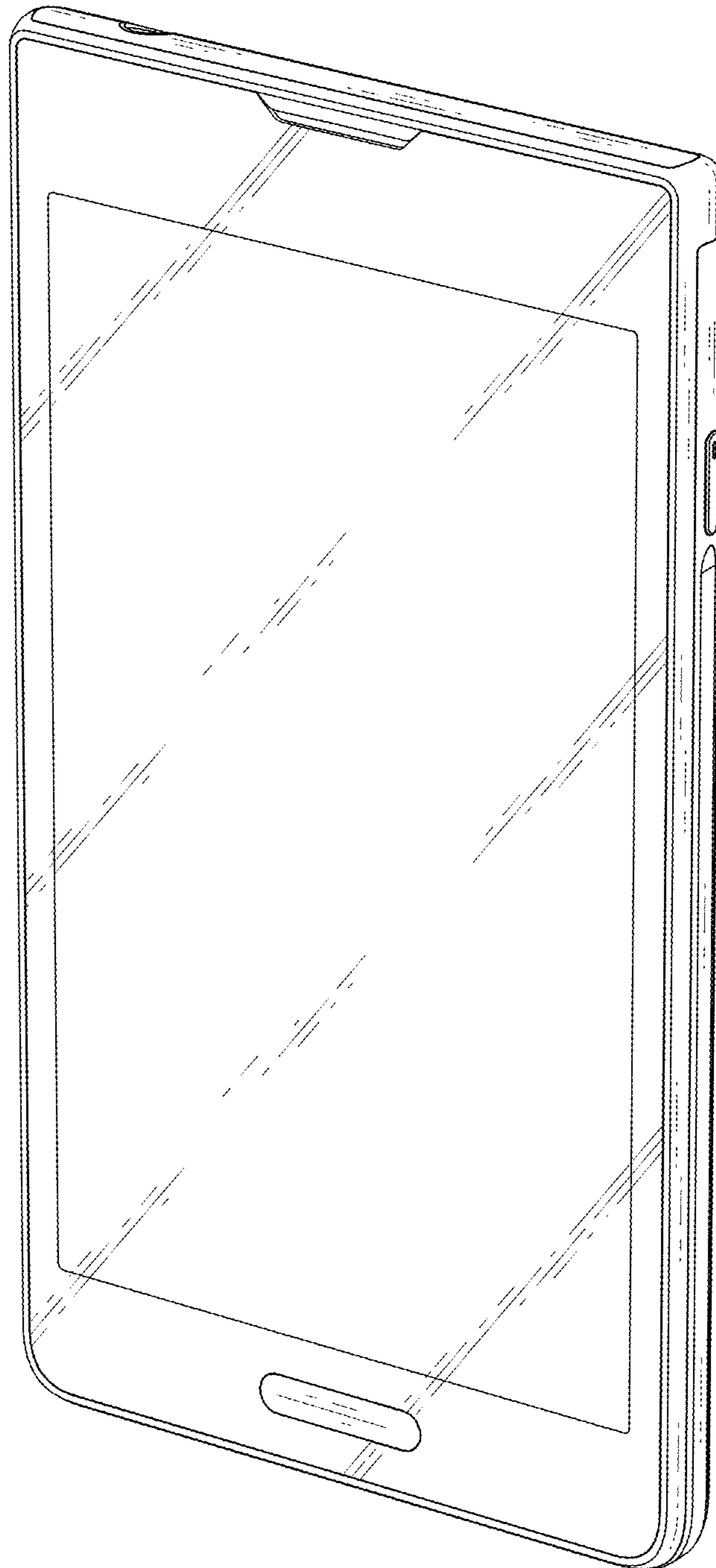

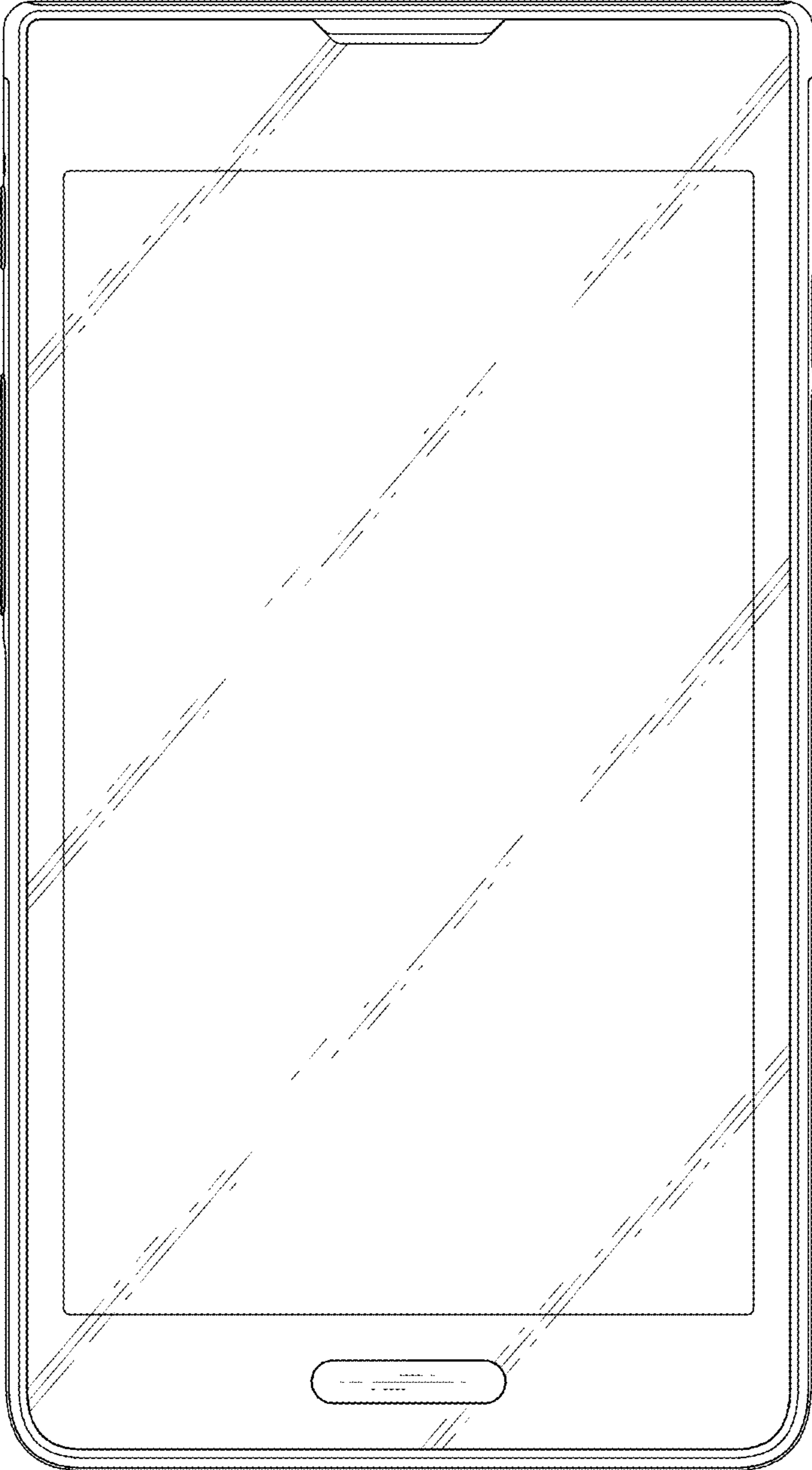

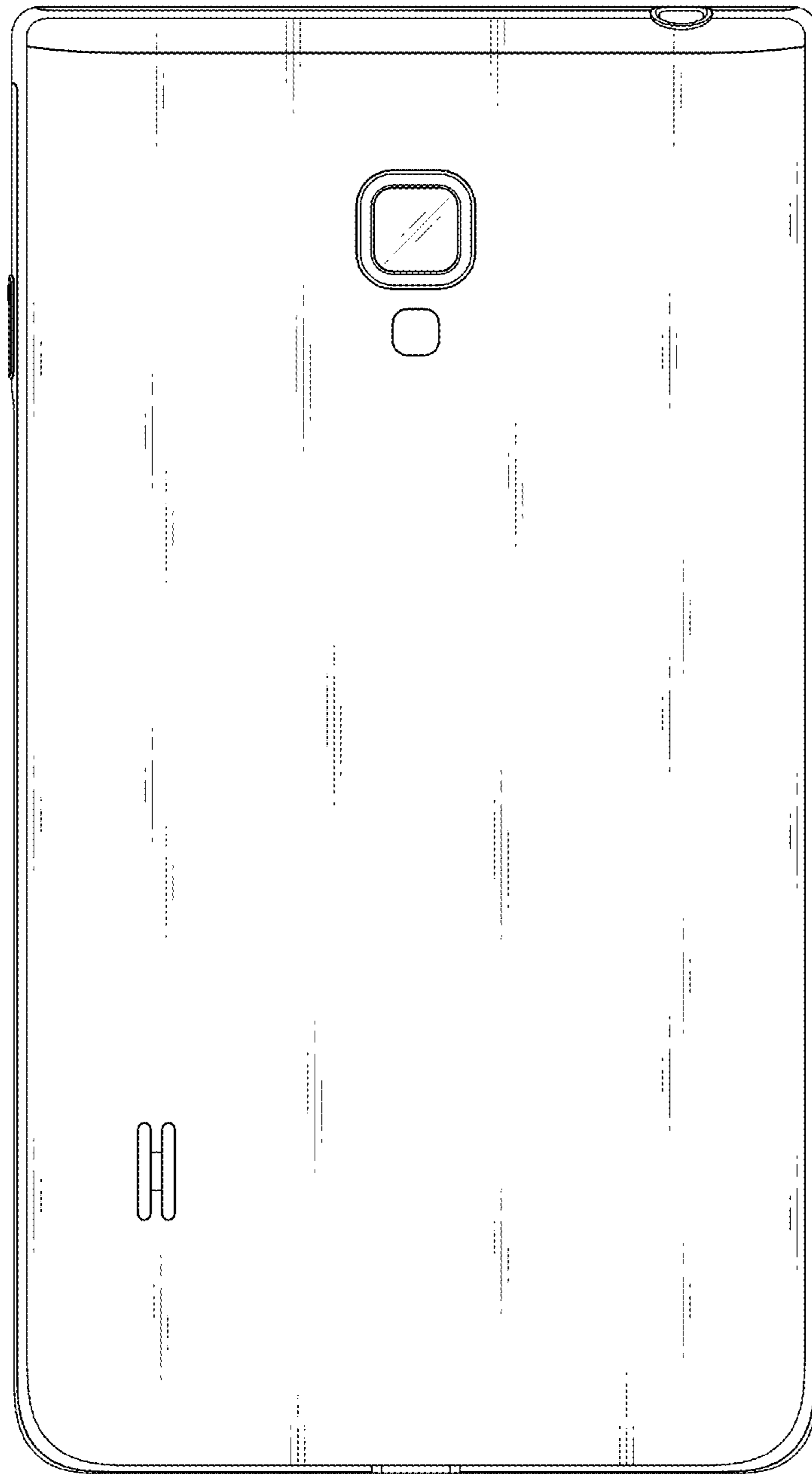

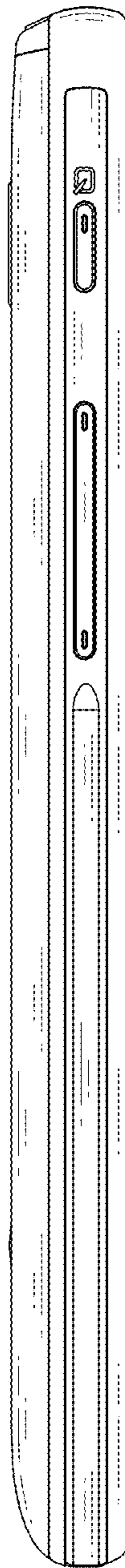

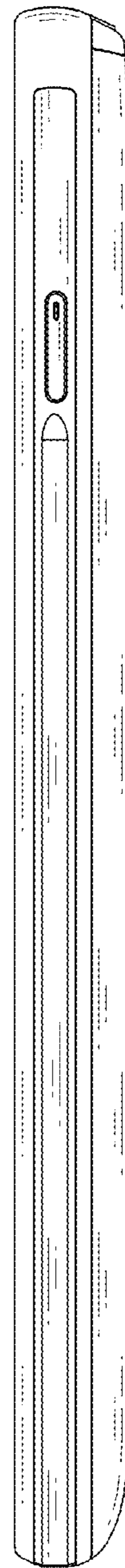

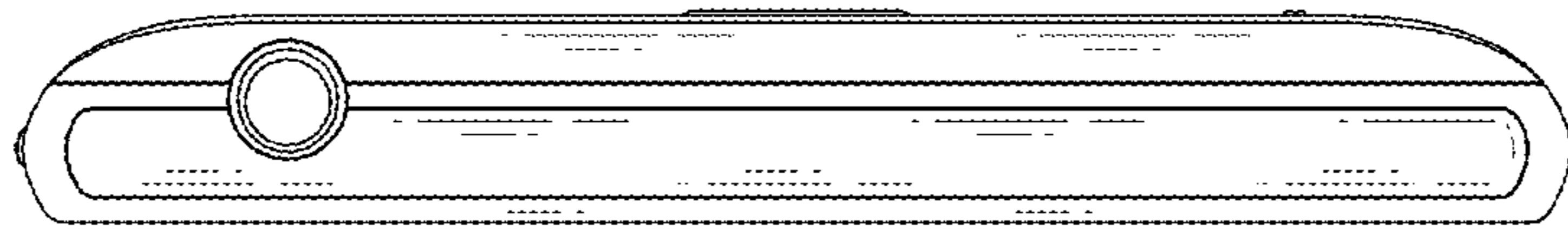
