FIG. 6 is a back view thereof;

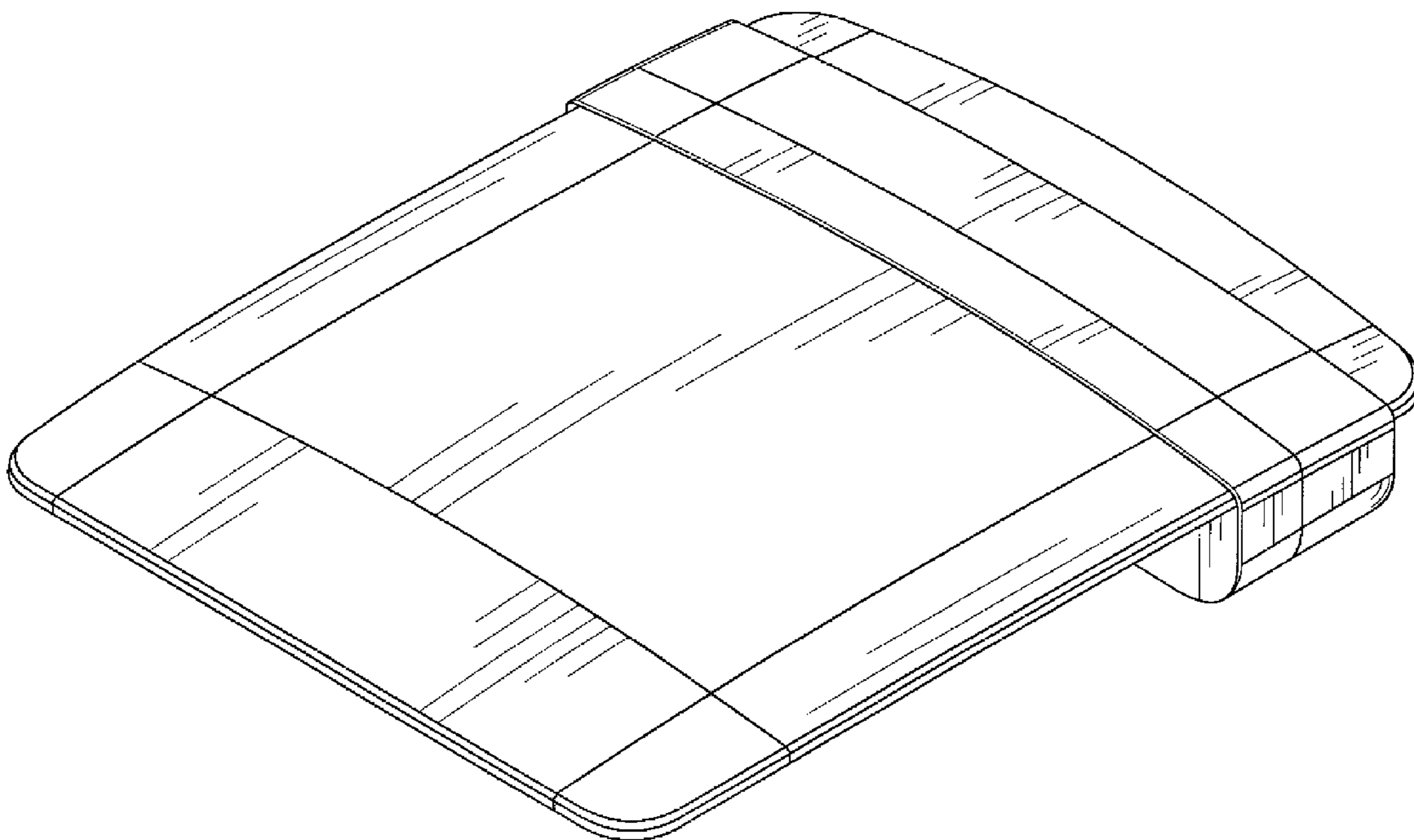
FIG. 7 is a perspective bottom view thereof;

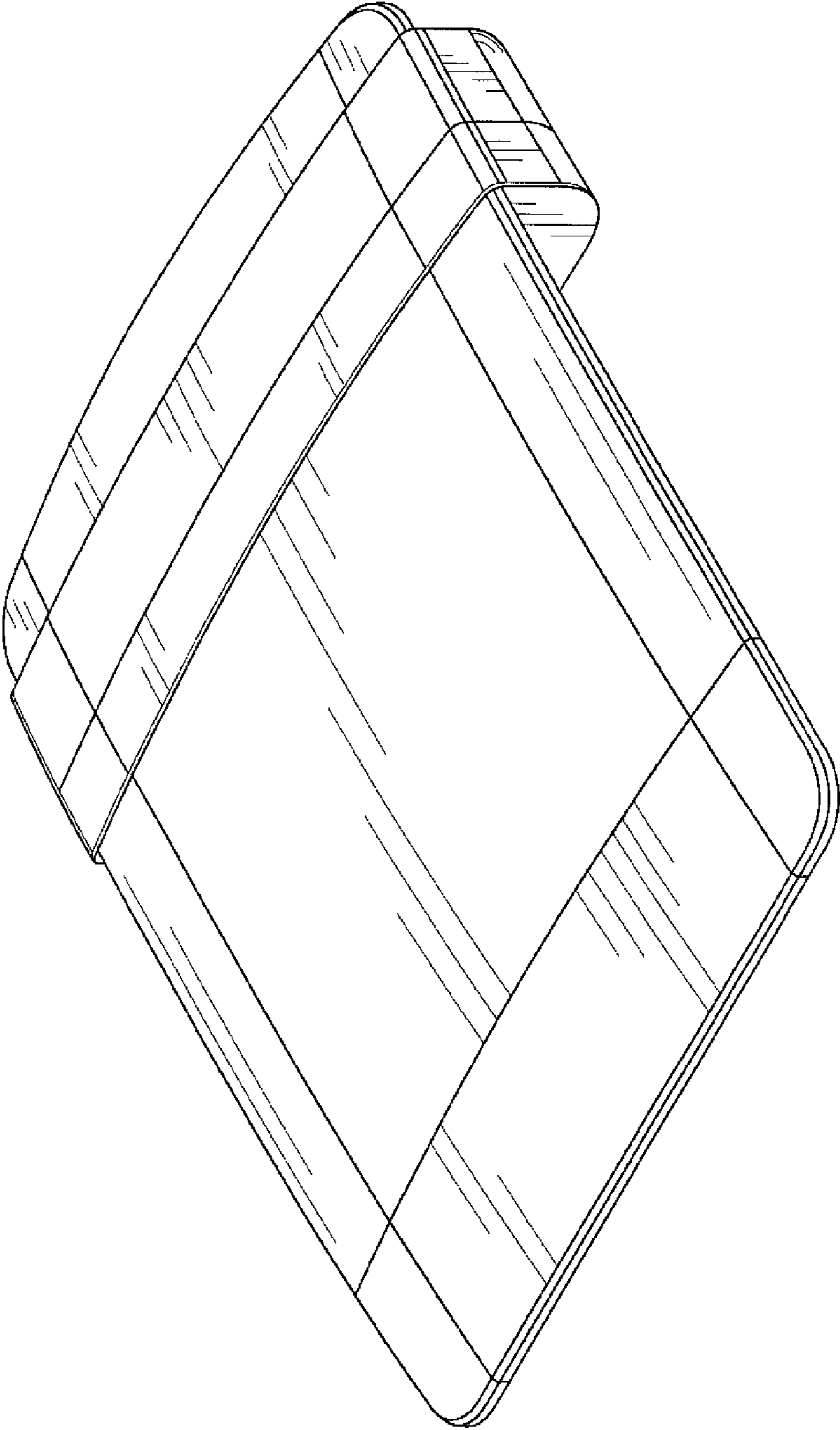

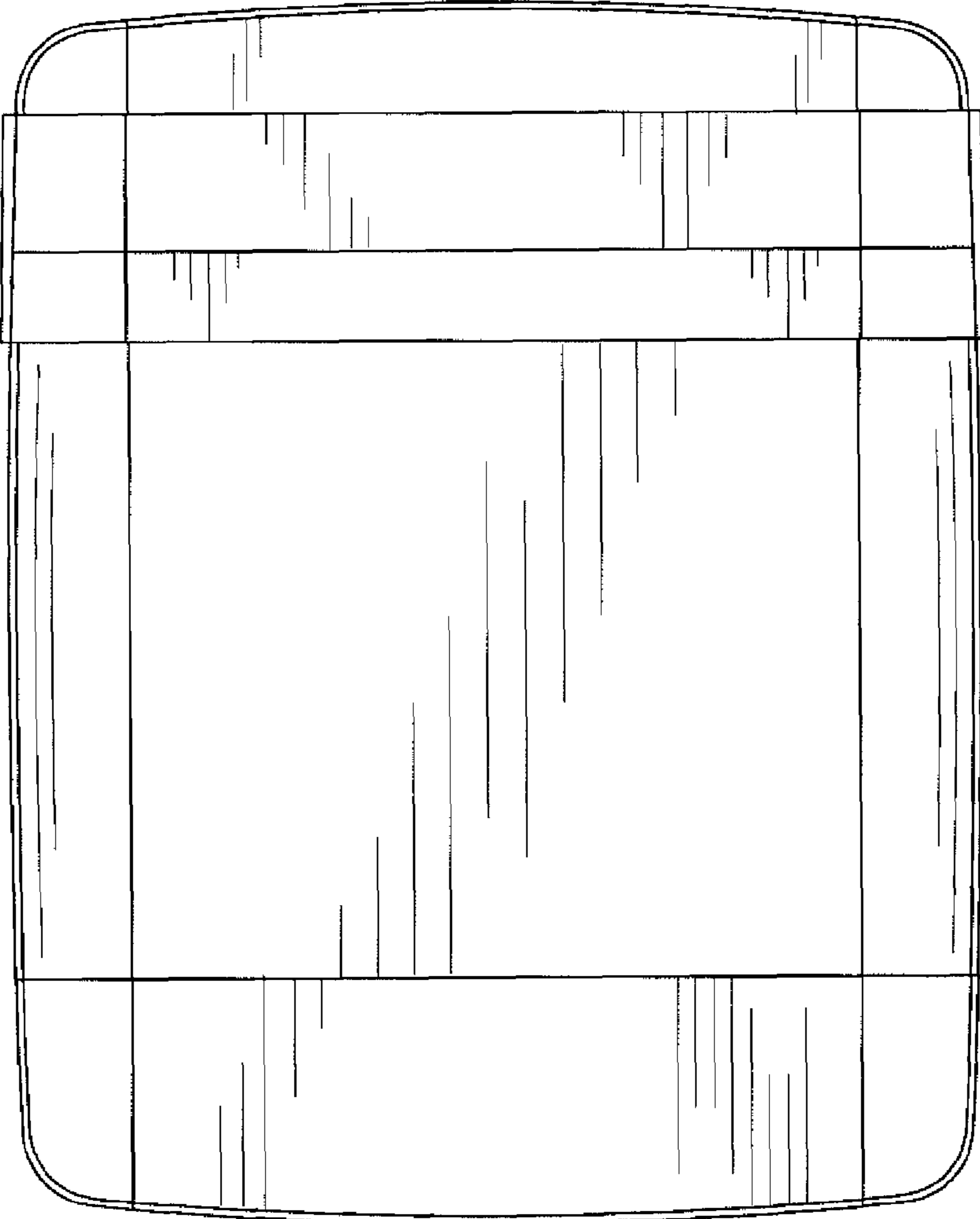

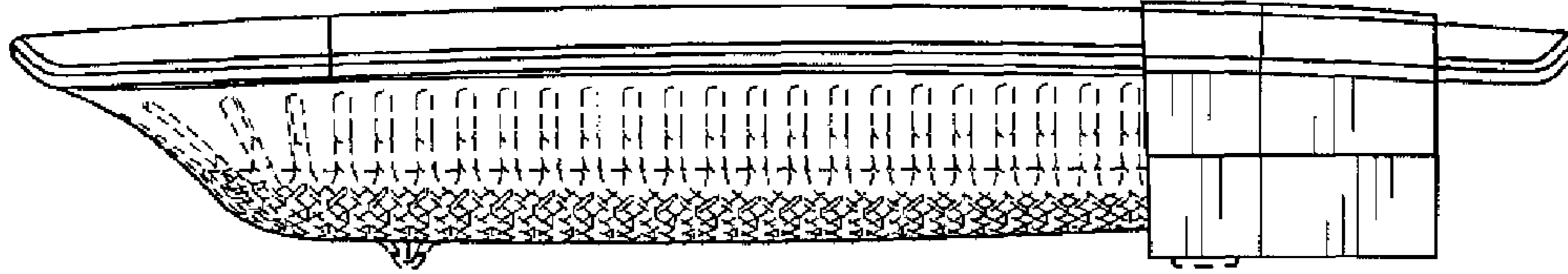

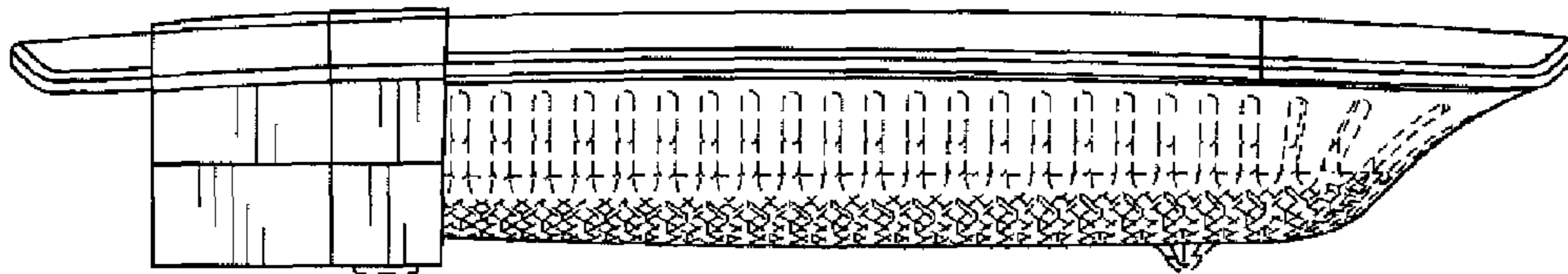

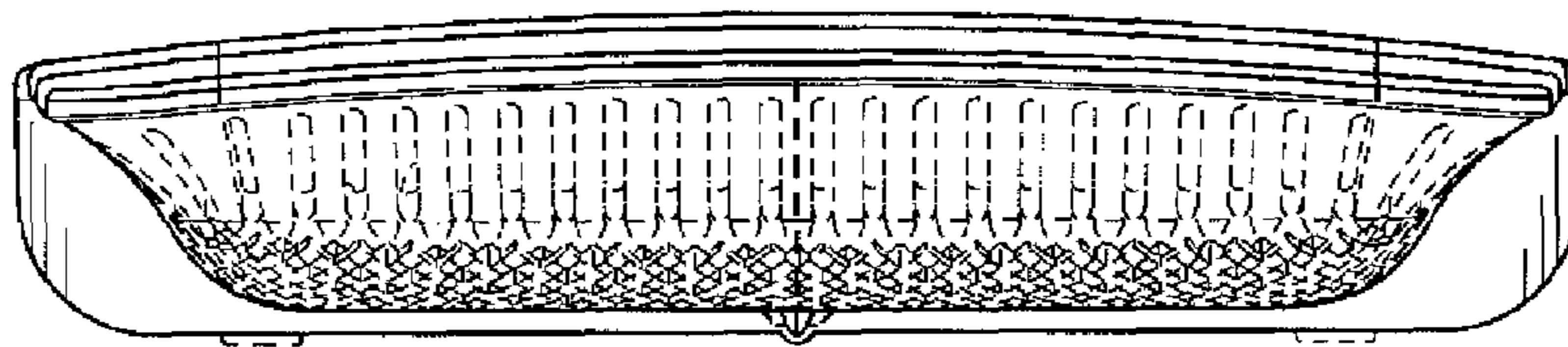

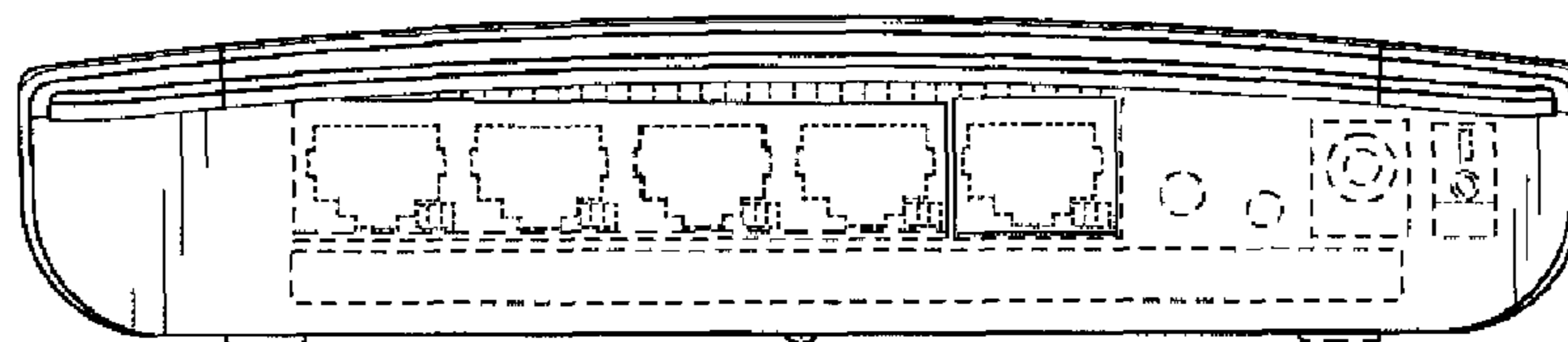

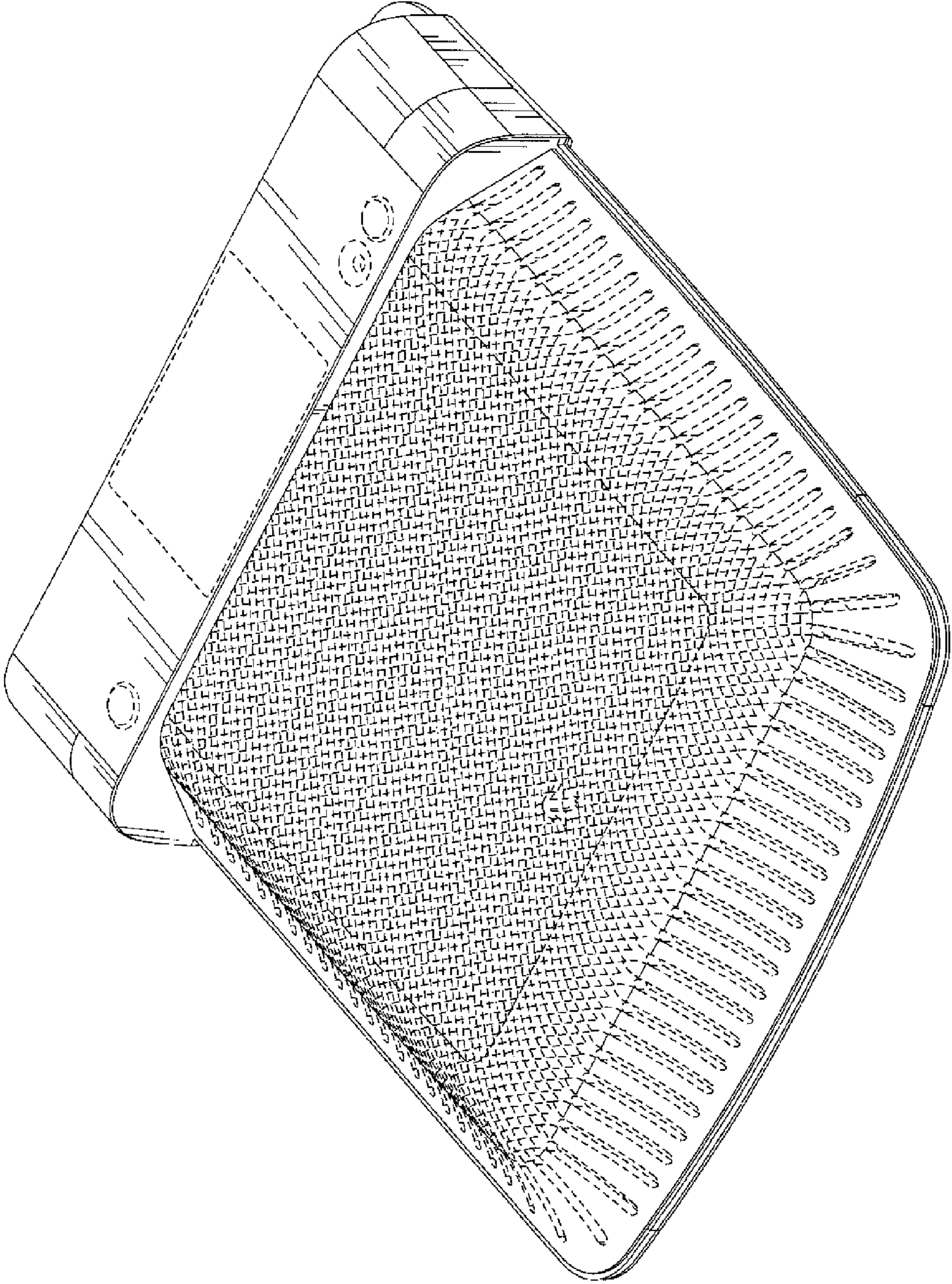

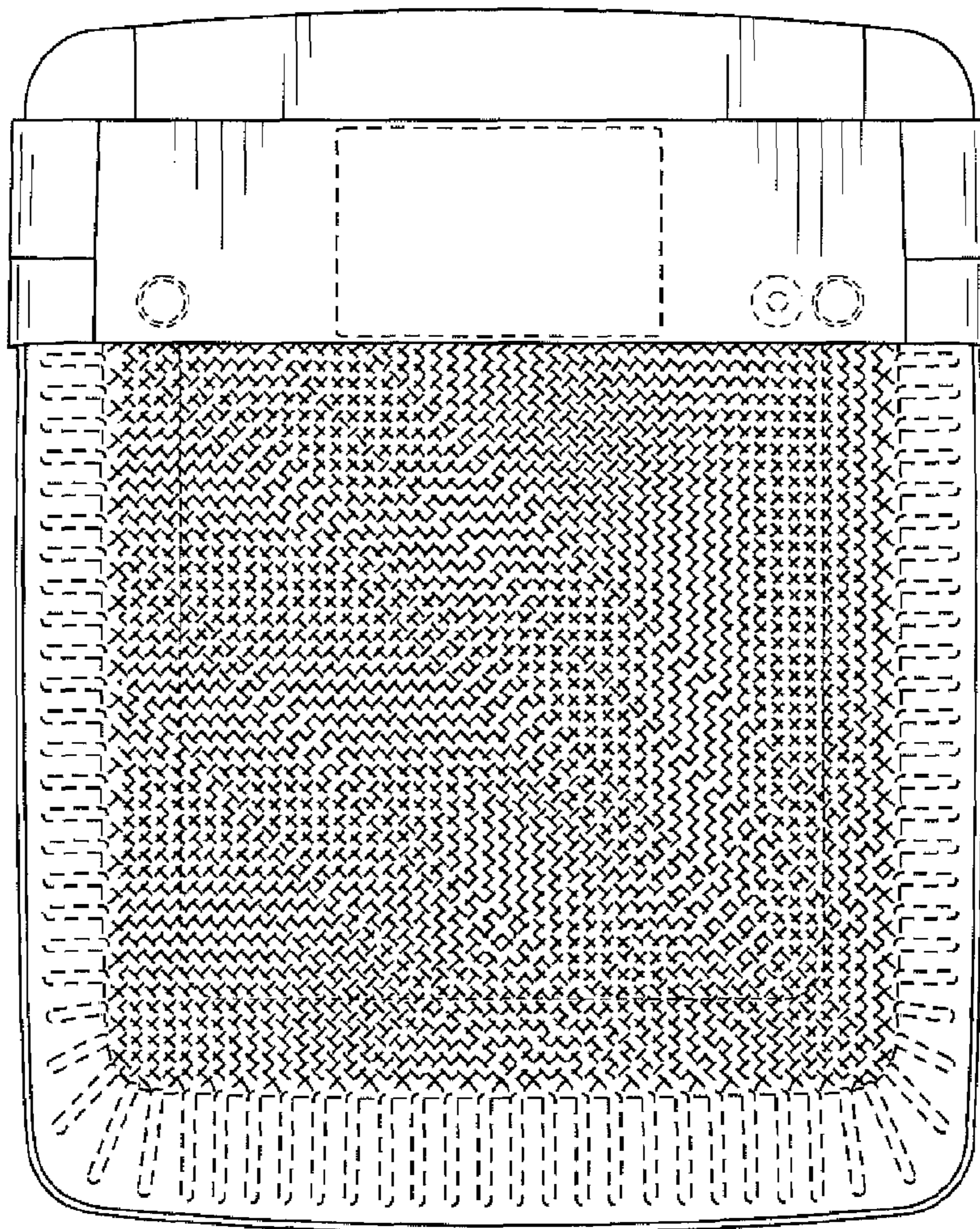

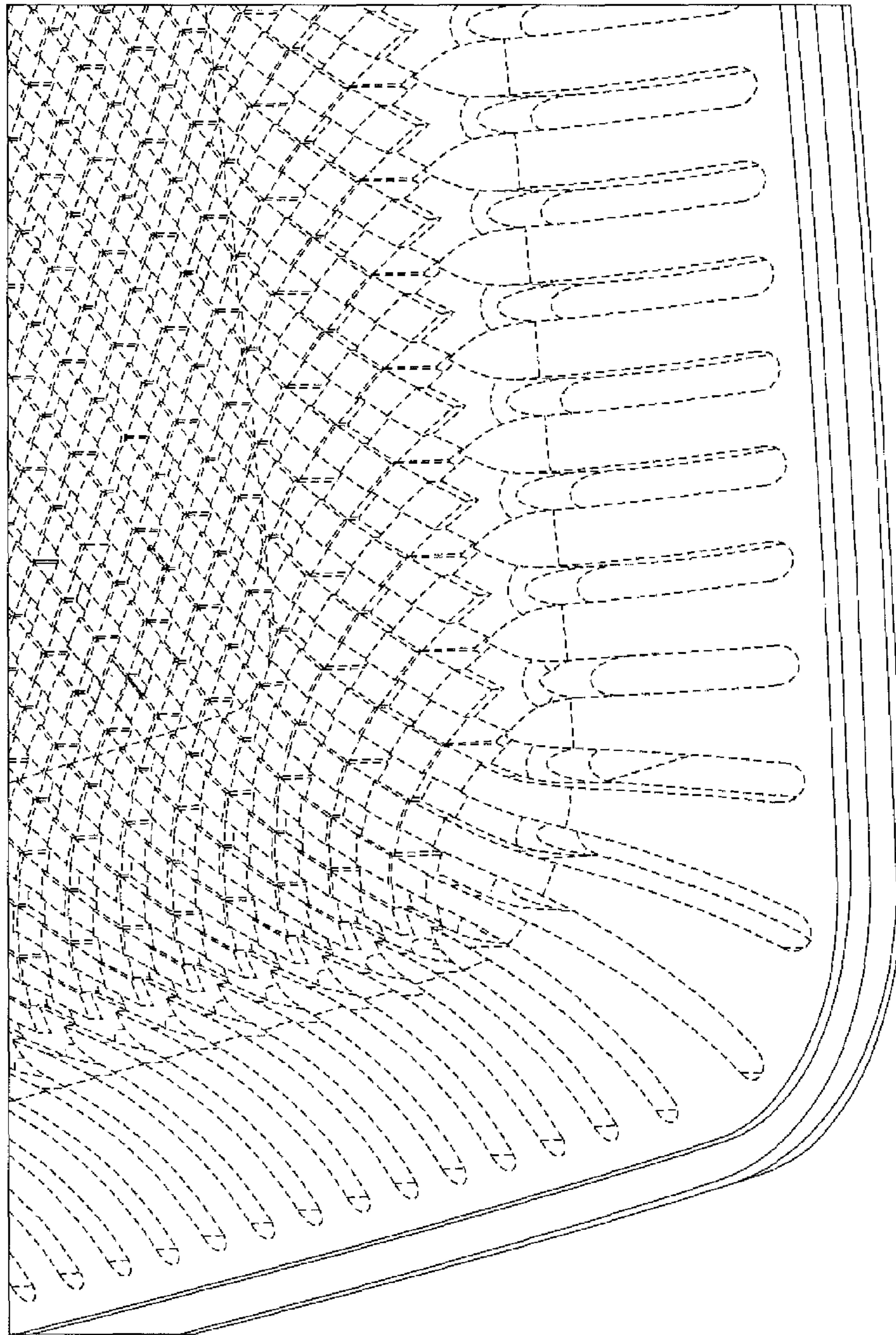
