FIG. 3 is a front view thereof, shown in the context of different placement in the environment.

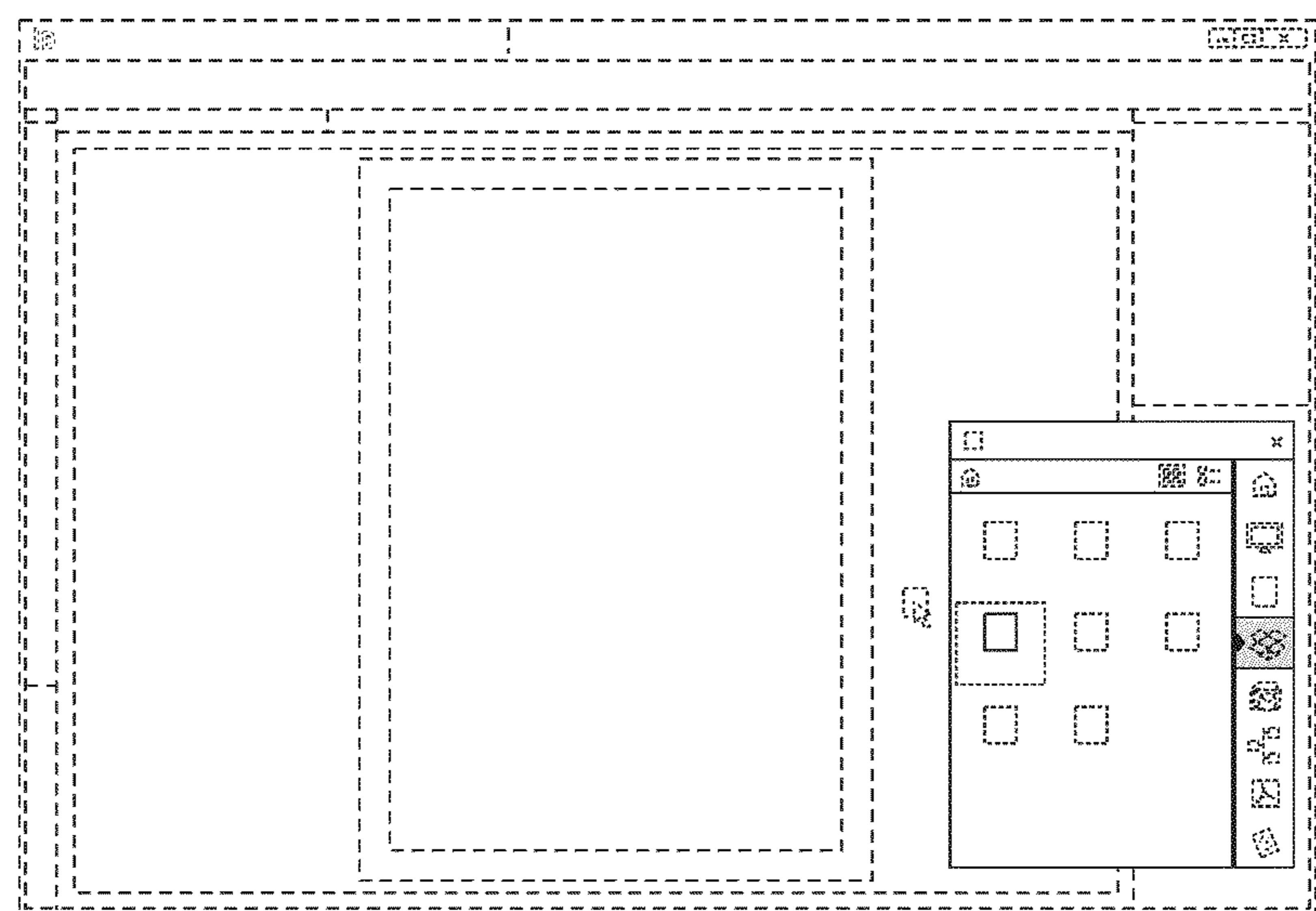

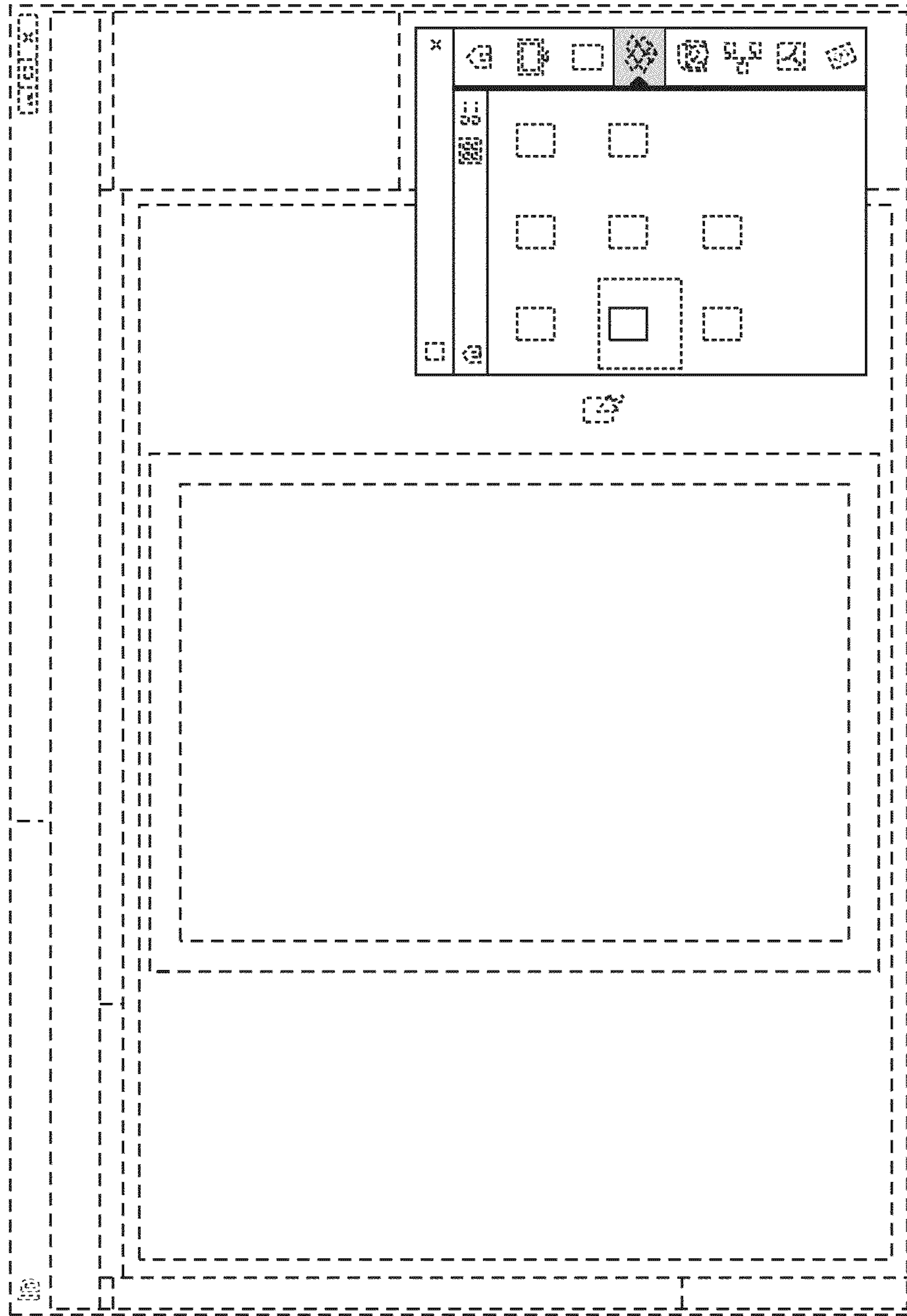
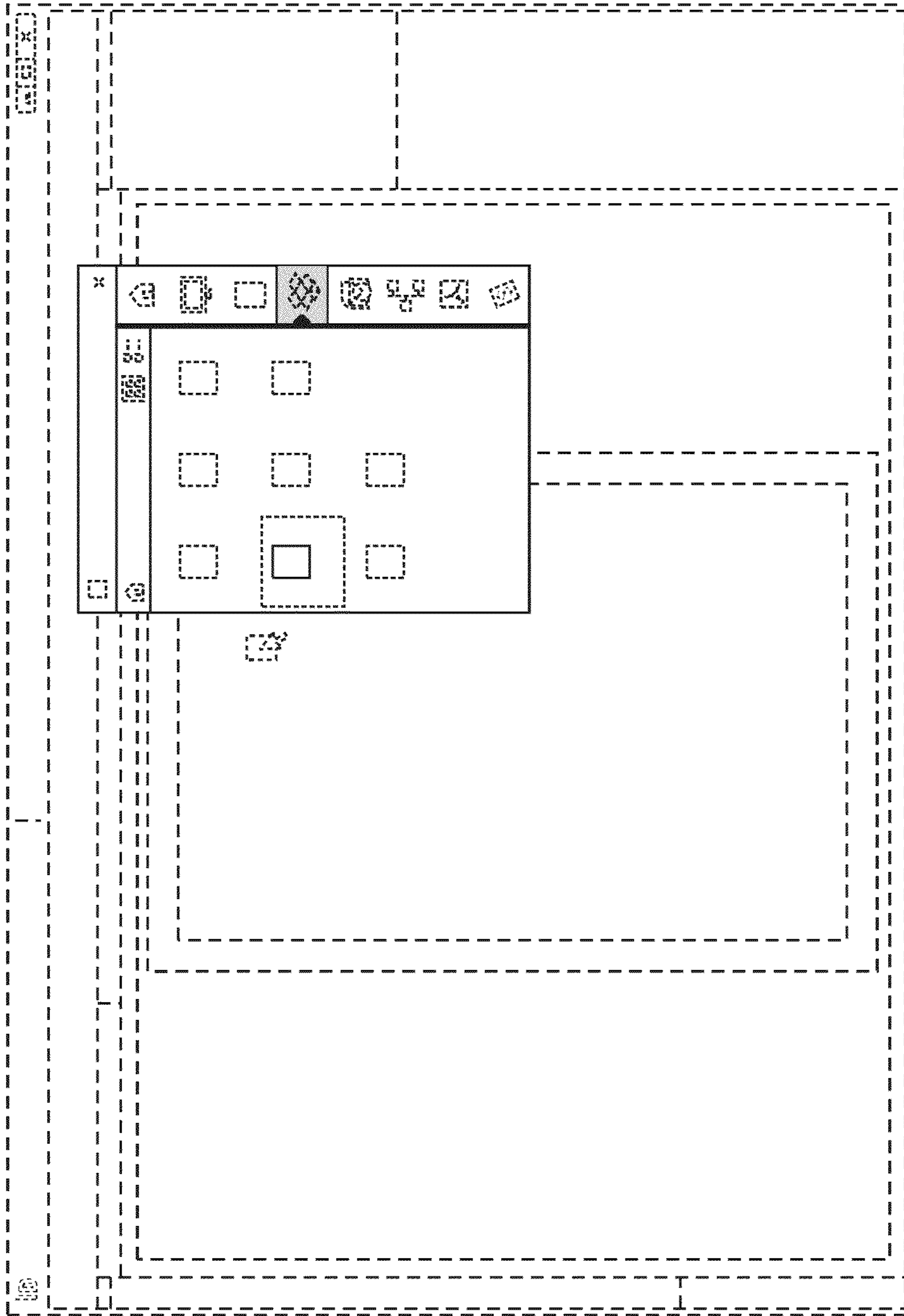

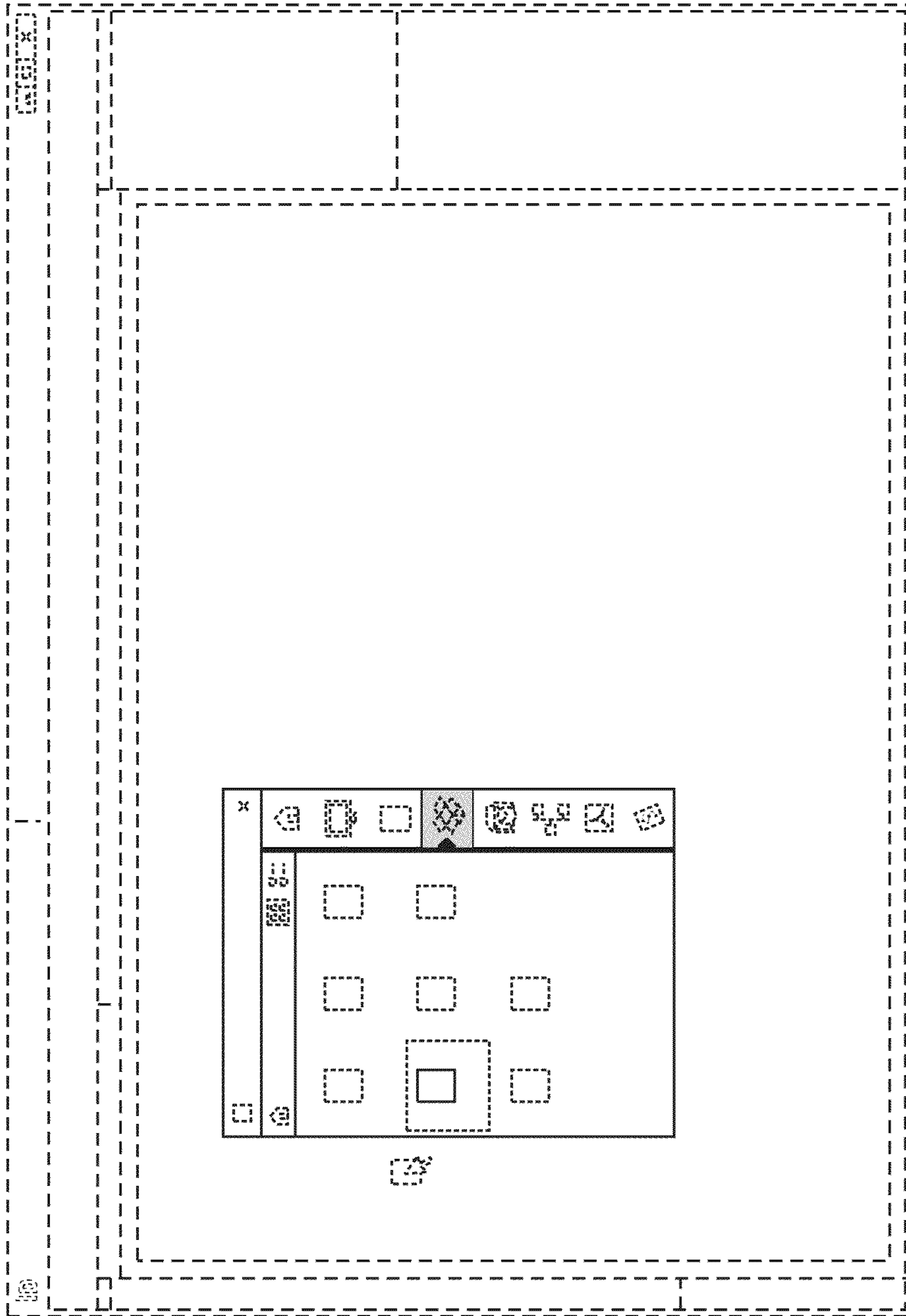
