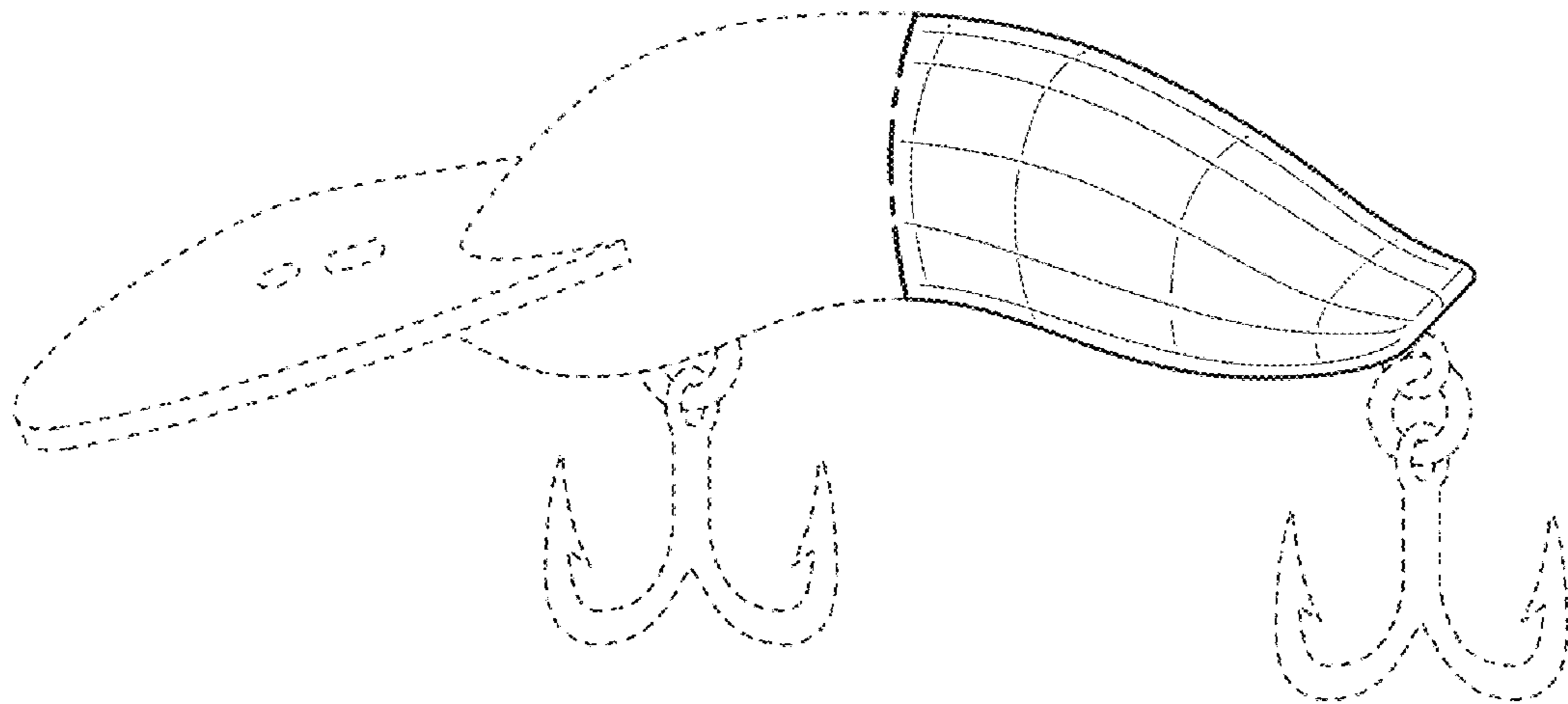

(57) **CLAIM**
The ornamental design for a fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of the fishing lure according to an embodiment;
 FIG. 2 is a right side view of the fishing lure illustrated in FIG. 1;
 FIG. 3 is a top view of the fishing lure illustrated in FIG. 1;
 FIG. 4 is a bottom view of the fishing lure illustrated in FIG. 1;
 FIG. 5 is a front view of the fishing lure illustrated in FIG. 1;
 FIG. 6 is a rear view of the fishing lure illustrated in FIG. 1;

 FIG. 7 is a cross-sectional view of the fishing lure illustrated in FIG. 1 taken along line 7-7 in FIG. 2.

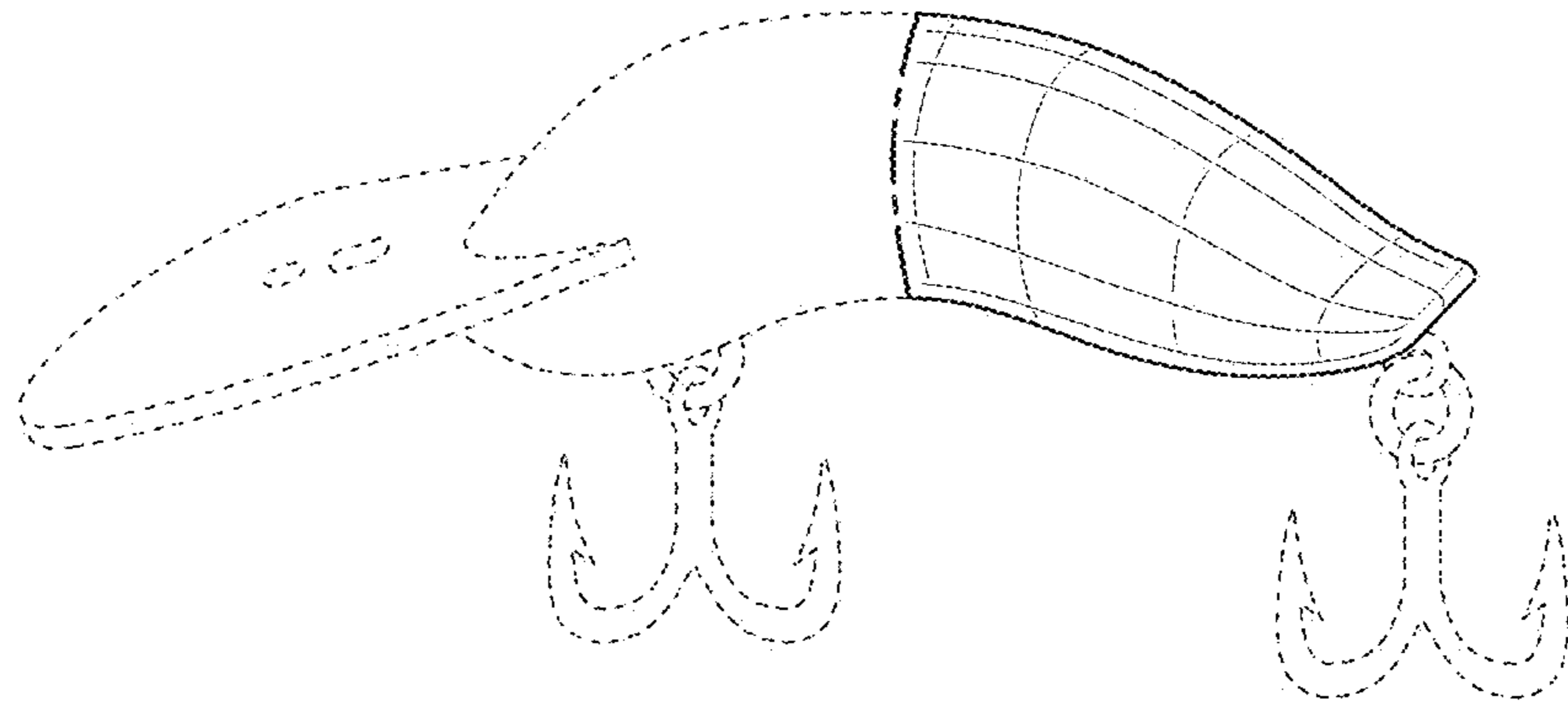

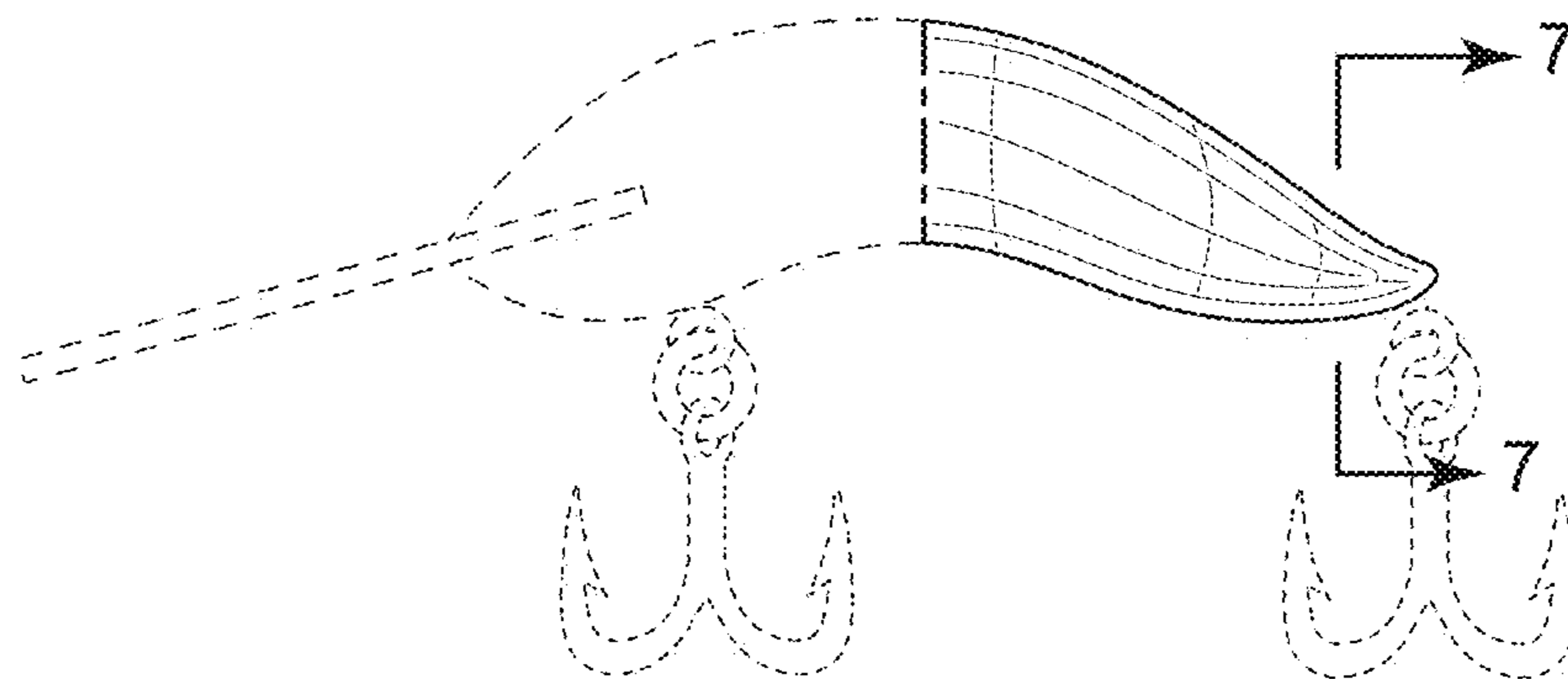

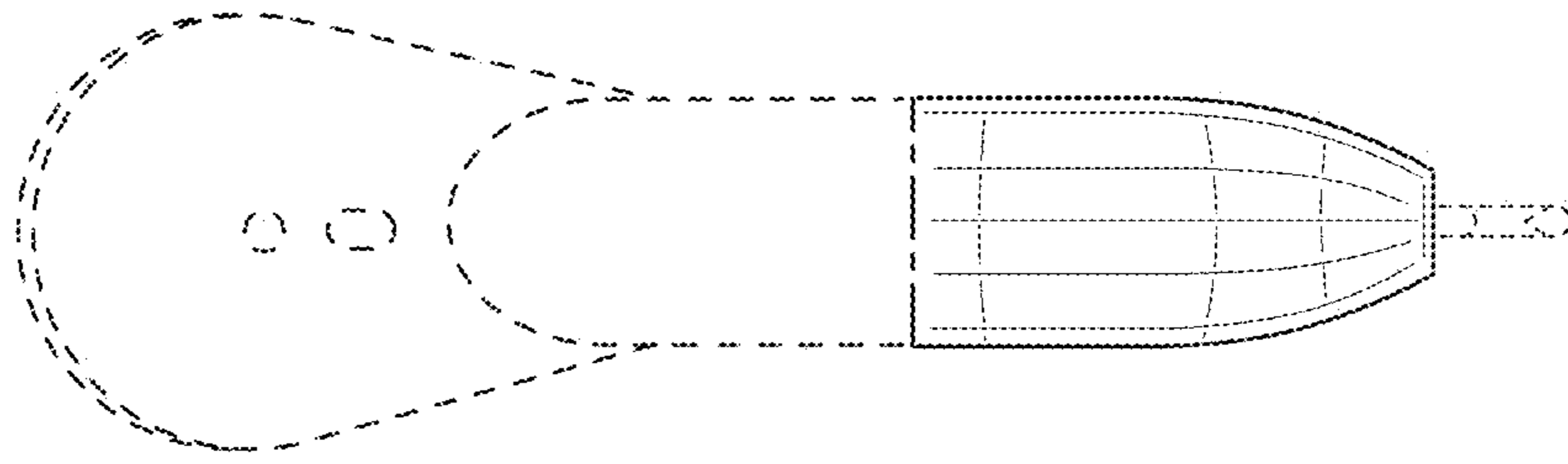

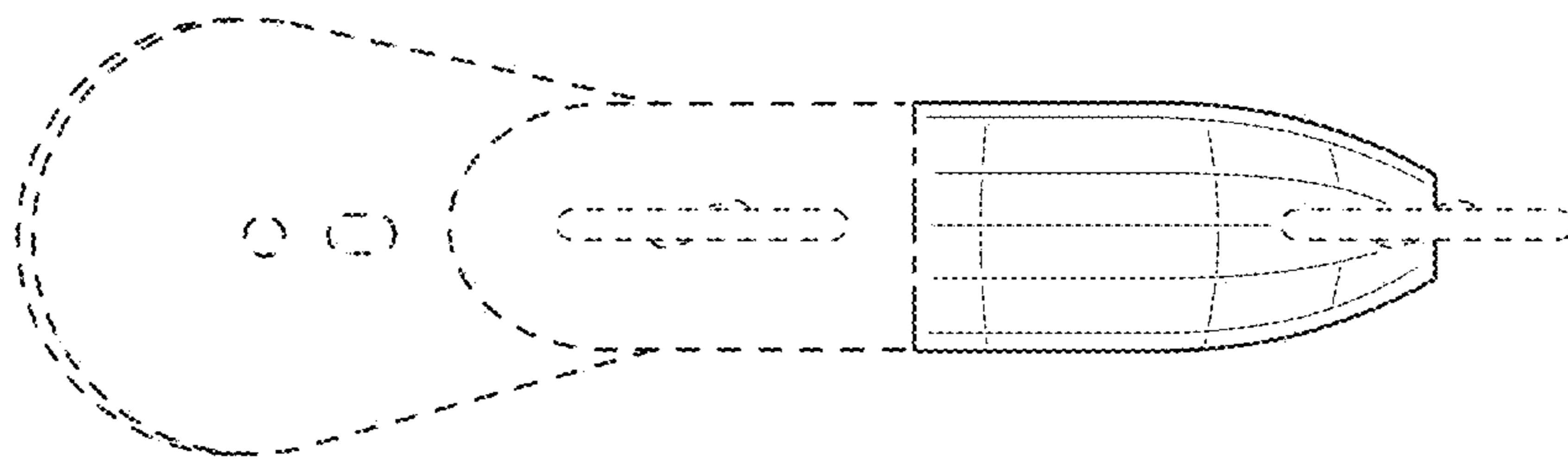

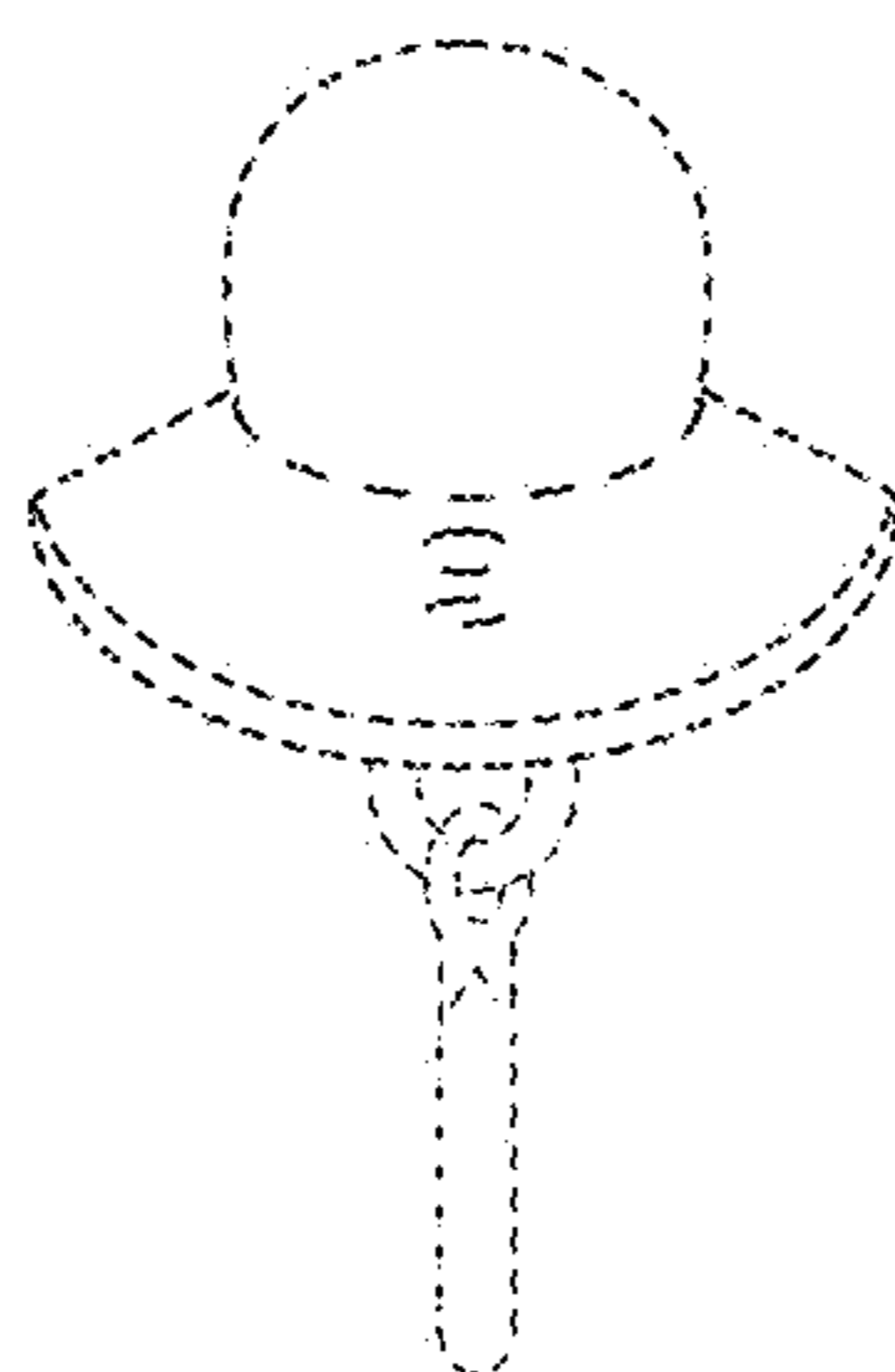

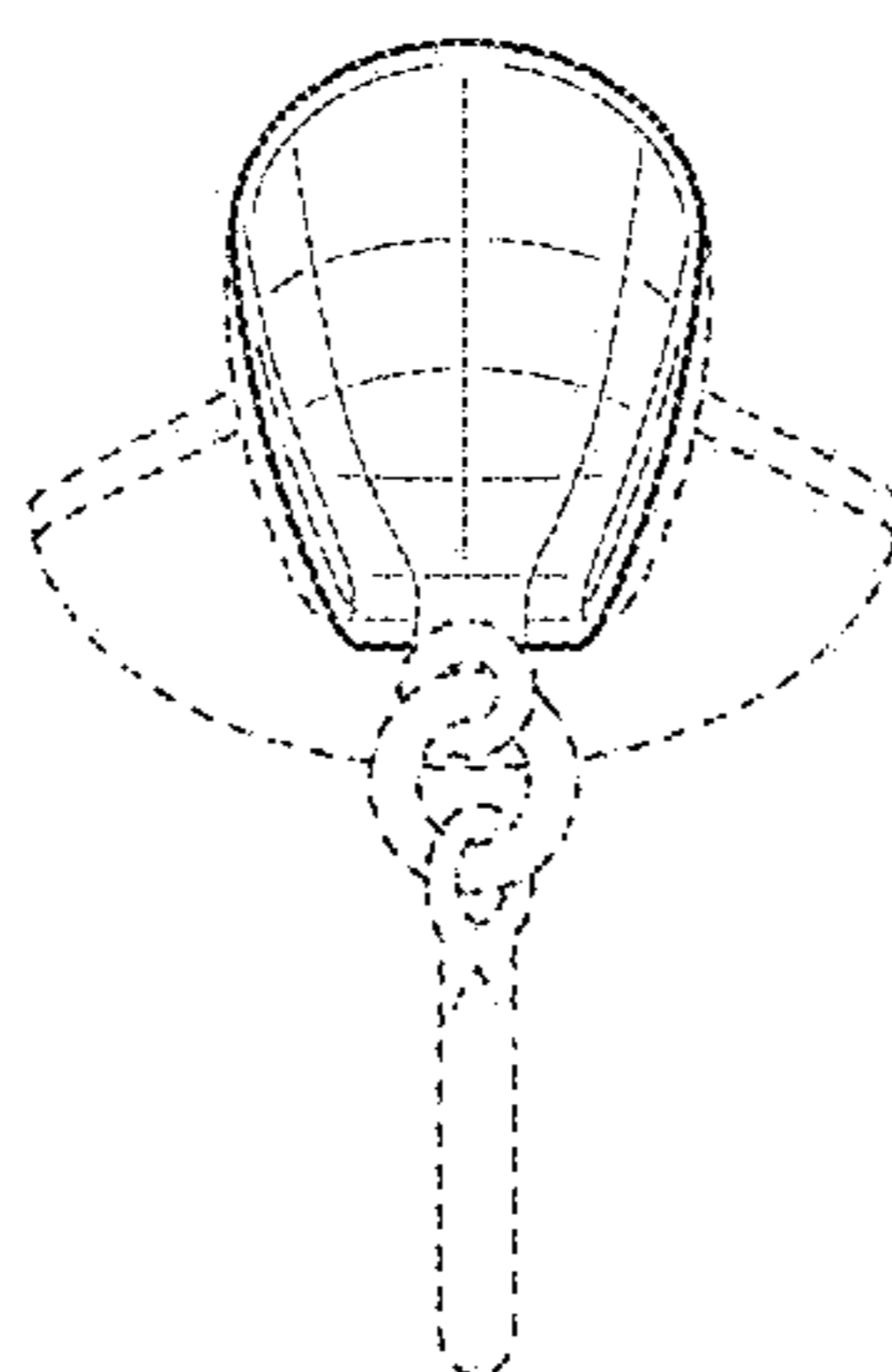
