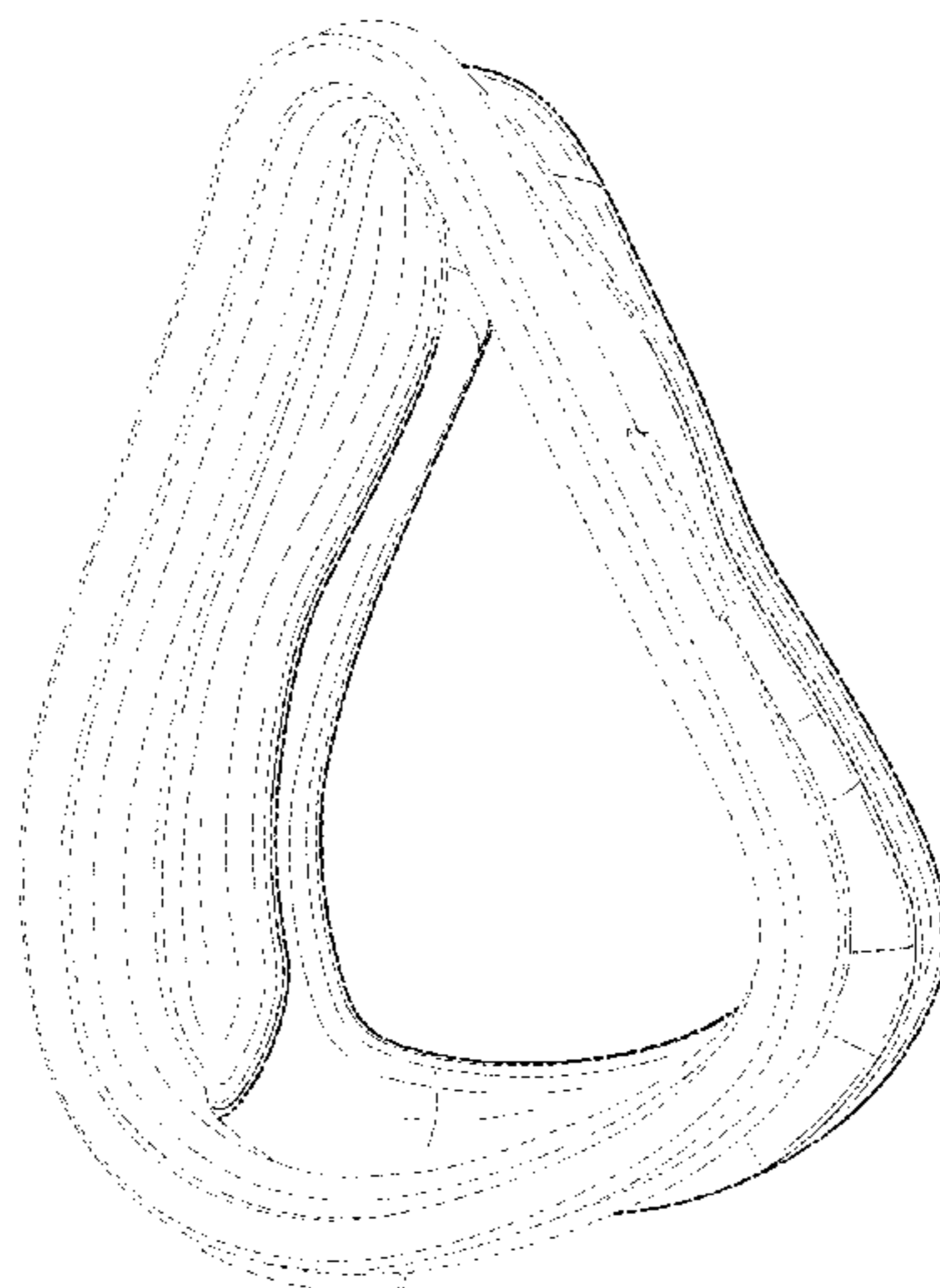
The ornamental design for a cushion for a respiratory mask, as shown and described.

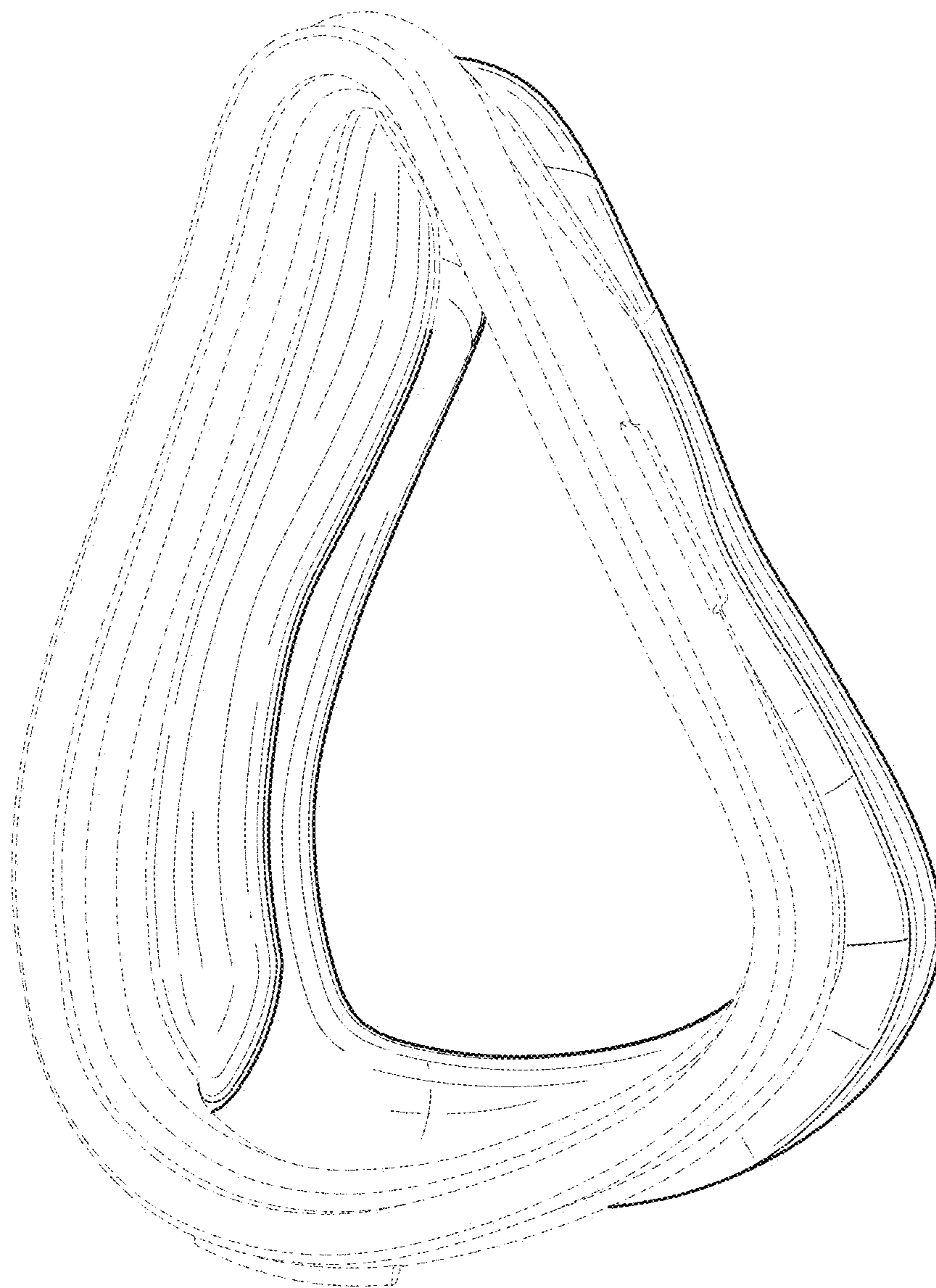

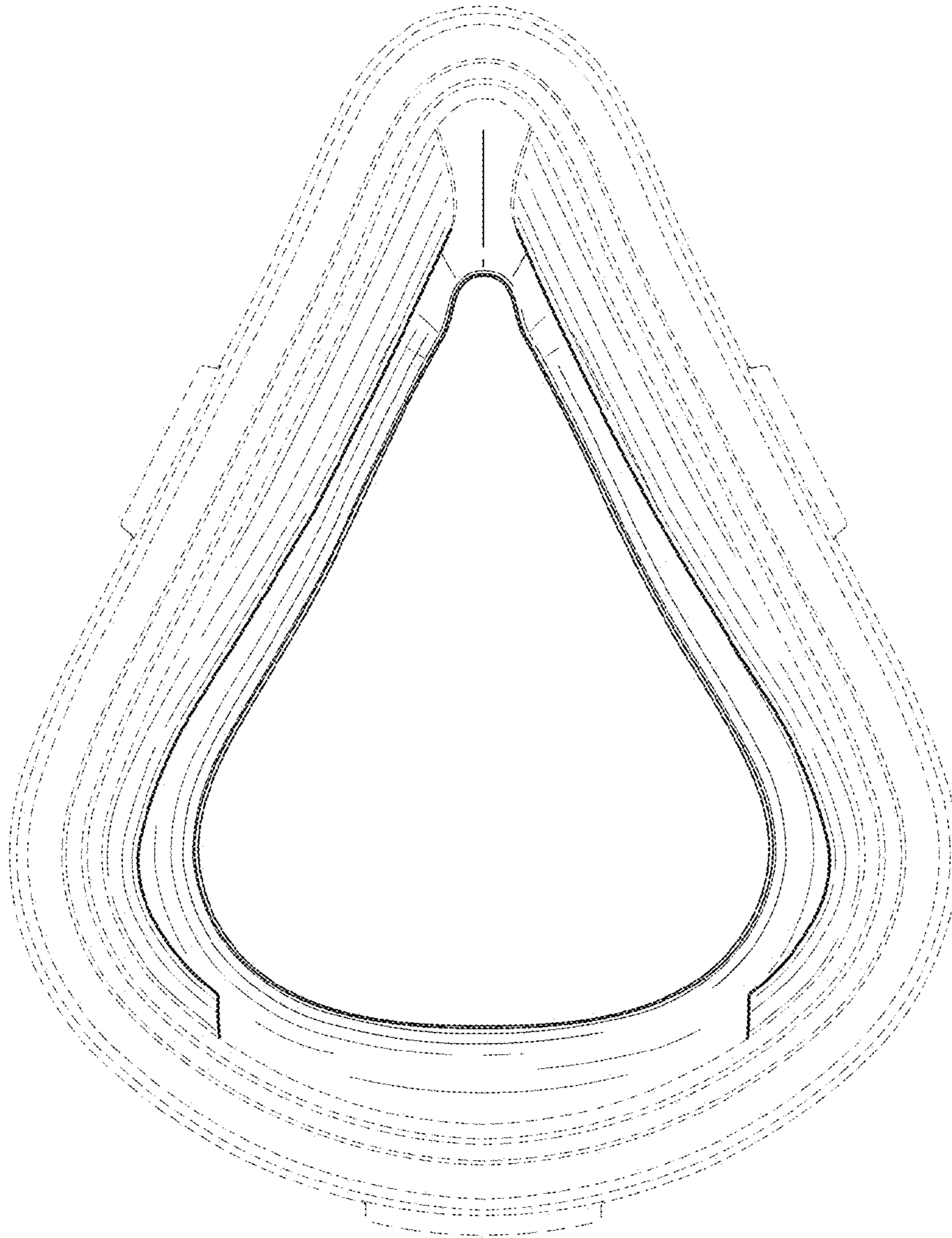

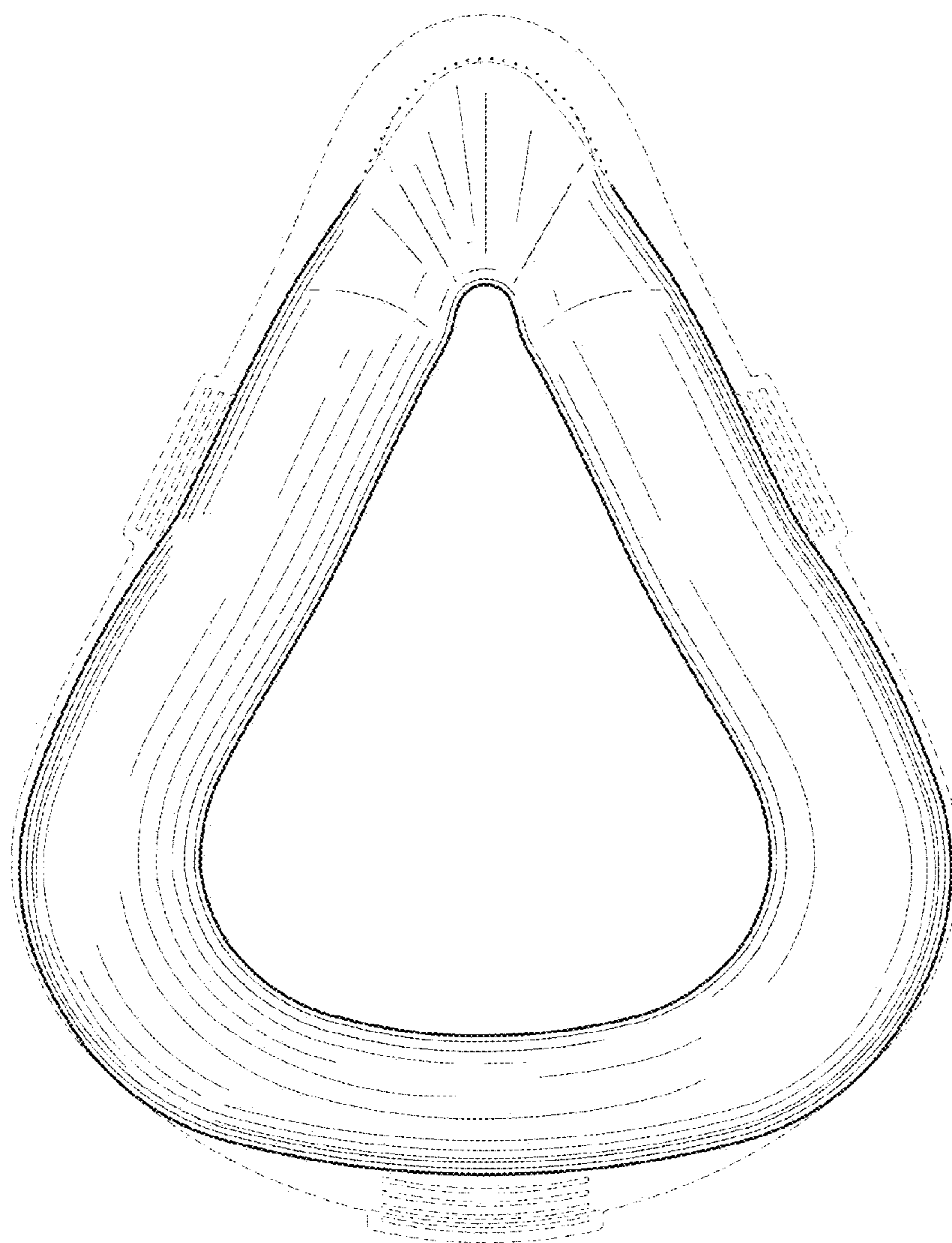

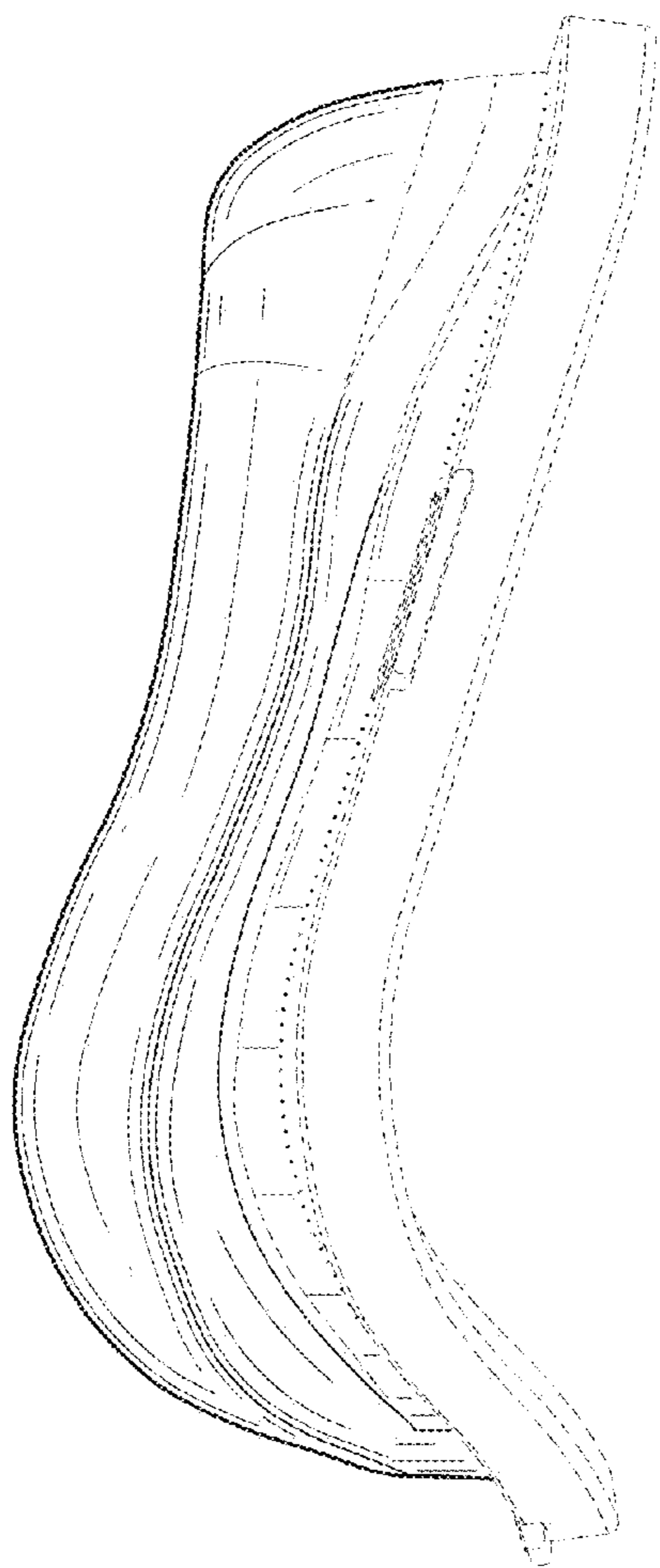

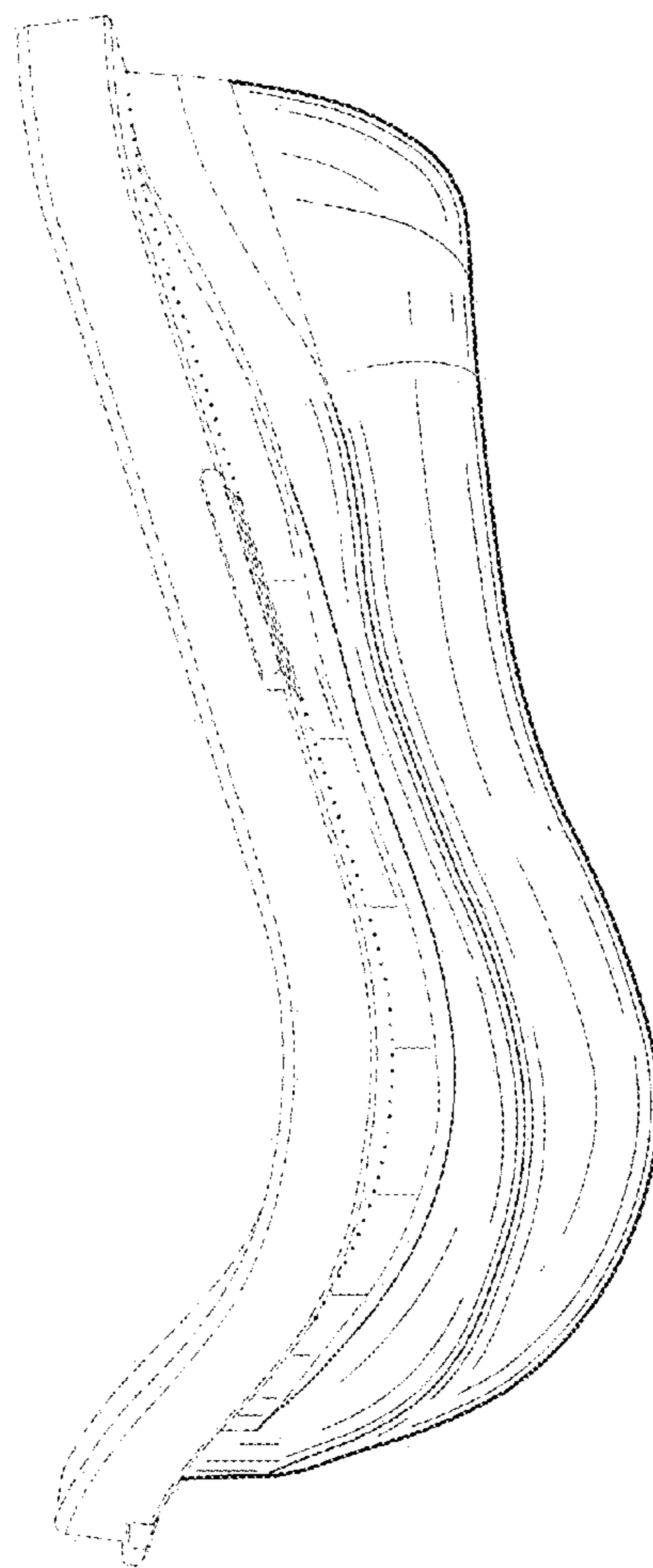

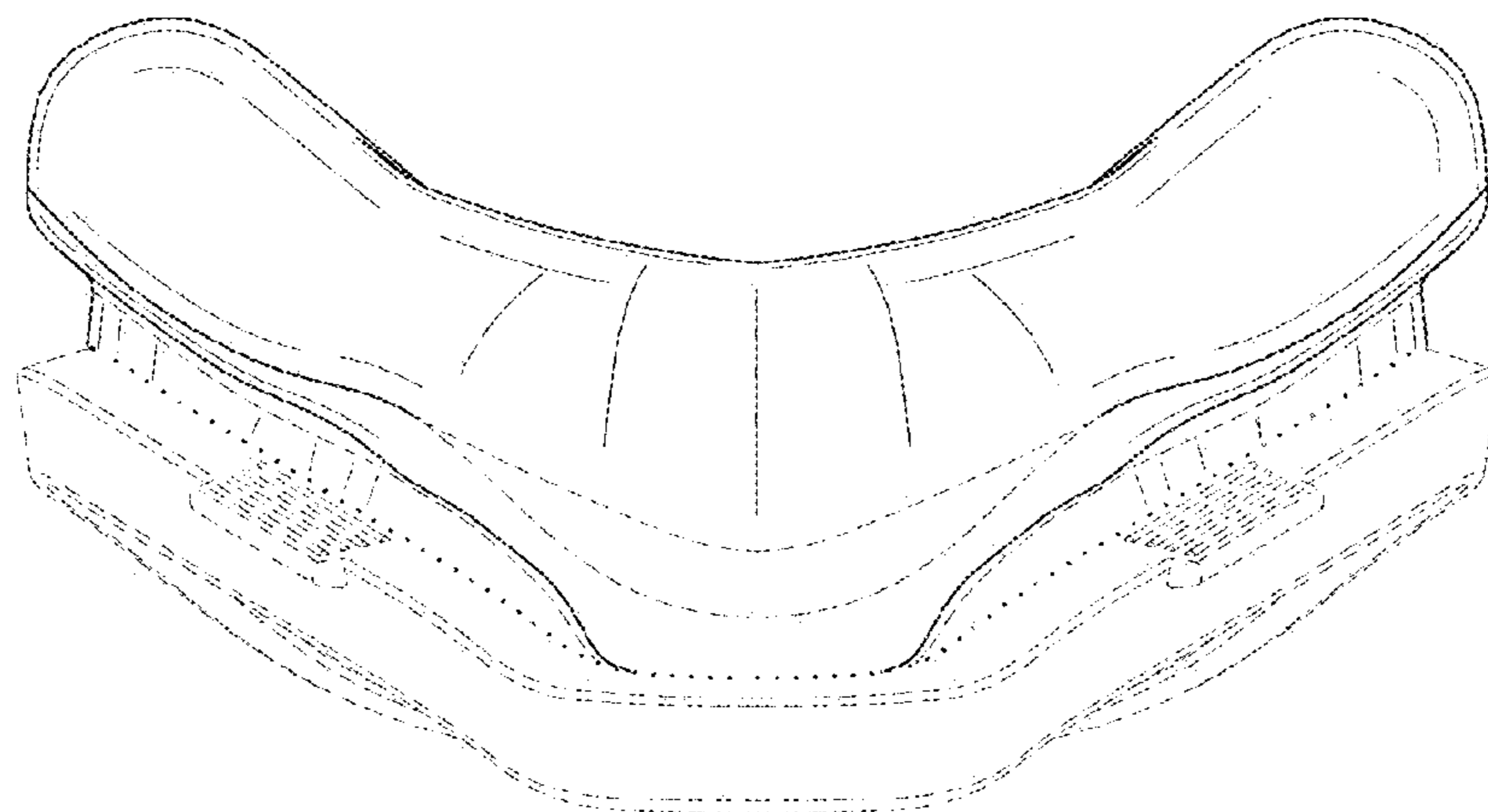

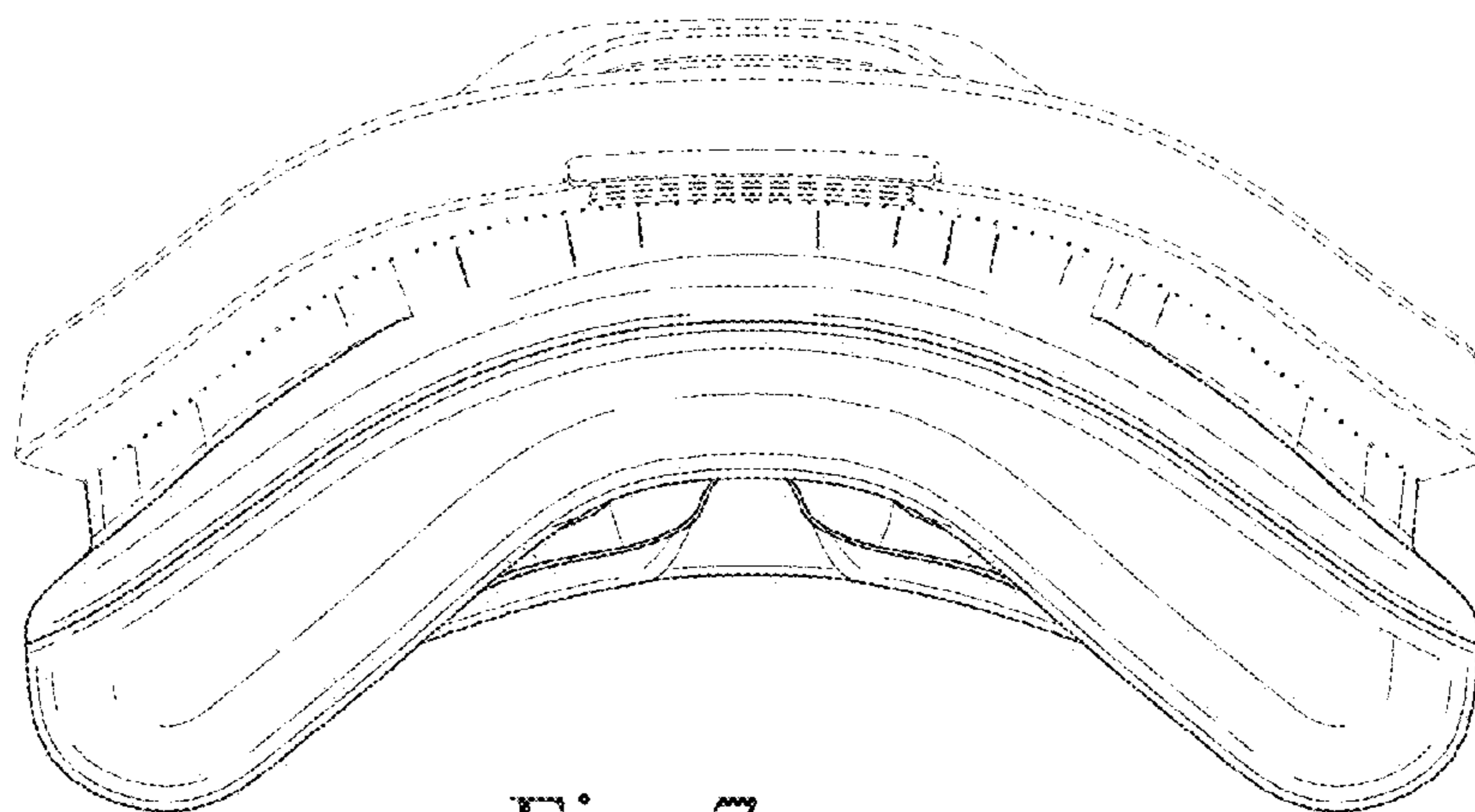

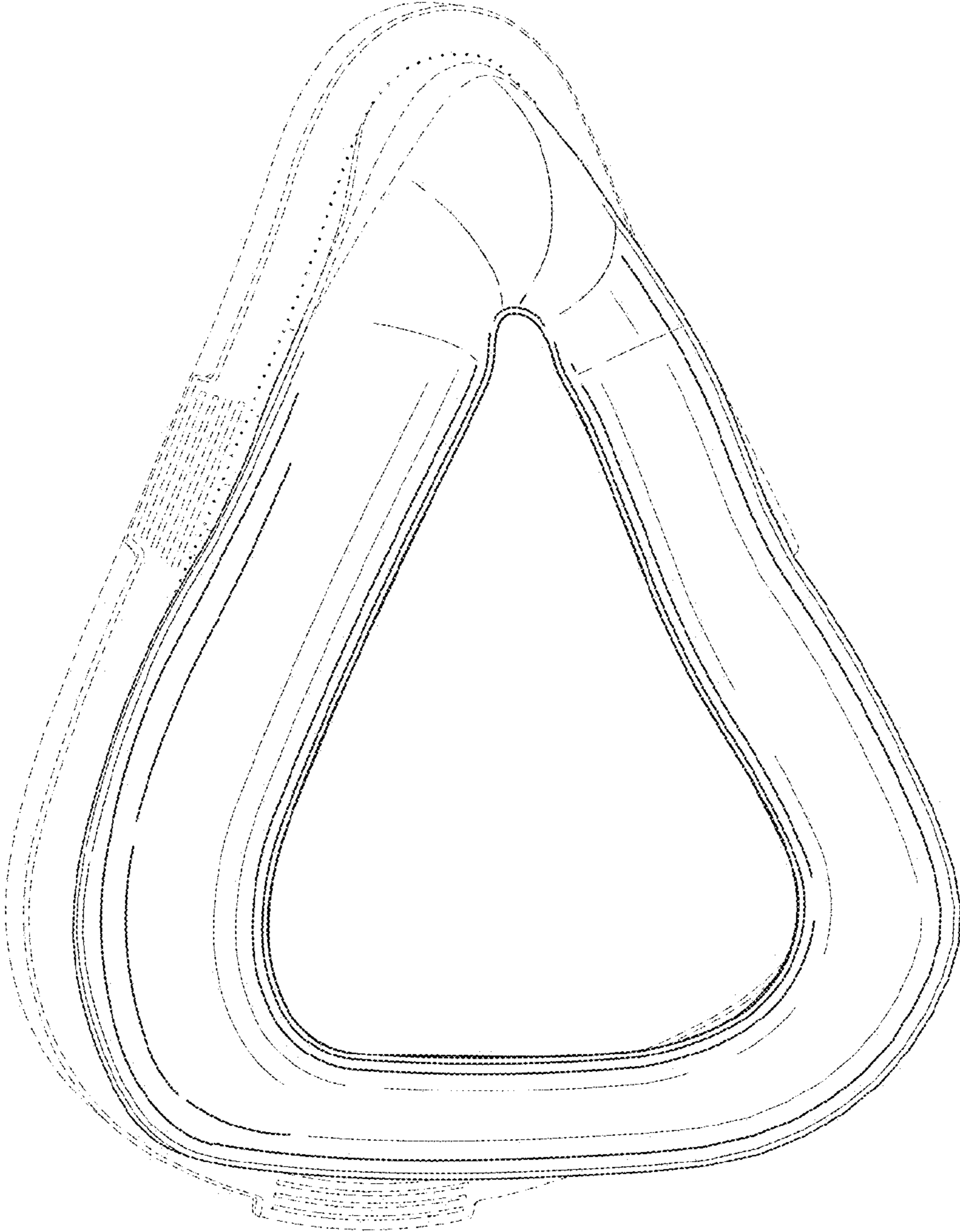
