(57) **CLAIM**

We claim the ornamental design for an earpiece, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an earpiece showing our new design;

FIG. 2 is a front view of FIG. 1;

FIG. 3 is a back view of FIG. 1;

FIG. 4 is a top view of FIG. 1;

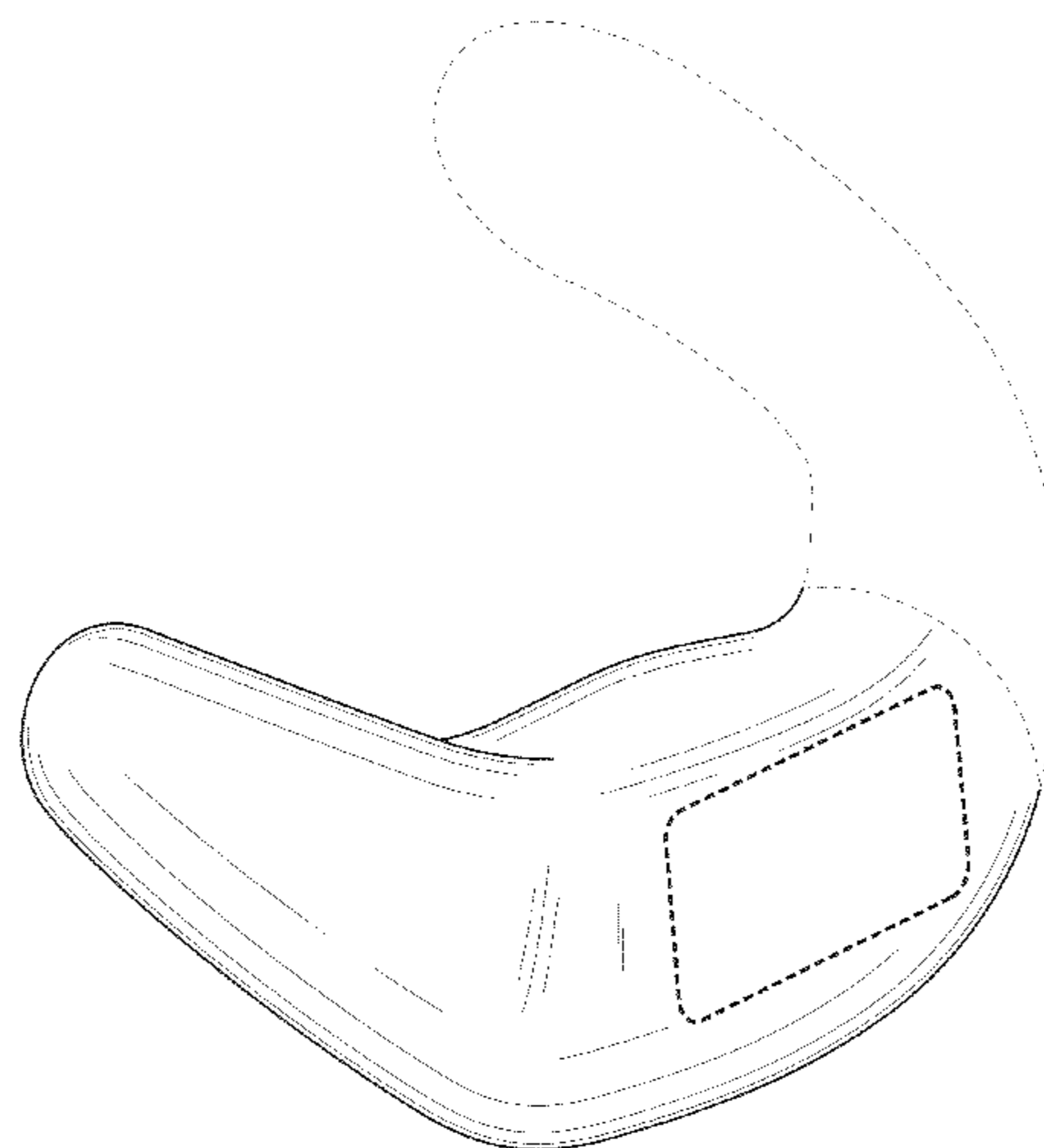
FIG. 5 is a bottom view of FIG. 1;

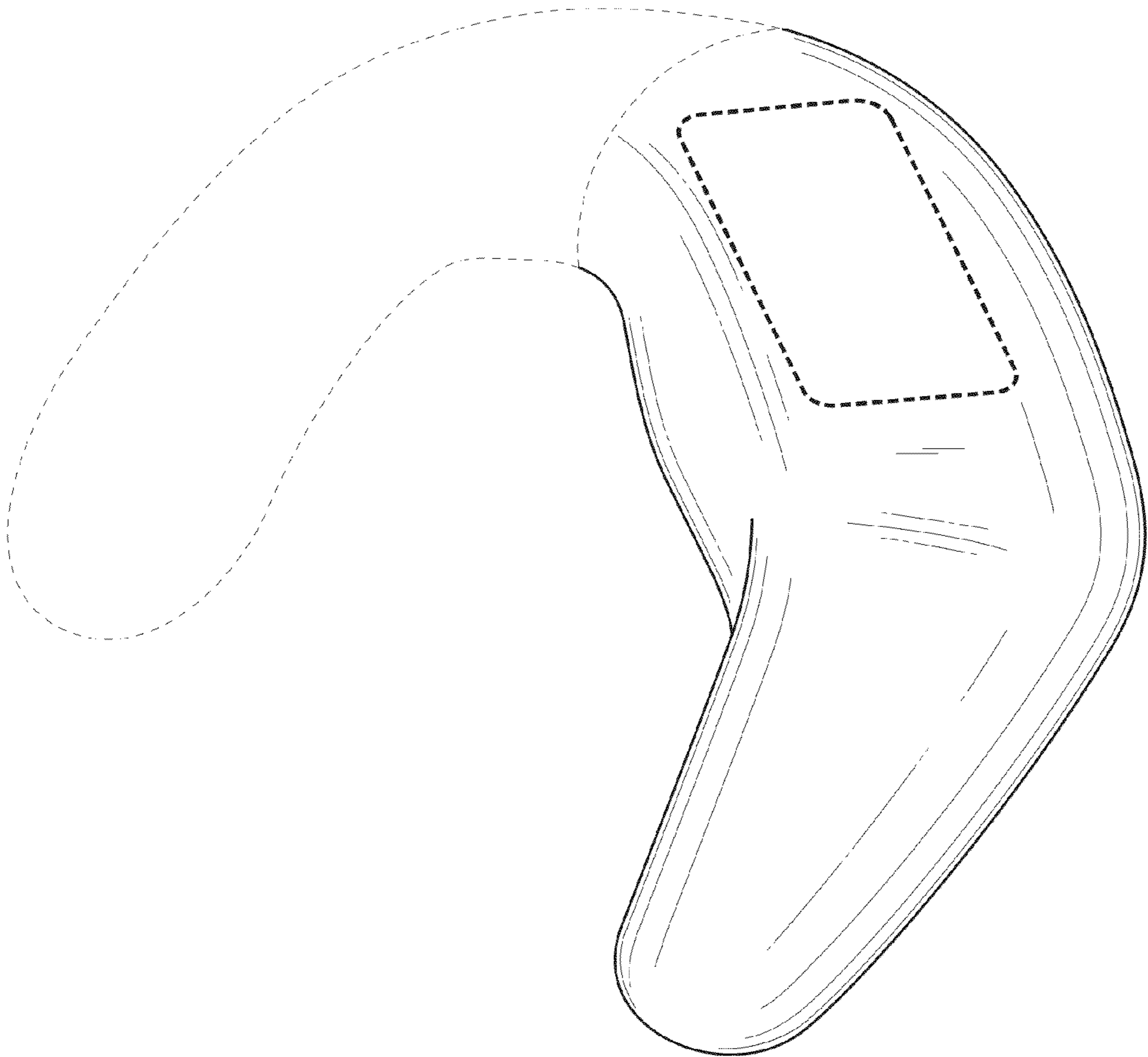
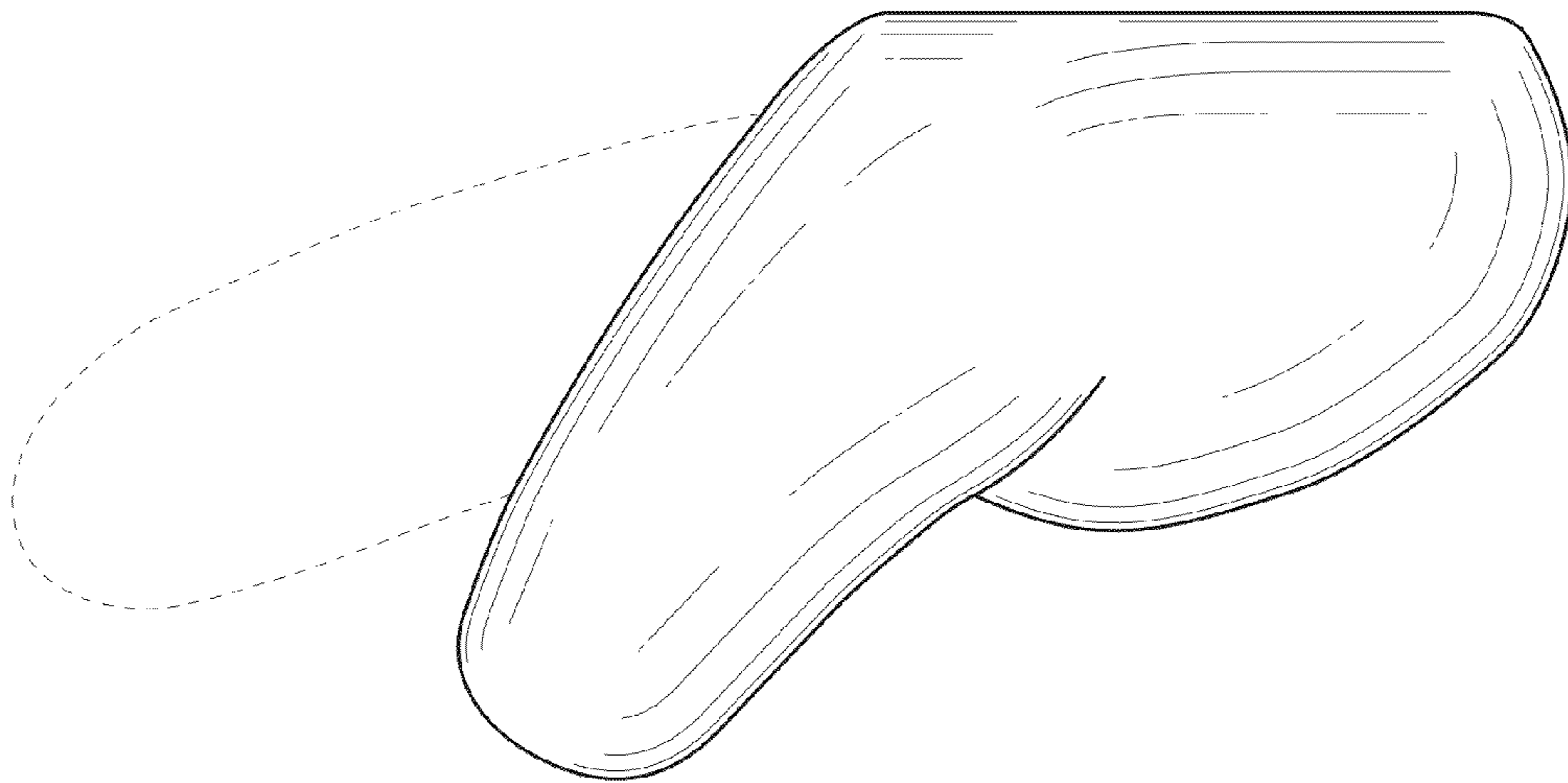

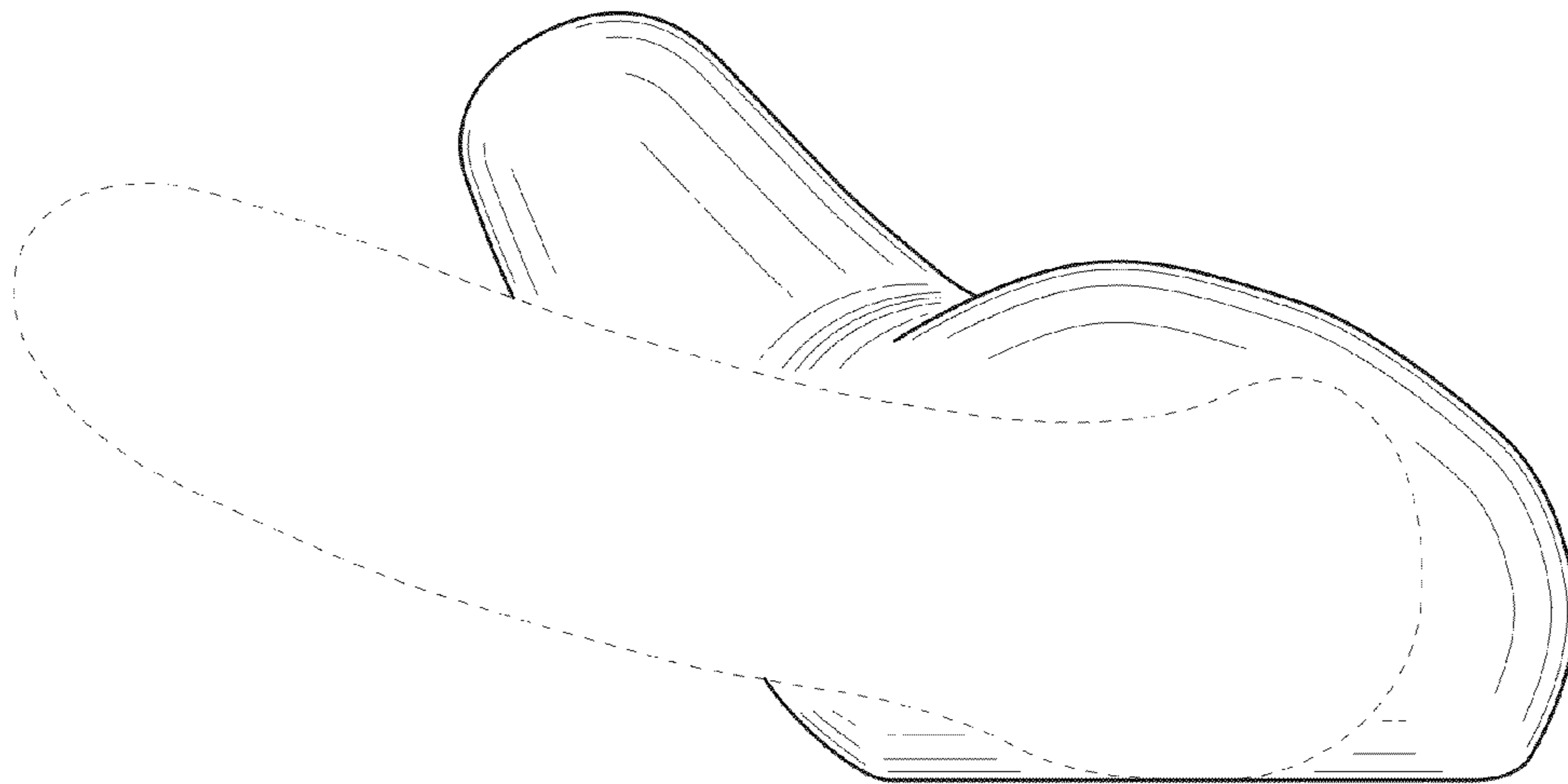

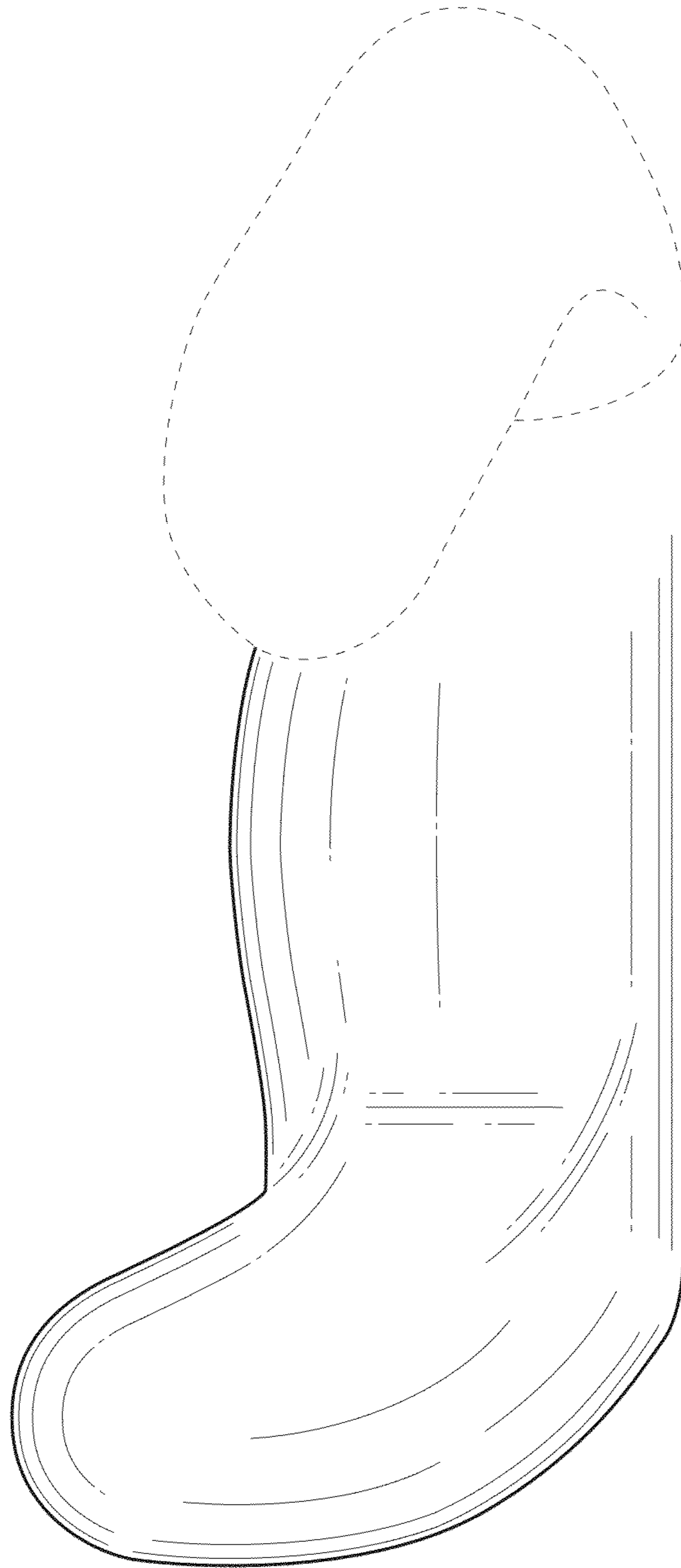

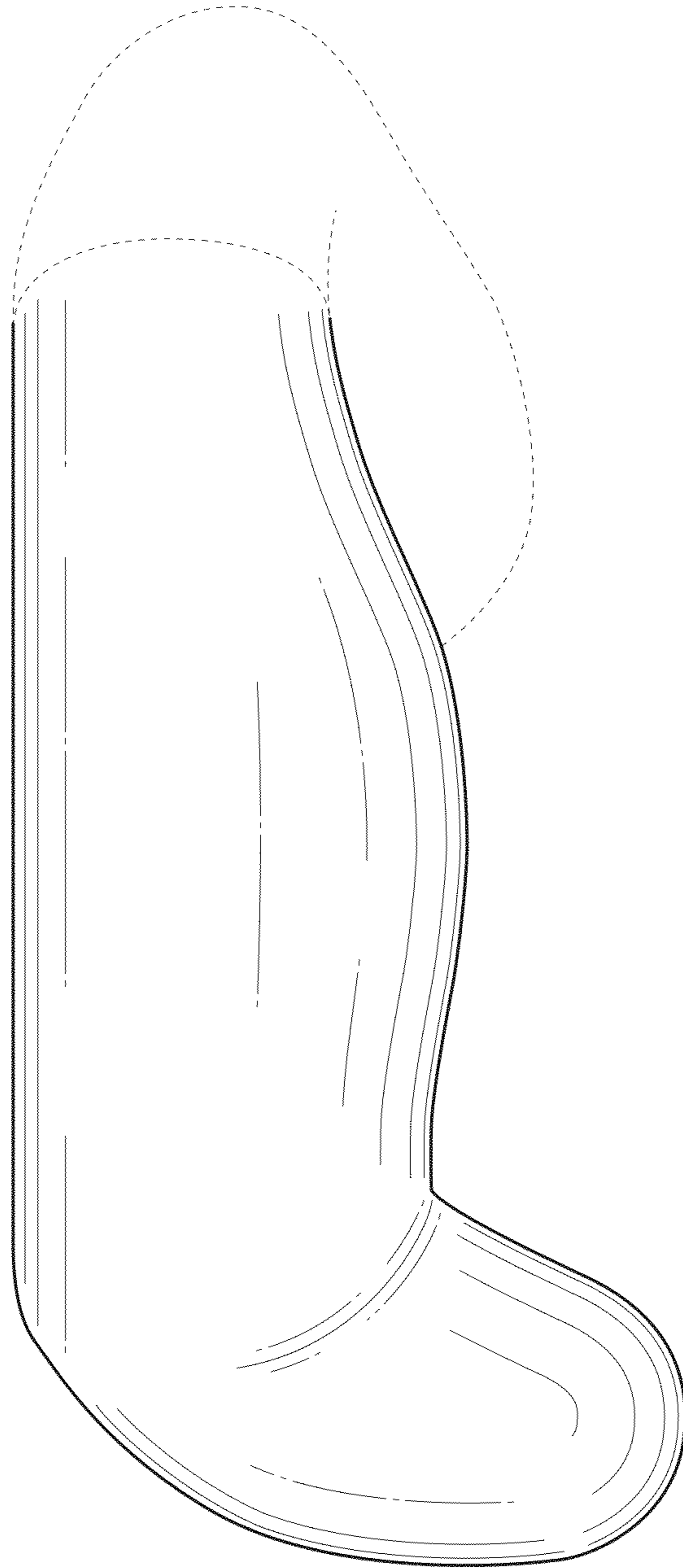

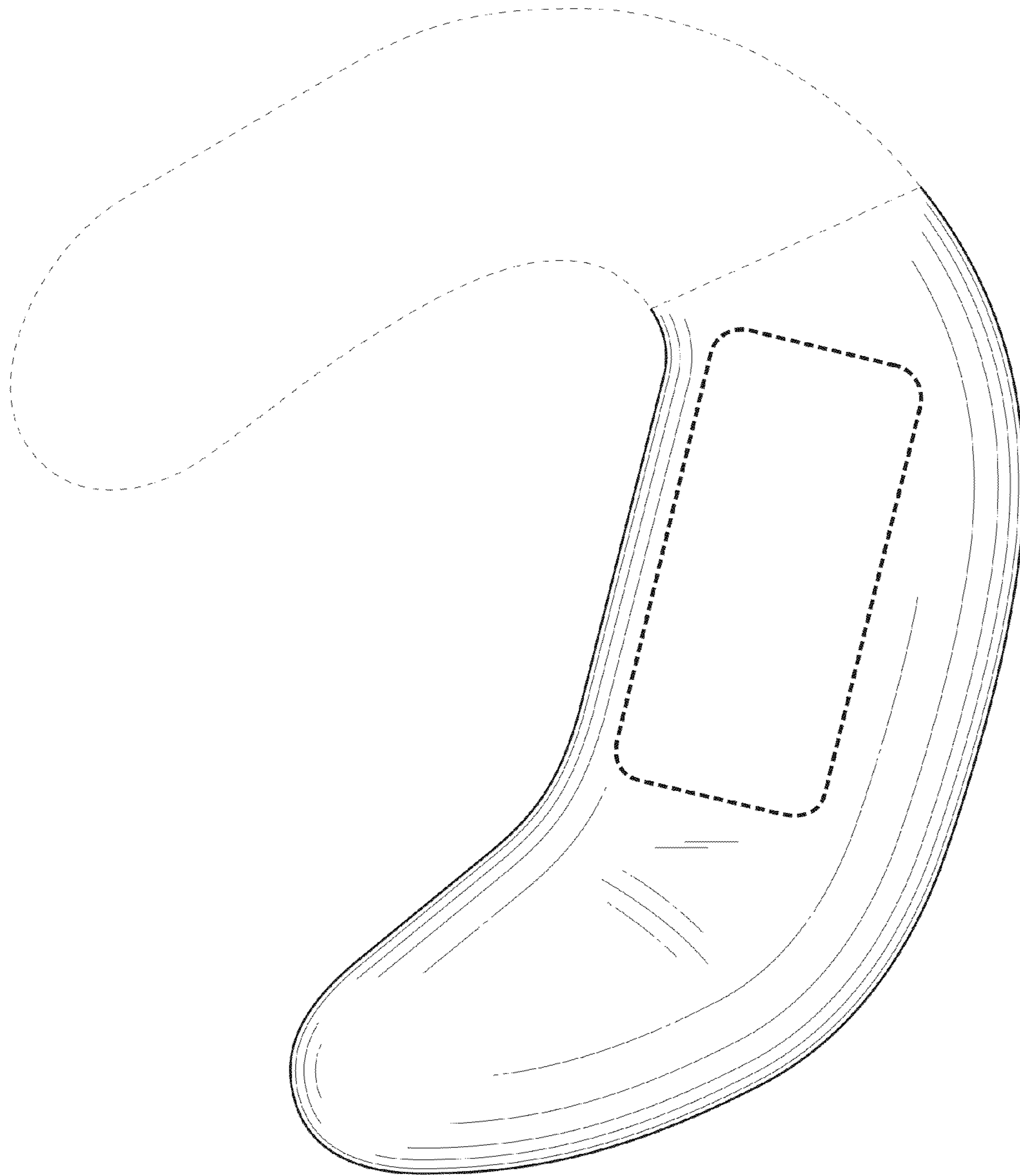
