(57) **CLAIM**

The ornamental design for a tile mosaic, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a tile mosaic showing my new design; FIG. 2 is a right side view thereof; FIG. 3 is a bottom side view thereof; FIG. 4 is a front view of a tile mosaic showing a second embodiment of my new design; FIG. 5 is a right side view thereof; and, FIG. 6 is a bottom side view thereof.

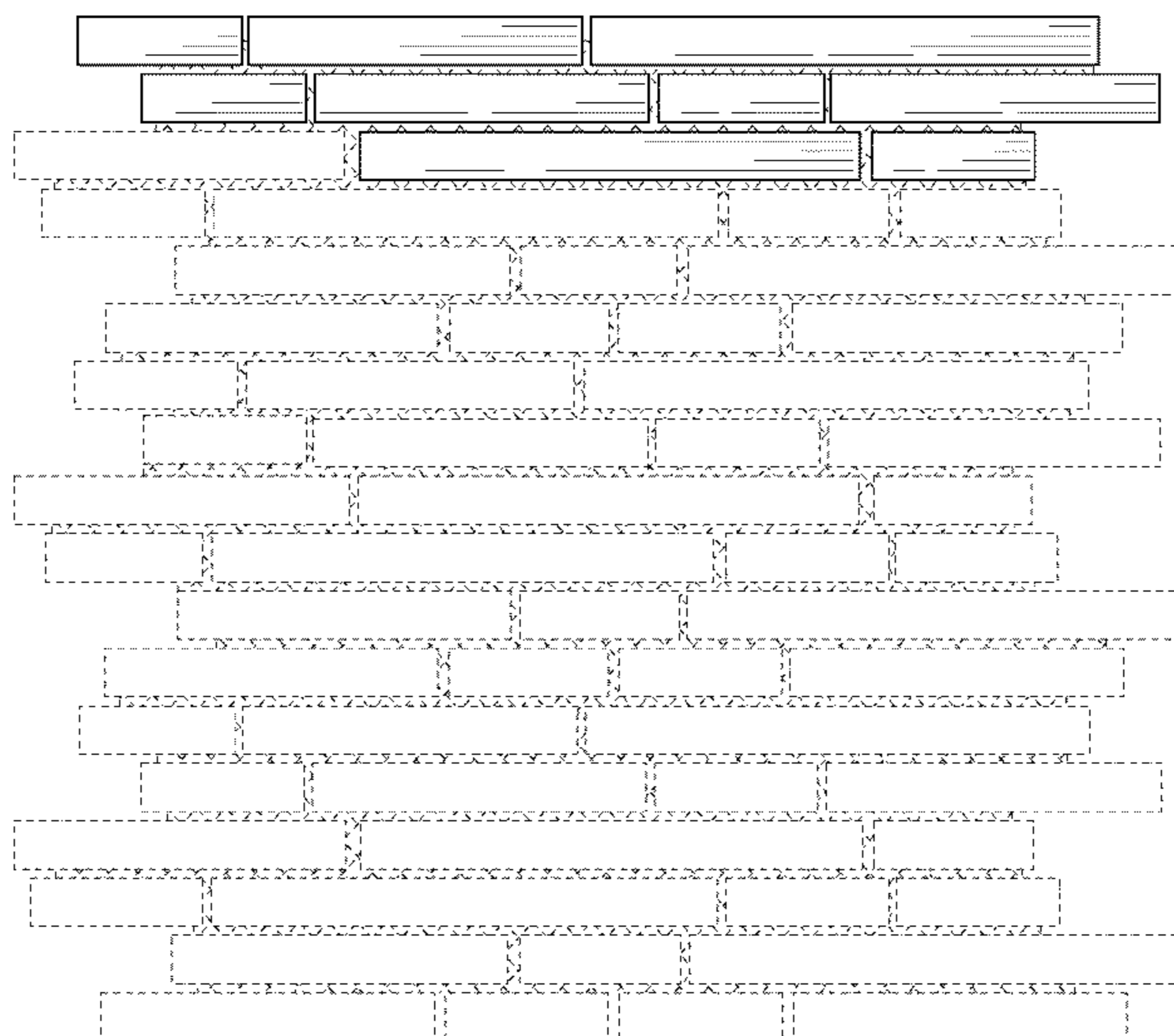

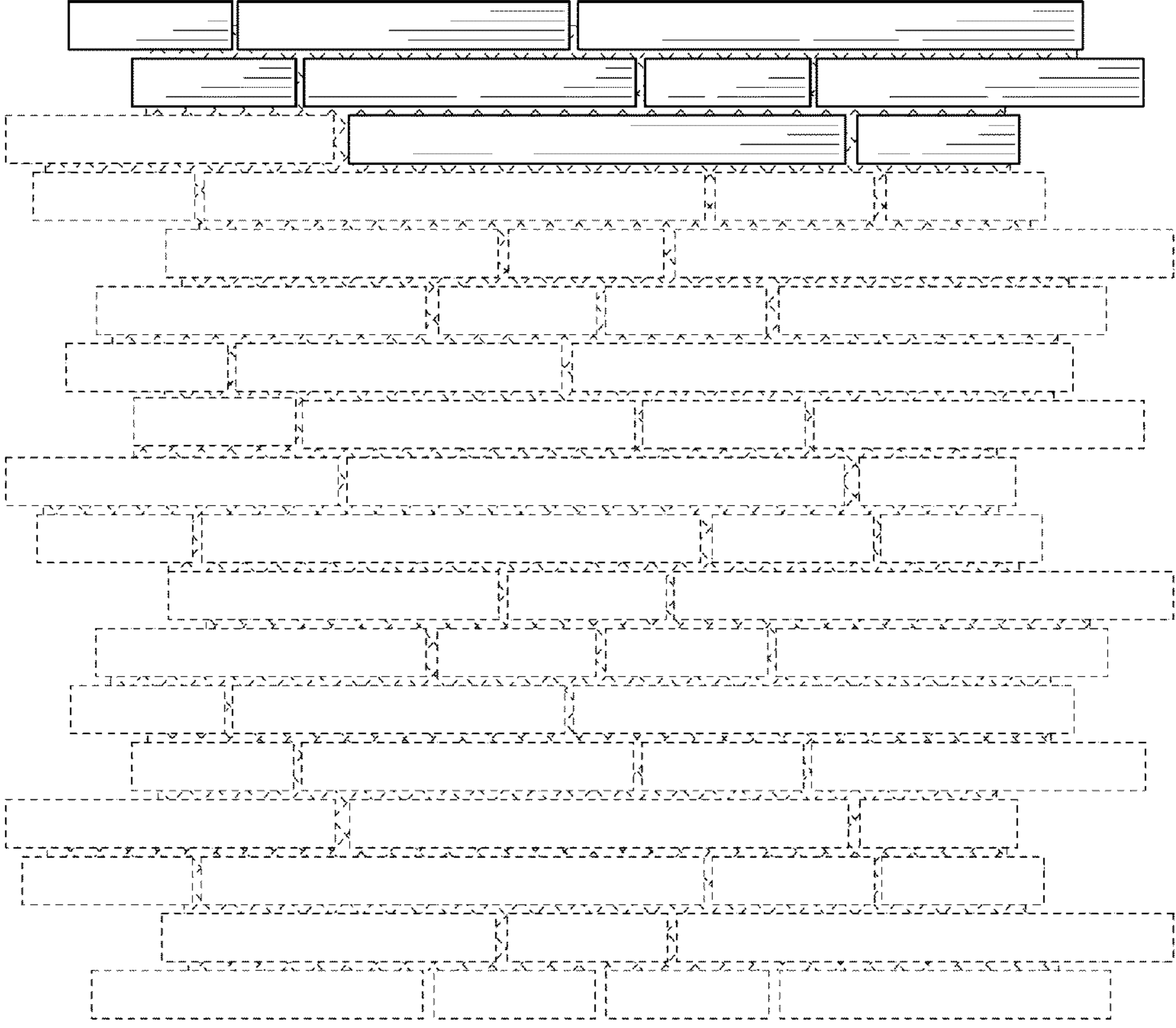

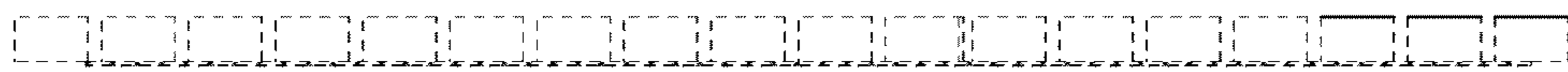

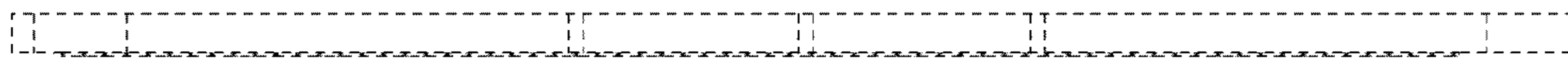

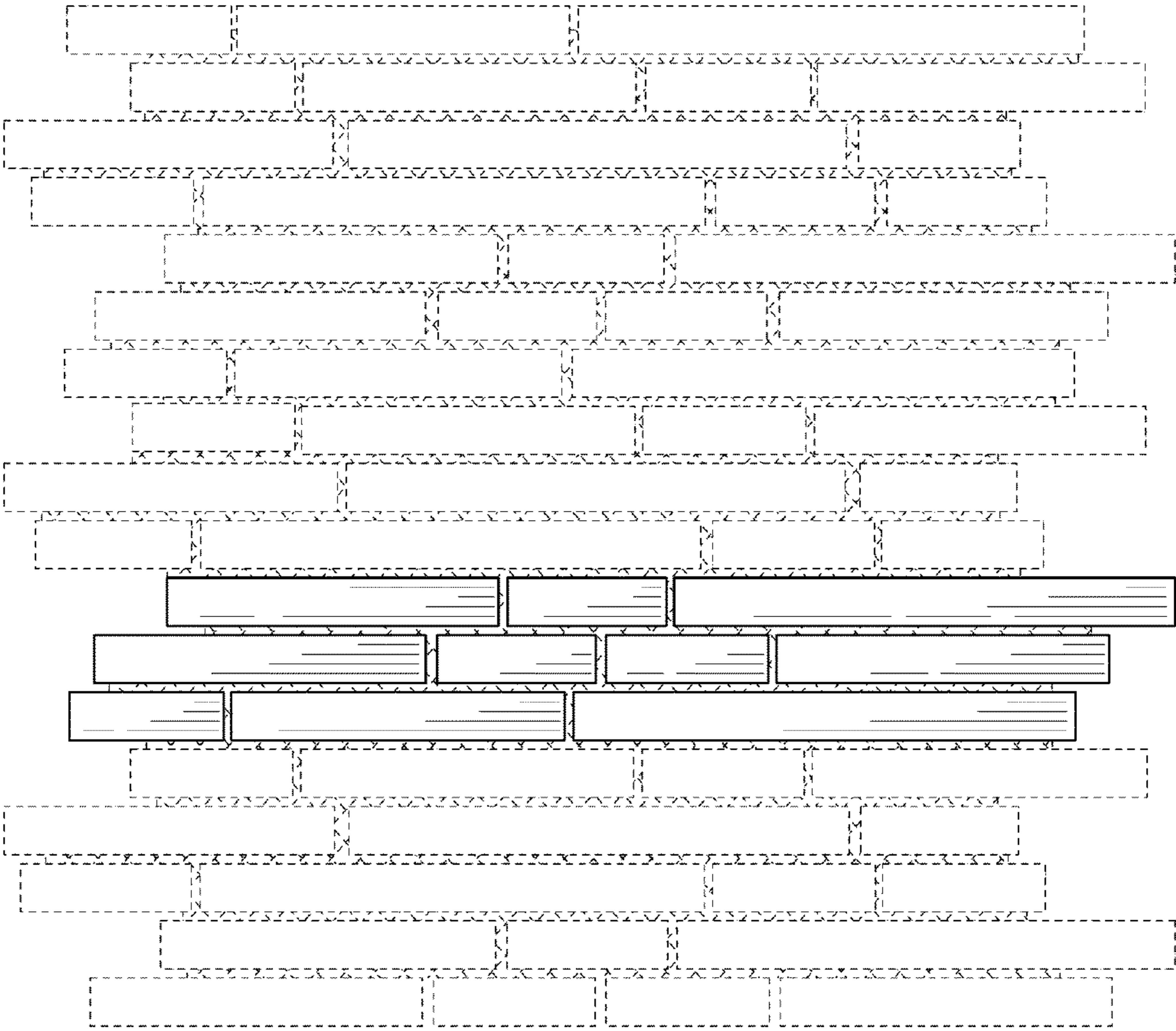

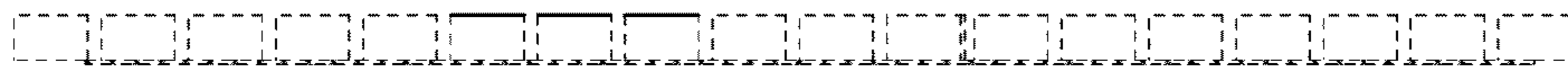

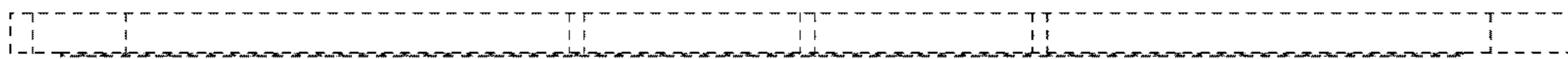
