The ornamental design for a nursing scarf, as shown and described.

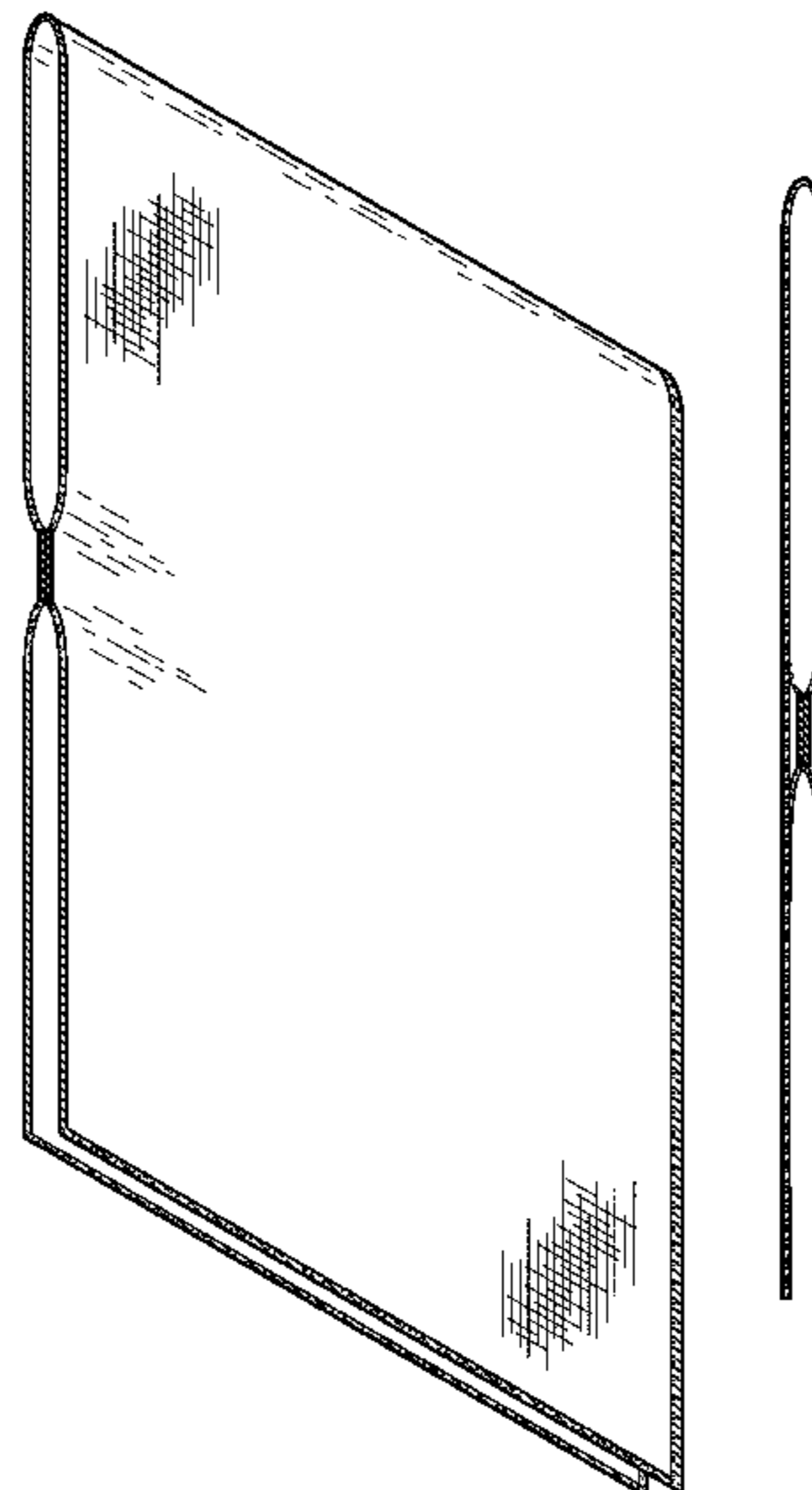
**DESCRIPTION**

FIG. 1 is a front perspective view of a nursing scarf showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a front perspective view of the nursing scarf shown in an environment of use thereof;  
FIG. 9 is a front perspective view of the nursing scarf shown collected in an environment of use thereof;  
FIG. 10 is a front perspective view of the nursing scarf shown in another environment of use thereof; and,  
FIG. 11 is a rear perspective view of the nursing scarf shown in the environment of use of FIG. 10.

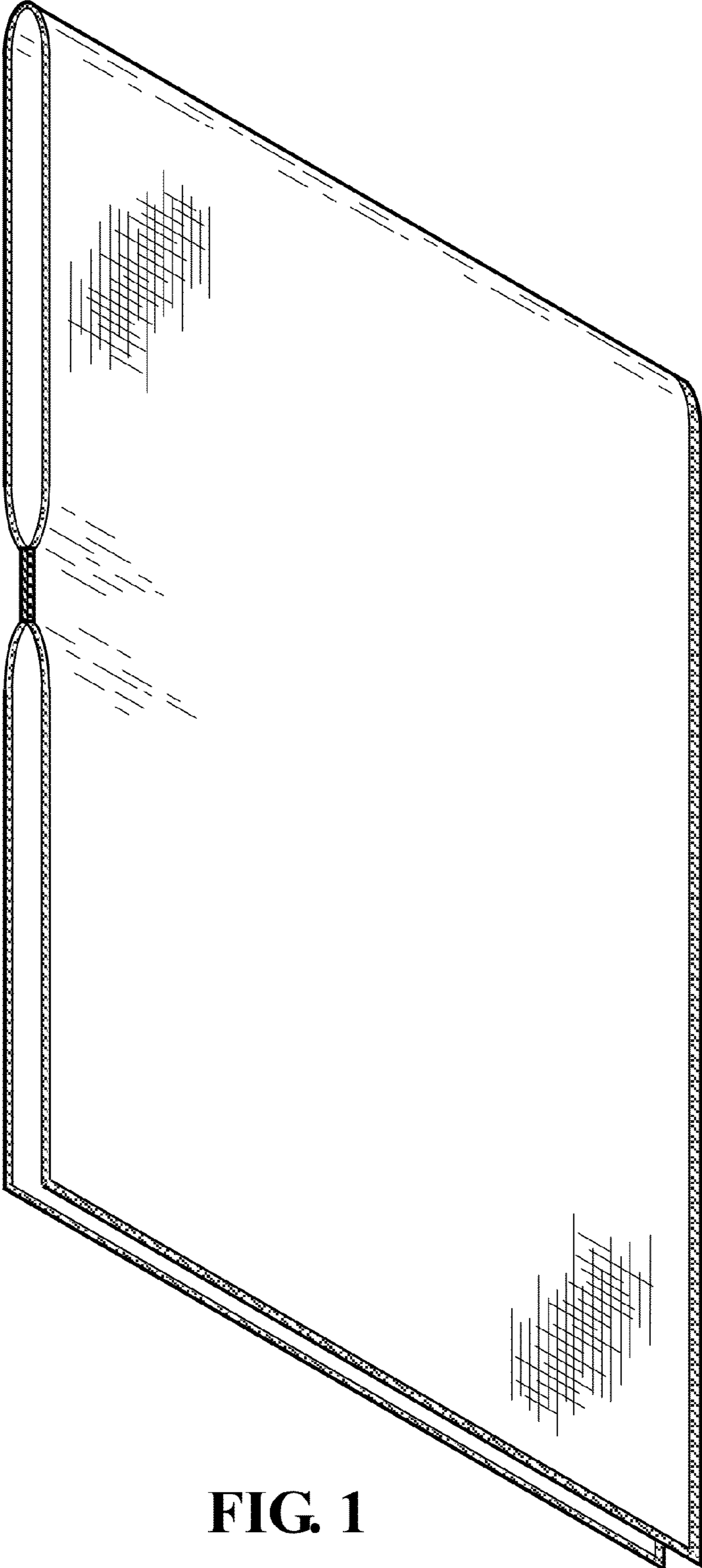

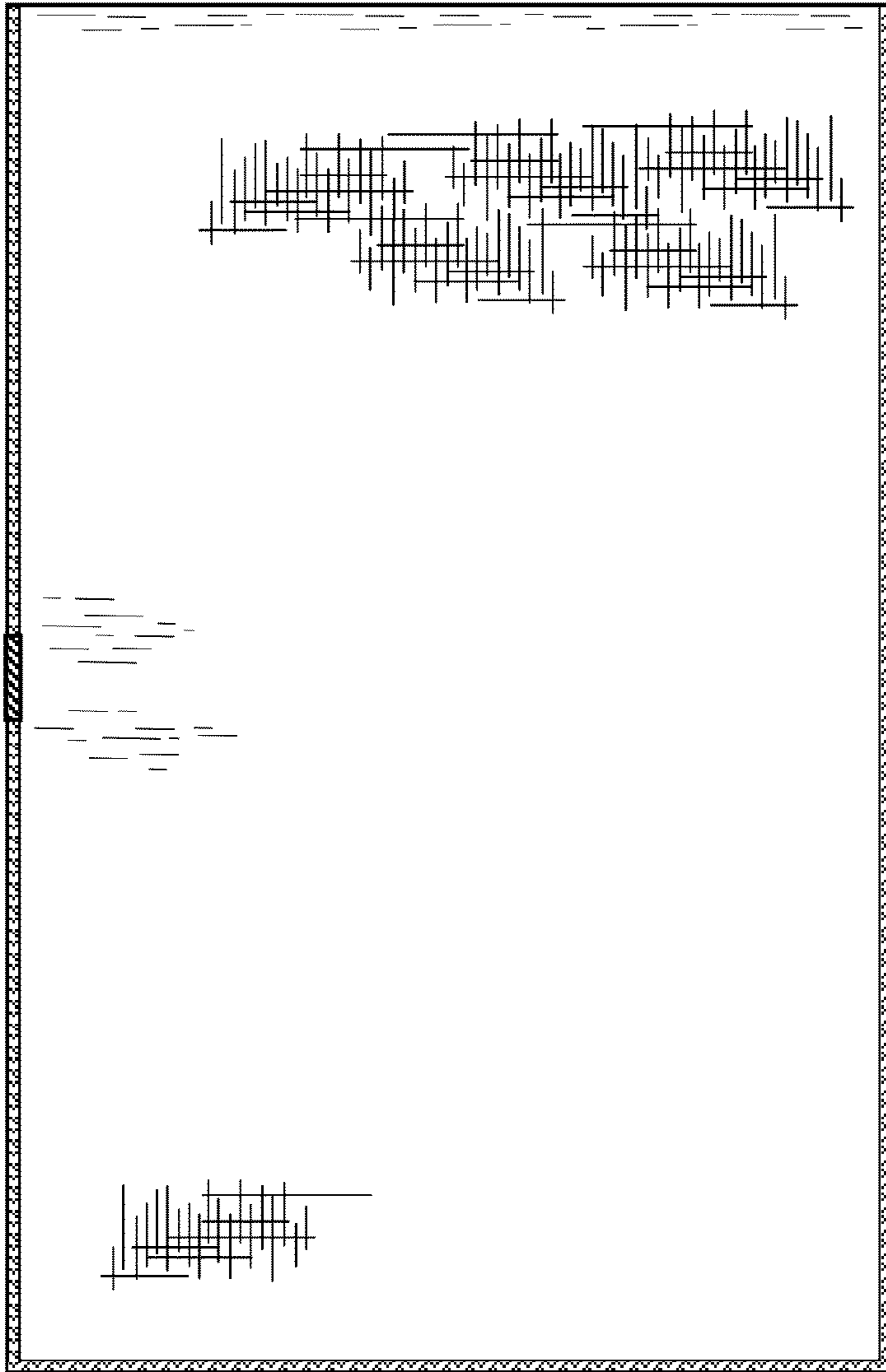

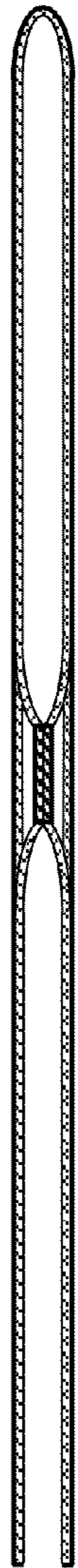

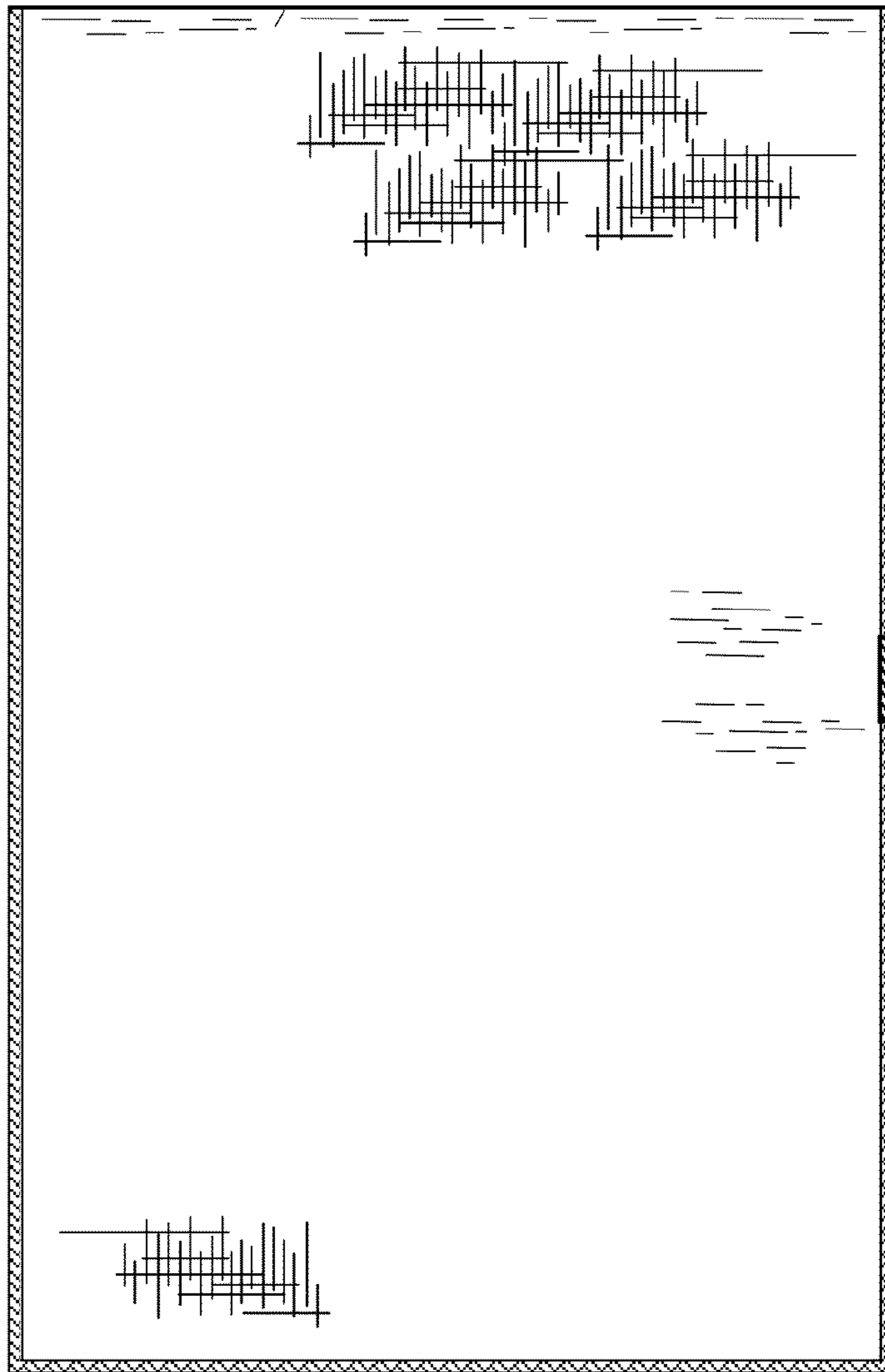

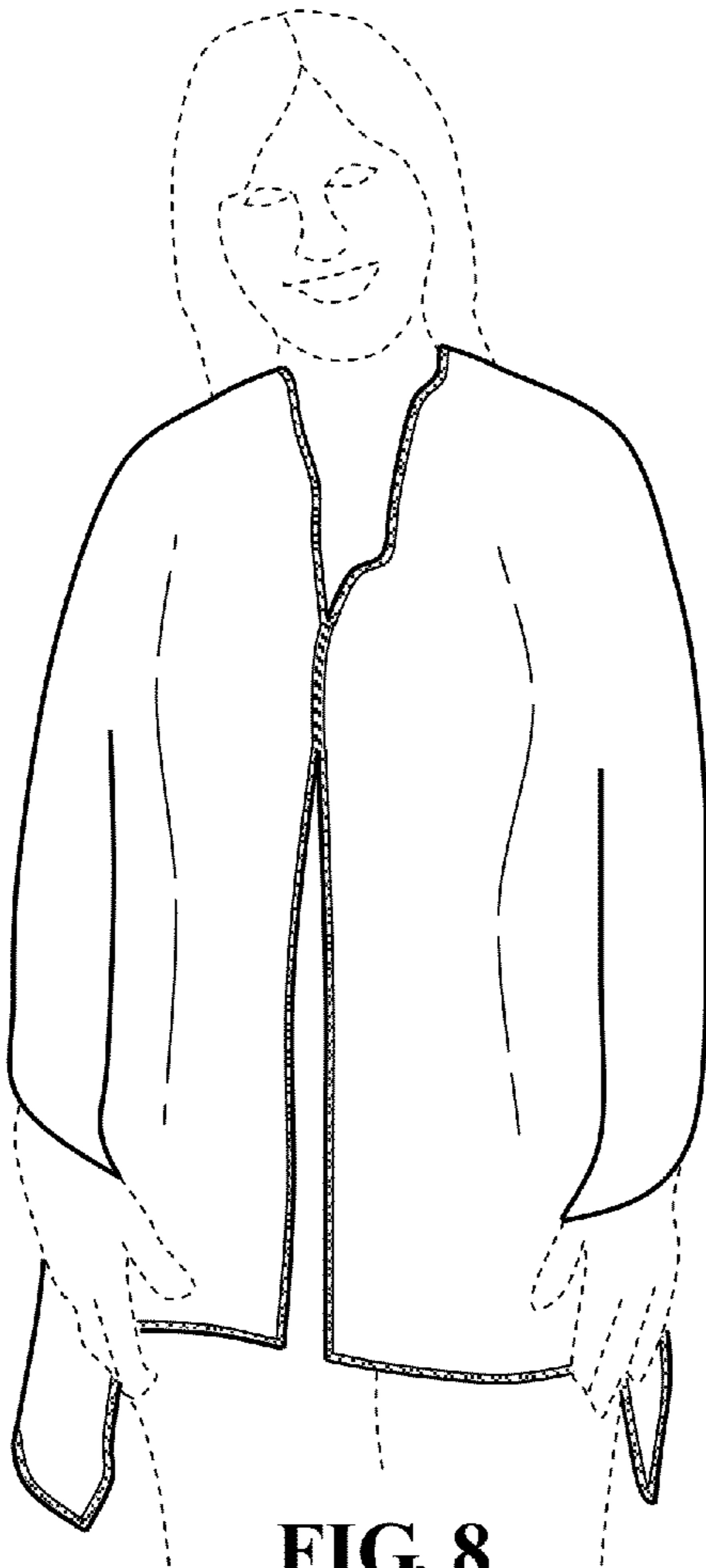

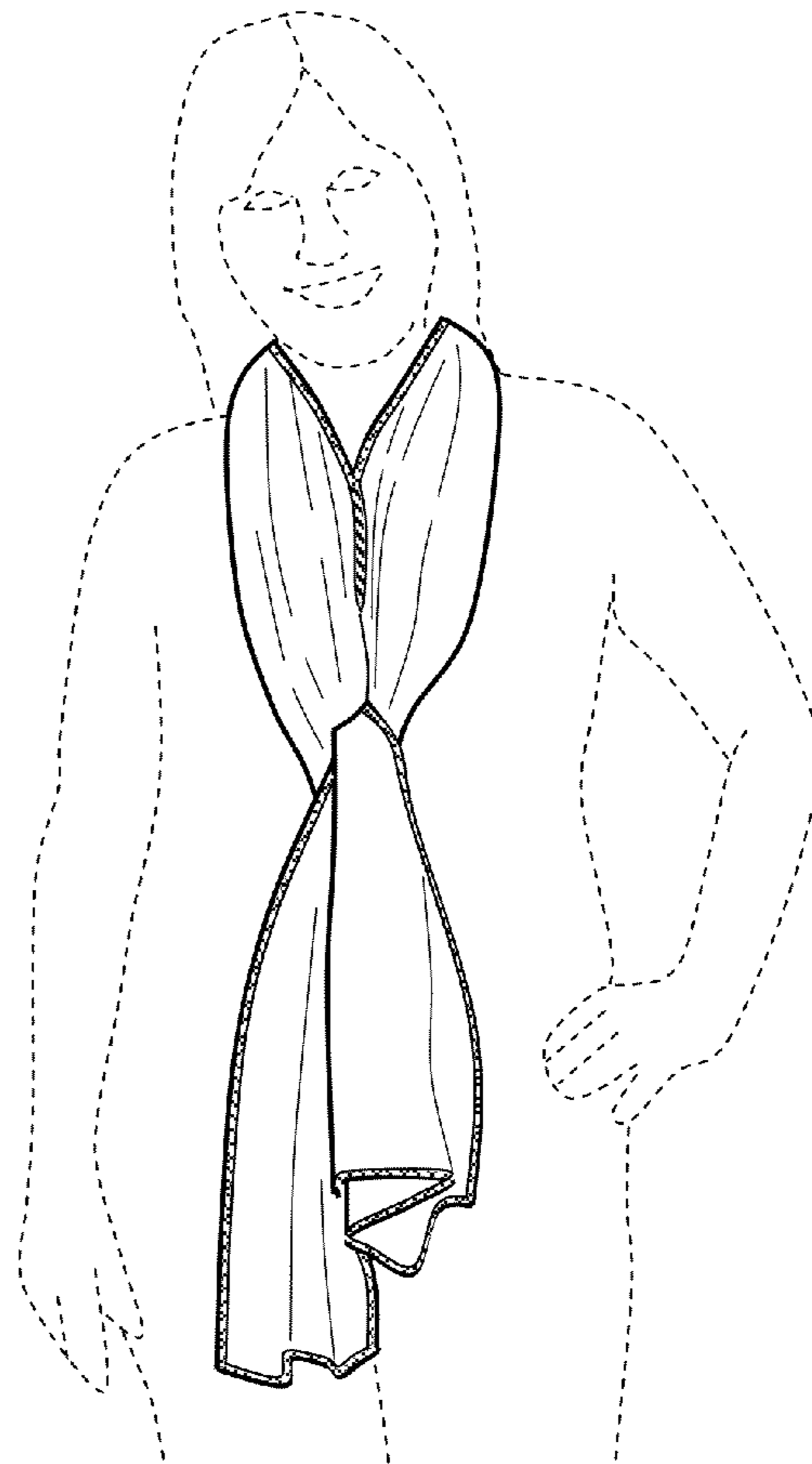
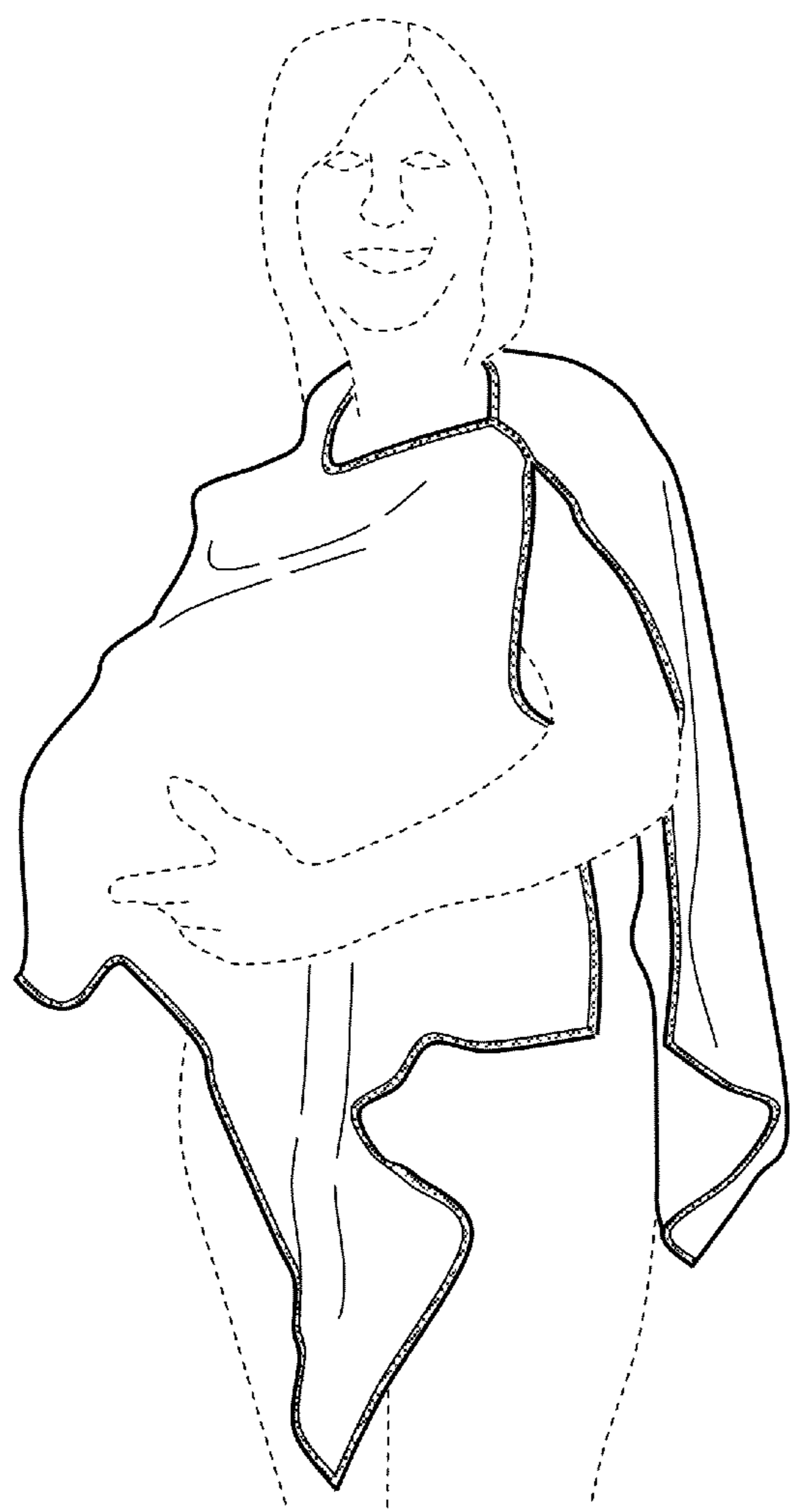
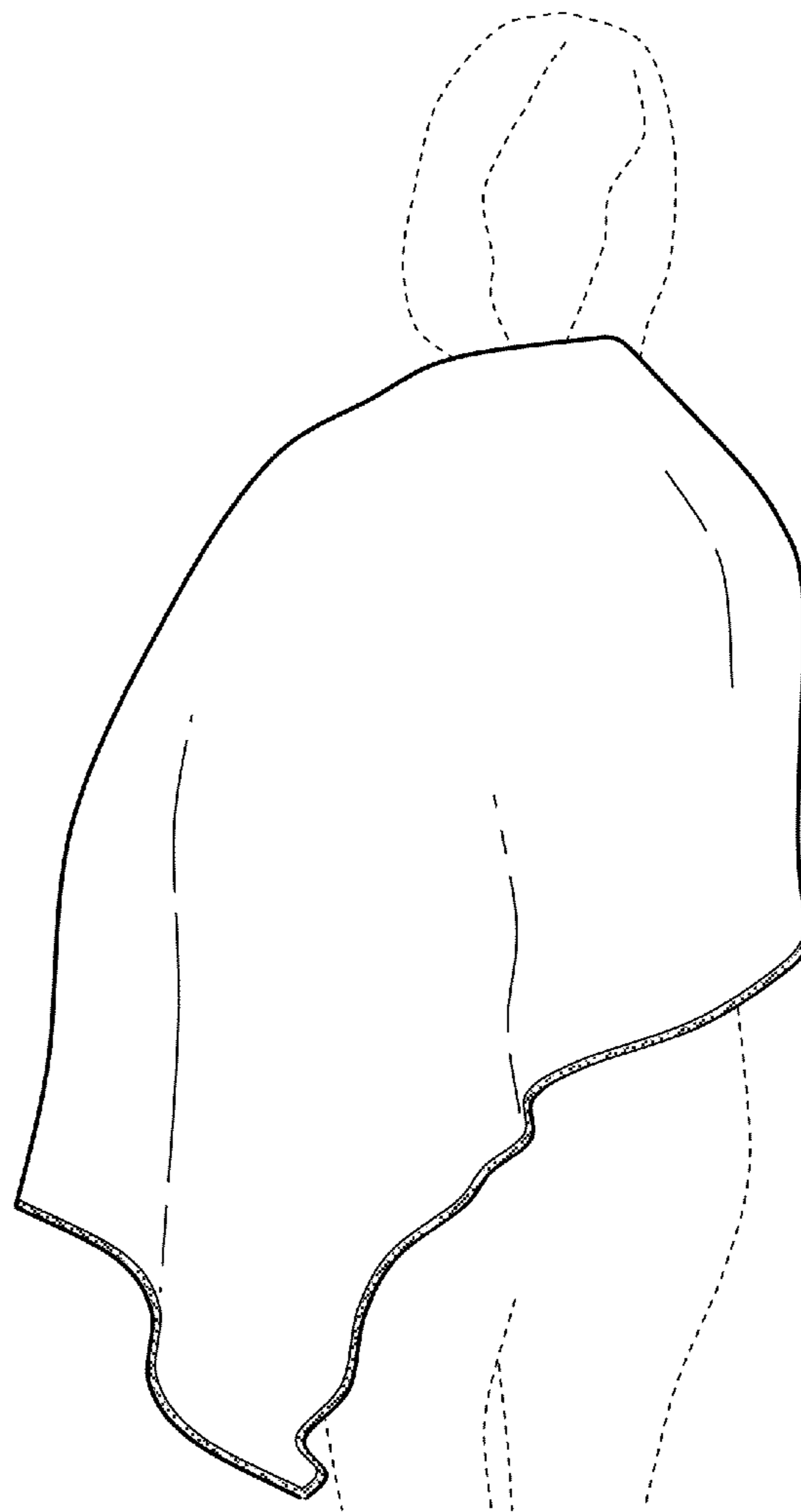
