The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of pants in accordance with a first embodiment of the design.

FIG. 18 is a right side view thereof;

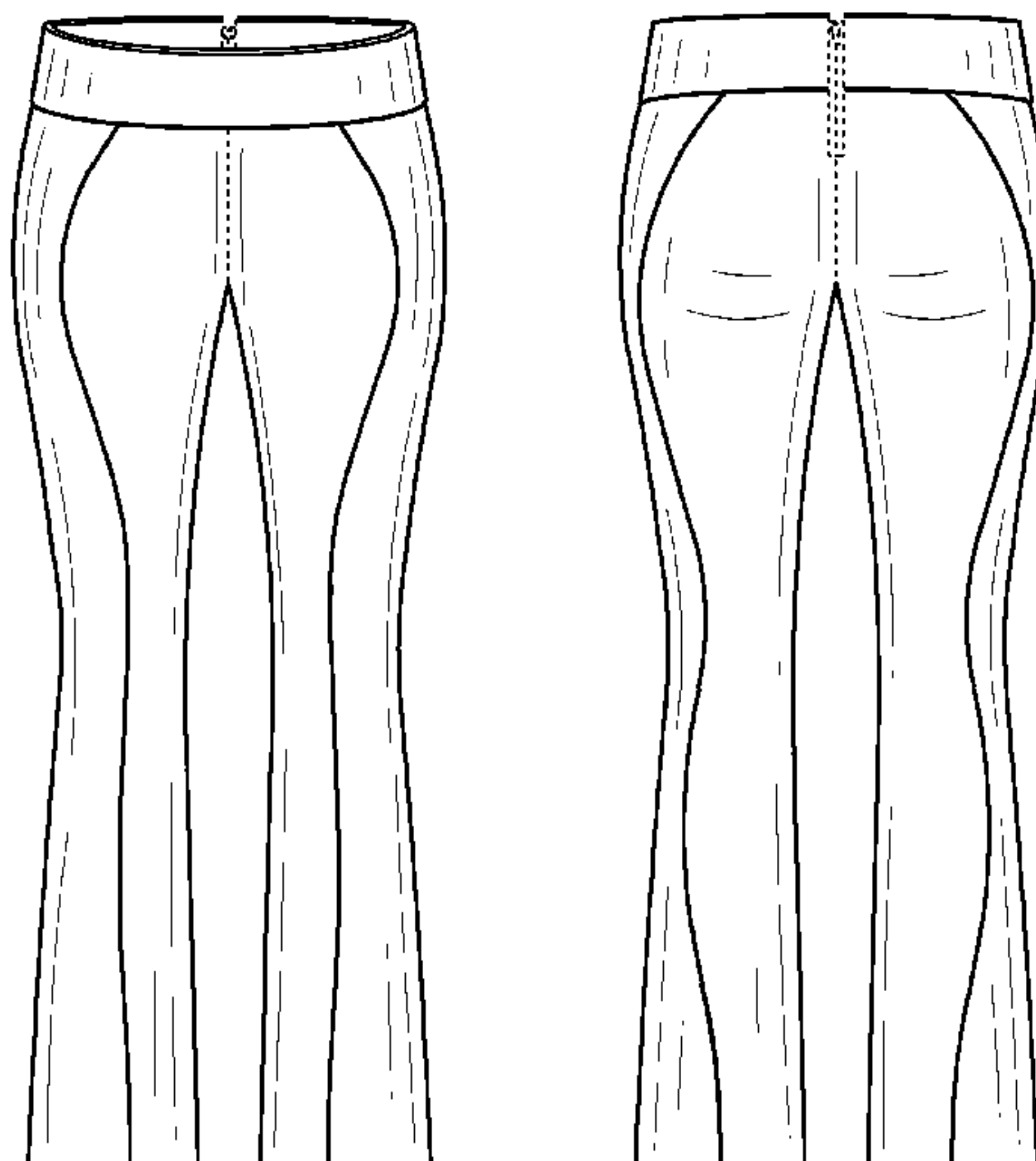
FIG. 19 is a left side view thereof;

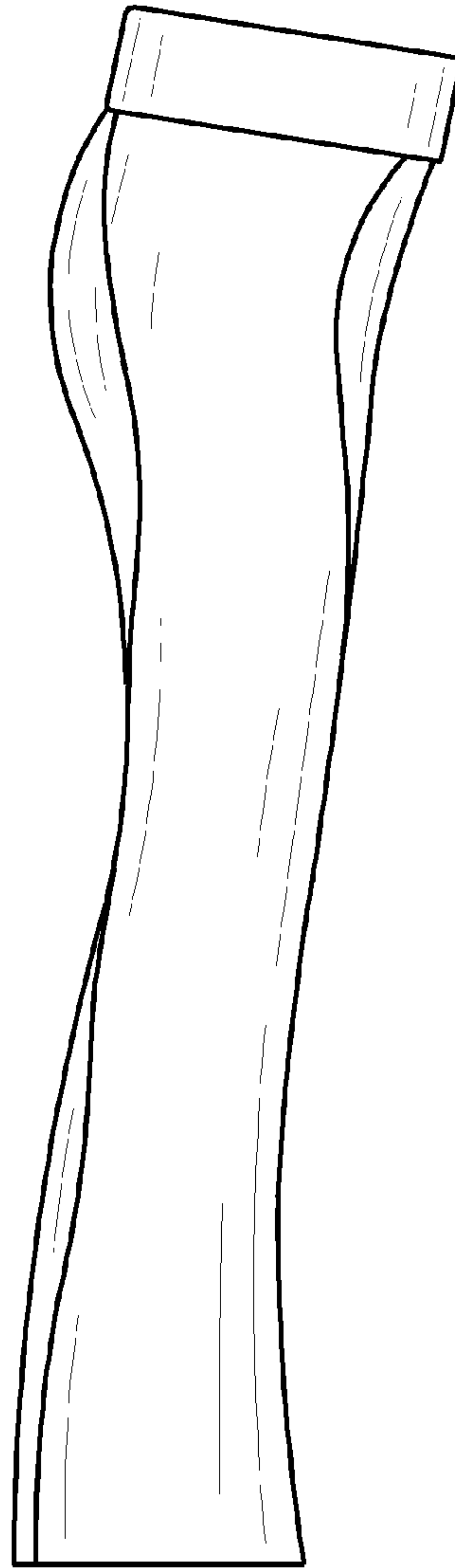

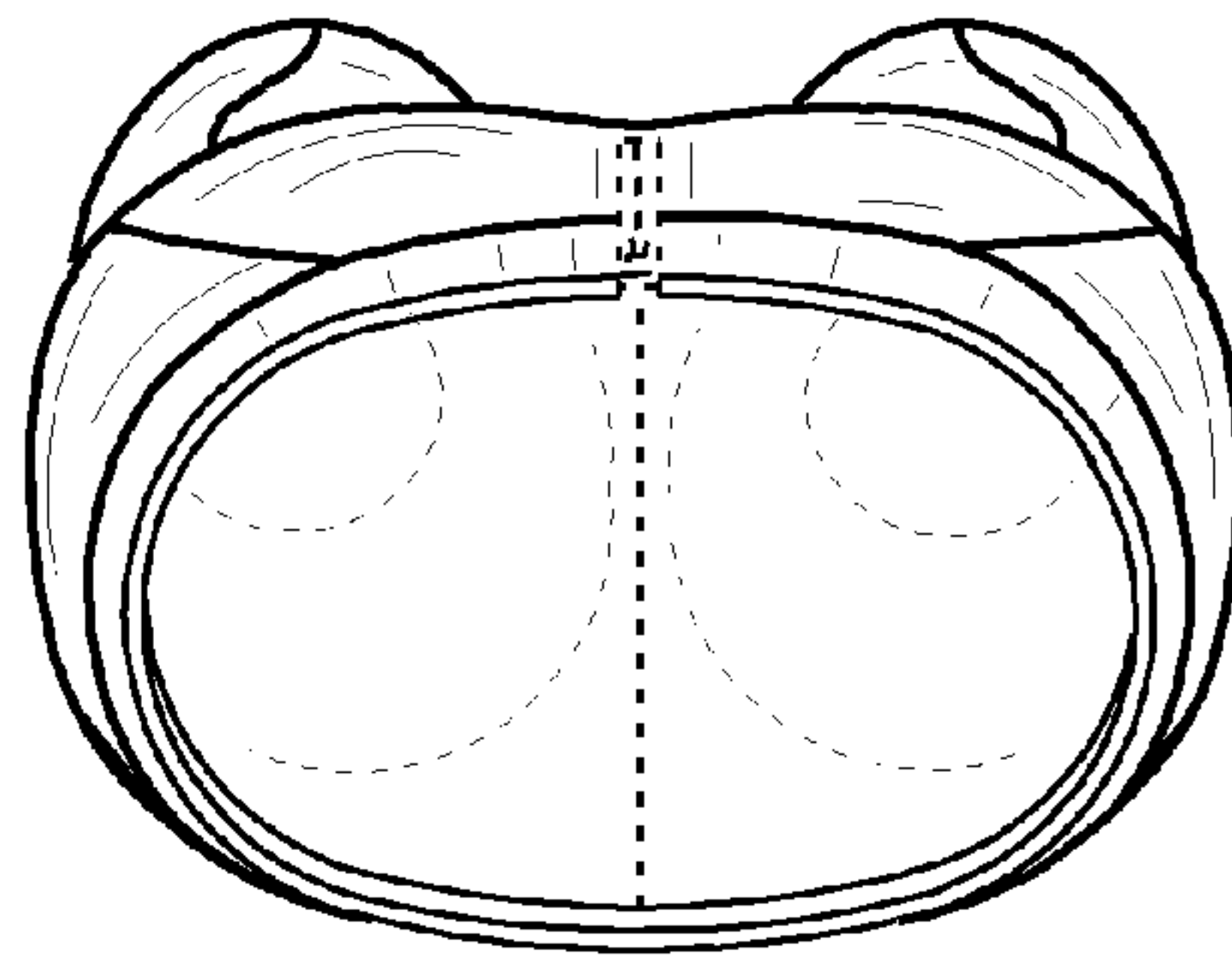

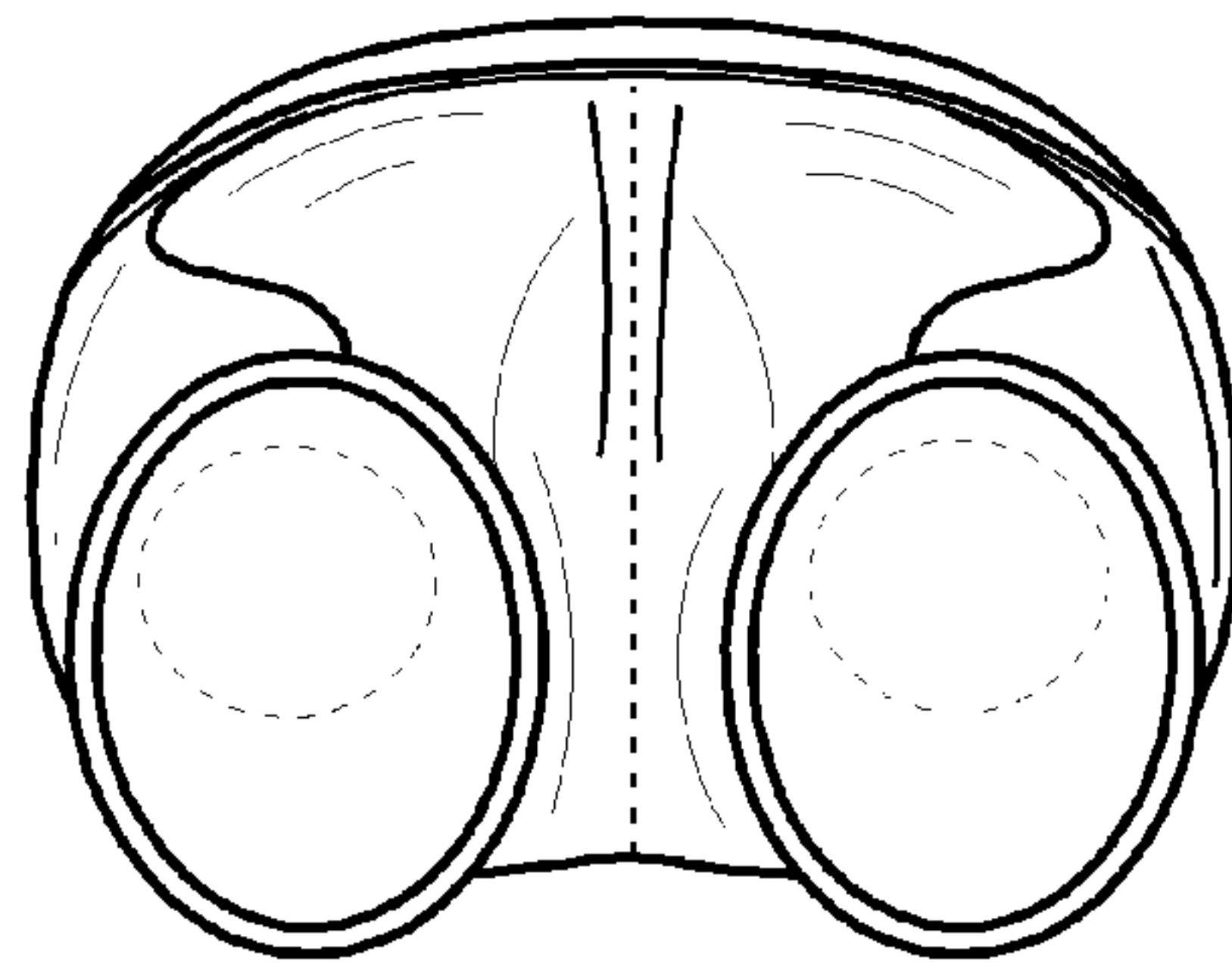

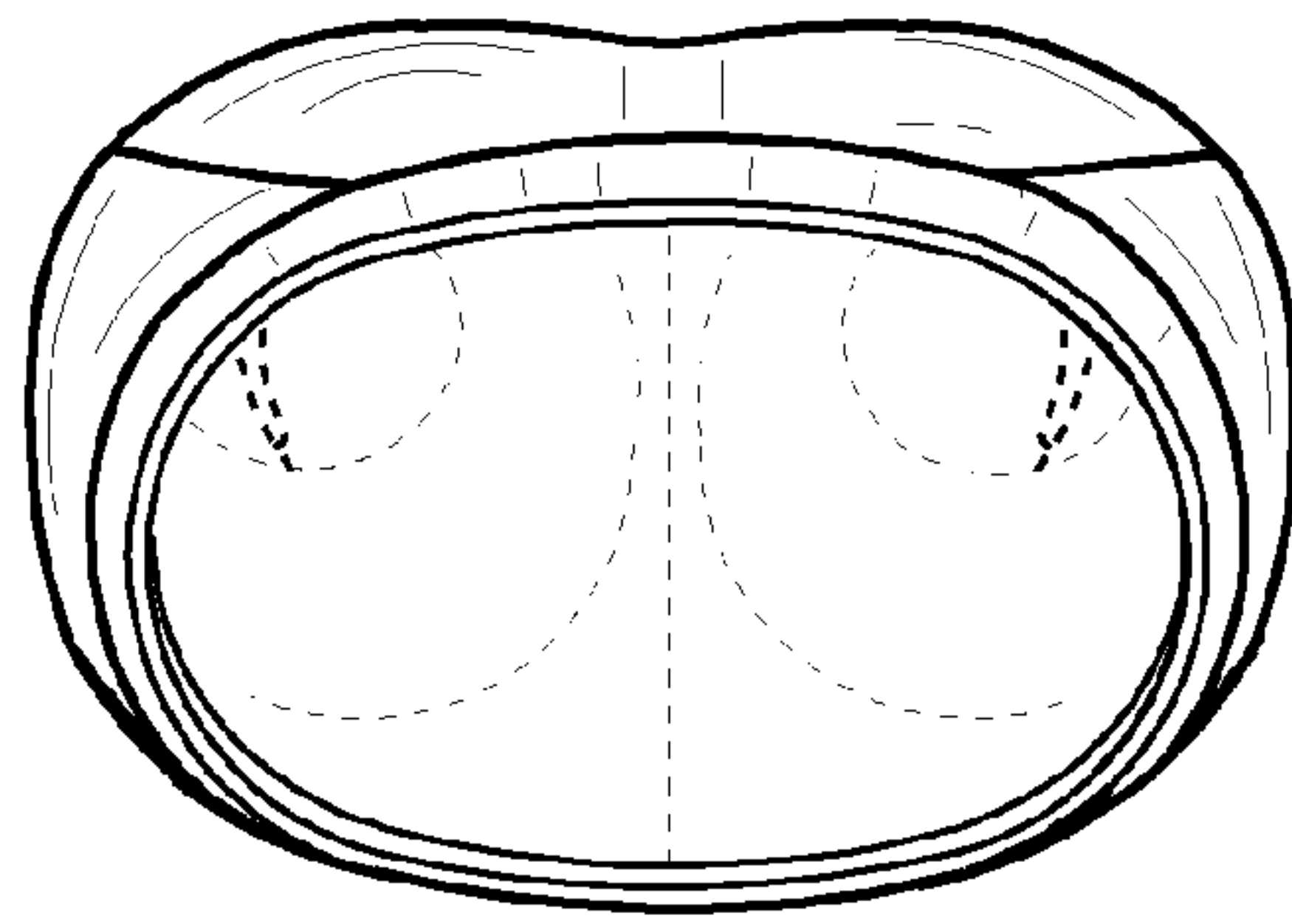

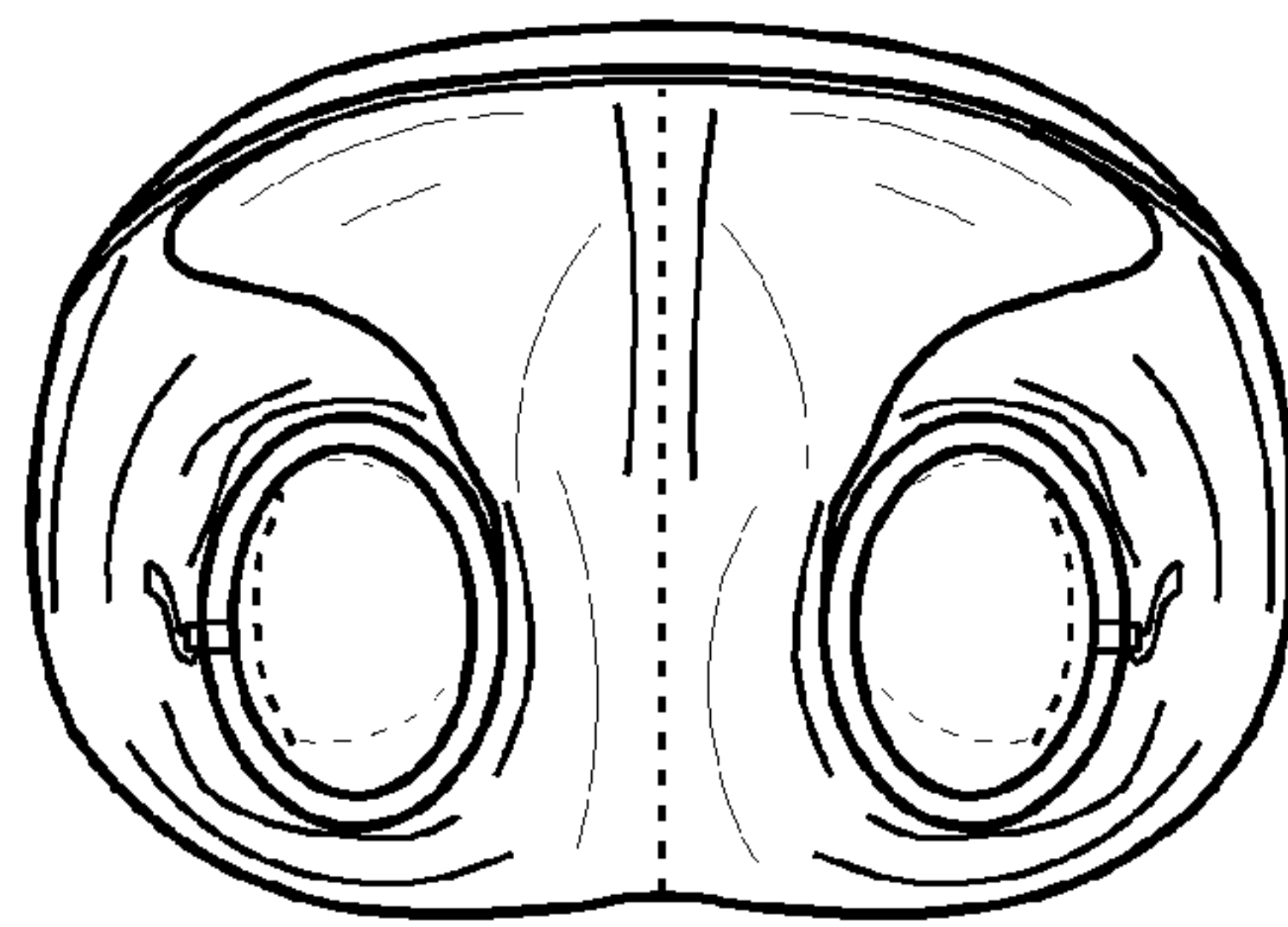

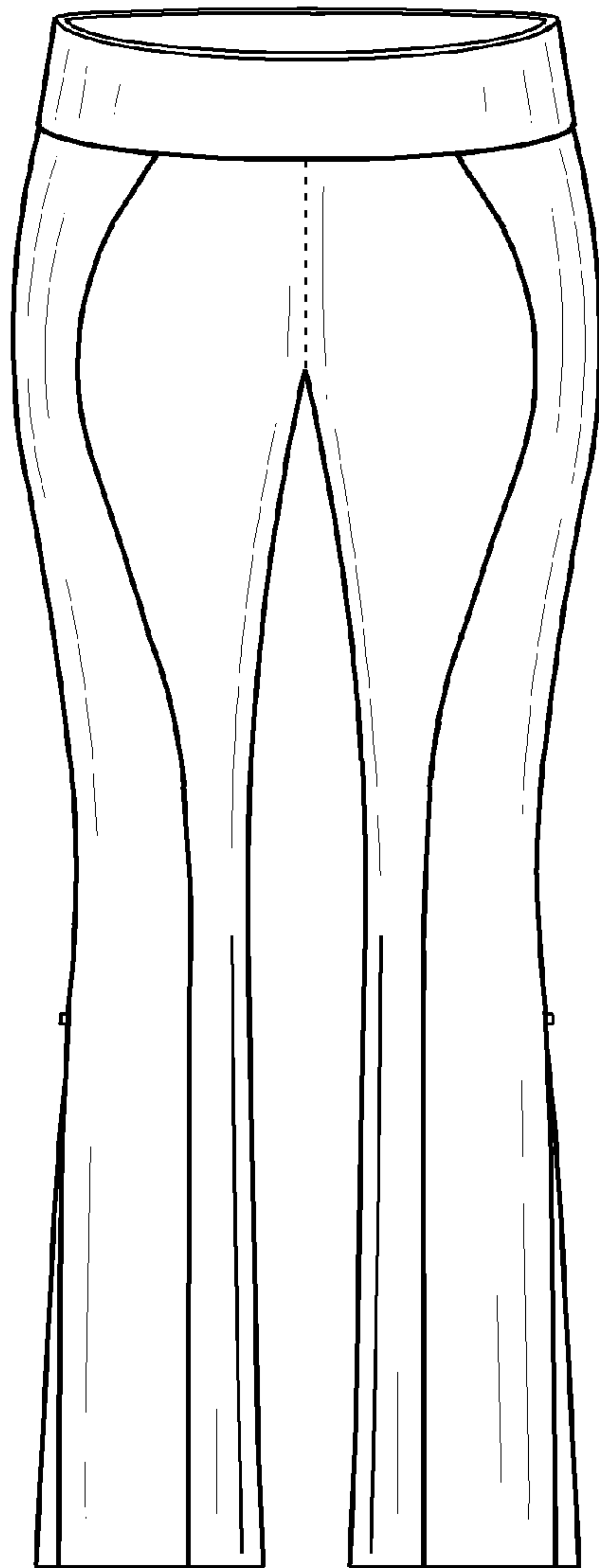

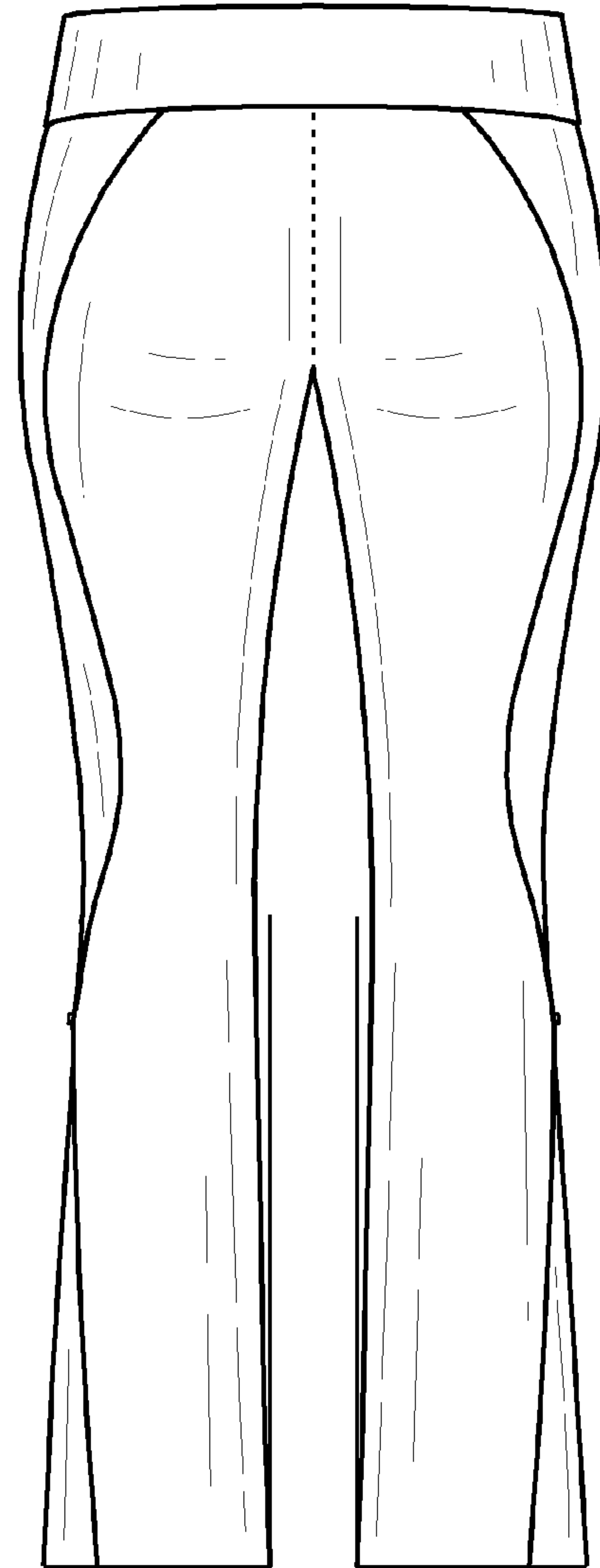

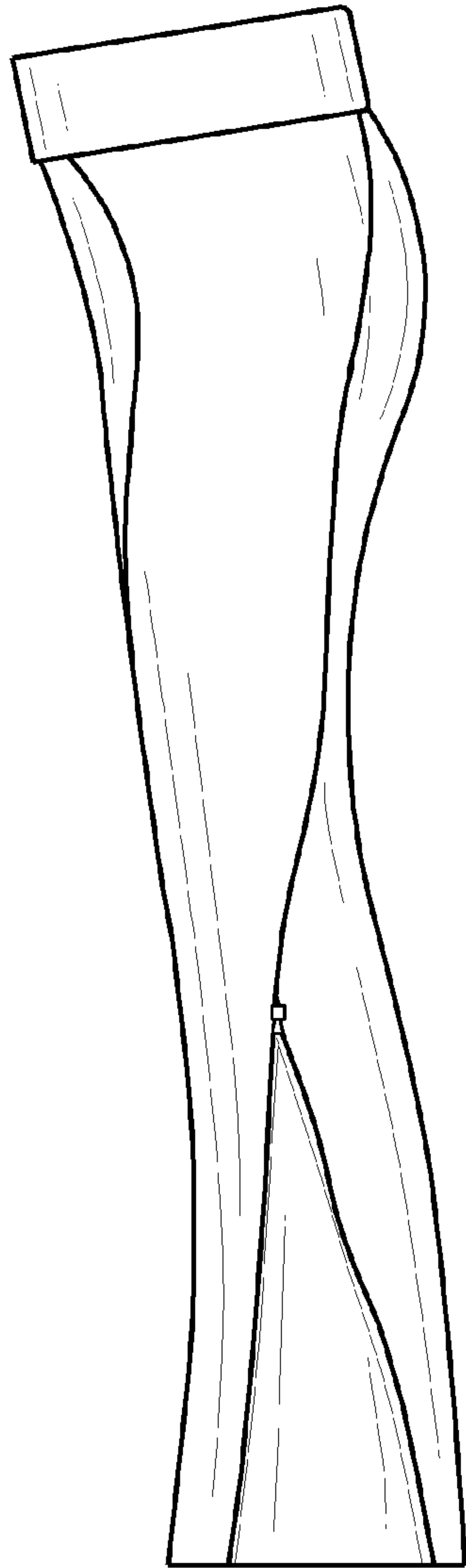

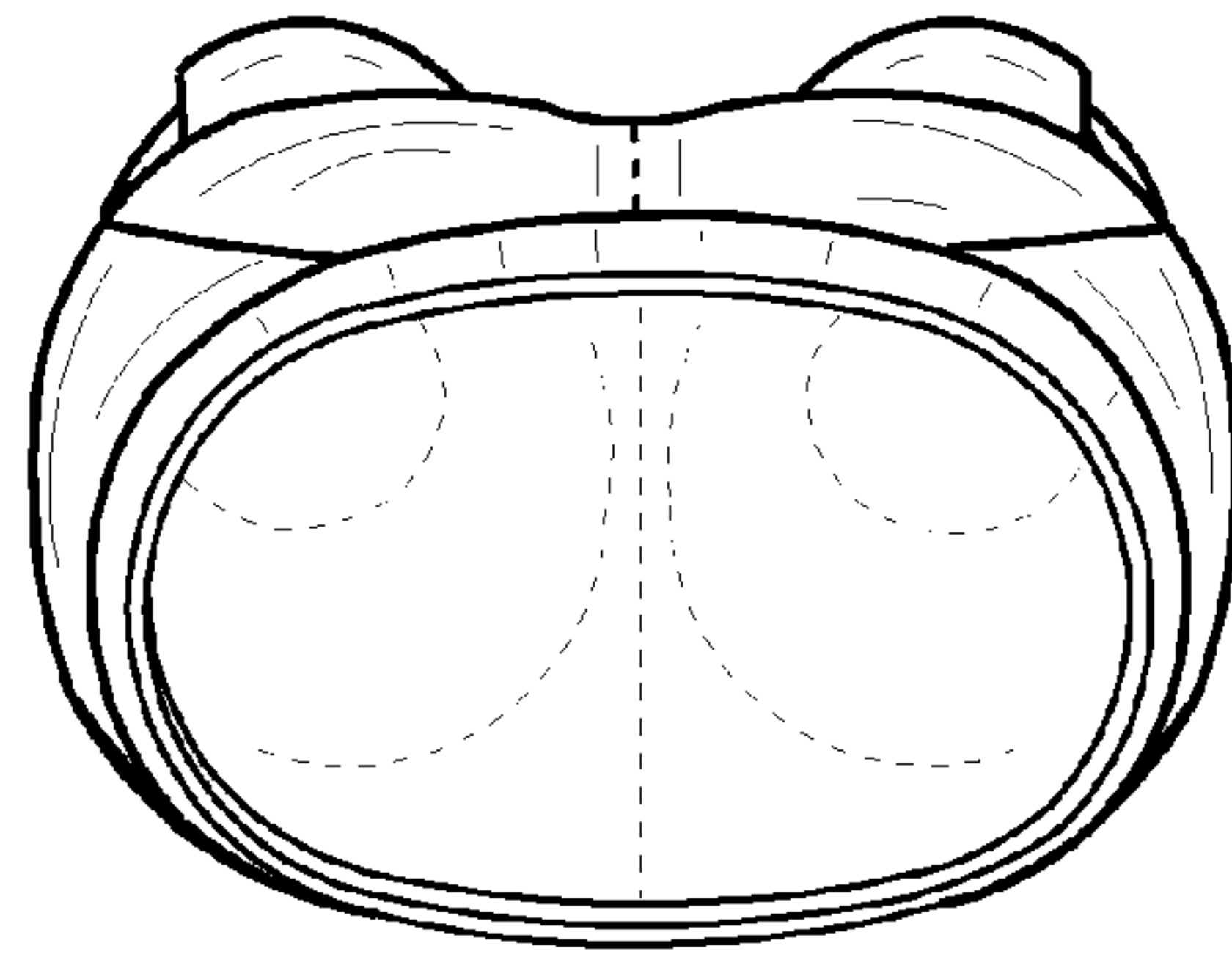

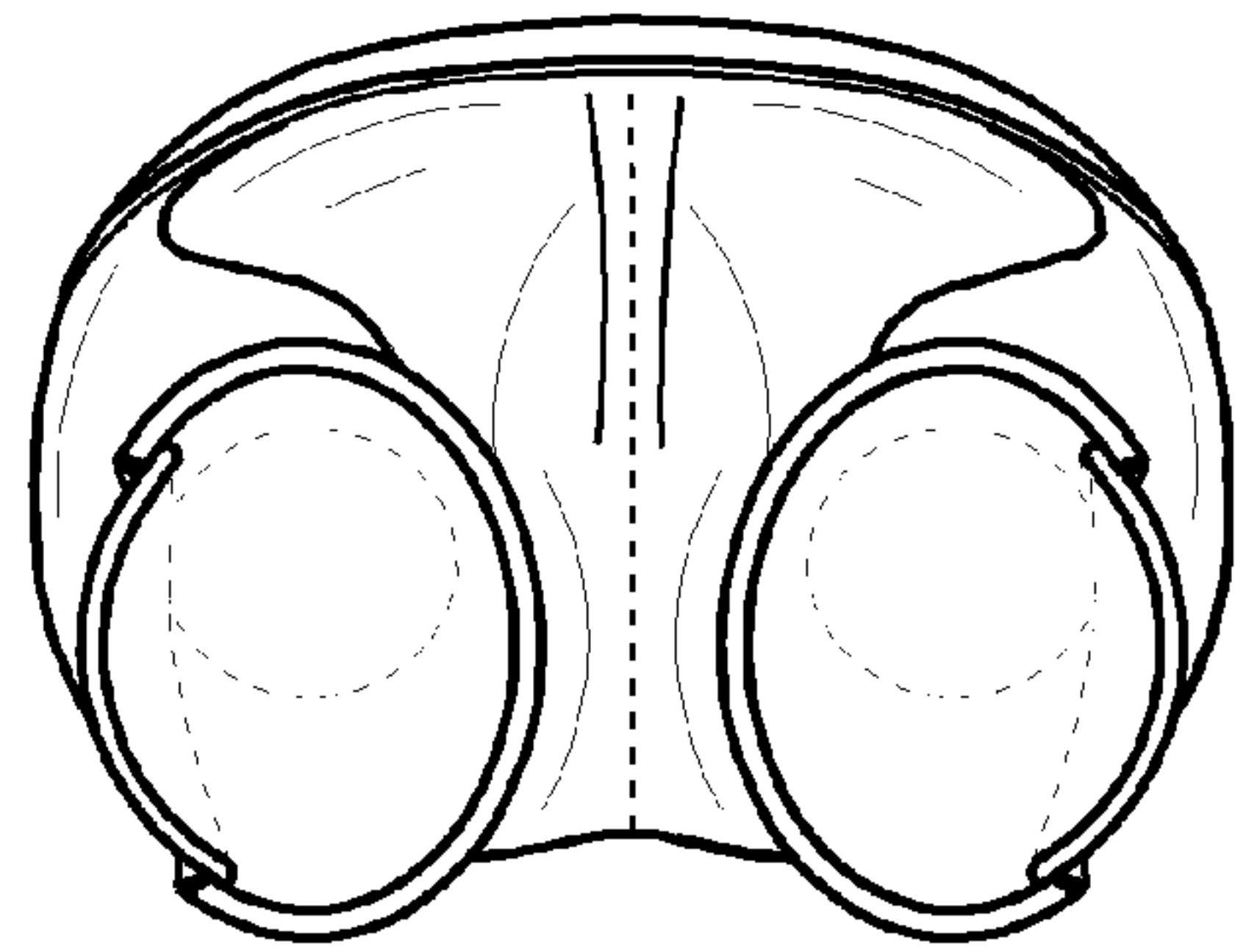
