FIG. 4 is a left side elevational view of the vest from FIGS. 1-3;

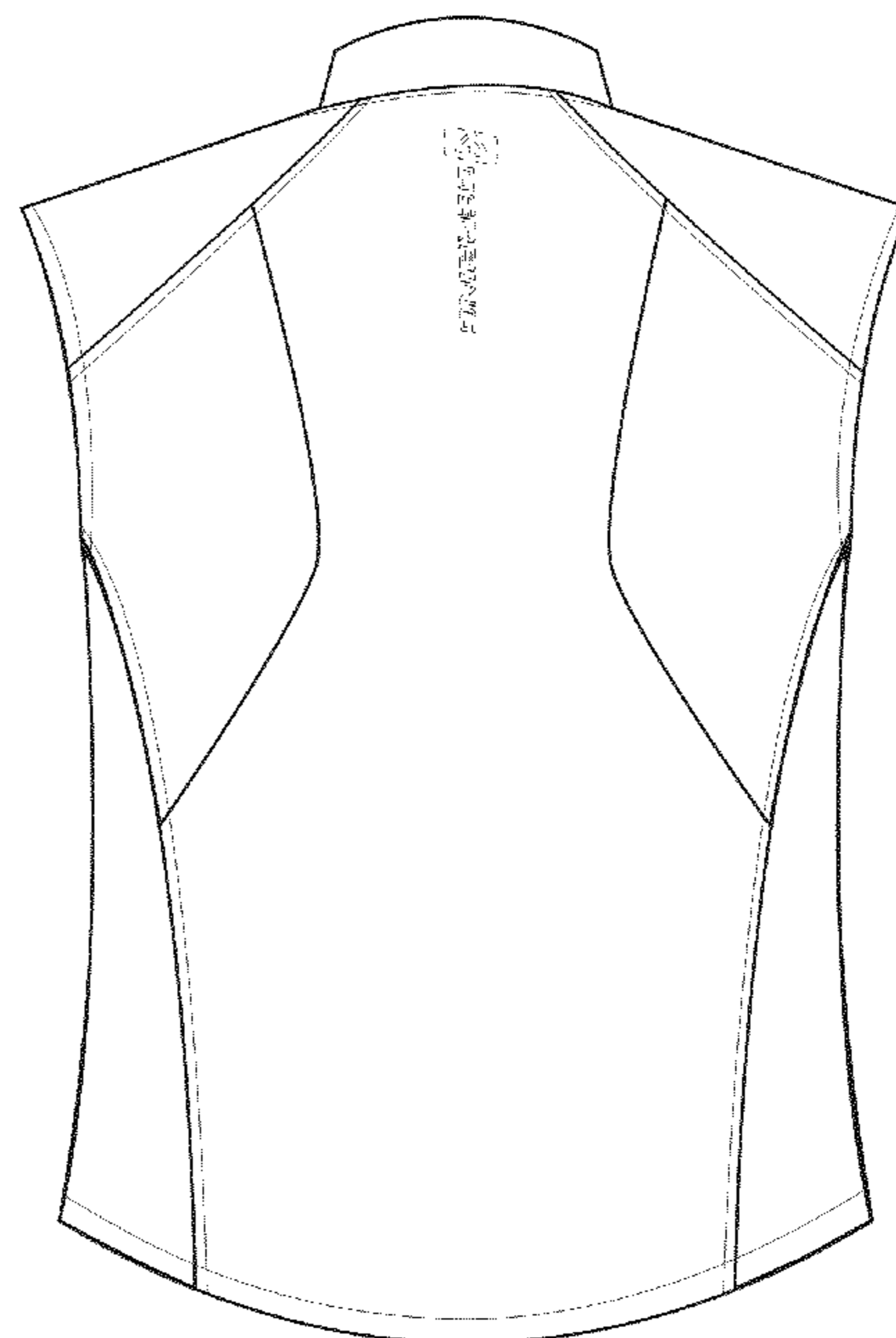
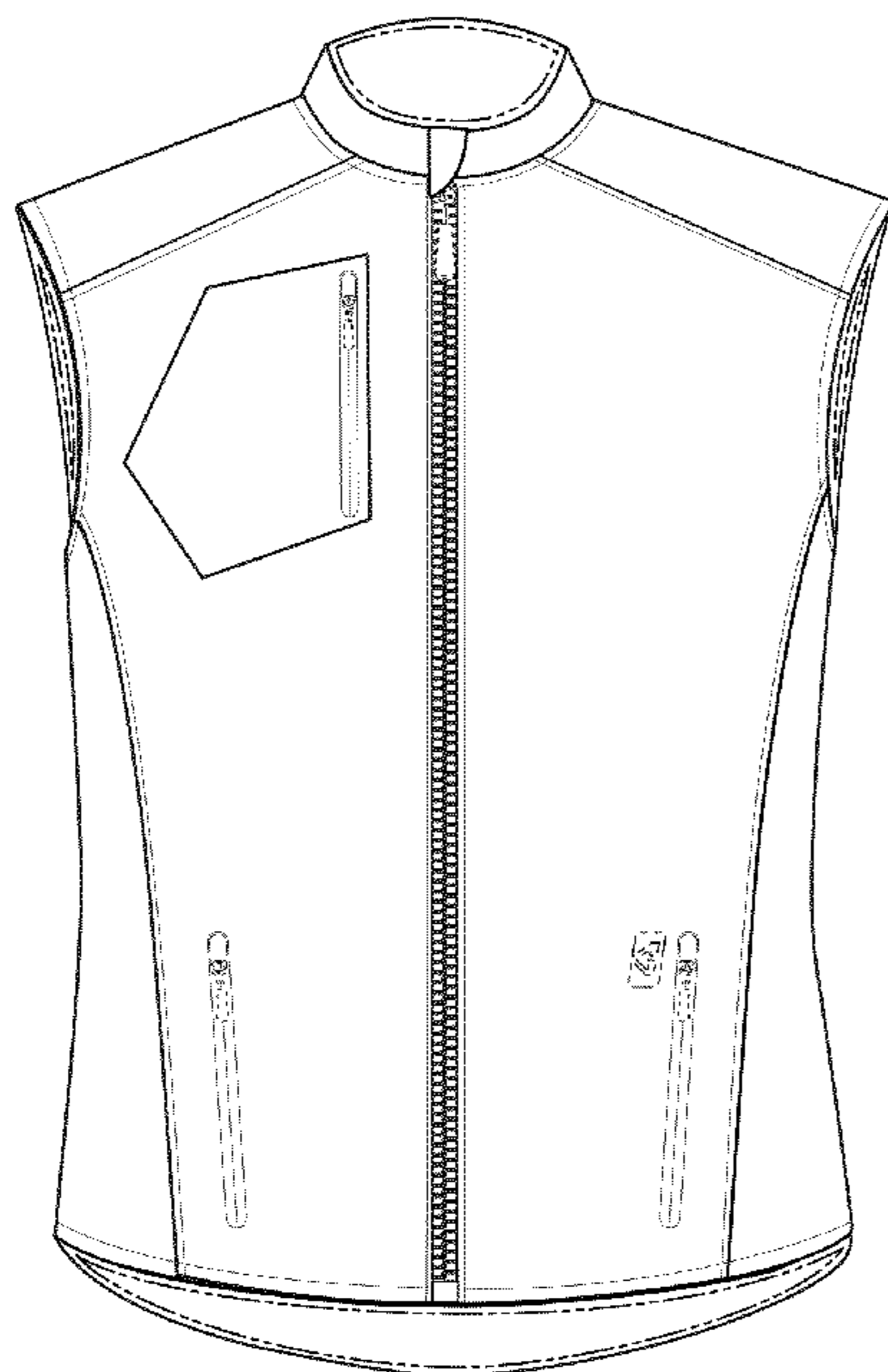
FIG. 5 is a right side elevational view of the vest from FIGS. 1-4;

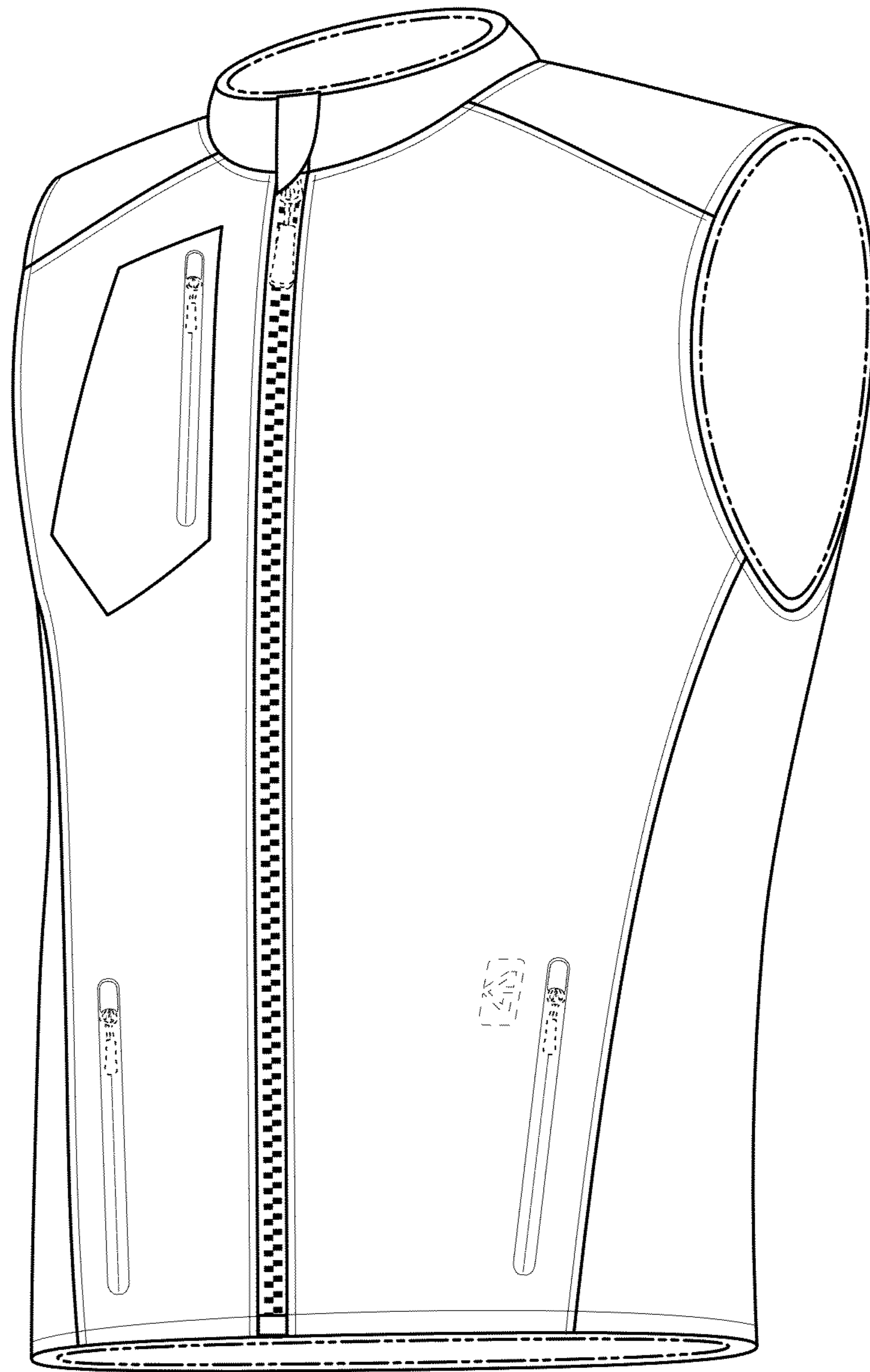

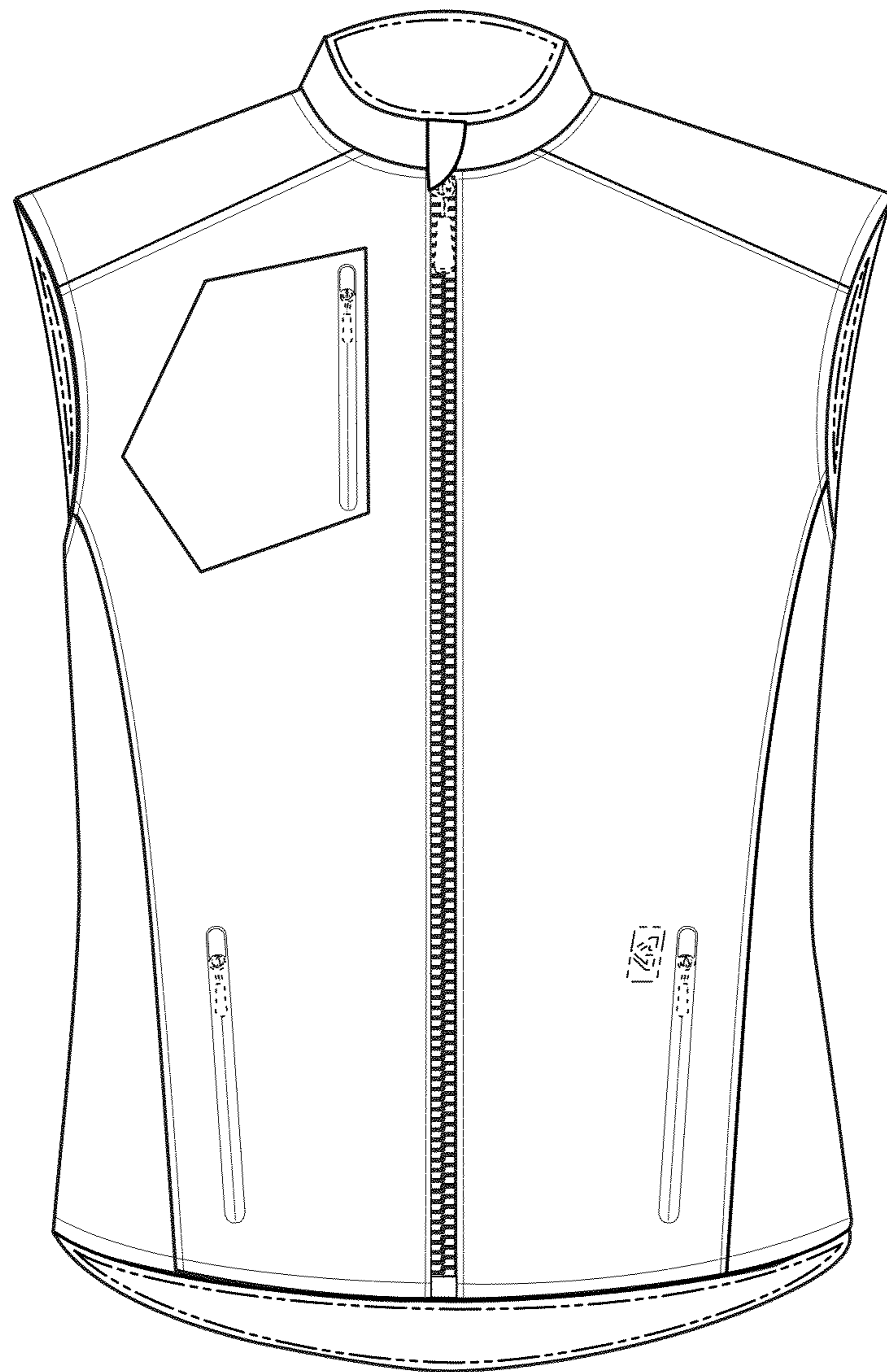

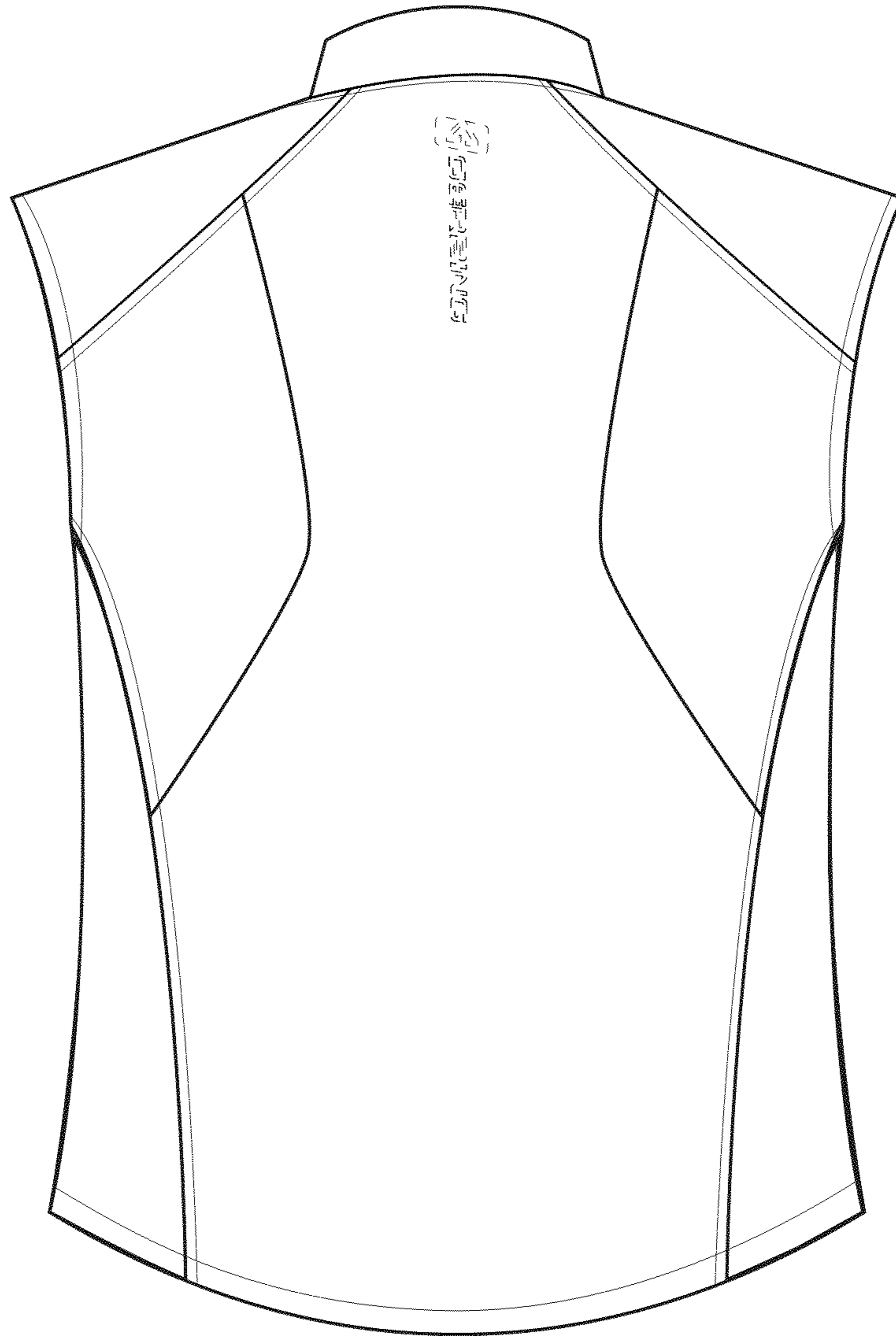

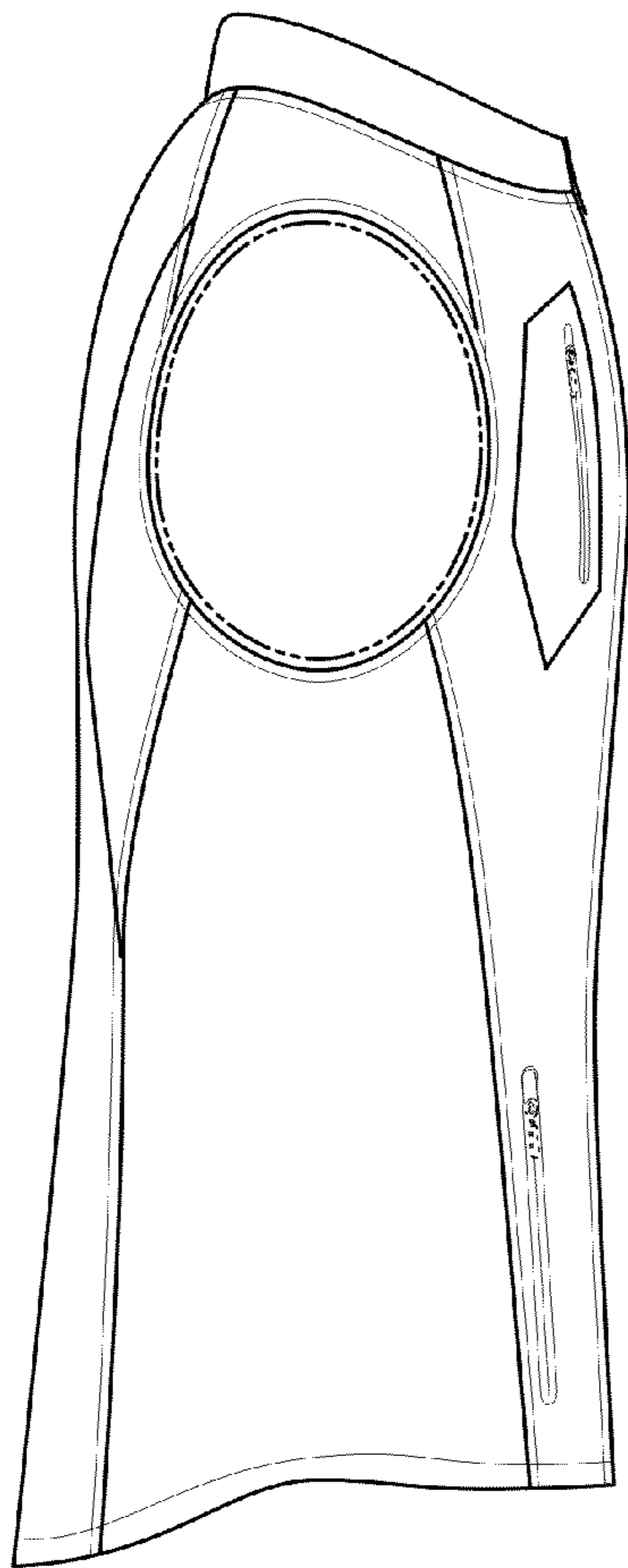

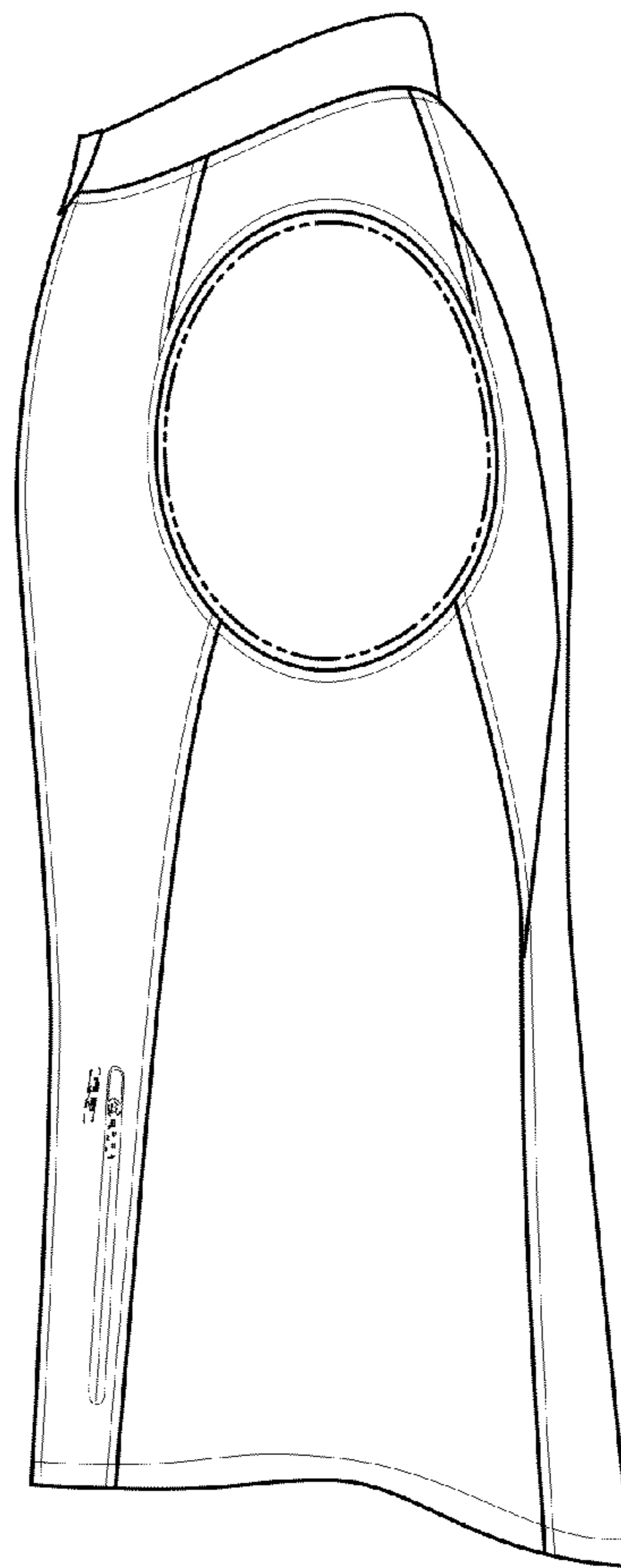

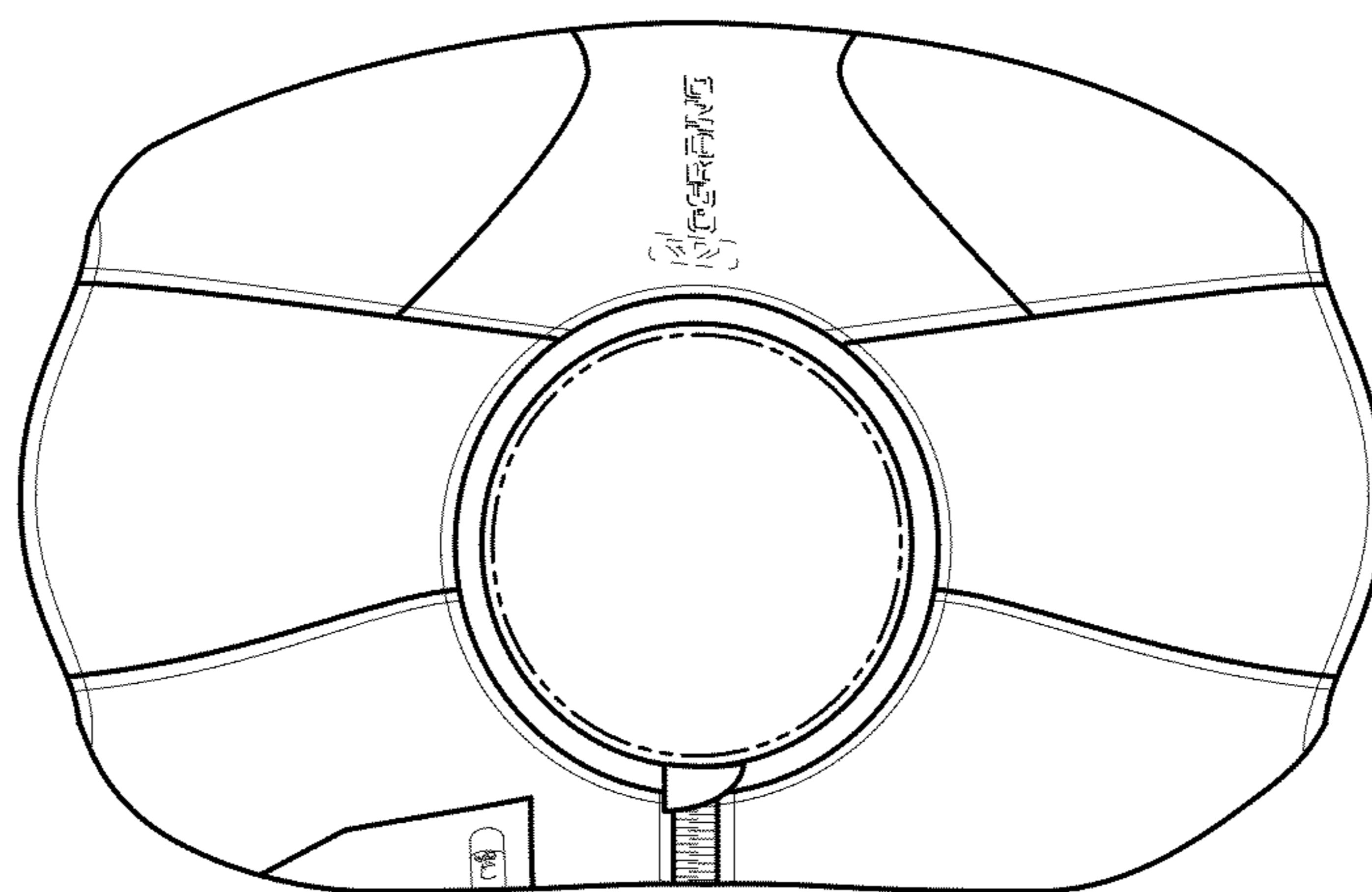

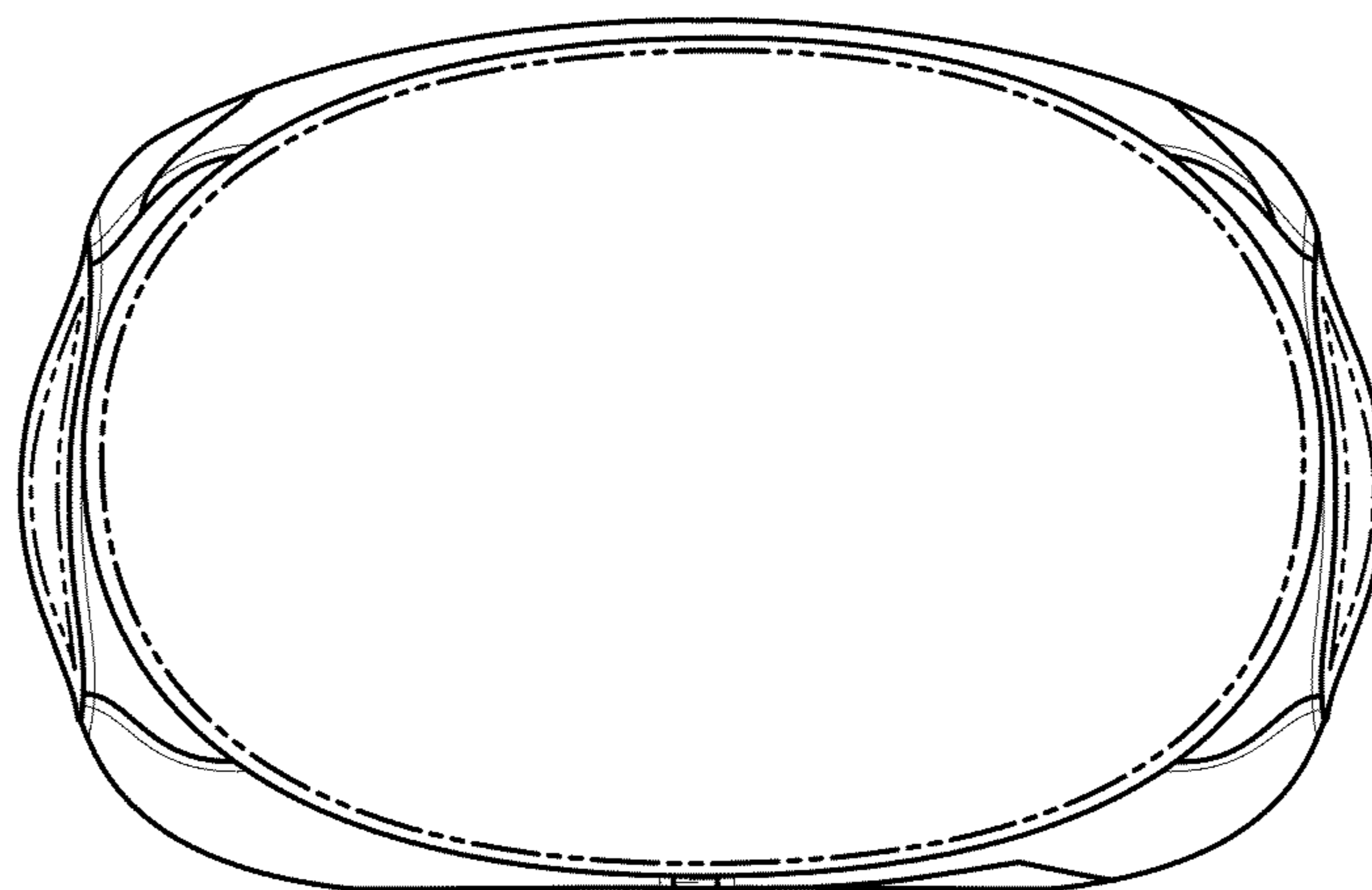
