**DESCRIPTION**

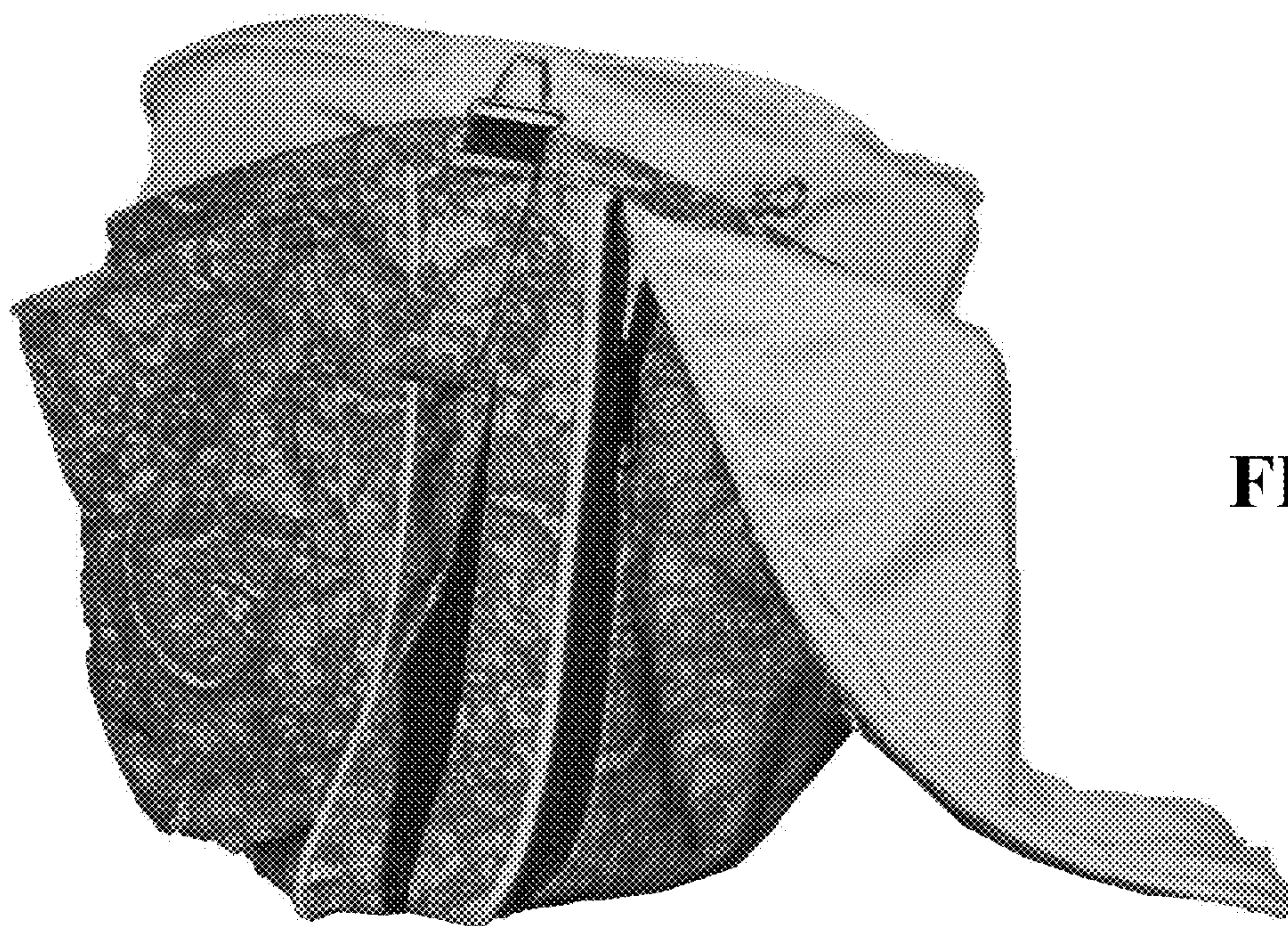
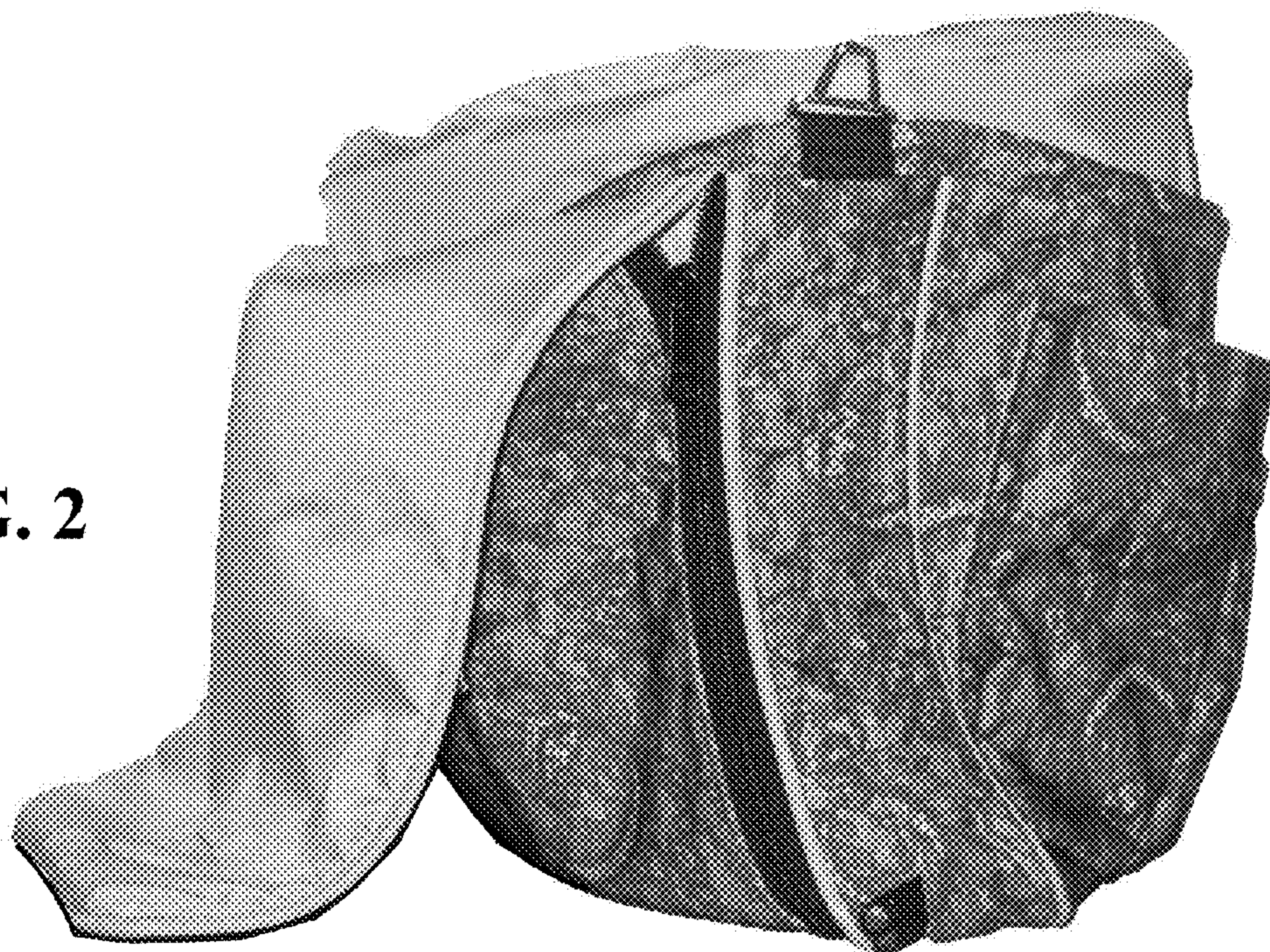

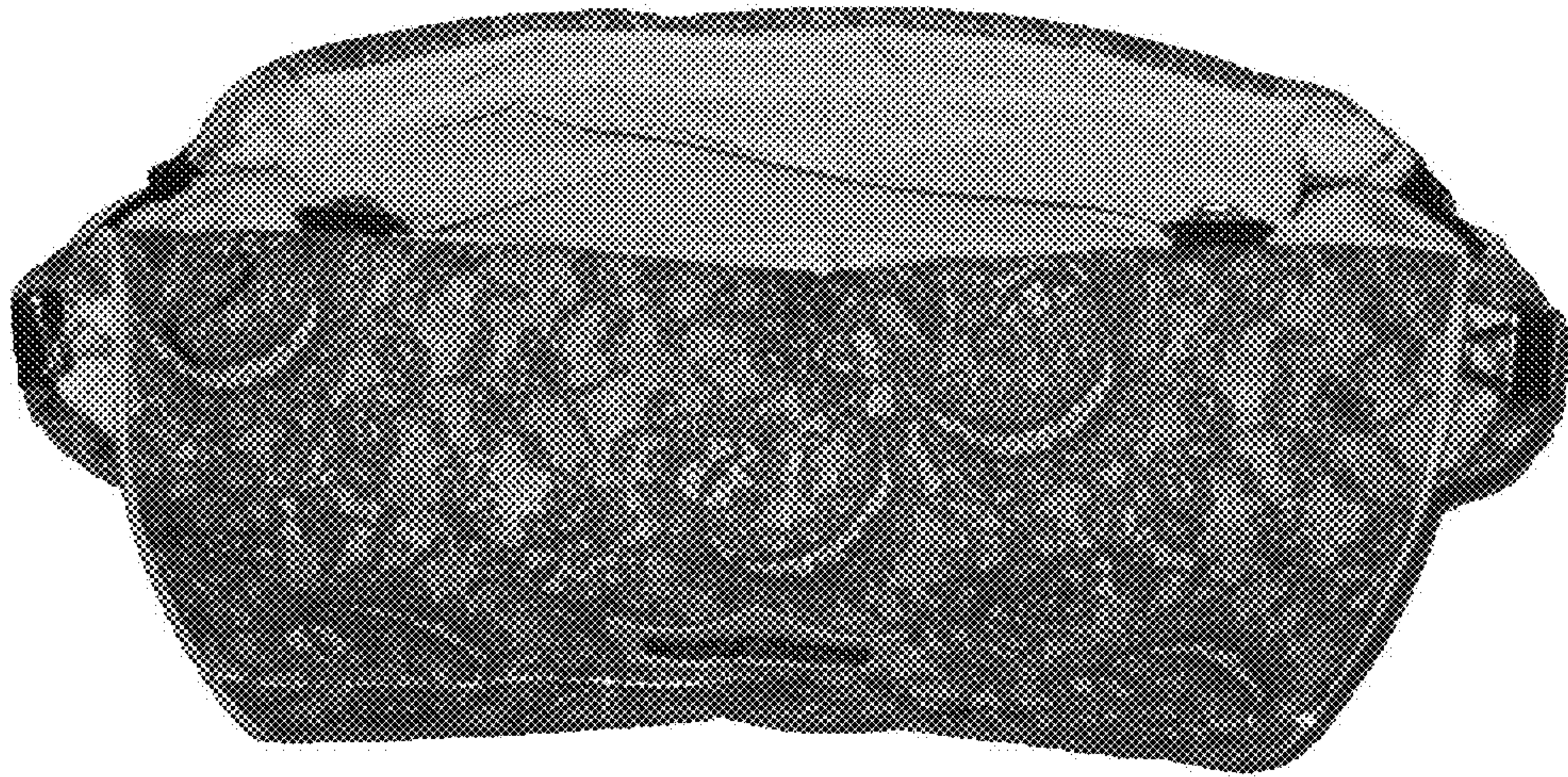

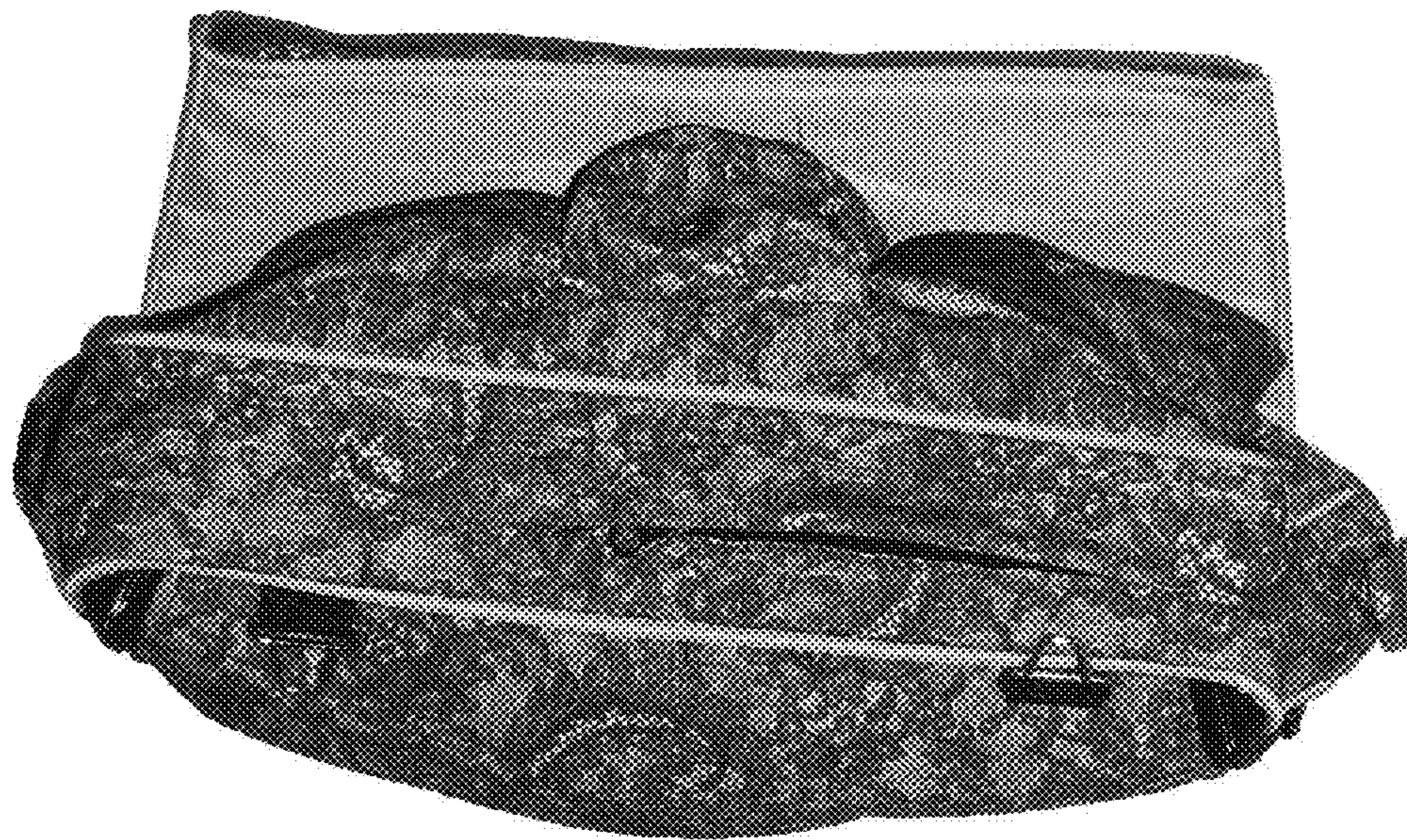

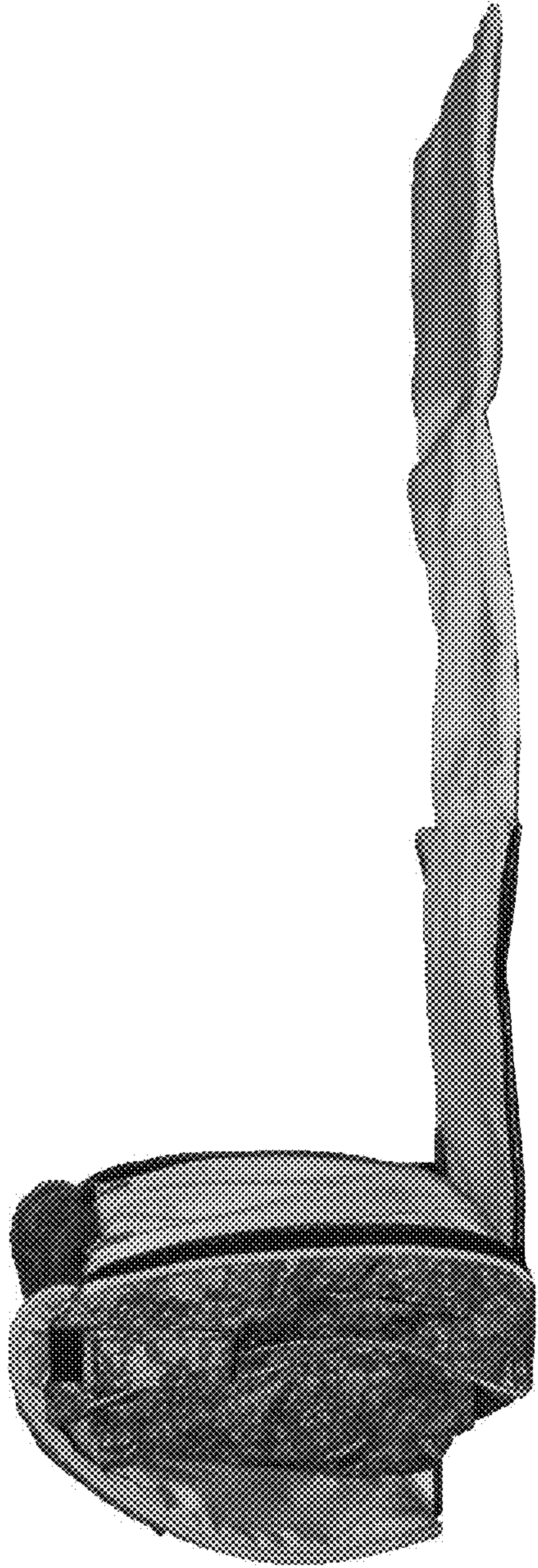

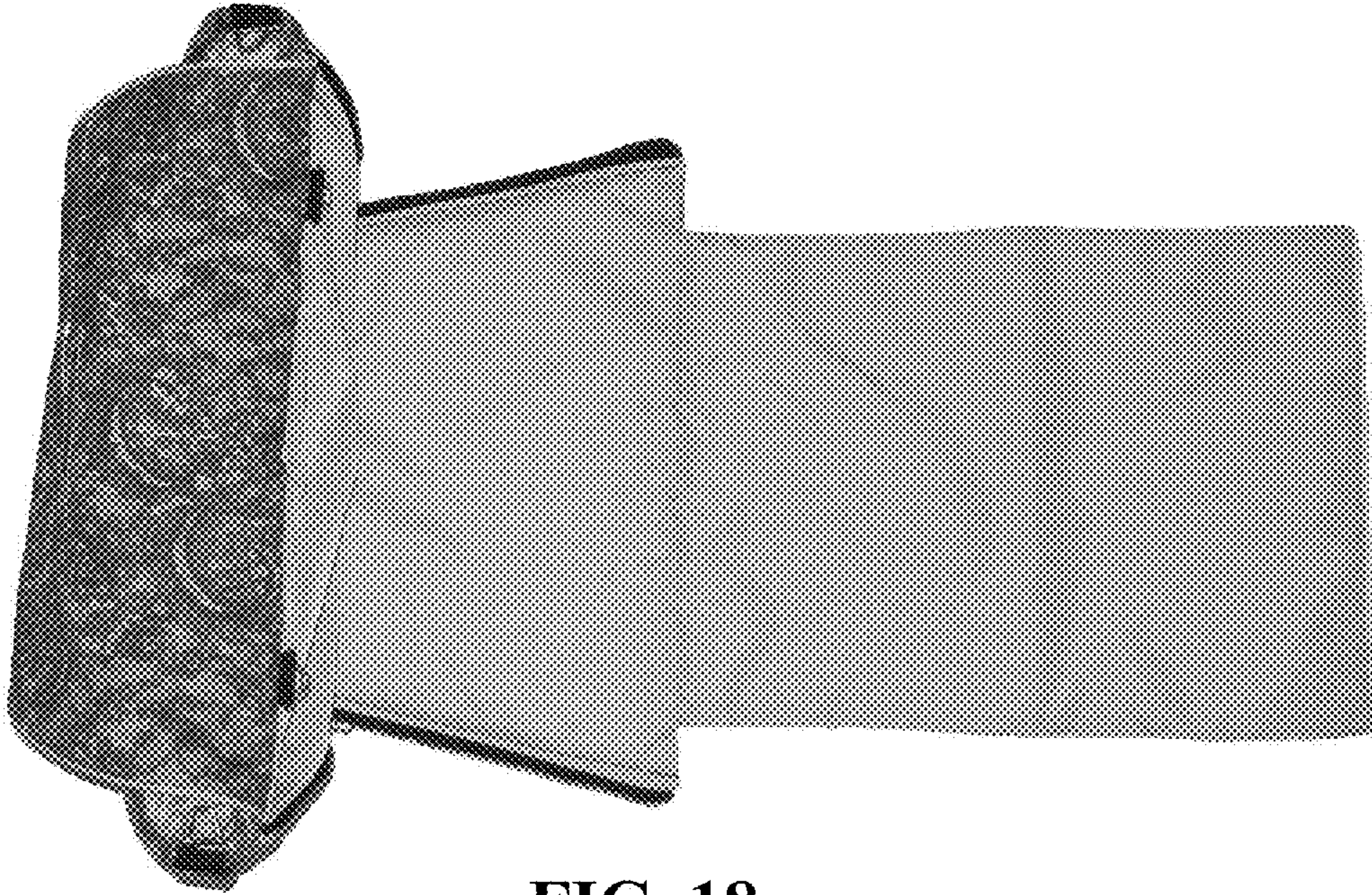

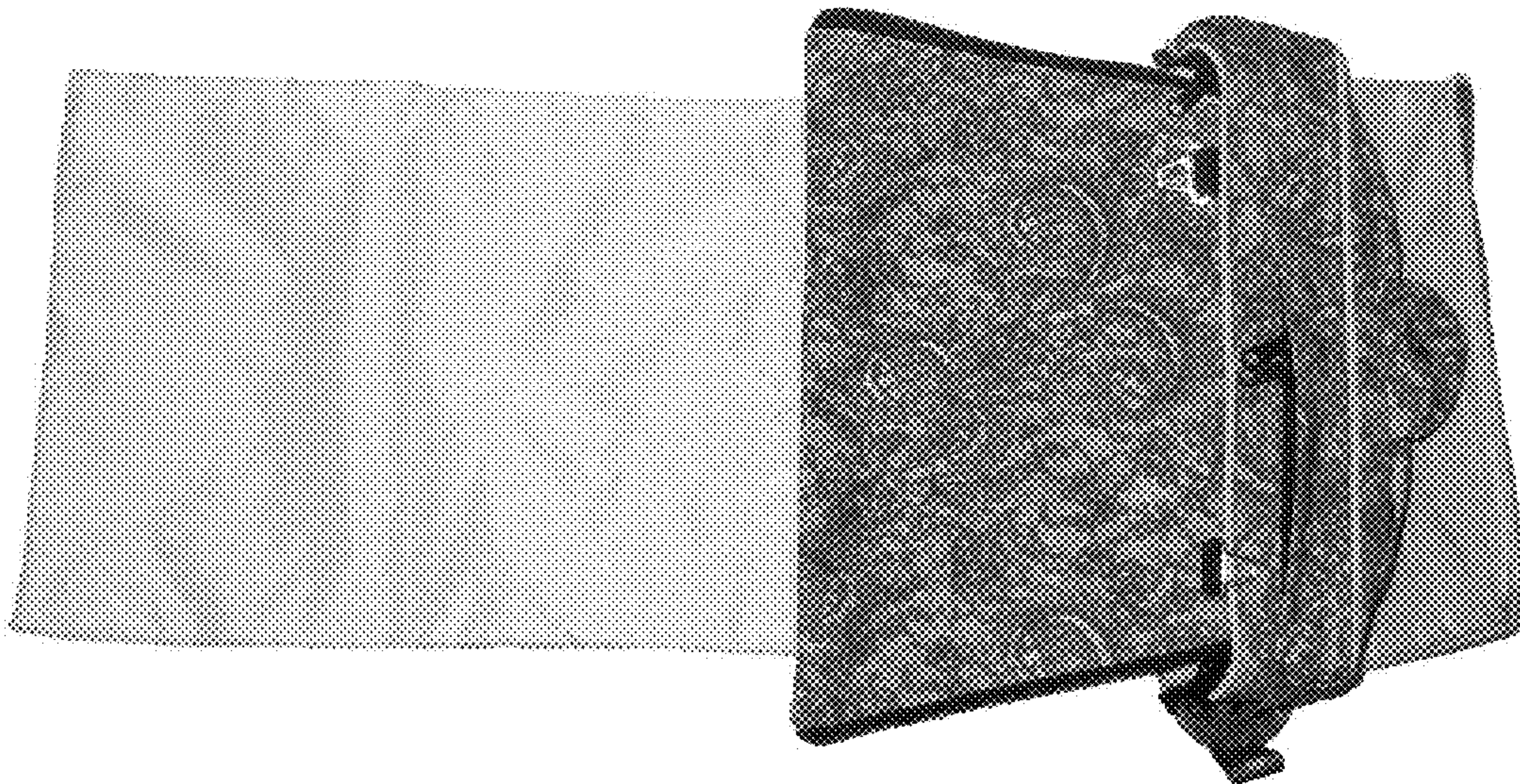
