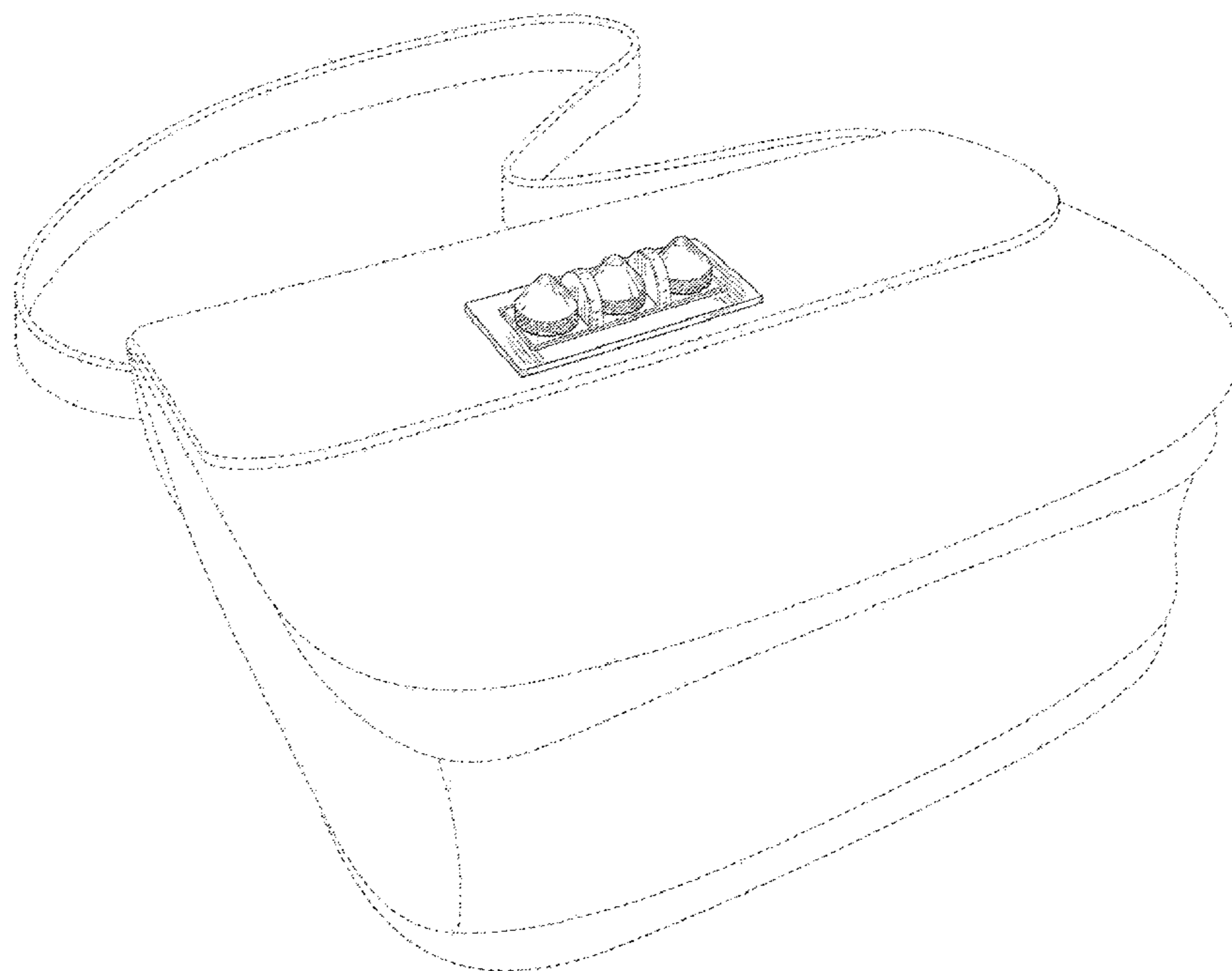
(57) **CLAIM**

The ornamental design for a clasp, as shown and described.

FIG. 1 is a perspective view of a clasp showing my new design, shown in the environment of a bag;
FIG. 2 is a front view of the clasp shown in FIG. 1;
FIG. 3 is a rear view of the clasp shown in FIG. 1;
FIG. 4 is a right side view of the clasp shown in FIG. 1;
FIG. 5 is a left side view of the clasp shown in FIG. 1;
FIG. 6 is a top view of the card case shown in FIG. 1;
FIG. 7 is a front perspective view of the clasp shown in FIG. 1;
FIG. 8 is a perspective view of a second embodiment of the clasp shown in FIG. 1, shown in the environment of a clutch;
FIG. 9 is a front view of the clasp shown in FIG. 8;
FIG. 10 is a rear view of the clasp shown in FIG. 8;
FIG. 11 is a right side view of the clasp shown in FIG. 8;

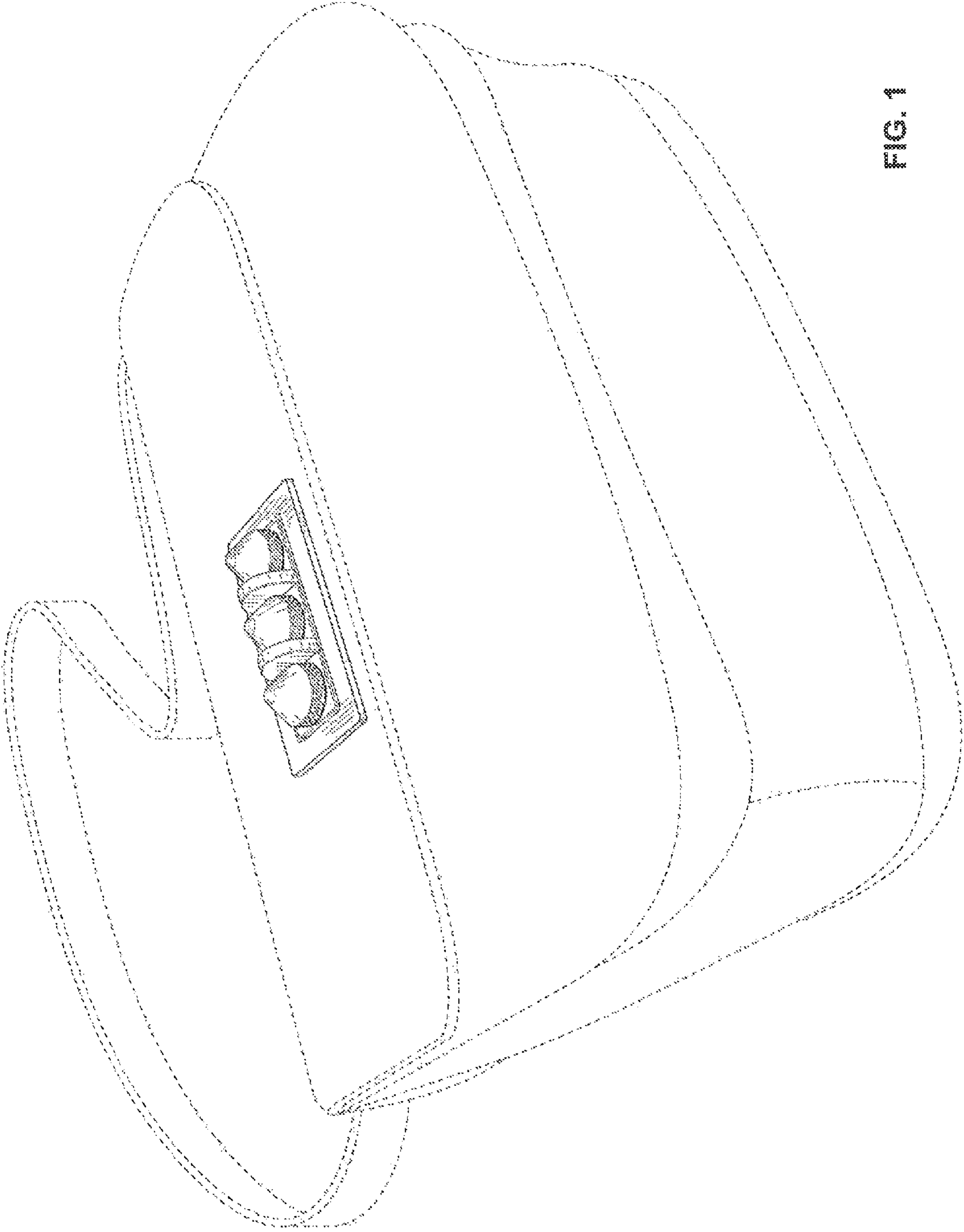

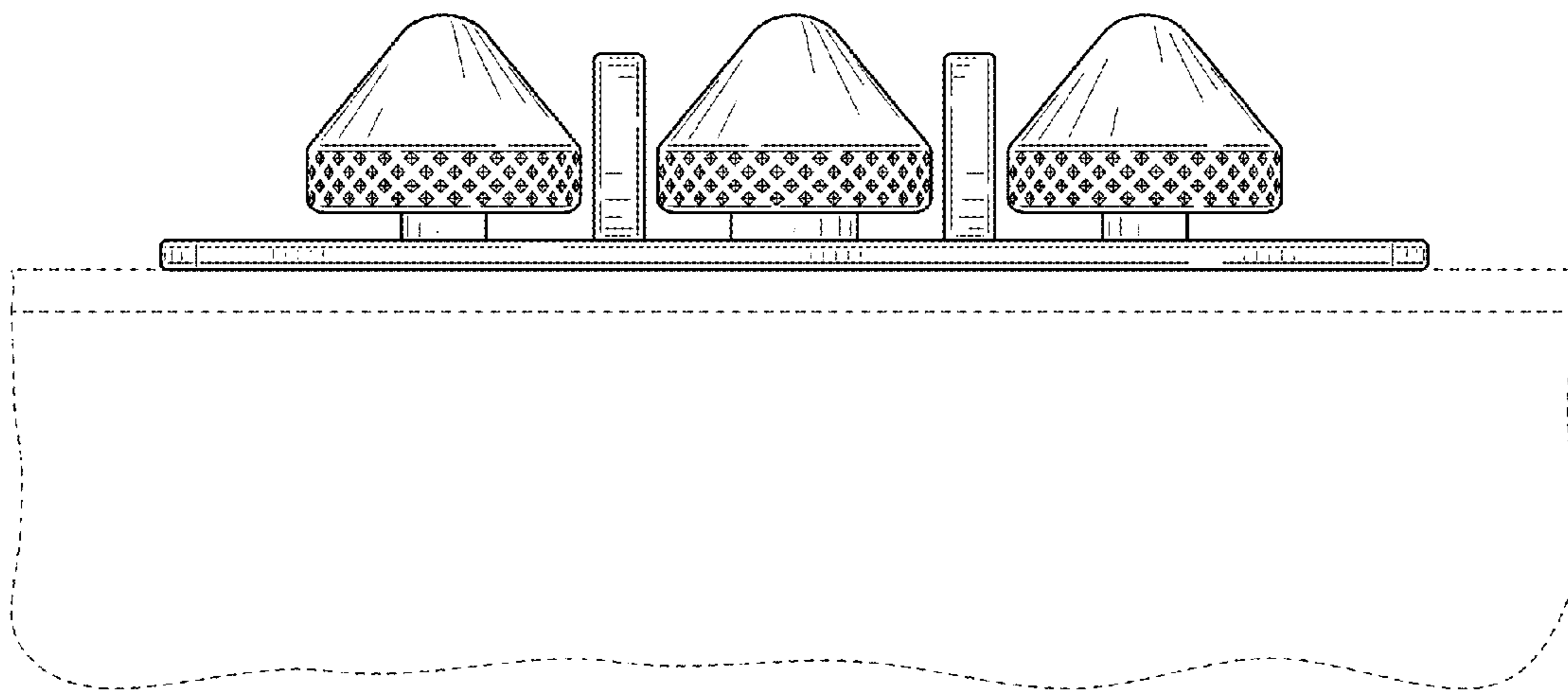

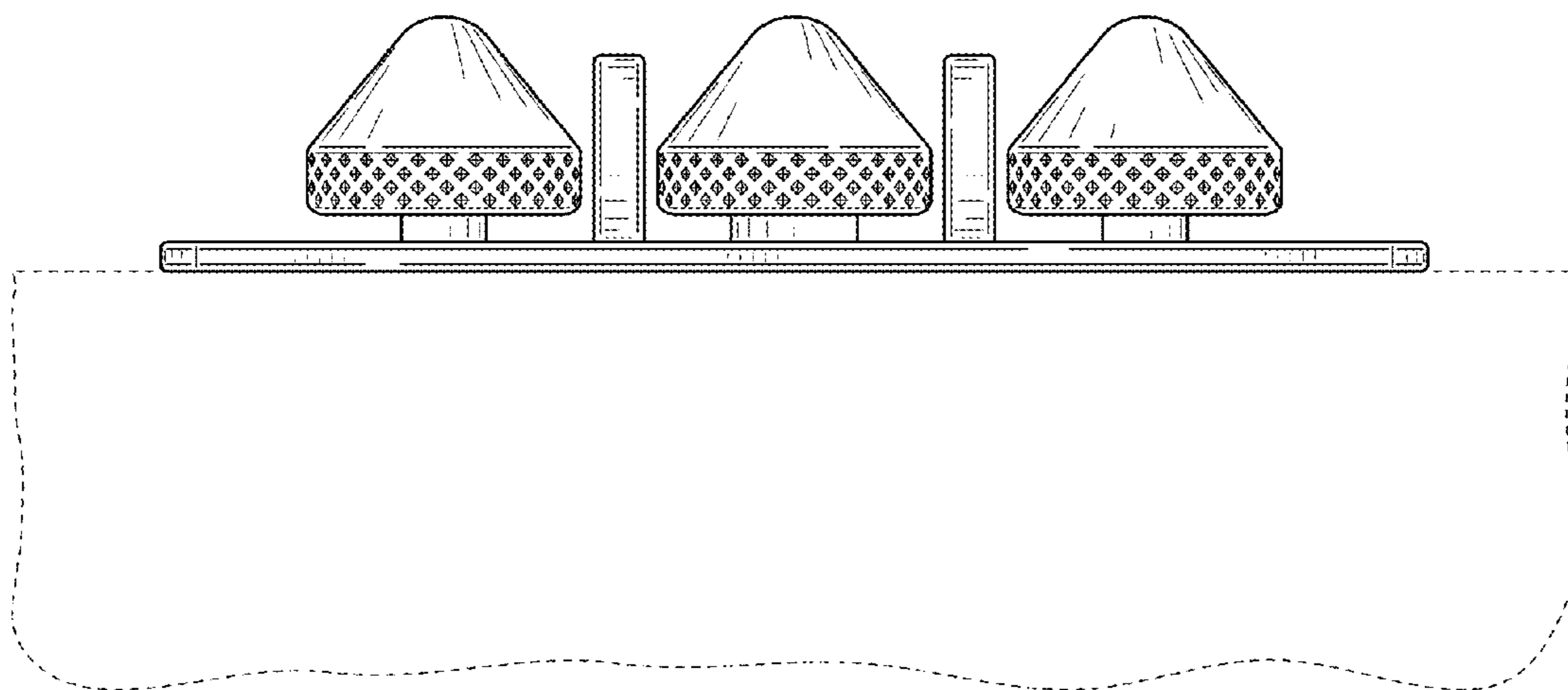

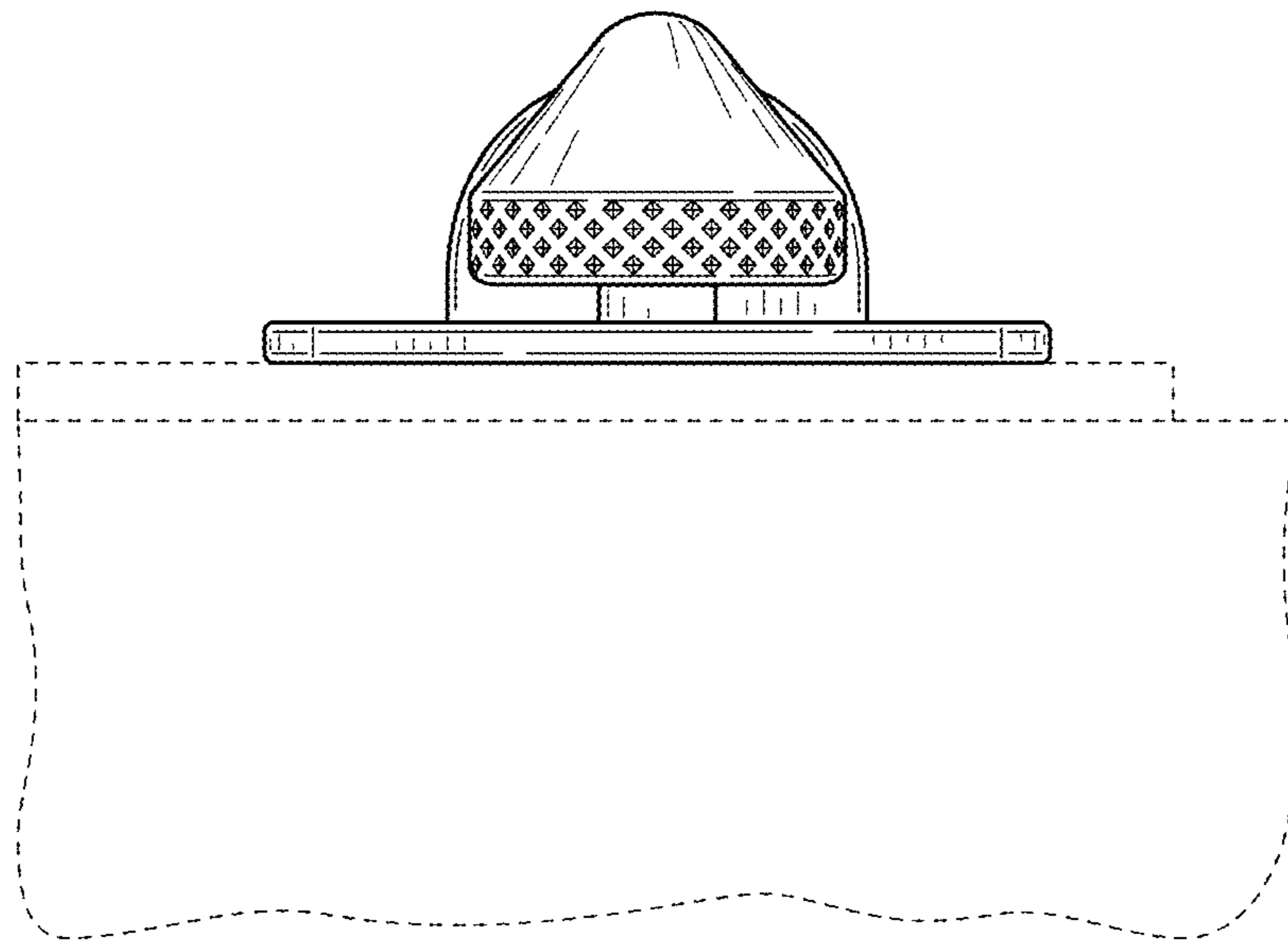

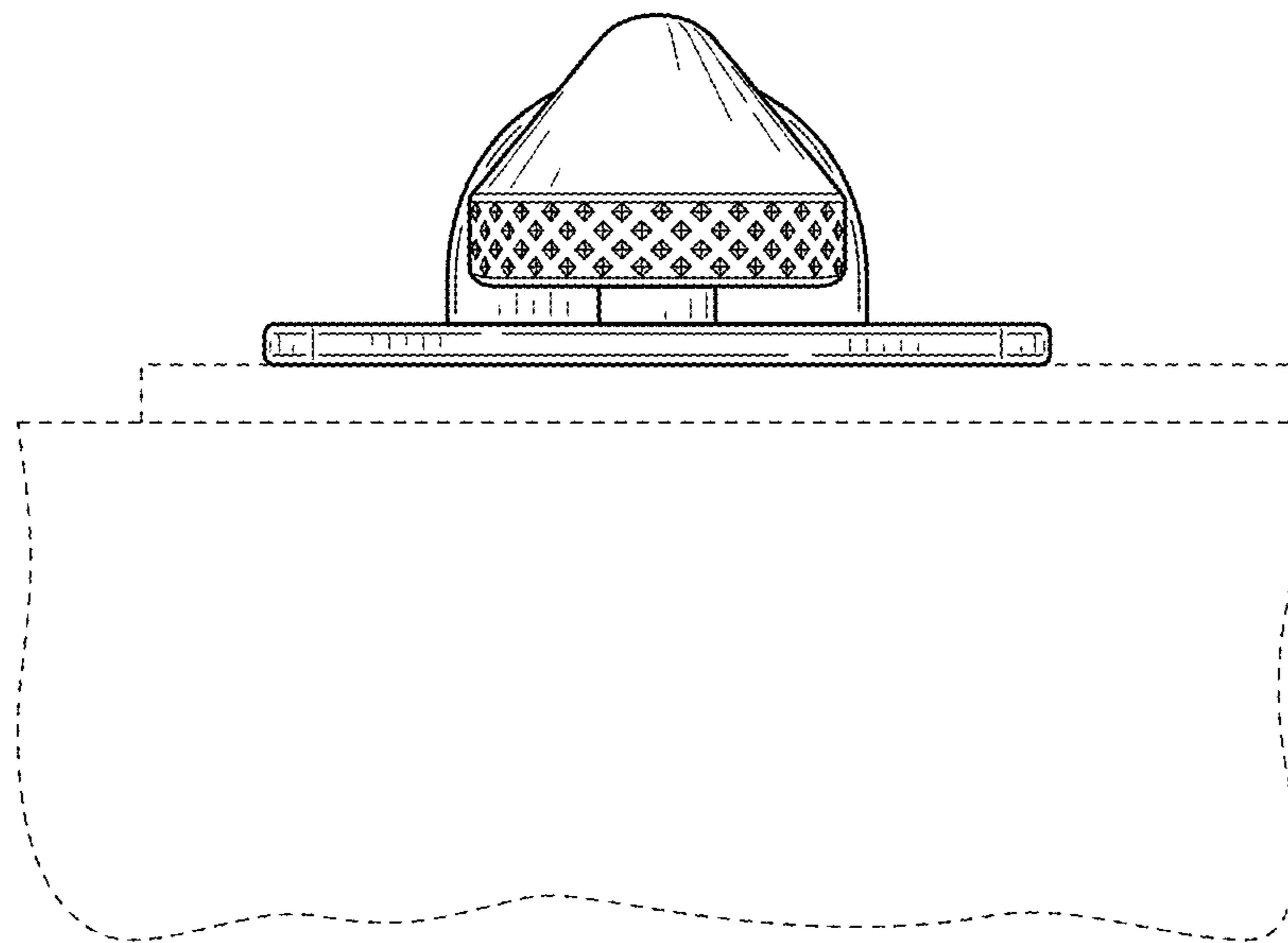

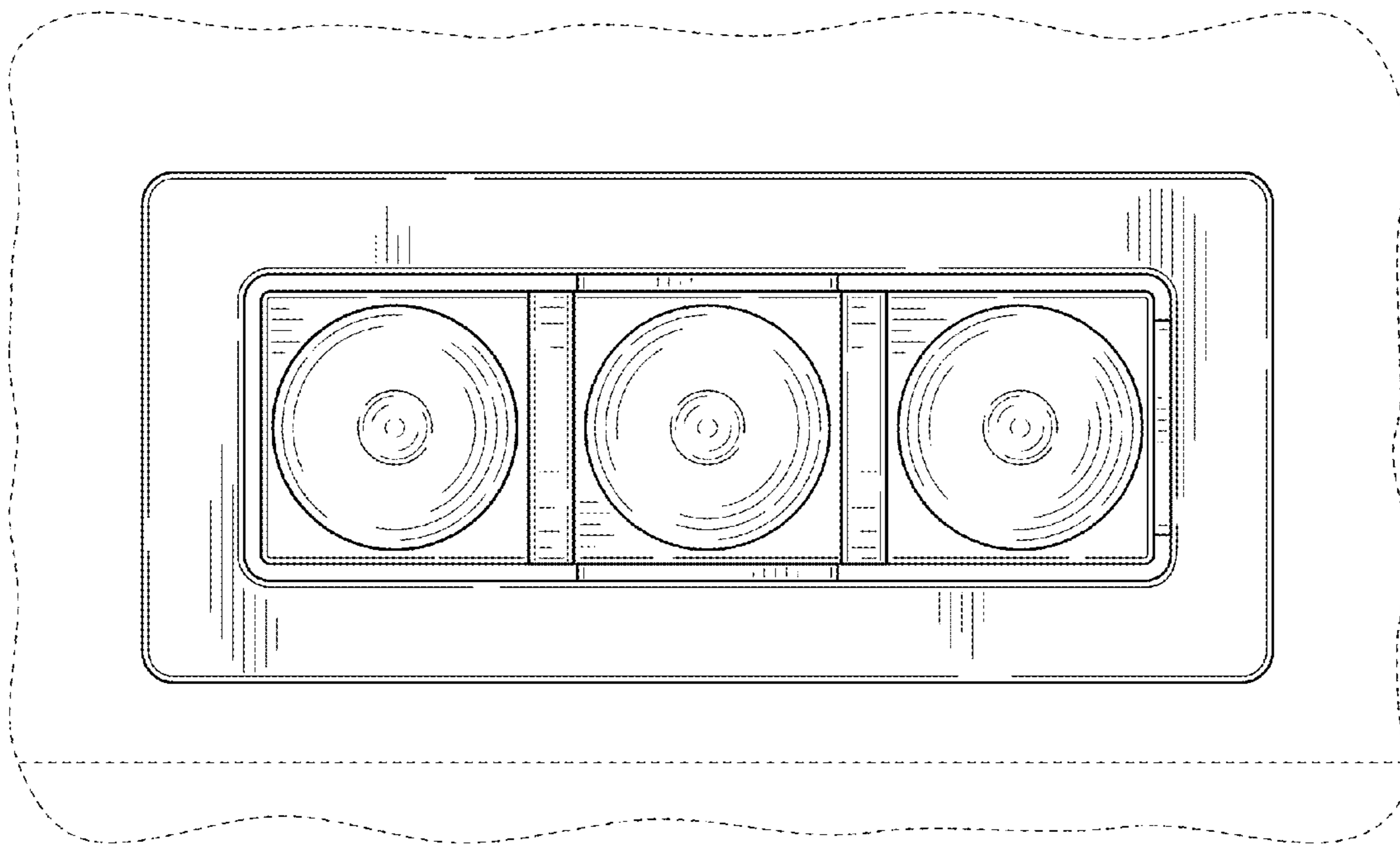

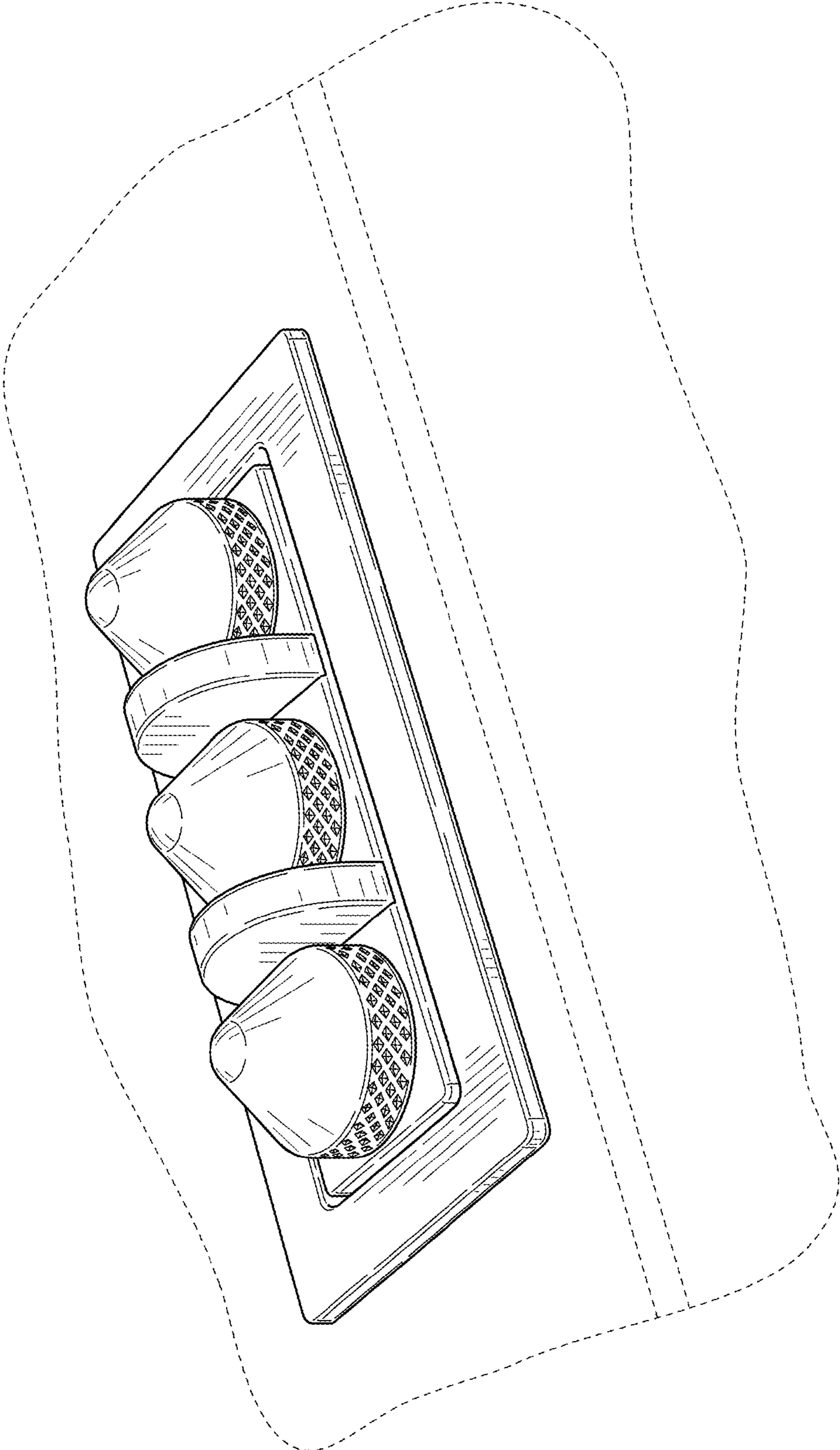

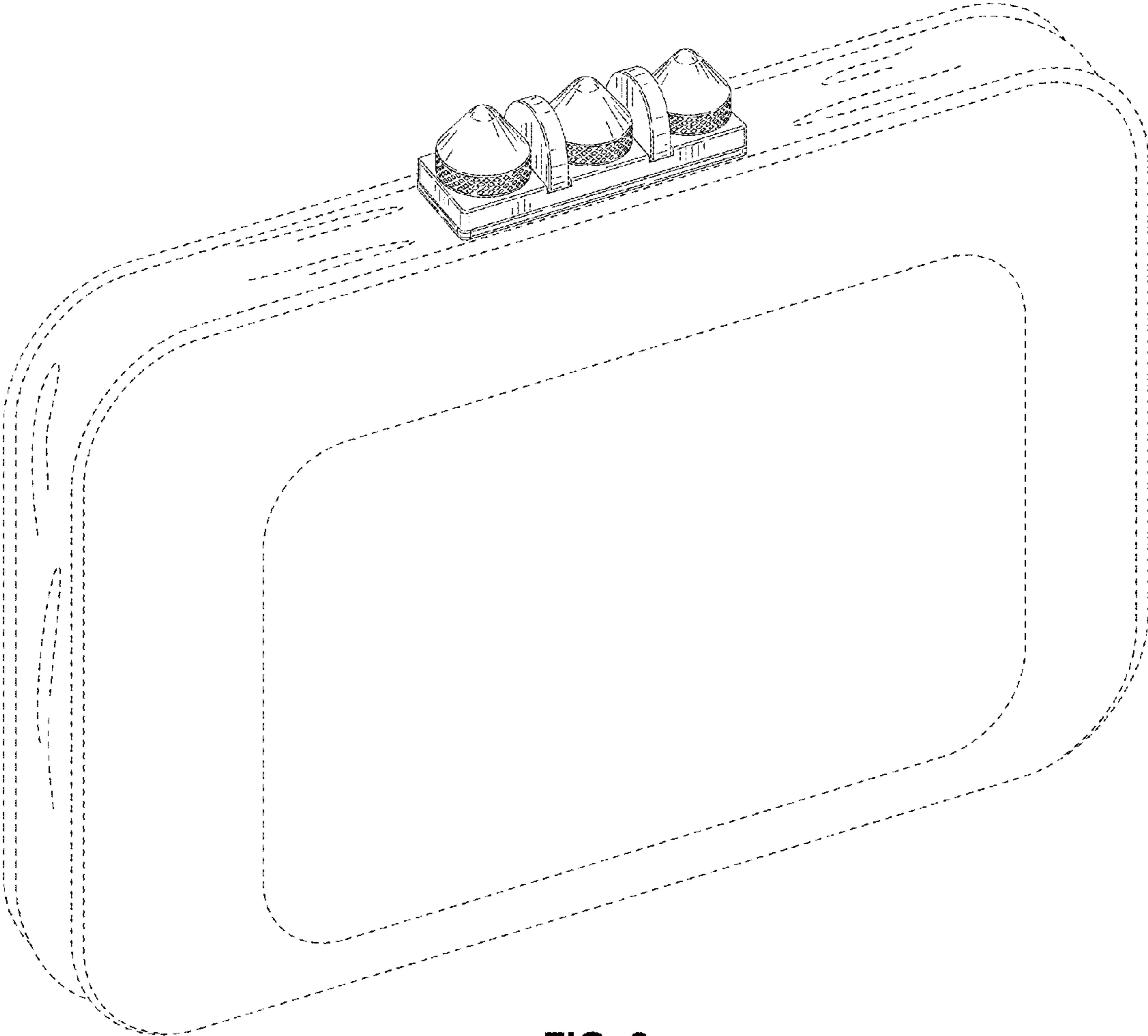

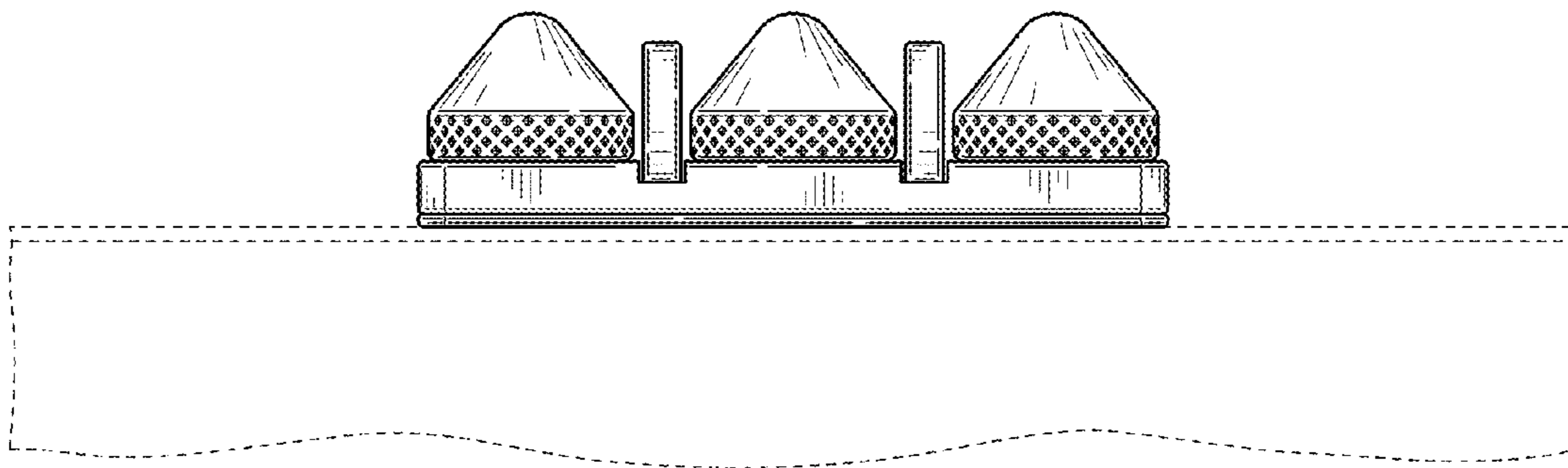

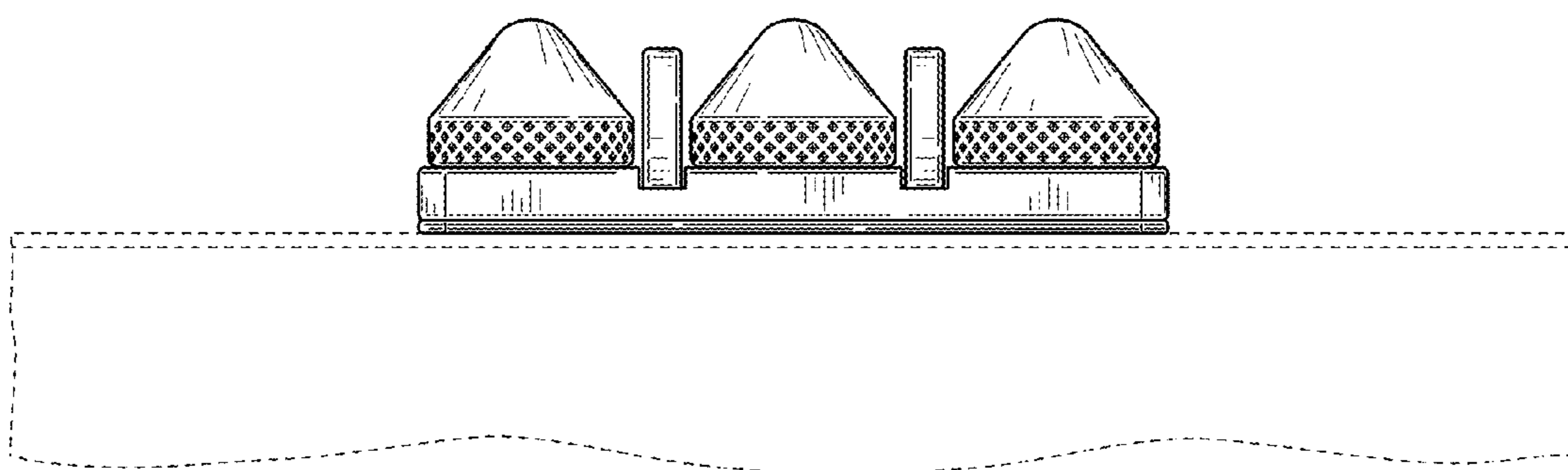

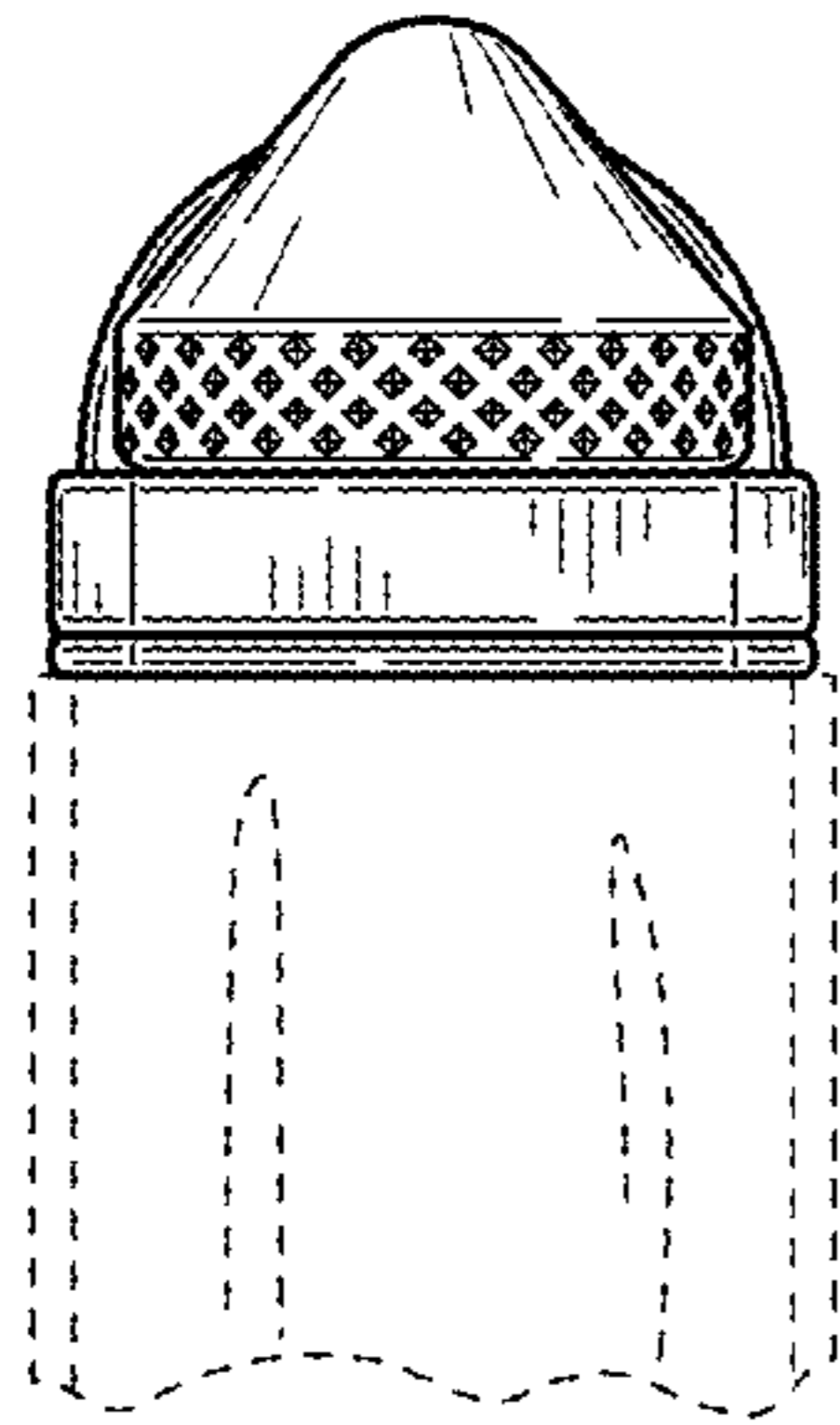

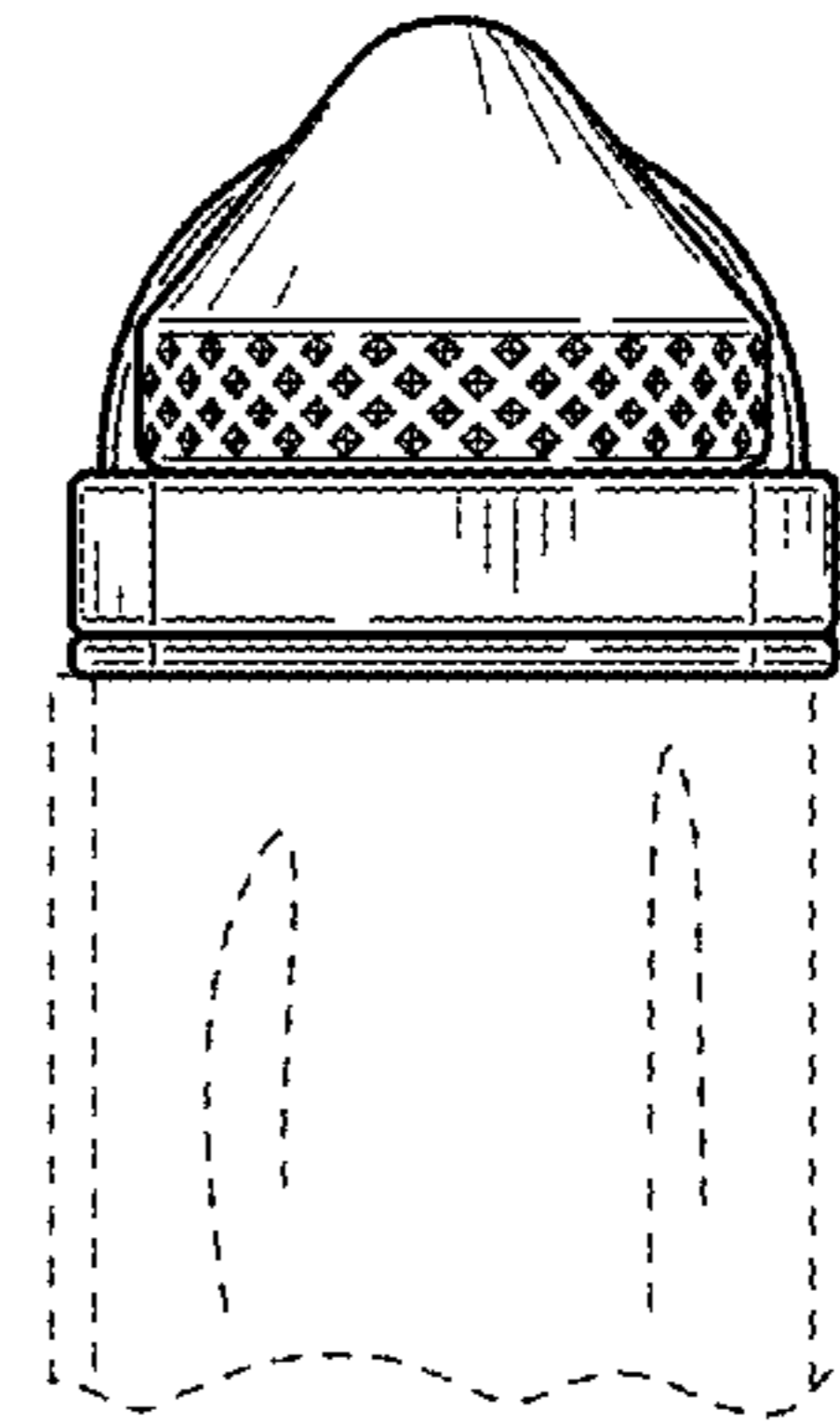

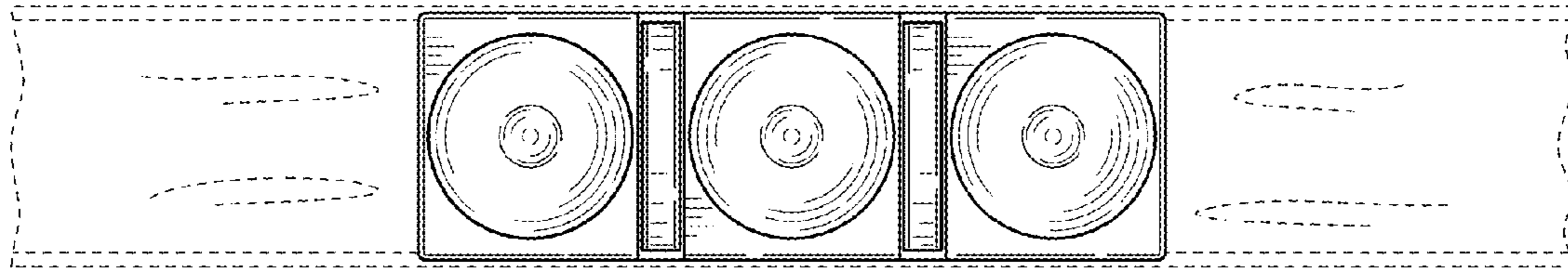

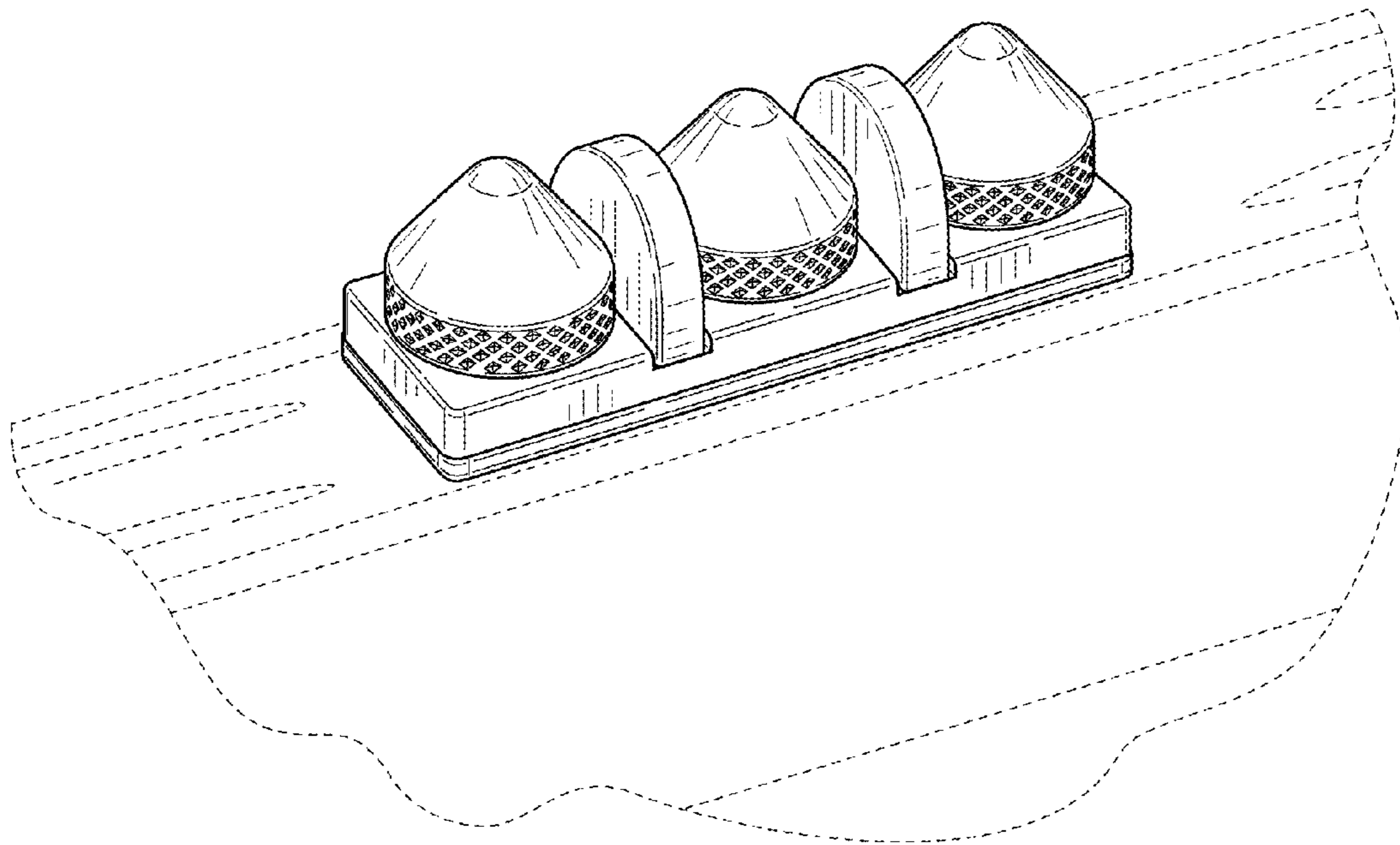

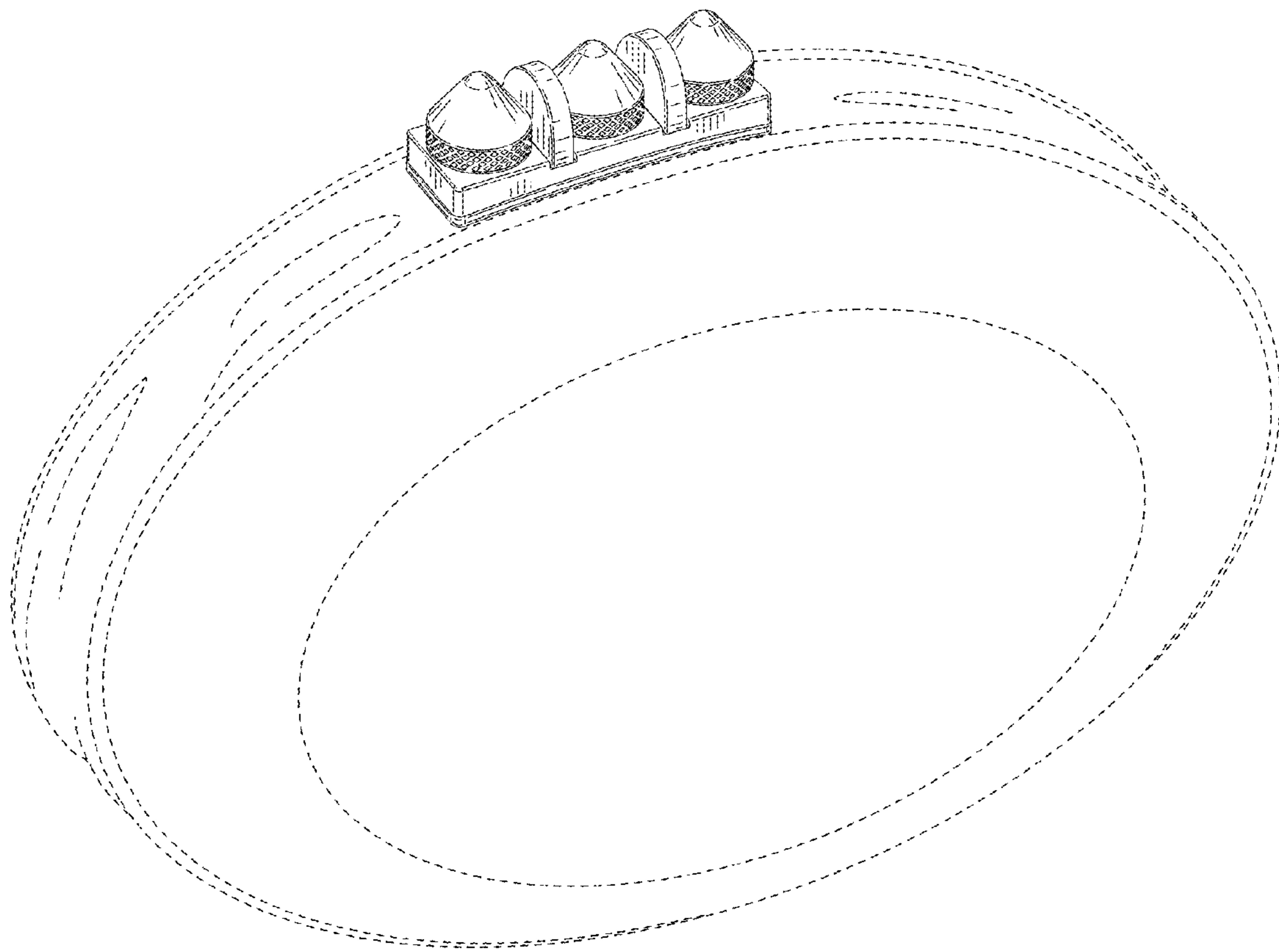

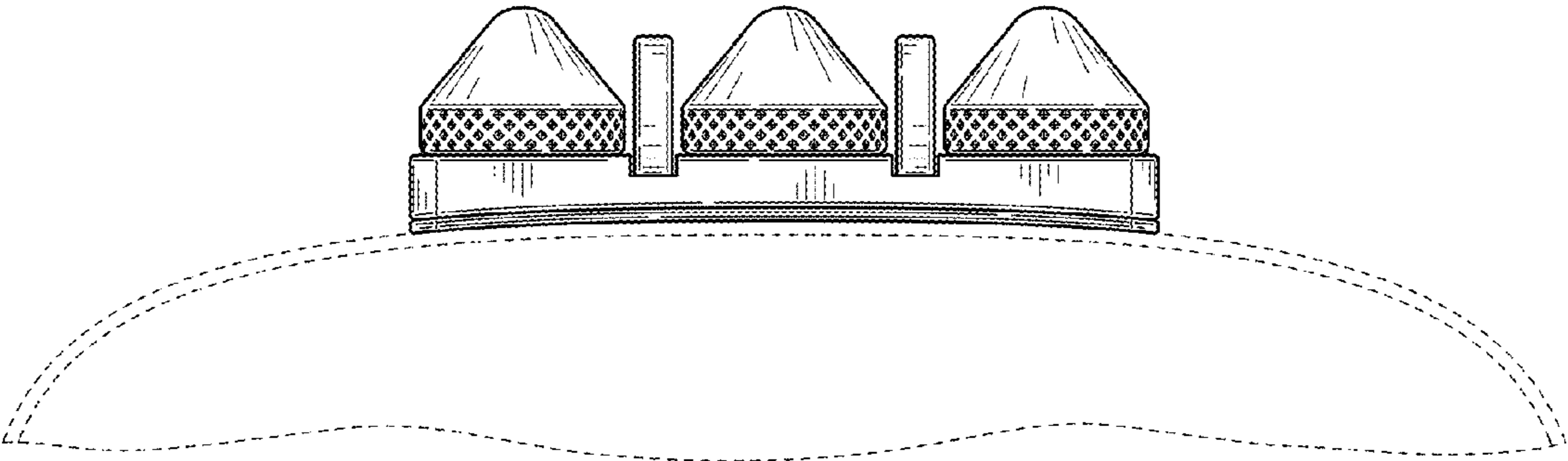

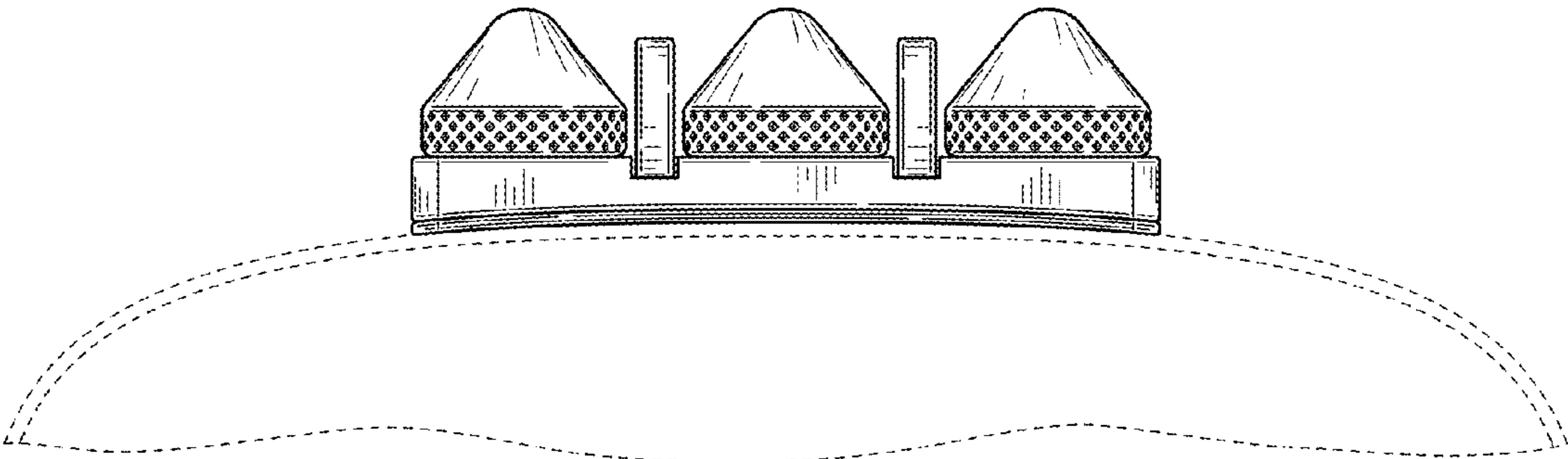

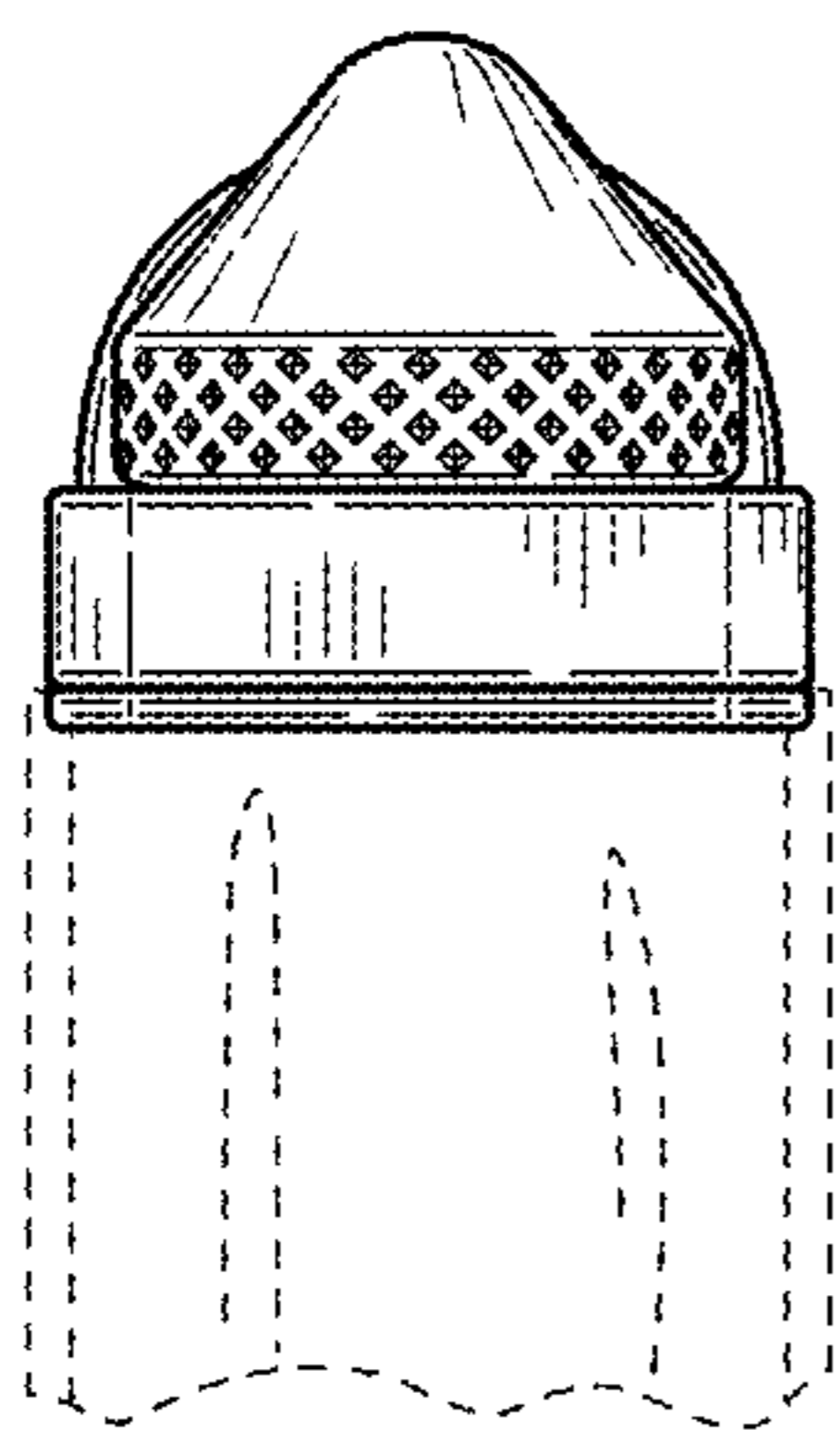

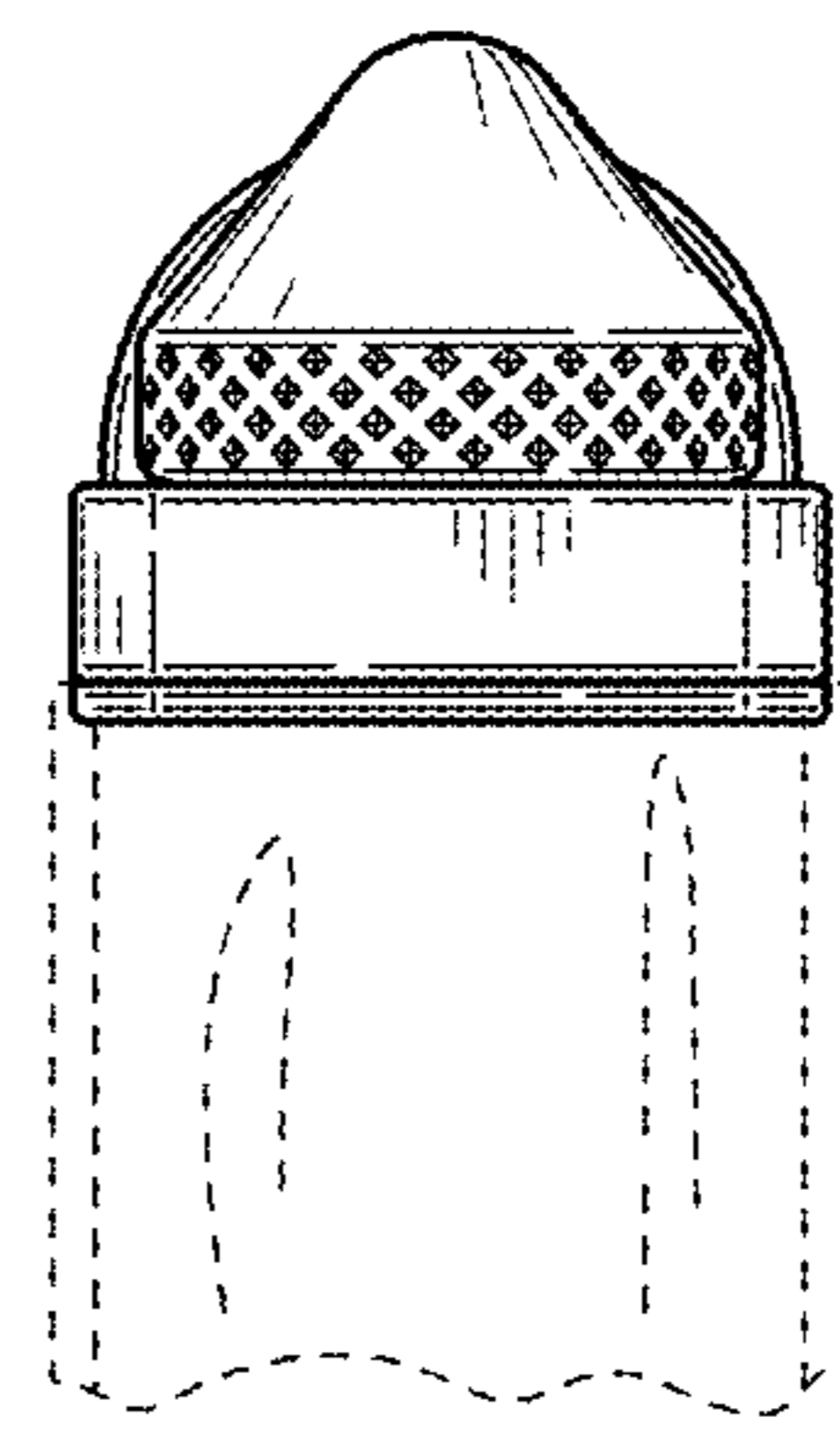

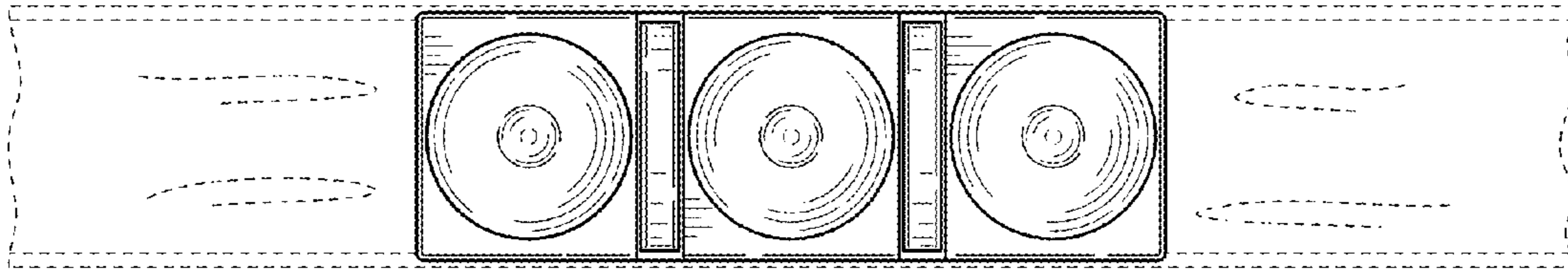

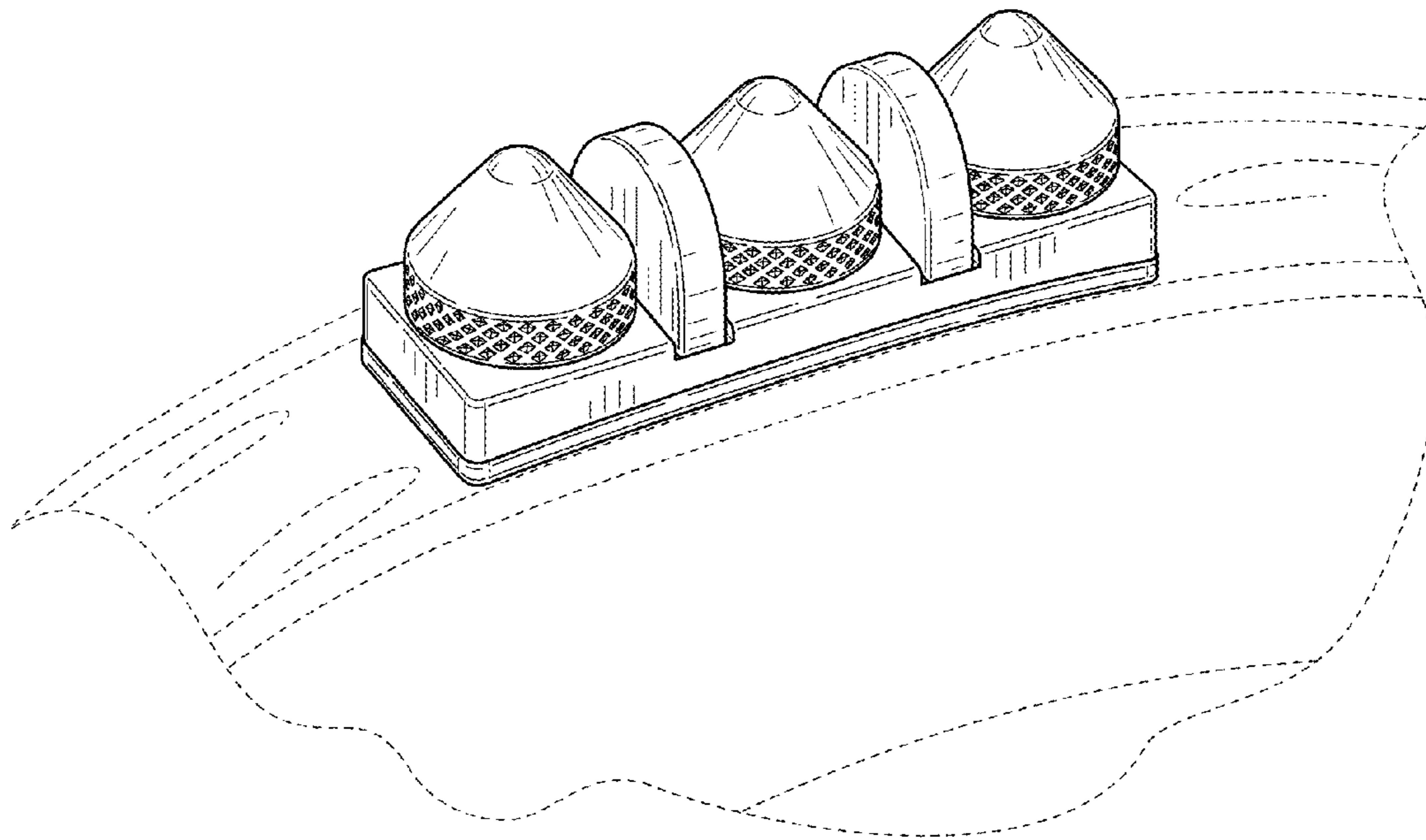
