The ornamental design for a bench, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a bench;  
FIG. 2 is a bottom view of the bench depicted in FIG. 1;

FIG. 4 is a left side view of the bench depicted in FIG. 1;

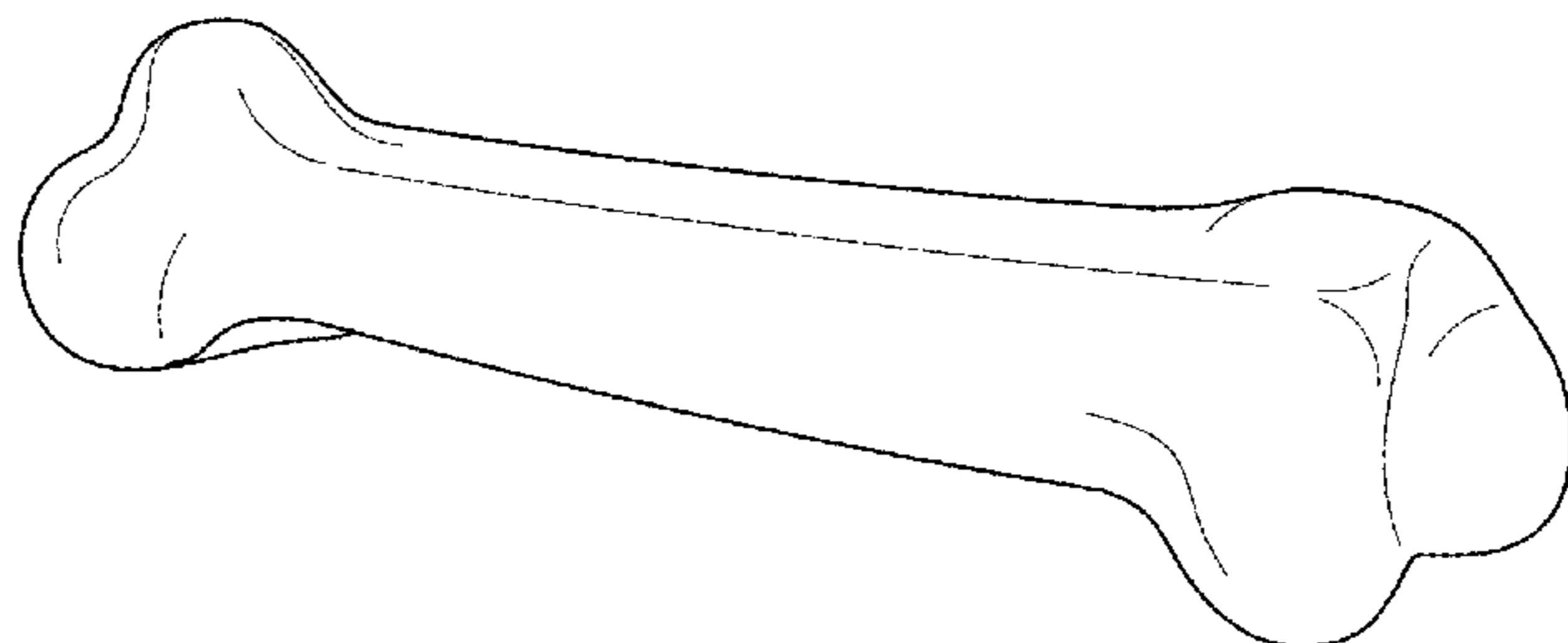
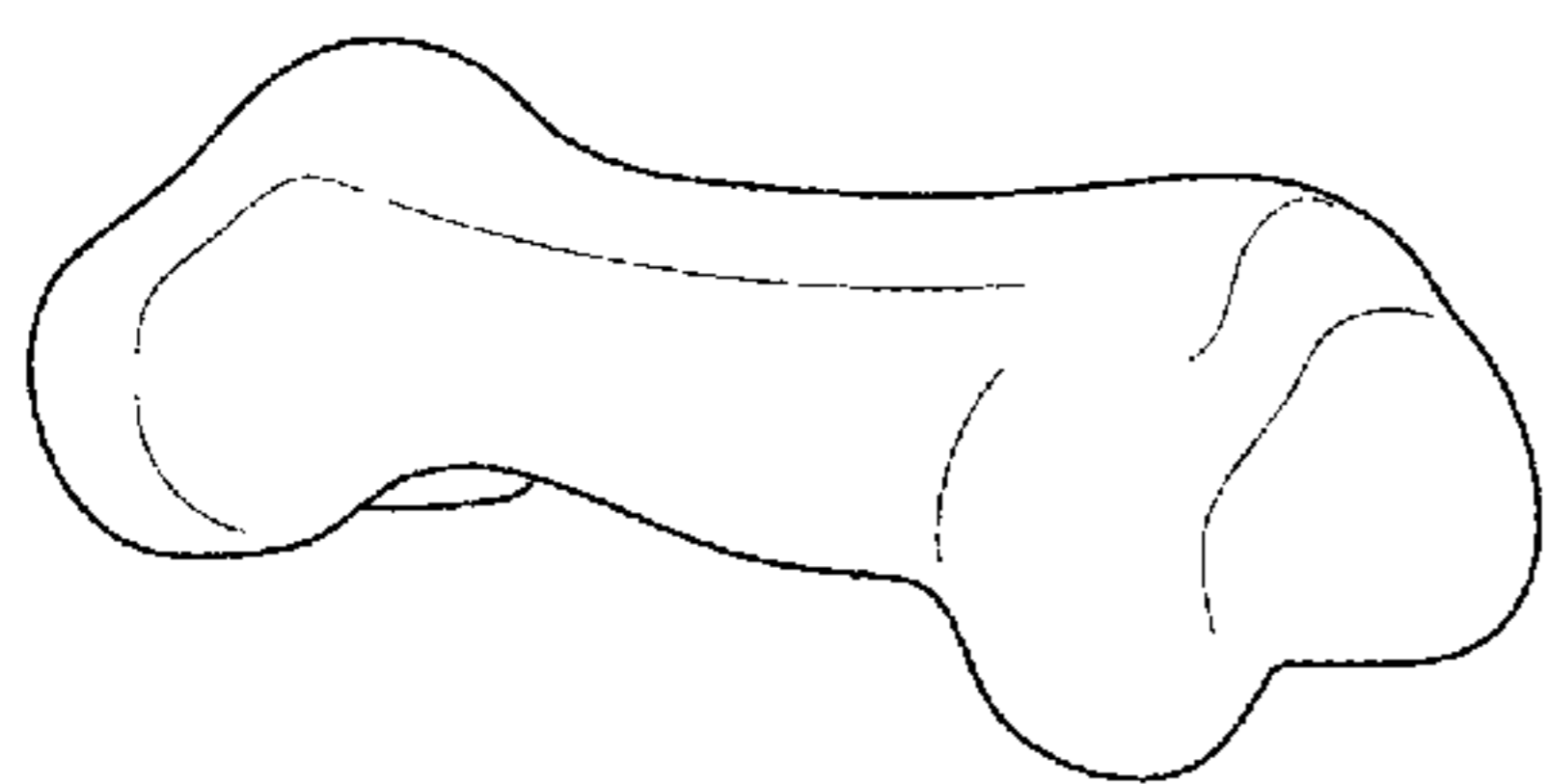

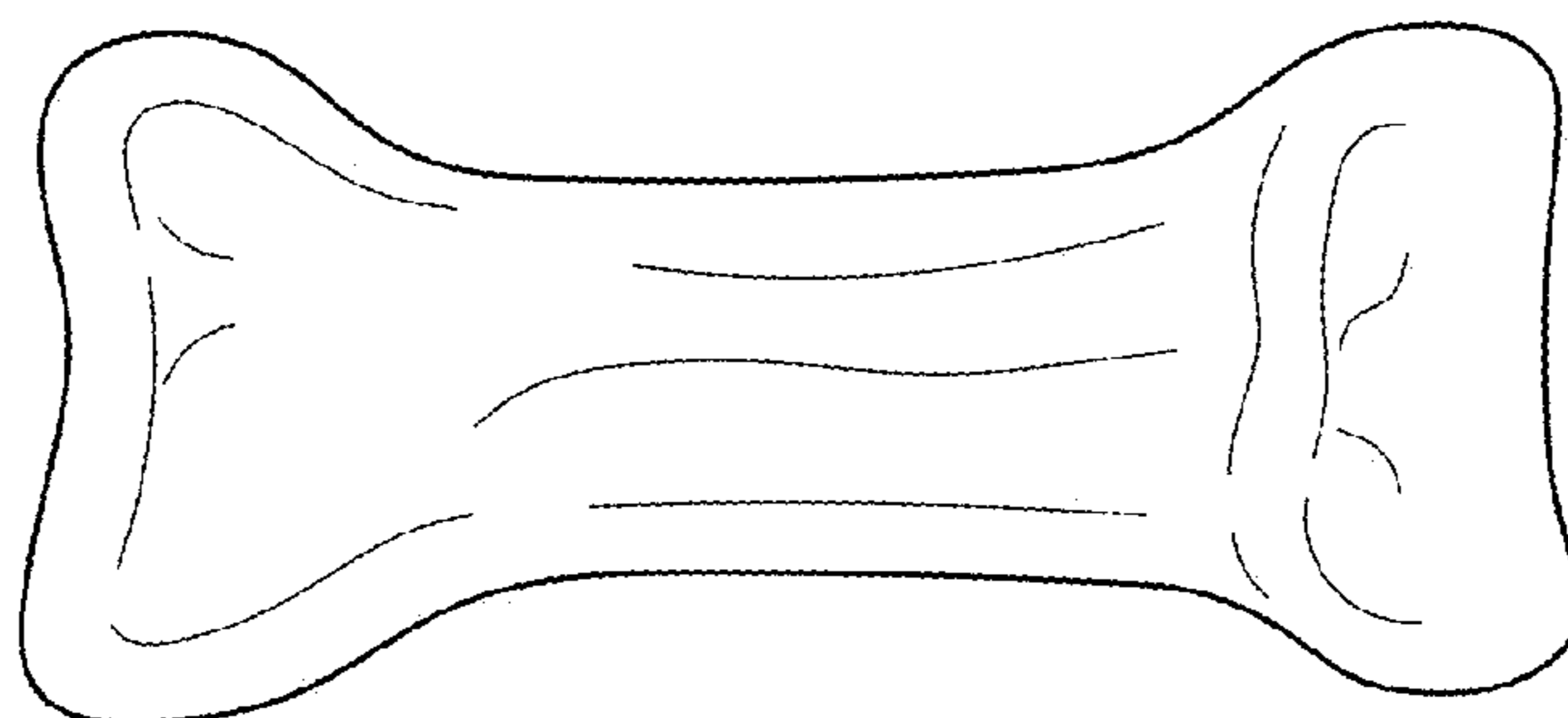

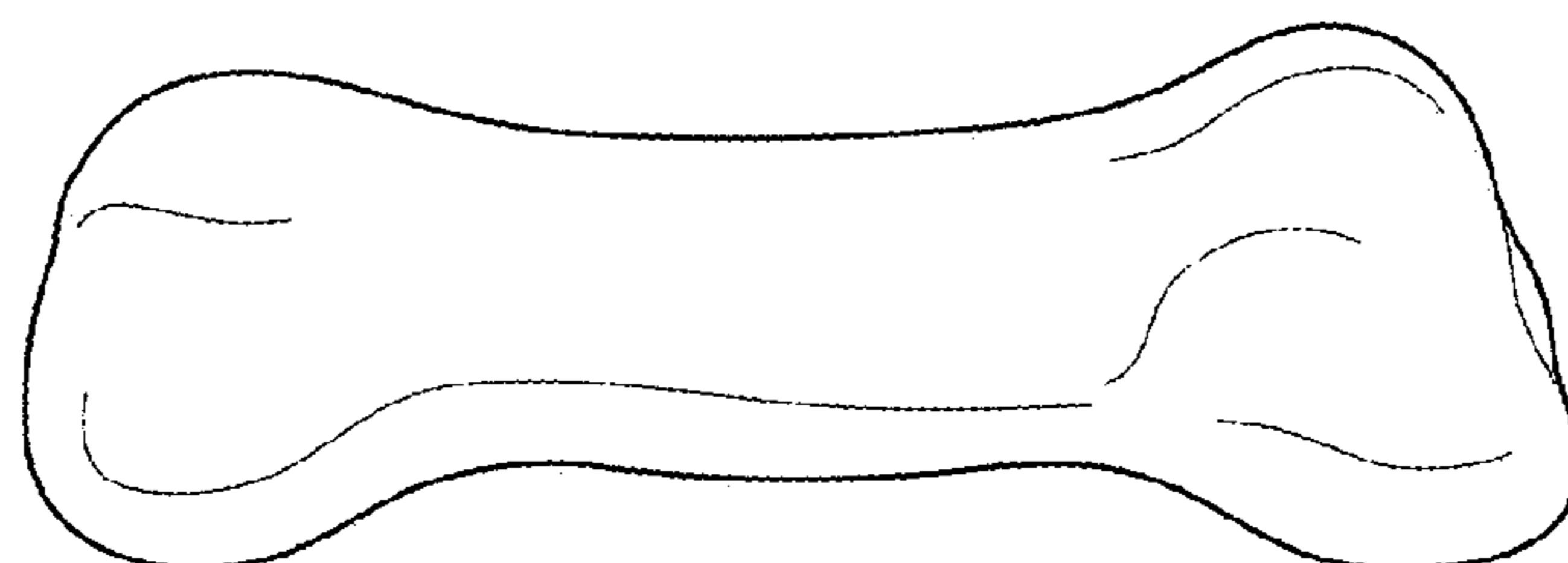

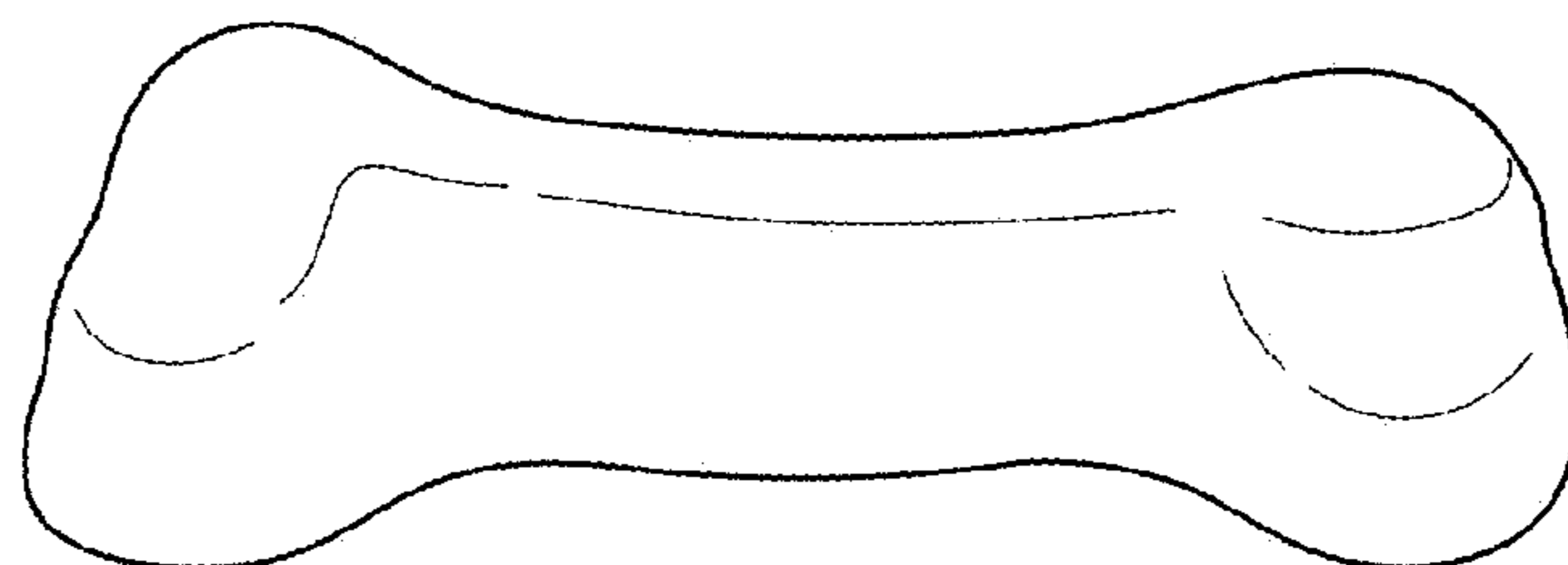

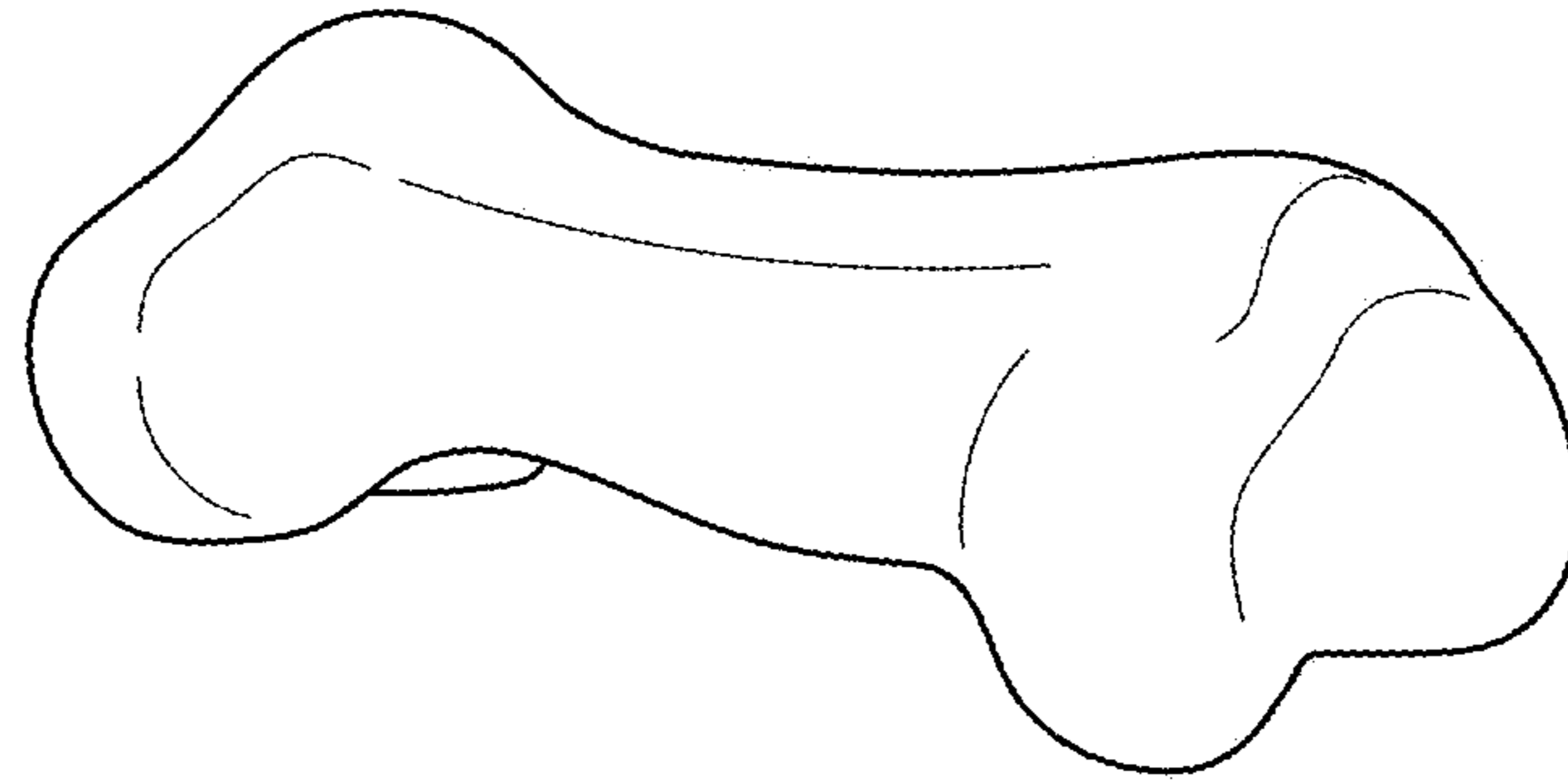

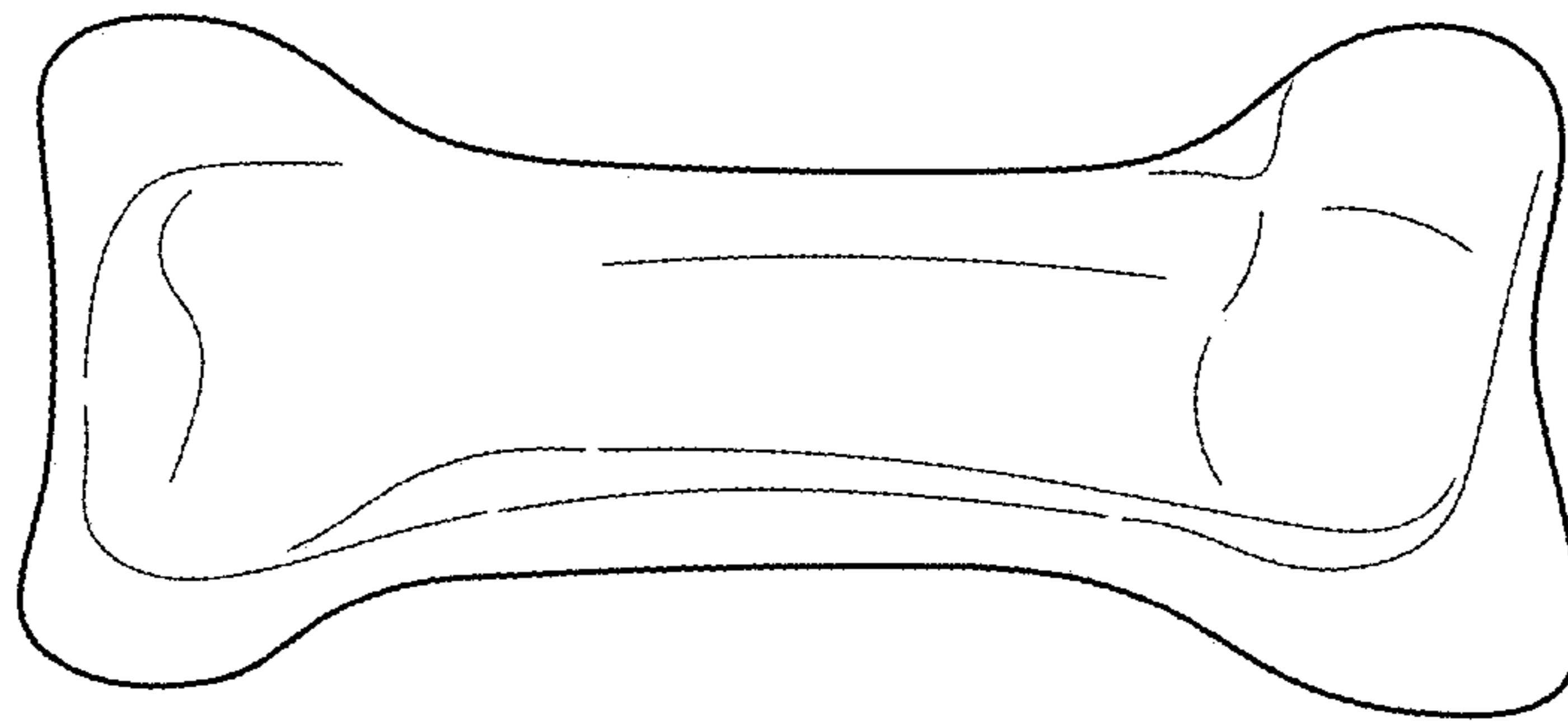

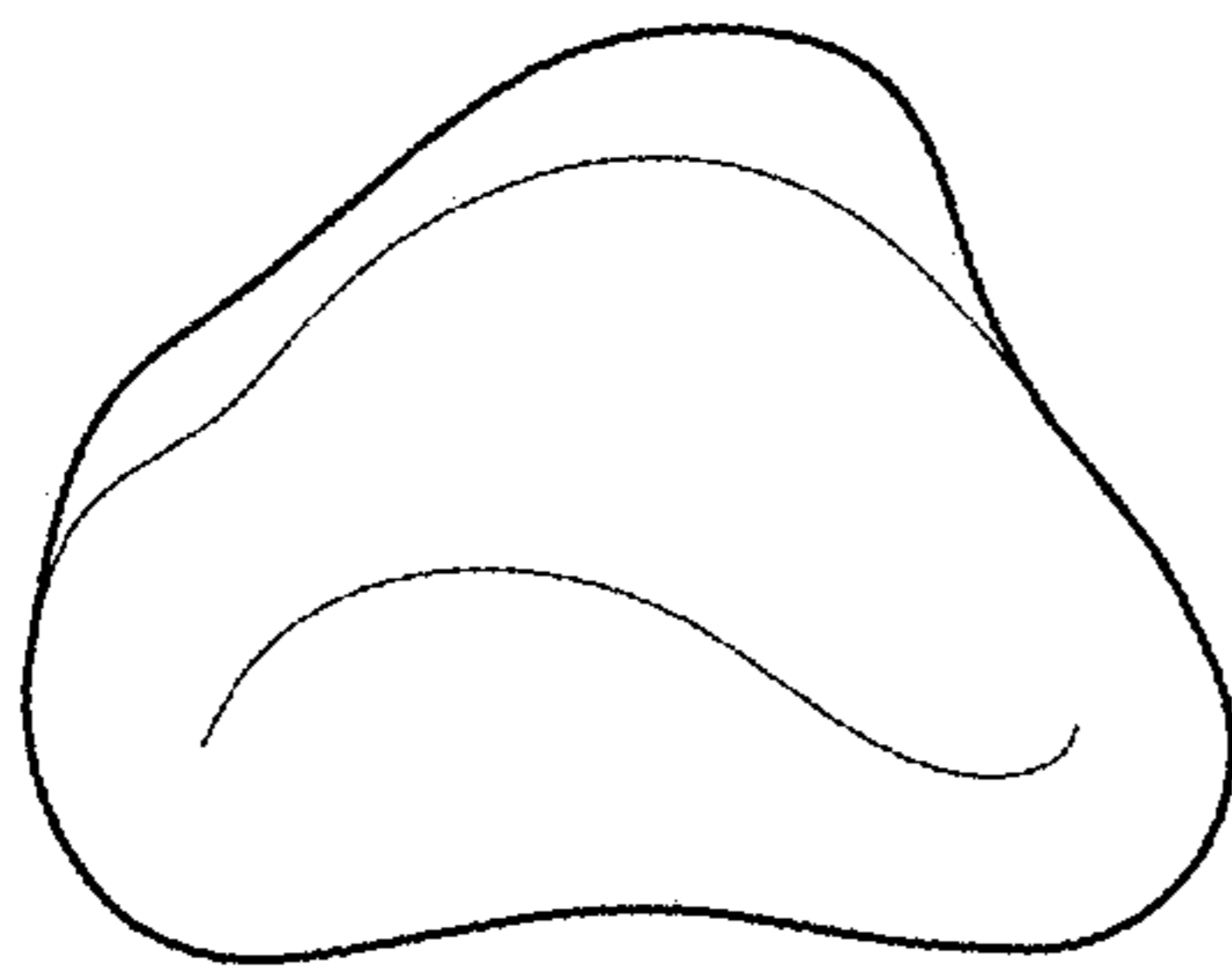

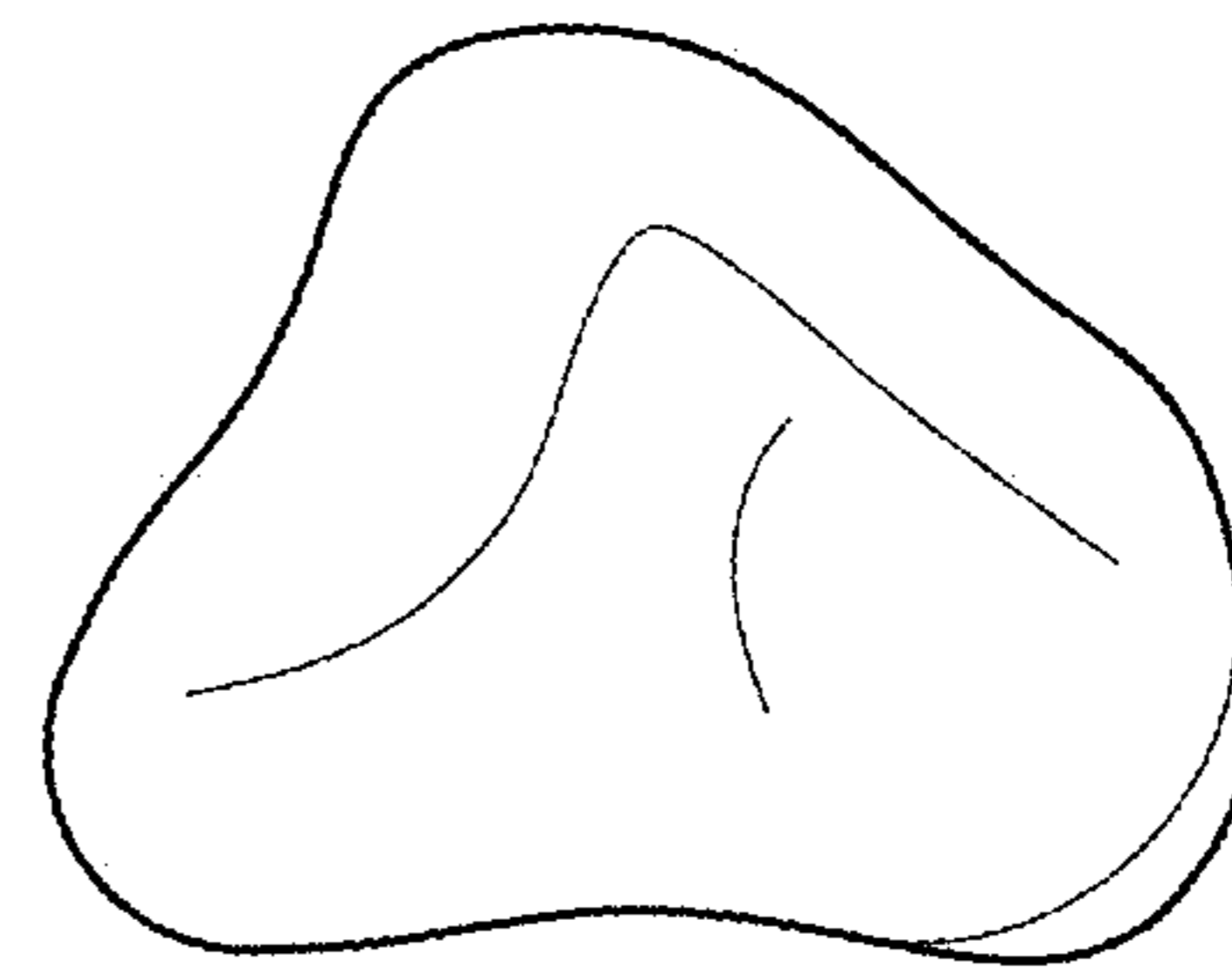

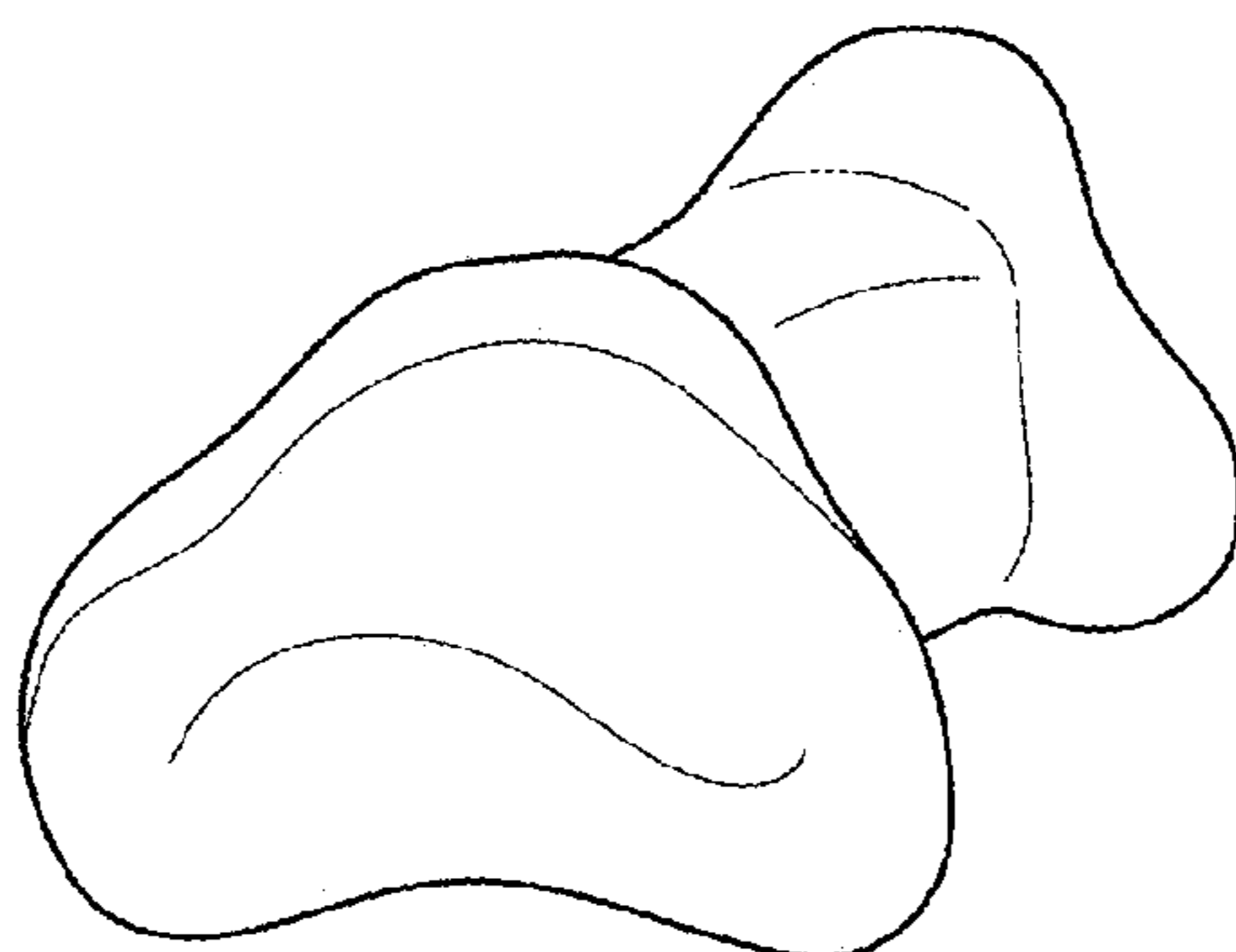

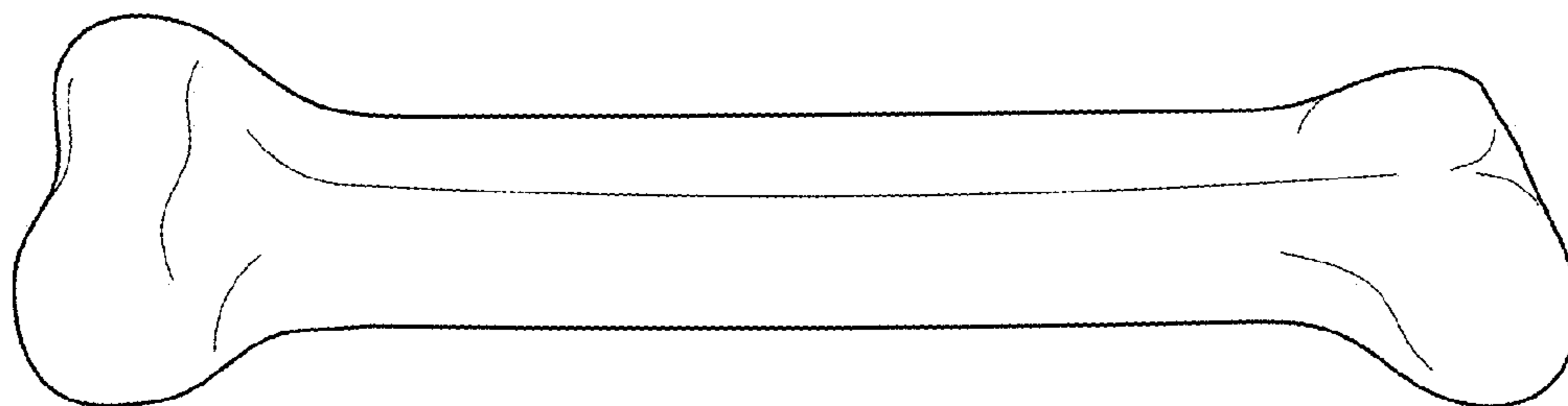

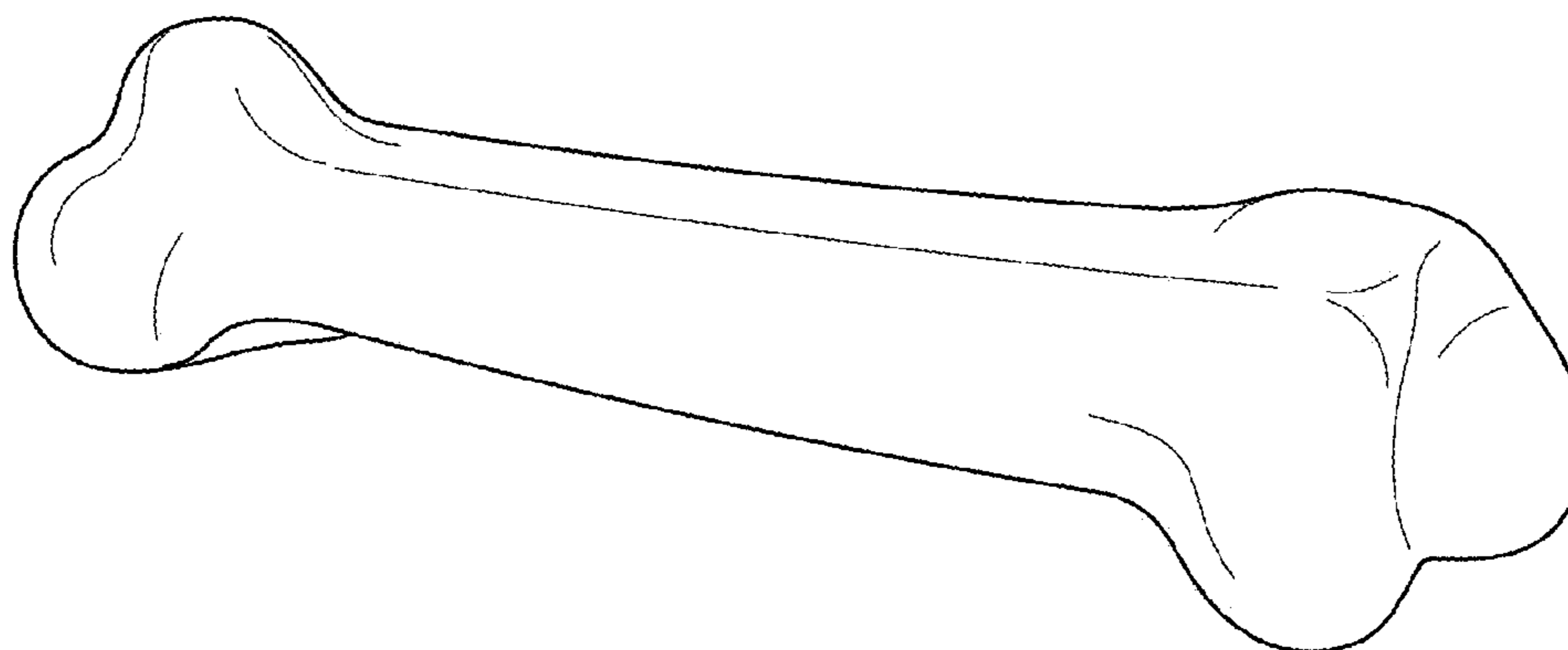
