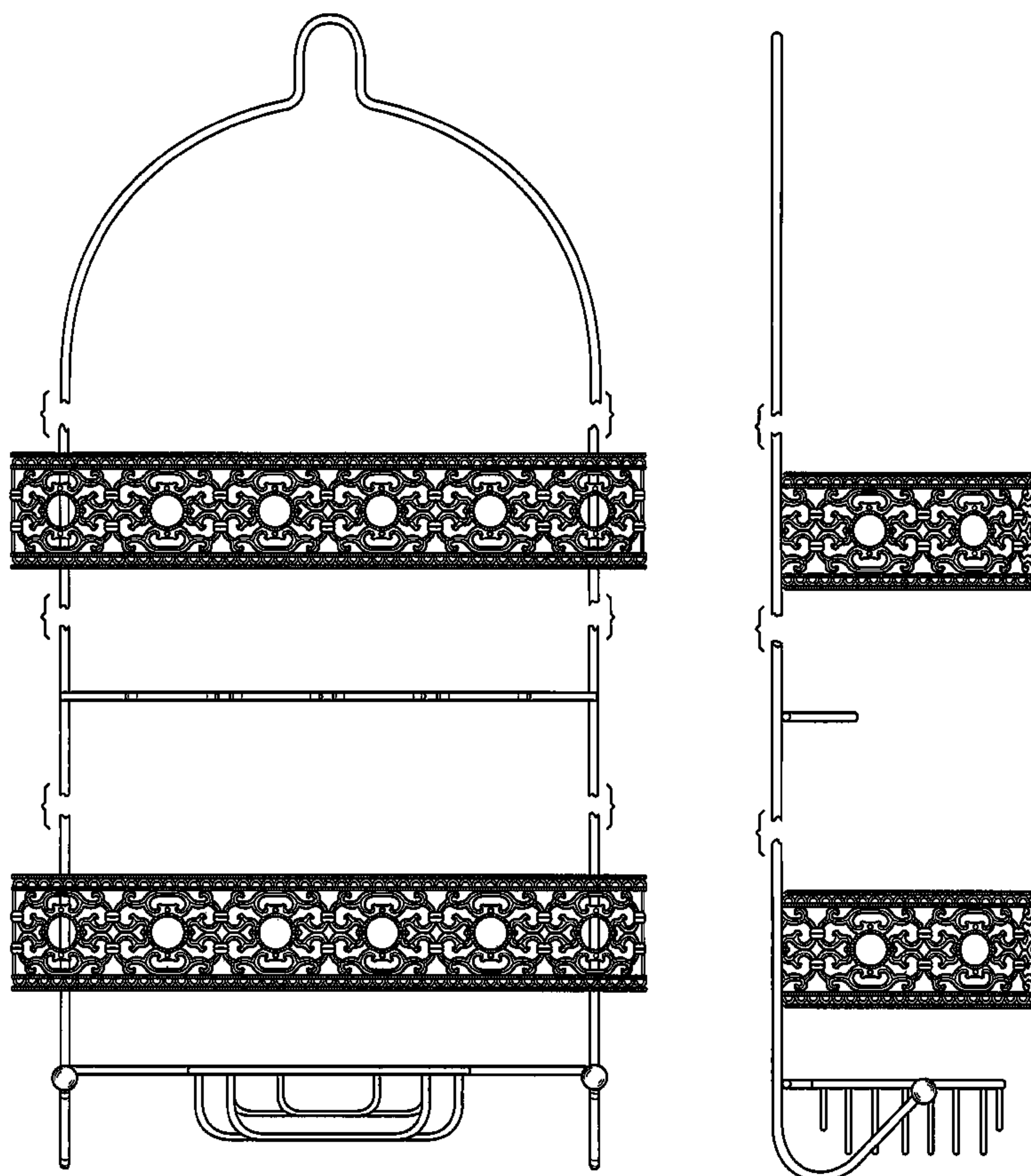
(57) **CLAIM**

The ornamental design for a shower caddy, as shown and described.

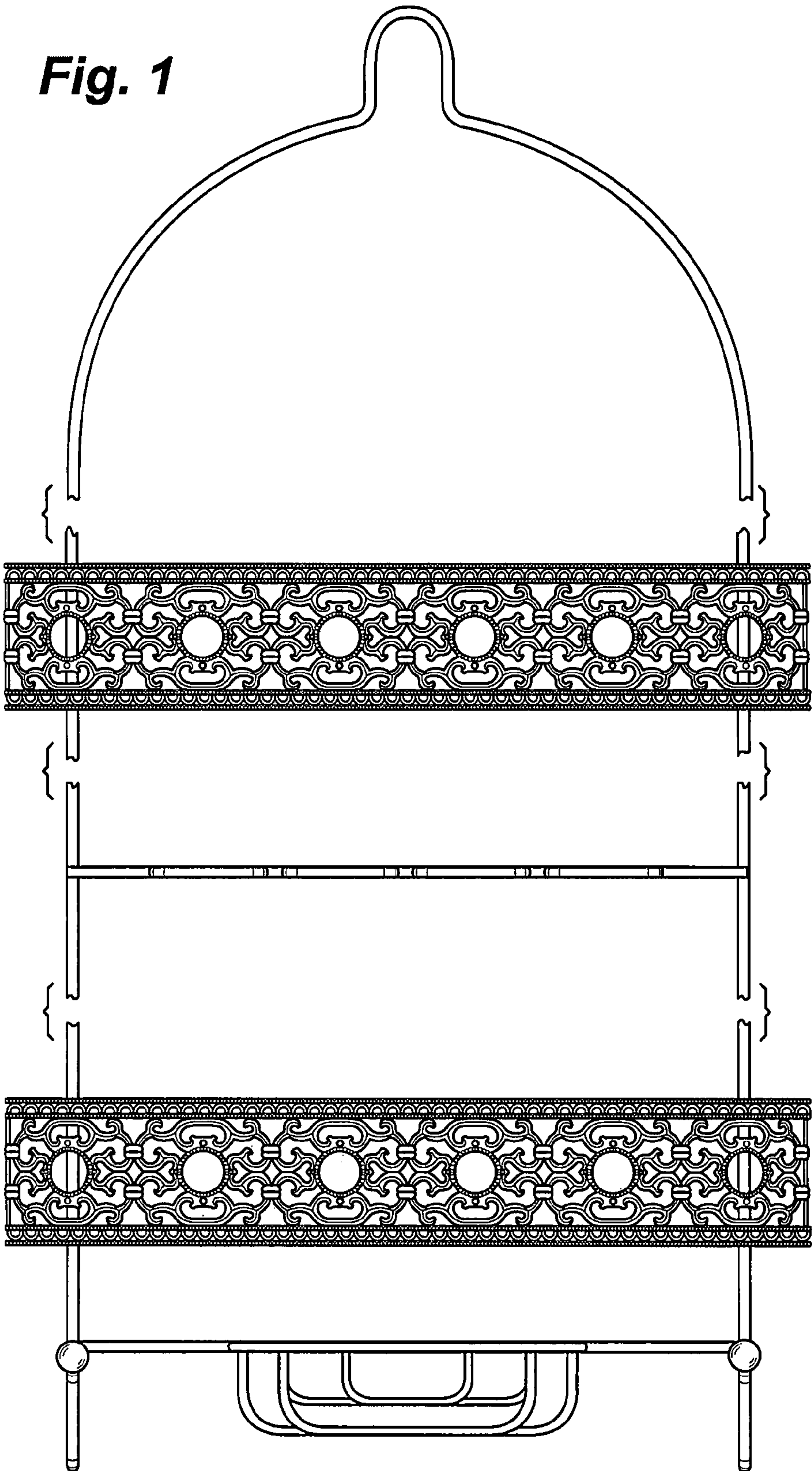
### DESCRIPTION

FIG. 1 is a front elevational view of a shower caddy in accordance with my new design;

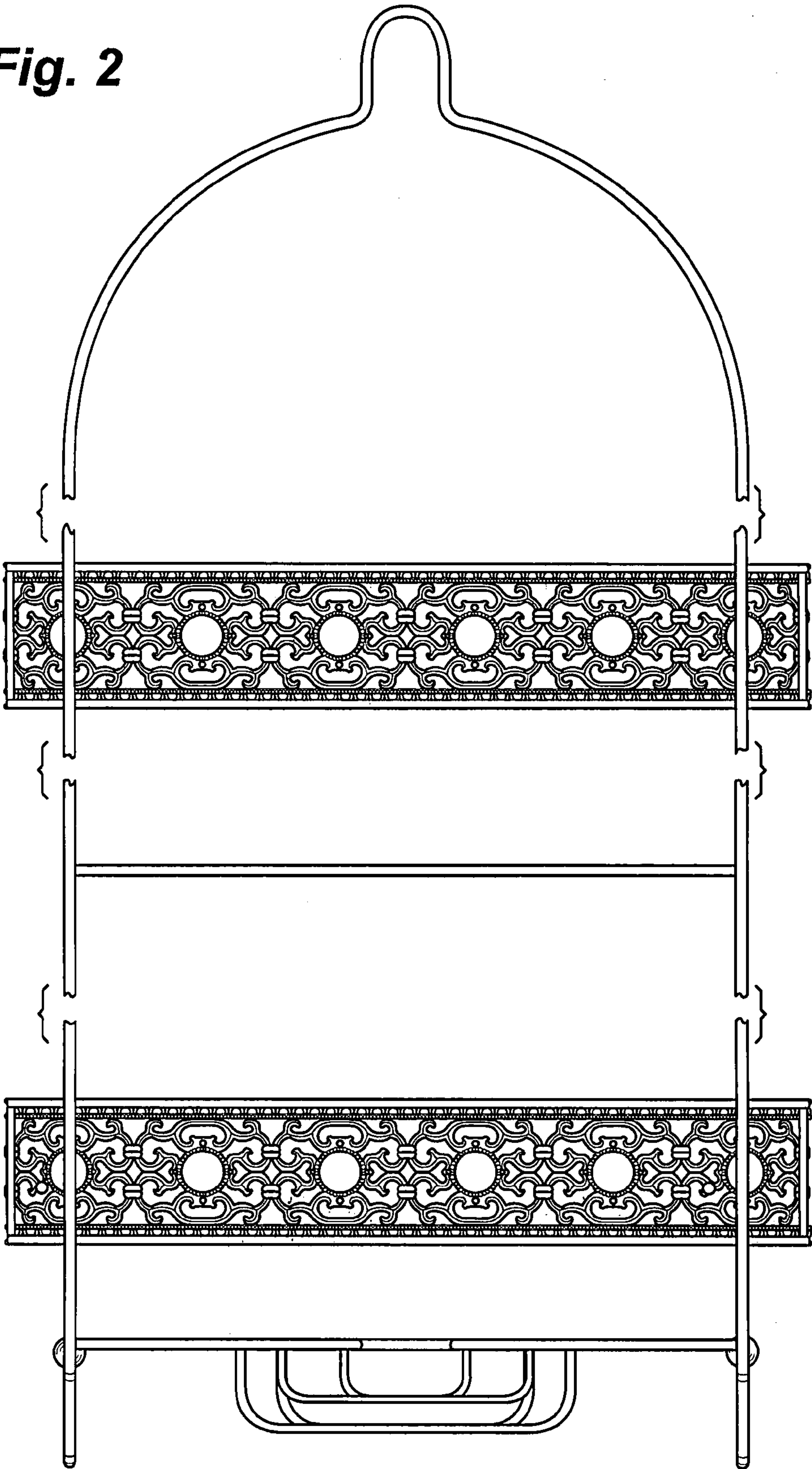

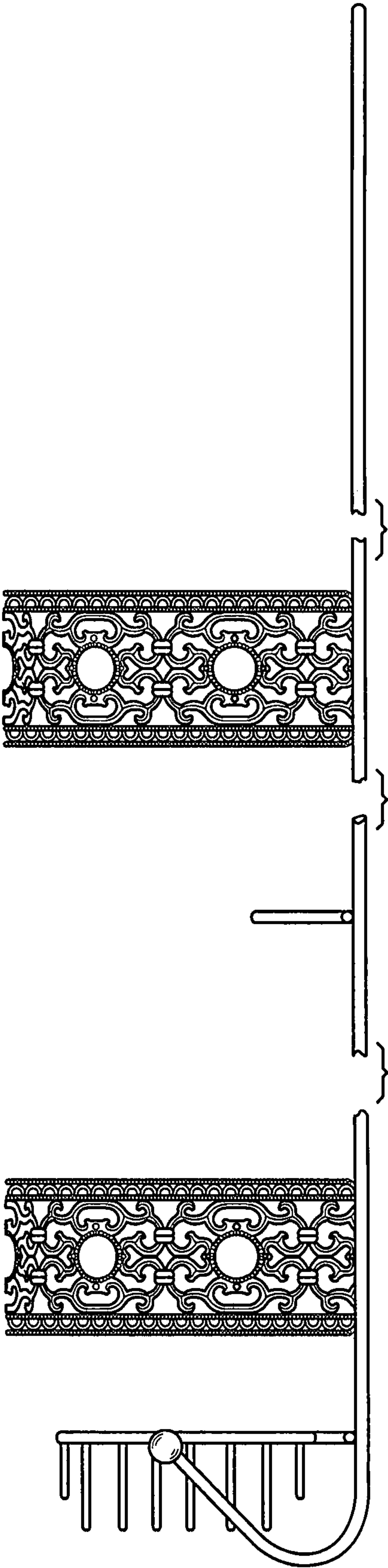




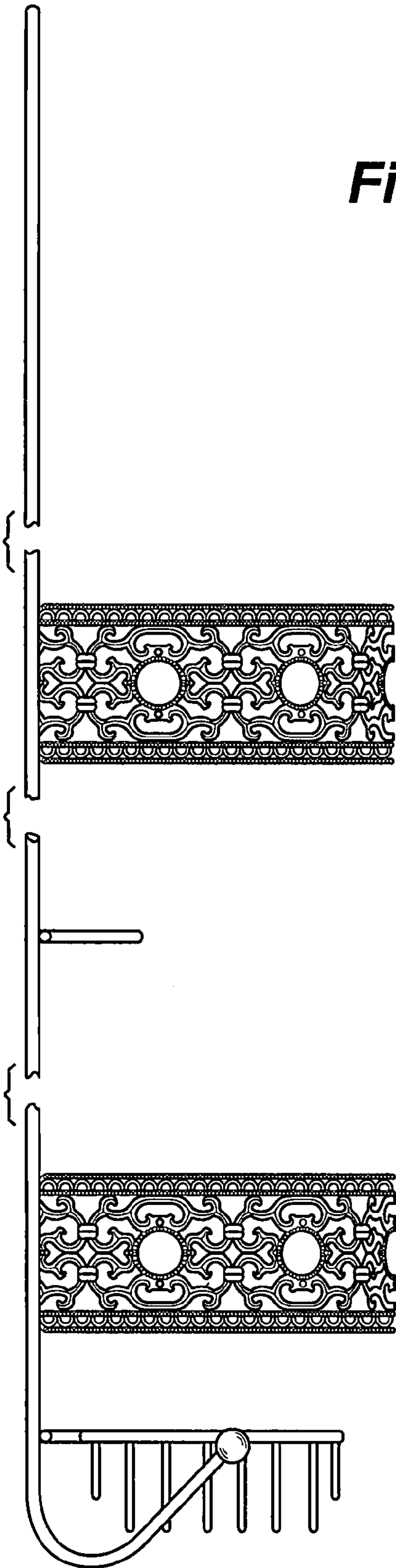

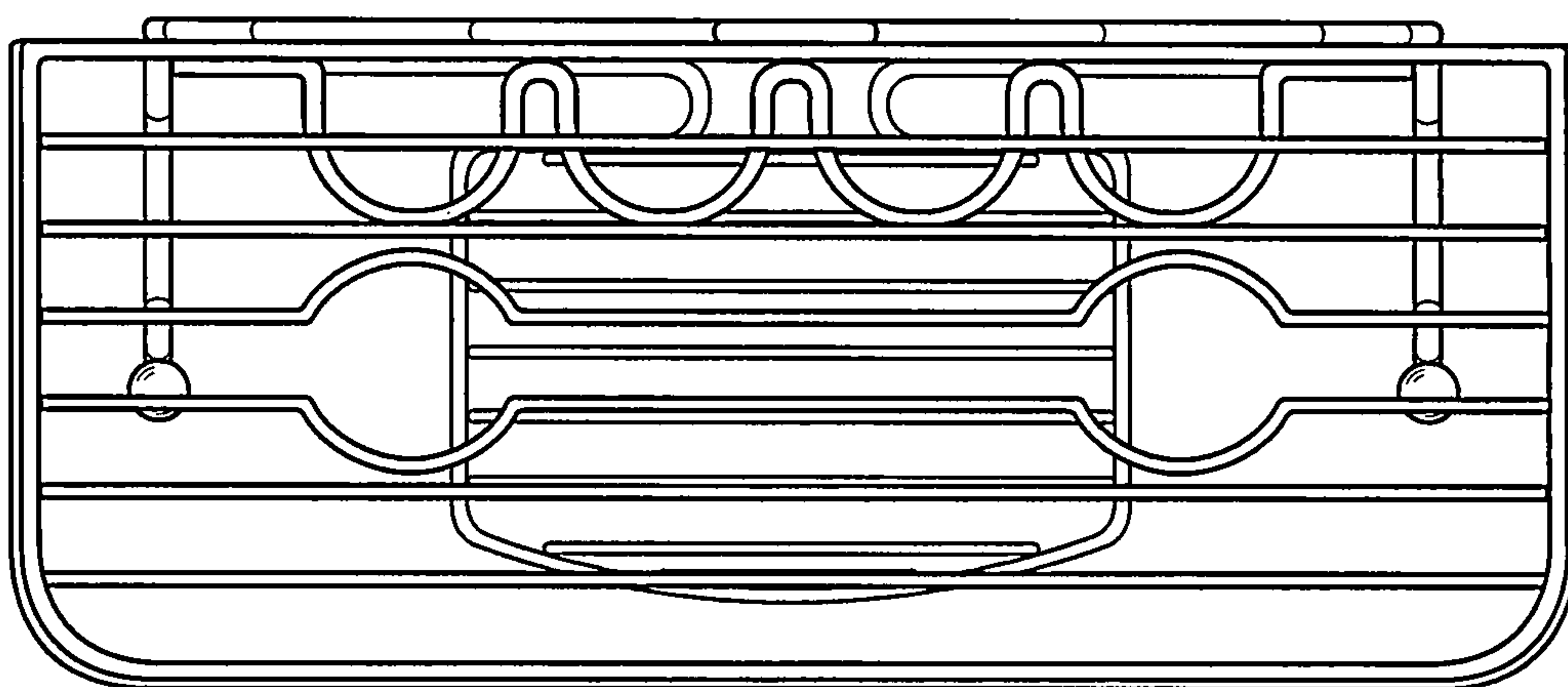

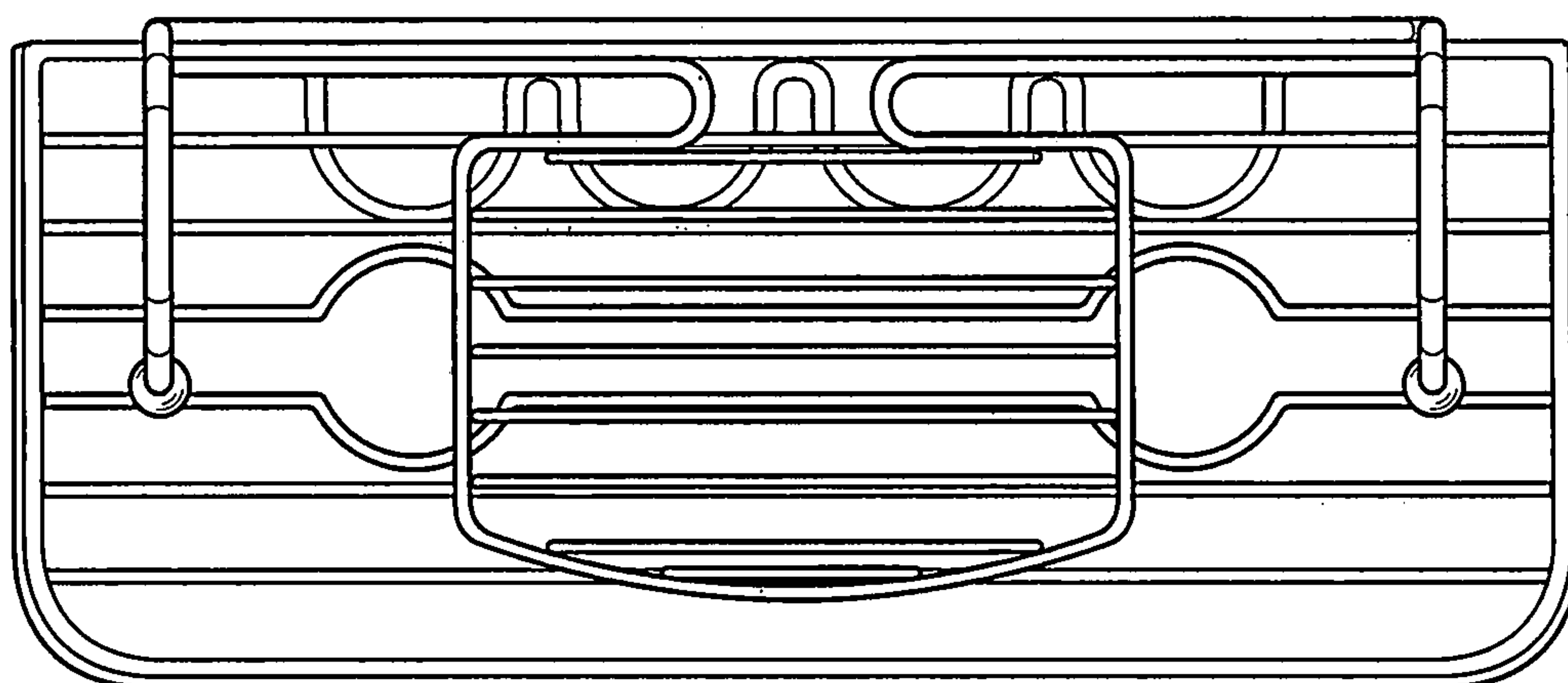
