The ornamental design for a beverage bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top right side perspective view of a beverage bottle showing my new design;

FIG. 2 is an exploded perspective view thereof in open position with pin removed;

FIG. 3 is a right side perspective view of FIG. 1;

FIG. 4 is a left side perspective view of FIG. 1;

FIG. 5 is a front perspective view of FIG. 1;

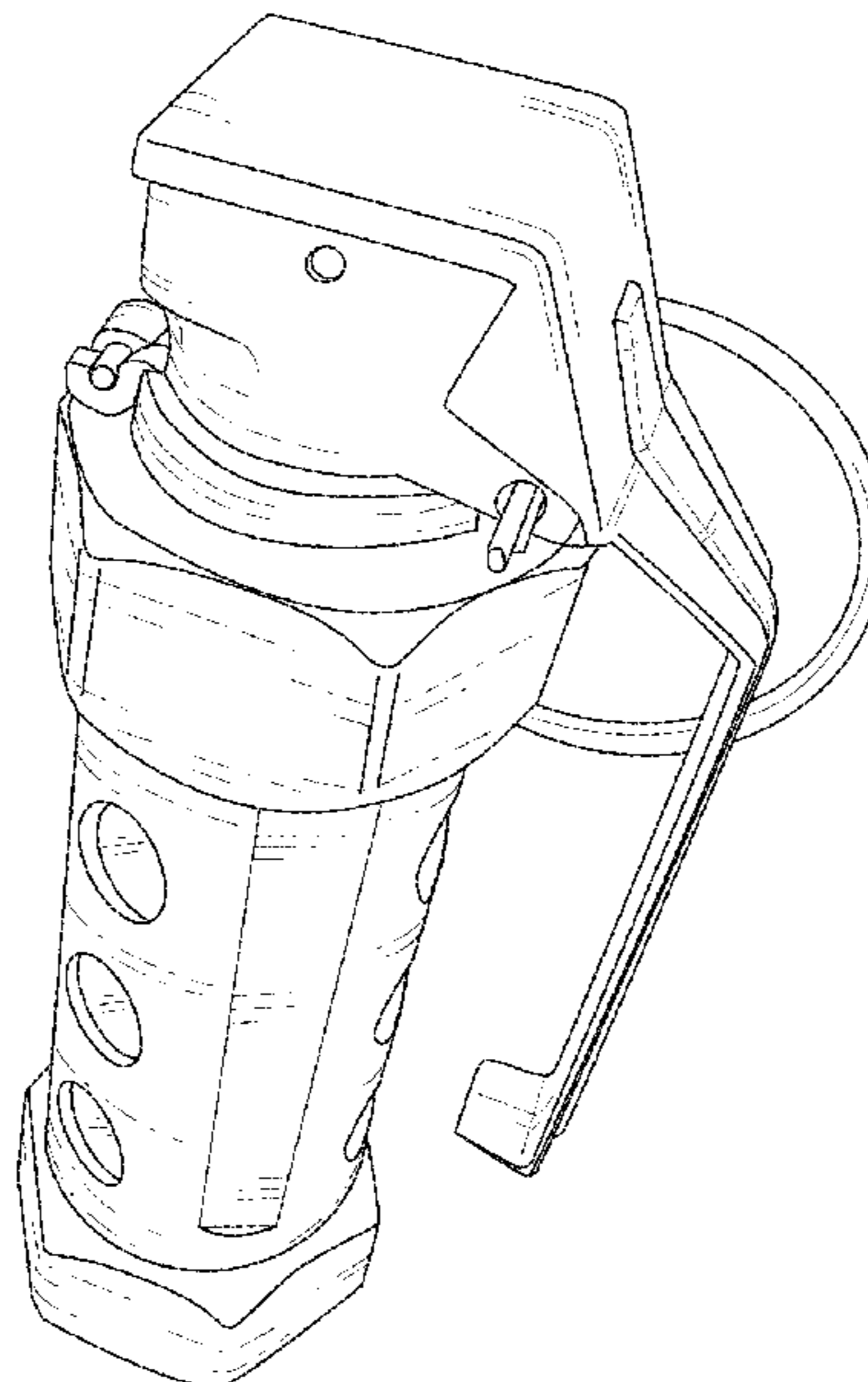
FIG. 6 is a rear perspective view of FIG. 1;

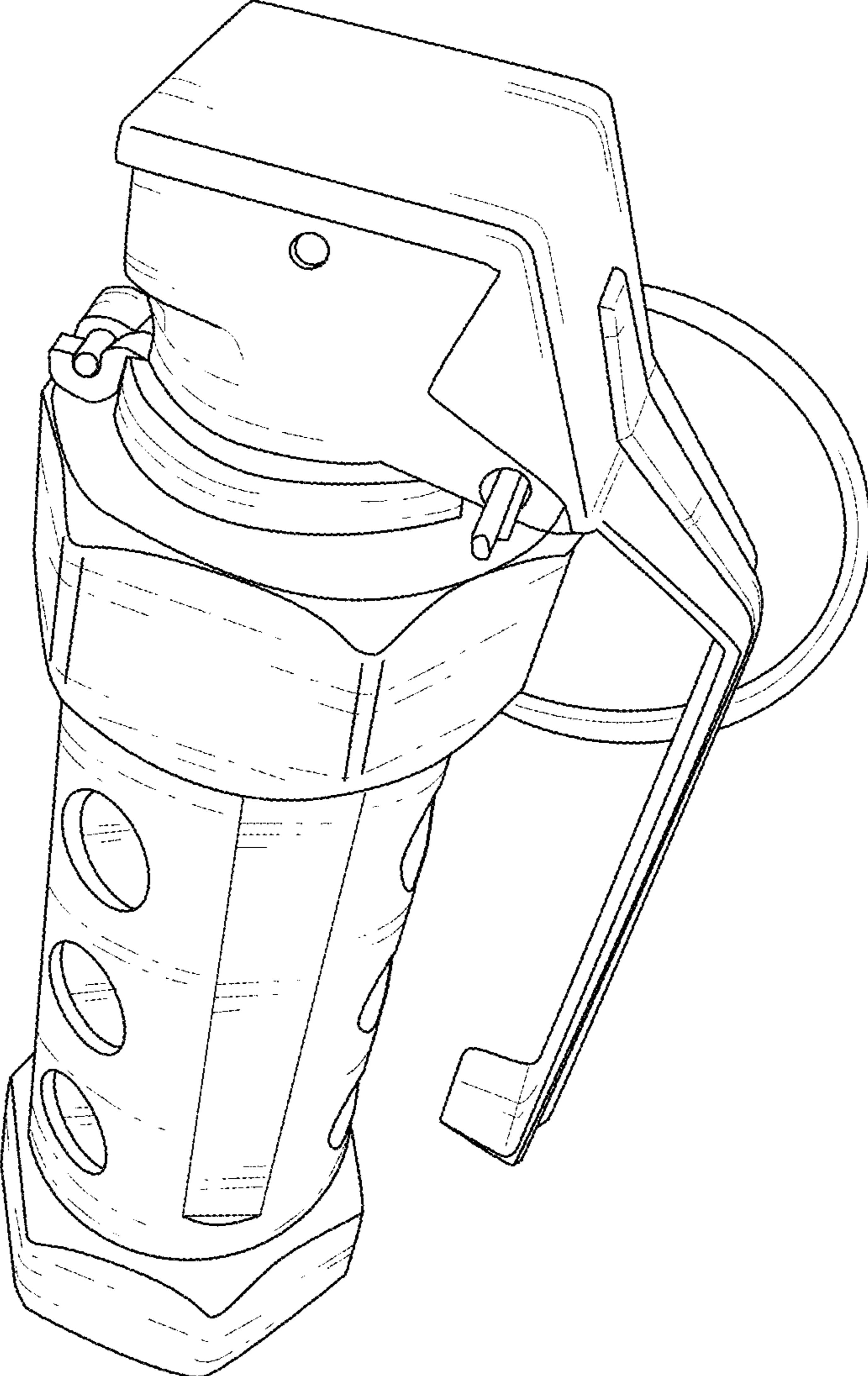

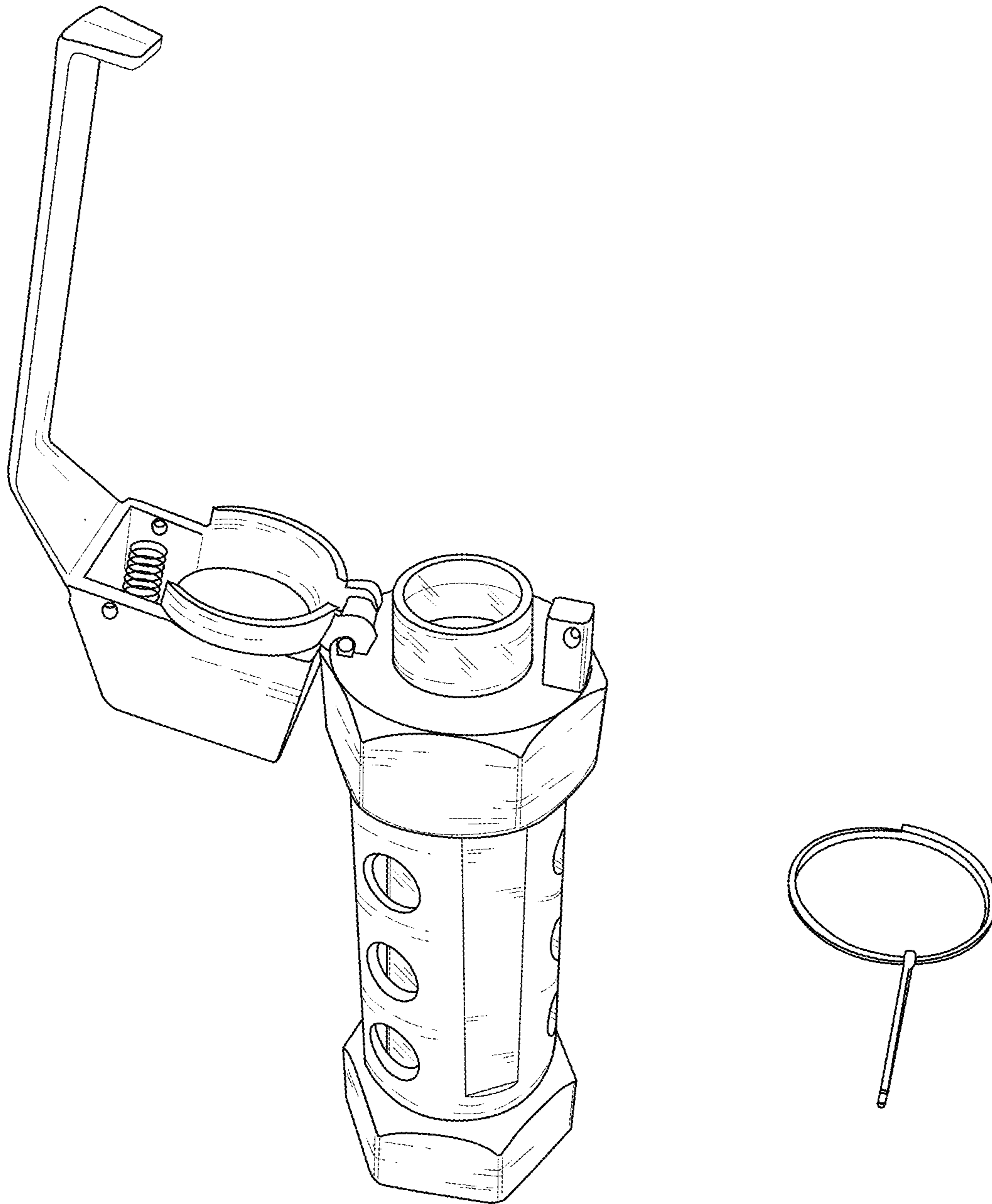

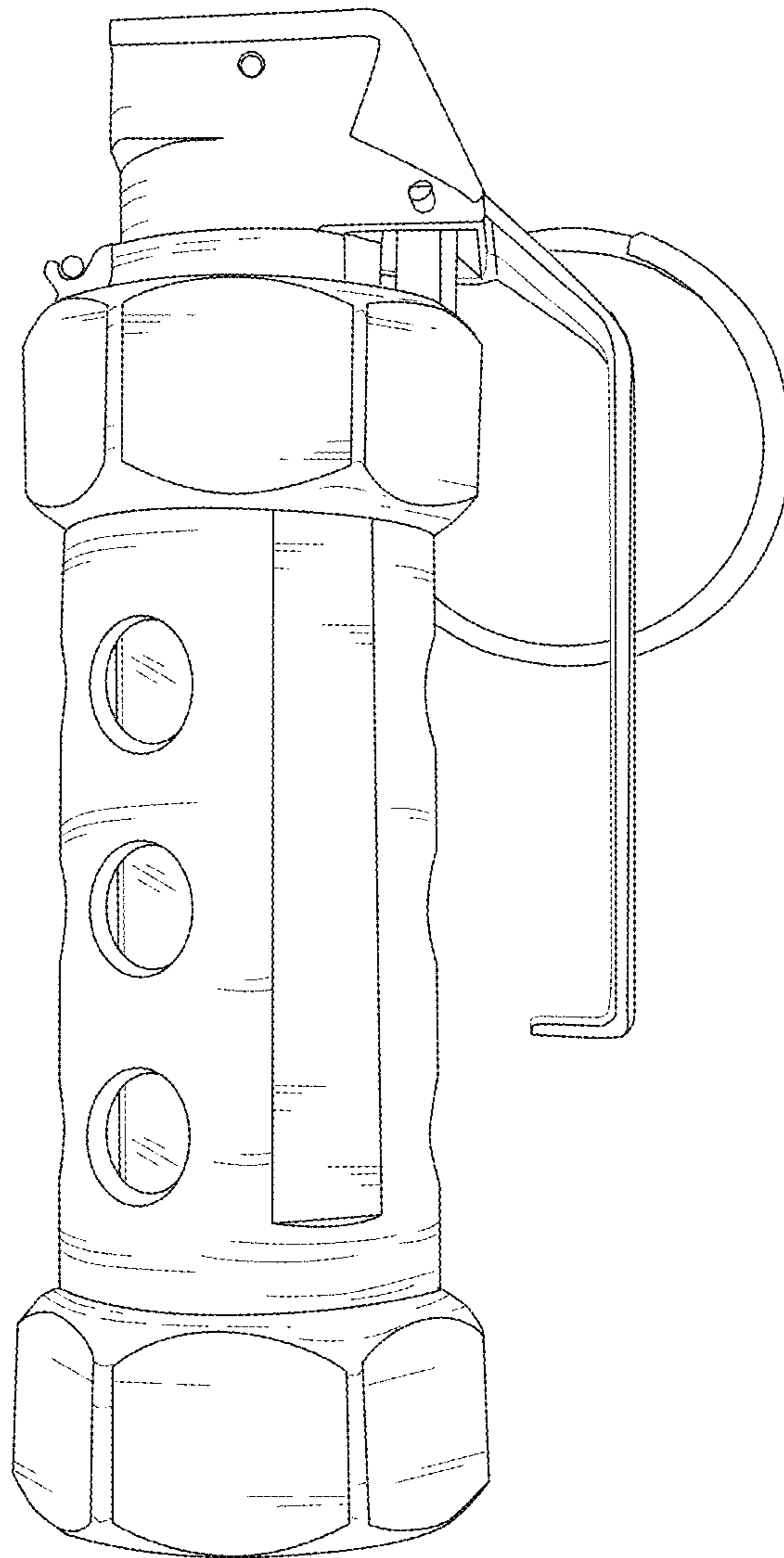

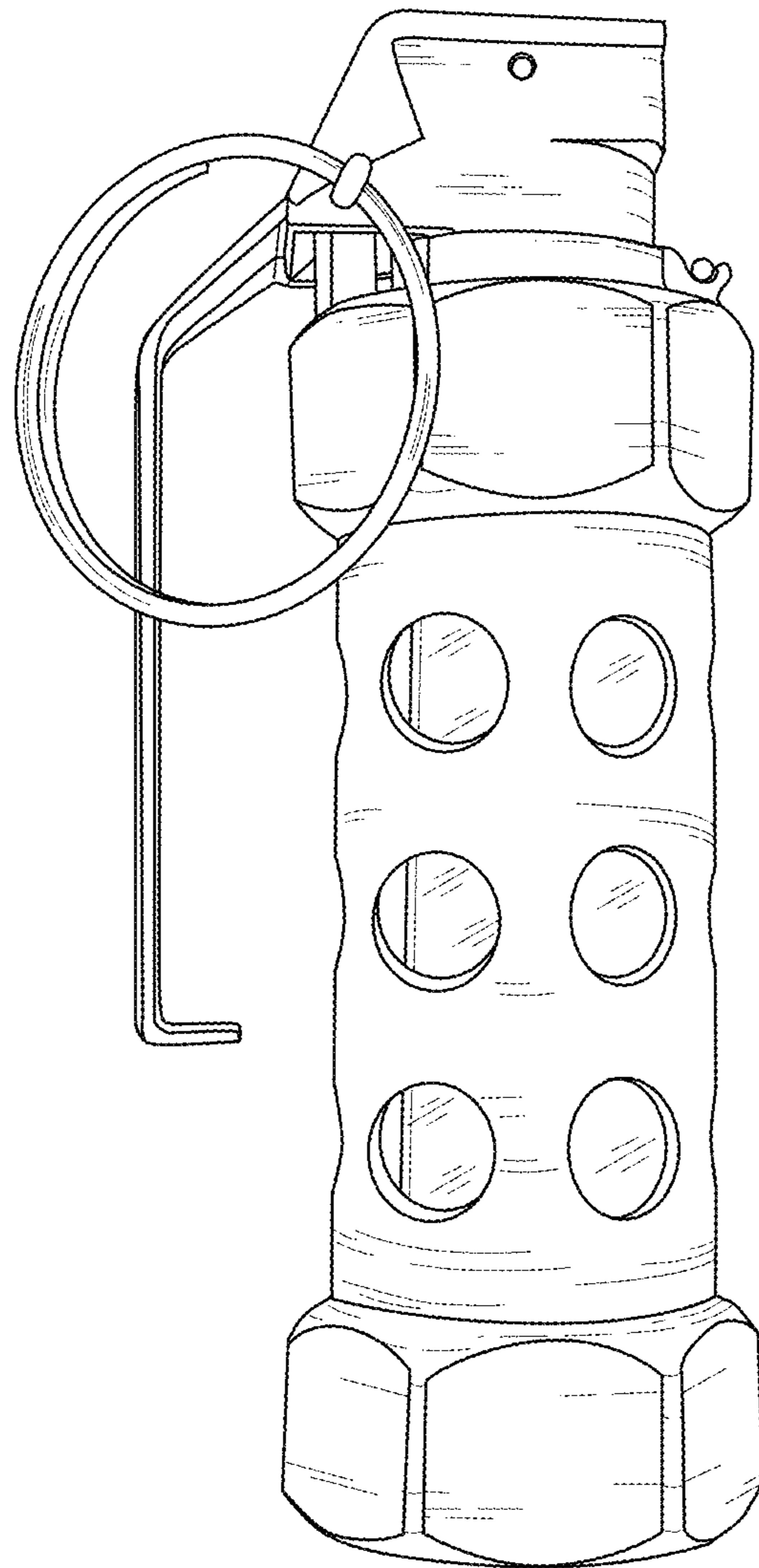

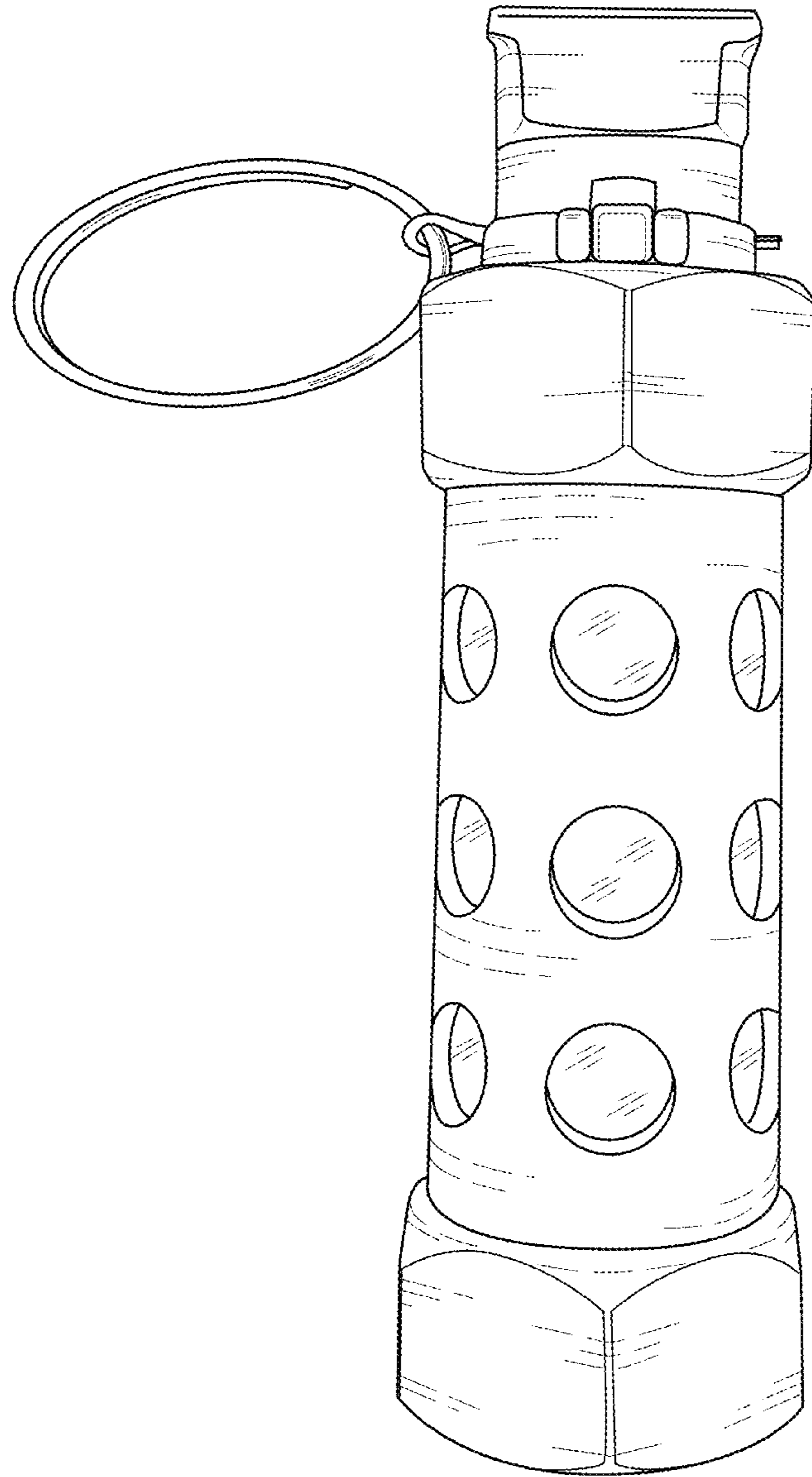

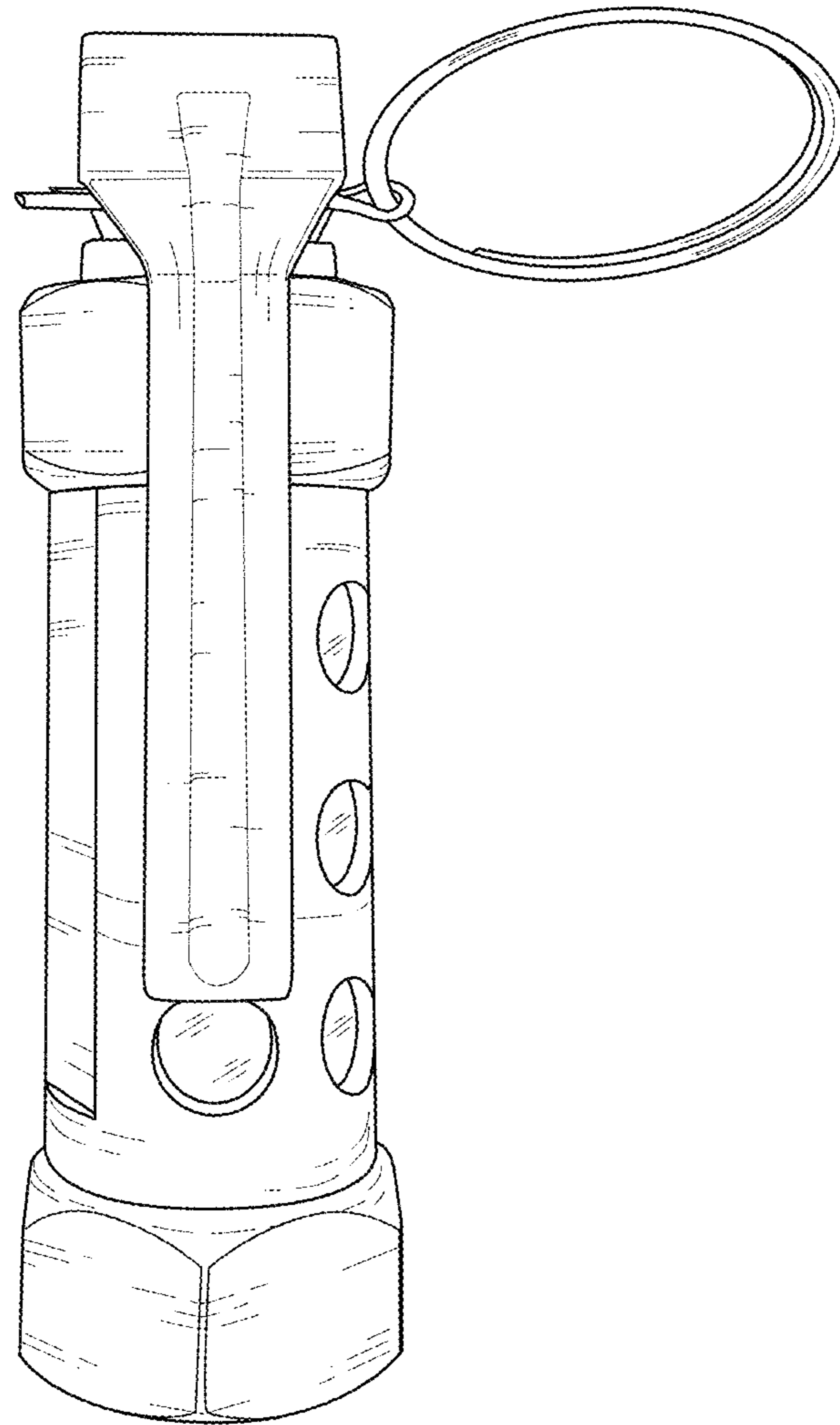

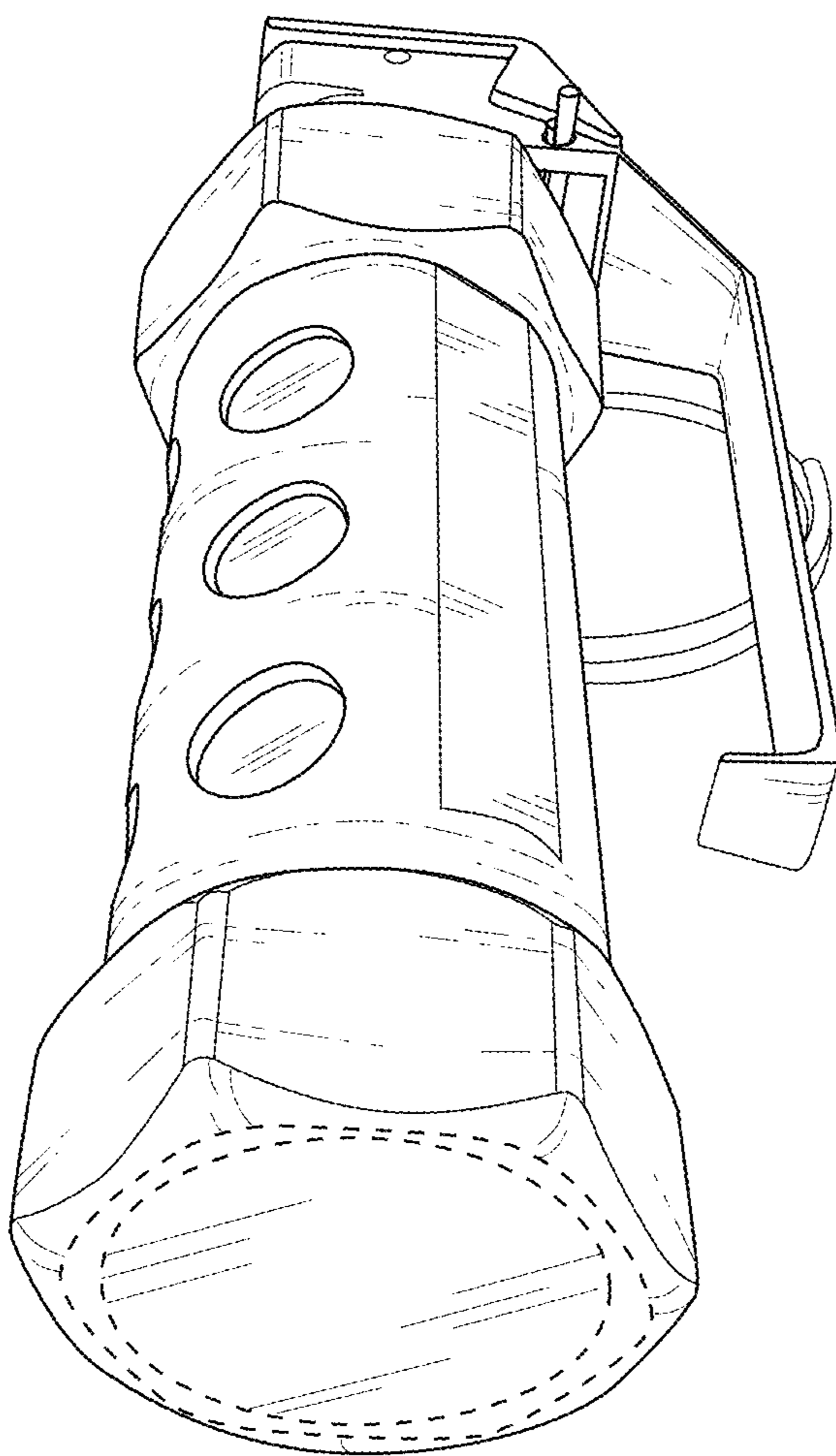

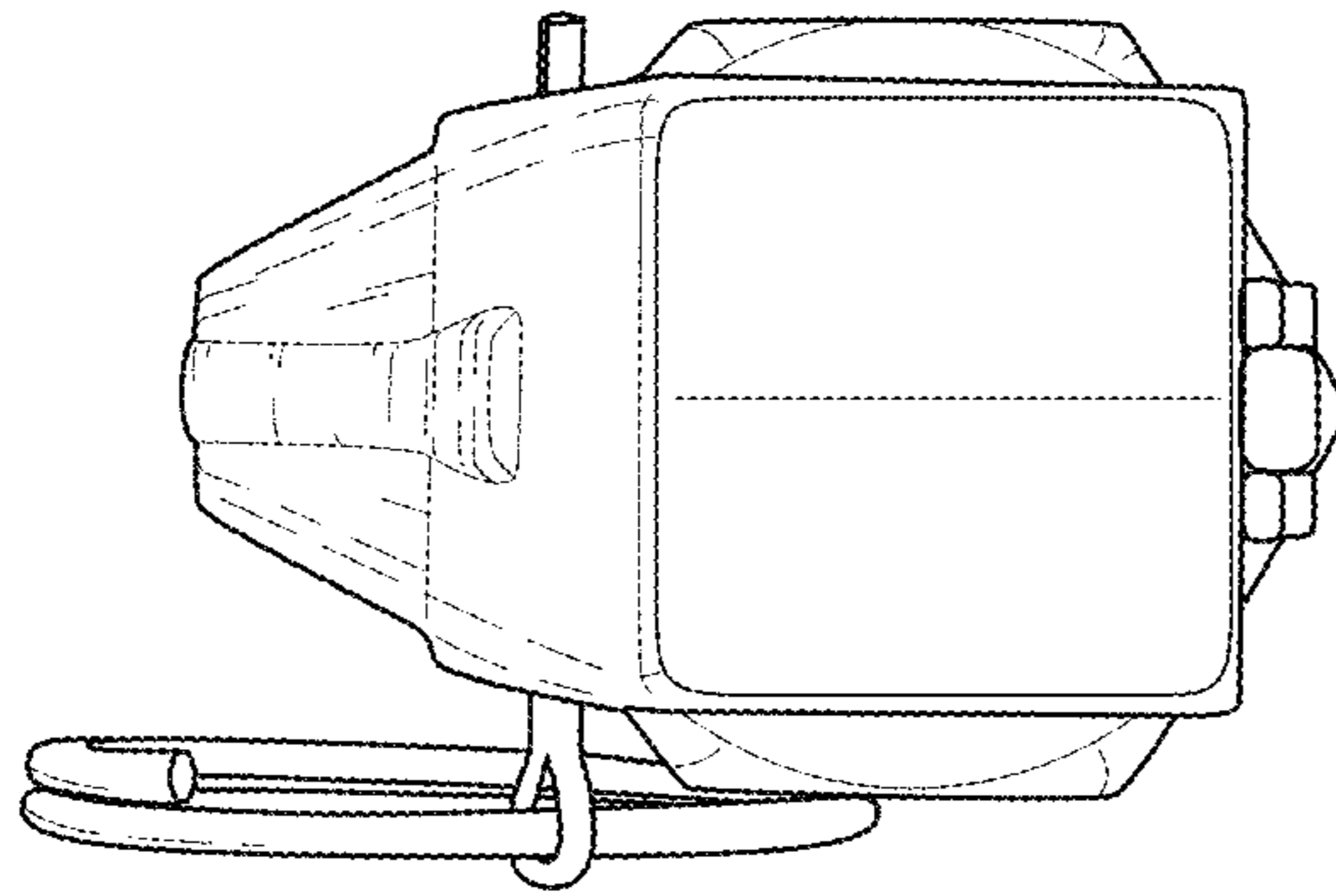
