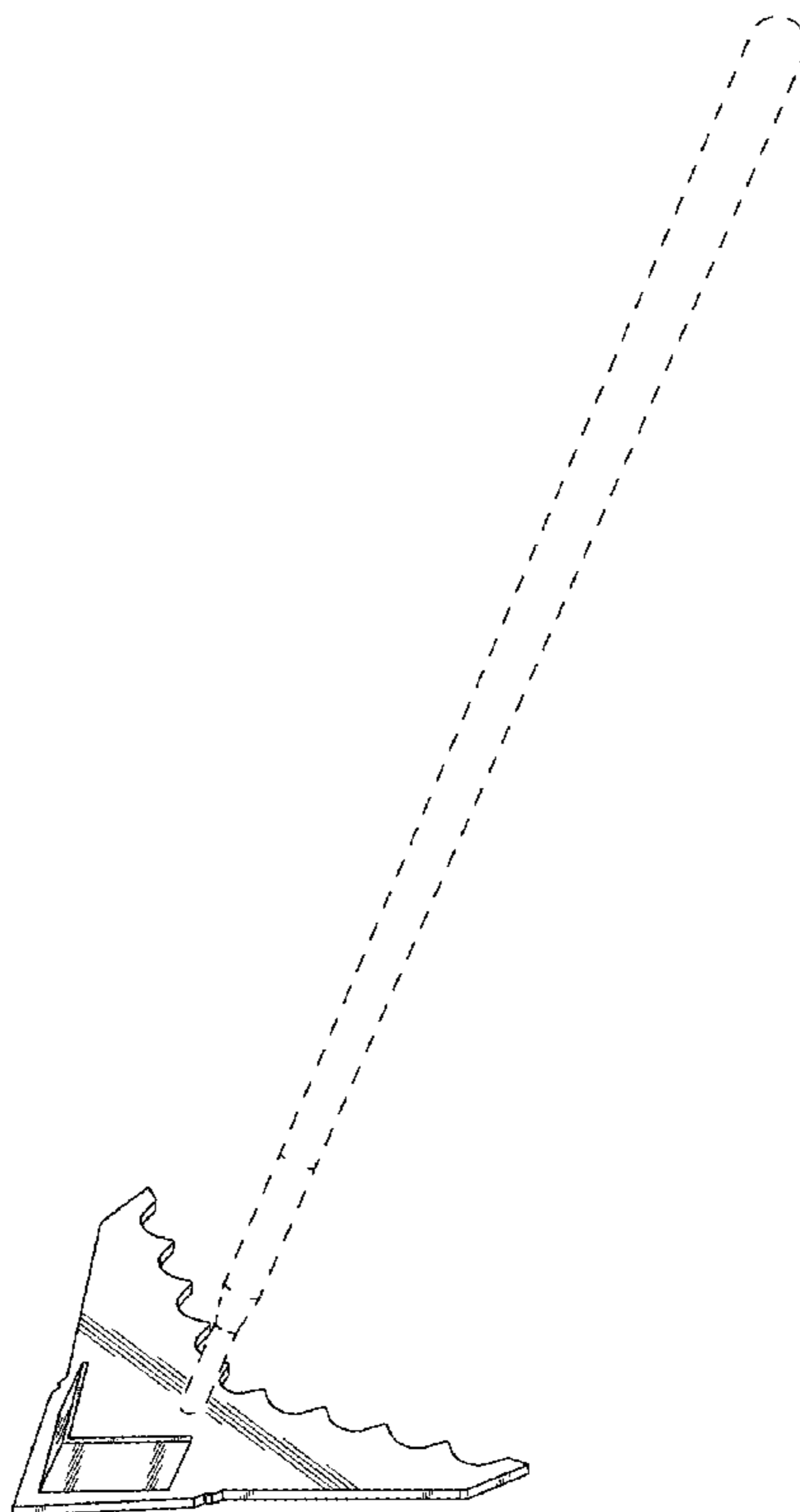
(57) **CLAIM**  
The ornamental design for a multi-faceted hoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a multi-faceted hoe, showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left view thereof, with a right view being a mirror image;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.  
The broken line showing of an elongated pole and receiver in the figures is for the purpose of illustrating environmental structure and forms no part of the claimed design.

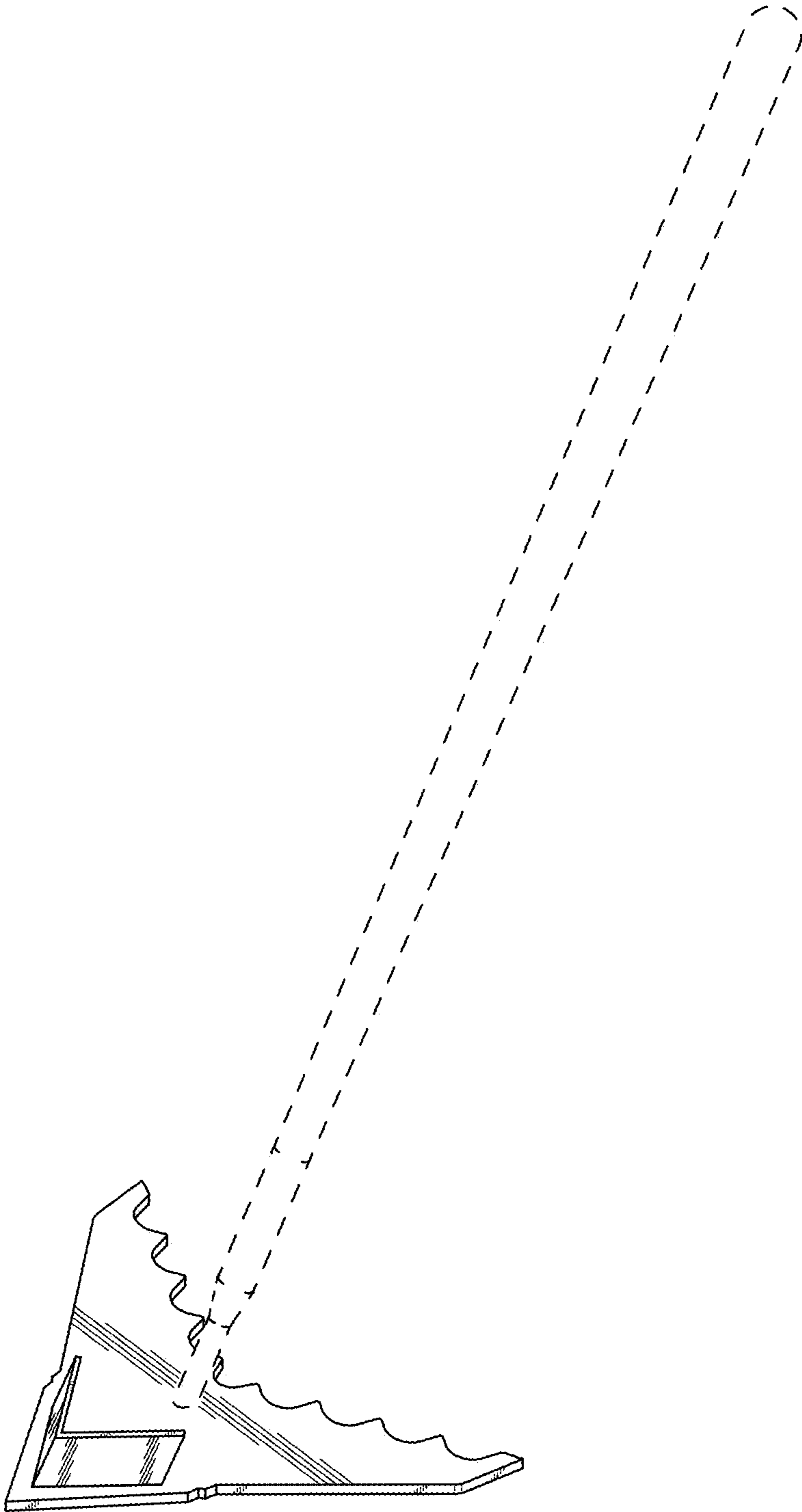

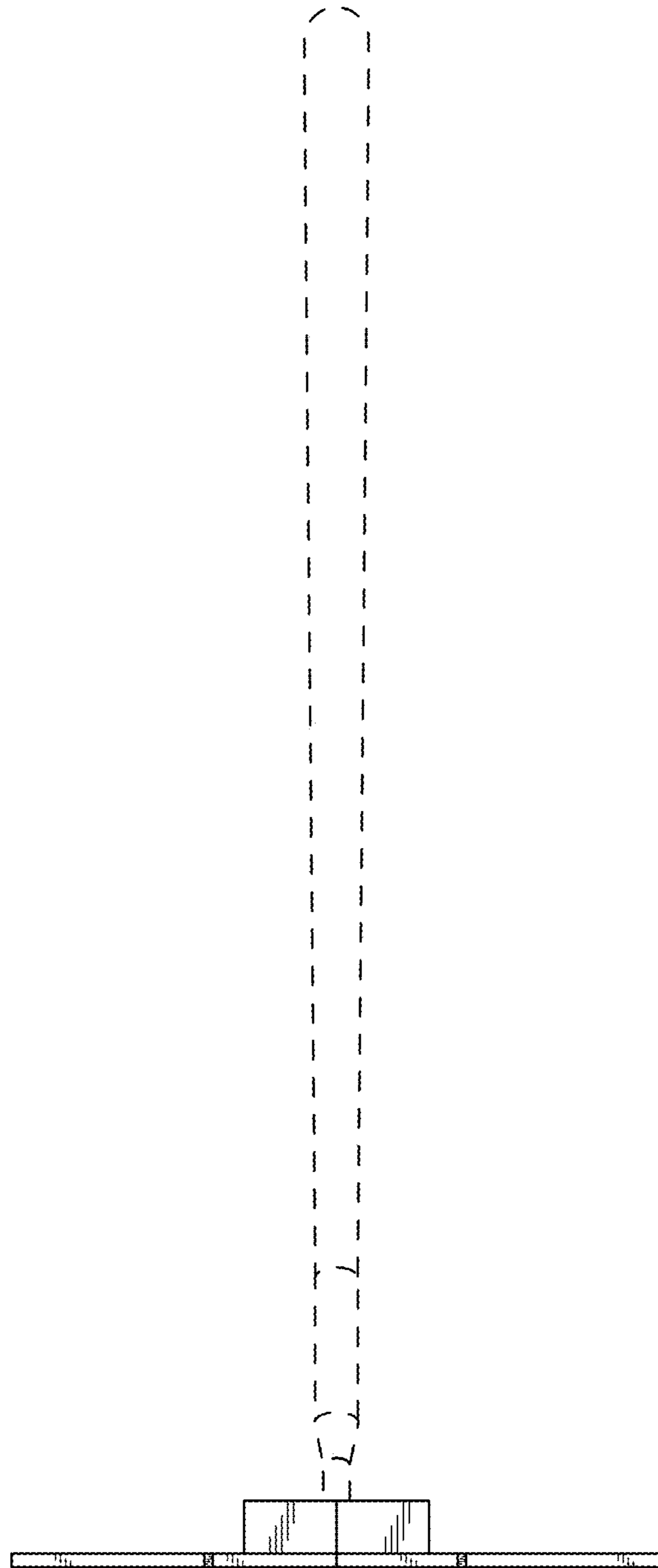

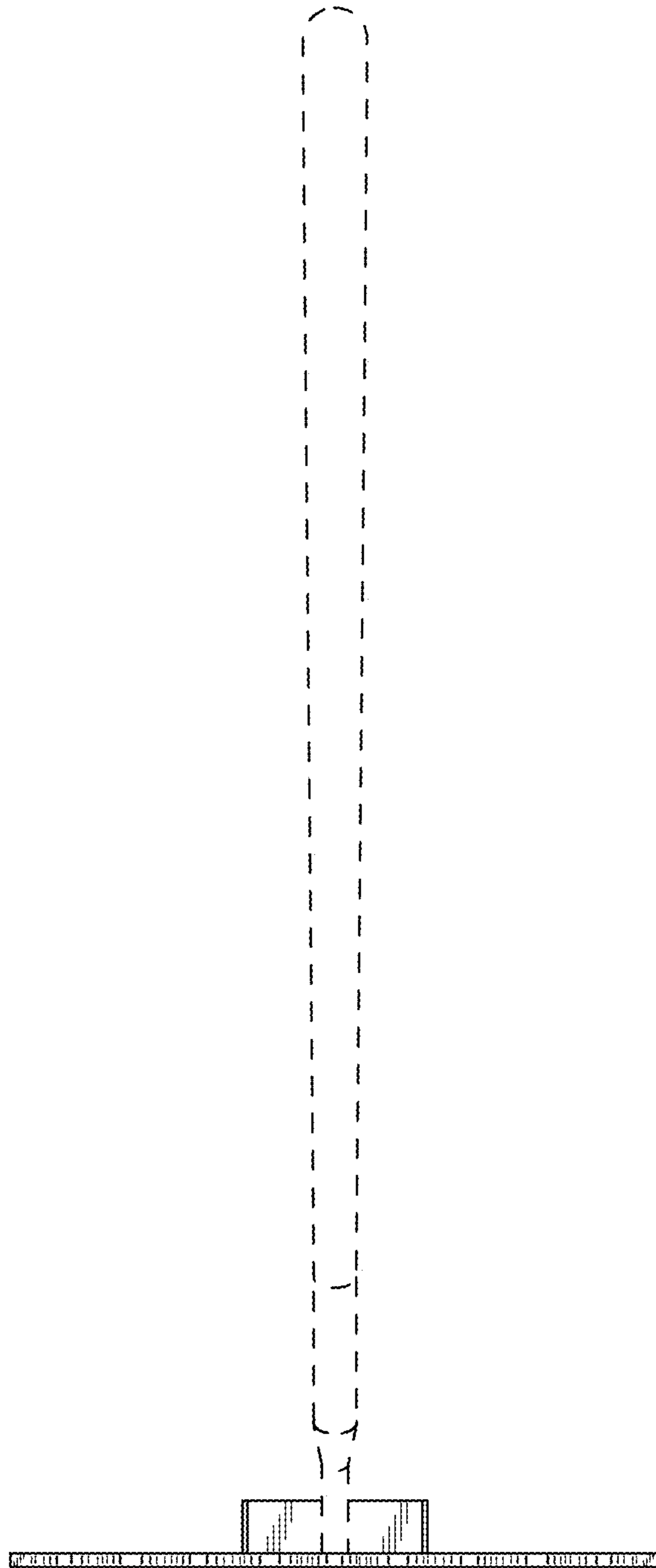

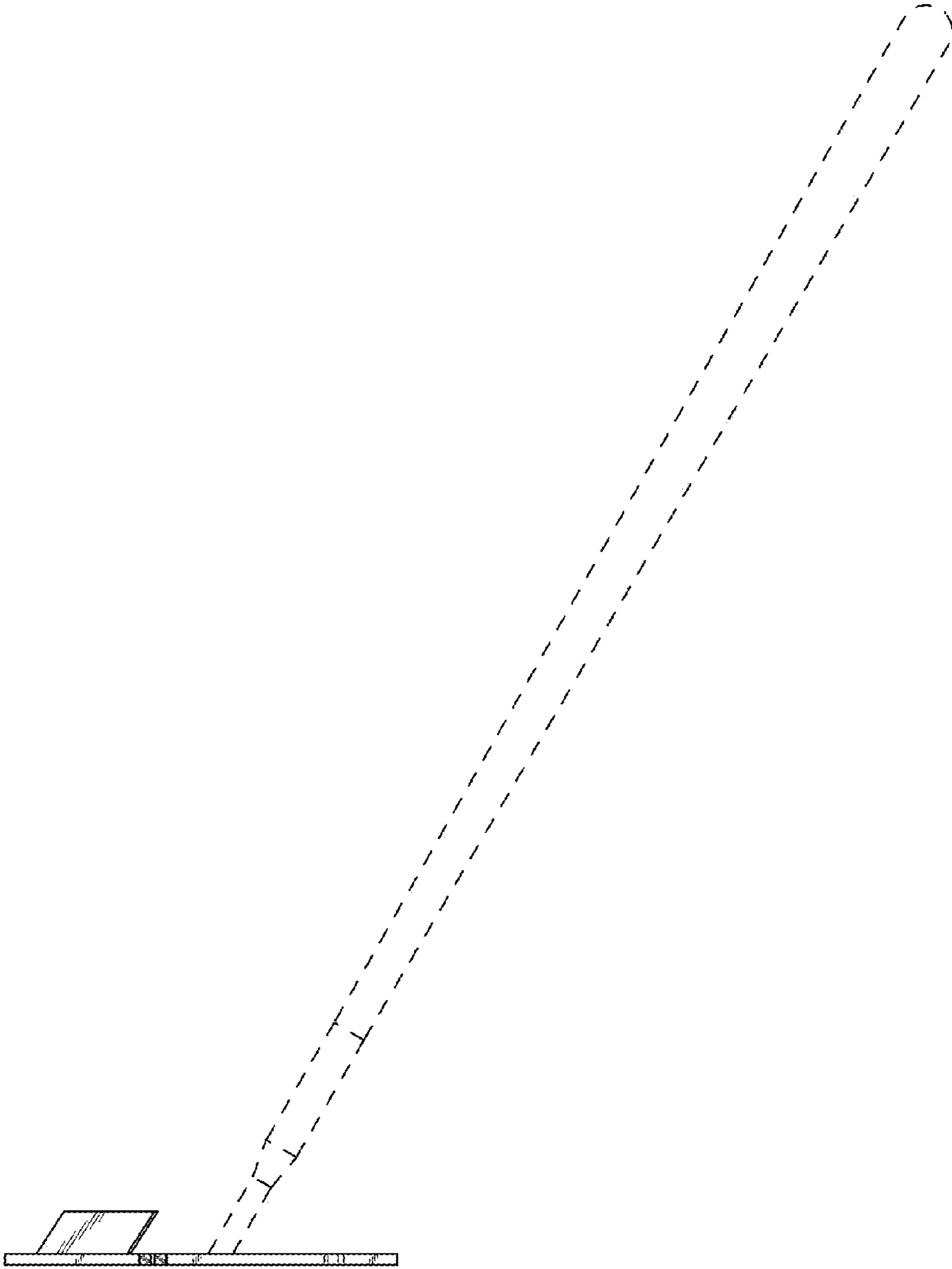

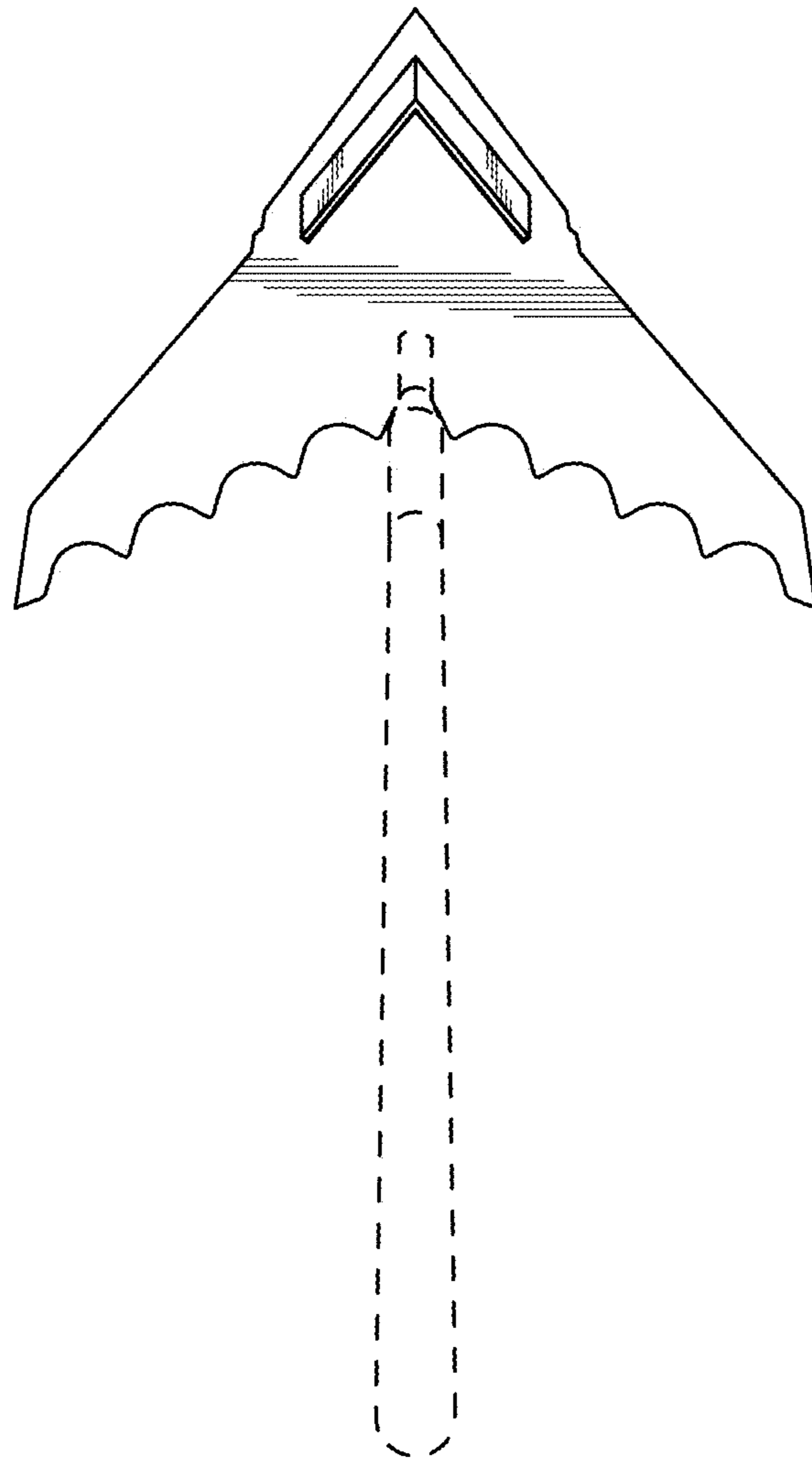

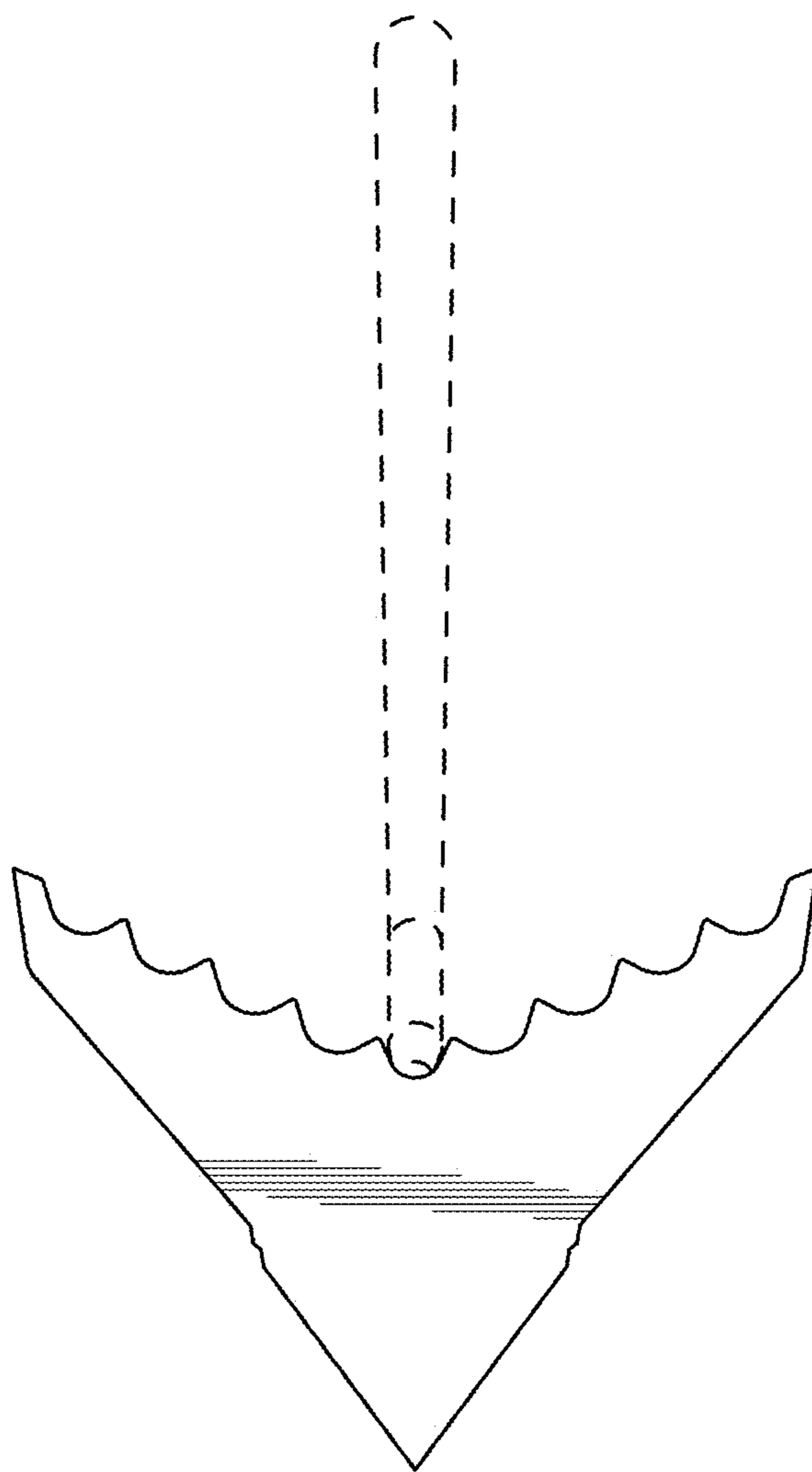
