FIG. 5 is a right side view of the bottle with a cap shown in FIG. 1;

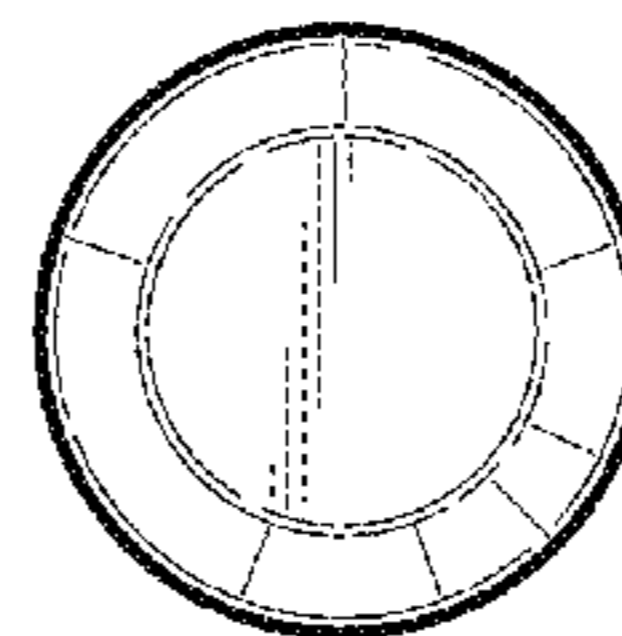
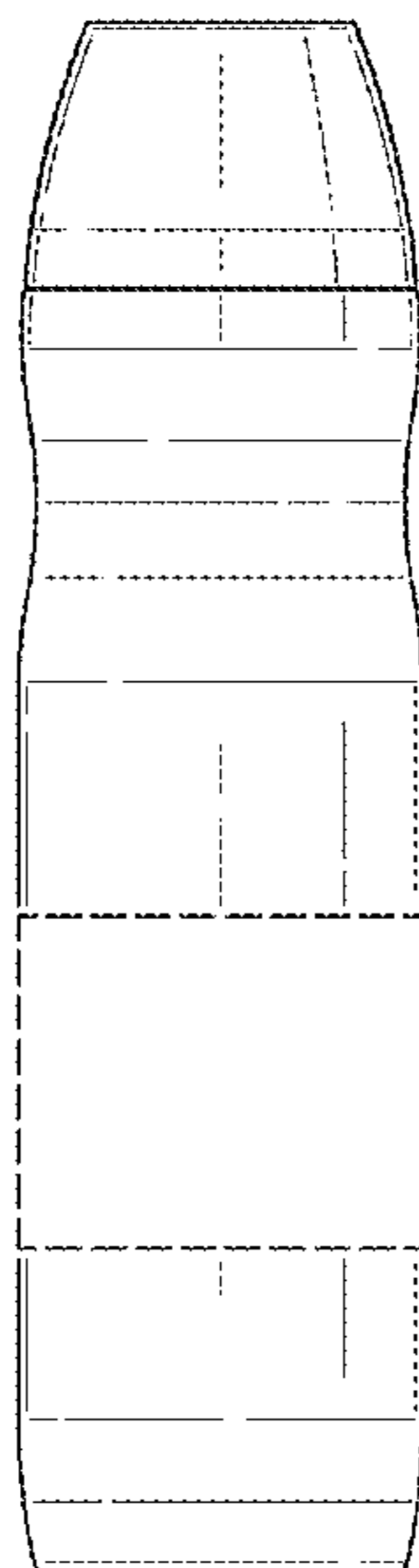
FIG. 6 is a top view of the bottle with a cap shown in FIG. 1;

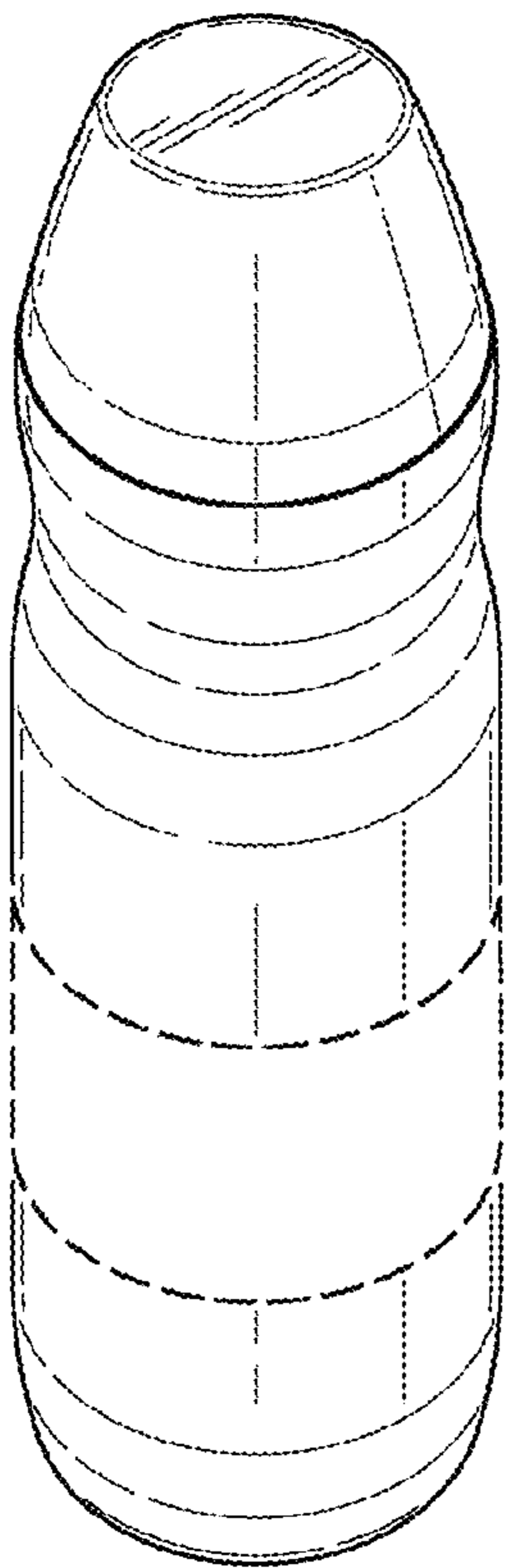

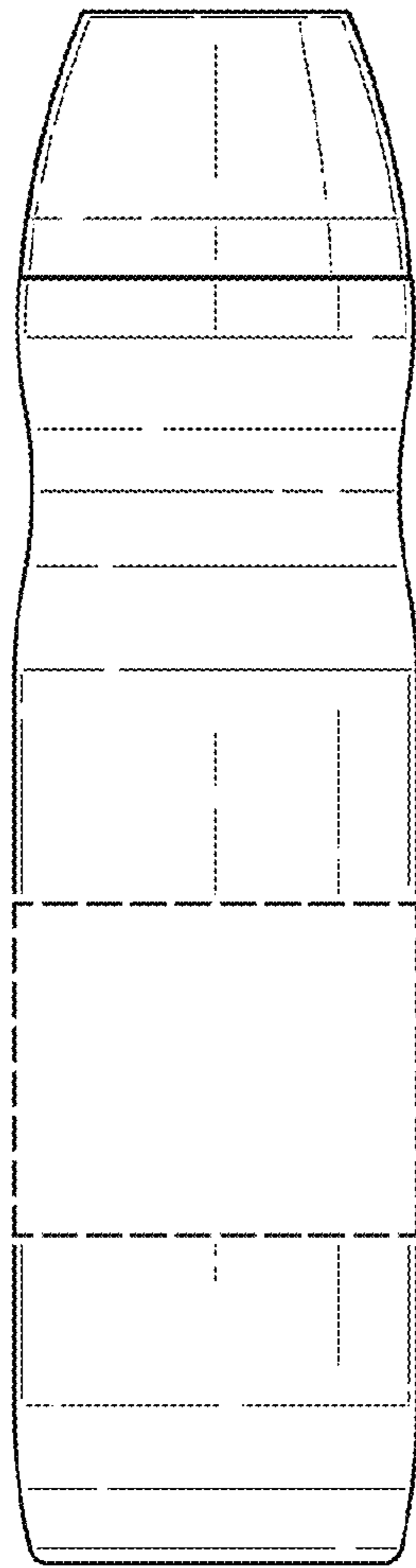

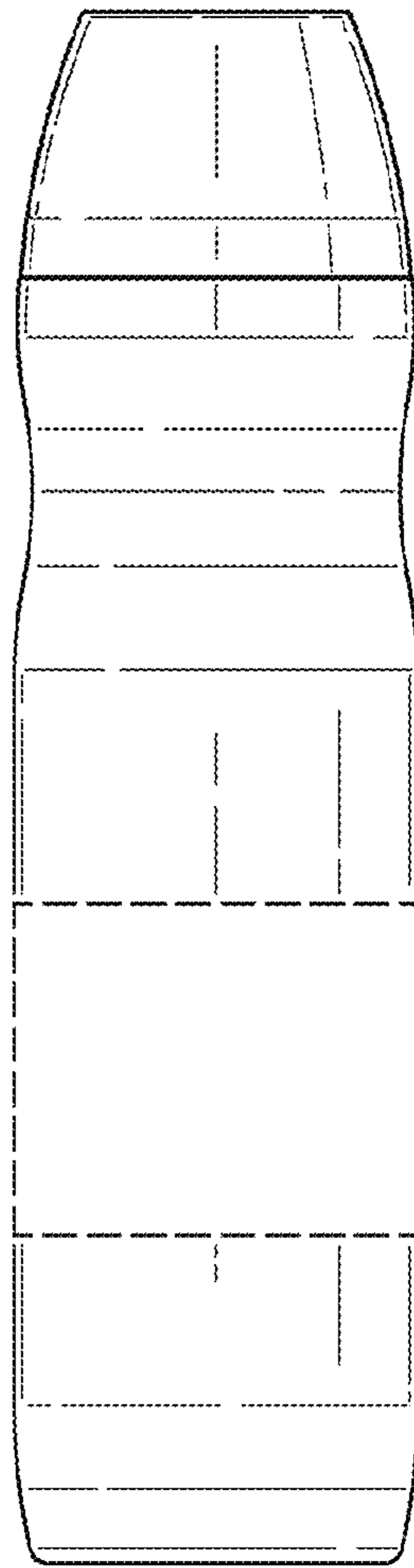

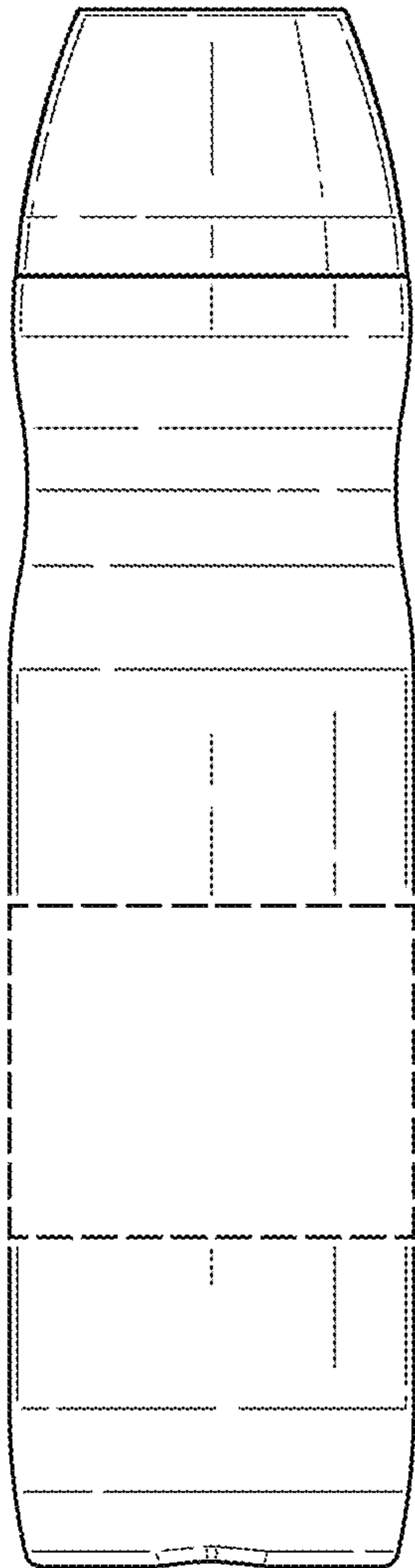

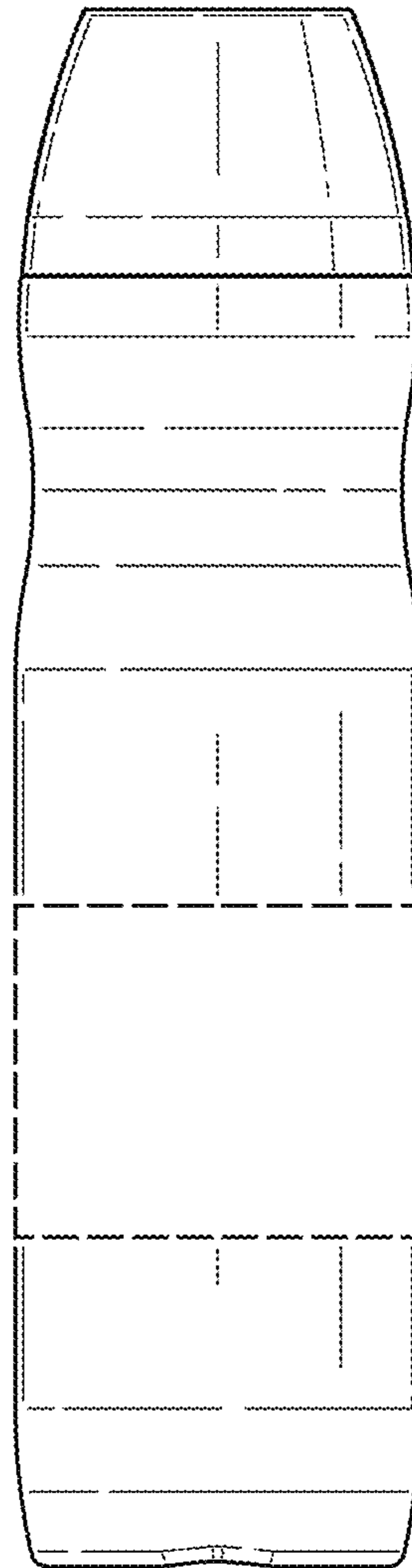

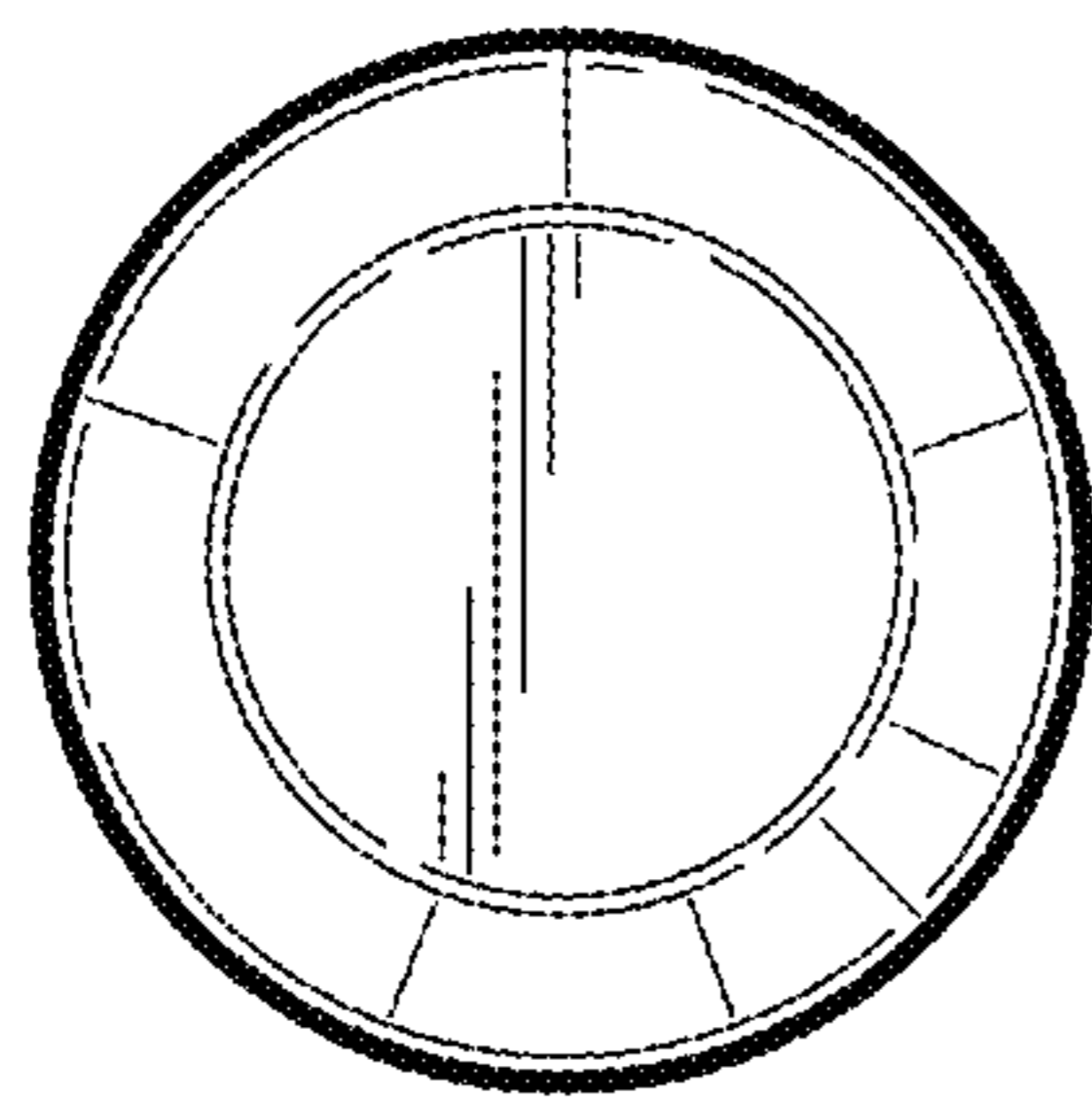

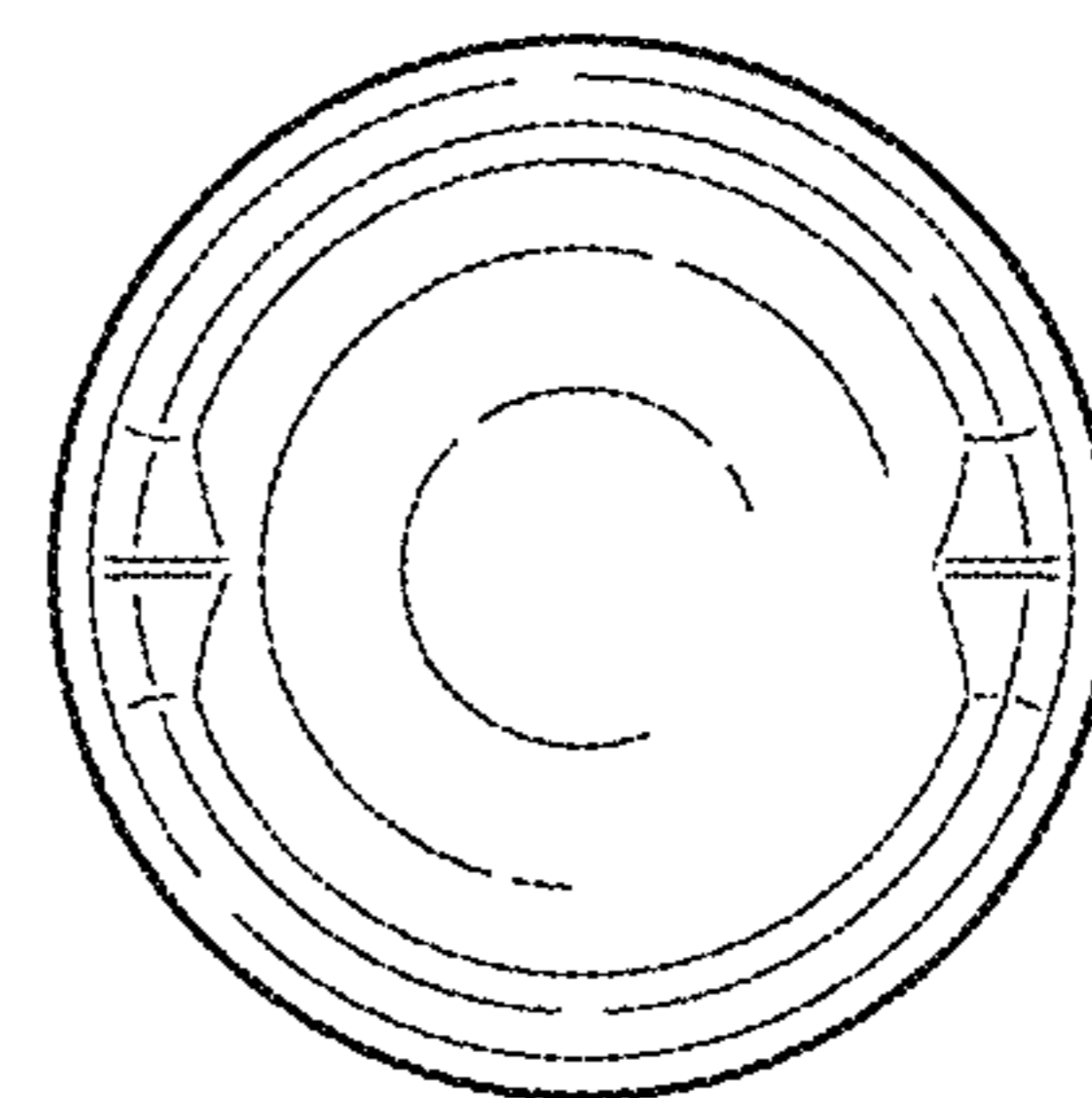
