DESCRIPTION

FIG. 1 is a perspective view of a television receiver, showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a rear perspective view thereof; and,
FIG. 9 is another left-side view thereof, in which a display part of the television receiver rotates to a first position to illustrate an alternate position.

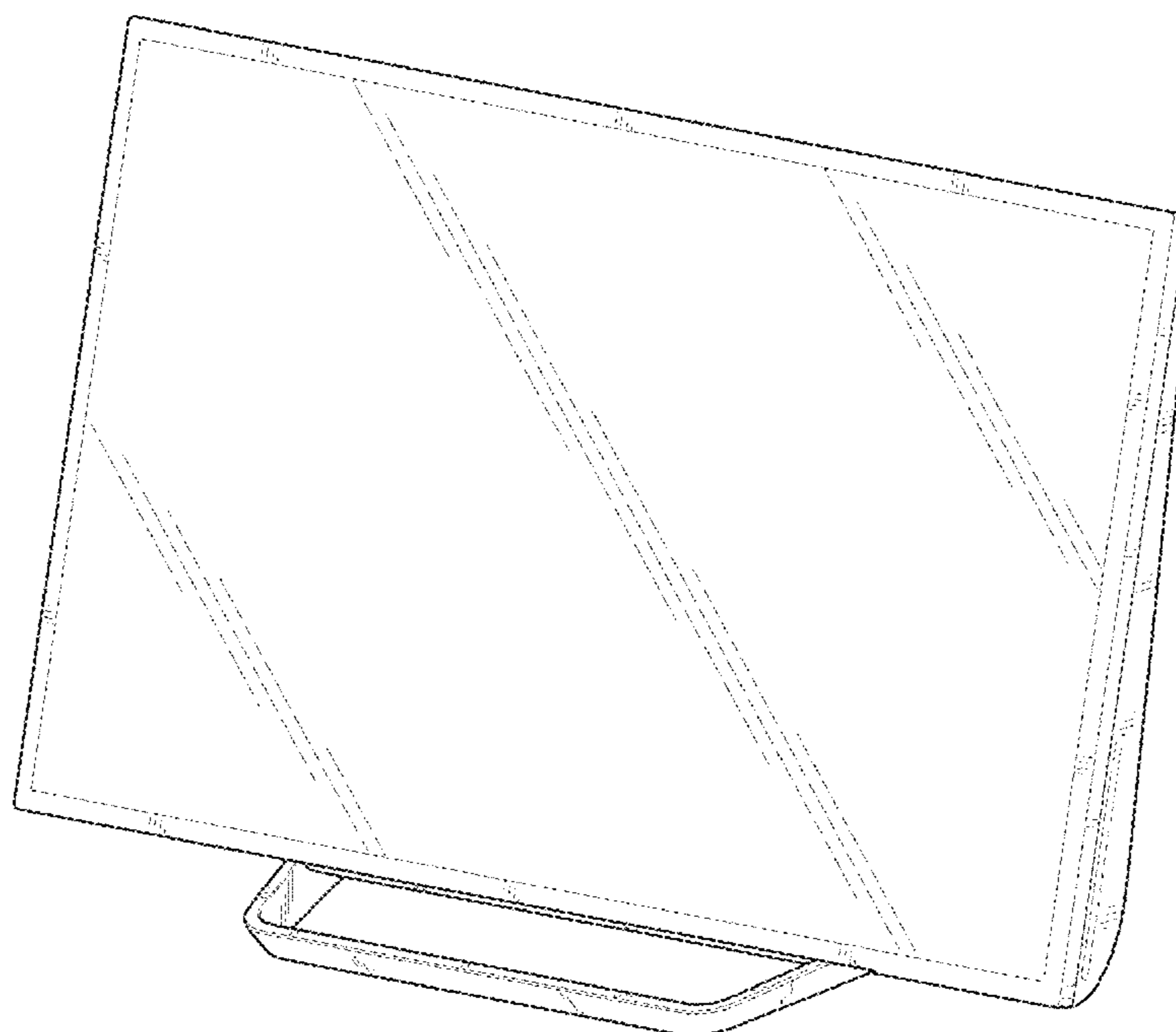

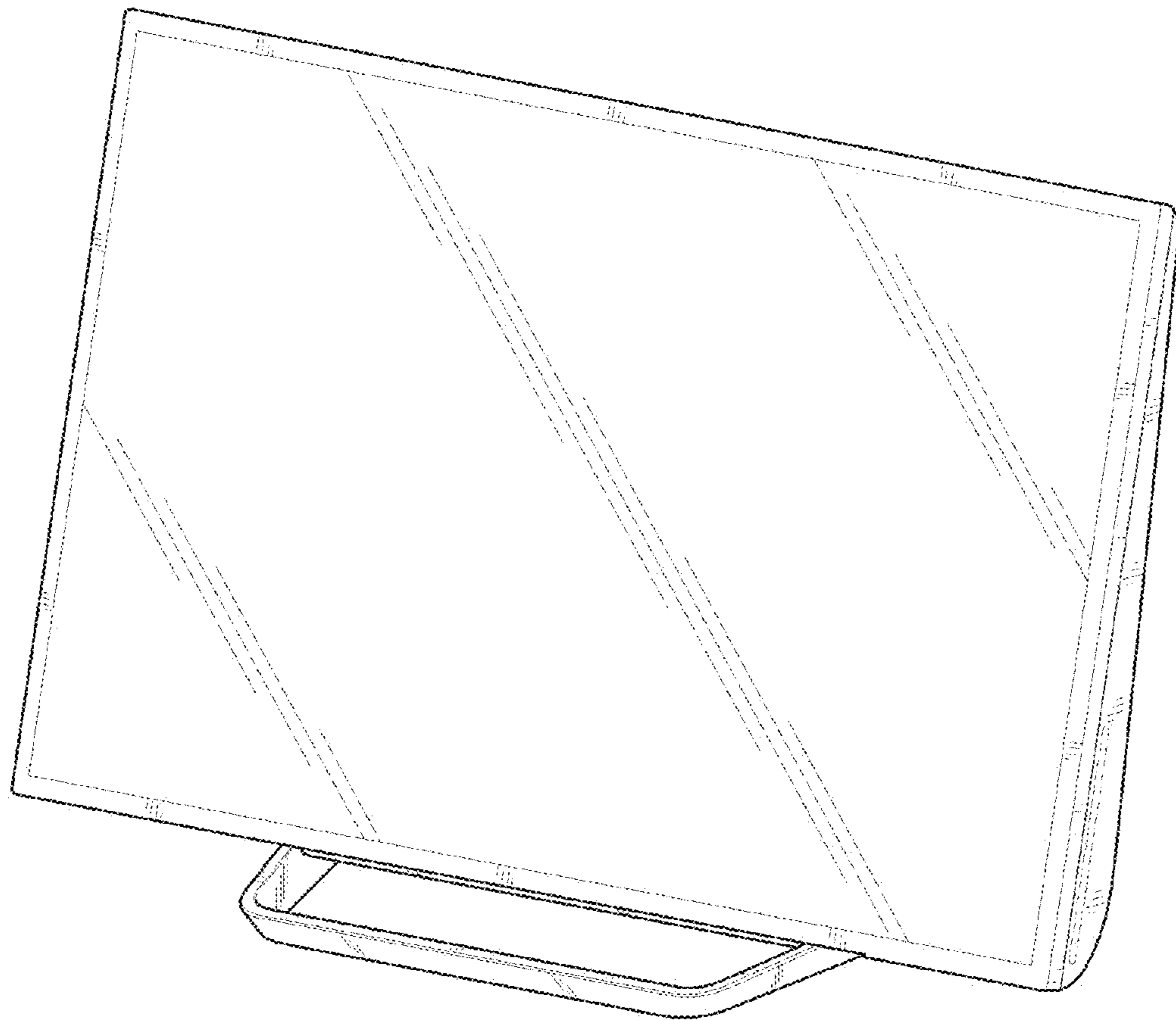

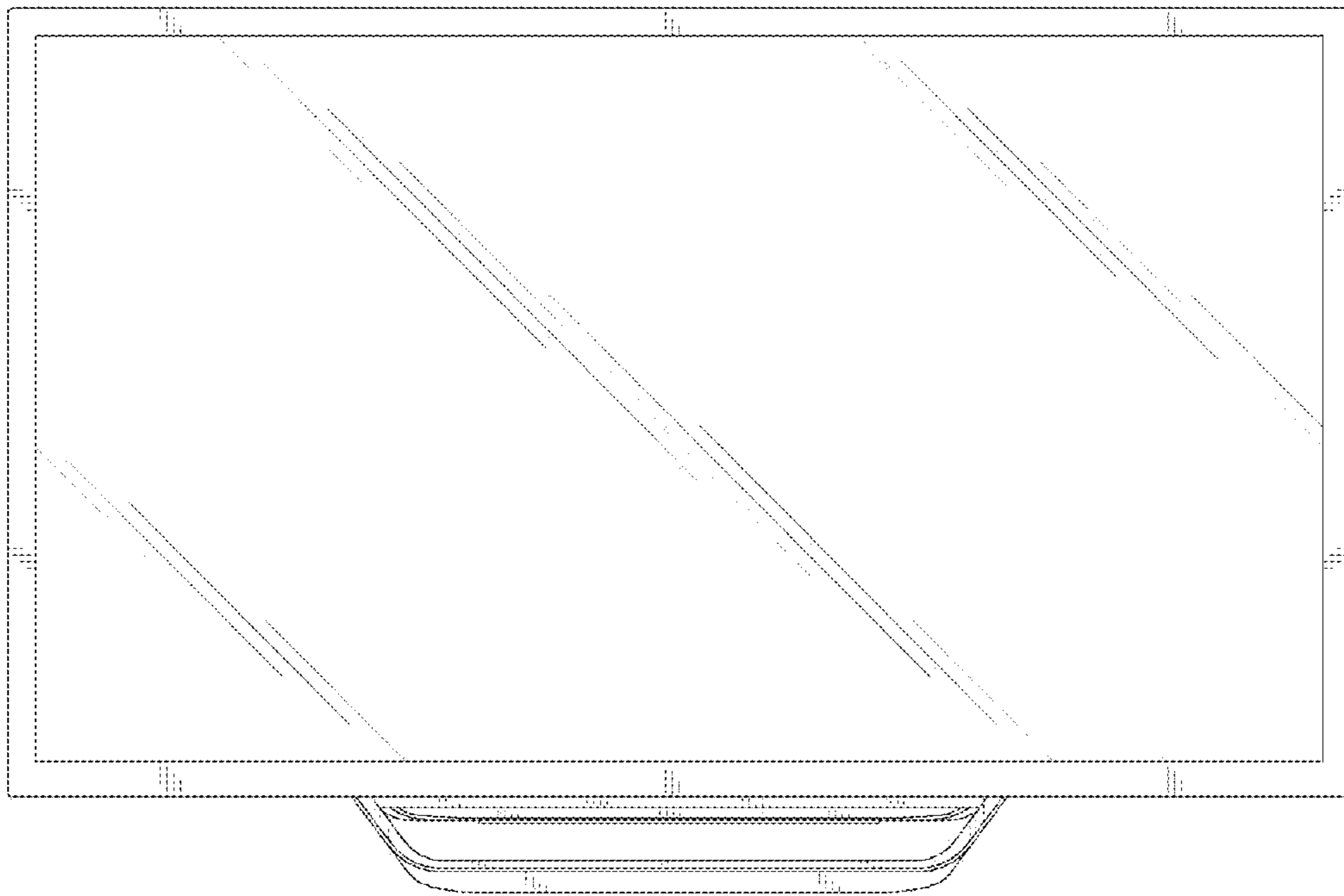

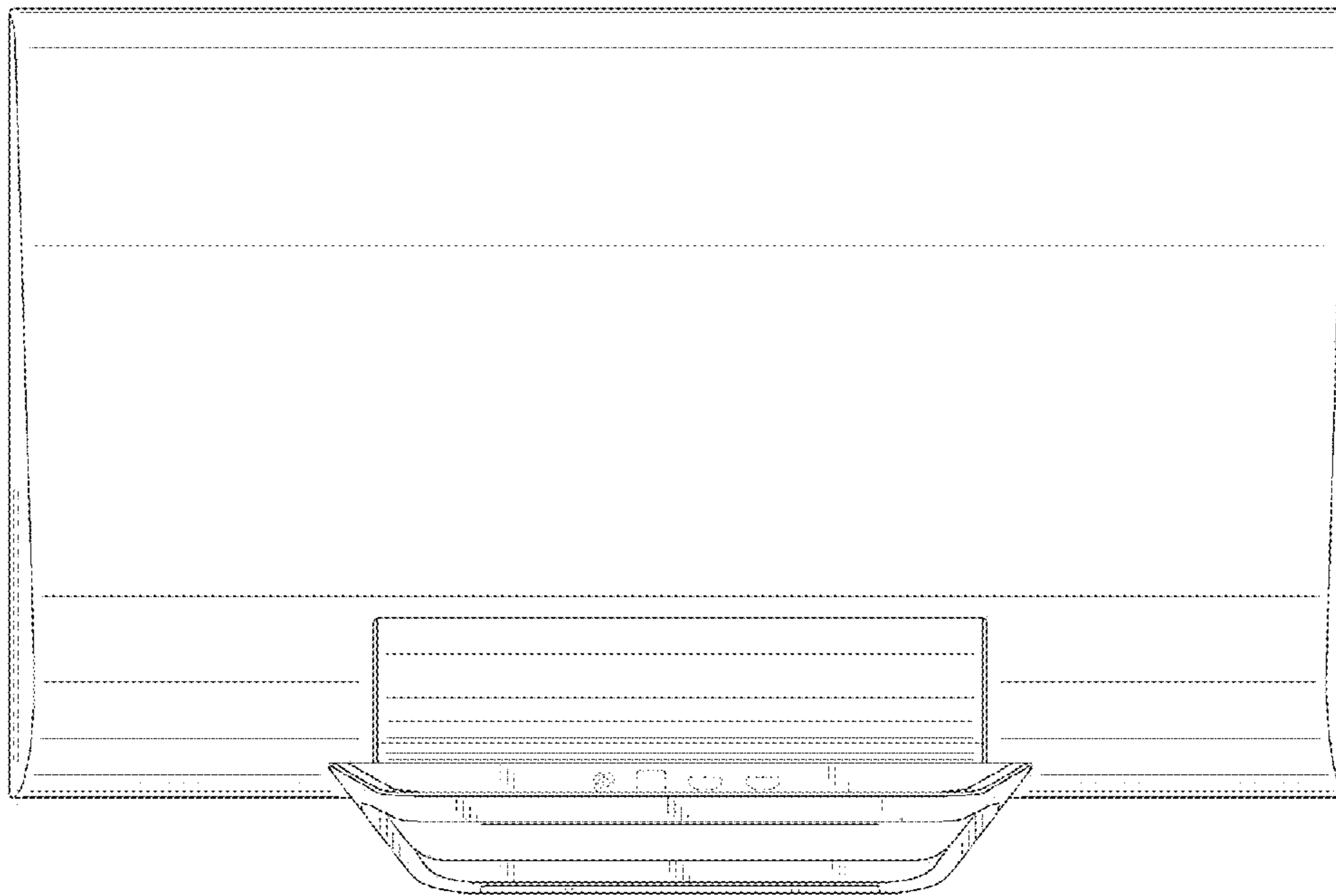

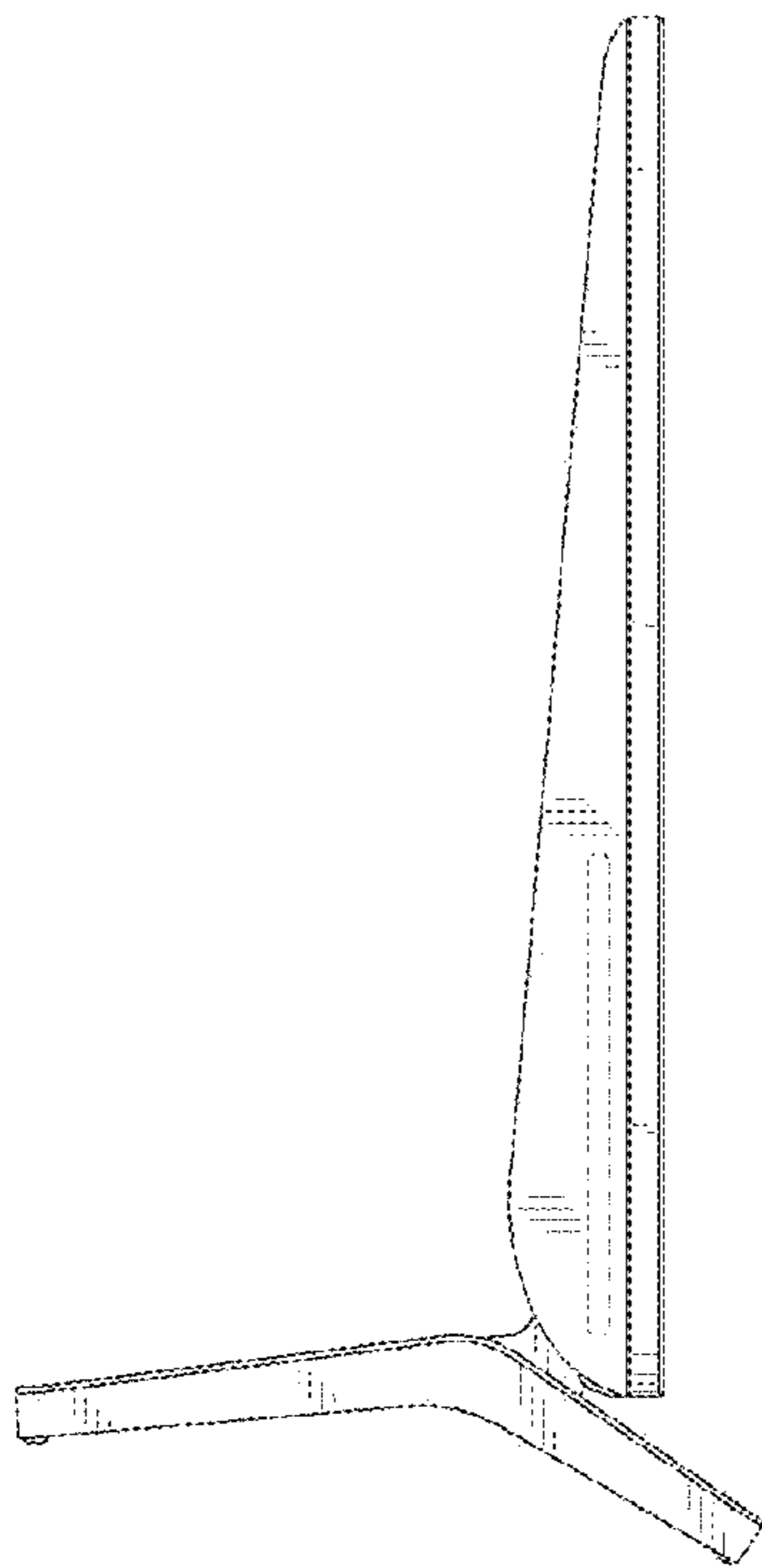

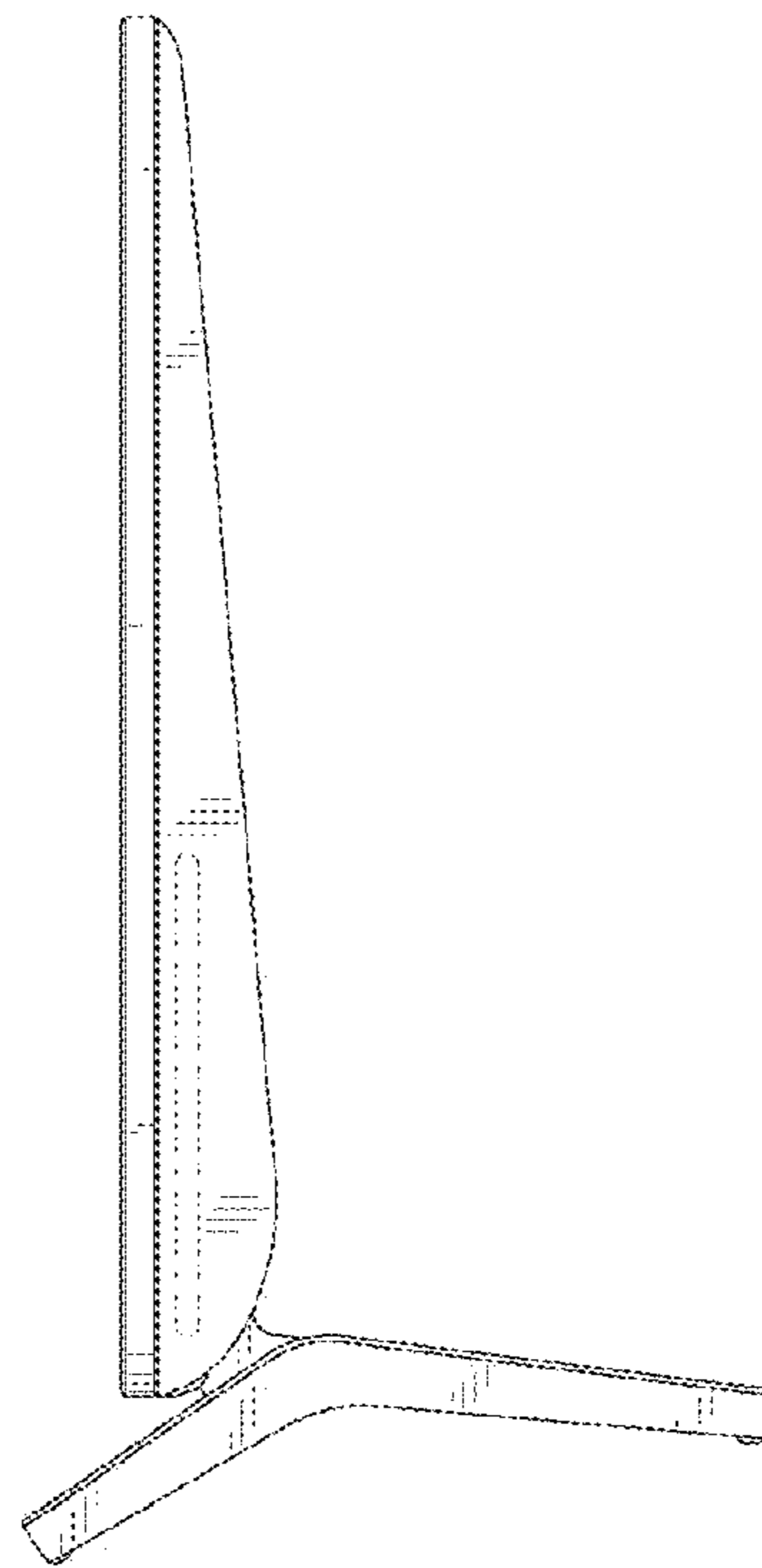

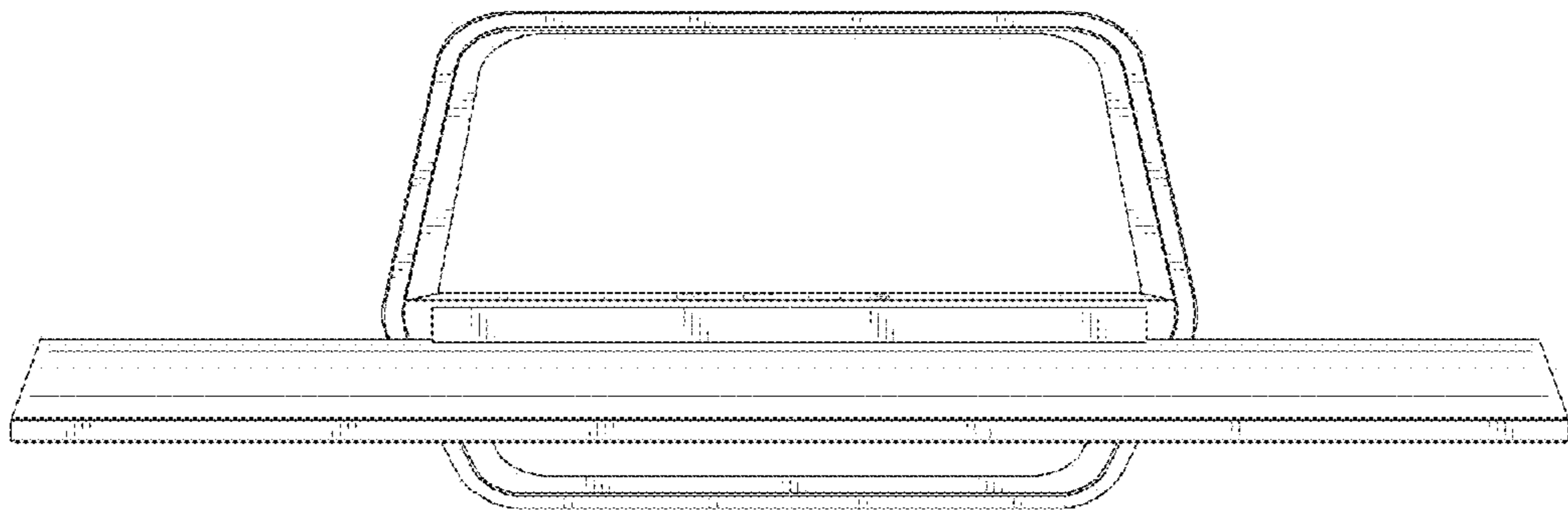

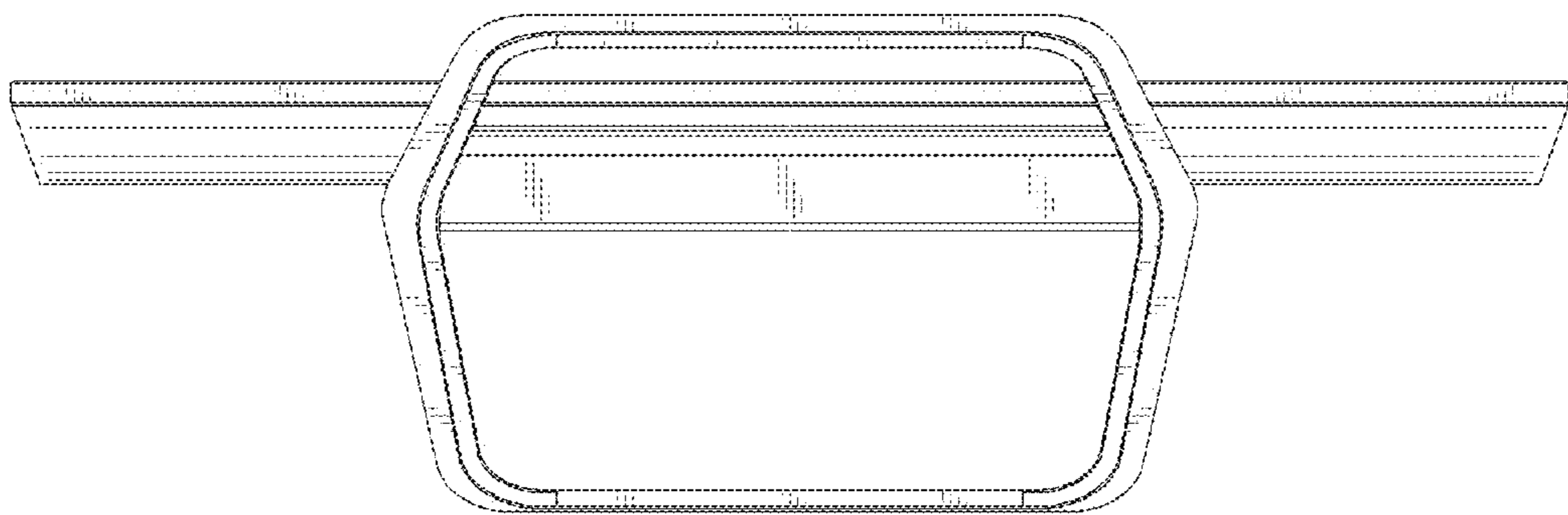

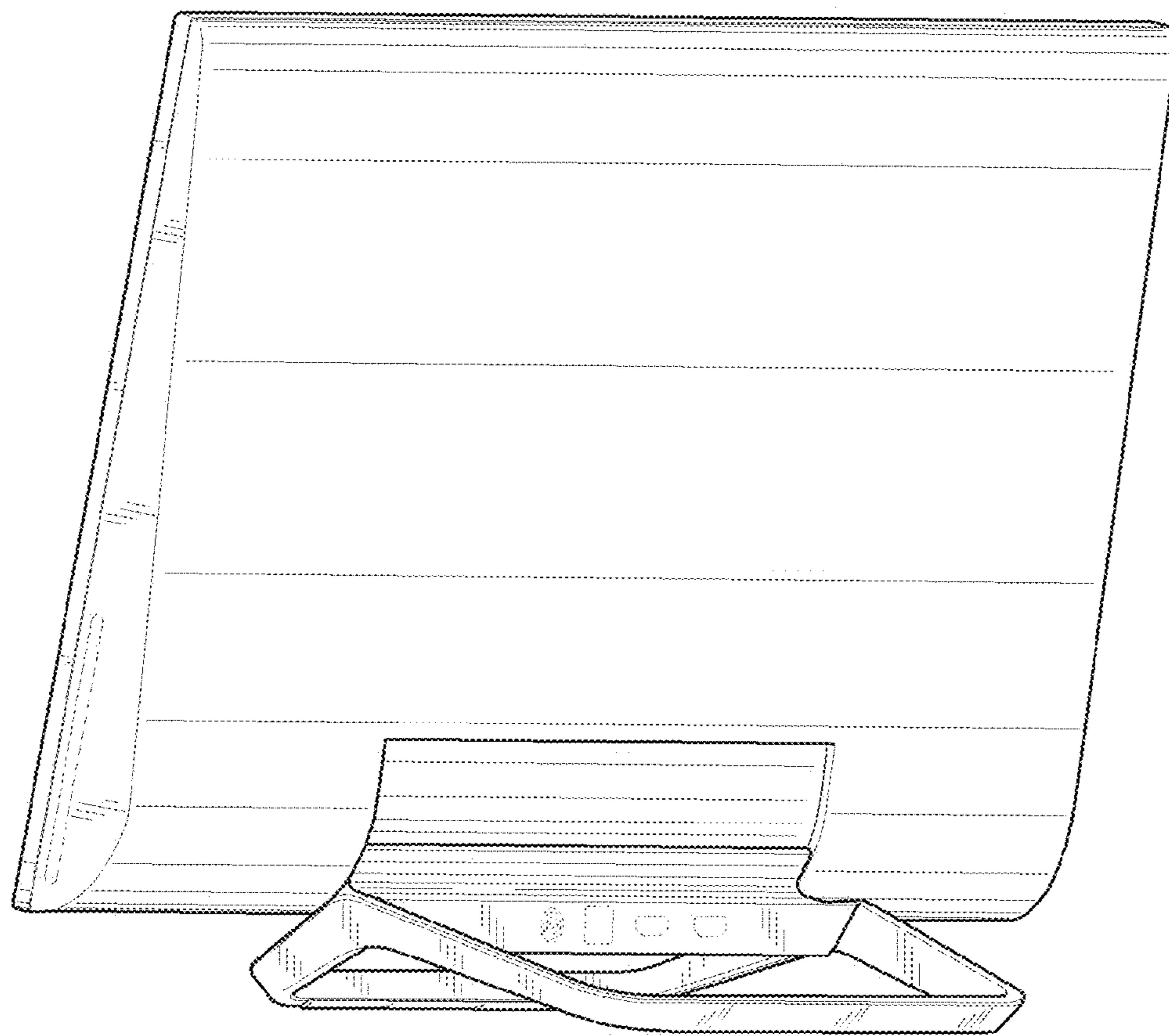
