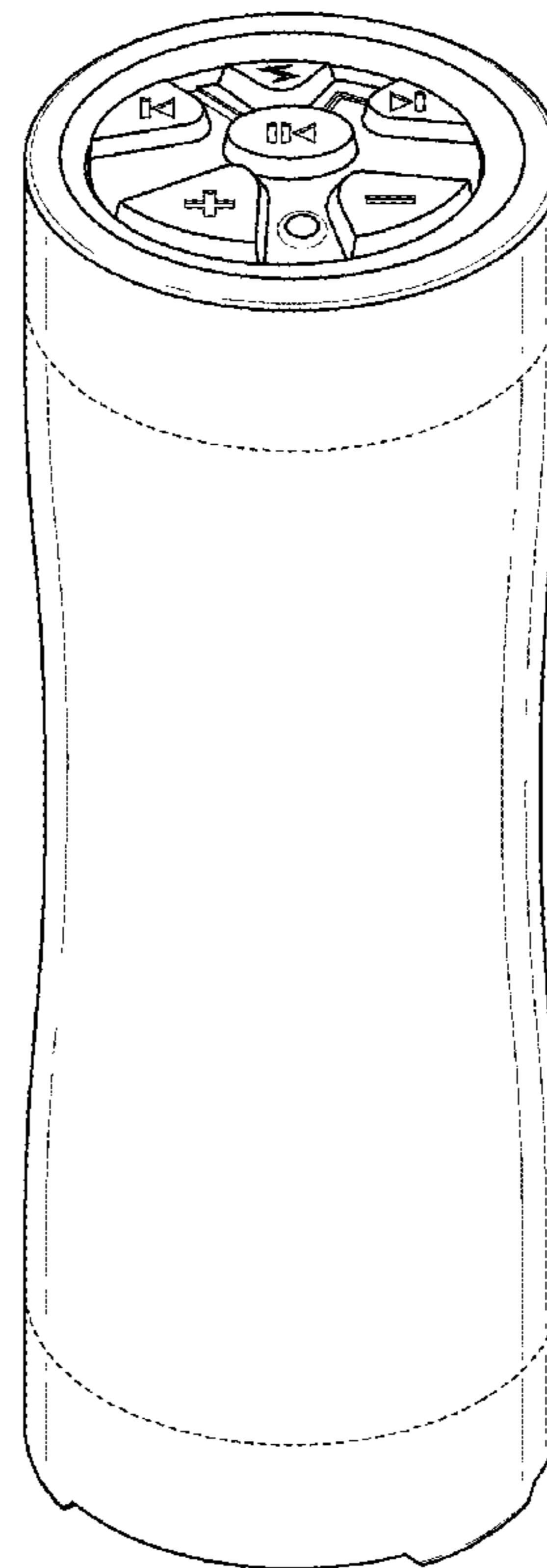
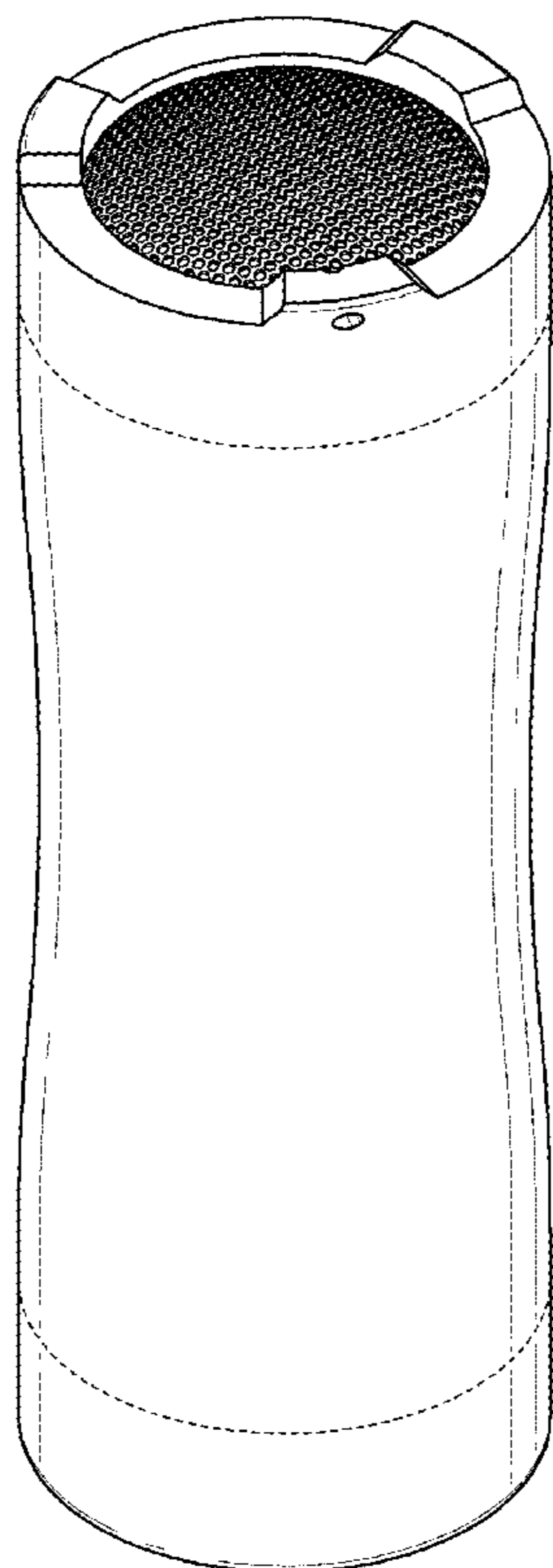
The ornamental design for a water-resistant speaker, as shown and described.

DESCRIPTION

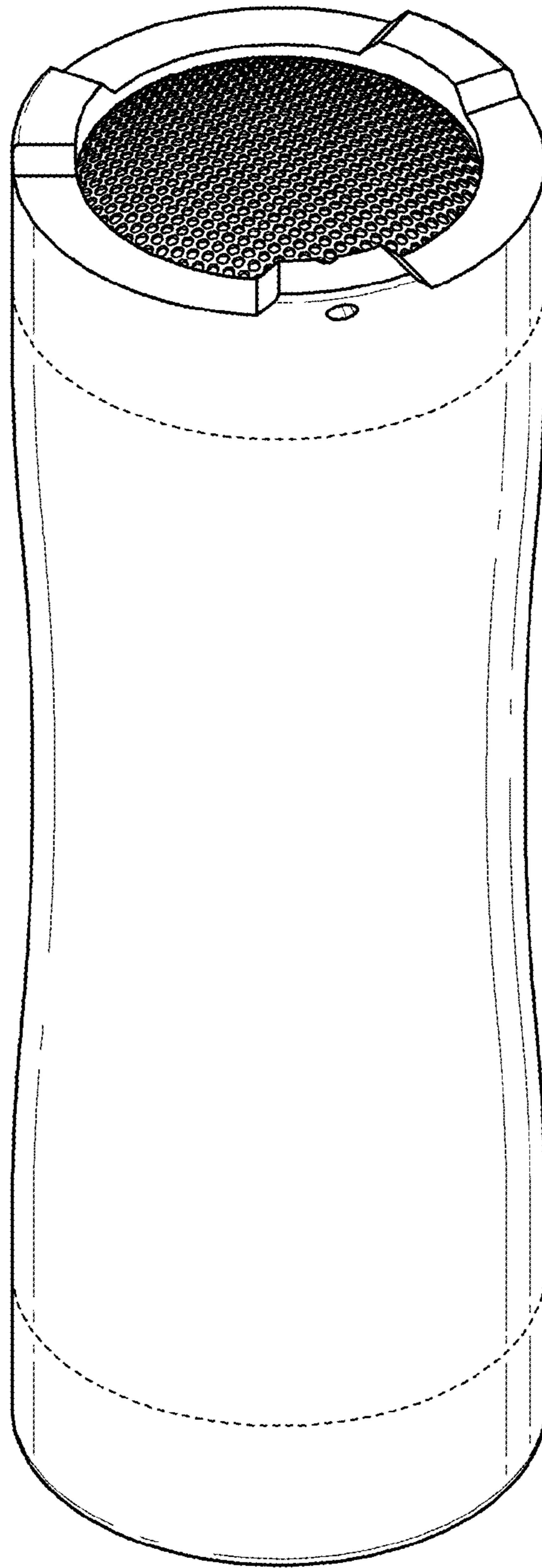

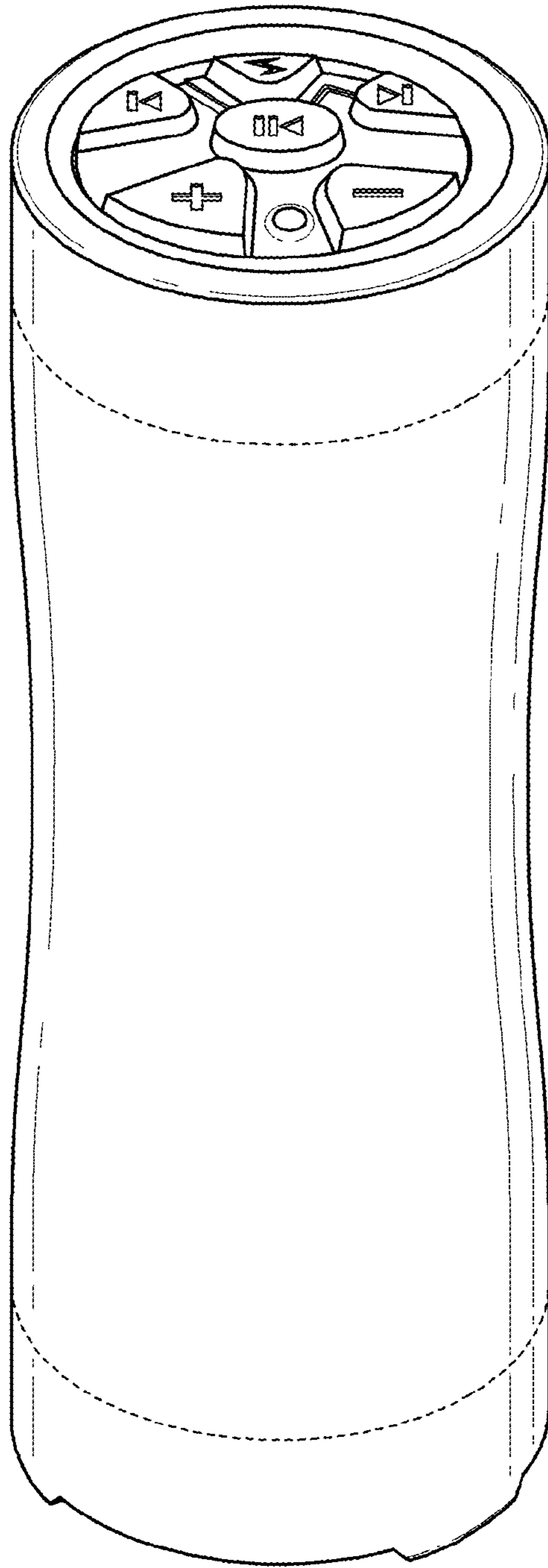

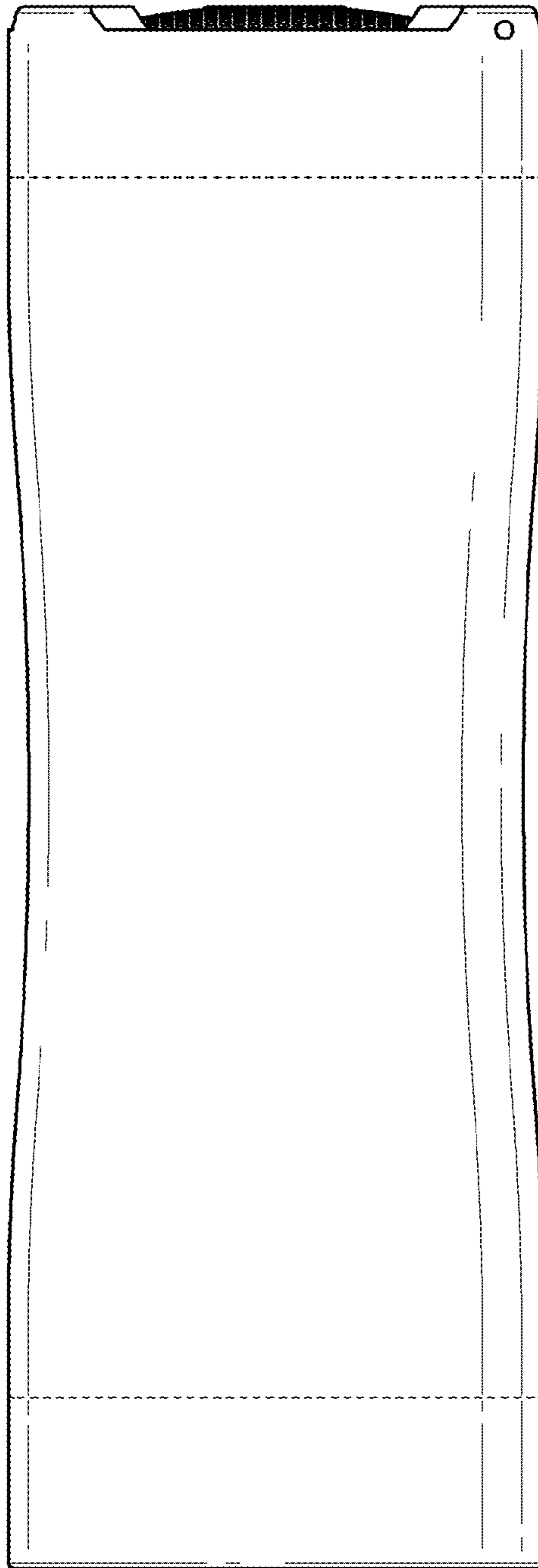

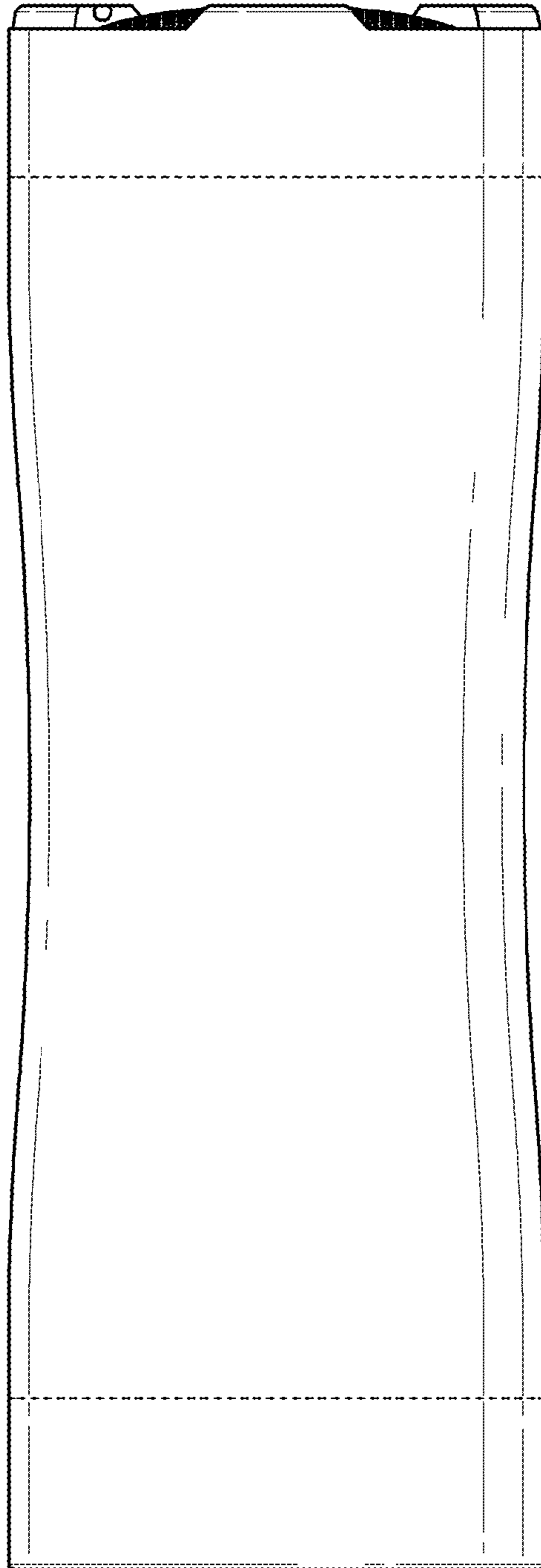

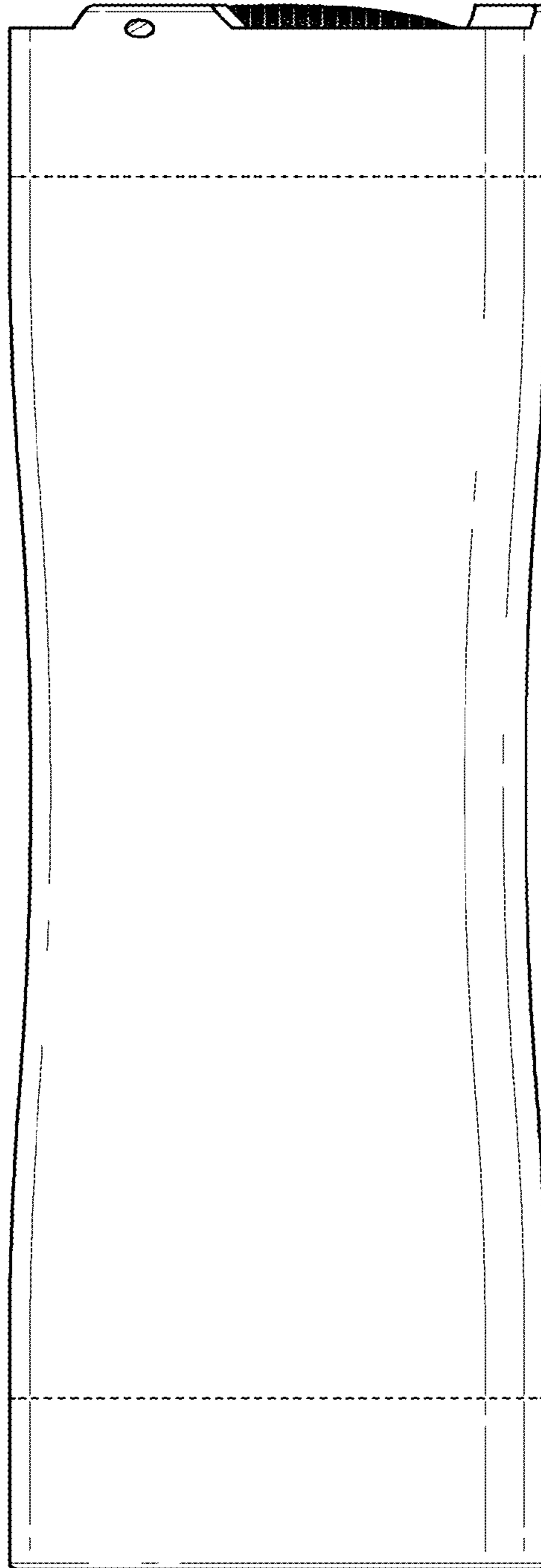

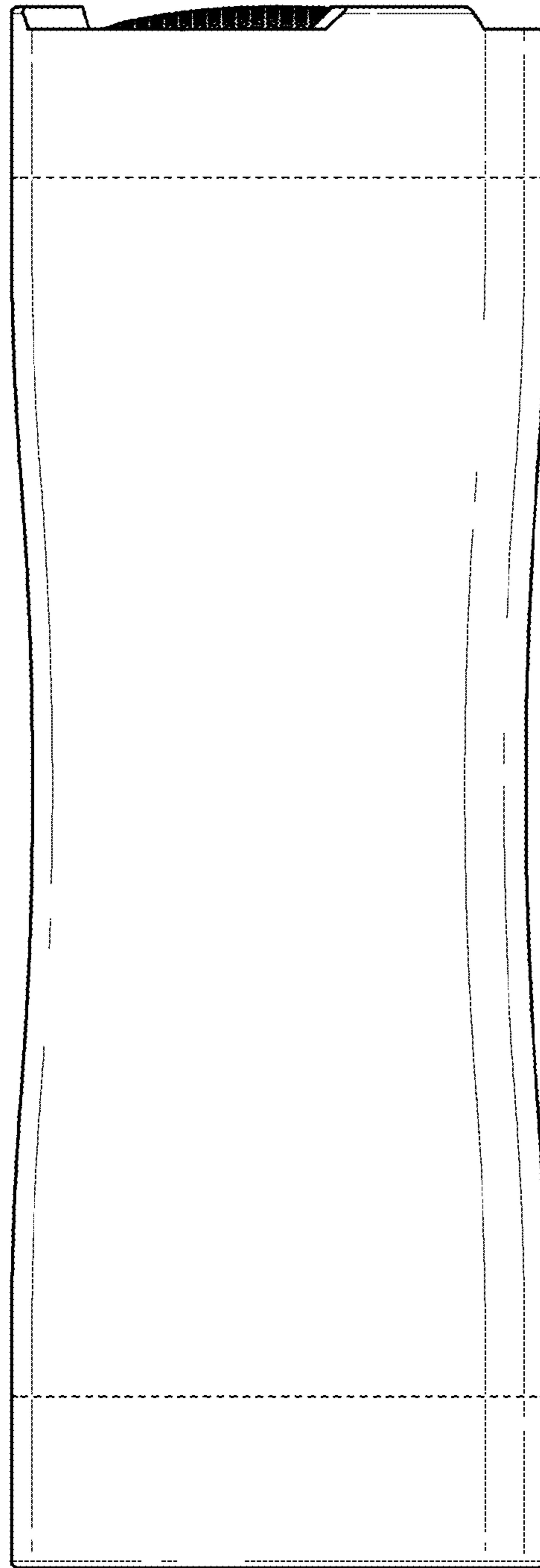

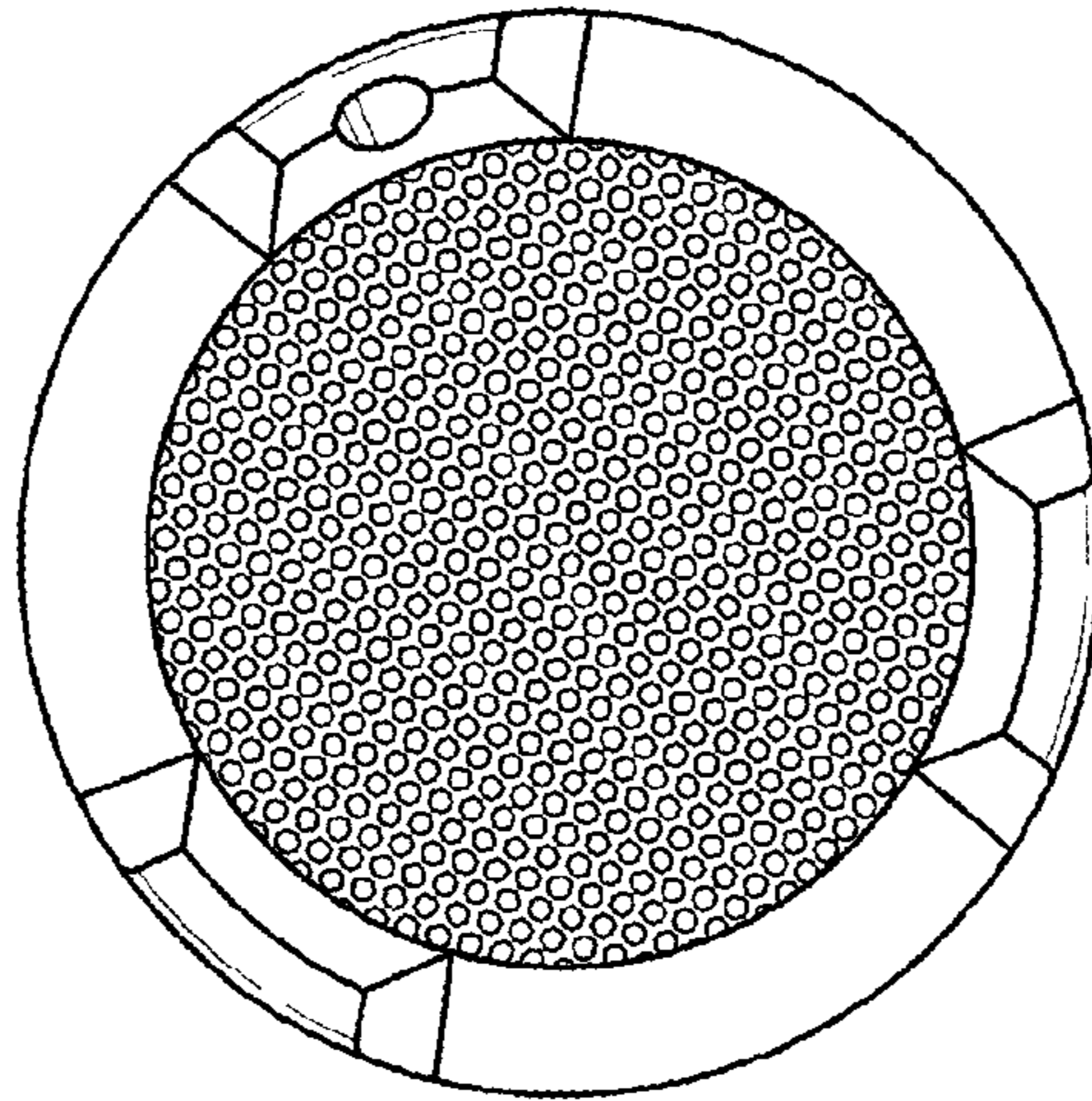

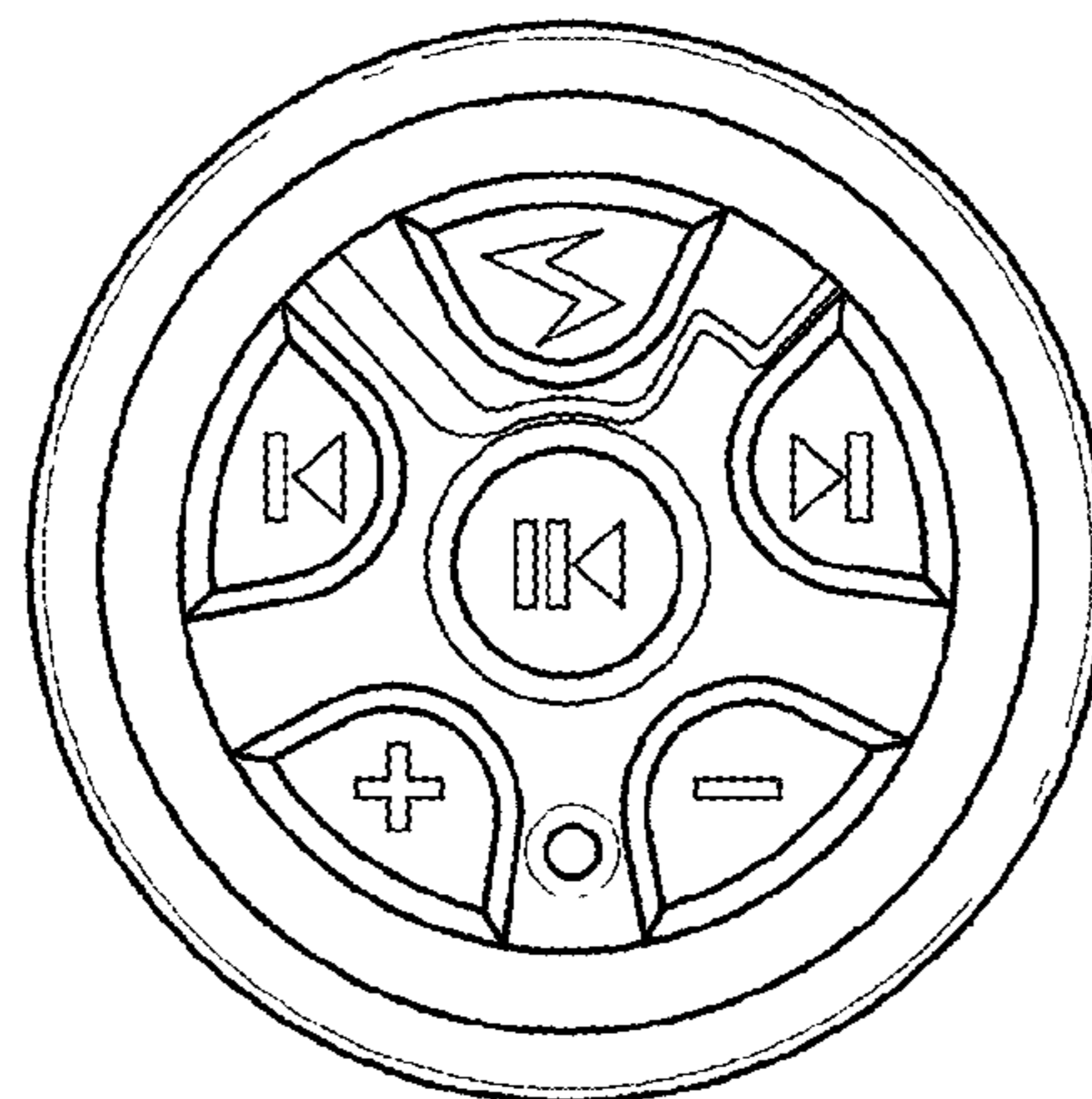
